

[PROPOSED] ORDER

In light of the parties' stipulation, the Court adopts the following schedule:

Defendants shall complete the production of written records, excluding audio recordings, photographic files, video files, and transcripts, by September 26, 2021, unless that date is modified by Court order for good cause.

Within thirty (30) days after Defendants' completion of the production of such records, Defendants shall produce to Plaintiffs a log of all records withheld from the production, as specified in the Court's March 26, 2021 Order.

Within fourteen (14) days after Defendants' production of the withholding log, the parties shall file a joint status report to apprise the Court on the status of the production and to propose a schedule for briefing any remaining legal disputes concerning the production.


