It is further alleged that CLAYTON THOM and VALERIE TANAKA acted with the intent to defeat or evade the reporting, assessment or payment of a tax liability equal to or greater than twenty-five thousand dollars (\$25,000), within any 12-consecutive-month period, in violation of Revenue and Taxation Code section 7153.5, a felony, to wit: \$42,000 collected by CNC Motors, Inc.

COUNT 46

FAILURE TO FILE SALES TAX RETURN (RE: 2021 JANUARY-MARCH)

It is further alleged that CLAYTON THOM acted with the intent to defeat or evade the reporting, assessment or payment of a tax liability equal to or greater than twenty-five thousand dollars (\$25,000), within any 12-consecutive-month period, in violation of Revenue and Taxation Code section 7153.5, a felony, to wit: \$43,727 collected by CNC Motors, Inc.

FIRST SPECIAL ALLEGATION

AGGRAVATED WHITE COLLAR ENHANCEMENT IN EXCESS OF \$500,000 (PENAL CODE SECTION 186.11(A)(2))

(STATUTE OF LIMITATIONS - COMMISSION WITHIN FIVE YEARS)

It is further alleged pursuant to Revenue and Taxation Code section 7154, that the offenses set forth in Counts Thirty-Nine through Fifty-One were committed on or after October 31, 2018.

On October 31, 2018, January 31, 2019, April 30, 2019, July 31, 2019, October 31, 2019, November 6, 2019, January 31, 2020, May 20, 2020, May 22, 2020, July 31, 2020, December 31, 2020, February 5, 2021, defendants CLAYTON THOM and VALERIE TANAKA caused the filing of a false sales tax return for CNC Motors, Inc. and or Lotus of Upland, LLC.

REQUEST FOR DISCOVERY

Pursuant to Penal Code section 1054.5, subdivision (b), the People informally request that defense counsel provide discovery to the People as required by Penal Code section 1054.3.

NOTICE TO ATTORNEY

Any materials accompanying this complaint or provided by the People in this case may contain information about witnesses. Such information is subject to Penal Code section 1054.2, which provides, "No attorney may disclose or permit to be disclosed to a defendant the address or telephone number of a victim or witness whose name is disclosed to the attorney pursuant to subdivision (a) of section 1054.1 unless specifically permitted to do so by the court after a hearing and a showing of good cause."
