1 A Special Statewide Grand Jury of the County of San Diego, State of California, hereby
2 accuses by this Indictment, the following defendants of committing, in the Counties of Orange,
3 San Diego, San Bernardino, Riverside, and Los Angeles, the following crimes:

4 **COUNT 1 - VEHICLE 1**

5 **GRAND THEFT OF AN AUTOMOBILE**

6 On or between March 17, 2015, and June 23, 2015, in the County of Orange, defendants
7 GAYLEASE MASON, KENNETH CHELSEA, and JAMES MILES committed the crime of
8 GRAND THEFT OF AN AUTOMOBILE, in violation of Penal Code section 487(d)(1), a felony,
9 in that they did unlawfully take an automobile, the property of another, to wit: 2014 Ford Taurus
10 from Exeter Finance.

11 **COUNT 2 - VEHICLE 1**

12 **GRAND THEFT**

13 On or about July 17, 2015, in the County of Los Angeles, defendant TAMIKA
14 WHITMORE and KENNETH CHELSEA committed the crime of GRAND THEFT, in violation
15 of Penal Code section 487(a), a felony, in that she did unlawfully take money and/or personal
16 property of another of a value exceeding Nine Hundred Fifty Dollars (\$950), to wit: \$17,000 in
17 sale auto sale proceeds from Santa Monica SUV.

18 **COUNT 3 - VEHICLE 8**

19 **GRAND THEFT OF AN AUTOMOBILE**

20 On or about August 20, 2015, in the County of San Bernardino, defendants KENNETH
21 CHELSEA and JAMES CURRY committed the crime of GRAND THEFT OF AN
22 AUTOMOBILE, in violation of Penal Code section 487(d)(1), a felony, in that they did
23 unlawfully take an automobile, the property of another, to wit: 2014 Mercedes CLA 250 from
24 Exeter Finance.

25 **COUNT 4 - VEHICLE 8**

26 **GRAND THEFT**

27 On or about September 5, 2015, in the County of Los Angeles, defendant JAMES CURRY
28 committed the crime of GRAND THEFT, in violation of Penal Code section 487(a), a felony, in

1 that he did unlawfully take money and/or personal property of another of a value exceeding Nine
2 Hundred Fifty Dollars (\$950), to wit: \$22,000 in auto sale proceeds from Malkanis Motors.

3 **COUNT 5 - VEHICLE 9**

4 **GRAND THEFT OF AN AUTOMOBILE**

5 On or between May 13, 2015, and August 24, 2015, in the County of San Diego, defendants
6 PATRICIA JENKINS aka PATRICIA HICKSON and KENNETH CHELSEA committed the
7 crime of GRAND THEFT OF AN AUTOMOBILE, in violation of Penal Code section 487(d)(1),
8 a felony, in that they did unlawfully take an automobile, the property of another, to wit: 2009
9 Lexus LS 460 from Exeter Finance.

10 **COUNT 6 - VEHICLE 9**

11 **GRAND THEFT**

12 On or about October 15, 2015, in the County of Los Angeles, defendant DAMISI
13 ADIMIKA HICKSON committed the crime of GRAND THEFT, in violation of Penal Code
14 section 487(a), a felony, in that she did unlawfully take money and/or personal property of
15 another of a value exceeding Nine Hundred Fifty Dollars (\$950), to wit: \$21,200 in auto sale
16 proceeds from Monza Car Dealership.

17 **COUNT 7 - VEHICLE 15**

18 **GRAND THEFT OF AN AUTOMOBILE**

19 On or about October 7, 2015, in the County of Orange, defendants KENNETH CHELSEA,
20 JAMES MILES, and JAMES CURRY committed the crime of GRAND THEFT OF AN
21 AUTOMOBILE, in violation of Penal Code section 487(d)(1), a felony, in that they did
22 unlawfully take an automobile, the property of another, to wit: 2010 Chevrolet Camaro from
23 Santander Consumer USA.

24 **COUNT 8 - VEHICLE 15**

25 **GRAND THEFT**

26 On or about October 10, 2015, in the County of Los Angeles, defendant JAMES CURRY
27 committed the crime of GRAND THEFT, in violation of Penal Code section 487(a), a felony, in
28

1 that he did unlawfully take money and/or personal property of another of a value exceeding Nine
2 Hundred Fifty Dollars (\$950), to wit: \$17,500 in auto sale proceeds from Michael Tran.

3 **COUNT 9 - VEHICLE 16**

4 **GRAND THEFT OF AN AUTOMOBILE**

5 On or about October 9, 2015, in the County of Orange, defendants JAMES MILES and
6 JAMES CURRY committed the crime of GRAND THEFT OF AN AUTOMOBILE, in violation
7 of Penal Code section 487(d)(1), a felony, in that they did unlawfully take an automobile, the
8 property of another, to wit: 2010 Jaguar XF from Santander Consumer USA.

9 **COUNT 10 - VEHICLE 16**

10 **GRAND THEFT**

11 On or about October 26, 2015, in the County of Los Angeles, defendant JAMES CURRY
12 committed the crime of GRAND THEFT, in violation of Penal Code section 487(a), a felony, in
13 that he did unlawfully take money and/or personal property of another of a value exceeding Nine
14 Hundred Fifty Dollars (\$950), to wit: \$15,000 in auto sale proceeds from Aziz Ahmady.

15 **COUNT 11 - VEHICLE 20**

16 **GRAND THEFT OF AN AUTOMOBILE**

17 On or between July 31, 2015, and August 4, 2015, in the County of Los Angeles,
18 defendants RONELD WILLIAMS, KENNETH CHELSEA, and TAMIKA WHITMORE
19 committed the crime of GRAND THEFT OF AN AUTOMOBILE, in violation of Penal Code
20 section 487(d)(1), a felony, in that they did unlawfully take an automobile, the property of
21 another, to wit: 2013 Ford Taurus from Valley Kia.

22 **COUNT 12 - VEHICLE 20**

23 **GRAND THEFT**

24 On or about August 18, 2015, in the County of Los Angeles, defendant TAMIKA
25 WHITMORE committed the crime of GRAND THEFT, in violation of Penal Code section
26 487(a), a felony, in that she did unlawfully take money and/or personal property of another of a
27 value exceeding Nine Hundred Fifty Dollars (\$950), to wit: \$6,600 in auto sale proceeds from
28 Roadrunner Auto Sales.

1 **COUNT 13 - VEHICLE G11**

2 **COMMERCIAL BURGLARY**

3 On or about June 30, 2016, in the County of Riverside, defendants STANLEY EDET and
4 KENNETH CHELSEA committed the crime of COMMERCIAL BURGLARY, in violation of
5 Penal Code section 459, a felony, in that they did unlawfully enter a commercial building
6 occupied by MIKE THOMPSON'S RV with the intent to commit larceny or any felony.

7 **COUNT 14 - VEHICLE G11**

8 **IDENTITY THEFT**

9 On or about June 30, 2016, in the County of Riverside, defendants STANLEY EDET and
10 KENNETH CHELSEA committed the crime of IDENTITY THEFT, in violation of Penal Code
11 section 530.5, a felony, in that they did willfully and unlawfully obtain personal identifying
12 information of HOWARD COLEMAN and used that information for an unlawful purpose.

13 **COUNT 15 - VEHICLE G11**

14 **GRAND THEFT OF AN AUTOMOBILE**

15 On or about June 30, 2016, in the County of Riverside, defendants STANLEY EDET and
16 KENNETH CHELSEA committed the crime of GRAND THEFT OF AN AUTOMOBILE, in
17 violation of Penal Code section 487(d)(1), a felony, in that they did unlawfully take an
18 automobile, the property of another, to wit: 2015 Leprechaun Recreational Vehicle from Mike
19 Thompson's RV.

20 **COUNT 16 - VEHICLE W2**

21 **COMMERCIAL BURGLARY**

22 On or about April 25, 2016, in the County of Los Angeles, defendant SABRINA
23 GREGORIO committed the crime of COMMERCIAL BURGLARY, in violation of Penal Code
24 section 459, a felony, in that she did unlawfully enter a commercial building occupied by KEYES
25 LEXUS with the intent to commit larceny or any felony.

1 COUNT 17 - VEHICLE W2

2 **IDENTITY THEFT**

3 On or about April 25, 2016, in the County of Los Angeles, defendant SABRINA
4 GREGORIO committed the crime of IDENTITY THEFT, in violation of Penal Code section
5 530.5, a felony, in that she did willfully and unlawfully obtain personal identifying information of
6 BETTY GREGORIO and used that information for an unlawful purpose.

7 COUNT 18 - VEHICLE W2

8 **GRAND THEFT OF AN AUTOMOBILE**

9 On or about April 25, 2016, in the County of Los Angeles, defendant SABRINA
10 GREGORIO committed the crime of GRAND THEFT OF AN AUTOMOBILE, in violation of
11 Penal Code section 487(d)(1), a felony, in that she did unlawfully take an automobile, the
12 property of another, to wit: 2014 Lexus GS350 from KEYES LEXUS.

13 COUNT 19 - VEHICLE W3

14 **COMMERCIAL BURGLARY**

15 On or about April 26, 2016, in the County of Los Angeles, defendant SABRINA
16 GREGORIO committed the crime of COMMERCIAL BURGLARY, in violation of Penal Code
17 section 459, a felony, in that she did unlawfully enter a commercial building occupied by
18 MARTIN CHEVROLET with the intent to commit larceny or any felony.

19 COUNT 20 - VEHICLE W3

20 **IDENTITY THEFT**

21 On or about April 26, 2016, in the County of Los Angeles, defendant SABRINA
22 GREGORIO committed the crime of IDENTITY THEFT, in violation of Penal Code section
23 530.5, a felony, in that she did willfully and unlawfully obtain personal identifying information of
24 BETTY GREGORIO and used that information for an unlawful purpose.

25 COUNT 21 - VEHICLE W3

26 **GRAND THEFT OF AN AUTOMOBILE**

27 On or about April 26, 2016, in the County of Los Angeles, defendant SABRINA
28 GREGORIO committed the crime of GRAND THEFT OF AN AUTOMOBILE, in violation of

1 Penal Code section 487(d)(1), a felony, in that she did unlawfully take an automobile, the
2 property of another, to wit: 2016 Chevrolet Camaro from MARTIN CHEVROLET.

3 **COUNT 22 - VEHICLE W4**

4 **COMMERCIAL BURGLARY**

5 On or about June 7, 2016, in the County of Los Angeles, defendants STANLEY EDET and
6 KENNETH CHELSEA committed the crime of COMMERCIAL BURGLARY, in violation of
7 Penal Code section 459, a felony, in that they did unlawfully enter a commercial building
8 occupied by FELIX CHEVROLET with the intent to commit larceny or any felony.

9 **COUNT 23 - VEHICLE W4**

10 **IDENTITY THEFT**

11 On or about June 7, 2016, in the County of Los Angeles, defendants KENNETH
12 CHELSEA and STANLEY EDET committed the crime of IDENTITY THEFT, in violation of
13 Penal Code section 530.5, a felony, in that they did willfully and unlawfully obtain personal
14 identifying information of KEITH ROBERTS and used that information for an unlawful purpose.

15 **COUNT 24 - VEHICLE W4**

16 **GRAND THEFT OF AN AUTOMOBILE**

17 On or about June 7, 2016, in the County of Los Angeles, defendants KENNETH
18 CHELSEA and STANLEY EDET committed the crime of GRAND THEFT OF AN
19 AUTOMOBILE, in violation of Penal Code section 487(d)(1), a felony, in that they did
20 unlawfully take an automobile, the property of another, to wit: 2016 Chevrolet Camaro from
21 FELIX CHEVROLET.

22 **COUNT 25 - VEHICLE W4**

23 **RECEIVING STOLEN PROPERTY**

24 On or about June 15, 2016, in the County of Los Angeles, defendant KENNETH
25 CHELSEA committed the crime of RECEIVING STOLEN PROPERTY, in violation of the
26 Penal Code section 496(a), a felony, in that he did unlawfully buy or receive property, exceeding
27 nine hundred and fifty dollars (\$950) in value, that had been stolen or obtained in a manner
28 constituting theft, knowing the property to be so stolen and obtained.

1 COUNT 26 - VEHICLE W5

2 **COMMERCIAL BURGLARY**

3 On or about June 8, 2016, in the County of Los Angeles, defendant STANLEY EDET
4 committed the crime of COMMERCIAL BURGLARY, in violation of Penal Code section 459, a
5 felony, in that he did unlawfully enter a commercial building occupied by GLENDALE DODGE
6 with the intent to commit larceny or any felony.

7 COUNT 27 - VEHICLE W5

8 **IDENTITY THEFT**

9 On or about June 8, 2016, in the County of Los Angeles, defendant STANLEY EDET
10 committed the crime of IDENTITY THEFT, in violation of Penal Code section 530.5, a felony, in
11 that he did willfully and unlawfully obtain personal identifying information of KEITH ROBERTS
12 and used that information for an unlawful purpose.

13 COUNT 28 - VEHICLE W5

14 **GRAND THEFT OF AN AUTOMOBILE**

15 On or about June 8, 2016, in the County of Los Angeles, defendant STANLEY EDET
16 committed the crime of GRAND THEFT OF AN AUTOMOBILE, in violation of Penal Code
17 section 487(d)(1), a felony, in that he did unlawfully take an automobile, the property of another,
18 to wit: 2016 Dodge Challenger from GLENDALE DODGE.

19 COUNT 29 - VEHICLE W7

20 **COMMERCIAL BURGLARY**

21 On or about June 8, 2016, in the County of Los Angeles, defendant STANLEY EDET
22 committed the crime of COMMERCIAL BURGLARY, in violation of Penal Code section 459, a
23 felony, in that he did unlawfully enter a commercial building occupied by SANTA MONICA
24 CHRYSLER JEEP DODGE RAM with the intent to commit larceny or any felony.

25 COUNT 30 - VEHICLE W7

26 **IDENTITY THEFT**

27 On or about June 8, 2016, in the County of Los Angeles, defendant STANLEY EDET
28 committed the crime of IDENTITY THEFT, in violation of Penal Code section 530.5, a felony, in

1 that he did willfully and unlawfully obtain personal identifying information of KEITH ROBERTS
2 and used that information for an unlawful purpose.

3 **COUNT 31 - VEHICLE W7**

4 **GRAND THEFT OF AN AUTOMOBILE**

5 On or about June 8, 2016, in the County of Los Angeles, defendant STANLEY EDET
6 committed the crime of GRAND THEFT OF AN AUTOMOBILE, in violation of Penal Code
7 section 487(d)(1), a felony, in that he did unlawfully take an automobile, the property of another,
8 to wit: 2016 Jeep Cherokee from SANTA MONICA CHRYSLER JEEP DODGE RAM.

9 **COUNT 32 - VEHICLE W7**

10 **RECEIVING STOLEN PROPERTY**

11 On or about June 15, 2016, in the County of Los Angeles, defendant KENNETH
12 CHELSEA committed the crime of RECEIVING STOLEN PROPERTY, in violation of the
13 Penal Code section 496(a), a felony, in that he did unlawfully buy or receive property, exceeding
14 nine hundred and fifty dollars (\$950) in value, that had been stolen or obtained in a manner
15 constituting theft, knowing the property to be so stolen and obtained.

16 **COUNT 33 - VEHICLE W8**

17 **COMMERCIAL BURGLARY**

18 On or about June 11, 2016, in the County of Los Angeles, defendant STANLEY EDET
19 committed the crime of COMMERCIAL BURGLARY, in violation of Penal Code section 459, a
20 felony, in that he did unlawfully enter a commercial building occupied by KEYES WOODLAND
21 HILLS BUICK GMC with the intent to commit larceny or any felony.

22 **COUNT 34 - VEHICLE W8**

23 **IDENTITY THEFT**

24 On or about June 11, 2016, in the County of Los Angeles, defendant STANLEY EDET
25 committed the crime of IDENTITY THEFT, in violation of Penal Code section 530.5, a felony, in
26 that he did willfully and unlawfully obtain personal identifying information of KEITH ROBERTS
27 and used that information for an unlawful purpose.
