After a full trial of all disputed issues, the Court finds, declares, and decrees as follows:

1. Judgment in the above-entitled cause shall be entered in favor of the Plaintiff, the People of the State of California, and against the Defendants, James Joseph Kelly III and Justin Louis Mullins;

2. Defendant James Joseph Kelly III shall, pursuant to Civil Code section 52, subdivision (b)(2), pay a civil penalty of twenty-five thousand dollars (\$25,000.00) to Felipe Alvarado;

3. Defendant Justin Louis Mullins shall, pursuant to Civil Code section 52, subdivision (b)(2), pay a civil penalty of twenty-five thousand dollars (\$25,000.00) to Felipe Alvarado; and

4. The Attorney General is awarded all costs of investigating and prosecuting this action, including its reasonable attorney's fees and costs, pursuant to Code of Civil Procedure section 1021.8, subdivision (a), to be paid to the Public Rights Law Enforcement Special Fund.


