Re: Initiative Constitutional Amendment Proposal on Gender Identity Liberty And Freedom

The undersigned hereby respectfully requests and submits the initiative measure set forth below that the Attorney General's Office prepare a circulating title and summary for the proposed initiative measure. The full text of the initiative measure is as follows:

"CALIFORNIA CONSTITUTION  
ARTICLE 1 DECLARATION OF RIGHTS

SEC. 32. Free exercise and enjoyment of gender identity without discrimination or preference are guaranteed. This liberty of conscience does not excuse acts that are licentious or inconsistent with the peace or safety of the State. The Legislature shall make no law respecting an establishment of gender identity A person is not incompetent to be a witness or juror because of his or her own gender identity."


The undersigned further hereby certifies and states, in accordance with the provisions of Sections 9001 and 9608 of the California Elections Code, as follows:

"I, Ashley Illma Gore, declare under penalty of perjury that I am a citizen of the United States, 18 years of age or older, and a resident of the County of Los Angeles, California."

"I, Ashley Illma Gore, acknowledge that it is a misdemeanor under state law (Section 18650 of the Elections Code) to knowingly or willfully allow the signatures on an initiative petition to be used for any purpose other than qualification of the proposed measure for the ballot. I certify that I will not knowingly or willfully allow the signatures for this initiative to be used for any purpose other than qualification of the measure for the ballot."

### **GENDER IDENTITY LIBERTY AND FREEDOM ACT**

An act to review Article I, Section 4. of the California Constitution and to add Section 32. to the California Constitution, relating to the establishment and freedom of liberty of the conscience.

### **CALIFORNIA CONSTITUTION**

#### **ARTICLE I DECLARATION OF RIGHTS**

SEC. 4. Free exercise and enjoyment of religion without discrimination or preference are guaranteed. This liberty of conscience does not excuse acts that are licentious or inconsistent with the peace or safety of the State. The Legislature shall make no law respecting an establishment of religion. A person is not incompetent to be a witness or juror because of his or her opinions on religious beliefs.

### **FULL TEXT OF INITIATIVE PROPOSAL**

#### **ARTICLE I DECLARATION OF RIGHTS**

SEC. 32. Free exercise and enjoyment of gender identity without discrimination or preference are guaranteed. This liberty of conscience does not excuse acts that are licentious or inconsistent with the peace or safety of the State. The Legislature shall make no law respecting an establishment of gender identity A person is not incompetent to be a witness or juror because of his or her own gender identity.”
