#### TO: ALL CALIFORNIA LAW ENFORCEMENT AGENCIES

Since 2016, pursuant to Penal Code section 18140, law enforcement agencies have been mandated to enter Gun Violence Restraining Orders (GVRO) into the California Restraining and Protective Order System (CARPOS) maintained and operated by the California Department of Justice (CA DOJ). In an effort to capture accurate data on GVROs and to eliminate duplicate entries, the CA DOJ is requesting agencies utilize the modify message key (MGVO) transaction to update any information in one or more data fields within an existing GVRO record, rather than entering in an entirely new order.

### **Modify Requirements**

- A. Only the contributor of an original record or CA DOJ can modify the record. Agencies cannot modify a record entered by another agency.
- B. Mandatory data fields can be modified, but not deleted.
- C. The name used in identifying the record to be modified must be spelled and spaced exactly the same as the record on file in the CARPOS.
- D. The multiple content data fields AKA, CMC and SMT require a different modify format (see Modify Format for Multiple Occurring Fields, Section 6.8.3 located in the Terminal Operators Guide located on CLEW).
- E. No more than nine (9) fields can be modified in any transaction. Data field codes (DFC) and rules apply to modify transactions.
- F. Any addition or correction of the information in the MIS field will supersede the original contents of the field. To correct the MIS field, enter the new information and any of the original message content which should be retained.

#### **Basic Modify Format**

MGVO.FCN.RSP.DFC/dfc (up to nine (9) different DFCs)

Example: modify issue and expiration date

Fields to be modified must be identified by their data field code followed by a slash (/) and the new data (e.g., ISS/iss=ISS/20210506 and EXP/exp=EXP/20210521)

Fields to be modified must be identified by their data field code followed by a slash (/) and the new data (e.g., GVT/gvt=GVT/OGV, ISS/iss=ISS/20210506 and EXP/exp=EXP/20210521)
