## TO: ALL CALIFORNIA LAW ENFORCEMENT TELECOMMUNICATIONS (CLETS) USERS

The purpose of this information bulletin is to inform all criminal justice agencies that the California Department of Justice will be updating the California Restraining and Protective Order System (CARPOS) effective December 31, 2024. The update is to accommodate changes the Judicial Council has made to the Criminal, Domestic Violence, Juvenile, Elder Abuse, and Civil Restraining Order forms regarding the Body Armor prohibition pursuant to AB 92 (Penal Code Section 31360).

Below is the updated verbiage that will appear in the Firearms Provision Field (FAP) field when "B" is entered.

#### Issue date on or after 1/1/2025

CANNOT POSSESS, PURCHASE, OR RECEIVE FIREARMS, RECEIVERS, FRAMES, FIREARM PRECURSOR PARTS, AMMUNITION (AS DEFINED BY PC 16150[b]), OR BODY ARMOR (AS DEFINED BY PC 16288). MUST SURRENDER ALL FIREARMS, RECEIVERS, FRAMES, FIREARM PRECURSOR PARTS, AND BODY ARMOR TO LEA OR SELL TO A LICENSED GUN DEALER ONLY, AND MUST SHOW PROOF OF SURRENDER TO COURT. FOR ANY DOMESTIC VIOLENCE OR JUVENILE RESTRAINING ORDER, MUST ALSO SURRENDER AMMUNITION (AS DEFINED BY PC 16150[b]).

#### Issue date from 7/1/2022 to 12/31/2024

CANNOT POSSESS, PURCHASE, OR RECEIVE FIREARMS, RECEIVERS, FRAMES, FIREARM PRECURSOR PARTS, OR AMMUNITION (AS DEFINED BY PC 16150[b]). MUST SURRENDER ALL FIREARMS, RECEIVERS, FRAMES, AND FIREARM PRECURSOR PARTS TO LEA OR SELL TO A LICENSED GUN DEALER ONLY, AND MUST SHOW PROOF OF SURRENDER TO COURT.

FOR ANY DOMESTIC VIOLENCE OR JUVENILE RESTRAINING ORDER, MUST ALSO SURRENDER AMMUNITION (AS DEFINED BY PC 16150[b]).

#### Issue date from 1/1/2022 to 6/30/2022

CANNOT POSSESS, PURCHASE, OR RECEIVE FIREARMS OR AMMO, MUST SURRENDER ALL FIREARMS TO LEA OR SELL OR STORE WITH LICENSED GUN DEALER, MUST SHOW PROOF OF SURRENDER TO COURT. FOR ANY DOMESTIC VIOLENCE OR JUVENILE RESTRAINING ORDER, MUST ALSO Information Bulletin

### Issue date prior to 1/1/2022

CANNOT POSSESS, PURCHASE, OR RECEIVE FIREARMS OR AMMO, MUST SURRENDER ALL FIREARMS TO LEA OR SELL OR STORE WITH LICENSED GUN DEALER, MUST SHOW PROOF OF SURRENDER TO COURT.

No programming changes will be necessary.
