TO: ALL CALIFORNIA LAW ENFORCEMENT TELECOMMUNICATIONS (CLETS) USERS

The California Department of Justice will be updating the California Restraining and Protective Order System (CARPOS) effective **January 1, 2026**. Assembly Bill (AB) No. 2096 (2023-2024 Reg. Sess.) amended Civil Code section 527.85 to, among other things, include public institutions in the definition of postsecondary educational institutions. In response to AB 2096, the Judicial Council of California (JCC) has made substantial changes to the Postsecondary School Violence Restraining Orders form which require the following updates to CARPOS:

The below order types will be revised to remove the word “private” and display the following:

TSV TEMPORARY POSTSECONDARY SCHOOL VIOLENCE ORDER

SVO POSTSECONDARY SCHOOL VIOLENCE ORDER

Below is the updated verbiage for Postsecondary School Violence Restraining Orders when “Y” is entered in the Order to Not Abuse Field (ONA) field.

YES - THE RESTRAINED PERSON MUST NOT HARASS, MOLEST, STRIKE, STALK, ASSAULT, BATTER, ABUSE, DESTROY PERSONAL PROPERTY OF, OR DISTURB THE PEACE OF THE PROTECTED PERSON(S).

No programming changes will be necessary.
