## **Aces Cracked**

### **Bureau Requirements**

#### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should 500 Club Casino advertise a different name, the BGC ID (GEAR-001162) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying winning and losing hands
- Prize amount and prize type
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Aces Cracked gaming activity shall be attached to the following Bureau approved controlled game offered at 500 Club Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGR-002027)

#### **Object and Summary**

The Aces Cracked gaming activity features a fixed jackpot element, that is house-funded, attached to the eligible controlled game listed above. A prize is awarded to players participating in a jackpot game when a hand containing a pair of aces is beaten by a better hand at the showdown. In all instances, patrons shall be provided with ample advance notice of the rules and restrictions in order to qualify for the Aces Cracked gaming activity.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- In order to qualify for the jackpot, the player dealt the qualifying losing hand must use both hole cards.
- There is a minimum of two players required to be dealt in during a qualifying game in order for players to be eligible for this gaming activity.
- When a qualifying hand is made, a casino representative will verify that the hand qualifies. Any deviation from a standard deck will nullify the promotion.
- In order to qualify for the promotion, the player must complete the applicable bets on each round. If the player goes all-in, this is considered to have completed all bets.
- The player must lose the hand at the showdown, after the final round of betting.
- In the event that during a round of play, two players have the same qualifying losing hands, each player will split the posted prize amount evenly.
  - In the event the prize is something that cannot be split (merchandise, cars, etc.), the pre-determined cash value of the prize will be used and split between the players.

## **Aces Cracked**

# Dragon Jackpot

## **Bureau Requirements**

### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001236) listed below shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times that the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands and the restrictions for the qualifying events
- Jackpot prize amount
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Game**

The Dragon Jackpot shall be attached to the following Bureau approved controlled game offered at 500 Club Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- EZ Baccarat (GEGR-002039)

### **Object and Summary**

The Dragon Jackpot features a predetermined fixed jackpot prize between \$1,000 and \$500,000. A player(s) is awarded a fixed jackpot prize when they successfully bet on four consecutive Dragon 7 Bonus Bets while at a single table and win each of the Dragon 7 Bonus Bets that they place. In order for the table to be eligible, a Non-Dragon hand must precede the four consecutive Dragon 7 Bonus Bets. Per the base game rules, a scoreboard monitor (that is attached to each table) will be used to verify that four consecutive Dragon 7 Bonus Bets have been hit. Once the fourth consecutive Dragon 7 Bonus Bet hits, the game will be stopped. The video surveillance will be checked by a casino representative to verify which players had wagered on the Dragon 7 Bonus Bet four times in a row. The qualifying players will be paid from the cage the same day that the jackpot is hit.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- There is no minimum amount of players required to be dealt in during a qualifying game in order for the table to qualify for the jackpot.
- In the event that during a round of play, two or more players qualify for the jackpot prize, the players will evenly split the prize.
- The winning hands must be verified by a casino representative on duty. The prize shall be paid once the hands are verified. A casino representative will oversee the payout.
- There shall be no limit to the number of fixed prizes that can be won by a single player within a promotional period.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible to participate and qualify in this gaming activity as a player.

## Dragon Jackpot

- Casino employees are eligible to participate and win the Dragon Jackpot.
- Backline bettors are eligible to participate and qualify for this gaming activity.
- If a player has between one and three consecutive Dragon 7 Bonus Bet wins and sits out the next round before achieving the fourth Dragon 7 Bonus Bet, the number of consecutive bonus bet hits will reset for the player. The player will be ineligible for the jackpot if a fourth consecutive Dragon 7 Bonus Bet hits.

### **Prize**

All fee collections and table limits are for the designated controlled game and are Bureau approved, predetermined, and posted at each table.

### **Administrative Fees**

500 Club Casino shall not retain an administrative fee as the Dragon Jackpot is house funded.

### **No Purchase Necessary**

The Dragon Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Dragon Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

# Hourly High Hand

## **Bureau Requirements**

### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001157) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Minimum qualifying hand restrictions
- Prize amount and prize type
- No purchase necessary information
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Hourly High Hand shall be attached to all Bureau approved Poker games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

### **Object and Summary**

The player who obtains the highest ranking poker hand during a predetermined and posted time period shall win a predetermined and posted fixed prize ranging in value from \$10 to \$100,000. The qualifying hands made by players shall be tracked on a display board in a prominent area of the Casino. The player with the high hand that meets all of the eligibility requirements must have their hand verified by a casino representative.

### **Qualifying Hands**

A player who makes the highest five-card poker hand during a predetermined and posted time period shall be awarded with the posted prize amount. The hand made shall be at least the advertised minimum qualifying hand. Only one of the minimum qualifying hand options below shall be offered at any one time that the Hourly High Hand is being offered for play. They shall not be offered together at any time nor shall any combination of the minimum qualifying hand in each option be offered together at any time that this gaming activity is being offered for play. Patrons shall be provided with ample advance notice of which minimum qualifying hand option is being offered for play, as well as the requirement for the qualifying hand. If no minimum qualifying hand is achieved within the promotional period, no prize will be awarded. Furthermore, the minimum qualifying hand shall be displayed prominently within the Casino at all times the Hourly High Hand is being offered for play.

## Hourly High Hand

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- A player is eligible to win this promotion by making the highest ranking qualifying hand during the posted times of this promotion.
- There is a minimum of two players required to be playing a poker game in order to qualify for this promotion.
- In games utilizing hole cards, the player dealt the winning high hand must use one of their two hole cards in order to qualify for the promotion.
- Casino employees are eligible to participate in the promotion on or off duty, in or out of uniform.
- When a player achieves the highest poker hand for the predetermined and designated time period, that player shall receive 100% of the posted prize amount from the cage.
- All qualifying high hands must be verified by a casino representative in order to be eligible. Any deviation from a standard deck shall nullify the hand.
- In the event that two or more players have the exact same qualifying high hand the prize will be split equally among the players. If the prize is a non-cash prize then the cash value of the prize will be split among those players.
- Tournament games do not qualify for the promotion.
- Players must be present to win.
  - In the event a player is not present, the prize will be awarded to the next highest hand.
- Winning players must claim their prize within five minutes from when their name is called.
- There is no limit to the number of times a player may win this promotion.

### **Prize**

The prize will be a predetermined amount in the form of cash, live casino chips, or merchandise ranging in value from \$10 to \$100,000. All prizes for this promotion shall be predetermined and posted in advance, throughout the gaming floor and in all literature promoting such an event.

### **Funding**

The Hourly High Hand is funded by 500 Club Casino. There shall be no additional jackpot fees or collection fees taken for this promotion.

### **Administrative Fees**

500 Club Casino shall not retain an administrative fee for this promotion as it is house funded.

### **No Purchase Necessary**

The Hourly High Hand shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Hourly High Hand. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

# Last Man Standing

## **Bureau Requirements**

### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001158) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Eligible games and tables
- Eligible time periods
- Prize amount and prize type
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Last Man Standing promotion shall be attached to all Bureau approved Poker games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

### **Object and Summary**

The Last Man Standing promotion will award the player who plays the longest consecutive number of hours with a predetermined and posted prize. The player that plays the most consecutive hours at the designated table(s) will win the posted prize. The eligible table will be predetermined by management and announced to the players prior to the beginning of the promotion. Any interested players shall be afforded the opportunity to be eligible for the Last Man Standing promotion. If necessary, the Casino will open additional tables to accommodate all eligible players. The prize will be awarded to the player who plays the longest amount of consecutive hours at all eligible tables. Hours will be tracked by a casino representative on a computer spreadsheet.

***Example:** 500 Club Casino announces that in 15 minutes, they will be opening a table for Texas Hold'em and will be offering the Last Man Standing promotion at that table at that time. Once the 15 minutes has passed and the promotional period has begun, the players who were at the table at the beginning of the promotion are all eligible to participate and win the prize. The player who sits and plays the longest amount of time at that table will win the posted prize.*

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- A player is eligible to win this promotion by playing the longest amount of hours at a designated table.
- There is a minimum of two players required in an eligible game to qualify for this promotion.
- Casino employees are eligible to participate in this promotion when they are off duty and out of uniform.



## **Last Man Standing**

- In the event that more than one table is designated for this promotion, the tables shall each receive their own prize. Each designated table will not split the posted prize amount.
- Players will remain eligible for this promotion as long as they have not missed three consecutive blinds.
- A player is eligible to win this promotion a maximum of three times within a 24-hour period.
- Tournament games do not qualify for the promotion.

### **Prize**

The prize will be a predetermined fixed amount in the form of cash, live casino chips and/or merchandise ranging in value from \$5-\$100,000. The prize will be awarded within 7 days of the promotion ending and will be available at the cage for the player to collect.

### **Funding**

The Last Man Standing promotion is funded by 500 Club Casino. There shall be no additional jackpot fees or collection fees taken for this promotion.

### **Administrative Fees**

500 Club Casino shall not retain an administrative fee for this promotion as it is house funded.

### **No Purchase Necessary**

The Last Man Standing promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

## **Player's Menu**

### **Bureau Requirements**

#### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001156) will be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, will be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Eligible dates and times
- Prize and prize amount
- Time required to earn food
- How time will be tracked
- Any other restrictions that apply to this gaming activity.

#### **Eligible Controlled Games**

The Player's Menu will be attached to all Bureau approved games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules will be played as approved by the Bureau.

#### **Object and Summary**

The Player's Menu promotion will allow a player to eat for free or at a substantially discounted rate from a selected menu when they play for a qualifying period of time, which is tracked through a log to be maintained by 500 Club Casino. In all instances, patrons will be provided with ample advance notice of the amount of time that a player must play in order to be eligible for the Player's Menu. Furthermore, the time requirements and Player's Menu will be displayed prominently within 500 Club Casino at all times this gaming activity is being offered for play.

All players who wish to participate will be tracked by a casino representative. Once a player has played for a pre-designated and posted time period ranging from 10 minutes to 4 hours, their time will be verified and then they will be awarded with free or substantially discounted food from the Player's Menu.

#### **Eligibility Requirements**

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- There is a minimum of two players, a player and a player-dealer, required in order for players in a California game to be eligible for this promotion.
- There is a minimum of two player required in order for players in a poker game to be eligible for this promotion.
- There is no time requirement to qualify for this promotion.
- There is no limit to the number of times a player may qualify for this promotion.
- Tournament games are eligible for this promotion.
- Casino employees are eligible on/off duty and in/out of uniform.
- Backline bettors are eligible for this promotion.
- The player-dealer position is eligible for this promotion.

## **Player's Menu**

- Third Party Provider of Proposition Player Services (TPPPS), as defined in Section 19984 of the California Business and Professions Code, are eligible for this promotion.

### **Prize**

The prize will be allowing a player to eat a menu item for free or at a substantially discounted rate from a selected Player's Menu. For players that complete the time requirement, certain items on the Player's Menu with a value of \$1 to \$100 will be offered for free/or at a substantially discounted rate.

### **Funding**

The Player's Menu is funded by 500 Club Casino. There will be no additional jackpot fees or collection fees taken for this promotion. All fee collections and table limits are for the designated base games and are Bureau approved, pre-determined and posted at each table.

### **Administrative Fees**

500 Club Casino will not retain an administrative fee for this promotion as it is house funded.

### **No Purchase Necessary**

The Player's Menu does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

The Clovis 500 Club is requesting **modification** to the already approved gaming activity, California Jackpot Games, **GEGA-001439**.

### SECTION III

1. Poker Jackpot Games
2. All Poker Games and Limits approved for play at the Clovis 500 Club. All Poker games that are eligible for this jackpot will be clearly posted well in advance of the beginning of the promotion.
3. A prize is awarded to players participating in a jackpot poker game when a designated second hand is beaten by a better qualifying hand at the showdown. The winning and losing hands must use two (2) hole cards and three (3) community cards from the board. When a qualifying hand is announced, a key employee shall verify that both hands indeed qualify. The dealer, under the supervision of the key employee, at the table, in front of the players, will count down the deck of cards, verifying its integrity. If there is any deviation of that of a standard deck of cards, the jackpot win will be nullified. Video footage of the hand played will be reviewed by management to insure the integrity of game as it was played and as the jackpot was won. Poker Tournament games do not qualify for the Poker Jackpot Games promotion. Players with qualifying winning and losing hands must play through the final betting round, which is after "the river," in order to qualify for the jackpot. If a player with one of the qualifying hands folds prior to the final betting round, the table will be in-eligible for the jackpot.

In the event that during a round of play, two (2) or more players have qualifying losing or winning hands, only the player with the highest ranked losing and winning poker hands will receive the posted prize percentage of the jackpot for the losing and winning hand. The remaining player(s), including those who had lower ranked qualifying hands, will receive the posted prize percentage of the table share. However, if two (2) or more players have the same ranking winning or losing qualifying hand, they shall equally split and distribute the posted percentage of the prize amount between those players.

Only one of these qualifying hand chart options may be offered at any one time that the Poker Jackpot Game is being offered for play. They shall not be offered together at any time nor may any combination of the qualifying hand chart options be offered together at any time that this gaming activity is being offered.

Corresponding jackpot amounts for the designated options and jackpots being offered will be prominently displayed within the card room and on any flyers or advertisements to be used to promote the gaming activity.

4. Fixed prize amount
5. The gaming activity will be house funded.
6. No additional fees will be collected.
7. The fixed jackpot will have a minimum initial seeding within the following range:

California Jackpot Games Initial Seeding = \$100 minimum up to \$100,000.00 maximum.

A mini jackpot shall be offered in the amount of \$1,500 for the qualifying hand of Aces Full of Tens in Qualifying Hand Chart 1, qualifying hand of Aces Full of Jacks in Qualifying Hand Chart 2, and qualifying hand of any Aces Full House in Qualifying Hand Chart 2.

The fixed jackpot may be worth double or triple the amount displayed during certain hours of the day or during certain days, within the approved minimum and maximum prize amounts. These hours and/or days will be clearly posted within the card room and on any flyers or advertisements to be used to promote the gaming activity prior to the onset of any double or triple value being offered. When won, the posted jackpot prize shall be paid in the form of casino chips.

8. Players that make the predetermined advertised hand, as defined as one of the options in item 3 above, will be eligible to win a share of the fixed jackpot activity prize based upon a payout table being used, as described below. The certain payout table being used will be prominently displayed within the card room and on any flyers or advertisements to be used to promote the gaming activity. Only one of these payout table options may be offered at any one time that the Poker Jackpot Game is being offered for play. They shall not be offered together at any time nor may any combination of the payout table options be offered together at any time that this gaming activity is being offered.

Payout 1: Losing Hand 40%, Winning Hand 20%, Table Share 40%

Table Share = will be divided equally among the remaining players who are dealt into the game at the table where the jackpot was won.

9. Upon a jackpot being hit and paid out, a new jackpot will be re-seeded immediately at a designated amount within the prize amount range as described in section 7. The designated prize amount will be house funded. The Clovis 500 Club reserves the option to infuse amounts into the posted jackpot prize, within the approved minimum and maximum prize amounts, from time to time if it feels the jackpot amount should increase.
10. A minimum of 5 players must be dealt into the game for the table to be eligible to win the California Jackpot Game.
11. No fees will be taken by the house.
12. California Jackpot Games is offered by the Clovis 500 Club for free to all persons who wish to participate in a No Purchase Necessary game without paying any table fees or collections, or placing any live wagers. The club will provide instructional tables for all patrons who wish to play at a No Purchase Necessary game. These participants will be eligible to win the a designated portion of the posted Jackpot prize amount based on the payout option being used at the time as described in section 8 above. If less than five (5) patrons wish to play at a No Purchase Necessary game, the Clovis 500 Club will provide a dealer and deal out a minimum of five hands, one hand per patron wishing to play, with

the remainder of the required five hands to be designated as imaginary players. The No Purchase Necessary table will be available as long as a patron would like to play and will remain available at any time the Clovis 500 Club is open for business. All advertisements will state "No Purchase Necessary".

#### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GETR-000127) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- How a player may enter the tournament
- The game(s) that will be offered during the play of the tournament
- The fees that will be charged for entering the tournament, including a description for each fee charged and whether it shall be retained by the Casino, added directly into the tournament prize pool, or any other method of retention or distribution
- The amount of tournament chips that will be awarded to each player upon entry into the tournament
- The tournament prize structure that will be offered and the number of players that will be paid
- When the patron(s) will be paid and the manner in which they will be paid
- Any other restrictions that apply to the Poker Tournaments

#### **Gaming Activities Played with Tournaments**

- The rules and procedures for any and all gaming activities that are being offered in conjunctions with the Poker Tournaments
- All information related to prize ranges and amount for all gaming activities associated with the Poker Tournaments

#### **Tournament Log**

500 Club Casino shall maintain all completed tournament logs for at least seven years. These logs shall be maintained in either paper or electronic format. The Casino shall also retain and make available the most recent three months of the tournament logs for inspection by a representative of the Bureau during all hours of operation. Upon request of the Bureau, a licensee shall provide the Bureau with copies of such tournament logs. Tournament logs shall contain the following information:

- Name of gambling establishment
- Day, date, time and name advertised for the tournament
- Total number of tables used
- Name of controlled games offered
- Method of entry
- Number and amount of rebuys and/or add-ons offered
- Number of participants
- Name of each fee charged, amount of each fee charged, total number of each fee collected, and cumulative amount of collected
- Source of all funds for tournament prize pool
- Amount of the prize pool
- Amount and reason for any deductions from the total collected prize pool



## **Poker Tournaments**

- Name of gaming activities offered (when applicable)
  - Funding source
  - Prize amount
  - Total number of prizes awarded
  - Total amount deducted from prize pool (when applicable)
- Results of the tournament, including the total amount paid out and amount paid for each place in the tournament
- Printed name and signature of casino staff responsible for administering the tournament

### **Eligible Controlled Games**

The Poker Tournaments shall be attached to all Bureau approved Poker controlled games offered at 500 Club Casino at all times that the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

### **Gaming Activities Offered During Tournament Play**

#### **Bounties**

- If there is a bounty offered for the tournament; when “player x” knocks out the “advertised bounty” player(s) by ending their play in the tournament, then “player x” will be awarded their bounty.
- The bounty(s) will be paid to “player x” during the tournament or as soon as their tournament play ends; to be determined by the casino.
- The bounty amount will range from \$5 to \$5,000.
- If a bounty or bounties are advertised, the prize amount will be deducted from the total number of buy-ins, rebuy(s) and add-on(s) or the Casino will pay this prize amount and will not be reimbursed.
- If a group at the final table decides to split the prize pool among them evenly, the bounty(s) will become part of the total split.

### **Freeroll Tournament**

#### **Object and Summary**

Entry is gained via points awarded during tournament play and any predetermined and posted qualifying live play. The number of points needed to gain entry shall be displayed prior to the start of any qualifying tournament.

#### **Eligibility Requirements**

This gaming activity shall be open to all tournament players playing at any of the above listed controlled games during predetermined specified hours and posted for the gaming activity. Listed below are specific eligibility requirements:

- Players will qualify for a freeroll tournament by playing for a minimum of 1 hour in a qualifying live game. The top 10 - 100 players will be entered into the freeroll tournament, tracked with a spreadsheet maintained by the Casino.
- Players entered into the freeroll tournament will either not be required to pay an entry fee or will have their entry fee reduced.
- All procedures, times and point amounts will be displayed prominently via printed flyers, digital display, and any other forms of advertisements.

#### **Prize**

The prize pool will range from \$100 - \$100,000.

## Poker Tournaments

### Funding

The Freeroll Tournament prize pool is funded by \$1 - \$1,000 taken from the buy-in for previous tournaments. The Casino may add extra funds to the existing prize pool to increase the amount and will not be reimbursed.

### Tournament Entry

- Tournament entry is open to all customers.
- The specific structure will be on any and all advertisements and must be made available to patrons prior to the start of the tournament. The structure of a tournament will not change once sign-ups begin.
- **Promotional materials will not advertise gender-based discounts nor imply a gender-based entrance policy.**
- Patrons may enter a tournament by paying the buy-in and entry fee. All fees, prices charged, and the amount of tournament chips provided will be equal for the initial buy-in and posted for all players.
- Entry may be earned by winning a previous tournament or a Bureau approved gaming activity. All gaming activities and/or promotions shall be approved by the Bureau prior to being offered for play.
- More than one method of entry for a specific tournament may be utilized.

### Tournament Structure

Buy-in	\$1 - \$500,000
Re-buy	\$1 - \$500,000
Number of Re-Buys	0 - Unlimited
Add-Ons	\$1 - \$500,000
Number of Add-Ons	0 - 25
Entry Fee*	\$1 - \$1,000
Service Charge**	\$1 - \$1,000
Dealer Appreciation Fee***	\$1 - \$1,000

\*The Casino will retain the designated entry fee that will be income for the casino and/or to pay expenses and tips for the house dealers and staff.

\*\*Service Charge will be taken from the Entry fee and be used to cover any staffing costs or tipping shortfalls.

\*\*\*Dealer Appreciation Fee is a fee that will not become part of the prize pool. This fee is obtained for dealer cost and tips. This shall be an optional fee that tournament entrants may pay in exchange for additional tournament chips.

### Tournament Prize Amounts & Source of Funds

The prizes will be the cumulative amount of buy-ins, re-buys, and add-ons. The prizes may also be guaranteed. The Casino may provide prizes or add funds to the prize pool for special events.

- When the prize amount is guaranteed the payouts will be a cash value ranging from \$100 - \$100,000. The cash will be paid to players from the buy-ins, re-buys, and add-ons. If there is not enough cash to cover the guaranteed prize amount, 500 Club Casino will fund the difference and will not be reimbursed.
- When the prize pool is not based solely on buy-ins, re-buys and add-ons, 500 Club Casino will determine and set the payout structure.

## **Poker Tournaments**

- 500 Club Casino may also guarantee a tournament prize pool amount, ranging in value from \$1 to \$100,000 in the form of a predetermined and posted non-cash prize. In this case, the cost of the non-cash prize shall either be fully funded by 500 Club Casino or reimbursed from the player buy-ins, re-buys, and add-ons in an amount equivalent to the cash value of the non-cash prize. However, if the total of the player buy-ins, re-buys, and add-ons exceeds the value of the non-cash prize, the excess amount shall also be awarded to the winning player(s). If the total of the buy-ins plus the re-buys and add-ons (if applicable) does not equal the value of the non-cash prize, 500 Club Casino shall cover the shortfall and will not be reimbursed.

### **Tournament Prize Structure**

When the prize is not guaranteed, the prize structure will be broken down by the number of paid entries and percentage paid. The percentage paid out will always equal 100%. In the event the players decide to forgo the payout structure and “split” the total prize pool among them, it shall be permitted and shall be noted in detail on the casino’s tournament log.

Promotional prizes will be paid in the form of cash, live casino chips, extra poker tournament chips, jewelry, electronics, clothing, vehicles, watercrafts, gift certificates, sporting events, concert tickets, gift certificates, entertainment, food comps, entry into future Poker Tournaments (GETR-000127), and travel. Patrons shall be given ample notice of what prize is being offered and it shall be displayed prominently.

### **Entities Involved Other than the House**

500 Club Casino shall not allow other entities to become involved in the play of Poker Tournaments at their gambling establishment.

### **No Purchase Necessary**

The gaming activities attached to the Poker Tournaments shall be offered for free, on a general and indiscriminate basis, with no restrictions. The Casino shall provide No Purchase Necessary tables for patrons who request to participate in the gaming activities attached to the Poker Tournaments without paying any entry into the tournament. The NPN player must adhere to all rules as the tournament player. All advertisements shall state “No Purchase Necessary” when referencing the gaming activities offered during the Poker Tournaments.

## Promo Chips

### **Bureau Requirements**

#### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should 500 Club Casino advertise a different name, the BGC ID (GEAR-001154) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Eligible games
- Eligible dates and time periods
- Promo Chip coupon/voucher values
- Procedures to redeem coupon/vouchers for Promo Chips
- Any other restrictions that apply to this gaming activity.

#### **Eligible Controlled Games**

The Promo Chips gaming activity shall be attached to all Bureau approved California games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

Patrons are awarded Promo Chips via advertisements in magazines, websites, mailing advertisements, as a prize for winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament. Players who receive Promo Chips shall be eligible to win the specific amount on the chip. Promo Chips may not be exchanged for live casino chips. All applicable collection fees shall be paid when using a Promo Chip. Promo Chips may not be used to pay collection fees or jackpot fees.

The Promo Chips are used in live games exactly like live casino chips, the difference being they cannot be exchanged for cash and may only be used for base game wagers. Promo Chips shall initially be in the form of a coupon/voucher, which shall be offered to all patrons that wish to come to 500 Club Casino and use them to play. When a patron receives a Promo Chip coupon/voucher, they shall take the coupon/voucher to the cage for verification, logging, and redemption for the Promo Chip(s) to be used in a live game. Promo Chips shall be used as the player's wager on the betting circle. Promo Chips shall not be taken into the house dealer's tray, nor shall they be paid from the house dealer's tray.

- If a player uses a Promo Chip and wins the hand, the player shall receive the value of the Promo Chip in live casino chips, paid by the player-dealer. The Promo Chip is taken to the cage by a casino representative, logged and exchanged for the value listed on the chip. The live casino chips shall be brought back to the player-dealer.
- If the player who played the Promo Chip loses the hand, a casino representative shall verify the chip has been played. The Promo Chip shall then be collected by the house dealer and dropped into the drop box for accounting purposes.
- If the player pushes, meaning they receive no action on the hand, the Promo Chips may be played again until the player wins or loses the hand.

## Promo Chips

**Example:** A player receives a \$5 Promo Chip coupon/voucher to play on any California game. The player would take the coupon/voucher to the cage. Cage personnel would log the redemption code of the coupon/voucher and exchange the coupon/voucher for a promotional Promo Chip. The player would then place the \$5 Promo Chip on the gaming table, pay the posted collection fee (if applicable) and the game would play.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- Each Promo Chip coupon/voucher shall state the specific qualifying game a player may use the Promo Chip at, as well as the value of the Promo Chip that the player shall receive upon redeeming the coupon/voucher at the cage.
- Players may not exchange the Promo Chip coupon/vouchers or Promo Chips for live casino chips.
- Backline players are eligible to use a Promo Chip to place a wager.
- A player is only eligible to redeem one Promo Chip coupon/voucher during a promotional period.
- A casino representative shall track the coupon/voucher in a log.
- The Promo Chip coupon/voucher may only be used during the promotional period.
- The Promo Chip cannot be used for collection fees, bonus bets, or jackpot fees.
- Casino employees, on or off duty, in or out of uniform, are eligible for this promotion.
- Promo Chip vouchers/coupons do not expire.
- Tournament games do not qualify for this promotion.
- Patrons in the player-dealer position are not eligible to use the Promo Chip as a payout or to place a wager.
- Third-Party Providers of Proposition Players Services (TPPPS) are not eligible for this gaming activity.

### **Prize**

A Promo Chip shall have a non-cash face value ranging from \$1 to \$500 dollars.

### **Funding**

The Promo Chips gaming activity shall be fully funded by 500 Club Casino. There will be no additional promotion fees or jackpot fees taken in order to fund this gaming activity or for players to participate.

### **Administrative Fees**

500 Club Casino shall not retain an administrative fee, as this promotion is house funded.

### **No Purchase Necessary**

The Promo Chips gaming activity does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

## Raffle Giveaway

### **Bureau Requirements**

#### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should 500 Club Casino advertise a different name, the BGC ID (GEAR-001167) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Casino at all times the gaming activity is being offered for play:

- Eligible games
- Drawing dates and time
- How drawing tickets are earned
- Prize amounts and prize type
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Raffle Giveaway gaming activity shall be attached to all Bureau approved all games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The Raffle Giveaway gaming activity features a fixed prize element and awards players with the chance to earn raffle tickets based on the amount of time played in eligible controlled games. All players dealt into any of the above listed games will have the opportunity to earn drawing tickets. Tickets will be earned at a rate of two tickets for every hour of play. Hours played will be rounded down to the nearest half hour if a player is credited with partial hours. The hours played and number of tickets given to each player will be tracked on a spreadsheet by a casino representative. Tickets will be placed in a drawing drum. At predetermined times, a casino representative will draw a ticket from the drum. The ticket drawn will immediately be destroyed. The remaining tickets will stay in the drum for the duration of the promotion.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- There is a minimum of two players, a player and a player-dealer, required to be dealt into a California game in order for players to be eligible to receive drawing tickets.
- There is a minimum of two players required to be dealt into a poker game in order for players to be eligible to receive drawing tickets.
- There is no limit to the number of tickets a player may earn or the number of times a player may win a prize during a promotional period.
- Winning ticket holders must be present to win.
  - If the winning ticket holder is not present or does not claim their prize within five minutes, the posted prize amount will be added to the posted prize for the next drawing.
- Casino employees are eligible to participate in this promotion on or off duty, in or out of uniform.
- Backline bettors are not eligible for this promotion.

## Raffle Giveaway

- Tournament games do not qualify for this promotion.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible for this promotion.

### **Prize**

The prize will be a predetermined fixed amount in the form of cash, live casino chips, or merchandise which will range in value from \$10 to \$100,000. Prizes shall be predetermined and prominently posted in advance and shall remain posted for the duration of the promotion being offered for play.

### **Funding**

This promotion is fully funded by 500 Club Casino. No extra collection or jackpot fees are taken in order for players to participate.

### **Administrative Fees**

500 Club Casino shall not retain an administrative fee, as the gaming activity is house funded.

### **No Purchase Necessary**

The Raffle Giveaway gaming activity shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. 500 Club Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Raffle Giveaway gaming activity. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

# Royal Flush Jackpot

## **Bureau Requirements**

### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001164) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hand
- Jackpot prize amount
- No Purchase Necessary Opportunity
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Royal Flush Jackpot shall be attached to the following Bureau approved controlled games offered at 500 Club Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGR-002027)
- Omaha High-Low Split (GEGR-002036)

### **Object and Summary**

The Royal Flush Jackpot features a fixed jackpot prize, which is awarded to players participating in a qualifying poker game when a Royal Flush in any suit is achieved. All prizes will be paid in the form of live casino chips.

### **Qualifying Hands**

The Royal Flush Jackpot prize shall be awarded to a player who achieves a qualifying hand as shown below while dealt into a qualifying poker game.

<b>Qualifying Hand</b>	<b>Prize</b>
Royal Flush (any suit)	\$20-\$200,000

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- There is a minimum of five players required to be dealt in during an eligible game in order for players to be eligible for the jackpot.
- The qualifying hand must use two hole cards and three community cards from the board to qualify.
- In order to qualify for the promotion, both players must complete all applicable bets. If the player goes all-in, this is considered to have completed all bets.
- When a qualifying hand is announced, a casino representative shall verify that the hand qualifies. Any deviation from a standard deck will nullify the jackpot.



## Royal Flush Jackpot

- There is no limit to the number of times a player may win a prize in any give promotional period.
- Tournament games do not qualify for this gaming activity.
- Casino employees are eligible to participate is this gaming activity on or off duty and in or out of uniform.

### **Prize**

The prize will be a fixed amount ranging from \$20-\$200,000 in the form of live casino chips. The prize will be paid to the player at the table from the cage by a casino representative once the hand has been verified by a casino representative. Furthermore, the jackpot prize amount shall be displayed prominently within 500 Club Casino at all times the jackpot is being offered for play.

### **Funding**

This gaming activity is fully funded by 500 Club Casino. At no time will any fees be collected from the players for the purpose of funding the gaming activity.

### **Administrative Fees**

500 Club Casino shall not retain any administrative fee, as this gaming activity is house funded.

### **No Purchase Necessary**

The Royal Flush Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Royal Flush Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

# Splash Pot

## **Bureau Requirements**

### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should 500 Club Casino advertise a different name, the BGC ID (GEAR-001165) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Eligible games
- Eligible time period(s)
- Method used to splash the pot
- All specific qualifying conditions
- Availability of No Purchase Necessary
- Amount to be added to the pot (prize amount)
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Splash Pot gaming activity shall be attached to all Bureau approved Poker games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

### **Object and Summary**

The Splash Pot gaming activity features a house-funded promotional element which shall be attached to the above listed approved controlled games at 500 Club Casino. During predetermined times and intervals of the promotional period, a casino representative shall use a lucky table method to “splash the pot” by adding a predetermined and posted prize to the pot at the start of the hand.

The qualifying times for the promotion will be determined by one of two methods:

- Option 1- The prize will be added to the pot at designated times and days which will be clearly specified and announced to the players beforehand.
- Option 2- The prize will be added to the pot when certain qualifying events occur, such as when a score is made during a televised sporting event being shown at 500 Club Casino.

After qualifying time is determined and announced, a lucky table method will be used to determine the table that receives the “Splash Pot.” The method for determining which table will receive the posted Splash Pot prize involves a drawing where a bin, basket, or other non-electronic randomizer shall be used. The cards, balls or other lammer which are pre-printed, equally sized and colored, shall be mixed within the randomizer. During predetermined times and intervals of the promotional period, a casino representative shall announce the commencement of the drawing. A casino representative shall then select an eligible table by randomly choosing a card, ball or other lammer from the randomizer. Each card or ball shall depict a number that corresponds to each eligible poker table.

## Splash Pot

Betting procedures and play shall proceed as normal. The player with the winning hand shall win the pot, including the added prize amount. In the event of a tie, the winning players shall split the pot evenly. The regular pot shall be split according to standard poker rules.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- A minimum of five players must be dealt into the game in order to qualify for the promotion. A table without five players will not be represented by a card, ball or other lammer when the table selection occurs.
- There is no minimum amount of time played required for a table to qualify for this promotion.
- In the event that two or more players tie, the pot shall be evenly distributed between each player with the winning hand. If the prize is a non-cash prize it will be doubled, and each player shall receive a prize of equal value.
- In order to qualify for the gaming activity, the player must complete the applicable bets on each round. If the player goes all-in, this is considered to have completed all bets.
- There is no limit to the amount of times a player may win a prize during any given promotional period.
- One or more tables may be selected at each drawing. The number of tables to receive prizes will be clearly posted.
- When an eligible table is drawn, the card, ball, or other lammer will be placed back into the bin, basket, or lottery ball machine with the availability to be drawn again.
- Casino employees are eligible for this promotion when on or off duty, in or out of uniform.
- Tournament games do not qualify for the promotion.

### **Prize**

The Splash Pot gaming activity features a fixed prize amount ranging from \$1 to \$10,000. The prize shall be paid in the form of live casino chips, merchandise, event tickets, or gift certificates.

### **Funding**

This promotion will be fully funded by the 500 Club Casino. Therefore, there shall be no additional jackpot fees or collection fees taken for this promotion.

### **Administrative Fees**

500 Club Casino shall not retain an administrative fee as this promotion is house funded

### **No Purchase Necessary**

The Splash Pot gaming activity shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. 500 Club Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Splash Pot gaming activity. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

# Sports Giveaway

## Bureau Requirements

### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001166) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Prize amount or item and corresponding point during the sports game that it shall be awarded
- Eligible controlled games and time periods
- Schedule of when prizes shall be awarded including if a sports game goes beyond its normal stopping point
- Amount of time required to be played and qualifying hands in order to earn a square
- Number of squares awarded based on time played and per qualifying hand
- Any No Purchase Necessary opportunity
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Sports Giveaway shall be attached to all Bureau approved poker games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

### **Object and Summary**

During a predetermined and posted sporting event, 500 Club Casino shall allow “live” poker players, who have played at least one hour or have made a predetermined qualifying hand, to put their name in a blank square on a board for the Sports Giveaway promotion. Each player’s hours shall be tracked by a casino representative on a computer log in system. The board shall have 100 squares (10 squares by 10 squares), as shown below. Numbers shall be drawn to determine the numbers assigned to each column and row. Numbers 0 through 9 shall be randomly drawn by a casino representative. The numbers shall be selected approximately five minutes before the sporting event. The home team shall be represented on the top row of the diagram and the visiting team down the left side of the diagram. The assignment of the numbers shall correspond with the home team from left to right and the visiting team from top to bottom.

## Sports Giveaway

Squares are issued on a first come, first serve basis. One square per person shall be chosen by the player once a player has earned it. Players can qualify to receive more than one square by playing more hours or achieving a qualifying hand multiple times. The numbers on the board shall correspond to the score of the game. The numbers assigned to each square are determined by the point where each vertical and horizontal line intersects on the board. ### Funding

The Fortune Pai Gow Poker Progressive Jackpot is a player-funded progressive jackpot which features both progressive and fixed prizes.

The Casino will initially seed the jackpot in an amount between \$1,000 and \$50,000. Once there are sufficient monies in the Fortune Pai Gow Poker Progressive Jackpot reserve fund, the initial seed will be reimbursed to the Casino and shall be documented in the accounting records. - Third-Party Providers of Proposition Player Services (TPPPS) are not eligible to place a jackpot collection fee and become eligible for the Ultimate Texas Hold'em Progressive gaming activity when in the player-dealer or player position.

### Prize

The Ultimate Texas Hold'em Progressive Jackpot features progressive and fixed elements. A Royal Flush is paid 100% of the progressive jackpot amount shown on the progressive meter. All other hands are paid from the reserve fund, they do not get deducted from the amount shown on the meter. In the event the reserve fund is depleted, the Casino will make up any shortfall and will be reimbursed once there are sufficient monies in the jackpot fund. All prizes are paid out immediately in the form of cash.

- In the event more than one progressive meter pay (at different tables) or any other qualifying hand hits during the same round, all winning players will be paid the posted progressive prize or the posted fixed amount.



## Ultimate Texas Hold'em Progressive Jackpot

- When more than one progressive meter pay hits (at different tables), one progressive pay will be paid from the meter and the others will be paid from the reserve fund.
- In the event the reserve fund is depleted, the Casino will make up any shortfall and will be reimbursed once there are sufficient monies in the jackpot fund. All hands will be paid 100% of the posted prize.

### **Funding**

The Ultimate Texas Hold'em Progressive Jackpot is a player-funded jackpot featuring progressive and fixed elements. The Casino will initially seed the jackpot at an amount between \$1,000 and \$50,000. Once there are sufficient monies in the Ultimate Texas Hold'em Progressive Jackpot reserve fund, the initial amount will be reimbursed to the Casino and shall be documented in the accounting records. After the progressive jackpot is hit, it will be re-seeded by the reserve fund in an amount between \$1,000 and \$50,000. In the event the reserve fund cannot cover the re-seed, the Casino will re-seed the jackpot and will be reimbursed for the amount of the re-seed once there are sufficient monies in the reserve fund. The progressive prize pool shall increase based solely on the number of jackpot collection fees placed and collected. The Casino will not provide any additional funds to the jackpot other than the initial seed or re-seed amounts. There is no cap on this progressive prize pool.

Each \$1 jackpot fee paid by a player will be broken down as follows:

- \$0.31 will be immediately posted to the meter.
- \$0.69 will be tracked in a reserve fund. The reserve fund will be used to payout all fixed prize amounts, re-seed the metered progressive jackpot prize between \$1,000 and \$50,000, and pay administrative fees.

### **Administrative Fees**

500 Club Casino shall retain an administrative fee of \$12-\$16 per table per hour from the jackpot reserve fund. The administrative fee shall be utilized to cover expenses incurred by the gambling establishment for administering the Ultimate Texas Hold'em Progressive Jackpot.

### **No Purchase Necessary**

The Ultimate Texas Hold'em Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Ultimate Texas Hold'em Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### **Equipment**

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

1. When a player has a progressive winner, the dealer shall press the appropriate hand button on the keypad.
2. The house dealer shall then contact a casino representative.

## Ultimate Texas Hold'em Progressive Jackpot

3. Once the casino verifies the progressive win, the casino representative shall insert the key, rotate it to "JPH," and then press "J-pot" button. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
4. Returning the key to the "Run" position will restore normal operation of the table, and adjust the meter appropriately for the prize won.
5. When the house dealer reconciles all action (on behalf of the player-dealer), they press "Game Over." This resets the system to begin the next hand.
6. Once the "J-pot" button is pressed, the prize is logged into Game Manager.

In all instances, patrons shall be provided with ample advance notice of the posted promotional prize.

### **Qualifying Hands**

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- The prize shall be awarded to a player when he or she has made the pre-determined and designated winning qualifying hand(s) during the pre-determined and specified promotional period.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be conspicuously and prominently displayed in 500 Club Casino at all times that the gaming activity is being offered for play:

- Eligible games, dates and time periods.
- Qualifying hands and their corresponding progressive and fixed prize amounts.
- Amount of jackpot collection fees.
- No Purchase Necessary information.
- Any other restrictions that apply to this gaming activity.

#### **Eligible Controlled Games**

The G3 Buster Blackjack Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at 500 Club Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

#### **Object and Summary**

With the G3 Buster Blackjack Progressive Jackpot, a player that wishes to be eligible for the jackpot will provide the house dealer with live casino chips or cash not to exceed \$100.00. This prepaid money will be credited to the individual meter in front of that player's seated position. A \$1.00 jackpot fee is equal to one credit on the player's bankroll meter and when a player chooses to participate to the Jackpot Game, \$1.00 jackpot fee will be deducted from the player's bankroll meter.

- The G3 features an XML file that contains various options that can be activated or not. The XML file can only be access and modified by DEQ. This XML file is mandatory for the G3 to run, and cannot be modified manually as it is encrypted using a very secure algorithm. The mystery prize options, like the Lucky Dealer, Lucky Player, and Magic Card prizes, will be deactivated by an entry in our encrypted XML file. This can only be done by DEQ, and will be part of all software setups for the card rooms. No other prizes will be awarded to any player with the exception of pay chart set forth below.
- Additionally, the Prepaid Players' Jackpot Game Aide System does not use any Random Number Generator (RNG) in its operation.

The jackpot game aide system adds a player funded progressive jackpot element to a Blackjack style game played in California Card rooms. The base Blackjack style game that this jackpot will be appended to must be approved by the Bureau to be eligible to add the Buster Blackjack Progressive.

### **G3 Buster Blackjack Progressive Jackpot**

1. To begin each round, players must make their regular base game wager. They may optionally place a jackpot fee of \$1.00 or one credit (1 credit = \$1.00) on their own hand. To limit the fee to \$1.00, DEQ will program the software so that the fee amount can only be \$1.00 by specifying it in the secure setup of the system. This can only be done by DEQ, and will be part of all software setups for the California card rooms.
2. A G3 Progressive Jackpot Tracking Bet Manager (see Figure 2 in Appendix 1) is installed on the table in front of each betting position.
  - a. Each player has the option to pay the house dealer any amount not exceeding \$100 to have credits placed on his/her bankroll meter.
  - b. Once the meter shows the credits, the player may choose when to participate to the Jackpot Game by pressing the “Player” button on the Jackpot Tracking Bet Manager.
3. Once all players have placed their base game wager and jackpot fee, the house dealer will press “Start” on the Dealer Interface (see Figure 3 in Appendix 1). This will light up the G3 Progressive Jackpot Tracking Bet Manager, indicating participation in the progressive jackpot and will lock them until the dealer presses the “Stop” button. The appropriate amount of money gathered will also be sent to the G3 Progressive Jackpot Tracking LCD meter sign (see Figure 5 in Appendix 1).
4. The house dealer then follows standard approved procedures for dealing the base games, as listed above. After all players and the player-dealer have been dealt their hands, the play of the base games continues per the approved rules of the game.
  - a. A qualifying hand refers to the combination of the player-dealer’s cards. To be eligible to win on the G3 Buster Blackjack Progressive Jackpot, the player-dealer must receive a final score of more than 21 (a “busted hand”). The amount won on the gaming activity will be based on the number of cards in the player-dealer’s busted hand. The amount won will increase with the total number of cards in the player/dealer’s busted hand.

#### **Qualifying Hands**

Players that make one of the advertised qualifying hands, as shown below, will be eligible to win their share of the posted prize amount, according to the payout options, as shown below. All qualifying hands must be offered together at all times this gaming activity is offered for play.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Only players that have placed the \$1.00 jackpot collection fee are eligible for a G3 Buster Blackjack G3 Progressive Jackpot payout.
- Only players seated at the table are eligible to win. Backline bettors are not eligible to place a jackpot collection fee, nor receive the prize amount for a qualifying hand.

## **G3 Buster Blackjack Progressive Jackpot**

- A minimum of two players, a player and a player-dealer, must be dealt into the game in order for the table to qualify for the G3 Buster Blackjack G3 Progressive Jackpot gaming activity.
- A player is eligible for a G3 Buster Blackjack G3 Progressive Jackpot prize payout regardless of whether their hand wins, loses, or ties with the player-dealer's for the controlled game.
- A Third-Party Provider of Proposition Player Services (TPPPS) is not eligible to place a jackpot collection fee and become eligible for the G3 Buster Blackjack G3 Progressive Jackpot gaming activity.
- Casino employees are not eligible to participate in the G3 Buster Blackjack G3 Progressive Jackpot while in uniform.
- If the house dealer enters the wrong information, authorized personnel must resolve the situation using the Game Server features (see Figure 6 in Appendix 1).
- If the house dealer makes a mistake while dealing the cards, he should declare the hand a misdeal, and re-deal the cards. Caution: the dealer must not press STOP. Each player's optional jackpot fee will remain the same during the re-dealt hand.

### **Prizes**

Once the proper paperwork has been filled out and the hands have been verified, a casino representative will pay the winners in live casino chips. All monies collected and paid out shall be tracked both electronically and on a hand written log to be maintained by the Casino for examination by regulatory and law enforcement personnel.

### **Fixed Prize**

- All fixed prizes can be paid directly to the winning players.
- All fixed payouts will be deducted from the reserve fund.
- All fixed prizes at a table will be paid first and all progressive prizes will be paid after all fixed prizes have been paid.
- All fixed payouts will be paid by a casino representative. Once the proper verification has been done (in accordance with the casino internal controls), the casino representative will pay the fixed win(s) into the player's personal bet manager.

### **Progressive Prize**

- A hand where the player-dealer gets a final score of more than 21 by using eight (8) or more cards is paid 100% of the progressive jackpot amount shown on the progressive meter.
- In the event that more than one player qualifies for the progressive prize during the same round, the posted prize will be split equally among those that qualified for a payout.
- Once the casino verifies a progressive win, the authorized personnel (i.e. supervisor or manager) shall perform the appropriate payment procedure.
- In the case of multiple eligible tables, winners are paid in the order in which the wins occur.
- At the end of the hand, the dealer presses "STOP." This unlocks the G3 Progressive Jackpot Tracking Bet Managers so the next hand may begin.



## **G3 Buster Blackjack Progressive Jackpot**

### **Funding**

The G3 Buster Blackjack Progressive Jackpot is a player funded jackpot which features fixed and progressive prize elements. The Casino will initially seed the jackpot at a minimum of \$1000. Once there are sufficient monies in the G3 Buster Blackjack Progressive jackpot reserve fund, the initial seed will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. There shall be a cap of \$500,000 for the progressive prize pool. Any monies collected after the cap has been reached shall go into the reserve fund. After the progressive jackpot is hit, it will be reseeded by the reserve fund at a minimum of \$1000. In the event the reserve fund does not have enough to cover the seed amount, the Casino will make up any shortfall. The Casino will be reimbursed from the reserve fund once monies are available.

Each jackpot fee paid by a player will be broken down as follows:

- \$0.80 will be immediately posted on the meter.
- \$0.20 will be tracked in a reserve fund. The reserve fund will be utilized to immediately reseed the metered progressive jackpot prize.

Each player has the option to pay the house dealer any amount not exceeding \$100 to have credits placed on their bankroll meter. All monies paid toward credits on the bankroll meter will be dropped into a separate and locked drop box specifically designated for jackpot collection fees. If a player decides to leave the table and still has money on their bankroll meter, the house dealer will call over a casino representative and have a receipt printed out for the amount cashed out. The receipt will be kept by the casino representative for reconciliation purposes at the end of their shift. The casino representative will then reimburse the player in live casino chips for the amount shown on that player's bankroll meter which will match the amount on the printed receipt.

### **Administrative Fees**

500 Club Casino shall retain an administrative fee of \$16 to \$30 per table per hour from each jackpot collection fee placed and collected. The administrative fee shall be utilized to cover expenses incurred by the Casino for administering the G3 Buster Blackjack G3 Progressive Jackpot gaming activity.

### **No Purchase Necessary**

The G3 Buster Blackjack Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the G3 Buster Blackjack Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

## G3 Buster Blackjack Progressive Jackpot

### Equipment

#### GLI Certification

The G3 System hardware and software related to and used in conjunction with this gaming activity, which is used on each eligible 21st Century Blackjack 9.0 table for this gaming activity, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

#### **Appendix 1: G3 Progressive Jackpot Tracking System components**

The current section presents the important components of the G3 Progressive Jackpot Tracking Systems. The system is mainly composed of these visible components: The Personal Bet Managers, A Dealer Interface and a double-sided LCD screen.

#### **A. Personal Bet Manager**

Located in front of each betting spots, the personal bet managers are the interfaces used by the players to place their side wager. The player buys credits from the dealer and once they are available in his credit bank, he can place a bet using the dealer hand button.

### B. Dealer Interface

This device is used by the dealer to operate the system. The house dealer can buy and sell credits to players and manage the course of the game. When a prize is awarded to a player, a supervisor or a manager can login on the system using a key on the dealer interface and proceed with the payment.

The dealer interface is installed on a metal support fixed to the table as shown in Figure 4.

### C. The LCD Screen

Located on one side of the table, the screen displays a graphical animation showing all the important information related to the game, the payout schedule, the various transactions being performed and the live jackpot value.

The system is also composed of other components that are not visible to the players but are required for the system to operate: The G3 Table Controller and The G3 Game Server.

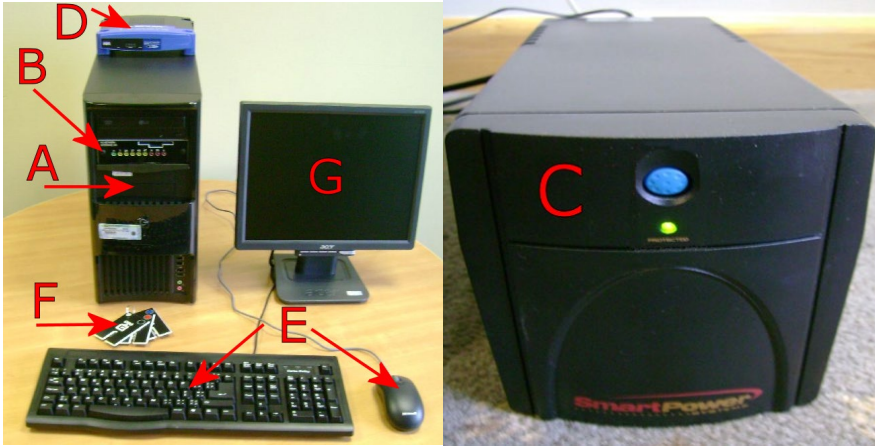
## G3 Buster Blackjack Progressive Jackpot

### D. G3 Game Server

The server is the central component of the G3 System. It performs the following tasks:

- Configures and maintain the various options for all clients (tables).
- Maintain the Progressive Jackpot value and communicate it to all clients (tables).
- Maintain the database of all the system on a RAID configuration.
- Generate the various reports for all system components.

- G- A 15" LCD screen

### E. G3 Table Controller

Installed under each table where the G3 system is running, the device controls all hardware and software components (PBM, TD, DI) at the table level. This computer communicates with the G3 Game Server through an Ethernet (TCP-IP) connection.

## **Player Rewards Card**

### **Bureau Requirements**

#### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001349) will be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, will be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- How and where to sign up for the Player Rewards Card
- Required amount of time to be played and corresponding points earned
- The date(s) and time(s) the activity shall be offered
- Eligible games and betting limits
- All prizes offered and specific amount of points required for each prize
- The time frame in which the points earned are valid
- When the bonus prize(s) will be offered throughout the promotion
- When the Sign-Up Bonus will be offered throughout the promotion and the amount of points to be awarded
- Fee for replacement card
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Players Rewards Card may be attached to all Bureau approved games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The Players Rewards Card is a loyalty reward program open to all 500 Club Casino patrons. Players who sign up for the loyalty reward program will be assigned a Player Rewards Card which will reward players with points based on the amount of time the player participates in designated games during predetermined and posted time periods ranging from 10 minutes to 90 days.

#### **Player's Card Computer System Description**

The player's card shall include the casino name, some descriptive language regarding restrictions for the card, and the problem gambling phone number. The card shall include a unique identifier such as a numeric code, bar code or magnetic strip. The card may take the form of a physical card or an electronic version accessible from a mobile device.

- Players will receive a player's card if they sign up for the Player Rewards Program at the cage cashier or other designated area.
  - Players may sign up and receive a player's card at any time.

## Player Rewards Card

- Player information shall be maintained in a secure database accessible only by casino management. Access to the database shall also be tracked by casino management.
  - No one except the network administrator(s) shall have access to the back-end systems where the data is stored.
  - Access to the data is limited by permissions based on the user's work needs.
  - Marketing managers will have access to customer data for marketing purposes.
- The card shall be non-transferable and may only be used by the player to whom the card is assigned.
- If the player's card is lost or stolen, they can ask a casino representative for a replacement.
  - The first replacement will be free of charge. If within three months of a replacement the player needs another replacement, there will be a \$5 charge for that replacement.
    - After three months the replacement will be free. The three month time frame is reset after every replacement.
  - Players who do not have their physical card may have a casino representative look them up on the system to participate in the promotions that require a Player Rewards Card.
- A computer device, with a barcode reader or other device such as a magnetic strip or RFID reader, will be affixed to the gaming table or casino podium.
- Player's will track their time by having their cards scanned, which will cause their time to be automatically recorded by a computer or similar device at the table or by having a casino representative manually scan or enter the card information into the computer device.
- The casino representative may also input the player's time played into the computer device manually.
- A printable record of the amount of time a player has accumulated during the promotional period shall be available upon request by the player.
- If the Player's Card Computer System should stop working during the promotion, the Casino may either pause, discontinue, or manually track the promotion.

### How Points are Earned Based on Time Played

Points shall be earned based on the amount of time played. Each player who plays at a predetermined and posted eligible game and has their time of play recorded will earn points based on time played. The points can be redeemed for prizes during or at the end of a predetermined and posted promotional period. The range of points per hour played will range from 1 to 200,000. During predetermined and posted times, bonus rates may be offered by the Casino (for example, double points may offered during off-peak hours).

*Example: A player signs up for the Players Rewards Card at the cashier and receives a player's card. The player presents the card to a casino representative at the gaming table. The casino representative enters the player into the tracking software and will input the type of game limit played. At the end of the gaming session, the player will be logged out by the casino representative. The tracking software tabulates the amount of points the player earned based on time played and adds it to the player's account. The player may check their point balance and redeem points with a casino representative at any time during the promotion.*

## Player Rewards Card

### How Player Rewards Points are Redeemed

Players may redeem points for prizes at any time during the promotion or at the end of the promotional period. All prizes shall have a predetermined and designated value. Points shall be earned based on the amount of time played during the promotional period. After a player has accumulated a predetermined and specific amount of points, a player may redeem the accrued points for a predetermined and designated prize. When predetermined and posted, points may also be redeemed for money in these cases 1 point will be worth \$0.01 to \$100.

- Players may be eligible for multiple prize(s) throughout the promotion.
- Players may redeem their points for multiple prizes so long as the total amount of points required for all prizes is within the player's point balance.
- As points are redeemed, they will be deducted from the player's point balance.
- Points are non-transferable and may only be redeemed by the player who earned them.
- Points may be redeemed at any point during or at the end of the posted promotional period. Points that are not redeemed at the end of the promotional period will expire within 180 days.
- All reward points are subject to review and verification. The Casino reserves the right to adjust balances or void points due to any confirmed error or fraud.
- A player may check their point balance with a casino representative at any time during the promotion.

### Eligibility Requirements

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- Players must be 21 or older and provide a valid ID to sign up for a player's card.
- In order for a poker game to qualify for this promotion, there must be a minimum of two players dealt into the game.
- The Casino may choose to limit the promotion to an eligible game and betting limit, as long as it's predetermined and posted.
- In order for a California game to qualify for this promotion, there must be a minimum of two players, a player and a player-dealer, dealt in to the game.
- Backline bettors are eligible for this promotion.
- Casino employees are eligible for this promotion while off duty and out of uniform.
- On-duty proposition players are eligible for this promotion.
- Third Party Proposition Players are only eligible to participate in this promotion when off duty and while playing Poker games.
- A patron who assumes the player-dealer position will not be logged out of the system and shall continue to have their time tracked.
- Time spent participating in Tournaments will not earn the player points towards this promotion; however, if written in to the approved rules of a tournament, using the Player Rewards Card to sign up for a Tournament may earn a player bonus points.



## **Player Rewards Card**

### **Prize**

The prize shall be a fixed value amount ranging from \$1 to \$100,000. Prizes include cash, live casino chips, coupons for the Match Play Promotion (GEAR-001159), vehicles, promotional merchandise, food, and entry into Poker Tournaments (GETR-000127).

### **Bonus Prize**

The Casino may also offer a Bonus Prize. When offered, players who reach a predetermined and posted point level will qualify for a Bonus Prize. The Bonus Prize shall be a fixed value amount ranging from \$1 to \$100,000. Prizes include live casino chips, jewelry, electronics, and vehicles.

### **Sign Up Bonus**

When predetermined and posted, the Casino may offer a fixed amount of points to players who are signing up for the Player Rewards Card for the first time. These additional points will range from 1 to 2,000.

All prizes for this promotion will be predetermined and posted in advance throughout the gaming floor, and in all literature promoting such event.

### **Funding**

The Players Rewards Card shall be fully funded by 500 Club Casino. No additional fees of any kind shall be taken for this promotion.

### **Administrative Fees**

500 Club Casino shall not retain any administrative fee as this promotion is house-funded.

### **No Purchase Necessary**

The Players Rewards Card does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary Table to be offered while conducting this gaming activity.

# Spin the Wheel

## **Bureau Requirements**

### **Advertising**

The 500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001344) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Drawing dates and times
- Eligible games and time periods
- Requirement of Player Rewards Card (GEAR-001349)
- Amount of spaces that will be on the wheel
- Prizes that shall be available to win by spinning the wheel
- Selected option and procedures for players to earn a chance to spin the wheel
- If applicable, the qualifying hand chart
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Spin the Wheel shall be attached to the following Bureau approved controlled games offered at 500 Club Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGR-002027)

- Ultimate Texas Hold'em (GEGR-002041)

### **Object and Summary**

The Spin the Wheel promotion awards players with the opportunity to spin the prize wheel and win prizes ranging from \$10 to \$500,000. The prize wheel will have a predetermined and posted amount of spots ranging from 6 to 100 spots. Each spot will represent a possible prize.

When offering the Spin the Wheel promotion, the casino will have two options on how players may earn the opportunity to spin the wheel. The selected option will be predetermined and posted. The two options are:

## Spin the Wheel

### High Card Selection Option

When this option is selected the procedures are as follows:

- All tables offering the predetermined and posted eligible game(s) will be assigned a table number between one and thirteen.
  - Before offering the promotion the casino will make sure that there are no more than thirteen tables offering the eligible game(s).
- Using a standard deck of cards, a casino representative will create a deck of cards, which only contains cards that represent the table numbers of all of the tables offering the eligible game(s).
  - Ace will represent table one;
  - All numbered cards will represent the table with the corresponding number;
  - Jack will represent table eleven;
  - Queen will represent table twelve;
  - King will represent table thirteen.
- At a predetermined and posted time a casino representative will take a pre-shuffled deck of cards and select a card.
  - Before the cards are shuffled, a casino representative will take this deck of cards and remove the cards that correspond to tables that are not eligible for the Spin the Wheel promotion.
    - Tables that are not offering the eligible game or who do not have the minimum amount of players, will not be eligible for the promotion.
- A casino representative will go to the selected table with a pre-shuffled standard deck of cards.
- The cards will then be spread, face down, on the table.
- Each active player at the table, will select a card.
- The player with the highest ranked card will spin the wheel.
  - The rank of each card, in order of highest to lowest, will be ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3, and 2.
  - The suit raking, in order of highest to lowest, will be spades, hearts, diamonds, and clubs.
- The winning player will be given the opportunity to spin the wheel at the completion of their hand.

### Qualifying Hand Option

When this option is selected the procedures are as follows:

- Players will participate in an eligible game.
- If a player is dealt a qualifying hand, as listed below;
- A casino representative will verify the hand.
- The winning player will be given the opportunity to spin the wheel at the completion of their hand.

### Qualifying Hands

A player that makes a qualifying hand, as listed below, shall be eligible to win the opportunity to spin the wheel for the opportunity to win a prize. Qualifying hands in poker games must include all hole cards. Only one of the three qualifying hand charts may be offered at any one time. All qualifying hands within a chart must be offered together at all times.

### **Administrative Fees**

The Casino will not retain any administrative fee, as this promotion is house funded.

### **No Purchase Necessary**

The Spin the Wheel shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. **All advertisement material shall state "No Purchase Necessary" when referencing the Spin the Wheel. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.**

# Drawing Promotion

## **Bureau Requirements**

500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001345) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Procedures and requirements for earning drawing tickets
- Requirement of Player Rewards Card (GEAR-001349)
- Number of tickets that will be awarded
- Drawing dates and times
- Procedures and requirements for drawing
- Prizes that will be available to win for each drawing
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Drawing Promotion shall be attached to all Bureau approved games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

### **Object and Summary**

The Drawing Promotion awards players with 1 to 1,000 tickets which are used to enter a drawing, where the player can win fixed prizes ranging in value from \$10 to \$100,000.

There are two different ways in which a player may earn tickets:

- Qualifying Hours – during a predetermined time period a player may earn a predetermined amount of tickets per hour.  
*Example: On May 5, 2025 from 6 AM to midnight players who play a poker game will win the three tickets per hour.*
  - The amount of time played will be tracked through the Player Rewards Card (GEAR-001349).
- Wheel Spin – at a predetermined day and time a casino representative will spin a wheel and award a predetermined amount of tickets to the player seated in the corresponding seat of the spot the wheel lands on.
  - The wheel will have a spot for every seat in the casino.
  - If the wheel lands on an unoccupied seat the wheel will be spun again until it lands on an occupied seat.
  - The wheel needs to complete three rotations in order for the spin to count.
    - If the wheel does not complete three rotations the wheel will be spun again.
  - The pointer must come to rest between two of the pegs.
    - If the pointer stops upon one of the pegs the wheel will be spun again.

## Drawing Promotion

Once a player has earned a ticket(s) the following will occur:

- A casino representative will verify that the player qualifies for the promotion and will award the ticket(s).
- The player will receive a standard raffle ticket(s) that will be divided into two sections; one section for the player and one section for the Casino.
- The player will fill out the casino section of the ticket(s) with their first name, last name, and phone number.
- The player will then hand the casino portion of the ticket(s) to the casino representative.
- The ticket(s) will then be placed in a barrel or other non-electronic randomizer.
- All tickets will be the same color and size.

- There is no minimum amount of time a player is required to play in order to qualify for this promotion.
- There is no minimum or maximum number of active players required at a table in order for the table to be eligible to earn drawing tickets.
- Backline bettors are not eligible for this promotion.
- To be eligible for the promotion players must have a Player Rewards Card.
- There is no limit to the amount of tickets a player may earn for this promotion.
- There is no limit to the amount of prizes a player may win during the promotional period.
- Tickets are non-transferrable and can only be used by the player who earned them.
- The winning player will have their I.D. checked by a casino representative.
- Players must be present for the drawing in order to win the posted prize(s).
- Players must claim prize within five minutes.
  - If the prize is not claimed within five minutes the prize will be rolled over to the next drawing. Unless it is the last scheduled drawing; in this case the casino will pull tickets until there is a winner.
- Casino employees are eligible to participate in this activity when off duty and out of uniform.
- Third-Party Proposition Players shall not be eligible to participate in this promotion.
- Players participating in tournaments will be eligible to earn drawing tickets and win a drawing prize.

The Casino will not retain any administrative fee, as this promotion is house funded.

### **No Purchase Necessary**

The Drawing Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Drawing Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

## EZ Baccarat Panda 8 G3 Progressive Jackpot

### **Bureau Requirements**

500 Club Casino may advertise various names for this gaming activity. Should 500 Club Casino advertise a different name, the BGC ID (GEAR-001343) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times that the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands and their corresponding progressive and fixed prize amounts
- Amount of jackpot collection fees
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The EZ Baccarat Panda 8 G3 Progressive Jackpot gaming activity shall be attached to the following Bureau approved controlled games offered at 500 Club Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- EZ Baccarat Panda 8 (BGC ID: GEGR-002039)

#### **Object and Summary**

With the EZ Baccarat Panda 8 G3 Progressive Jackpot, a player that wishes to be eligible for the jackpot will provide the house dealer with live casino chips or cash not to exceed \$100. This prepaid money will be credited to the individual meter in front of that player's seated position. A \$1 jackpot fee is equal to one credit on the player's bankroll meter and when a player chooses to participate to the Jackpot Game, \$1 jackpot fee will be deducted from the player's bankroll meter.

- The G3 features an XML file that contains various options that can be activated or not. The XML file can only be access and modified by DEQ. This XML file is mandatory for the G3 to run, and cannot be modified manually as it is encrypted using a very secure algorithm. The mystery prize options, like the Lucky Dealer, Lucky Player, and Magic Card prizes, will be deactivated by an entry in our encrypted XML file. This can only be done by DEQ, and will be part of all software setups for the card rooms. No other prizes will be awarded to any player with the exception of pay chart set forth below.
- Additionally, the Prepaid Players' Jackpot Game Aide System does not use any Random Number Generator (RNG) in its operation.

The jackpot game aide system adds a player funded progressive jackpot element to the game of EZ Baccarat played in California Card rooms. The base game of EZ Baccarat that this jackpot will be appended to must be approved by the Bureau to be eligible to add the G3 progressive jackpot.

## EZ Baccarat Panda 8 G3 Progressive Jackpot

1. To begin each round, players must make their regular base game wager. They may optionally place a jackpot fee of \$1 (1 credit = \$1) on their own hand. To limit the value of 1 credit to \$1, DEQ will program the software so that the credit amount can only be \$1 by specifying it in the secure setup of the system. This can only be done by DEQ, and will be part of all software setups for the California card rooms.
2. A G3 Progressive Jackpot Tracking Bet Manager (see Figure 2 in Appendix 1) is installed on the table in front of each betting position.
  - a. Each player has the option to pay the house dealer any amount not exceeding \$100 to have credits placed on their bankroll meter.
  - b. Once the meter shows the credits, the player may choose when to participate in the Jackpot Game by pressing the “Player” button on the Jackpot Tracking Bet Manager.
3. Once all players have placed their base game wager and jackpot fee, the house dealer will press “Start” on the Dealer Interface (see Figure 3 in Appendix 1). This will light up the G3 Progressive Jackpot Tracking Bet Manager, indicating participation in the progressive jackpot and will lock them until the house dealer presses the “Stop” button. The appropriate amount of money gathered will also be sent to the G3 Progressive Jackpot Tracking LCD meter sign (see Figure 5 in Appendix 1).
4. The house dealer then follows standard approved procedures for dealing the base game. Then, if the round results in a Dragon 7 or a Panda 8 hand, the Dealer will resolve the progressive wagers according to the pay table below. A Dragon 7 hand is when a Banker’s point count equals 7 with a total of three cards and Player’s point count is lower than 7. In the case where Player’s point count equals 8 with a total of three cards and Banker’s point count is lower than 8, the house dealer declares the hand a “Panda 8”.
5. If the cards dealt during the round result in a winning hand for the optional progressive wagers, the electronic Baccarat shoe (Hawk, Angel and Bee shoes) and G3 system will automatically recognize the winning hand and the system will ask for the casino employee’s confirmation that the hand was in fact the recognized hand. Once the hand has been verified, the casino employee will press F1 or enter the appropriate Key to confirm the displayed prize (as required by the system’s setup)

### Qualifying Hands

Players that make one of the advertised qualifying hands, as shown below, will be eligible to win their share of the posted prize amount, according to the payout options, as shown below. All qualifying hands must be offered together at all times this gaming activity is offered for play.

## **EZ Baccarat Panda 8 G3 Progressive Jackpot**

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Only players that have placed the \$1 jackpot collection fee are eligible for an EZ Baccarat Panda 8 G3 Progressive Jackpot payout.
- Only players seated at the table are eligible to win. Backline bettors are not eligible to place a jackpot collection fee and receive the prize amount for a qualifying hand.
- A minimum of two players, a player and a player-dealer, must be dealt into the game in order for the table to qualify for the EZ Baccarat Panda 8 G3 Progressive Jackpot gaming activity.
- Prizes shall be paid out in the order that they are won. Fixed prizes will be paid first.
- In the instance of multiple linked tables qualifying for a progressive payout, all winners shall be paid, the amount shown on the LCD monitor, in the order in which the wins occur.
  - Any additional payouts shall be paid from the reserve fund. In the even the reserve fund is deleted, the Casino will make up the shortfall. The Casino will be reimbursed from the reserve fund once monies are available.
- A player is eligible for an EZ Baccarat Panda 8 G3 Progressive Jackpot prize payout regardless of whether their hand wins, loses, or ties with the player-dealer's for the controlled game of EZ Baccarat Panda 8.
- If the house dealer enters the wrong information, authorized personnel must resolve the situation using the Game Server features (see Figure 6 in Appendix 1).
- If the house dealer makes a mistake while dealing the cards, he should declare the hand a misdeal, and re-deal the cards. Caution: the house dealer must not press STOP. Each player's optional jackpot fee will remain the same during the re-dealt hand.
- The player in the player-dealer position is not eligible to participate in this promotion.
- A Third Party Provider of Proposition Player Services (TPPPPS) is not eligible to participate at any time.
- A patron in the player-dealer position is not eligible for this promotion.
- Casino employees are eligible to participate only when off duty and out of uniform.

### **Prize**

Once the proper paperwork has been filled out and the hands have been verified, a casino representative will pay the winners in live casino chips. All monies collected and paid out shall be tracked both electronically and on a hand written log to be maintained by the Casino for examination by regulatory and law enforcement personnel.

### **Fixed Prizes:**

- All fixed prizes won will be paid directly to the winning players.
- All fixed payouts will be deducted from the amount shown on the progressive meter. The posted progressive jackpot amount will be instantly updated to reflect the change.

### **Progressive Prizes:**

- A Heavenly Dragon 7 pays 100% of the progressive jackpot amount shown on the progressive meter.
- A Mighty Panda 8 pays 10% of the progressive jackpot amount shown on the progressive meter.
- If the hand qualifies for a progressive prize, the amount of the progressive jackpot prize will be divided among all players who placed a fee for the progressive wager.

## **EZ Baccarat Panda 8 G3 Progressive Jackpot**

- Once the casino verifies a progressive win, the authorized personnel (i.e. supervisor or manager) shall perform the appropriate payment procedure.
- In the case of multiple linked tables, winners are paid in order in which the authorized personnel (supervisor or manager) authorize the wins. It is recommended to process tables in the order that the wins occur. Note: Left to the casino's internal controls discretion.
- At the end of the hand, the house dealer presses "STOP." This unlocks the G3 Progressive Jackpot Tracking Bet Managers so the next hand may begin.

### **Funding**

The EZ Baccarat Panda 8 G3 Progressive Jackpot is a player funded jackpot which features fixed and progressive prize elements. The Casino will initially seed the jackpot at a minimum of \$1,000. Once there are sufficient monies in the EZ Baccarat Panda 8 G3 Progressive Jackpot reserve fund, the initial seed will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. There shall be a cap of \$500,000 for the progressive prize pool. Any monies collected after the cap has been reached shall go into the reserve fund. After the progressive jackpot is hit it will be re-seeded by the reserve fund at a minimum of \$1,000 and a maximum of \$100,000. At any time, should the amount accumulated in the reserve fund reach \$100,000 then the G3 system will automatically generate a 2nd reserve and the portion of the jackpot fee (\$0.05) in excess of that \$100,000 will now be sent to that 2nd reserve fund. If that 2nd reserve fund reaches \$100,000, then any excess monies (\$0.05) will all be sent to the meter. In the event, the reserve fund does not have enough to cover the seed amount; the Casino will make up any shortfall. The Casino will be reimbursed from the reserve fund once monies are available.

Each jackpot fee paid by a player will be broken down as follows:

- \$0.80 will be immediately posted on the meter.
- \$0.20 will be tracked in a reserve fund. The reserve fund will be utilized to immediately reseed the metered progressive jackpot prize.

Each player has the option to pay the house dealer any amount not exceeding \$100 to have credits placed on their bankroll meter. All monies paid toward credits on the bankroll meter will be dropped into a separate and locked drop box specifically designated for jackpot collection fees. If a player decides to leave the table and still has money on their bankroll meter, the house dealer will call over a casino representative and have a receipt printed out for the amount cashed out. The receipt will be kept by the casino representative for reconciliation purposes at the end of their shift. The casino representative will then reimburse the player in live casino chips for the amount shown on that player's bankroll meter which will match the amount on the printed receipt.

### **Administrative Fees**

The 500 Club Casino shall retain administrative fee of \$16-\$30 per table per hour from the reserve fund. The administrative fee shall be utilized to cover expenses incurred for administering the EZ Baccarat Panda 8 G3 Progressive Jackpot.

## **EZ Baccarat Panda 8 G3 Progressive Jackpot**

### **No Purchase Necessary**

The EZ Baccarat Panda 8 G3 Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Bad Beat Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

# EZ Baccarat Panda 8 G3 Progressive Jackpot

## Equipment

### GLI Certification

The G3 System hardware and software related to and used in conjunction with this gaming activity, which is used on each eligible EZ Baccarat Panda 8 table for this gaming activity, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

### **Appendix 1: G3 Progressive Jackpot Tracking System components**

The current section presents the important components of the G3 Progressive Jackpot Tracking Systems. The system is mainly composed of these visible components: The Personal Bet Managers, A Dealer Interface and a double-sided LCD screen.



#### **A. Personal Bet Manager**

Located in front of each betting spots, the personal bet managers are the interfaces used by the players to place their side wager. The player buys credits from the dealer and once they are available in his credit bank, he can place a bet using the player hand button.

### B. Dealer Interface

This device is used by the dealer to operate the system. The house dealer can buy and sell credits to players and manage the course of the game. When a prize is awarded to a player, a supervisor or a manager can login on the system using a key on the dealer interface and proceed with the payment.

The dealer interface is installed on a metal support fixed to the table as shown in Figure 4.

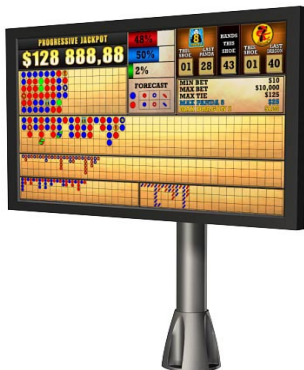


Figure 5: The LCD Screen

### C. The LCD Screen

Located on one side of the table, the screen displays a graphical animation showing all the important information related to the game, the payout schedule, the various transactions being performed and the live jackpot value.

The system is also composed of other components that are not visible to the players but are required for the system to operate: The G3 Table Controller and The G3 Game Server.

### D. G3 Game Server

The server is the central component of the G3 System. It performs the following tasks:

- Configures and maintain the various options for all clients (tables).
- Maintain the Progressive Jackpot value and communicate it to all clients (tables).
- Maintain the database of all the system on a RAID configuration.
- Generate the various reports for all system components.

The G3 Game Server PC includes:

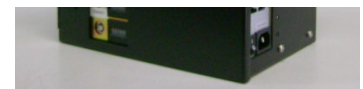

### E. G3 Table Controller

Installed under each table where the G3 system is running, the device controls all hardware and software components (PBM, TD, DI) at the table level. This computer communicates with the G3 Game Server through an Ethernet (TCP-IP) connection.

# Blazing Sevens Progressive Jackpot

## **Bureau Requirements**

### **Advertising**

The 500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001356) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying Hands
- Prize payout structure
- The prize amount to be awarded
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Blazing Sevens Progressive Jackpot shall be attached to the following Bureau approved controlled game offered at 500 Club Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Pure 21.5 Blackjack (GEGA-003642)

### **Object and Summary**

The object of the Blazing Sevens Progressive Jackpot is for participating players to achieve a qualifying hand, as shown below, in order to win a fixed or progressive prize.

1. To begin each round, players must make their regular base game wager. Players may optionally place any bonus bets and optional \$1 jackpot fee. Players who do not make a base game wager are not eligible to place a jackpot fee.
2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a live casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
  - a. Should the sensor malfunction, the chips will be returned to the players and no jackpot will be offered during that time, until the malfunction is fixed.
3. Once all players place their controlled game wagers, bonus bets, and jackpot fees, the house dealer will press "Start Game" on the keypad. The sensors will then light up, indicating participation in the gaming activity. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
4. The house dealer then follows standard approved procedures for dealing the controlled game. Any player who makes a qualifying hand will be paid out, as described below.

## Blazing Sevens Progressive Jackpot

### Qualifying Hands

Players who make one of the advertised qualifying hands, as shown below, shall be eligible to win their share of the posted prize amount, according to the posted payout options. All qualifying hands within a chart must be offered together at all times.

**Blazing Sevens Progressive Jackpot Qualifying Hands Chart**

### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing the above listed controlled game during the predetermined specified hours posted for the gaming activity.

- A minimum of two seated players, the player and the player-dealer, are required to be dealt in during the base game in order for players to be eligible and the table to qualify for the Blazing Sevens Progressive Jackpot.
- A player may qualify for the jackpot regardless of the outcome of the controlled game.
- Backline bettors are not allowed to participate in this gaming activity.
- Players who obtain a hand that qualifies for more than one prize will only be awarded the prize with the higher value.
  - *Example: A player who is dealt a total of three cards and they are all 7s will only be awarded the "Three 7s prize" and will not be awarded both the "Three 7s" prize and the "First Two Cards Are 7s" prize.*
- Casino employees are eligible to participate in the gaming activity when they are off duty and out of uniform.
- Players who are playing multiple hands may place a jackpot fee on each hand.
- There is no limit to the amount of prizes a players may win during a promotional period.
- Players acting in the player-dealer position are not eligible to place an optional \$1 jackpot fee and participate in this gaming activity.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible for this gaming activity.

### Prize

The Blazing Sevens Progressive Jackpot features both progressive and fixed prizes. All prizes will be paid by a casino representative. Once all proper paperwork has been filled out, the casino representative will pay the winner(s) in live casino chips. The payouts will not be made from the house dealer's tray.

### Progressive Prize

The progressive prize will range from a minimum of \$1,000 and will have no maximum amount. The actual amount shall depend on the amount the jackpot was originally seeded at, as well as how much time has accumulated in order for the jackpot to increase progressively each day.

- 100% of the progressive jackpot amount shown on the progressive meter shall be awarded to players who are dealt three cards with a face value of 7; and all three cards are of the same color.

## Blazing Sevens Progressive Jackpot

- If more than one progressive prize winning hand hits at the same time all winning players will split the prize evenly.
  - In the event there is an odd number of chips, the casino will make up the shortfall and will be reimbursed from the reserve fund once there are sufficient monies.
  - All progressive prize payouts will be paid from the Blazing Sevens Progressive Jackpot meter.

### Fixed Prizes

Fixed prizes will be awarded at a set amount of \$500, \$100, or \$50 depending on the qualifying hand.

- \$500 will be awarded to players who are dealt three cards with a face value of 7.
- \$100 will be awarded to players whose first two cards dealt have a face value of 7 and are of the same suit.
- \$50 will be awarded to players whose first two cards dealt have a face value of 7.
- If more than one fixed prize winning hand hits at the same time all winning players will be paid the corresponding fixed prize amount.
- All fixed prize payouts will be paid from the Blazing Sevens Progressive Jackpot reserve fund.
  - In the event that the reserve fund is depleted, the Casino will make up any shortfall and will be reimbursed once there are sufficient monies in the reserve fund.

All monies paid out will be tracked both electronically and on a hand written log to be maintained by the gambling enterprise, for examination by regulatory and law enforcement personnel.

### Funding

The Blazing Sevens Progressive Jackpot is a player-funded jackpot with both fixed and progressive prizes. The jackpot is funded by an optional \$1 jackpot fee, which is paid by players in order to be eligible for the prizes mentioned above. The \$1 jackpot fee, paid by each player, will be broken down as follows:

- \$0.20 will be immediately posted on the jackpot meter.
- \$0.80 will be tracked in the Blazing Sevens Progressive Jackpot reserve fund.

The Casino will initially seed the jackpot meter at an amount between a minimum of \$1,000 and a maximum of \$50,000. Once there are sufficient monies in the reserve fund, the initial seed will be reimbursed to the Casino from this reserve fund. There is no cap to the Blazing Sevens Progressive Jackpot meter.

After the progressive jackpot is hit, the jackpot meter will be re-seeded by the reserve fund at an amount ranging between a minimum of \$1,000 and a maximum of \$50,000. In the event that the reserve fund is depleted, the Casino will make up any shortfall. Once there are sufficient monies in the reserve fund, the re-seed amount will be reimbursed to the Casino from the reserve fund.

All increases and decreases to the Blazing Sevens Progressive Jackpot reserve fund and jackpot meter shall be documented in the accounting records.

## **Blazing Sevens Progressive Jackpot**

### **Administrative Fees**

The Casino will retain an administrative fee ranging from \$10 to \$16, taken per table per hour. The administrative fee will be taken from the reserve fund. The fee shall be used for the operation costs and the administration of the jackpot.

### **No Purchase Necessary**

The Blazing Sevens Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Blazing Sevens Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### **Equipment**

The electronic software and digital reader related to and used in conjunction with this gaming activity has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

1. Once the casino verifies the progressive win, the supervisor will press the confirm button. To complete the action, a casino representative's card swipe is required. This records the win onto the Game Manager computer and adjusts the meter appropriately for the prize won. House procedures are then followed for paying the prize. (Reviewing the monitor connected to the Game Manager will show the prize amount to be paid, and pressing the "money bag" icon will print a win page, which can be used to help record the payout for accounting.)
2. Once the house dealer reconciles all action, the house dealer presses "End Game." This resets the system to begin the next hand.
3. Once the casino representative's card is swiped the prize is logged into Game Manager. If the progressive pay needs to be backed out at this point, the prize will need to be manually backed out using the Game Manager manual adjustment feature.

## Hot Seat Promotion

### **Bureau Requirements**

Furthermore, all rules and procedures for this promotion, including but not limited to the following, will be prominently displayed in 500 Club Casino at all times the promotion is being offered:

- Eligible games and time periods
- Eligible Dates and Times
- Specific Prize Amounts
- Only open to Player's Club Card members (GEAR-001257)
- Opportunity for No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Hot Seat Promotion shall be attached to all Bureau approved games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The Hot Seat Promotion is a house funded fixed bonus prize promotion that awards players who are dealt in a card game a chance for their seat to be drawn and for that person to win a predetermined prize. Numbered placards or balls corresponding to a seat will be drawn manually from a drum or similar non-electronic device, to randomly select a "hot seat" number. Once the seat number has been determined, it will be announce on the casino floor followed by a drawing for a table number. Table number placards or balls corresponding to the table numbers for all active (at least two players for poker games and at least one player and one player-dealer for California games) live tables will be placed in a drum or similar non-electronic device and a table number will be randomly chosen and announced on the casino floor. The patron occupying the "hot seat" wins the prize. If the chosen seat is empty, the Casino shall redraw another seat until a winner is found.

#### **Eligibility Requirements**

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- At least two players must be playing at a poker style game in order to qualify for this promotion.
- At least one player and one player-dealer must be playing at a California style game in order to qualify for this promotion.
- Players must be seated and playing at a designated table in order to qualify for the promotion.
- If the chosen seat is empty, the Casino shall redraw another seat until a winner is found.
- Casino employees are eligible to participate in this promotion at any time.

## Hot Seat Promotion

- Third-Party Proposition Players (TPPPS) will not be eligible to participate in this promotion.
- Players in the player-dealer position are not eligible for this promotion.

### **Prize**

The Hot Seat Promotion features a fixed prize element. The prize does not increase and does not rollover. The player who is seated at the randomly selected table and seat will receive a prize ranging from \$1 to \$1,000,000 in the form of cash, live casino chips, Promotional Chips (GEAR-001154), and Match Play (GEAR-00169). Prize amounts shall be predetermined and posted before being offered.

### **Funding**

The Hot Seat Promotion will be fully funded by 500 Club Casino. There shall be no additional promotion fees, jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate.

### **Administrative Fees**

500 Club Casino will not retain an administrative fee, as this gaming activity is house funded.

### **No Purchase Necessary Procedures**

The Hot Seat Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Hot Seat Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.



## Match Play Free Play Promotion

### **Bureau Requirements**

#### **Advertising**

The 500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001159) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Match Play Coupon and/or Free Play Chip Voucher value(s)
- Procedures to redeem coupons and/or vouchers
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Match Play Free Play Promotion shall be attached to all Bureau approved California games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

Patrons are awarded Match Play Coupons or Free Play Chip Vouchers via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. Both the Coupons and the Vouchers will have the name of an eligible game and a face value clearly printed on them. The value for both the Match Play Coupons and the Free Play Chip Vouchers will range between \$5 and \$1,000,000. Players who receive a Match Play Coupon will be eligible to win the specific amount printed on the coupon if they place a base game wager on an eligible game equal to the amount listed on the match play coupon. Players who receive a Free Play Chip Voucher will be eligible to redeem the voucher for Free Play Chips, in the value of the voucher, to be used only as a base game wager at the eligible game printed on the voucher. The procedures are as follows:

#### **Match Play Coupon**

- To use a Match Play Coupon a player must place a base game wager, equal to the face value of the coupon, and the Match Play Coupon in the appropriate betting area for the game listed on the coupon.
  - The coupon will be counted as part of the total base game wager in terms of winning or losing.
  - It will also be counted as part of the base game wager in terms of Total Table Action for collection rates.
- If the player wins the hand they will be paid their wager as well as the listed amount on the Match Play Coupon by the player-dealer.
  - The coupon will be collected by the house dealer.
  - A casino representative will sign the coupon and will drop it in the drop box for accounting purposes.

## Match Play Free Play Promotion

- If the player loses the hand they will lose the wager and the coupon.
  - The money part of the wager is collected by the player-dealer.
  - The coupon is taken to the cage by the casino representative.
  - At the cage the coupon will be logged, and exchanged into live casino chips for the value listed on the coupon.
  - The live casino chips will then be given to the player-dealer.
- If the player pushes (receives no action), the player will keep the coupon and be able to keep using it until the player loses or wins a hand.

### Free Play Chip

- When a player receives a Free Play Chip Voucher they shall take the voucher to the cage for verification, logging, and redemption of the Free Play Chip(s) to be used in a live game.
  - Free Play Chips are of a different style and design from the standard casino chip.
  - The Free Play Chips are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash and they can only be used on the game specified on the voucher.
- Free Play Chips shall be used as the player's base game wager and placed on the appropriate betting circle.
  - It will also be counted as part of the base game wager in terms of Total Table Action for collection rates.
- Free Play Chips shall not be taken into the house dealer's tray, nor shall they be paid from the dealer's tray.
- If the player wins the hand they will be paid like normal by the player-dealer.
  - The Free Play Chips will be collected by the house dealer.
  - A casino representative will then verify that the chips have been played and will drop the chips in the drop box for accounting purposes.
- If the player loses the hand they will lose the wager and the Free Play Chip(s).
  - The Free Play Chips will be collected by the player-dealer.
  - A casino representative will verify that the Free Play Chips have been played and will take the chips to the cage.
  - At the cage the Free Play Chips will be logged, and exchanged into live casino chips for the value listed on the Free Play Chips.
  - The live casino chips will then be given to the player-dealer.
- If the player pushes (receives no action), the chip(s) may be played again until the player wins or loses a hand.

### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in 500 Club Casino at all times that the gaming activity is being offered for play:

- The required amount a player must buy-in for and the corresponding amount of bonus chips they shall earn
- The time required to play in order to retain the earned bonus chips
- The dates(s) and time(s) the promotion shall be offered
- The games eligible for the promotion
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Premier Rewards Program shall be attached to all Bureau approved California games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The Premier Rewards Program will be open to all patrons who sign-up and maintain an active premier player's bank account. Participants will receive a predetermined amount of Promo Chips (GEAR-001154) ranging from \$10 to \$1,000,000 when they buy-in to any predetermined controlled game listed above for a predetermined amount ranging from \$10 to \$1,000,000. A player will receive their bonus chips on the gaming table once a casino representative verifies their player's bank account balance at the cage when they buy-in to the game.

### **Premier Players Bank Account Description**

Players can sign up for the Premier Player's Bank Account by going to the cage and filling out an application. A player may check their balance at any time by going to the cage cashier and showing their ID.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Players must buy-in to a predetermined listed for an amount ranging from \$10 to \$1,000,000 to be eligible for this promotion.
- There shall be no minimum or maximum number of players required for this promotion.
- A player is only eligible for this gaming activity once per day.
- There is no minimum amount of time players have to play in order to be eligible for this promotion.

### **No Purchase Necessary**

The Premier Rewards Program does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

## Customer Incentive Program

### **Bureau Requirements**

#### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001393) will be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, will be prominently displayed in 500 Club Casino at all times the gaming activity is being offered for play:

- Corresponding time played and points earned or awarded
- The date(s) and time(s) the gaming activity shall be offered
- The number of points earned corresponding to the prize amount
- The time frame in which the points earned are valid
- The possible prize(s) offered for meeting the requirements of the gaming activity
- When the bonus prize(s) will be offered throughout the promotion
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Customer Incentive Program shall be attached to all Bureau approved California and Poker controlled games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The Customer Incentive Program features a promotional element attached to the games listed above. This gaming activity is a loyalty reward program open to all 500 Club Casino patrons. The promotion will reward players with points based on time of play at designated table games during predetermined and eligible periods ranging from 10 minutes to 90 days. The range of points per hour played will range from 1 to 500,000. During predetermined and posted times, 500 Club Casino may offer bonus rates on play during off-peak hours or in specific games, within the range as shown above (for example, double points).

#### **How Points are Earned Based on Time Played**

Points shall be earned based on the amount of time played. Each player that plays posted certain table game during live play will, at certain times, receive points, which will gain them eligibility to win predetermined and designated prizes.   - No one except the network administrator(s) has access to the back-end systems where the data is stored.
  - Access to the data is by user level with multiple levels based on the users work needs.
  - Marketing managers will have access to customer data for marketing purposes.
- Player's time played is tracked by having their card scanned.
- A computer device, with a bar code reader, will be affixed to the gaming table or casino podium and a gambling establishment employee will scan the player's card. The gambling establishment employee will then input the player's average wager and time played into the computer device.
- A printable record of the amount of time a player has accumulated during the promotional period shall be available at any time it is requested by the player.

In all instances, the actual prize(s) that players are eligible to redeem their points for shall be predetermined and conspicuously posted in 500 Club Casino at all times that this gaming activity is being offered.

### **Funding**

The Customer Incentive Program shall be fully funded by 500 Club Casino. No additional fees of any kind shall be taken for this promotion. All fee collections and table limits are for the designated base game and are Bureau approved, predetermined and posted at each table.

### **Administrative Fees**

500 Club Casino shall not retain any administrative fee for operating the Customer Incentive Program gaming activity as this promotion is house-funded.

### **No Purchase Necessary**

The Customer Incentive Program does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary Table to be offered while conducting this gaming activity.



## VIP Prime Membership

### **Bureau Requirements**

#### **Advertising**

500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001395) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the 500 Club Casino at all times the gaming activity is being offered for play:

- Procedures for purchasing the VIP Prime Membership
- Monthly price of membership
- The date(s) and time(s) the promotion shall be offered
- Any limits to the amount of prizes a VIP Prime Member may win during the promotional period
- Any limitations to the quantity of a prize
- The games eligible for the promotion
- Eligible prizes, prize quantities, and prize values
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The VIP Prime Membership promotion shall be attached to all Bureau approved California games offered at 500 Club Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The VIP Prime Membership promotion is an enhancement to the Customer Incentive Program (GEAR-001393). The VIP Prime Membership will offer patrons who sign up and pay a monthly fee, the opportunity to participate and win prizes that are both complimentary and independent to those awarded in the Customer Incentive Program and other gaming activities.

In order to participate in the VIP Prime Membership promotion patrons need to first be members of the Customer Incentive Program (GEAR-001393). They will then sign-up and pay a corresponding monthly fee. A VIP Prime Member Card will be given to members to represent their membership status in the Customer Incentive Program (GEAR-001393) and the VIP Prime Membership.

#### **Eligibility Requirements**

This gaming activity shall be open to all players 21 years of age and older with valid I.D.

- This gaming activity is restricted to Customer Incentive Program members (GEAR-001393).
- Participants may sign up for the Customer Incentive Program and the VIP Prime Membership on the same day.
- Participants must pay the monthly fee on time.
- Participants may pay the monthly fee with credit card, cash, live casino chips, or Customer Incentive Program (GEAR-001393) points.
- All VIP Prime Members are subject to the same monthly fee.

## VIP Prime Membership

- VIP Prime Members will be guaranteed at least one opportunity to participate and win a prize per month.
- Promotional periods in this gaming activity are equal to one month.
- A VIP Prime Membership card will have the player's name and membership number. If the card is lost or stolen, a replacement will be replaced free of charge.
- The VIP Prime Membership is non-transferable.
- Casino employees are not eligible to participate in this promotion.
- Third-Party Providers of Proposition Player Services (TPPPS), on or off duty, shall not be eligible to participate in this promotion.
- A VIP Prime Member is eligible to participate in this promotion while in the player-dealer position.
- There is no limit to how many VIP Prime Membership prizes a player may win during the life of their membership.
- Any limit to the amount of prizes a VIP Prime Member may win during a promotional period will be predetermined and posted.
- A participant in this promotion must claim any advertised prizes within the posted promotional periods
  - A prize will not be awarded to participants after a promotional period has ended, regardless if the monthly fee was paid.
- Tournament games (GETR-000127) are eligible for this gaming activity.

### **Prize**

The VIP Prime Membership offers fixed prizes which range in value from \$1 to \$1,000,000. The eligible prizes are grouped into two categories; Complimentary Prizes and Independent Prizes.

### **Complimentary Prizes**

Complimentary prizes are prizes that compliment a currently active gaming activity. These prizes will be awarded in addition to the prize awarded by the gaming activity. These prizes consist of receiving additional:

**Example of a Complimentary Prize:** *Every Mondays in the month of August, patrons who participate in the Promo Chip promotion by buying into an eligible game for \$2,000 will receive \$250 in Promo Chips. All VIP Prime Members who buy-in to the Promo Chip promotion for \$2,000 will receive an additional \$100 in Promo Chips for a total of \$350 in Promo Chips.*

### **Independent Prizes**

500 Club Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001382) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the 500 Club Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands and corresponding prize amounts
- Jackpot Fee
- Availability of No Purchase Necessary
- Administrative Fees
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive shall be attached to the following Bureau approved controlled games offered at 500 Club Casino, as shown below, at all times these gaming activities are being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Fortune Pai Gow Poker (GEGR-002017)
- Face Up Pai Gow Poker (GEGR-002266)

### **Object and Summary**

The Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive considers the best advertised qualifying hand(s) possible among each individual player's cards. Players who achieve a qualifying hand will be paid according to the paytable, below.

- To begin each round, players must make their regular base game wager. Players who have placed a base game wager may optionally place any bonus bets along with the optional jackpot fee of \$1.
- "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players who wish to participate in the jackpot must place the optional jackpot fee on the sensor. The sensor will then light up.
- Once all players place their bets and/or jackpot fee, the house dealer will press "Coin In" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
- The house dealer then follows standard approved procedures for dealing the base game. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.
- A player will win the posted prize if one of the qualifying hands is achieved. All seven cards in the players' hand will be considered.

## Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive

### Qualifying Hands

In order to form a qualifying hand, a player must use all seven of the cards that were dealt to them. All qualifying hands within a chart must be offered together at all times.

### Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive Qualifying Hands

Hand Dealt	Hand Requirements
7 Card Straight Flush (No Joker)	A hand that consists of seven cards of the same suit in consecutive ranking without the use of a joker. A king, queen, jack, 10, 9, 8, and 7 is the highest ranked 7 Card Straight Flush and a 7, 6, 5, 4, 3, 2, and ace is the lowest ranked 7 Card Straight Flush.
7 Card Straight Flush (With Joker)	A hand that consists of seven cards of the same suit in consecutive ranking with the use of a joker. A king, queen, jack, 10, 9, 8, and 7 is the highest ranked 7 Card Straight Flush and a 7, 6, 5, 4, 3, 2, and ace is the lowest ranked 7 Card Straight Flush.
Five Aces	A hand that consists of four aces and a joker.
Royal Flush	A hand that consists of an ace, king, queen, jack and 10 of the same suit.
Straight Flush	A hand that consists of five cards of the same suit in consecutive ranking. A king, queen, jack, 10 and 9 is the highest ranked Straight Flush and a 5, 4, 3, 2 and ace is lowest ranked Straight Flush.
Four of a Kind	A hand that consists of four cards of the same rank. Four aces is the highest ranked Four of a Kind and four 2s is the lowest ranked Four of a Kind.
Full House	A hand that consists of a Three of a Kind and a Pair. Three aces and two kings is the highest ranked Full House and three 2s and two 3s is the lowest ranked Full House.

### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- A minimum of two active players, including the player-dealer, are required to qualify for this gaming activity.
- Only seated players, who are dealt a designated hand and placed the optional jackpot fee, are eligible for payouts.
- Backline bettors are not eligible to place a jackpot fee or receive the prize amount for a qualifying hand.
- Casino employees are eligible for the Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive only when off duty.
- A player can qualify for the jackpot element of the game regardless of the outcome of the base game.
- A player may participate and win both the fixed and progressive prizes multiple times, with no limitations.
- Tournament games do not qualify for this promotion.
- Players who are playing multiple hands are eligible to place a jackpot fee and win on each hand.
- Players in the player-dealer position are eligible to participate in this promotion.

## Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive

- Third-Party Provider of Proposition Player Services (TPPPS) are not eligible for this promotion.

### **Prizes**

The Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive features progressive and fixed prizes. All prizes will be paid by a casino representative. Once all proper paperwork has been filled out, the casino representative will pay the winner(s) in live casino chips. The payouts will not be made from the house dealer's tray.

### **Progressive Prizes**

The progressive prize will range from a minimum of \$1,000 and will have no maximum amount. The actual amount shall depend on the amount the jackpot was originally seeded at as well as the amount collected from the jackpot fees. All progressive prizes will be paid from the progressive meter.

- A 7 Card Straight Flush (No Joker) is paid 100% of the progressive jackpot amount shown on the progressive meter.
- A 7 Card Straight Flush (With Joker) is paid 25% of the progressive jackpot amount shown on the progressive meter.
- Five Aces will be paid 10% of the progressive jackpot amount shown on the progressive meter.
- In the event that more than one progressive prize hand is achieved during the same round, all winning players will be paid the full amount of the posted prize.
  - The player who wins the highest value prize will be paid from the meter and the other winners will be paid from the reserve fund.
  - If the prize value is the same for some or all winners, one will be paid from the meter and the others from the reserve fund.
  - If the reserve fund is depleted the casino will make up the shortfall and will be reimbursed once there are sufficient monies in the reserve fund.
- When a player has a progressive winning hand, the dealer shall press the appropriate hand button on the keypad.

### **Fixed Prizes**

Fixed Prizes will be awarded at a set amount of \$500, \$100, \$75, or \$4 depending on the qualifying hand. Fixed prizes will be paid from the reserve fund, they do not get deducted from the amount shown on the progressive meter.

- A Royal Flush is paid \$500.
- A Straight Flush is paid \$100.
- A Four of a Kind is paid \$75.
- A Full House is paid \$4.
- In the event that more than one fixed prize hand is achieved during the same round, all winning players will be paid the full amount of the posted prize.
- In the event the reserve fund is depleted, the Casino will make up any shortfall and will be reimbursed once there are sufficient monies in the reserve fund.

All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained, by the gambling enterprise, for examination by regulatory and law enforcement personnel.

## Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive

### **Prize Payout Structure**

Players that make one of the advertised qualifying hands, as shown above, will be eligible to win a prize according to the payout table as shown below. Patrons will be provided with ample advance notice of the prize payout structure being offered for play. Furthermore, it will be displayed prominently within the Casino at all times the Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive is being offered for play. All prizes within a chart must be offered together at all times.

### **Funding**

The Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive is a player-funded progressive jackpot which features both progressive and fixed prizes.

The Casino will initially seed the jackpot in an amount between \$1,000 and \$50,000. Once there are sufficient monies in the Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive reserve fund, the initial seed will be reimbursed to the Casino and shall be documented in the accounting records.

The progressive meter shall increase daily based solely on the number of jackpot fees placed and collected each day. There is no cap to the Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive meter.

Each \$1 jackpot fee paid by a player will be broken down as follows:

- \$0.33 will be immediately posted on the meter.
- \$0.67 will be tracked in a reserve fund.

After the progressive jackpot is hit, it will be re-seeded by the reserve fund at an amount between \$1,000 and \$50,000. In addition, the reserve fund will be used to pay out all fixed prize amounts. In the event that the reserve fund is depleted, the casino will make up any shortfall. Once there are sufficient monies in the Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive reserve fund, the re-seed amount will be reimbursed to the Casino and shall be documented in the accounting records.

### **Administrative Fees**

The Casino will take an administrative fee ranging from \$16 to \$30 per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with administering the progressive jackpot.

## Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive

### **No Purchase Necessary**

The Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### **Equipment**

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

- When a player has a progressive winning hand, the house dealer shall press the appropriate hand button on the keypad.
- The house dealer shall then contact the casino representative.
- Once the Casino verifies the progressive win, the casino representative shall insert the key and rotate it to "JPH" and then press "J-pot" button. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
- Returning the key to the "Run" position will restore normal operation of the table and adjust the meter appropriately for the prize won.
- When the house dealer reconciles all action (on behalf of the player-dealer), he/she presses "Game Over." This resets the system to begin the next hand.
- Once the "J-pot" button is pressed, the prize is logged into Game Manager.
- If the electronic software or digital reader malfunctions or breaks down, the gaming activity will not be offered.
