EXECUTIVE SUMMARY

CalGang is a statewide database used by law enforcement agencies to share gang-related intelligence for criminal investigations. The confidential database is designed to enhance officer safety and improve the efficiency of criminal investigations.

The California Department of Justice (DOJ) oversees and audits CalGang pursuant to **Assembly Bill (AB) 90 (Chapter 695, Statutes of 2017), the Fair and Accurate Gang Database Act of 2017**. AB 90 (codified in Penal Code sections 186.34, 186.35 and 186.36) requires DOJ to improve the quality of the database by drafting and implementing regulations, annually publish a report on the CalGang database on February 15 of each year, and manage the CalGang database. This report marks DOJ's ninth annual report for CalGang as required by AB 90 and is based on the 9,948 records that existed in the CalGang database as of September 30, 2025.

On October 22, 2020, DOJ adopted **California Code of Regulations Title 11, Chapter 7.5, Department of Justice Regulations for the Fair and Accurate Governance of the CalGang Database (CalGang Regulations)**. These regulations govern the operation, oversight, and use of the CalGang database, including, among other things, establishing the requirements for entering and reviewing gang designations, the retention period for listed gangs, and the criteria for identifying gang members. The regulations prioritize accountability, data protection, and individual rights. Per the regulations, records in CalGang are confidential and are only for the use of law enforcement agencies for criminal investigations. Information and records in CalGang cannot be disclosed to evaluate an individual's eligibility for education, employment, housing, enforcing federal immigration law, or for military screening purposes unless required by state or federal statute or regulation. Currently, CalGang data is not included as a database accessed through the California Law Enforcement Telecommunications System, which is routinely checked when law enforcement has an encounter with an individual. A person may be entered into CalGang when they meet all of the requirements set forth in Article 5 of the CalGang Regulations. Gang intelligence in CalGang comes from source documents completed by agencies that use the database. These source documents include, but are not limited to, Field Interview Cards, Arrest Reports, Crime Reports, Jail Classification Reports, and Gang Registrations. Adults are removed ("auto-purged") from the database after five years, and minors are removed after three years, unless they continue to meet the criteria for being an active gang member based on additional contact with law enforcement.

The tables and charts provided in this report summarize data captured during October 1, 2024 – September 30, 2025. This includes data that was entered into CalGang by local agencies prior to AB 90 and prior to DOJ's issuance of the CalGang Regulations.

AT A GLANCE

Penal Code section 186.36, subdivision (p) requires DOJ to publish an annual report regarding the CalGang database that contains, by ZIP code, the referring agency, race, gender, age, and the following information for each user agency:

- The number of persons included in the CalGang database on the day of reporting, September 30, 2025.
- The number of persons added to the CalGang database during the immediately preceding 12 months.
- The number of requests for removal of information from the CalGang database received during the immediately preceding 12 months.
- The number of requests for removal of information that were granted during the immediately preceding 12 months.
- The number of petitions for removal of information that were adjudicated, including dispositions, during the immediately preceding 12 months.
- The number of persons whose information was removed (i.e., “auto-purged”) from the CalGang database due to the expiration of the five-year (for adults) or three-year (for minors) retention period during the immediately preceding 12 months.
- The number of times an agency did not provide a Penal Code section 186.34 notice or documentation because doing so would compromise an active criminal investigation, in the immediately preceding 12 months.
- The number of times an agency did not provide a Penal Code section 186.34 notice or documentation because doing so would compromise the health or safety of the designated minor, in the immediately preceding 12 months.
- The results from each user agency’s annual audits.
 - Records that fail (they do not meet minimum requirements set forth in Article 5 of the CalGang Regulations) during auditing are manually removed from the system and removal is verified by DOJ.
 - Data from an agency that no longer participates in using the database are removed.


CalGang Regulations, Title 11, Chapter 7.5, sections 755.8 subdivision (g) and 756.6 require the reporting of the following additional information:

- The number of times an agency received an information request pursuant to subdivision (d)(1) of Penal Code section 186.34.
 - Please see Column P on the “FULL” tab within the Excel dataset published with this report.
- The number of proxy queries conducted by a participating accessing agency, and the name of each non-participating agency requesting the proxy query.
 - Please see the tab titled “Proxies.”
- CalGang Misuse Reporting.
 - Agencies that failed to submit the Misuse form are listed on the tab titled “Misuse.”
- The results from each agency’s annual gang records audits.
 - Please see the tab titled “Gang Audits.”



Chart 1: Total Number of Individuals¹ in CalGang by Gender:





Chart 2: Total Number of Individuals¹ in CalGang by Race:





Chart 3: Total Number of Individuals¹ in CalGang by Age:





CALGANG CONTEXT DOCUMENT

Dataset Overview and History

DOJ is responsible for the oversight of CalGang, the database of statewide gang-related intelligence information. Data is entered directly into CalGang by law enforcement officers. The data reported in DOJ's annual report is an aggregation of individual-level information to provide a summary of data as mandated by AB 90.

Statutory Authority

Penal Code section 186.36, and the CalGang Regulations, mandate that DOJ collect CalGang data and report annually on the information included in this dataset.

Data Characteristics and Known Limitations

1. Some of the data published in this report was entered into CalGang prior to DOJ assuming its oversight responsibilities on January 1, 2018.
2. The terms column(s), tab(s), row(s) and field(s) in the numbered items below, are referring to the Excel dataset, which accompanies the Executive Summary.
3. All values in the “Reporting Year” column summarize data from October 1, 2024 through September 30, 2025.
4. The value “Unreported” indicates the field was left blank by user agencies.
5. In the 2020 report and subsequent reports available on the CalGang website, the age category level “10 to 17” on the “FULL” tab, was changed to “13 to 17” as there are no longer any persons under the age of 13 in the system and the new regulations now prohibit anyone under the age of 13 from being included.
6. Approval or denial of court petitions may be reflected in the current year or in a subsequent year’s report depending on the timing of the adjudication process.
7. On the “FULL” tab within the excel file available on the CalGang website, the category “All” is not a sum of the agency’s rows. The sum of each category for a selected agency will equal the total listed for that agency. For example, when filtered by the category “All,” the total number of individuals entered by Anaheim Police Department is 4; thus, the total for each individual category (Age, Gender, Race) within Anaheim Police Department will equal 4.
8. Due to the method of entry into CalGang, it is possible for an individual to have multiple entries within the database. For example, a verified entry into the database is entered into a node (or region) by law enforcement agency A and another distinct verified entry is entered into a different node by law enforcement agency B. Both entries are valid and counted as separate individuals; however, they correspond to one person. A verified entry means that there are two distinct criteria substantiating that entry.

9. On the “FULL” tab, there may be rows where the ZIP code indicates a value of “0” for records added but there are values indicated for requests for removal and petitions. This is because the ZIP codes that are associated with records and the ZIP codes that are provided to law enforcement agencies from requests/petitions may not be the same. For example, a contact may be made that results in a designation in a ZIP code that is not where the person resides; a person may move after a designation and subsequently submit a request for removal, attorneys can request information on a client’s behalf, et cetera.
10. To elaborate on the Charts 5 and 6 above, record and gang audits failed for the following reasons:
 - a. “Agency Didn’t Provide Source Documents” refers to instances where an agency provided no response or source documents when audit documents were requested.
 - b. “Agency Unable to Locate Source Documents” refers to records where an agency reported to DOJ that they could not locate the source documents and removed the record from the system.
 - c. “Gang Did Not Meet Requirements, §753(a)” refers to section 753 of the CalGang Regulations, which outlines the requirements for an organization to be designated as a criminal street gang in CalGang. If a gang fails to meet those requirements during an audit, the gang and its members in the system must be purged.
 - d. “Source Documentation Not Substantiated” refers to instances where a record’s inclusion in the database was not substantiated by the source document.
 - e. “Gang No Longer Meets, §753.3 Requirements – Individual Must Be Removed” refers to when an Individual(s) is removed from CalGang because the gang they are determined to no longer meet the minimum requirements to remain in CalGang.
11. The audit tab now includes a column for “Total Records Auto-Purged.” This captures records that were selected to be audited but reached their automatic purge date prior to completion of the audit.
12. While DOJ no longer has law enforcement users who designate people in CalGang, it does act as a law enforcement agency, and as such, has responded to information requests in compliance with Penal Code section 186.34, subdivision (d).
13. On the “FULL” and “Agency Totals” tabs, when a person submits a request to know if they are in the system (also known as an information request), they may not disclose their age, sex, or gender. This results in “Unreported” category levels in the “Information Requests” column.
14. Non-users with a need to know/right to know can submit a “proxy query request” to any CalGang user agency. The user agency must verify the non-user’s need to know/right to know before fulfilling the proxy query request. Proxy query requests can be submitted by non-users from law enforcement agencies (LEAs) within California, but also federal and out of state LEAs with a need to know and a right to know. For example, a detective at the Los Angeles County Sheriff’s Department, a current user agency, may not have a caseload that warrants permanent access to CalGang. However, they may have a single case that involves a suspected gang member, which establishes need to know/right to know. The non-user can request a proxy query of CalGang be done by one of their agency’s users, or a user from a different agency, if their agency does not have access.

15. There are user agencies that do not enter data and therefore are not listed on the “FULL” tab. Agencies that are “View Only” are still required to report misuse to DOJ and any that fail to do so are listed on the “Misuse” tab.
