*Gun show traders may participate at no more than 12 gun shows in any calendar year. (Pen. Code, §§ 16620, 26805, 30348.) The gun show trader must have a valid federal firearms license and a current certificate of eligibility, and all firearms sales must be completed through a licensed dealer. (Pen. Code, §§ 16620, 26525.) Additionally, a gun show trader can sell only used firearms other than handguns, cannot sell more than 15 used firearms other than handguns at any single gun show, and cannot sell more than 75 used firearms other than handguns in any calendar year. (Pen. Code, § 26525.)

**INSTRUCTIONS FOR LIST OF PROSPECTIVE FIREARMS DEALERS, AMMUNITION VENDORS, AND GUN SHOW TRADERS OFFERING
FIREARMS OR AMMUNITION FOR SALE OR DISPLAY:**

The List of Prospective Firearms Dealers, Ammunition Vendors, and Gun Show Traders Offering Firearms or Ammunition for Sale or Display (BOF 105) must be completed and signed by the licensed gun show producer. Use as many BOF 105 forms as required to list all firearms dealers, ammunition vendors, and gun show traders for the gun show or event being reported. Please note: the total number of firearms dealers, ammunition vendors, and gun show traders must be entered on page 3.

The gun show producer shall also submit no later than fifteen (15) days prior to the gun show or event a Revised Annual Event and Security Plan form (BOF 104A) if significant changes have been made since the original Annual Event and Security Plan form (BOF 104) was submitted.

Similarly, if you previously submitted a BOF 105, but the list of firearms dealers, ammunition vendors, and gun show traders for the gun show has changed, submit a new BOF 105 with the updated list to:

The BOF 105 must be submitted to the Department of Justice seven (7) calendar days before the commencement of a gun show or event, but not later than noon on Friday for a show or event held on a weekend. (Pen. Code, § 27220.)

Providing Personal Information: All the personal information requested in the form must be provided. If you fail to provide any of the required personal information, the unprocessed report will be returned to you for completion and resubmission.

Access to Your Information: You may review the records maintained by the Division of Law Enforcement in the Department of Justice that contain your personal information, as permitted by the Information Practices Act. See below for contact information.

Possible Disclosure of Personal Information: In order to verify compliance with the requirements for a gun show or event pursuant to Penal Code sections 27200 through 27350 and to determine the eligibility of prospective firearms, dealers, ammunition vendors, and gun show traders to offer firearms or ammunition for sale display, we may need to share the information you give us with entities as authorized in Penal Code section 11105. The information you provide may also be disclosed in the following circumstances:

- With other persons or agencies where necessary to perform their legal duties, and their use of your information is compatible and complies with state law, such as for investigations or for licensing, certification, or regulatory purposes.
- To another government agency as required by state or federal law.
