If you disagree with the Firearm Dealer Citation, you may appeal the decision(s) to the California Department of Justice (DOJ) by completing this form and explaining why you disagree. You must sign this form and return it to the DOJ either by email to <u>RCU@doj.ca.gov</u>, fax to (916) 731-3354, or mail via USPS to the office address listed at the bottom of this form. <u>Appeals must be postmarked or received no later than 30 days after the date of assessment indicated on the citation</u>. Firearm dealers who are granted an extension to correct a Level 1 or Level 2 violation have an additional 30 days from the new correction due date to file a timely appeal. The deadline to appeal a fine from a Level 3 or Level 4 violation is 30 days even if DOJ granted an extension to correct the violation.

**General Instructions** - Per the California Code of Regulations, title 11, division 5, chapter 2, section 4020, the DOJ <u>must</u> receive <u>all</u> appeals in writing. Clearly identify the facts that form the basis for the filing. Further, the appellant must include a copy of the Firearm Dealer Citation that is being appealed. An appellant may include evidence to support the appeal.
