

## 5 Card Bonus Progressive Jackpot

### **Bureau Requirements**

#### **Advertising**

Larry Flynt's Lucky Lady Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001245) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands and corresponding prize amounts
- Jackpot fee amount and breakdown
- Administrative fees
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The 5 Card Bonus Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at Larry Flynt's Lucky Lady Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Three Card Poker (GEGR-001804)
- Three Card Poker 6 Card Bonus (GEGR-001803)
- Ultimate Texas Hold'em (GEGR-001802)
- Mississippi Stud 3 Card Bonus (GEGR-002063)
- Crazy 4 Poker (GEGR-002060)

#### **Object and Summary**

The 5 Card Bonus Progressive Jackpot features both progressive and fixed jackpot prizes that are linked between five different games, Three Card Poker, Three Card Poker 6 Card Bonus, Ultimate Texas Hold'em, Mississippi Stud 3 Card Bonus, and Crazy 4 Poker. The object of the 5 Card Bonus Progressive Jackpot is to place an optional wager on a hand that the player believes will form a five card qualifying hand, as mentioned below, in order to win a corresponding prize.

1. To begin each round, players must make their regular base game wager. The players may optionally place any bonus bets along with the optional jackpot fee of \$1.
2. Players may place all progressive jackpot fees on the Player Hand sensor, the Player-Dealer Hand sensor or both in front of their betting position to qualify for any progressive or fixed payouts.
  - a. Placing a jackpot fee on the Player Hand sensor signifies that the player believes they will form a qualifying hand.
  - b. Placing a jackpot fee on the Player-Dealer Hand sensor signifies that the player believes that the player-dealer will form a qualifying hand.
  - c. Placing a jackpot fee on both the Player Hand sensor and the Player-Dealer Hand sensor signifies that the player believes that either their hand, the player-dealers hand or both will form a qualifying hand.

3. Once all players have placed their bets and optional jackpot fee(s), the house dealer shall press “Start Game” on the keypad. The sensors shall then light up, indicating participation in the progressive jackpot. The house dealer shall then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
4. The house dealer then follows standard approved procedures for dealing the base game. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.

In Three Card Poker and Three Card Poker 6 Card Bonus, the 5 Card Bonus Progressive Jackpot qualifying hands consider the player’s and/or the player-dealer’s three cards, and the top two (out of three) “community cards” that are dealt and flopped at the conclusion of the hand. The community cards are only used for the purpose of resolving the 5 Card Bonus Progressive Jackpot payouts.

In Ultimate Texas Hold’em, the 5 Card Bonus Progressive Jackpot qualifying hands consider the player’s and/or player-dealer’s two cards (hole cards), and the first three “community cards” (the flop).

In Mississippi Stud 3 Card Bonus, the 5 Card Bonus Progressive Jackpot qualifying hands considers the player’s and/or player-dealer’s two cards (hole cards), and the three “community cards.”

In Crazy 4 Poker, the 5 Card Bonus Progressive Jackpot qualifying hands considers the player’s and/or player-dealer’s 5 hole cards.

### **Qualifying Hands**

Players that make one of the advertised qualifying hands, as shown below, shall be eligible to win their share of the posted prize amount, according to the payout options listed below. All qualifying hands within a chart must be offered together at all times:

#### **5 Card Bonus Progressive Jackpot Qualifying Hands**

Royal Flush	A hand that consists of an ace, king, queen, jack and 10 of the same suit.	Progressive
Straight Flush	A hand that consists of five cards of the same suit in consecutive ranking. A king, queen, jack, 10 and 9 is the highest ranked Straight Flush and a 5, 4, 3, 2 and ace is the lowest ranked Straight Flush.	Progressive
Four of a Kind	A hand that consists of four cards of the same rank. Four aces is the highest ranked Four of a Kind and four 2s is the lowest ranked Four of a Kind.	Fixed
Full House	A hand that consists of a Three of a Kind and a Pair. Three aces and two kings is the highest ranked Full House and three 2s and two 3s is the lowest ranked Full House.	Fixed
Flush	A hand that consists of five cards of the same suit but are not in consecutive ranking. An ace, king, queen, jack and 9 is the highest ranked Flush and a 7, 5, 4, 3 and 2 is the lowest ranked Flush.	Fixed

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- A minimum of two players, a player and a player-dealer, are required to play for this gaming activity.
- Only seated players, who have paid the optional \$1 jackpot fee and are dealt a designated hand, are eligible for payouts.
- Backline bettors are not eligible to place a jackpot collection fee or receive a prize for a qualifying hand.
- If a player with a qualifying hand folds prior to the final betting round, they will still be eligible for the 5 Card Bonus Progressive Jackpot payout.
- There is no limit to how many times a player may win a progressive or fixed prize within a promotional period.
- For Three Card Poker games, a patron may place a base game wager as well as the optional \$1 jackpot fee on any two unoccupied seats, as well as their own, and become eligible for multiple payouts.
- For Ultimate Texas Hold'em, Mississippi Stud 3 Card Bonus, and Crazy 4 Poker a patron may place a base game wager as well as the optional \$1 jackpot fee on any unoccupied seat, as well as their own, and become eligible for multiple payouts.
- The 5 Card Bonus Progressive Jackpot may run concurrently with other Bureau-approved jackpots for the eligible games listed above. Patrons are eligible to win a prize for each jackpot they qualify for.
- Casino employees are eligible for the 5 Card Bonus Progressive Jackpot when off-duty.
- Tournament games are not eligible for this gaming activity.
- Third-Party Provider of Proposition Player Services (TPPPS) are not eligible to place a jackpot collection fee and become eligible for the 5 Card Bonus Progressive Jackpot when in either the player-dealer or player capacity.
- The player-dealer position is not eligible for this promotion.

### **Prize**

Once the proper paperwork has been filled out and the hands have been verified, a casino representative will pay the winners in live casino chips. All monies collected and paid out shall be tracked both electronically and on a hand written log to be maintained by the casino for examination by regulatory and law enforcement personnel.

### **Progressive Prize**

All progressive prizes shall be paid from the 5 Card Bonus Progressive Jackpot prize pool. A player with a Royal Flush is paid 100% of the progressive jackpot amount shown on the progressive meter. A player with a Straight Flush is paid 10% of the progressive jackpot amount shown on the progressive meter. In the event that more than one progressive meter pay is hit, the progressive prize will be equally split among the winners. In the event that there is an odd number of chips, the amount will be rounded up to the nearest dollar paid by the reserve fund.

## 5 Card Bonus Progressive Jackpot

### **Fixed Prize**

All fixed payouts will be deducted from the amount in the reserve fund. In the event that more than one qualifying hand hits during the same round, all fixed prize winning players will be paid 100% of the posted fixed prize amount. In the event that the reserve fund is depleted, the Casino will cover any shortfall. The Casino shall be reimbursed for any shortfall covered once there are sufficient monies in the reserve fund.

### **Prize Payout Structure**

Patrons shall be given ample notice of the actual jackpot prize amount. Furthermore, the amount of the progressive jackpot prize pool shall be displayed prominently within the Casino at all times the 5 Card Bonus Progressive Jackpot is being offered for play.

### **Funding**

The 5 Card Bonus Progressive Jackpot is a player funded progressive jackpot which features fixed and progressive prize elements. The Casino will initially seed the jackpot at a minimum of \$5,000 to a maximum of \$100,000. Once there are sufficient monies in the reserve fund, the initial seed will be reimbursed to the Casino and shall be documented in the accounting records. There is no cap to this progressive jackpot.

After the progressive jackpot is hit, it will be re-seeded by the reserve fund at an amount between a minimum of \$5,000 and a maximum of \$100,000. In addition, this reserve fund will payout all fixed amounts. In the event the reserve fund is depleted, the Casino will make up any shortfall. Once there are sufficient monies in the 5 Card Bonus Progressive Jackpot reserve fund, the re-seed amount, up to the amount the Casino funded, will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. All increases and decreases to the 5 Card Bonus Progressive Jackpot fund shall be documented in the accounting records.

Each \$1.00 jackpot fee paid by a player shall be broken down as follows:

- \$0.20 shall be immediately posted on the meter.
- \$0.80 shall be tracked in a reserve fund.

### **Administrative Fees**

The Casino shall take an administrative fee of \$5 to \$20 per table per hour. The administrative fee shall be taken from the reserve fund. The fee shall cover the costs associated with administering and accounting for the jackpot.

## 5 Card Bonus Progressive Jackpot

### **No Purchase Necessary**

The 5 Card Bonus Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the 5 Card Bonus Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### **Equipment**

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

- When a player has a progressive winner, the dealer shall select the player spot corresponding to the player with the winning progressive hand.
- The house dealer shall then press the appropriate hand button on the display.
- The house dealer shall then contact a casino representative.
- Once the casino verifies the progressive win, a casino representative will press "Confirm", then swipe the authorization card. This records the win onto the Game Manager.
- House procedures are then followed for paying the prize.
- When the house dealer reconciles all action (on behalf of the player-dealer), they press "Game Over." This resets the system to begin the next hand.
- If the electronic software or digital reader malfunctions or breaks down, the jackpot will not be offered.

Baccarat Bonus Hands Promotion

Other names may be used. The GEGA number assigned will be posted on all advertisements, flyers, signs etc generated by Normandie Casino (NC).

2. **Name each controlled game that is associated with this gaming activity:**

21<sup>st</sup> Century Baccarat 5.0, Baccarat, Ultra Baccarat, EZ Baccarat.

3. **Describe any Jackpot or any other type of prize awarded:**

When the following combination of cards occurs, the posted prize will immediately be paid to the player(s) betting on the Player or Banker hands. The posted prize amount will be awarded to each player with a wager on the hand that makes the qualifying hand. Each seated player with a wager on the qualifying hand will receive the posted prize amount; the prize amount will not be split. Players with a backline wager will not be eligible. Both Player and Banker hands must be played and completed according to the approved game rules in order for the table to qualify. Also, a win or lose must occur in order for the player, banker, or both hands to qualify. If the player hand, banker hand, or both hands make qualifying hands, as shown below, and the value of the hands is the same (tie), then the hands do not qualify. However, the hand that achieves a qualifying hand will qualify regardless of whether it wins or loses.

The player hands will qualify regardless of whether the cards are suited or unsuited, so long as they have the three cards specified in the table.

The banker hands will qualify regardless of whether the cards are suited or unsuited, so long as they have the three cards specified in the table.

Only these qualifying hands will be offered, and shall be offered together at all times that this gaming activity is being offered.

**4. If a cash prize is involved, is the amount progressive or a fixed amount?**

The prize is a fixed cash amount and will be prominently posted in the poker area of the casino. The prize amount will range as listed in number 3 and will be determined and displayed prior to the offering of the promotion.

**5. Explain if the gaming activity is House funded or player funded:**

Player funded. \$1.00 will be collected from the Player/Dealer position during each round of play and dropped in a separate affixed collection box attached to the gaming table. This collection box will be counted for and accounted for separately as are the other player funded jackpots in the gambling establishment.

**6. Describe any special fee collection involved in this gaming activity, for example, a Jackpot collection fee.**

\$1.00 jackpot collection fee.

**7. Describe how the Jackpot will be seeded and how prizes will be awarded.**

The jackpot will be initially seeded at \$1,000.00. It will increase by a minimum of \$50.00 per day and the increase will take place by 9:00 AM each morning. If the minimum daily increase is not collected, the casino will cover the different. If more than the minimum daily increase is collected, then all funds will be added to the jackpot fund. Once the jackpot has reached \$5,000.00, the initial \$1,000.00 in seed money shall be refunded to the casino. If a qualifying hand is made and the jackpot fund does not have enough to pay the posted amount to all players that qualify, the casino shall cover the shortfall and will not be re-imbursed for covering the shortfall. The jackpot will not have a cap.

**8. Explain any prize distribution including prizes given to the winner, loser, or any other player or patron.**

A pre-determined and fixed amount of cash (awarded in casino chips) when offered during the designated times.

**9. Explain any re-seeding of the fund once the prize is won.**

The promotion will be made on certain days and times to a pre-determined games.

**10. Explain any minimum or maximum number of players required to be dealt into the game for the table to be eligible for the gaming and activity prize.**

A minimum of two players are need to be eligible for the prize, a player/dealer and a player.

A Third Party Provider of Proposition Player Services (TPPPPS) is not eligible for the Baccarat Bonus Hands Promotion when in either the player-dealer or player capacity.

No Limit and Limit Texas Hold'em, 7 Card Stud, Low Ball, Omaha Hi-Lo, Pai Gow Poker, Pure 21.5 Blackjack, Three Card Poker, Easy Poker, Lightning Poker, Super 9, Blackjack, 13 Card, Card Craps, Caribbean Stud, 21<sup>st</sup> Century Baccarat, Pai Gow Tiles.

3. **Describe any Jackpot or any other type of prize awarded:**

A player who achieves a designated qualifying hand in a particular game during the posted eligibility period receives the opportunity to place his or her name on the football board (which is a board containing 100 squares) and predict the final score for both teams competing in the particular football game (i.e., Monday Night Football game). The squares on the football board are filled up prior to the start of the particular game. At the end of each quarter of the game the player with the square that corresponds to the then current score wins a cash prize of \$100-\$1,000 as posted. At the end of the game the winning players from each quarter are then eligible to win a cash prize of \$1,000-\$5,000 as posted with the prize being awarded to that player who has correctly predicted the final score.

Designated Qualifying Hands for each game are as follows:

Hold'em, Seven Card Stud, Easy Poker, Lightning Poker: Aces Full or Better (unless all the squares are not filled three hours before the football game is scheduled to start in which case the designated qualifying hand is Full House or Better)

Lowball: Wheel with or without a Joker

Pai Gow Poker: Full House or better

Blackjack games: Ace/King Suited or Ace/Picture Suited, as posted (unless all the squares are not filled three hours before the football game is scheduled to start in which case the designated qualifying hand is any Blackjack)

Baccarat: Suited Nine  
Three Card Poker: Three of a Kind or Better  
Caribbean Stud: Straight or Better  
Super 9: Any 3-3-3  
13 Card: Four of a Kind in back hand with Flush in middle hand  
Card Craps: Seven on first draw

**4. If a cash prize is involved, is the amount progressive or a fixed amount?**

The cash prize is initially fixed but is then progressive if there is no winner. The cash prize awarded at the end of each quarter must be claimed before the start of the next quarter. If this cash prize is not claimed before the start of the next quarter it carries over to the next quarter of the same football game. The cash prize awarded at the end of the game must be claimed within 30 minutes of the end of the game.

House funded.

## Blazing Sevens Progressive Jackpot

### Object and Summary

A player that makes one of the qualifying hands listed below for the Blazing Sevens Progressive Jackpot is eligible to win either a fixed prize or the progressive prize amount.

1. To begin each round, players must place a base game wager in order to qualify for the jackpot. Along with any bonus bets the player places a wager on, player(s) have the option to place an optional \$1 jackpot fee and become eligible for the jackpot.
2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players who wish to participate must place the jackpot fee on the sensor. The sensor will then light up.
3. Once all players place their controlled game wagers and jackpot fees, the house dealer will press "Start Game" on the keypad. The sensors will then light up, indicating participation in the progressive gaming activity.
4. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
5. The house dealer then follows standard approved procedures for dealing the controlled game. Any player who makes a qualifying hand will be paid out, as described below.

Players, who make one of the advertised qualifying hands, shall be eligible to win their share of the posted prize amount, according to the payout options, as shown below. All hands within the chart must be offered together at all times this promotion is offered for play.

- A player can qualify for the jackpot element of the game regardless of the outcome of the controlled game.
- A minimum of two players, a player and the player-dealer, are required to be dealt into the base game in order for the table to qualify for this promotion.
- There is no minimum amount of time that must be played in order for an eligible table to qualify for the jackpot.
- There is no limit to the number of times a patron may win a prize during any promotional period.
- Casino employees are eligible to participate when off duty and out of uniform.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible for this promotion.

All monies collected and paid out shall be tracked both electronically and on a hand written log to be maintained by the casino for examination by regulatory and law enforcement personnel.

- Three seven's (7s) of the same color is paid 100% of the progressive jackpot amount shown on the progressive meter.
- All other hands are paid a fixed amount from the reserve fund. They do not get deducted from the amount shown on the meter.
- In the event more than one player achieves a winning progressive hand, all winning players will share, in equal amounts, the posted progressive prize.
  - In the event there is an odd number of chips, the odd amount will be awarded to the patron seated closest to the first action position.
- In the event more than one player achieves the same winning fixed hand, all winning players will be paid the posted fixed prize.
  - In the event the reserve fund is depleted, the Casino will make up any shortfall. The Casino shall be reimbursed for any shortfall covered once there are sufficient monies in the reserve fund.
- Players who are playing multiple hands are eligible to place multiple jackpot fees and qualify for multiple prizes.
- All progressive and fixed payouts will be paid by a casino representative.
  - Once the proper paperwork has been filled out, a casino representative will immediately pay the winner(s) in live casino chips from the cage. No payouts will be made from the house dealer's tray.

### **Funding**

The Blazing Sevens Progressive Jackpot is a player funded progressive jackpot which features fixed and progressive prize elements. The Casino will initially seed the jackpot at a minimum of \$1,000 to a maximum of \$50,000. Once there are sufficient monies in the Blazing Sevens Progressive Jackpot fund, the initial seed will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. There is no cap to this progressive jackpot.

After the progressive jackpot is hit, it will be re-seeded by the reserve fund at an amount between a minimum of \$1,000 and a maximum of \$50,000. In addition, this reserve fund will payout all fixed amounts. In the event the reserve fund is depleted, the Casino will make up any shortfall. Once there are sufficient monies in the Blazing Sevens Progressive Jackpot reserve fund, the re-seed amount, up to the amount the Casino funded, will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. All increases and decreases to the Blazing Sevens Progressive Jackpot fund shall be documented in the accounting records.

Each \$1 jackpot fee paid by a player will be broken down as follows:

- \$0.20 will be immediately posted on the meter.
- \$0.80 will be tracked in a reserve fund.

## Blazing Sevens Progressive Jackpot

### Administrative Fees

The casino will take an administrative fee ranging from \$10 - \$16 per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with the complicated computer system and program in addition to technicians having to service the systems.

### No Purchase Necessary

The Blazing Sevens Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Blazing Sevens Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### Equipment

The electronic software and digital reader related to and used in conjunction with this gaming activity has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

1. When a player has a progressive winning hand, the dealer shall press the appropriate hand button on the keypad.
2. The house dealer shall then contact a supervisor.
3. Once the Casino verifies the progressive win, the supervisor will press the confirm button.
  - a. To complete the action, a Supervisor or Executive card (depending on jackpot level) swipe is required.
  - b. This records the win onto the Game Manager computer and adjusts the meter appropriately for the prize won.
  - c. House procedures are then followed for paying the prize. (Reviewing the monitor connected to the Game Manager will show the prize amount to be paid, and pressing the "money bag" icon will print a win page, which can be used to help record the payout for accounting.)
4. When the dealer reconciles all action, he presses "END GAME". This resets the system to begin the next hand.
5. Once the Supervisor or Executive card (depending on jackpot level) is swiped, the prize is logged into Game Manager. If the progressive pay needs to be backed out at this point, the award will need to be manually backed out using the Game Manager manual adjustment feature.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, will be prominently displayed in Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Bonus Chip values
- Buy-in amount for Bonus Chips
- Whether the Bonus Chip is single-use or multi-use
- Procedures to redeem Bonus Chips
- Any other applicable restrictions and/or information

#### **Eligible Controlled Games**

The Bonus Chip Promotion will be attached to all Bureau approved California games offered at Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered for play. All controlled game rules will be played as approved by the Bureau.

#### **Object and Summary**

The Bonus Chip Promotion will be open to all patrons who buy-in for a predetermined amount ranging from \$5 to \$100,000; those patrons will receive a specific amount of Bonus Chips to play in any controlled game listed above. When patrons buy-in to a predetermined game for a predetermined and posted amount ranging from \$5 to \$100,000, they will receive a predetermined and posted amount ranging from \$5 to \$200,000. The Bonus Chips are of a different style and design from the standard live casino chip ("casino chips"). The Bonus Chips cannot be exchanged for cash and must be played on the gaming table, at the predetermined game. Once the Bonus Chip(s) has been placed as a wager, the following applies:

- If the player wins, the player will receive live casino chips for his/her bet from the player-dealer. The player either retains the Bonus Chips to be used again or it will be collected by the house dealer and placed in the drop box for accounting purposes.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands
- Prize payout structure
- The prize amount that shall be awarded
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The EZ Baccarat Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at Larry Flynt's Lucky Lady Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- EZ Baccarat (GEGA-002992)

#### **Object and Summary**

The EZ Baccarat Progressive Jackpot adds an optional \$1 player-funded progressive and fixed jackpot elements to the game of EZ Baccarat (GEGA-002992). The EZ Baccarat Progressive Jackpot considers both the player and banker hands. To begin each round, players must make their regular base game wager. Players may place any bonus bets along with the optional jackpot fee of \$1. Once the house dealer removes all jackpot fees from the table, the jackpot fees shall be dropped into a separate and locked jackpot collection box. The house dealer then follows standard approved procedures for dealing the base game. A player is NOT required to place a wager on the Dragon 7 Bonus Bet or the Panda 8 wager in order to be eligible to place an optional \$1 jackpot fee on the EZ Baccarat Progressive Jackpot. This promotion shall be available at predetermined dates and times posted in the Casino. When a winning hand is confirmed, the player with the qualifying jackpot hand shall receive either a progressive jackpot prize or a fixed prize, depending on the winning qualifying hand.

1. "Hockey Puck" discs shall be attached to the table in front of each betting position. These discs have a sensor and shall detect when a casino chip is placed on them. Players must place the jackpot fee on the sensor. The sensor shall then light up.
2. Once all players have placed their base wagers and optional jackpot fees, the house dealer shall press "Start Game" on the keypad. Patrons shall be provided with ample advance notice of what the qualifying hands are, as well as the requirements for completing the qualifying hands. Furthermore, the qualifying hands shall be displayed prominently within the Casino at all times the EZ Baccarat Progressive Jackpot is being offered for play.

Players that make one of the advertised qualifying hands, as shown below, shall be eligible to win their share of the posted prize amount, according to the payout options, as shown below. All qualifying progressive and fixed hands within a chart and listed below must be offered together at all times.

All cards in the banker hand must be the same color. <b>Example:</b> All cards in the player hand are red and all cards in the banker hand are black. Or all cards in both the player and banker hands are all red.
Panda 8 vs. Dragon 7 - Any	The player hand wins with a three-card total of 8 points and the banker hand loses with a three-card total of 7 points.

### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- There is no time requirement for how long a game must be played in order to be eligible for an EZ Baccarat Progressive Jackpot payout.
- There is no limit to the number of times a player may win the EZ Baccarat Progressive Jackpot during the promotional period. A player may only win once per hand.
- A player must make a base game wager in order to be eligible for this jackpot.
- A minimum of two players, a player and a player-dealer, are required in order for the table to be eligible to participate in the EZ Baccarat Progressive Jackpot.

Players that make one of the advertised qualifying hands, as shown above, shall be eligible to win their share of the posted EZ Baccarat Progressive Jackpot prize amounts, according to the payout option as shown below. Patrons shall be provided with ample advance notice of the prize payout being offered for play. Furthermore, it shall be displayed prominently within the Casino at all times the EZ Baccarat Progressive Jackpot is being offered for play.

## **EZ Baccarat Progressive Jackpot**

### **Funding**

The EZ Baccarat Progressive Jackpot is a player-funded jackpot with both fixed and progressive elements, which is funded by an optional \$1 jackpot fee. The Casino shall initially seed the jackpot at a minimum of \$1,000 to a maximum of \$100,000. Once there are sufficient monies in the EZ Baccarat Progressive Jackpot reserve fund, the initial seed shall be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records.

After the progressive jackpot is hit, it shall be re-seeded from the reserve fund at an amount between \$1,000 and \$100,000. In addition, this reserve fund shall payout all fixed prize amounts. In the event the reserve fund is depleted, the Casino shall make up any shortfall. Once there are sufficient monies in the reserve fund, the re-seed amount, up to the amount that the Casino funded, shall be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. All increases and decreases to the EZ Baccarat Progressive Jackpot reserve fund shall be documented in the accounting records.

Each \$1 jackpot fee shall be broken down as follows:

- a. \$0.15 shall be immediately posted on the meter.
- b. \$0.85 shall be tracked in a reserve fund.

### **Administrative Fees**

The Casino shall retain an administrative fee ranging in an amount between \$1 and \$16, taken per table per hour. The administrative fee shall be taken from the reserve fund. The fee shall cover the cost associated with the complicated computer system and program in addition to technicians having to service the systems.

### **No Purchase Necessary**

The EZ Baccarat Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the EZ Baccarat Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### **Equipment**

The electronic software and digital reader related to and used in conjunction with this gaming activity has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI). If there is a malfunction or the digital reader breaks, the jackpot shall not be offered.

- When a player has a progressive qualifying hand, the house dealer shall press the appropriate hand button on the keypad.
- The house dealer shall then contact a supervisor.
- Once a supervisor verifies the progressive win, the supervisor shall press the confirm button. To complete the action, a supervisor or executive card (depending on jackpot level) swipe is required. This records the win onto the Game Manager computer and adjusts the meter appropriately for the prize won. House procedures are then followed for paying the prize. (Reviewing the monitor connected to the Game Manager shall show the prize amount to be paid, and pressing the "money bag" icon shall print a win page, which can be used to help record the payout for accounting).



## **EZ Baccarat Progressive Jackpot**

- When the house dealer reconciles all action, he/she presses “END GAME.” This resets the system to begin the next hand.
- Once the supervisor or executive card (depending on jackpot level) is swiped the prize is logged into Game Manager.
  - If the progressive pay needs to be backed out (voided) at this point, the prize shall need to be manually backed out using the Game Manager manual adjustment feature.

- The date(s) and time(s) the gaming activity shall be offered.
- The prize(s) offered for meeting the requirements of the gaming activity.
- The time required to play and method to redeem in order to earn food.
- How time will be tracked through the Players Reward Program (GEAR-000955) or a log.

#### **Eligible Controlled Games**

**Funding**

The Casino will initially seed the jackpot at \$1,000. Once there are sufficient monies in the Fortune Pai Gow Poker Progressive Jackpot fund, the initial seed will be reimbursed to the Casino and shall be documented in the accounting records. After the progressive jackpot is hit it will be re-seeded at \$1,000.

  - In games without a flop (i.e. 7 card stud), players would need to have a complete 5 card hand to qualify.
- In Texas Hold'em games, the player dealt a qualifying hand must use both of their hole cards.
- In Omaha and Omaha Hi-Lo games, the player dealt a qualifying hand must have a pocket pair in order to qualify for quads.
- In stud format games, the player dealt a qualifying hand may use one, two, three, or all four (when applicable) hole cards.
- In Texas Hold'em and Omaha, players must use two hole cards in order to qualify for straight flushes and royal flushes.
- Players do not have to win the hand in order to be eligible for the promotional prize.
- All qualifying hands must be verified by a casino representative in order to be eligible. Any deviation from a standard deck will nullify the hand.
- In the event that one or more players at a table have the same qualifying hands (ex: straight flushes), only the highest hand by suit will be paid out. The suit ranking from highest to lowest shall be spades, hearts, diamonds, and clubs.



## High Hand Giveaway Promotion

- In the event that multiple players have qualifying hands (ex: all qualifying hands are present in the game) each player will be paid the promotional prize.
- In the event two or more players have the exact same qualifying hand at the same time in a stud format game, the prize will be split evenly among the players. If the prize is a non-cash item, then the cash value of the prize will be split among those players.
- There is no limit to the number of times a player may win a prize through this promotion.
- Casino employees are eligible to participate in this promotion, on or off duty and in or out of uniform.
- Tournament games (GETR-000117) are eligible for this promotion.

### **Prize**

The High Hand Giveaway Promotion features progressive prize amounts of \$10 to \$100,000 paid in the form of live casino chips, cash, merchandise, promotional chips (GEAR-001020), or gift certificates. Each progressive prize will start at \$10 and will increase regularly by a predetermined and posted amount (paid by the Casino) until a qualifying hand is achieved.

***Example:** Every 24 hours the Straight Flush, Royal Flush, and Quads progressive prizes will increase by \$100 and the updated prize amounts will be updated on all promotion literature.*

Each progressive prize will have a cap of \$100,000, however the cap may be lowered as determined based on different promotional periods and will be advertised by Larry Flynt's Lucky Lady Casino throughout the gaming floor and in all literature promoting such an event. In addition, once the value of the cap has been decided and posted for a promotional period, the cap can not be modified until a new promotional period has begun. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

- Qualifying hands and corresponding prizes
- Jackpot fee required
- The prize amount that shall be awarded and how it shall be distributed between all eligible players
- "Prize Multiplier" eligibility (including times, dates, and funding source)
- Any No Purchase Necessary opportunity
- Any other restrictions that apply to this gaming activity

#### **Object and Summary**

The Jackpot Games gaming activity features a progressive jackpot prize element funded by a \$1 jackpot fee per active player and is taken from the pot, by the house dealer after the flop (for Texas Hold'em, Omaha, and Omaha High-Low Split) or after the Fifth Street (for Seven Card Stud and Seven Card Stud High-Low Split). A prize is awarded to players participating in any designated poker game, as stated above, when a designated second hand, which contains two hole (face-down) cards, is beaten by a better qualifying hand at the showdown. When the winning and losing hands are confirmed by a casino representative, the players with the qualifying hands will receive the posted percentage of the jackpot prize. Additionally, a posted percentage of the jackpot prize, known as the Table Share, shall be evenly distributed among all other seated players at the qualifying table who have participated in the designated game and placed a jackpot fee, as shown below. In all instances, patrons will be provided with ample advance notice of the percentage division of the posted jackpot prize for the game in which they are playing.

## Jackpot Games

### Qualifying Hands

### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- Players with qualifying winning and losing hands must play through the showdown in order to qualify for the jackpot.
  - If a player with one of the qualifying hands folds prior to the final betting round, the table will be in-eligible for the jackpot.
- There must be a minimum of four players dealt in an eligible controlled game in order for players to be eligible and the tables to qualify for the Jackpot Games prize.
- At least two hole cards must be used in both qualifying hands in order to qualify for the jackpot.

- The jackpot prize will be awarded as soon as possible after the winning and losing hands have been verified by a casino representative and all necessary paperwork and documentation are completed.
- Casino employees shall be eligible to participate in the Jackpot Games gaming activity whether on or off duty, in or out of uniform.
- Players participating in poker tournament games are not eligible to participate in the gaming activity.
- There is no limit on how many times players can win this promotion.

### Prize

The progressive jackpot prize shall be based on the amount of jackpot fees collected and shall be paid out in live casino chips.

## Jackpot Games

### **Funding**

The Jackpot Games shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Jackpot Games. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

## **Live Action Tournament Promotion**

### **Bureau Requirements**

#### **Advertising**

Larry Flynt's Lucky Lady Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001027) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered for play:

- Eligible game(s) and table(s).
- Eligible dates and time period(s).
- Amount to be added to the pot (prize amount).
- Prize value.
- Availability of No Purchase Necessary.
- Any other restrictions that apply to this gaming activity.

#### **Eligible Controlled Games**

The Live Action Tournament Promotion shall be attached to all Bureau approved Poker games offered at Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The Live Action Tournament Promotion features a promotional element attached to all the Bureau approved Poker games offered at Larry Flynt's Lucky Lady Casino. The Live Action Tournament Promotion is an event within a live poker game. The live poker games selected for the Live Action Tournament Promotion will be discretionary to the Casino and the chosen tables selected will be posted in advance and in a conspicuous place. The Casino will choose the games/tables to be used in the promotion based on business interests, such as whether a particular game may be underperforming and therefore, require the promotion to enhance the appeal and economic status. The Casino may elect to run the promotion for different games concurrently, but the games would be separate, i.e. a separate live game tournament for Omaha and Hold'em, at the same time.

The Casino will award players who have collected the most Live Action Tournament chips during a pre-determined and designated time period with a chance to win cash prizes or additional prizes such as promotional items or entry into tournaments. Prizes will have a value between \$50 and \$10,000.

The top three players with the most Live Action Tournament Promotion chips at the end of the promotional period will be eligible to win their share of the Live Action Tournament Promotion prize. Prize amounts will be based on the payout table being used, as shown below. Only one of these options may be offered at any one time.

## Live Action Tournament Promotion

Eligible tables are based on specific games and limits that are predetermined a week before the promotion is offered. Once all tournament chips have been awarded during the promotional period, a floor person will count them and determine the first, second and third place finishers in terms of total tournaments chips earned. Players with Live Action Tournament chips collected during the time-period have to be present when the Live Action Tournament chips are counted. Prizes will then be awarded to each player, according to the payout tables below. At the conclusion of the tournament, players are allowed to negotiate a deal between each other with the assistance of the poker floor staff. If by chance three or more players have the same amount of Live Action Tournament chips, the players will evenly split the remaining prize pool. Once the winners are declared, the winners have 180 days to claim their corresponding prize. If the prize is not claimed, unclaimed prizes will be turned over to the State of California by virtue of the abandoned funds process.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- There is a minimum of two players required to be playing in the eligible poker game, as listed above, in order for the game to qualify.
- All winning hands, when the pot contains the tournament chips, will be verified by the house dealer and a casino floor person.
- The tournament chips may not be exchanged for live chips or given to another player.
- The tournament chips must stay on the table in clear view of the players, house dealer, and casino floor person.
- Up to the three players who have won the most tournament chips will win a pre-determined and designated prize.
- Not all players who receive a tournament chip will win.
- In the event of a tie during the eligible game:
  - If there is an even number chips at stake, then a split pot would equal one chip each.
  - If there are an odd number of chips, or more people tied than chips to be won, one chip would go to each person who gets a share of the pot, beginning left of the dealer button, until the supply is exhausted.
- Casino employees are eligible for the promotion only when off-duty and out of uniform.
- Poker tournament games do not qualify for this promotion.

The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Live Action Tournaments Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

A prize is awarded to players who placed a jackpot fee and is participating in an eligible game when a designated hand held by a player, is beaten by a better qualifying hand held by the player-dealer position. When the winning and losing hands are confirmed, the players with the qualifying hands shall receive the posted percentage of the jackpot prize. Additionally, a posted percentage of the jackpot prize, known as the Table Share, shall be evenly distributed among all other seated players at the qualifying table who have participated in the designated game and placed a jackpot fee, as shown below. Only one of these options may be offered at any one time. Patrons shall be given ample notice of which option is being offered for each eligible game. Furthermore, it shall be displayed prominently via printed flyers, digital display, and any other forms of advertisements.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- One qualifying hand must be held by the player-dealer position and one hand must be held by a player position in order for the table to qualify for the jackpot.
- Backline bettors are not eligible to win a prize or receive a share of the jackpot prize amount.
- A minimum of two players, a player and a player-dealer, must be dealt into the game in order for the table to qualify for the jackpot.
- When a qualifying jackpot hand is announced, a casino representative shall verify that both hands qualify. Any deviation from a standard deck shall nullify the jackpot. Prize shall be paid out at the cage. Prize shall be paid out once valid identification is presented at the cage. Prizes not claimed in a predetermined reasonable amount of time shall be added back towards the prize pool.
- In the event that during a round of play, two or more players have qualifying losing hands against the player-dealer, the player with the higher ranked qualifying hand shall receive the "Losing Hand" prize percentage for the jackpot. The remaining players, including those who had lower ranked qualifying hands, shall receive the posted prize percentage for the Table Share.

### **Prize**

The jackpot prize shall start at a minimum of \$200 and progress based on the number of jackpot fees collected. Jackpots may be paid in the form of cash, live casino chips, CA/Asian Promotional Chips (GEAR-001021), or Poker Promotional Chips (GEAR-001020). The actual jackpot prize amount shall depend on the amount the jackpot was originally seeded, as well as, how much time has accumulated in order for the jackpot to increase progressively each day. The actual jackpot prize amount shall be posted within Larry Flynt’s Lucky Lady Casino at all times the jackpot is being offered for play. Patrons shall be given ample notice of the actual jackpot prize amount.

### **Prize Payout Structure**

Players that make the advertised hands, as shown above, shall be eligible to win their share of the Pai Gow Gold Progressive Jackpot prize amount based on the payout table being used, as shown below. Only one of these options may be offered at any one time. Patrons shall be given ample notice of which option is being offered for each eligible game. ## **Pai Gow Gold Progressive Jackpot**

### **Funding**

The Pai Gow Gold Progressive Jackpot utilizes one jackpot reserve fund which shall be funded by an optional \$1 jackpot fee paid by players in order to participate in the gaming activity. The \$1 jackpot fee shall go directly to the jackpot reserve fund and shall be collected prior to the dealing of any cards and dropped in a separate drop box by the house dealer. The prize pool shall initially be seeded by Larry Flynt's Lucky Lady Casino in the amount of \$200 to \$5,000. Once sufficient funds are available in the jackpot reserve fund, the Casino shall be reimbursed the seed amount. The prize pool shall have no cap. Larry Flynt's Lucky Lady Casino shall retain an administrative fee between \$4 and \$6 per table per hour from the jackpot reserve fund to maintain the Pai Gow Gold Progressive Jackpot. The fee shall cover the costs associated with administering and accounting for the jackpot.

### **No Purchase Necessary**

The Pai Gow Gold Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Pai Gow Gold Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

The player who posts the highest Pai Gow Poker hand during each three hour period of the promotion has the opportunity to choose an envelope containing a cash prize as posted. A hand of Jacks Full or higher (no joker) is necessary to qualify for the prize.

**4. If a cash prize is involved, is the amount progressive or a fixed amount?**

A fixed amount per envelope.

**5. Explain if the gaming activity is House funded or player funded:**

Player funded.

Four Jokers = Up to \$200

Five Jokers = Up to \$700

Six Jokers = Up to \$2,500

A fixed amount as set forth on the cash wheel corresponding to the designated qualifying hand.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered for play:

- Corresponding time played and "Lucky Bucks" amount.
- The date(s) and time(s) the gaming activity shall be offered.
- How the number of points earned corresponds to the amount in prize value.
- The possible prize(s) offered for meeting the requirements of the gaming activity.
- The possible bonus rates offered on play during off-peak hours or in specific games.
- The redemption period will be displayed in Larry Flynt's Lucky Lady Casino to give players ample notice.

#### **Object and Summary**

The Player Rewards Program features a promotional element attached to all California and Poker games offered at Larry Flynt's Lucky Lady Casino. This gaming activity is a loyalty reward program open to all Larry Flynt's Lucky Lady Casino patrons. This promotion will reward players with Lucky Bucks based on time of play at designated table games during pre-determined and eligible periods.

#### **How Player Points/Prizes are Earned Based on Time Played**

Points/Prizes shall be earned based on the amount of time played. Each player who plays a Bureau approved game shall have their Player Rewards Card scanned/swiped and their hours played shall be tracked.

- The player will receive points to gain them the eligibility to win a pre-determined and designated prize(s).
- Players shall be able to redeem their points at a rate of \$.25 to \$5 per hour of play.
- Prior to the promotional period a sign(s) will state how many Lucky Bucks will be earned per hour and any other details and/or restrictions.
- The Casino may offer bonus rates.
  - An example is double Lucky Bucks on play during off-peak hours or in specific games as long as it is within the specified range.
- Patrons will be given ample notice of how many Lucky Bucks will be awarded as well as the amount of time or number of hands required to earn points for each eligible controlled game.

## Player Rewards Program

### How Player Points/Prizes are Redeemed

Players may either redeem their Lucky Bucks at any time during the promotion. All prizes shall have a pre-determined and designated value. After a player has accumulated a pre-determined and specific amount of Lucky Bucks, based on time of play, a player may redeem the accrued Lucky Bucks for a pre-determined and designated prize.

- After a player has been awarded a prize, they may also be eligible for multiple and subsequent prize(s) until the end of the promotion.

- Player's can sign up for a Player Rewards Card free of charge. Lost or damaged cards shall be replaced at a fee to the player not to exceed \$5 cash or Lucky Bucks.
- Player information shall be maintained in a secure database accessed only by casino management. Access to the database will also be tracked by casino management.
- Points in accounts with no new activity (points accrued) for a period of six months shall expire. The account shall remain in the system indefinitely.
- Players are tracked per hour by having their card scanned by a designated floor person when they sit down to start playing. They remain in the system accruing time for the full hour until another scan is completed. If patrons play for the last 15 minutes before a scan, they shall qualify for the scan for that hour.
- Only the network administrator(s) has access to the back-end systems where the data is stored. Access to the data is by user level with multiple levels based on what the user will be doing.
  - Managers can edit time (i.e. if the player forgot to have their card scanned/swiped and need time added); floor persons can log players into the system if the player forgot their card.
- All data is backed up.
- A printable record of the amount of time a player has accumulated during the period of time the gaming activity is being offered, shall be available at anytime the player requests.

## **Player Rewards Program**

This gaming activity shall be open to all players 21 years of age and older with valid identification that sign up for a Player Rewards Card and participate in an eligible game for a designated period of time to earn Lucky Bucks. When the player chooses to exchange their accrued Lucky Bucks, they shall win a corresponding prize.

- Players must be seated and playing at a designated table in order to qualify for the promotion.
- There is no minimum or maximum amount of players required to be playing in a designated game in order for the table to be eligible for the promotion.
- There is no minimum or maximum amount of prizes that may be claimed by a player.
- Players may participate and win other promotions running concurrently.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered:

- Eligible games and time periods.
- Qualifying losing hands.
- The prize amount to be awarded.
- Availability of No Purchase Necessary.
- Any other restrictions that apply.

### **Eligible Controlled Game**

The Pocket Aces Cracked shall be attached to the following Bureau approved controlled games offered at the Larry Flynt's Lucky Lady Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

### **Object and Summary**

The Pocket Aces Cracked gaming activity features a fixed jackpot prize element attached to the eligible controlled game listed above. The jackpot prize is awarded to the player(s) participating in a game when he/she has a hand containing a pair of pocket aces (the two hole cards are pair of aces) and is beaten by a better hand at the showdown. Conspicuous signs will be posted throughout the casino with promotion times.

### **Qualifying Hands**

Players with pocket aces and their hand beat by a higher ranked hand on the showdown will be eligible to win the Pocket Aces Cracked promotion prize amount.

## Pocket Aces Cracked

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

- All players who are seated at the designated tables are eligible to win the jackpot.
- When this promotion is hit, the losing hand will win according to the payout table above.

#### **Eligible Controlled Games**

The Pays to Play promotion shall be attached to the following Bureau approved controlled games offered at Larry Flynt's Lucky Lady Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGR-001815)

#### **Object and Summary**

Players can earn a cash prize payout for every 100 hour increments of play during one calendar month in a controlled game, as listed above, during a pre-determined and posted time. Accumulated hours will be rounded down to the nearest 100 when calculating the cash prize. Player's time will be tracked via an hourly scan of their Player Rewards Card (GEAR-000955) at each one of the qualifying tables. Player's cards will be scanned hourly by a casino employee. The hours played will be sent to the player tracking database. Players can check how many hours they have accumulated at the concierge desk by presenting their Player Rewards Card. Players can claim their prize by using their player rewards card to print out a voucher at the kiosk, then redeeming the voucher for cash.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- A minimum number of two players are required to be seated and playing at the table in order to qualify for the promotion.
- Must play 100 hour increments in one calendar month in order to be eligible for the prize.
- Hours of play will not roll over from one month to the next.
- Players must use their Player Rewards Card to earn points.
- The play time is non-transferable.
- Players are eligible to participate in promotions running concurrently.
- There is no limit on how many times a player can win this promotion.

## **Poker Pays to Play**

- Employees of the Larry Flynt's Lucky Lady Casino are not eligible for this promotion.
- Players cannot earn points during tournament play.
- The Third Party Provider of Proposition Player Services is not eligible for this promotion.

### **Prize**

The Poker Pays to Play promotion awards a cash prize of \$500. There currently is no expiration date for players to claim their cash prizes.

### **Funding**

The Poker Pays to Play promotion is house funded. There are no collection fees associated with this promotion, other than those involved in the base game during live play.

### **Administrative Fees**

There is no administrative fee associated with the Poker Pays to Play promotion

### **No Purchase Necessary**

The Poker Pays to Play promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

## **Poker Promotional Chips**

### **Bureau Requirements**

#### **Advertising**

Larry Flynt's Lucky Lady Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001020) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods.
- Poker Promotional Chip values.
- Procedures to wager with Poker Promotional Chips.
- Any other applicable restrictions.
- Any other restrictions that apply to this gaming activity.

#### **Eligible Controlled Games**

The Poker Promotional Chips gaming activity shall be attached to all Bureau approved poker games offered at Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

Players may receive Poker Promotional Chip coupons in magazines, web-sites, or mailing advertisements.

- A Poker Promotional Chip coupon must be re-deemed at the cage for a Poker Promotional Chip(s).
- Poker Promotional Chip(s) will have a specific non-cash value printed on them.
- Poker Promotional Chip(s) are used as the player's wager and placed in the pot for the controlled game in which they are playing. In order to keep track of players who use a Poker Promotional Chip, the house dealer shall place a marker in front of each player who uses a Poker Promotional Chip.
- In the case that multiple players place a Poker Promotional Chip in the pot, the house dealer will exchange all but one of the Poker Promotional Chips with equal valued live chips before the pot is paid out (except with some split pot situations, noted below).
- When player uses a Poker Promotional Chip and wins, he or she will win the pot as well as receive the Poker Promotional Chip back for later use. The Poker Promotional Chip may continue to be used until the player loses.
  - If the winner of the pot did not use a Poker Promotional Chip as a wager, the house dealer will take the Poker Promotional Chip from the pot and exchange it with an equal valued live chip. The live chip will be added back to the pot and shall then be awarded to the winner.
- When a player uses a Poker Promotional Chip or not, if he or she loses, the pot shall be lost as normal.
- When two or more players split a pot (that includes a Poker Promotional Chip), and none of the players splitting the pot used a Poker Promotional Chip; the Poker Promotional Chip shall be exchanged with an equal valued live chip and the pot shall be split equally with any odd chips going to the player closest to the dealer button.

## Poker Promotional Chips

- When two or more players split a pot (that includes a Poker Promotional Chip), and one of the players splitting the pot used a Poker Promotional Chip; the pot shall be split evenly with the Poker Promotional Chip going to the player with a lamer and with odd chips going to the player closest to the dealer button.
- When two or more players split a pot (that includes Poker Promotional Chips), and two or more of the players, but not all (Ex. 3 of the 4 players splitting) used a Poker Promotional Chip; the pot shall be split evenly with the Poker Promotional Chips going to the player with lamers and with odd chips going to the player closest to the dealer button.
- When two or more players split a pot (that includes Poker Promotional Chips), and all players splitting the pot used a Poker Promotional Chip; the pot shall be split evenly, including Poker Promotional Chips (odd number shall be exchanged with live chips). Any odd live chips shall go to the player closest to the dealer button.

**Example:** *Three out of five players at a Texas Hold'em game each place a Poker Promotional Chip in the pot as a wager. The house dealer shall place a lamer in front of each of three players who used a Poker Promotional Chip. The house dealer shall then exchange two of the three Poker Promotional Chips with equal valued live chips, so that only one Poker Promotional Chip will be left in the pot. If one of the three players who wagered with a Poker Promotional Chip wins, he or she shall receive the pot and the Poker Promotional Chip to be used again. If one of the other two players (who did not use a Poker Promotional Chip) wins, the house dealer shall exchange the Poker Promotional Chip (that was placed in the pot) with an equal live chip and place the Poker Promotional Chip in the drop box. The house dealer shall then award the winning player the pot as normal. A player who loses his or her hand shall lose their Poker Promotional Chip (if wagered) and shall lose the pot as normal.*

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- There is no minimum or maximum number of players required to be playing in a game in order for the table to qualify for the use of the Poker Promotional Chips gaming activity other than the number of players required for game play.
- Poker Promotional Chips may only be used during approved Poker games. Each Poker Promotional Chip coupon will state the specific qualifying game(s) that a player may use the promotional chips at, the value of the promotional chip(s), and will also include an expiration date.
- Players may not exchange Poker Promotional Chip coupons or Poker Promotional Chip(s) for live chips or give them to another player. They will only be exchanged by the house dealer in a poker game.
- A player is only eligible to redeem one (1) Poker Promotional Chip coupon during a promotional period. A player who exchanges a coupon for a promotional chip will write their name on the coupon. The Casino will use the signed coupon to log the use of the promotional chips.
- Players may use Poker Promotional Chips with live chips when making a bet.
- Poker Promotional Chips may not be used to satisfy a jackpot or collection fee.
- Poker Promotional Chips may not be used in tournaments.

## **Poker Promotional Chips**

- Casino employees are eligible to participate in this gaming activity when off work and out of uniform.
- All procedures, times, and prize amounts must be displayed prominently via any form of advertising that Larry Flynt's Lucky Lady Casino wishes to utilize, including but not limited to printed flyers, digital display, the Casino's website, etc.

### **Prize**

A Poker Promotional Chip(s) will have a non-cash face value ranging from \$1 to \$500.

### **Funding**

The Poker Promotional Chips gaming activity will be fully funded by Larry Flynt's Lucky Lady Casino. There will be no additional promotion fees, jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate.

### **Administrative Fees**

Larry Flynt's Lucky Lady Casino shall not retain an administrative fee as part of this promotion.

### **No Purchase Necessary**

The Poker Promotional Chips gaming activity does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

## **Poker Tournaments**

### **Bureau Requirements**

#### **Advertising**

Larry Flynt's Lucky Lady Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GETR-000117) shall be referenced on all advertisements relating to the gaming activity.

Furthermore, all rules and procedures for the Poker Tournament and associated gaming activities, including but not limited to the following, shall be prominently displayed in Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered for play:

- How a player may enter the tournament.
- The game(s) offered during the play of the tournament.
- The fees charged for entering the tournament, including a description for each fee charged and whether it shall be retained by Larry Flynt's Lucky Lady Casino, added directly into the tournament prize pool, or any other method of retention or distribution.
- The amount of tournament chips awarded to each player upon entry into the tournament.
- The tournament prize structure offered and the number of players that will be paid.
- When the patron(s) will be paid and the manner they will be paid.
- The rules and procedures for any and all gaming activities being offered in conjunction with the Poker Tournaments.
- All information related to prize ranges and amounts for all gaming activities associated with the Poker Tournaments.
- Any other restrictions that apply to the Poker Tournaments.

#### **Advertising for Gaming Activities Associated with the Poker Tournament**

- The rules and procedures for any and all gaming activities being offered in conjunction with the Poker Tournaments.
- All information related to prize ranges and amount for all gaming activities associated with the Poker Tournaments.
- Patrons will be given ample notice of which gaming activity option is being offered, and it will be displayed prominently via printed flyers, digital display, and any other forms of advertisements Larry Flynt's Lucky Lady Casino uses to promote the tournament(s).
- Bounty(s) gaming activity may be offered to tournament patrons who pay the buy-in and entry fee. If the bounty(s) is offered, the activity advertising will be prominently posted with the prize amount and how the bounty(s) will be funded; whether by the total number of buy-ins, rebuy(s) and add-on(s) or if the casino will fund this prize amount.

#### **Tournament Log**

Larry Flynt's Lucky Lady Casino shall maintain all completed tournament logs for at least seven years. These logs shall be maintained in either paper or electronic format. The cardroom shall also retain and make available the most recent three months of the tournament logs for inspection by a representative of the Bureau during all hours of operation.

## **Poker Tournaments**

Upon request of the Bureau, a licensee shall provide the Bureau with copies of such tournament logs. Tournament logs shall contain the following information:

- The name of Gambling Establishment.
- The day, date, time and name advertised for the tournament.
- The total number of tables used.
- The names of the controlled games offered.
- The method of entry.
- The number and amount of rebuys and/or add-ons offered.
- The number of participants.
- The name of each fee charged, amount of each fee charged, total number of each fee collected and cumulative amount of collected.
- The source of all funds for tournament prize pool.
- The amount of the prize pool.
- The amount and reason for any deductions from the total collected prize pool.
- The name of gaming activities offered (when applicable):
  - Funding source.
  - Prize amount.
  - Total number of prizes awarded.
  - Total amount deducted from prize pool (when applicable).
- The results of the tournament, including the amount paid out and amount paid for each place in the tournament.
- The signature of casino staff responsible for administering the tournament.

### **Eligible Controlled Games**

The controlled games that may be offered during Poker Tournaments at Larry Flynt's Lucky Lady Casino shall only be those as listed below. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGR-001815)
- Omaha Hi-Lo (GEGR-001816)
- Seven Card Stud (GEGR-001819)
- Omaha & Pot Limit (GEGR-001817)

### **Gaming Activities Offered During Tournament Play**

#### **Bounties**

Bounties are house funded and may be offered to tournament patrons who pay the buy-in and entry fee. When the "advertised bounty" player(s) is/are knocked out ending their tournament play, then the player eliminating the "advertised bounty" player(s) will be awarded the prize. If the advertised bounty player(s) are not knocked out during the tournament, then the prize goes to the bounty player(s).

- The bounties will be paid during the tournament or as soon as their tournament play ends. If there are multiple winners, the prize will be split evenly.
- The prize amount will range from \$1 to \$10,000 and be paid out in live chips, cash, or a combination of both.

## Poker Tournaments

- When a bounty(s) is offered during tournament play, then the bounty prize amount will be deducted from the total number of buy-ins, rebuy(s) and add-on(s) or the casino will pay this prize amount.
- If a group at the final table decided to split the prize pool amongst themselves evenly, the bounty prize amount will become part of the total prize split.

### Tournament Entry

- Tournament entry is open to all customers.
- Casino employees and Third-Party Proposition of Player Services (TPPPS) employees may enter the tournament and thus participate in the associated gaming activities.
  - They must be out of uniform and off-duty while playing in the tournament.
  - They will be allowed to keep any prizes won for the Poker Tournament and associated gaming activities.
- The specific structure will be on any and all advertisements, and must be made available to patrons prior to the start of the tournament. The structure of a tournament will not change once sign-ups begin.
- **Promotional materials will not advertise gender-based discounts nor imply a gender-based entrance policy.**
- Patrons may enter a tournament by paying the buy-in and entry fee. All fees, prices charged, and the amount of tournament chips provided will be equal for the initial buy-in and posted for all players.
- Entry may be earned by winning a previous tournament or a Bureau approved gaming activity. All gaming activities and/or promotions shall be approved by the Bureau prior to being offered for play.
- More than one method of entry for a specific tournament may be utilized.

### Tournament Structure

\*Entry fee will be retained by Larry Flynt's Lucky Lady Casino to offset the cost of operating the tournament.

\*\*Service fee will be retained by Larry Flynt's Lucky Lady Casino to pay tournament staff.

\*\*\*Table and Time Restriction for Add-ons and Buy-Ins: Tournament rules will define if and when these will be available.

### Tournament Prize Amounts & Source of Funds

The prizes will be the cumulative amount of buy-ins, re-buys, and add-ons. The prizes may also be guaranteed meaning Larry Flynt's Lucky Lady Casino will make-up any shortfall in case there are not enough buy-ins. Special tournaments may have the prizes fully funded by the house.

- The minimum payout will be the amount of the advertised guarantee. If the total of the buy-ins, re-buys and add-ons exceeds the guaranteed amount, the payout will be the total of that amount.



## **Poker Tournaments**

- A gaming activity associated with the Poker Tournament will be paid out by a Larry Flynt's Lucky Lady Casino floor person after the players' identification has been verified.

### **Tournament Prize Structure**

When the prize is not guaranteed, the prize structure will be broken down by the number of paid entries and percentage paid. The percentage paid out will always equal 100%. In the event the players decide to forgo the payout structure and "split" the total prize pool among them, it shall be permitted and shall be noted in detail on the casino's tournament log. Other prizes may include entry into any tournament event.

### **Entities Involved Other Than the House**

At any time, Larry Flynt's Lucky Lady Casino may be hosting a charity tournament for the Community of Gardena and/ or other entities. These organizations shall be reputable and federally recognized as non-profit or charity organizations. These organizations will not be involved in running the tournament; however, their name may be used in conjunction with the advertising and promoting of the event. Larry Flynt's Lucky Lady Casino may donate prizes such as entries into Larry Flynt's Lucky Lady Casino tournaments at no cost to the charity. Entities or persons such as City of Gardena clubs, organizations, chambers, groups, sponsors, police department, celebrities (World Series of Poker Tournament main event winners), etc., may participate.

### **No Purchase Necessary**

The gaming activity attached to the Poker Tournaments shall be offered for free, on a general and indiscriminant basis, with **no restrictions**. Larry Flynt's Lucky Lady Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activities attached to the Poker Tournaments without paying any entry or table fee into the tournament. The NPN player must adhere to all rules as the tournament player. All advertisements shall state "No Purchase Necessary" when referencing the gaming activities offered during the Poker Tournaments.

- Eligible controlled games
- Eligible time period(s)
- Player Rewards Program card requirement (GEAR-000955)
- Amount of time played required to be eligible for free events
- Prize(s) and prize value(s)
- Requirements and time frame for claiming prizes
- No Purchase Necessary opportunity
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Special Events Player Rewards shall be attached to all Bureau approved games offered at Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

During predetermined and posted times, Larry Flynt's Lucky Lady Casino will offer free events to players for a predetermined and posted amount of time. Players will have their Player Rewards card (GEAR-000955) scanned every time they are seated and playing an eligible controlled game listed above. If the player accrues a certain amount of time played, they will be invited to attend a future event hosted by Larry Flynt's Lucky Lady Casino, free of charge. All time will be verified by a casino representative. Food may be served and the players with the most time played may be awarded a predetermined and posted prize.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Players must accumulate at least the predetermined and posted amount of time in order to receive an invitation to a future event.
- Time earned in a given promotional period does not roll over to the next promotional period.
- There is a maximum of one entry per player earned per promotional period, and a maximum of one prize awarded per player per promotional period.
- Playing time will only be tracked via the Player Rewards card (GEAR-000955).
  - If a player does not have their physical Player Rewards card, they may see a casino representative to look them up in the system and have their time credited.

The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. **All advertisement material shall state "No Purchase Necessary" when referencing the Special Events Player Rewards. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.**

Larry Flynt's Lucky Lady Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001197) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered for play:

- Eligible games
- Eligible dates and time periods
  - Including when a patron must turn in their Sports Bracket
- Minimum amount of time required to play in order to qualify
  - Player Rewards Program Card (GEAR-000955) requirement
- Number of prizes available
- Prizes and prize values
- Requirements and procedures for claiming prize
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Sports Bracket Promotion shall be attached to all Bureau approved games offered at Larry Flynt's Lucky Lady Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

### **Object and Summary**

During a predetermined and posted time period, the Sports Bracket Promotion shall be open to all players who play for a minimum and predetermined amount of hours (ranging from 1-100), between predetermined dates (as advertised), and in any eligible controlled game listed above. Patrons wishing to participate in the Sports Bracket Promotion must see a casino representative for the bracket. - Tournament games are not eligible with this gaming activity.
- A Third-Party Provider of Proposition Player Services (TPPPS) is not eligible to place a jackpot collection fee and become eligible for the Ultimate Texas Hold'em Progressive jackpot when in either the player-dealer or player capacity.

**Prize**

**Fixed Prize**

- All fixed payouts shall be paid by a casino representative. See the Ultimate Texas Hold'em Progressive Jackpot Qualifying Hands payable above for qualifying hands and payouts.

**Progressive Prizes**

### **Envy Bonus**

**9. Explain any re-seeding of the fund once the prize is won.**

The Jackpot is reseeded from the player-funded Jackpot fund. Any shortfall will be covered by a loan from the House.

**10. Explain any minimum or maximum number of players required to be dealt into the game for the table to be eligible for the gaming and activity prize.**

A minimum of four players and maximum of ten players.

**11. Explain if the house is retaining any administrative or any other type of fee operating the game activity.**

The house will retain an administrative fee of between \$4.00-6.00 based on the number of table hours that the promotion is offered. The administrative fee may be adjusted based on market factors and cost of operating the Jackpot activity. The amount of the administrative fee will depend upon a number of factors including additional recordkeeping requirements and additional training of personnel concerning the rules and

other requirements applicable to the Jackpot activity and administration of the Jackpot activity.

**12. Describe any opportunity(s) for the person to play for the prize without placing any live wagers or paying any table fees.**

A no purchase necessary (NPN) option is available to any person who requests it. Any person wishing to participate without a purchase or live chips will have the same opportunity to play for the Jackpot Prize as the player participating in the live game. Advertisements will advise all patrons that there is a general and indiscriminate opportunity to participate in an NPN game to qualify for the Jackpot prize.
