Bureau Requirements

Advertising

The Parkwest Casino 580 may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-000931) shall be referenced on all advertisements relating to the Bonus Bet Chip Promotion.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Parkwest Casino 580 at all times that this promotion is being offered:

- Eligible games and time periods.
- Bonus chip values.
- Buy-in amount for Bonus Bet Chips
- Procedures to redeem Bonus Bet Chips.
- Any other applicable restrictions and/or information.

Object and Summary

The Bonus Bet Chip Promotion will be open to all patrons who buy-in to a pre-determined game for a pre-determined amount ranging from \$10 to \$100,000. Participants will receive a specific amount of Bonus Bet Chips in any controlled game listed above. Players may purchase Bonus Bet Chips at the cage at pre-determined and posted times. When patrons buy-in to a pre-determined game for a pre-determined and posted amount ranging from \$10 to \$100,000, they will receive an equal value in Bonus Bet Chips in return for buying into a predetermined game. The Bonus Bet Chips are of a different style and design from the standard casino chip. The Bonus Bet Chips can not be exchanged for cash and must be played on the gaming table. Once the Bonus Bet Chips have been placed as a wager, the following applies:

- If the wager wins, the player will receive live chips for his/her bet from the player-dealer. The player retains the bonus chip and can reuse the Bonus Bet Chips on another wager.
- If the player pushes, the Bonus Bet Chips will remain with the player until the hand loses.

Bonus Bet Chip Promotion

- If the bet loses, the Bonus Bet Chips are given to the player-dealer. The losing Bonus Bet Chips are verified by the casino's Floor Service Representative and redeemed for the value of the chip at the cage by casino cage staff members for the player-dealer. Rules of Play

The Bonus Chip Promotion will be open to all patrons who buy-in to a pre-determined game for a pre-determined amount ranging from \$10 to \$100,000. Participants will receive a specific amount of Bonus Chips in any controlled game listed above.

Purchasing Bonus Chips

Players may purchase bonus chips at the cage at pre-determined and posted times. When patrons buy-in to a pre-determined game for a pre-determined and posted amount ranging from \$10 to \$100,000, they will receive an amount ranging from \$1 to \$10,000 in bonus chips for buying into a predetermined game.

Bonus Chips:

The prize shall be awarded to a player when he/she redeems one of the aforementioned advertisements. The player will receive the advertised amount of bonus chips. The bonus chips are of a different style and design from the standard casino chip. The bonus chips can not be exchanged for cash and must be played on the gaming table. Bureau Requirements

Advertising

The Parkwest Casino 580 may advertise various names for this gaming activity. Should Parkwest Casino 580 advertise a different name, the BGC ID (GEGA-004601) shall be referenced on all advertisements relating to the California Games Jackpot.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in Parkwest Casino 580 at all times this gaming activity is being offered for play:

- Eligible games and time periods.
- Qualifying hands and corresponding prizes.
- Jackpot fee required.
- The prize amount that shall be awarded and how it shall be distributed between all eligible players.
- Any No Purchase Necessary opportunity.
- Any other restrictions that apply to this gaming activity.

Object and Summary

The California Games Jackpot gaming activity features both fixed and progressive jackpot prizes. A prize is awarded to players, who have paid the \$1 jackpot fee, in any designated California game, when the player-dealer has been dealt a qualifying hand. After the hand is confirmed, those players who paid the jackpot fee shall receive the posted prize from the progressive jackpot.

Qualifying Hands

When the player-dealer makes one of the following advertised qualifying hands during the play of an eligible California game, all players who paid the jackpot fee shall be eligible to win their share of the posted California Games Jackpot progressive prize amount, as shown below. The payout shall be split evenly for the posted progressive amount among the players who paid the jackpot fee. The entire posted fixed amount will be given to each player who paid a jackpot fee. Only the following hands that have been Bureau approved, pre-determined, and designated by the Casino are eligible. The qualifying hands within the chart below must be offered together at all times.

Example: Prior to the play of the hand, five players placed a jackpot wager. The jackpot hand was made by the player-dealer and the posted prize is \$42,000. Each of the five players would then receive \$8,400.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

- When a qualifying hand is announced, a floor person shall verify that the hand qualifies. Any deviation from a standard deck will nullify the jackpot.
- There is no minimum or maximum number of players required to be dealt in during an eligible game in order for players to be eligible and the tables to qualify for the California Games Jackpots prize amount.
- Players are eligible to win this promotion more than once. There is no limit on the amount of times a player can win the jackpot.
- Only off duty and out of uniform Casino employees shall be eligible to participate in the California Games Jackpots promotion.
- Third Party Provider of Proposition Player Services, on and off duty, shall not be eligible to participate in the California Games Jackpots promotion.
- Tournament Games do not qualify for this promotion.

Prize

The jackpot prizes are both fixed and progressive with a minimum value of \$500 and a maximum of \$500,000. The jackpot prize shall be paid in the form of cash, casino chips, merchandise, trips, poker tournament entries, electronics, or other prizes. If the prize is not cash, it will not exceed the value of \$500,000. The actual progressive jackpot prize amount shall depend on the amount the jackpot was originally seeded at, as well as how much time was accumulated in order for the jackpot to increase progressively each day.

Funding

The California Games Jackpots gaming activity utilizes one Jackpot account which shall be funded by a \$1 jackpot collection which shall be dropped in a separate drop box marked as "Jackpot." The prize pool shall be initially seeded at \$20,000 from the following dormant jackpot accounts: Texas Hold'em Mega Cash Jackpot (GEGA-002380), Texas Hold'em Fast Cash Jackpot (GEGA-000584), Omaha Mega Cash Jackpot (GEGA-003091), and Omaha Fast Cash Jackpot (GEGA-003095). A summary of the dormant accounts is below. While the dormant accounts are still available, the \$1 jackpot collection shall be put in the reserve account. Once the dormant accounts have run out, the jackpot will be funded by the \$1 jackpot collection. When the \$1 jackpot collection has been taken, a portion of the fee will go to the main jackpot account and the rest shall be placed in the reserve account. All fixed prize payouts will be paid from the reserve account. The progressive prize pool will be increased daily at predetermined

and designated times with an amount ranging from \$5 to \$10,000 based on the amount collected. If the dormant accounts are still available, the increase amount shall be based on the amount collected the day before, but taken from the dormant accounts. Once the dormant accounts are depleted, the increase amount shall be based on the amount collected the day before. When a qualifying jackpot hand is made, it will be re-seeded from one of the dormant accounts listed above, with an amount ranging from \$10,000 to \$50,000 if it's still available. After the dormant accounts have been depleted, it will then be re-seeded by the reserve account in an amount ranging from \$10,000 to \$50,000. The Parkwest Casino 580 shall cover any shortfall and shall be refunded by the reserve.

Administrative Fees

The Parkwest Casino 580 shall retain an administrative fee of \$5-\$10 per table per hour from all approved California games. This fee will be used to cover advertising for the jackpot prize, security to pull and count the boxes, accounting, equipment, surveillance, and the cost of the gambling establishment personnel that administer the jackpot.

No Purchase Necessary

The California Games Jackpots Promotion gaming activity shall be offered for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary (NPN) game. The Parkwest Casino 580 shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. Within a reasonable amount of time of a No Purchase Necessary player requesting to play one of the specific games within the gaming activity, a No Purchase Necessary table will be made available. The casino dealer will deal a hand to the No Purchase Necessary player and to all other seated positions, including what would be the player-dealer position. The casino dealer will play/monitor all of the hands dealt except for the No Purchase Necessary player's. If the No Purchase Necessary player makes one of the qualifying hand(s), listed above, they will be awarded that associated prize or their portion thereof. There shall be no time restriction placed on the No Purchase Necessary player regarding the number of hands dealt. There shall be no live wagering or cash/casino chips used at this table. All advertisement material shall state "No Purchase Necessary" when referencing the California Games Jackpots gaming activity. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Advertisement Requirements

The Casino 580 may advertise various names for this tournament. Should the Casino 580 advertise a different name, the BGC ID listed above shall be referenced on all advertisements relating to the California Games Tournaments.

Furthermore, all rules and procedures for California Games Tournaments, including but not limited to the following, shall be displayed conspicuously and prominently in the Casino 580 at all times that a California Games Tournament is offered for play:

- How a player may enter the tournament.
- The game(s) that will be offered during the play of the tournament.
- The fees that will be charged for entering the tournament, including a description for each fee charged and whether it shall be retained by the Casino 580, added directly into the tournament prize pool, or any other method of retention or distribution.

Object and Summary

The Cash and Prize Drawings Promotion features a promotional element attached to the eligible controlled games as listed above, offered at Parkwest Casino 580. The promotion will reward players with 1-20 ticket(s) based on the pre-determined and designated qualifying hands and/or time played at designated table games during predetermined and eligible periods.

Players may additionally earn ticket(s) by playing certain eligible games based on pre-determined and designated times periods; 1-20 tickets can be earned per hour of play. A player's time will be tracked through their player's card (Player Loyalty Rewards Program GEGA-003087) or manually on a log controlled by a Casino employee.

Cash and Prize Drawing Promotion

The Casino may also offer bonus tickets, in addition to the regular amount of tickets earned through time played and qualifying hands per designated games, at the rate of 1-20, during off-peak hours or in specific games; this applies to both qualifying hands and based on time played. Patrons will be given ample notice of the amount of times and how many tickets will be awarded. A player can earn tickets by achieving a below listed qualifying hand and/or playing a predetermined amount of time.

The drawing ticket is a standard raffle ticket divided into two sections, one section for the player and one section for the Casino. The player must retain their portion of the ticket in order to claim the prize. Furthermore, the player fills out the Casino section of the ticket with their first and last name, game, table number, and date, prior to giving the Casino section of the ticket to a Casino employee to deposit into the secure container. The ticket will then be used for drawings for the Cash and Prize Drawings Promotion.

The section of the ticket with the player information will be retained by the Casino and deposited into a secure container. The container will be maintained on the Casino floor and monitored by the surveillance system and Casino personnel. The tickets will be mixed up using a clear rotating plastic container. The winning ticket will be drawn by a casino floor person. The player with the winning ticket will have two minutes to claim their prize from the drawing location. Once the winning ticket is drawn, the player must bring the other half of the ticket to the drawing location within two minutes of their name being called to claim the prize. Once the player has claimed their winning ticket they will be taken to the cage to redeem the prize. If the winning player does not claim their prize within the two minute time period, the Casino may draw another ticket until there is a winner, or the Casino may choose to wait until the next scheduled drawing time to draw another ticket. The Casino is not responsible for lost tickets. If the player does not have the other half of their winning ticket, at the time of the drawing, the player would need to provide valid identification to the floor supervisor. The tickets are only valid for the current promotional period and expire at the end of the promotional period. The plastic container will be emptied and the remaining tickets destroyed at the end of the promotional period.

Qualifying Hands

A player who achieves one of the qualifying hands listed below shall earn at least 1-20 ticket(s) to be entered into the Cash and Prize Drawing Promotion for a predetermined and posted prize. All qualifying hands within each chart must be offered concurrently. Parkwest Casino 580 may only offer one qualifying hand option during a promotional period.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- There is no restriction on the amount of tickets that a player may earn to be entered into the drawing.
- A player can earn tickets by achieving an above listed qualifying hand or time played.
- Players can earn 1-20 tickets per hour of play.
- When a qualifying hand is announced, a casino floor person will verify the qualifying hand. Any deviation from a standard deck will nullify the hand.
- In the event that two or more players achieve a qualifying hand, each player will receive a ticket for the drawing. This includes backline bettors, if allowed in the base game rules.
- There must be at least two players (a player and a player-dealer) actively playing in a game.

Cash and Prize Drawing Promotion

- Once the winning ticket is drawn, the player must bring the other half of the ticket to the drawing location within two minutes of their name being called to claim the prize.
 - The Casino is not responsible for lost tickets. If the player does not have the other half of their winning ticket, at the time of the drawing, the player would need to provide valid identification to the floor supervisor.
 - If the winning player does not claim their prize within the two minute time period, the Casino may draw another ticket until there is a winner, or the Casino may choose to wait until the next scheduled drawing time to draw another ticket.
- Both sections of the winning tickets will be retained by the Casino for 90 days.
- Backline bettors are eligible to participate, if allowed in the base game rules.
- All players are eligible to earn a drawing ticket regardless whether their hand wins, loses, or ties (pushes) with the player-dealer's hand (excluding Baccarat games).
- Tournament games do not qualify for the gaming activity.
- Third Party Providers of Proposition Services (TPPPS) are not eligible to receive a drawing ticket even if they achieve a qualifying hand.
- Casino employees are not eligible to participate in this gaming activity.

Prize

The prize amount will be a fixed amount ranging from \$1 to \$500,000 in the form of cash, live casino chips, Bonus Chips (Bonus Chip Promotion GEGA-004405), Free Play Chips/Match Play Chips (Match Play Coupon Promotion GEGA-003024), electronics, trips, tickets to attractions and movies, promotional merchandise, food vouchers (Food Rewards Program GEGA-004108), gift cards, vehicles, and entry into California Games Tournament (GEGA-003523). Once the player has claimed their winning ticket they will be taken to the cage to redeem the prize. In all instances, prizes for this promotion will be pre-determined and posted on all advertisements related to this promotion.

Funding

The Cash and Prize Drawings Promotion is fully funded by Parkwest Casino 580. There shall be no additional promotion fees, jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate.

Administrative Fees

Parkwest Casino 580 will not take any administrative fees for this promotion, as this promotion is house funded.

No Purchase Necessary

The Cash and Prize Drawings Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Cash and Prize Drawings Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Customer Incentive Program

Bureau Requirements

Advertising

The Casino 580 may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004484) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in The Casino 580 at all times the gaming activity is being offered:

- Corresponding time played and points earned or awarded.
- The date(s) and time(s) the gaming activity shall be offered.
- The number of points earned corresponding to the prize amount.
- The time frame in which the points earned are valid.
- The possible prize(s) offered for meeting the requirements of the gaming activity.
- When the bonus prize(s) will be offered throughout the promotion.
- Availability of No Purchase Necessary.
- Any other applicable restrictions.

Eligible Controlled Games

The Customer Incentive Program shall be attached to all Bureau approved California and Poker controlled games offered at The Casino 580 at all times this gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

Rules of Play

The Customer Incentive Program features a promotional element attached to the games listed above. This gaming activity is a loyalty reward program open to all Casino 580 patrons. This promotion will reward players with points based on time of play at designated table games during pre-determined and eligible periods ranging from 10 minutes to 90 days.

Player's Card and Computer System Description

The Player's Card shall include the Casino name on the card, some descriptive language regarding restrictions for the card, and the problem gambling phone number. It shall also include a bar-code. This card will look different from the card used for the Player Loyalty Rewards Program (GEGA-003087).

- The card shall be non-transferable and can only be used by the player who the card is assigned.
- If a player's card has been lost or stolen, they can ask a Floor Service Representative for a new one at no cost to the player.
- Player information shall be maintained in a secure database accessed only by casino management. Access to the database shall also be tracked by casino management.
- Player's time played is tracked by having their card scanned. They will receive a player's card once they sign up for the Customer Incentive Program at the cashier. An iTouch, iPad, or similar tablet computer device, with a bar code reader, will be affixed to the gaming table and a gambling establishment employee will scan the player's card. The gambling establishment employee will then input the player's average wager and time played into the computer tablet device.

Customer Incentive Program

- Player information shall be maintained in a secure database accessed only by casino management. Access to the database shall also be tracked by casino management. No one except the network administrator(s) has access to the back-end systems where the data is stored. Access to the data is by user level with multiple levels based on what the user will be doing. Marketing managers will have access to customer data for marketing purposes (i.e., emails, texts, mass mailing, etc.)
- A printable record of the amount of time a player has accumulated during the period of time that the gaming activity is being offered, shall be available at anytime at their request.

How Player Rewards Points are Earned Based on Time Played

Points shall be earned based on the amount of time played. Each player that plays a certain table game during live play will, at certain times, receive points, which will gain them eligibility to win pre-determined and designated prizes. The range of points will be 1 to 200,000 points for each hour of play. The Casino 580 may offer bonus rates (for example, double points) on play during off-peak hours or in specific games, within the range as shown above. Patrons will be given ample notice of how many points will be awarded, as well as, the amount of time required to earn points for each eligible game.

Example: A player signs up for the Customer Incentive Program at the cashier and receives a player's card. The player presents the card to the gambling establishment employee at the gaming table. The gambling establishment employee scans the player's card using a bar code reader on the computer tablet device and will then input the average wager per hand of the player in fifteen minute increments. At the end of the gaming session, the player will be logged out by the gambling establishment employee. The program tabulates the amount of points the player has earned and records it in the player's account. The player may check their point balance and redeem points with a gambling establishment employee at any time during the promotion.

How Player Rewards Points are Redeemed

Players may either redeem their points at any time during the promotion or at the end of the promotional period. The redemption period will be displayed in The Casino 580 to give players ample notice. Points not redeemed by the end of the promotional period will expire within 30 days of the promotional period. All prizes shall have a pre-determined and designated value. The point to dollars ratio for the rewards program is 1 point is worth \$0.10 - \$100. After a player has accumulated a pre-determined and specific amount of points, based on time of play, a player may redeem the accrued points for a pre-determined and designated prize.

- After a player has been awarded a prize, they may also be eligible for second and subsequent prize(s) until the end of the promotion.
- Players may redeem their points for multiple prizes as long as the total amount of points required for the prizes are within the player's point balance.
- Once the points are redeemed, these points will be subtracted from their point balance.
- Upon request, a player may check their point balance with a Casino Floor Services Representative at any time during the promotion.
- Points are non-transferrable, and can only be used by the player who earned them.
- Points are eligible for redemption at anytime during the promotion or at the end of the promotional period. Points not redeemed at the end of that period will expire.

Customer Incentive Program

- All reward points are subject to review and verification. The Casino reserves the right to adjust balances or void any points due to error or fraud.

Prize

The prize amount shall be a fixed amount ranging from \$1 to \$100,000 in the form of cash, casino chips, free play chips (GEGA-003024), bonus chips (GEGA-004405), coupons, vehicles, promotional merchandise, food, entries into tournaments, entries into a Bureau approval gaming activity, etc. In addition to the fixed amount, during pre-determined and posted times throughout the promotion, there will be bonus prizes awarded when players reach a certain point level. The bonus prize will range from \$1 - \$100,000. In all instances, the actual prize(s) that players are eligible to redeem their points for shall be pre-determined and conspicuously posted in The Casino 580 at all times that this gaming activity is being offered.

Eligibility

This gaming activity shall be open to all players 21 years of age and older with valid I.D. who sign up for a Player Reward Card and participate in an eligible game for a designated period of time to earn points. When the player chooses to exchange their accrued points, they shall win a corresponding prize.

- Players must be seated and playing at a designated table in order to qualify for the promotion.
- In order for the table to qualify for the promotion, there is a minimum of two players for poker and California games and up to the maximum allowable in the controlled game.
- On and off duty, in or out of uniform casino employees shall not be eligible to participate in this promotion.
- Third Party Proposition Players, on or off duty, shall not be eligible to participate in this promotion.
- Tournament games do not qualify for this promotion.

Funding

The Customer Incentive Program gaming activity is fully funded by The Casino 580. There will be no additional fees collected in order to fund this gaming activity or for players to participate. All fee collections and table limits are for the designated base game and are Bureau approved, pre-determined and posted at each table.

Administrative Fees

The Casino 580 shall not retain an administrative fee for operating the Customer Incentive Program gaming activity.

No Purchase Necessary

The Customer Incentive Program does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require No Purchase Necessary tables to be offered while conducting this gaming activity.

Food Reward Program

Advertising Requirements:

Casino 580 may advertise various names for this program. Should the Casino advertise a different name, the BGC ID (GEGA-004108) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be displayed conspicuously and prominently in Casino 580 at all times the gaming activity is being offered:

- The date(s) and time(s) the gaming activity shall be offered.
- The prize(s) offered for meeting the requirements of the gaming activity.
- Time required to earn food.
- How time will be tracked.
- Procedures for players having their card stamped.
- Any other applicable restrictions.

Summary:

Based on customer demand and industry trends, The Casino 580 proposes to add a gaming activity for all currently approved controlled games. The promotion will allow a player to eat for free/or at a substantially discounted rate from a selected menu when they play for a qualifying period of time, which is tracked through their Player Rewards Card or on a log if they do not have a players' rewards card. In all instances, patrons shall be provided with ample advance notice of the amount of time that a player must play in order to be eligible for the "Player's Menu." Furthermore, the time requirements and "Player's Menu" shall be displayed prominently within The Casino 580 at all times this gaming activity is being offered for play.

Controlled Game:

The Food Reward Program shall be associated with all currently approved BGC games offered at Casino 580.

Prize:

The prize will be allowing a player to eat a menu item for free/or at a substantially discounted rate from a selected "Player's Menu." For players that complete the time requirement, certain items on the "Player's Menu" with a value of \$1 - \$25 will be offered for free.

Funding:

This promotion will be solely funded by Casino 580. There will be no extra collection or fees of any kind assessed to the players.

Eligibility to Win:

All players who wish to participate will be tracked by a casino employee. Once a player has played a pre-designated and posted time period ranging from 10 minutes to 4 hours, their time will be verified and then they will be awarded by eating for free/or at a substantially discounted rate from the "Player's Menu." A player may qualify for this promotion a maximum of three times within a 24 hour period.

Food Reward Program

- The time that a player must play at a table or game will range from 10 minutes up to 4 hours, as pre-determined and designated by Casino 580. This time requirement shall be the same for all players.
- A player may qualify for this promotion a maximum of three times within a 24-hour period.
- Time will be tracked by each minute of play and may be added together as a running total through the 24-hour period. However, all time accrued during a 24-hour period will expire after that period and may not be carried over from one 24-hour period to another 24-hour period.
- Player's time will be tracked by the Casino through a log if the player does not have a player's rewards card.
- Player's time may also be tracked through the Players Reward Program (GEGA-003087).
- A player does not have to have a players' rewards card to be eligible for this promotion.
- Time accrued may only be used by the player that earned it; it is non-transferrable.
- Tournament players are not eligible to receive discounted and/or free items from the "Player's Menu."
- Casino employees are eligible while off duty, but are ineligible during the time they are on duty and working.
- There are no restrictions on the number of players required to be playing in a Poker and/or California game in order for players to be eligible to accrue time.
- Backline bettors are not eligible for this promotion. Third Party Provider of Proposition Player Services, as defined in Section 19984 of the California Business and Professions Code, are not eligible for this promotion.

No Purchase Necessary:

The Food Reward Program does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

Highlighted Quad Promotion Rules

Casino 580

The Highlighted Quad Promotion will be a jackpot associated with all limits and versions of Texas Hold'em excluding tournaments. One of the 13 ranks (Ace-King) will be highlighted each day. If a player makes quads on the highlighted rank, the player will win the jackpot. The jackpot will be a progressive amount ranging from \$50 to \$10,000 and will be funded from the Mega Cash jackpot collections. The jackpot will be seeded from the Mega Cash jackpot fund with an amount ranging from \$50 to \$10,000 and increase with an amount ranging from \$25 to \$1,000 daily.

The daily highlighted quad will be posted on an electronic promotional board along with the current amount of the jackpot. The daily highlighted hand will change daily based on the following schedule:

- Day 1 the highlighted hand will be 4 twos.
- Day 2 the highlighted hand will be 4 threes.
- Day 3 the highlighted hand will be 4 fours.
- Day 4 the highlighted hand will be 4 fives.
- Day 5 the highlighted hand will be 4 sixes.
- Day 6 the highlighted hand will be 4 sevens.
- Day 7 the highlighted hand will be 4 eights.
- Day 8 the highlighted hand will be 4 nines.
- Day 9 the highlighted hand will be 4 tens.
- Day 10 the highlighted hand will be 4 Jacks.
- Day 11 the highlighted hand will be 4 Queens.
- Day 12 the highlighted hand will be 4 Kings.
- Day 13 the highlighted hand will be 4 aces.
- Day 14 restart the above schedule.

If the jackpot has not been hit by the 14th day, the highlighted hand will reset to 4 twos, but the prize amount will continue to increase. Once the prize has been claimed the jackpot will reseed from the Mega Cash jackpot fund (GEGA-002380) in the amount of \$50 to \$10,000, but the highlighted hand remains the same for the rest of the day. If the same highlighted hand is hit on that day, the jackpot will be awarded at the reseeded amount. If the highlighted hand is hit and the hand qualifies for another approved promotion the player will only win the promotion that pays the most. A minimum of two (2) players are required to be dealt in during a qualifying game in order for players to be eligible and the table to qualify for the promotion.

When a qualifying hand is announced, a floor person shall verify that the hand qualifies. Any deviation from a standard deck shall nullify the promotion.

In order to qualify for the promotion, the Four of a Kind must be made using two (2) hole cards and two (2) board cards.

Qualifying hands are only eligible for one promotional prize at a time.

There is no restriction to the number of times a player is eligible for this promotion.

Tournament games do not qualify for this promotion.

Casino employees are eligible to win this promotion if they are playing while they are off duty.

SUMMARY

Based on customer demand and industry trends, Casino 580 proposes to add a gaming activity to the following games:

- Texas Hold'em
- Pure 21.5 Blackjack
- Commission Free Baccarat
- Pai Gow Poker
- Fortune Pai Gow Poker
- Three Card Poker 1.0

The promotion will award players who play a predetermined amount of time at the Casino 580 in a particular game.

PRIZE

This promotion will reward players with points based on the amount of time played at designated table games during pre-determined and posted eligible periods or based on pre-determined and posted designated qualifying hands. Players that make any of the following pre-determined and posted hands will be awarded points. Please see attached chart of qualifying hands. The range of points will be from one (1) to one hundred (100) points per hour of play.

The casino may offer pre-determined and posted bonus earn rates, schedules (double, triple, etc.) on play during off-peak hours or in specific games, within the range, as shown above.

Players will be given ample notice of how many points will be awarded, as well as the amount of time required to earn points of which pre-determined and posted qualifying hands will be eligible to earn points for each eligible game.

Prize amounts may be fixed amounts ranging from \$1 to \$100,000 or up to the allowable amount based on the local ordinance in the form of cash or non-cash items, casino chips, coupons, vehicles, promotional merchandises, food, entries into tournaments, or raffle tickets for various prizes or merchandises. Cash prizes are fixed amount and are not progressive.

FUNDING

This promotion will be solely funded by the Casino 580. There will be no extra collection or fees of any kind assessed to the poker players.

NO PURCHASE NECESSARY

Since there is not a “chance” element attached to this promotion there is not a requirement for the “no purchase necessary” procedure.

ELIGIBILITY

The promotion will be open to all players who play in a game where the Casino 580 management has determined and announced that they will track a player’s play time or qualifying hand. At specific and pre-determined periods of time, a designated the Casino 580 employee will record the player’s time or by hand made by manually recording the player’s information when they qualify for earning points in the promotion.

All hours or qualifying hands that are tracked shall be made available when a player requests to see their status. The Casino 580 may also post the top point earners at their discretion. All recording of time or hands may be verified by a designated the Casino 580 employee.

The following details are offered:

- The Casino 580 will post prior to any promotion the qualifying games, hours and/or hands prominently within the Casino and on all literature and advertisements
- In order for the table to qualify for the promotion, there must be two (2) players or more for all California games and four (4) players or more for all Poker games.
- After a player has attained a predetermined and specific amount of time in a game and/or made a qualifying hand, they will be awarded a prize.
- After a player has been awarded a prize they will be eligible for a second and subsequent prizes until the end of the promotion.

- All reward points are subject to review and verification. The casino reserves the right to adjust balances or void any points due to error or fraud.

BASE GAME RULES

All base game rules that have been approved by the Bureau of Gambling Control for the casino games will be followed. There are no changes whatsoever.

Bureau Requirements

Advertising

The Casino 580 may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004493) shall be referenced on all advertisements relating to the Premier Rewards Program.

Object and Summary

The Premier Player Reward Program will be open to all patrons who sign-up and maintain an active premier player's bank account. Participants will receive a specific amount of Bonus Chips (GEGA-004405) when they buy-in to any pre-determined controlled game listed above for a pre-determined amount ranging from \$10 to \$100,000. A player will receive their bonus chips on the gaming table once a floor person verifies their player's bank account balance at the cage, when they buy-in to the game.

Players who maintain an active premier player's bank account will be in one of three levels, as listed below, depending on what their average daily balance is. Each category is awarded its own range of bonus chips for that pre-determined and posted period. All eligible times and prizes will be clearly displayed in advertisements and any literature produced for this gaming activity.

Premier Players Bank Account Description

Players can sign up for the Premier Player's Bank Account by going to the cage and filling out an application. A player may check their balance at any time by going to the cage cashier and showing their ID.

Eligibility Requirements

- Players must buy-in to a pre-determined listed for an amount ranging from \$10 to \$100,000 to be eligible for this promotion.
- There shall be no minimum or maximum number of players required for this promotion.
- A player is only eligible for this gaming activity once per day.

Object and Summary

During predetermined and posted promotional periods, patrons who are Customer Incentive Program members (GEGA-004484), and who sign-up and pay a corresponding monthly fee, are eligible to receive one or more predetermined and posted prizes throughout the promotional period.

All VIP Prime Members are subject to the same monthly fee, are eligible to receive the same prize(s), and will have the same amount of time to claim their prize(s) as all other VIP Prime Members during the posted promotional period. A VIP Prime Member Card will be given to members to represent their membership status in the Customer Incentive Program (GEGA-004484) and the VIP Prime Membership Promotion.

VIP Prime Membership Promotion

The eligible prizes awarded by the Casino to VIP Prime Members are grouped into two categories; Category A and Category B.

Category A represents prizes normally awarded in gaming activities or promotions. Category A prizes consists of California Games Tournament Entries (GEGA-003632), gift cards, electronics, limousine service, event tickets, private dining, shoe shine service, valet and preferred parking, private events, ride share service, and car wash service.

Prize
