Bad-Beat Jackpot. Other names may be used. In all cases, the Player's Club (PC) shall affix the GEGA number assigned by the Bureau of Gambling Control (BGC) to all advertisements, flyers, etc.

#### 2. Name each controlled game that is associated with this gaming activity:

Texas Hold'em GEGA-000948

#### **3.** Describe any Jackpot or any other type of prize awarded:

The prize will be cash awarded in the following manner:

50% to the Losing Hand20% to the Winning Hand30% to all players on the table who played in that particular round of play

#### 4. If a cash prize is involved, is the amount progressive or a fixed amount?

The prize amount is progressive. The bad-beat jackpot will be seeded at a minimum of \$1,000.00 and will increase every morning between \$50 - \$150.00. When won, the badbeat jackpot will be re-seeded at a minimum of \$1,000.00 and will increase within the range provided above. The jackpot will cap at \$50,000.00. If the cap is reached, a reserve will be funded with the minimum daily increases.

#### 5. Explain if the gaming activity is House funded or player funded:

House funded

### 6. Describe any special fee collection involved in this gaming activity, for example, a Jackpot collection fee.

There will be no fees collected.

#### 7. Describe how the Jackpot will be seeded and how prizes will be awarded.

This promotion will be seeded and re-seeded by the Casino. When a player makes a designated qualifying hand in a participating controlled game, they will be awarded their share of the bad-beat jackpot.

When a player makes a posted qualifying hand in a controlled game, the floor person will verify such hand and determines if all policy and procedures were followed. In all poker games, both players' hole cards must play. Players with qualifying winning and losing hands must play through the final betting round, which is after "the river," in order to qualify for the jackpot. <u>The table will be in-eligible for the jackpot if a player with one of the qualifying hands folds prior to the final betting round.</u>

The qualifying hands are listed below:

GameQualifying HandTexas Hold'emAAAJJ or better beaten by Four of a Kind or better

### 8. Explain any prize distribution including prizes given to the winner, loser, or any other player or patron.

A no purchase necessary (NPN) option is available to any person who requests it. Any person wishing to participate without a purchase or live chips will have the same opportunity to play for the Promotional Prize as the player participating in the live game. Advertisements will advise all patrons that there is a general and indiscriminate opportunity to participate in an NPN game to qualify for the Promotional prize.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Player's Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands
- Prize payout structure
- The prize amount to be awarded
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Blazing Sevens Progressive Jackpot shall be attached to the following Bureau approved controlled game offered at Player's Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

• 21<sup>st</sup> Century Blackjack 5.0 with Buster Blackjack Bonus Bet (GEGA-002526)

#### **Object and Summary**

A player that achieves one of the qualifying hands listed below for the Blazing Sevens Progressive Jackpot is eligible to win either a fixed amount prize or the progressive prize.

- 1. To begin each round, players must place a base game wager in order to qualify for the jackpot. Along with any bonus bets the players place a wager on, players have the option to place an optional \$1 jackpot fee and become eligible for the jackpot.
- 2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a live casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
  - a. Should the sensor malfunction, the chips will be returned to the players and no jackpot will be offered, until the malfunction is fixed.
- 3. Once all players place their base game wagers, any optional bonus bets, and optional jackpot fees, the house dealer will press "Start Game" on the keypad. The sensors will then light up, indicating participation in the gaming activity. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
- 4. The house dealer then follows standard approved procedures for dealing the controlled game. Any player who makes a qualifying hand will be paid out, as described below.

#### **Qualifying Hands**

Players who make one of the advertised qualifying hands (based on the player's initial two cards and the player-dealer's face-up card), as shown below, shall be eligible to win their share of the posted prize amount, according to the payout options, as shown below. All qualifying hands within a chart must be offered together at all times this gaming activity is offered for play.

#### Blazing Sevens Progressive Jackpot Qualifying Hands Chart

#### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- A minimum of two seated players, the player and the player-dealer, are required to be dealt in the base game to be eligible for the jackpot.
- A minimum number of three decks must be used for this promotion.
- A player may qualify for the jackpot, regardless of the outcome of the controlled game, as the qualifying hand is based on the player's initial two cards and the player-dealer's face-up card.
- There is no limit on the number of times a player may win a prize during any promotional period.
- Casino employees are eligible to participate in the gaming activity when they are off duty and out of uniform.
- Backline bettors are not eligible for this promotion.
- Tournament games are not eligible for this promotion.
- The player-dealer position is not eligible for this promotion.
- Third-Party Providers of Player Services (TPPPS) are not eligible for this promotion.

#### <u>Prize</u>

All monies collected and paid out shall be tracked both electronically and on a hand-written log and will be maintained by the gambling enterprise, for examination by regulatory and law enforcement personnel.

- Three 7s suited is paid 100% of the progressive jackpot amount shown on the progressive meter.
- All other hands are paid a fixed amount from the reserve fund. They do not get deducted from the amount shown on the meter. In the event the reserve fund is depleted, the Casino will make up any shortfall and will be reimbursed once there are sufficient monies in the reserve account.
- In the event more than one progressive meter pay hits during the same round, all winning players will share, in equal amounts, the posted progressive prize. In the event the reserve fund is depleted, the Casino will make up any shortfall and will be reimbursed once there are sufficient monies in the reserve account.
  - In the instance there is an odd amount, the shares will be rounded up to the nearest cent.

- When a player has a progressive winning hand, the house dealer shall contact a supervisor who will press the appropriate hand button on the keypad after verifying the hand.
- All progressive and fixed prizes will be paid by a casino representative after verification.
  - Once the proper paperwork has been filled out, the casino representative will pay the winner(s) in live casino chips. The payouts will not be made from the house dealer's tray.

#### Funding

The Blazing Sevens Progressive Jackpot is a player-funded progressive jackpot which features both a progressive prizes and fixed prizes. There is an optional \$1 jackpot fee that is required to be eligible for the prize. The \$1 jackpot fee paid by each player will be broken down as follows:

- a. \$0.43 will be immediately posted on the meter.
- b. \$0.57 will be tracked in the reserve fund.

Player's Casino will initially seed the jackpot at a minimum of \$1,000 to a maximum of \$50,000. Once there are sufficient monies in the Blazing Sevens Progressive Jackpot reserve fund, the initial seed amount will be reimbursed to Player's Casino from the reserve fund and shall be documented in the accounting records. There is no cap to the Blazing Sevens Progressive Jackpot fund.

After the progressive jackpot is hit, the jackpot fund will be re-seeded by the reserve fund at an amount ranging between a minimum of \$1,000 and a maximum of \$50,000. In the event that the reserve fund is depleted, Player's Casino will make up any shortfall. Once there are sufficient monies in the Blazing Sevens Progressive Jackpot reserve fund, the re-seed amount will be reimbursed to Player's Casino from the reserve fund and shall be documented in the accounting records. All increases and decreases to the Blazing Sevens Progressive Jackpot fund shall be documented in the accounting records.

#### **Administrative Fees**

Player's Casino will take an administrative fee ranging from \$8 to \$16 per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with the complicated computer system and program in addition to technicians having to service the systems.

#### No Purchase Necessary

The Blazing Sevens Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the Blazing Sevens Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

#### Equipment

The electronic software and digital reader related to and used in conjunction with this gaming activity has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

- Once the casino verifies the progressive win, the supervisor will press the confirm button. To complete the action, a casino representative's card swipe is required. This records the win onto the Game Manager computer and adjusts the meter appropriately for the prize won. House procedures are then followed for paying the prize. (Reviewing the monitor connected to the Game Manager will show the prize amount to be paid, and pressing the "money bag" icon will print a win page, which can be used to help record the payout for accounting.)
- 2. Once the house dealer reconciles all action, the house dealer presses "End Game." This resets the system to begin the next hand.
- 3. Once the casino representative's card is swiped the prize is logged into Game Manager. If the progressive pay needs to be backed out at this point, the prize will need to be manually backed out using the Game Manager manual adjustment feature.

#### Advertising

The Player's Casino may advertise various names for this gaming activity. <u>Should the Casino</u> advertise a different name, the BGC ID (GEGA-004638) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Player's Casino at all times the gaming activity is being offered for play:

- How a player may enter the tournament.
- The game(s) that will be offered during the play of the tournament.
- The fees that will be charged for entering the tournament, including a description for each fee charged and whether it shall be retained by the Casino, added directly into the tournament prize pool, or any other method of retention or distribution.
- The amount of tournament chips that will be awarded to each player upon entry into the tournament.
- The tournament prize structure that will be offered and the number of players that will be paid.
- When the patron(s) will be paid and the manner in which they will be paid.
- Any other restrictions that apply to the California Games Tournaments.

#### Tournament Log

The Player's Casino shall maintain all completed tournament logs for at least seven years. These logs shall be maintained in either paper or electronic format. The cardroom shall also retain and make available the most recent three months of the tournament logs for inspection by a representative of the Bureau during all hours of operation. Upon request of the Bureau, a licensee shall provide the Bureau with copies of such tournament logs. Tournament logs shall contain the following information:

- Name of Gambling Establishment
- Day, date, time and name advertised for the tournament
- Total number of tables used
- Name of controlled games offered
- Method of entry and amount of any entry fees
- Number and amount of rebuys and/or add-ons offered
- Source of all funds for tournament prize pool
- Number of participants
- Name of each fee charged, amount of each fee charged, total number of each fee collected, and cumulative amount of charged
- Amount of the prize pool
- Amount and reason for any deductions from the total collected prize pool
- Name of gaming activities offered (when applicable)
  - o Funding source
  - o Prize amount
  - o Total number of prizes awarded
  - Total amount deducted from prize pool (when applicable)
- Results of the tournament, including the amount paid out and amount paid for each place in the tournament

• Signature of casino staff responsible for administering the tournament

#### **Eligible Controlled Games**

The Players Casino CA Games Tournaments shall be attached to all Bureau approved California controlled games offered at the Players Casino at all times that the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### Gaming Activities Offered During Tournament Play

There are no Bureau approved gaming activities available with the tournament play.

#### **Tournament Variations**

#### Freeroll Tournaments

- It shall be predetermined and posted when a Freeroll Tournament shall be offered.
- Entry is gained via live game play. Players must qualify by playing live games for a period of time ranging from 1-200 hours within a one day to six month period. Players will be tracked using the Player's Card under the Customer Incentive Program (GEGA-004636.)
- The Freeroll Tournament prize pool will be cash and/or prizes ranging from \$100-\$50,000.
- The Freeroll Tournaments will be funded by the Player's Casino.

#### Tournament Entry

- Tournament entry is open to all customers.
- The specific structure will be on any and all advertisements and must be made available to patrons prior to the start of the tournament. The structure of a tournament will not change once sign-ups begin.
- Promotional materials will not advertise gender-based discounts nor imply a gender-based entrance policy.
- Patrons may enter a tournament by paying the buy-in and entry fee. All fees, prices charged, and the amount of tournament chips provided will be equal and posted for all players.
- Entry may be earned by winning a designated tournament. Full or partial entry may be obtained through a Player's Casino promotion. All promotions will be approved by the Bureau before Player's Casino may offer them for play.
- More than one method of entry for a specific tournament may be utilized.

\*The Entry Fee will be retained by the casino for administering the tournament.

\*\*Service Charge will be used to cover any staffing costs and tips shortfalls.

\*\*\*Staff Appreciation Fee is a fee that will not become part of the prize pool. This fee is obtained for staffing cost and tips.

#### Tournament Prize Amounts & Source of Funds

The prizes will be the cumulative amount of buy-ins, re-buys, and add-ons. The prizes may also be guaranteed.

- When the prize amount is guaranteed the payouts will be a cash value ranging from \$100-\$100,000. The cash will be paid to players from the buy-ins, re-buys, and add-ons. If there is not enough cash to cover the guaranteed prize amount, Player's Casino will fund the difference.
- When the prize pool is not based solely on buy-ins, re-buys and add-ons, the Player's Casino will determine and set the payout structure.

#### Tournament Prize Structure

When the prize is not guaranteed, the prize structure will be broken down by the number of paid entries and percentage paid. The percentage paid out will always equal 100%. In the event the players decide to forgo the payout structure and "split" the total prize pool among them, it shall be permitted and shall be noted in detail on the casino's tournament log.

Prizes may also be in the form of vehicles, trips, vacation packages, buy-ins for another tournament, jewelry, player-tracking points, sports/entertainment tickets, etc.

#### Entities Involved Other than the House

At any time, Players Casino may offer a charity tournament that would include other organizations. These organizations shall be reputable and federally recognized as non-profit or charity organizations. These organizations will not be involved in running the tournament; however, their name may be used in conjunction with the advertising and promoting of the event. Players Casino may donate prizes such as entries into Players Casino tournaments at no cost to the charity.

#### Advertising

The Player's Casino may advertise various names for this gaming activity. <u>Should the Casino</u> advertise a different name, the BGC ID (GEAR-001096) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Player's Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands and corresponding number of tickets earned
- Amount of time played required to earn tickets and the corresponding number of tickets earned.
- Drawing date and time
- Prize amount(s) and prize description(s)
- Day and time ticket(s) will be discarded.
- No Purchase Necessary (NPN) Opportunity
- Any other restrictions that apply to this gaming activity.

#### **Object and Summary**

The California Games Cash Drawing Promotion features a prize element where a player will be given the opportunity to enter the cash drawing and be awarded a prize when the player complete the qualifying hand specified for a particular game. Players enrolled in the Customer Incentive Program (GEGA-004636) featuring the Players Rewards Card, may earn tickets eligible for the drawing by playing designated California games, listed above, during the pre-designated and posted times. The players who make a qualifying hand will be eligible to win between 1 and 10 tickets, which will be entered in the drawing. The qualifying hands are listed in the table below. Tickets earned will be tracked via the Customer Incentive Program (GEGA-004636). The player's rewards card will be swiped when the player has a qualifying hand.

#### **California Games Cash Drawing Promotion**

A staff member will print out all of the qualifying tickets before the designated drawing time and place these tickets into the drawing bin. The tickets will include the player's name, the name of the promotion and the dates and times of the promotion. The tickets will be mixed in the drum of the drawing barrel prior to being drawn. At the announced time, a Player's Casino employee will draw a ticket from the drawing bin.

There will be two types of drawings: Regular and "Guaranteed Win." The type of drawing at each time slot will be clearly announced to players in all promotional material.

For a Regular drawing time, a maximum of three tickets will be drawn, subject to the conditions under the "Eligibility Requirements" below. A staff member of the Player's Casino will verify the winner. If a ticket is drawn and the winner is not present, the ticket shall be placed back in the drawing bin and a new ticket will be drawn.

Once the winning ticket has been drawn, if there are several small prizes leading up to a larger prize, the ticket shall be placed back in the drawing bin, to be eligible for that larger prize drawing. If there is no large prize drawing, after the winning ticket has been selected, then the ticket will be discarded after the prize for that ticket has been awarded and recorded following Casino procedure.

For a Guaranteed Win time slot, tickets will be drawn until a winner is found, with no maximum number of tickets drawn. Once a winning ticket is drawn, with the winner present, the prize will be rewarded. All tickets drawn for which the winner is not present shall be placed back into the drawing bin.

All of the tickets in the drawing bin will be discarded at the end of the promotional period, which may run from 1 to 90 days. The length of the promotional period will be clearly specified before the promotion starts.

#### **Qualifying Hands**

Player's Casino shall offer up to three qualifying hand charts for the California Games Cash Drawing Promotion. Each chart may include multiple specific qualifying hands; however, all qualifying hands within a chart must be offered together at all times.

#### **Option C**

#### **Eligibility Requirements**

This gaming activity shall be open to all players with a Player Rewards Card (Customer Incentive Program: GEGA-004636) who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- The player must have a Player's Casino Player Rewards Card (Customer Incentive Program: GEGA-004636) to be eligible for this promotion.
- The Player Rewards Card (Customer Incentive Program: GEGA-004636) must be on the patron in order to be eligible for qualifying hands.
- There is no purchase required to obtain a Player Rewards Card (Customer Incentive Program: GEGA-004636).
- There is no minimum or maximum number of players required to be playing in a designated game in order for the table to be eligible for the drawing, other than what is required for game play.
- The player with a qualifying hand must complete their hand in order to be eligible for the drawing.
- The player with a qualifying hand does not have to win the hand in order to be eligible for the drawing.
- Qualifying hands are entered through the drawing feature of the player rewards system. When a qualifying hand is made, a Casino employee will scan the player card of the qualifying player.
- Tickets are printed out by a Casino employee prior to each drawing and placed in the bin where they are stored until the end of the designated promotion period, which may run from 1 to 90 days.
- Tickets are non-transferable and can only be used by the player who received the qualifying hand. The winning player will have their ID checked by casino personnel.
- The player must be present to win.
- The player whose ticket has been drawn shall claim their prize within three minutes. If the winning ticket is not claimed within the three minutes, then it shall be treated as though the player was not present to win.
- There will be two types of drawings: Regular and "Guaranteed Win".
- The type of drawing for each time slot will be clearly announced to players in all promotional material.
- At Regular drawing times, if a ticket is drawn, and the winning player is not present, the ticket shall be placed back in the drawing bin and another ticket will be drawn. If the winner again is not present, then the ticket will be placed back in the drawing bin, and a third and final ticket will be drawn. If the holder of the third ticket drawn is not present, then the ticket in the drawing bin, and the prize will rollover to the next applicable promotional period.

- At Guaranteed Win times, tickets will be drawn until a winner is found, with no limit on the amount of tickets drawn. For example, promotional drawing periods are 2:00 pm, 4:00 pm, 6:00 pm, 8:00 pm, 10:00 pm, and 12:00 am. If 6:00 pm and 12:00 am are designated "Guaranteed Win", at those times tickets will be drawn until a winner is found and there will be no rollover. At 2:00 pm, 4:00 pm, 8:00 pm, and 10:00 pm, only three tickets will be drawn and if no winner is found the prize will roll over to the next time slot.
- There is no limit on the number of prizes that a player may win during the promotion.
- NPN players are eligible for this promotion.
- Tournament game tables are not eligible for this gaming activity.
- Casino employees are not eligible to participate in this gaming activity.
- Third-Party Providers of Proposition Player Services (TPPPPS), on and off duty, are not eligible to participate in this gaming activity.

#### <u>Prize</u>

A player that has his/her ticket drawn, and meets all the eligibility requirements, shall be awarded the posted prize ranging in value from \$1 to \$100,000 in the form of casino chips, cash, casino logo merchandise, clothing, and vacation packages. The prize will be paid when the ticket is drawn.

#### **Funding**

The California Games Cash Drawing Promotion will be fully funded by Player's Casino. Therefore, there shall be no additional collection fees taken for this promotion.

#### Administrative Fees

As this promotion is house-funded, there is no associated administration fee.

#### No Purchase Necessary

The California Games Cash Drawing Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the California Games Cash Drawing Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

#### Advertising

The Player's Casino may advertise various names for this gaming activity. <u>Should the Casino</u> advertise a different name, the BGC ID GEAR-001097 shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Player's Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Coupon values
- Procedures to redeem coupons or free play chips
- Whether the promotional chips given to players are single-play or multi-play.
- Any other restrictions that apply to this gaming activity.

#### **Eligible Controlled Games**

The California Games Promotional Chips shall be attached to all Bureau approved California Games offered at the Player's Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The California Games Promotional Chips gaming activity features a promotional element and may be attached to all Bureau approved California Games. Players may receive promotional chip coupons in magazines, websites, mailing advertisements, or handed out to patrons by management at their discretion. Each promotional chip coupon will state the specific qualifying game a player may wager the promotional chip. The promotional chip will have a specific non-cash value printed on the promotional chip. The promotional chip coupon will be exchanged at the cage for promotional chip, and then the chips will be used as the player's wager and placed on the betting circle for the controlled game they are playing. The player will need to bring the coupon (clipped or printed out) with them to the cage in order to acquire the chip. The cage employee will log the coupon, the date the chips were acquired, the type of chips issued, the value of the chip acquired, and who acquired the chips. The player is responsible for any collection associated with the promotional chip bet, unless the game is one in which the player-dealer pays all collection fees.

There are two different types of promotional chips for this promotion, multi-play chips and single use chips. Single-play chips and multi-play chips will be different colors and easily distinguishable from each other. Once the promotional chip has been verified by the floor person that it was played and won or lost, the house dealer will collect the promotional chip if lost, and exchange it for a live chip from their chip tray, for the player-dealer and then the house dealer will deposit the chip into the table drop box. The value of the promotional chip will be given to the player-dealer in live chips by the house dealer.

#### **Multi-Play Chips**

When a player uses a multi-play chip, and wins, they will win the value of the promotional chip wager, paid in live casino chips by the player-dealer, as well as receive the promotional chip back for later use. The value of the promotional chip will be given to the player-dealer in live chips by the house dealer. If a promotional chip is used and the hand is a push, then the chip may be used again until a win or a loss occurs. When the player uses a promotional chip and loses, the promotional chip will be collected by the house dealer and deposit the chip into the table drop box.

#### **Single-Play Chips**

If a player uses a single-play chip to place a wager, when the player wins, they will win the value of the promotional chip paid in live casino chips by the player-dealer. When the player uses a promotional chip and loses, the promotional chip will be collected by the house dealer and deposited into the table drop box. If the promotional chip is used and the hand is a push, then the chip may be used again, until a loss or a win occurs. The house dealer will collect the promotional chip whether the player wins, or loses and exchange it for a live chip from their chip tray for the player-dealer, and then the house dealer will deposit the chip into the table drop box. Then the house dealer will give the value of the single-play promotional chip to the player-dealer in live chips.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- Promotional chips may only be used during play of approved California Games.
- Each promotional chip coupon, will state the specific qualifying game a player may use the promotional chip as, as well as the value of the promotional chip that the player will receive upon redeeming the coupon at the cage.
- Players may not exchange the promotional chip coupons or promotional chips for live chips.
- Promotional chips will only be redeemable by the house dealer or casino employee.
- Backline players are eligible to use a promotional chip to place a wager.
- A player is only eligible to redeem one promotional coupon during a promotional period.
- The coupon will be tracked in a log by casino cage personnel.
- The promotional coupon may only be used during the promotional period.
- Promotional chips may be used as prizes in connection with other Bureau approved gaming activities.
- The promotional chip cannot be combined with live casino chips for wagering, used for tournament play, collection fees, bonus bets, or jackpot fees.
- Casino employees, on or off duty, in or out of uniform, are not eligible for this promotion.
- Third Party Providers of Proposition Players Services (TPPPPS) are not eligible to use the promotional chip as a payout or to place a wager.

#### <u>Prize</u>

A promotional chip will have a non-cash face value ranging from \$1 to \$500 dollars.

#### **Funding**

The California Games Promotional Chip gaming activity will be fully funded by Player's Casino. Therefore, there shall be no additional fees taken for this promotion. All fee collections and table limits are for the designated base games and are Bureau approved, predetermined, and posted at each table.

#### **Administrative Fees**

Player's Casino shall not retain an administrative fee, as this promotion is house funded.

#### No Purchase Necessary

The California Games Promotional Chips does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

#### Advertising

The Player's Casino may advertise various names for this gaming activity. <u>Should the Casino</u> advertise a different name, the BGC ID (GEGA-004636) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Player's Casino at all times the gaming activity is being offered:

- Corresponding time played and points earned or awarded.
- The date(s) and time(s) the gaming activity shall be offered.
- The number of points earned corresponding to the prize amount.
- The time frame in which the points earned are valid to be redeemed.
- The possible prize(s) offered for meeting the requirements of the gaming activity.
- When the bonus prize(s) will be offered throughout the promotion.
- The point level that a player must reach in order to be eligible for the bonus prize(s).
- Any other applicable restrictions.

#### **Eligible Controlled Games**

The Customer Incentive Program shall be attached to all Bureau approved California and Poker controlled games offered at the Player's Casino at all times this gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The Customer Incentive Program features a promotional element attached to the games listed above. This gaming activity is a loyalty reward program open to all Player's Casino patrons who obtain and use a Player's Card. This promotion will track players' time and reward players with points based on time of play at designated table games during pre-determined posted time periods.

#### Player's Card and Computer System Description

The player's card shall be obtained at no charge to the patron and shall include the casino name on the card, some descriptive language regarding restrictions for the card, and the problem gambling phone number. It shall also include a bar-code.

- The card shall be non-transferable and can only be used by the player who the card is assigned.
- If a players' card has been lost or stolen, they can ask a Floor Service Representative for a new one at no cost to the player.
- Player information shall be maintained in a secure database accessed only by casino management. Access to the database shall also be tracked by casino management.
- Player's time played is tracked by having their card scanned. They will receive a
  player's card once they sign up for the Customer Incentive Program at the
  designated registration area. Designated casino employees will be provided with a
  PDA (Personal Data Assistant) that will scan a player's card and input their
  information into the system. Player information shall be maintained in a secure
  database accessed only by casino management. Access to the database shall also
  be tracked by casino management. No one except the network administrator(s) has

access to the back-end systems where the data is stored. Access to the data is by user level with multiple levels based on what the user will be doing. Marketing managers will have access to customer data for marketing purposes (i.e., emails, texts, mass mailings, etc.)

- Alternatively, the card may be scanned through a PDA device, which is installed for each seat at a gaming table. The PDA device will register the player's time so that it can be tracked in the system.
- A printable record of the amount of time a player has accumulated during the period of time that the gaming activity is being offered, shall be available at anytime at their request.

#### How Player Rewards Points are Earned Based on Time Played

Points shall be earned based on the amount of time played. Each player that plays a certain table game during live play will, at certain times, receive points, which will gain them eligibility to win pre-determined and designated prizes. The range of points will be 1 to 200,000 points for each hour of play. Players only receive scans on the hour for a full hour of play and credit is only given for full hours of play. At the top of each hour, a Player's Casino representative will scan each Player Rewards Card in the cardroom, and the players who have a card will earn a scan. The Player's Casino may offer bonus rates (for example, double points) on play during off-peak hours or in specific games, within the range as shown above. Patrons will be given ample notice of how many points will be awarded, as well as, the amount of time required to earn points for each eligible game.

Example: A player signs up for the Customer Incentive Program at the designated registration area and receives a player's card. The player presents the card to the gambling establishment employee at the gaming table at 5:45 pm. The gambling establishment employee scans the player's card using a bar code reader on the PDA device at 6:00 p.m. At 7:00 p.m., a gambling establishment employee scans the player's card again, and the player is credited with one hour of play. The program tabulates the amount of points the player has earned and records it in the player's account. The player may check their point balance and redeem points with a gambling establishment employee at any time during the promotion.

#### How Player Rewards Points are Redeemed

Players may either redeem their points at any time during the promotion or at the end of the promotional period. The redemption period will be displayed in the Player's Casino to give players ample notice. Points not redeemed by the end of the promotional period will expire at the end of the promotional period. All prizes shall have a pre-determined and designated value. The point to dollars ratio for the rewards program is 1 point is worth \$0.10 - \$10.00. After a player has accumulated a pre-determined and specific amount of points, based on time of play, a player may redeem the accrued points for a pre-determined and designated prize.

- After a player has been awarded a prize, they may also be eligible for second and subsequent prize(s) until the end of the promotion.
- Player's may redeem their points for multiple prizes as long as the total amount of points required for the prizes are within the player's point balance.

All fee collections and table limits are for the designated base game and are Bureau approved, pre-determined and posted at each table.

#### Administrative Fees

The Player's Casino shall not retain an administrative fee for operating the Customer Incentive Program gaming activity.

#### No Purchase Necessary

The Customer Incentive Program does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require No Purchase Necessary tables to be offered while conducting this gaming activity.

Based on customer demand and industry trends, The Players Casino (AC) proposes to add a gaming activity for all currently approved controlled games. #### FUNDING

This promotion will be solely funded by PC. There will be no extra collection or fees of any kind assessed to the players.

#### NO PURCHASE NECESSARY

The Food Reward Program does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

#### **ELIGIBILITY TO WIN**

All players who wish to participate will be tracked by a PC customer service representative. The Football Promotion allows patrons who have scanned a minimum of five hours using their Customer Incentive Program card (GEGA-004636) in any of the above eligible controlled games to participate in predicting the winner of Sunday and Monday National Football League (NFL) professional football games, as well as the final score of the Monday night football game. This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Players are required to present their Customer Incentive Program card (GEGA-004636) in order to participate in this promotion.
- Players must have a minimum of five hours scanned using their Customer Incentive Program card (GEGA-004636) in order to participate in this promotion.
- There is a maximum of one entry per week per player.

- 1. The Fortune Pai Gow Poker Progressive considers the best hand possible among each individual player's cards.
- 2. To begin each round, players must make their regular base game wager. They may optionally place any bonus bets along with the optional jackpot fee of \$1. A minimum of two players are required to play for the progressive jackpot.
- 3. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
- 4. Once all players place their bets and/or jackpot fee, the house dealer will press "Game Start" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
- 5. The house dealer then follows standard approved procedures for dealing the base game. All seven cards will be considered. The base game includes a joker which is fully wild and can be used in any hand. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.
- 6. When a player has achieved a winning hand, the house dealer shall press the appropriate button on the keypad. A casino floor person will then be responsible for verifying the winning hand.

\*Per the base game rules, the joker is fully wild for this game and may be used accordingly to complete any hand.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- Backline bettors are not eligible to participate in this gaming activity.
- A minimum of two players (player and player-dealer) are required for the progressive jackpot.
- A player can qualify for the jackpot element of the game, regardless of the outcome of the base game.
- Winning players will be paid in live casino chips by a casino representative at their seat once their hand has been verified by a casino representative.
- There is no limit to the number of times a player can qualify for and win either the fixed or the progressive prize.
- A player may place a base game wager as well as the optional jackpot fee on any unoccupied seat, as well as their own, and become eligible for multiple payouts.
  - Example: If a seated player places a base game wager and the optional jackpot fee on their own seat as well as an unoccupied seat, and achieve a straight flush in both hands, they are eligible for two fixed prize payouts, each equal to 100% of the posted prize.
- Casino employees are eligible to play when off duty and out of uniform.
- Third-Party Providers of Proposition Players Services (TPPPS) are not eligible for this promotion.
- Tournament games are not eligible for this promotion.

#### Prize

The complete payout table for both the progressive prize and the fixed amount prize is listed below.

#### **Progressive Prize**

A player with a Five of a Kind is paid 100% of the progressive jackpot amount shown on the progressive meter. Once the proper paperwork has been filled out and the hand has been verified, the casino representative will pay the winner in live casino chips. In the event that more than one progressive meter pay is hit, the progressive prize will be equally split among the winners.

#### **Fixed Prize**

All fixed payouts will be paid by a casino representative. Once the proper paperwork has been filled out, the floor person will pay the winner in live casino chips. The payouts will not be made from the house dealer's tray. All fixed payouts will be deducted from the amount in the reserve fund and not from the progressive meter. In the event that more than one qualifying hand hits during the same round, all fixed prize winning players will be paid 100% of the posted fixed prize amount. In the event that the reserve fund is depleted, the Casino will cover any shortfall. Once there are sufficient monies in the Fortune Pai Gow Poker Progressive Jackpot reserve fund, the reseed amount will be reimbursed to Player's Casino from the reserve fund and shall be documented in the accounting records. All hands will be paid the posted prize as shown in the pav table below.

#### Funding

The Fortune Pai Gow Poker Progressive Jackpot is player funded with both fixed and progressive elements. The Casino will initially seed the jackpot at \$1,000. Once there are sufficient monies in the Fortune Pai Gow Poker Progressive Jackpot fund reserve, the initial seed will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. After the progressive jackpot is hit, the progressive meter will be reseeded by the reserve fund in a range of \$1,000 - \$5,000. In the event that the reserve fund is depleted, the Casino will cover any shortfall. Once there are sufficient monies in the Fortune Pai Gow Poker Progressive Jackpot reserve fund, the reseed amount will be reimbursed to Player's Casino from the reserve fund and shall be documented in the accounting records. There is no cap on the progressive jackpot.

Each \$1 jackpot fee paid by a player will be broken down as follows:

\$0.35 will be immediately posted on the progressive meter.

• \$0.65 will be tracked in the reserve fund. The reserve fund will be utilized to immediately reseed the metered progressive jackpot in the range of \$1,000 - \$5,000 following a progressive prize win. In addition, this reserve fund will be used to pay all fixed amount prizes and administrative fees.

All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained by the Casino, for examination by regulatory and law enforcement personnel.

#### **Administrative Fees**

The Casino will take an administrative fee ranging from \$8 - \$16 per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with the complicated computer system and program in addition to technicians having to service the systems. If there are not sufficient funds in the reserve fund at the usual time the administrative fee is to be withdrawn, the administrative fee will not be taken until the reserve fund is adequate again.

#### No Purchase Necessary

The Fortune Pai Gow Poker Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the Fortune Pai Gow Poker Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

#### **Equipment**

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

- When a player has a progressive winner, the house dealer shall press the appropriate hand button on the keypad.
- The house dealer shall then contact the casino representative.
- Once the Casino verifies the progressive win, the casino representative shall press "Confirm", then swipe the authorization card. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
- When the house dealer reconciles all action (on behalf of the player-dealer), they press "Game Over." This resets the system to begin the next hand.
- Once the "Confirm" button is pressed and the authorization card swiped, the prize is logged into Game Manager.
- If the electronic software or digital reader malfunctions or breaks down, the jackpot will not be offered.

#### Advertising

Player's Casino may advertise various names for this gaming activity. <u>Should the Casino</u> advertise a different name, the BGC ID (GEAR-001044) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Player's Casino at all times that the gaming activity is being offered for play:

- Eligible game(s).
- Eligible time period(s).
- Qualifying Hands.
- Prize Amount.
- Funding source: Poker Bad Beat Jackpot (GEGA-004385).
- Availability of No Purchase Necessary.
- Any other restrictions that apply to this gaming activity.

#### **Eligible Controlled Games**

The High Hand of the Hour Promotion shall be attached to the following Bureau approved controlled games offered at Player's Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGA-000948)
- Omaha (GEGA-000950)
- Omaha High-Low Split (GEGA-000965)
- Big O High-Low Split (GEGA-004398)

#### **Object and Summary**

During the eligible time period ranging from one-half hour to twenty-four hours, players who receive the highest qualifying hand will receive a predetermined and designated prize. During the promotional period the qualifying hands made will be recorded by the Player's Casino poker floor person, board person, or floor assistant and displayed in a manner clearly visible for all players to see, such as on a whiteboard. The board with the current highest qualifying hand will be located on the poker floor. The player with the highest qualifying hand for a specified time period will win the designated prize.

The promotion may be offered in only one, or all, of the above games during a specific promotional period; this will be clearly posted for the players.

If run concurrently, each game, Hold'em and Omaha (including Omaha, Omaha High-Low Split, and Big O High-Low Split) will have separate prizes and distinct qualifying hands.

**Example:** The promotion may be set up to apply only to Texas Hold'em during the designated time period.

#### **Qualifying Hands**

A player who makes the highest qualifying poker hand (according to traditional poker rankings) in designated games during a pre-determined and posted time period shall be awarded the posted prize. #### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- Only players in jackpot-eligible games, seated at the table, and dealt a qualifying hand are eligible to win.
- Players can win multiple times and win at all games.
- Tournament games do not qualify for this promotion.
- Casino employees on and off duty, in and out of uniform are eligible for the promotion.
- There is no minimum or maximum number of players needed to qualify for the promotion, other than what is already required for game play.
- All qualifying hands must be verified by a Casino floor person in order to be eligible.
- All winning players will have their ID checked by Casino personnel.
- Players must be present in the Casino in order to claim their prize.

#### No Purchase Necessary

The High Hand of the Hour Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the High Hand of the Hour Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

#### Advertising

The Player's Casino may advertise various names for this gaming activity. <u>Should the Casino</u> advertise a different name, the BGC ID (GEGA-004657) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Player's Casino at all times that the gaming activity is being offered for play:

- Eligible time period(s)
- Qualifying Hands and corresponding amount of points earned
- Prize amount, number of prizes, and when winners will be announced
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The High Hand Promotion shall be attached to the following Bureau approved controlled games offered at Player's Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGA-000948)
- Omaha (GEGA-000950)
- Omaha High-Low Split (GEGA-000965)
- Big O High/Low Split (GEGA-004398)

#### **Object and Summary**

During the eligible time period ranging from one hour to one month, players who receive a designated qualifying hand will receive a predetermined and designated number of points for the qualifying hand earned. Points will be tallied and maintained via the Customer Incentive Program (GEGA-004636) through the Player Rewards Card by a casino representative. The number of accumulated points for the top 10 point earners will be posted up on a board located by the poker floor podium. Prizes will be paid to the player(s) accumulating the most points in the promotional time period. Between 1 and 10 top point earners will earn a prize. The number of winners and amounts of prizes will be clearly posted prior to the beginning of the promotional period.

#### **Qualifying Hands**

A player who makes a qualifying hand during a pre-determined and posted time period shall be awarded with the posted number of points. The number of points awarded will be predetermined and posted prior to this gaming activity. Patrons shall be provided with ample advance notice of the qualifying hands. Only one of the minimum qualifying hand options below shall be offered at any one time that the High Hand Promotion is being offered for play. They shall not be offered together at any time nor shall any combination of the minimum qualifying hand options be offered for play. If a qualifying hand is not achieved within the promotional period, no prize will be awarded. Furthermore, the qualifying hands shall be displayed prominently within the Casino at all times the High Hand Promotion is being offered for play. In order to qualify for the promotion, in games utilizing hole cards, the player dealt the winning high hand must use at least one of their two hole cards. The hand does not need to be the winning hand in order to earn points. For example, if a player achieves a four of a kind in a hand, and another player achieves a straight flush, both hands will be eligible to earn points for the High Hand Promotion if they otherwise qualify.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Only players seated at the table, and dealt a qualifying hand, are eligible to win.
- Players may qualify to earn points or to win the prize for this promotion more than once in a 24 hour period.
- Tournament games do not qualify for this promotion.
- Casino employees on and off duty, in and out of uniform are eligible for the promotion.
- There is no minimum or maximum number of players needed to qualify for the promotion, other than what is already required for game play.
- All qualifying hands must be verified by a casino representative in order to be eligible.

- All winning players will have their ID checked by a casino representative.

The High Hand Promotion shall be funded from the reserve fund of the Poker Bad Beat Jackpot (GEGA-004385). There shall be no additional jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate. All collection fees and table limits are for the designated controlled games and are Bureau approved, predetermined, and posted at each table.

#### Administrative Fees

Player's Casino shall not retain an administrative fee as the High Hand Promotion is funded by the Poker Bad Beat promotion (GEGA-004385).

#### No Purchase Necessary

The High Hand Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the High Hand Promotion</u>. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.
### Advertising

Player's Casino may advertise various names for this gaming activity. <u>Should the Player's</u> <u>Casino advertise a different name, the BGC ID (GEGA-003903) shall be referenced on all advertisements relating to the Match Play Promotion.</u>

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be prominently displayed in the Player's Casino at all times the promotion is being offered:

- Eligible games and time periods.
- Coupon and/or free play chip value(s).
- Procedures to redeem coupons or free play chips.
- Any other applicable restrictions.

### **Eligible Controlled Games**

The Match Play Promotion shall be attached to all Bureau approved California games offered at the Player's Casino at all times that the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

### **Object and Summary**

Patrons are awarded match play or free play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. Players who receive a match play or free play coupon will be eligible to win the specific amount printed on the coupon if he/she places a wager on an eligible game equal to the amount listed on the match play coupon.

### **Match Play Coupon**

The Casino will offer match play coupons having a face value from \$5 to \$500 per coupon. The amount will be clearly stated on the coupon. Each coupon will state the specific qualifying game(s) for which the coupon may be used. When playing the match play coupon, the player must place a wager that is equal to the amount of the match play coupon and a player's winning hand will be paid his/her wager as well as the listed amount on the match play coupon by the player-dealer. The player-dealer will then have a floor person sign the coupon verifying that it has been won. All winning coupons are verified and signed by a floor person. Winning coupons are taken to the cage by the floor person, logged, and exchanged for the value listed on the coupon(s). That amount is then returned to the player-dealer. If a player loses, the money part of the wager is collected by the player-dealer, and the coupon is voided and collected by the house dealer. If the player pushes (receives no action), the coupon may be played again until the player wins or loses a hand.

**EXAMPLE**: A person receives a match play coupon with a value of \$5 that specifically states it may be used to place a wager on the Pai Gow Poker table. The person would place the coupon on the gaming table; place a bet that matches the amount on the coupon, and pay the posted collection (if applicable) for a single hand of play. If the player wins the hand, he/she will receive \$10 just as if they had placed a \$10 bet and the player-dealer will collect the coupon.

### Free Play Coupon/Chip

The Casino will offer free play chips having a face value from \$5 to \$500 per chip. The free play chips are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash.

The free play chips shall initially be in the form of a coupon which shall be offered to all patrons that wish to come into the Casino and use them to play. Patrons may be awarded free play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. When a patron receives a free play coupon he/she shall take the coupon to the cage for verification, logging, and redemption of the free play chip(s) to be used in a live game. Each coupon shall state the specific qualifying game(s) that the free play chip(s) may be used on.

Free play chips shall be used as the player's bet and placed on the betting circle. The player will pay the posted collection (if applicable) for a single hand of play. Free play chips shall not be taken into the dealer's tray, nor shall they be paid from the dealer's tray. The free play chip will be collected by the person in the player-dealer position who will then have a floor person verify that the chip has been played. All played free play chips are verified by a floor person. The free play chip is taken to the cage by a floor person, logged, and exchanged for the value listed on the chip and the amount designated on the free play chip is paid to the player-dealer. If the player loses the hand, the free play chip is forfeited and will be collected by the casino dealer and dropped in the drop box for accounting purposes. If the player pushes (receives no action), the chip may be played again until the player wins or loses a hand.

**EXAMPLE**: A person receives a free play chip coupon for \$10 that specifically states it can be used to place a wager on the No Bust Blackjack table. The player would take the coupon to the cage. Cage personnel would log the redemption code of the coupon and exchange the coupon for a promotional free play chip. The player would then place the free play chip on the gaming table, pay the posted collection (if applicable), and the hand would be played.

### **Eligibility Requirements**

The promotion will be open to all players who are seated and playing at the above listed games during the pre-determined and specified hours designated for the promotion.

- A minimum of two (2) players, a player and a player-dealer, is required to be playing in any of the games, as listed above, in order for the game to qualify.
- Each coupon will state the specific qualifying game(s) that a player may use the coupon at.
- Players shall not exchange the coupons for live chips or give them to another player.
- The coupons and chips shall only be redeemed after having been played by a customer, and then verified by a floor person.
- All procedures, times, qualifying hands, and prize amounts must be displayed prominently via any form of advertising that the Player's Casino wishes to use, including but not limited to printed flyers, digital display, the Casino's website, etc.
- Casino Employees, on and off duty and in and out of uniform, are not eligible for the promotion

• Third-Party Providers of Proposition Player Services (TPPPPS) are not eligible for the promotion.

### <u>Prize</u>

The match play coupons and/or free play chips shall have a value ranging from \$5 to \$500 for each coupon or free play chip. Players shall not exchange match play coupons or free play chips for live chips. Additionally, players shall not give match play coupons or free play chips to another player. The coupons and chips shall only be redeemed after having been played by a customer and then verified by a floor person.

### **Funding**

The Match Play Coupon Promotion shall be fully funded by the Player's Casino. There shall be no additional promotion fees, jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate.

### No Purchase Necessary

The Match Play Coupon Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

### Advertising

Player's Casino may advertise various names for this gaming activity. <u>Should the Casino</u> advertise a different name, the BGC ID (GEAR-001146) will be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, will be prominently displayed in Player's Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Prize amount(s) and prize description(s)
- Limit on the number of prizes (if applicable)
- No Purchase Necessary Opportunity
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Merchandise Giveaway Promotion will be attached to all Bureau approved California and poker games offered at Player's Casino at all times the gaming activity is being offered for play. All controlled game rules will be played as approved by the Bureau.

### **Object and Summary**

Players may earn a prize for being seated and playing in any live poker or California game during the designated promotional period(s).

### **Eligibility Requirements**

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- There is a minimum of two players, a player and a player-dealer, required for California games.
- There is a minimum of two player required for poker games.
- Players playing multiple hands are only eligible to win one prize.
- There is a limit of one prize per person, per promotional period.
- The Casino may place a limit on the number of prizes offered.
  - Example: The Casino may announce that beginning at 11:00 a.m. on a specified day, only the first 200 seated players will receive a souvenir Players Casino cap.
- Tournaments are eligible for this promotion.
- Casino employees are eligible for this promotion when off duty and out of uniform.
- Patrons in the player-dealer position are eligible for this promotion.
- Backline bettors are not eligible for this promotion.
- Third-Party Providers of Player Services (TPPPS) are not eligible for this promotion.

### <u>Prize</u>

The prize for the Merchandise Giveaway Promotion will be cash or merchandise with a value from \$1 to \$10,000.

### **Funding**

The Merchandise Giveaway Promotion is fully funded by Players Casino. There will be no additional fees taken from the players or the pot.

### **Administrative Fees**

Players Casino will not retain administrative fees, as this promotion is house funded.

### No Purchase Necessary

The Merchandise Giveaway Promotion will be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>. The Casino will provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material will state "No Purchase Necessary" when referencing the Merchandise Giveaway Promotion. The prize amount is progressive. The bad-beat jackpot will be seeded at a minimum of \$1,000.00 and will increase every morning between \$50 - \$150.00. When won, the badbeat jackpot will be re-seeded at a minimum of \$1,000.00 and will increase within the range provided above. The jackpot will cap at \$50,000.00. If the cap is reached, a reserve will be funded with the minimum daily increases.

In all poker games, both players' hole cards must play. Players with qualifying winning and losing hands must play through the final betting round, which is after "the river," in order to

qualify for the jackpot. The table will be in-eligible for the jackpot if a player with one of the qualifying hands folds prior to the final betting round.

Casino employees are eligible to participate in the jackpot at any time.

The Player's Casino Jackpot gaming activity features a progressive prize. A prize is awarded to players participating in a designated California game, as stated above, when a designated second hand is beaten by a better qualifying hand at the showdown. When the winning and losing hands are confirmed, those players with the qualifying jackpot hands shall receive the posted percentage of the jackpot prize. Additionally, a posted percentage of the jackpot prize, known as the table share, shall be evenly distributed amongst all other players at the qualifying table who have participated in the designated game, as shown below. Also, a posted percentage of the jackpot prize, known as the room share, shall be evenly distributed amongst all active players at the other qualifying tables who have participated in the same designated game at the time the jackpot is hit, as shown below.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

- When a qualifying hand is announced, a floor person shall verify that both hands qualify. Any deviation from a standard deck will nullify the jackpot.
- There must be at least two players, one player and one player-dealer to be eligible for a jackpot prize.
- Any backline bettors that wager on a winning or losing hand shall receive an equal portion of the posted prize percentage for that hand.
- One of the qualifying hands must be held by the player in the player-dealer position.
- Only one jackpot prize shall be paid per round of play.

### **Funding**

The Player's Casino Jackpot gaming activity features a progressive prize pool which shall be funded by a \$1 jackpot collection paid by the player-dealer per round of play. The Player's Casino will initially seed the Player's Casino Jackpot with \$500. The funds taken in per day for this gaming activity shall be split between the main jackpot prize pool and a reserve account. Once enough funds are established, the Casino will be reimbursed from the reserve account for the initial amount that the jackpot is seeded with. The Player's Casino Jackpot prize pool is then increased daily at pre-determined and designated times with the amount depending on the jackpot collection fees collected ranging in an amount from \$50 to \$500 per day. ### **Object and Summary**

The Pocket Aces Cracked promotion features a fixed jackpot prize attached to the games listed above. A prize is awarded to players participating in a game when a hand containing a pocket pair of aces is beaten by a better hand at the showdown.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

- There is no minimum or maximum number of players required to be dealt in during a qualifying game in order for players to be eligible and the table to qualify for the jackpot.
- When a qualifying hand is announced, a floor person will verify that both hands qualify. Any deviation from a standard deck will nullify the jackpot.
- In order to qualify for the jackpot, the player dealt the qualifying losing hand must use both hole cards.
- In order to qualify for the jackpot, there is no minimum round the player must complete. The player only needs to be dealt in.
- In order to qualify for the jackpot, the player must complete the applicable bets on each round. If the player goes all-in, this is considered to have completed all bets.
- In order to qualify for the jackpot, the player must lose the hand at the showdown, after the final round of betting.
- In the event that during a round of play, two players have qualifying hands, each qualifying hand will receive the full amount of the jackpot.

- The jackpot will not be valid during tournament play and is only valid during live game play.
- Casino employees on and off duty, in and out of uniform are eligible to participate and win the jackpot at any time.

### <u>Prize</u>

A player that receives the qualifying losing hand will receive a fixed cash amount ranging from \$1 to \$100,000 in the form of cash, chips, or merchandise.

### **Funding**

The Pocket Aces Cracked promotion shall be fully funded from the reserve account of the previously approved Poker Bad Beat Jackpot (GEGA-004385). There shall be no additional promotion fees, jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate. All collection fees and table limits are for the designated controlled game and are Bureau approved, pre-determined, and posted at each table.

The Double Jackpot shall be attached to all Bureau approved controlled games offered at Player's Casino. The eligible games will be clearly announced before the promotion begins. All controlled game rules shall be played as previously approved by the Bureau.

### **Object and Summary**

The Poker Bad Beat Jackpot features a progressive jackpot prize. A prize is awarded to players participating in any of the above named games when a designated qualifying hand is beaten by a better hand at the showdown. When the winning and losing hands are confirmed by a casino representative, those players with the qualifying jackpot hands shall receive the posted percentage of the jackpot prize amount. In addition, available to the players during certain designated times and tables, there will be two additional jackpot options offered known as the Double Jackpot and the Hardway Jackpot.

### **Qualifying Hands**

### Poker Bad Beat Jackpot

Players that make one of the following qualifying hands for any of the specified poker games shall be eligible to win their share of the Poker Bad Beat Jackpot prize amount, as shown below. The losing hand must be the second-best hand to qualify for the jackpot. Furthermore, the qualifying winning and losing hands shall be displayed prominently within Player's Casino at all times the Poker Bad Beat Jackpot is being offered for play. Only one qualifying hand option per game shall be offered at any one time.

The losing hand must be the second-best hand to qualify for the poker jackpot. If the highest ranking losing hand doesn't qualify for the qualifying hands table, no jackpot prize will be awarded.

For example: if there are two hands, A and B, which would otherwise qualify under the Poker Bad Beat Jackpot, Double Jackpot or Hardway Jackpot qualifying rules, and another hand C which is a better hand than B but does not qualify under the rules, there will be no jackpot prize awarded. In this case, hand B is the <u>third</u> best hand and the non-qualifying hand C is <u>second</u> best hand. If the highest ranking losing hand doesn't qualify for the qualifying hands table, no jackpot prize will be awarded.

Game example: While running the Poker Bad Beat jackpot, with board cards AAAQ10, if hand A is four of a kind using both hole cards (A, K), hand B is aces full of jacks using both hole cards (JJ's), and hand C is aces full of queens using only one hole card (Q,3), hand C is the second best hand but cannot win any jackpot because it does not qualify by the rules. In this scenario, there would be no jackpot because the two qualifying hands are the winning and third-place hands.

### Double Jackpot

Player's Casino may designate certain times and days at which the Poker Bad Beat Jackpot prize in specified games and/or limits will be doubled. The qualifications for the Double Jackpot will be exactly the same as for the currently running Poker Bad Beat Jackpot. For example, a Double Jackpot in Texas Hold'em may be offered from 6:00pm to 10:00pm every Monday night. The qualifying periods for the Double Jackpot will be clearly posted and announced beforehand. The Double Jackpot promotion may be offered in all games, or only in specific games and limits, for example, in limit Texas Hold'em only. Eligible games and limits will be clearly specified before the start of the promotion. The Poker Bad Beat Jackpot progressive meter will not change when the Double Jackpot is being offered as the amount is calculated from the posted Poker Bad Beat Jackpot amount. The amount that is shown on the progressive meter will be paid out and the other half of the Double Jackpot will be paid from the reserve fund.

Example, if the Double Jackpot is being offered and the jackpot hits when the progressive meter reads \$50,000, the other \$50,000 will be paid from the reserve fund.

### Hardway Jackpot

At other designated times, a different type of double jackpot known as the Hardway Jackpot promotion may be offered in Texas Hold'em. If a hand is beaten which qualifies under the Hardway Jackpot rules, the prize will be paid out as a Hardway Jackpot prize. Only the highest jackpot prize amount will be awarded.

Players that make one of the following qualifying hands for Texas Hold'em shall be eligible to win double the amount of the currently posted Poker Bad Beat Jackpot progressive jackpot prize. The Poker Bad Beat Jackpot progressive meter will not change when the Hardway Jackpot is being offered as the amount is calculated from the posted Poker Bad Beat Jackpot amount. The Hardway Jackpot will be paid from the reserve fund.

The Hardway Jackpot promotion, when offered, will run concurrently with the regular Poker Bad Beat Jackpot. The Hardway Jackpot promotion may be offered in Texas Hold'em at any given time except that the Hardway Jackpot will not be offered at the same time as the Double Jackpot. The Casino will offer the Hardway Jackpot at double the Poker Bad Beat Jackpot prize amount, with the qualifying hands from the table shown below. Only one type of jackpot will be awarded per qualifying hand situation. Only one qualifying hand per game shall be offered at any one time. Qualifying hands are shown in the table below:

### **Eligibility Requirements**

This gaming activity shall be open to all players seated and playing at an above listed controlled game during the predetermined and specified hours designated and posted for the gaming activity.

- In order to qualify for the jackpot(s), players with qualifying winning and losing hands must play through the final betting round. If any player(s) with one of the qualifying hands folds prior to the final betting round, then the table will be ineligible for the jackpot.
- In the event two or more players make a qualifying winning and/or losing hand, the player with the highest winning and/or losing qualifying hand shall win the posted percentage of the prize for that hand; all other players shall win the posted percentage of the table share.
- When a qualifying hand is announced, a casino representative shall verify both hands qualify. Any deviation from a standard deck will nullify the jackpot.
- In all eligible poker games, except for Lowball, two hole cards must be utilized.
- There must be at least three active players in order for each table to be eligible for the jackpot prize, with the exception of Hold'em style games.
- In Hold'em style games, including Omaha, Omaha Hi/Lo Split, Big O, Big O Hi/Lo Split, Pineapple, and Texas Hold'em, there must be at least four active players.
- If the jackpot amount is in the process of being changed on the jackpot prize pool display monitor at the time a qualifying hand is made, the prize awarded will be in the newly posted amount.
- The losing hand must be the second-best hand to qualify for the jackpot.
- A player must be dealt in the Jackpot qualifying hand to be eligible for the Winning, Losing, or Table share of the jackpot prize.
- Casino employees are eligible to participate in the jackpot on and off duty and in and out of uniform.
- Tournament games are not eligible for the jackpot.
- If multiple jackpots (different Bureau approved gaming activities) are offered at the same time, only the highest jackpot prize amount will be awarded if the player achieves the same qualifying event on multiple jackpots.

### Prize Amount

The players that make the predetermined and posted qualifying losing and winning hands shall be eligible to win the corresponding progressive prize amount. The prize amounts shall start at a minimum of \$100 with no maximum. The Hardway Jackpot and Double Jackpot will not be offered if the Poker Bad Beat Jackpot progressive meter reaches more than \$100,000. Players will be paid once the hands have been verified by a casino floor representative.

### Prize Payout Structure

Players that make the approved qualifying hands shall be eligible to win their share of the Poker Bad Beat Jackpot prize amount, according to the payout option, as shown below. Only one prize payout structure shall be used at any one time for this jackpot.

Tables shall be eligible for a posted percentage of the jackpot prize, referred to as the table share, which shall be evenly distributed among all other players participating at the table at the time the jackpot is hit. If the share of odd amounts is less than a dollar, the amount is rounded up to the nearest dollar. The Casino will use reserve funds to cover any additional shortfall to ensure all players are paid the same amount.

Players may be eligible for a posted percentage of the jackpot prize, referred to as the room share, which shall be evenly distributed amongst all active players at the other qualifying tables who have participated in the same designated game at the time the jackpot is hit, depending on the payout structure in place at the time, as shown below. Player's Casino will utilize a jackpot prize pool monitor and posters or other advertisements to display the prize amounts, and days and times of the promotion.

\*\* Room Share: The Room Share percentage is divided equally among all qualifying players who were dealt in at the time of the qualifying jackpot hand while seated at tables with a minimum of four players. Players that received a Losing, Winning, or Table Share are not eligible to also receive a Room Share. If the room share payout table is utilized and the Double Jackpot is hit, the entire posted amount will be doubled and then distributed to the losing hand, winning hand, players at the table, and players in the same game at different tables, according to the specified percentages.

### **Funding**

The Poker Bad Beat Jackpot features one progressive prize pool for all specified poker games and is player funded by a mandatory \$1 jackpot fee. The jackpot fee will be taken from the pot if a "flop" occurs in a designated hand, at a designated table. If a flop does not occur no jackpot fee shall be taken. For Lowball, the jackpot fee will be taken after the draw.

The Player's Casino will initially seed the Poker Bad Beat Jackpot with an amount ranging from \$100-\$100,000. When the jackpot fee has been taken, the entire \$1 jackpot fee goes to the reserve account from which all prize funds are drawn. The prize pool will progressively increase at predetermined and designated times each day in an amount ranging between \$50 and \$5,000 based on the collections taken in the previous day. The progressive meter will not have a cap. The Double Jackpot and the Hardway Jackpot will be supplemented by the reserve account.

The progressive prize amount is updated at 12:00 p.m. daily. The Double Jackpot and the Hardway Jackpot will not be offered if the Poker Bad Beat Jackpot progressive reaches more than \$100,000. If the jackpot passes the \$100,000 mark on a certain day, there will be a clear demarcation at that time.

When the jackpot has been hit, it will be reseeded with an amount ranging from \$100-\$100,000 immediately from the reserve account. If there are insufficient funds in the reserve account, the Casino will reseed the jackpot and shall be reimbursed once sufficient funds become available in the reserve account. If the collected amount from the day before is ever less than the minimum amount, the Casino will make up the difference and be reimbursed from the reserve account.

### **Administrative Fees**

Player's Casino shall retain an administrative fee in the range of \$8-\$16 per table per hour that the jackpot is in operation. The administration fee is taken from the reserve account. If there are not sufficient funds in the reserve account at the usual time the administrative fee is to be withdrawn, the administrative fee will not be withdrawn until such time as the reserve is again adequate.

### No Purchase Necessary

The Poker Bad Beat Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the</u> Poker Bad Beat Jackpot. <u>This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

### Advertising

Player's Casino may advertise various names for this gaming activity. <u>Should the Casino</u> advertise a different name, the BGC ID (GEGA-004619) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Player's Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Amount of time played required to earn tickets and corresponding number of tickets earned
- Drawing date(s) and time(s)
- Prize amount(s) and prize description(s)
- Number of tickets drawn
- Amount of time to claim prize
- Day and time ticket(s) will be discarded
- Funding source: Poker Bad Beat Jackpot (GEGA-004385)
- No Purchase Necessary Opportunity
- Any other restrictions that apply to this gaming activity

### **Object and Summary**

The Poker Cash Drawing Promotion features a fixed prize element where players will be given the opportunity to enter the drawing and be awarded a prize when the player completes the time requirement necessary. Players may earn tickets into the drawing by playing designated poker games for a pre-designated and posted time during specific time periods. Poker players who play between 1 hour and 100 hours will be eligible to win between 1 and 10 tickets to enter the drawing. Time will be tracked via the Customer Incentive Program (GEGA-004636) through the Players Rewards Card. The ticket to time ratio and prizes to be awarded will be clearly announced on all promotional literature prior to the promotional period.

For example, a player may receive one ticket for playing 40 hours in a given month or one ticket for every hour played between 12:00 p.m. and 8:00 p.m. on Mondays.

There will be two types of drawings- "Rollover" and "Guaranteed Win". The details of the drawing for each time slot will be clearly announced and publicized on all promotional materials. Each promotion may consists of either one or the other of these drawing types or a combination of the two.

Tickets will be generated from the player rewards computer. A casino representative will print out all the qualifying tickets before the designated drawing time and place these tickets into the drawing bin. Drawings will occur at a minimum of once a year and at a maximum of one drawing per hour daily. At the announced time, a Casino representative shall draw a ticket from the drawing bin.

For "Rollover" Drawing times, a maximum of three tickets will be drawn per the drawing period, subject to the conditions under "Eligibility Requirements" below. A casino representative of Player's Casino shall verify the winner. If a ticket is drawn and the winner is not present, the ticket shall be discarded and another ticket will be drawn. If the winner is again not present, the same procedure will be followed, and a third and final ticket will be drawn. If the holder of the third ticket is not present, the ticket will be discarded, and the prize will roll over to the next applicable promotional period, and then there will not be a winner for that time period. Once a winning ticket has been drawn, verified, and the prize awarded, the winning ticket would be retained for record-keeping purposes. All of the remaining tickets in the drawing bin shall be discarded at the end of a specified period, which will be from 1 hour to 1 year. The retention period will be clearly announced prior to the start of the promotion.

For "Guaranteed Win" drawing times, tickets will be drawn until a winner is found. There will be no three-ticket maximum. The same procedure will be followed regarding the handling of drawn tickets. Details follow under "Eligibility Requirements."

Winners of a "Guaranteed Win" drawing may be awarded the opportunity to select one envelope from a set of sealed, numbered envelopes each of which contains a key. A specified number of entrants will be awarded this opportunity by having their tickets drawn. On the final day of the promotion, from 1 to 10 drawings will be held, at each of which one winner will be selected. An additional prize, such as cash or merchandise, may be awarded to the winner at this time. Only the winning key will unlock and start the vehicle. The specific vehicle will be clearly advertised in advance of the promotion. Each player may win only one key regardless of the number of times their name is drawn. Once a player has made a final selection of an envelope, they will not be allowed to switch or change keys. Players must choose the envelope at the time their ticket is drawn. This prize option will only be associated with a "Guaranteed Win" type of drawing.

At a designated time, the key winners will try their keys in the vehicle in the order in which their keys were won. The person with the key which unlocks the vehicle is the prize winner. The player must be present to try the key in the vehicle.

Players who qualify by playing during designated time periods may earn entry into more than one drawing. For example, fulfilling the time requirement may qualify a player for a monthly drawing and also for a separate end of the year drawing.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Player's must have a Player's Casino Player Reward Card (GEGA-004636) to be eligible for this promotion. There is no purchase required to obtain a Player Rewards Card.
  - Player's may acquire a Player Rewards Card on the day of the promotion but may only be credited for drawing entries earned after acquiring the card.
- The amount of tickets awarded may differ for games and/or limits. This will be clearly announced to the players before the promotion commences.
- There is no minimum or maximum number of players required to be playing in a designated game in order for the table game to be eligible for the drawing, other than what is required for game play.
- Tickets are non-transferable and can only be used by the player earning the ticket by time played. The winning player will have their ID checked by a casino representative.
- Players must be present to win. The player whose ticket is drawn shall claim their ticket within 1 to 3 minutes. The time allowed to claim a ticket will be specified before the promotion commences and will be clearly posted on all advertisements. It is the players' responsibility to notify a casino representative of their presence.
- At "Rollover" drawing times, if a ticket is drawn and the winner is not present, the ticket shall be discarded and another ticket will be drawn. If the winner is again not present, the same procedure will be followed, and a third and final ticket will be drawn. If the holder of the third ticket is not present, the ticket will be discarded, and the prize will roll over to the next applicable promotional period. All winning tickets will be retained for record-keeping purposes.
- There may be 1 to 10 winners at each designated drawing time for a "Guaranteed Win" drawing. The number of winners will be clearly announced and posted prior to the drawing.
- The same procedure for handling drawn tickets in a "Guaranteed Win" drawing will be followed as in "Rollover" drawings, with the exception of the maximum number of tickets drawn.
- At "Guaranteed Win" drawing times, tickets will be drawn until a winner is found, with no limit on the amount of tickets drawn. For example, promotional drawing periods are 2:00 p.m., 4:00 p.m., 6:00 p.m., 8:00 p.m., 10:00 p.m., and 12:00 a.m. If 6:00 p.m. and 12:00 a.m. are designated "Guaranteed Win". At those times tickets will be drawn until a winner is found and there will be no rollover. At 2:00 p.m., 4:00 p.m., 8:00 p.m., and 10:00 p.m., only three tickets will be drawn and if no winner is found the prize will roll over to the next time slot.
- Any copied or altered tickets will be voided and the player will be disqualified.
- Tournament game tables are not eligible for this gaming activity.
- Casino employees are not eligible to participate in the promotion.

The following will also apply when the prize is a car giveaway:

- Player's Casino may offer a cash option for the winning key holder.
  - The availability of a cash option would be at management's discretion and clearly announced to patrons before the promotion begins.
  - If a cash option is offered the winning player would have the choice of cash or the vehicle.

- Keys are non-transferable. Any sale or transfer will disqualify the key winner from the promotion.
- The winner may be required to pay any applicable taxes on merchandise won.
- All applicable federal, state and local laws will be followed in awarding prizes.
- For any dispute regarding matters covered or not covered in these rules, management's decision will be final.

### <u>Prize</u>

A player that has their ticket drawn, and meets all the eligibility requirements, shall be awarded the posted fixed prize ranging in value from \$1 to \$100,000 in the form of live casino chips, cash, a motor vehicle, casino logo merchandise, clothing, tickets to sporting events, vacation packages, and/or merchandise. The player may be offered a choice of these prizes.

### **Funding**

The Poker Cash Drawing Promotion shall be funded by the reserve jackpot fund for the Poker Bad Beat Jackpot (GEGA-004385). Any shortfall shall be covered by Player's Casino and shall be reimbursed once there are sufficient funds in the reserve fund. Therefore, there shall be no additional collection fees taken for this promotion.

### Administrative Fees

Player's Casino shall not retain an administrative fee for this promotion, other than what is taken for the previously approved jackpots.

### No Purchase Necessary

The Poker Cash Drawing Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the Poker Cash Drawing Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

Poker Tournaments

### Advertising

Player's Casino may advertise various names for this tournament. <u>Should the Casino advertise</u> a different name, the BGC ID (GEGA-000541) shall be referenced on all advertisements relating to the gaming activity.

Furthermore, all rules and procedures for the tournament, including but not limited to the following, shall be prominently displayed in Player's Casino at all times the gaming activity is being offered for play:

- How a player may enter the tournament.
- The game(s) that will be offered during the play of the tournament.
- The fees that will be charged for entering the tournament, including a description for each fee charged and whether it shall be retained by Player's Casino, added directly into the tournament prize pool, or any other method of retention or distribution.
- The amount of tournament chips that will be awarded to each player upon entry into the tournament.
- The tournament prize structure that will be offered and the number of players that will be paid.
- When the patron(s) will be paid and the manner in which they will be paid.
- Patrons will be given ample notice of which option is being offered and it will be displayed prominently via printed flyers, digital display, and any other forms of advertisements that the club uses to promote the tournament(s).
- Any other restrictions that apply to the Poker Tournaments.

### **Gaming Activities Played with Tournaments**

- The rules and procedures for any and all gaming activities that are being offered in conjunction with the Poker Tournaments.
- All information related to prize ranges and amounts for all gaming activities associated with the Poker Tournaments.
- Live Play Credit- Number of hours required to play in live game in order to be eligible for additional tournament chips

### Tournament Log

The Player's Casino shall maintain all completed tournament logs for at least seven years. These logs shall be maintained in either paper or electronic format. The cardroom shall also retain and make available the most recent three months of the tournament logs for inspection by a representative of the Bureau during all hours of operation. Upon request of the Bureau, a licensee shall provide the Bureau with copies of such tournament logs. Tournament logs shall contain the following information:

- Name of Gambling Establishment
- Day, date, time and name advertised for the tournament
- Total number of tables used
- Name of controlled games offered
- Method of entry
- Number and amount of rebuys and/or add-ons offered
- Number of participants

Poker Tournaments

- Name of each fee charged, amount of each fee charged, total number of each fee collected, and cumulative amount of collected.
- Source of all funds for tournament prize pool
- Amount of the prize pool
- Amount and reason for any deductions from the total collected prize pool
- Name of gaming activities offered (when applicable)
  - o Funding source
  - Prize amount
  - o Total number of prizes awarded
- Results of the tournament, including the amount paid out and amount paid for each place in the tournament
- Signature of casino staff responsible for administering the tournament

### **Eligible Controlled Games**

The Poker Tournaments shall be attached to all Bureau approved Poker controlled games offered at the Player's Casino at all times that the gaming activity is being offered for play. All controlled games shall be played as approved by the Bureau.

### Gaming Activities Offered During Tournament Play

### Bounties

- If there is a bounty(s) offered for the tournament; when "player x" knocks out the "advertised bounty" player(s) by ending their play in the tournament, then "player x" will be awarded their bounty.
- The bounty(s) will be paid to "player x" during the tournament or as soon as their tournament play ends; casino will determine.
- The bounty amount will range from \$1.00 to \$10,000.00.
- If a bounty or bounties are advertised then this prize amount will be deducted from the total number of buy-ins, rebuy(s) and add-on(s) or the casino will pay this prize amount.
- If a group at the final table decided to split the prize pool amongst themselves evenly, the bounty(s) will become part of the total split.

### Live Play Credit

### Object and Summary

During selected times and tournaments, players will be allowed to earn extra tournament chips for playing in a live poker game within the immediate two hours prior to the tournament.

### Eligibility Requirements

• The player must play at a live poker game within the two hour period immediately preceding the tournament.

Poker Tournaments

- The player must request a card from a floor person. The floor person will monitor the player and stamp the card identifying the amount of time the player has played at the live table poker game.
- The minimum time a player must play at a live poker game to be eligible for the additional tournament chips is one hour. The maximum number of hours that a player can play at a live poker game and be eligible for the additional tournament chips is two hours.
- At the end of the designated time the player will turn the stamped card in to the tournament desk and receive additional tournament chips based on the amount of time played at the live table.

### <u>Prize</u>

Each player that plays for the predetermined and posted amount of time at a live poker game will receive between 1 - 2,000 additional tournament chips.

### Funding

No funding is needed in this gaming activity because tournament chips have no cash value.

### **Tournament Entry**

- Tournament entry is open to all customers.
- The specific structure will be on any and all advertisements and must be made available to patrons prior to the start of the tournament. The structure of a tournament will not change once sign-ups begin.
- Promotional materials will not advertise gender-based discounts nor imply a gender-based entrance policy.
- Patrons may enter a tournament by paying the buy-in and entry fee. All fees, prices charged, and the amount of tournament chips provided will be equal for the initial buy-in and posted for all players.
- Entry may be earned by winning a previous tournament or a Bureau approved gaming activity. All gaming activities and/or promotions shall be approved by the Bureau prior to being offered for play.
- More than one method of entry for a specific tournament may be utilized.

\*Add-on may consist of non-monetary instruments; for example, bring in a toy for Toys for Tots and receive \$500 in tournament chips, etc.

\*\* The Entry Fee is used for the income for the casino and/or pay expenses and tips for the dealers and staff.

\*\*\* The Service Charge will range from \$0 - \$500.00. The service charge is used exclusively to pay the tournament staff for tips, etc. This is not income for the casino.

Poker Tournaments

\*\*\*\* The Staff Appreciation Fee shall be an optional fee that tournament entrants may pay in exchange for additional tournament chips. This fee shall not be included in the tournament prize pool. This fee is retained by the casino and used exclusively to tip tournament dealers.

### **Tournament Prize Amounts & Source of Funds**

The prizes will be the cumulative amount of buy-ins, re-buys, and add-ons. The prizes may also be guaranteed. The cardroom may provide prizes or add funds to the prize pool for special events.

- When the prize amount is guaranteed the payouts will be a cash value ranging from \$100 - \$250,000. The cash will be paid to players from the buy-ins, re-buys, and addons. If there is not enough cash to cover the guaranteed prize amount, Player's Casino will fund the difference.
- When the prize pool is not based solely on buy-ins, re-buys and add-ons (free roll), Player's Casino will determine and set the payout structure.

### Tournament Prize Structure

When the prize is not guaranteed, the prize structure will be broken down by the number of paid entries and percentage paid. The percentage paid out will always equal 100%. In the event the players decide to forgo the payout structure and "split" the total prize pool amongst themselves, it shall be permitted and shall be noted in detail on the casino's tournament log.

Player's Casino may donate prizes such as entries into Player's Casino tournaments at no cost to the charity."

### No Purchase Necessary

The gaming activities attached to the Player's Casino's Poker Tournaments shall be offered for free, on a general and indiscriminant basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary (NPN) game. The Casino shall provide No Purchase Necessary tables for patrons who request to participate in the gaming activities attached to the Poker Tournaments without paying any entry into the tournament. The NPN player must adhere to all rules as approved. All advertisements shall state "No Purchase Necessary" when referencing the gaming activities offered during the Poker Tournaments

### Advertising

Player's Casino may advertise various names for this gaming activity. <u>Should the Casino</u> advertise a different name, the BGC ID (GEAR-001239) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Player's Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Requirements for qualifying hands
- Jackpot prize amount and prize description
- No Purchase Necessary Opportunity
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Royal Flush Jackpot Promotion shall be attached to the following Bureau approved controlled games offered at Player's Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

### **Object and Summary**

The Royal Flush Jackpot Promotion features a progressive jackpot prize, which is awarded to players participating in a qualifying poker game when a Royal Flush in any suit is achieved. All prizes will be paid in the form of live casino chips.

### **Qualifying Hands**

The Royal Flush Jackpot prize shall be awarded to a player who achieves a qualifying hand as shown below while dealt into a qualifying poker game. A qualifying Royal Flush hand will be eligible for this jackpot in addition to the Super Jackpot (GEAM-000501), the Poker Bad Beat (GEGA-004385), the High Hand of the Hour (GEAR-001044), or any other similar promotions. The Royal Flush Jackpot Promotion may be run concurrently with the other promotions listed above. All qualifying hands in each option, as predetermined, posted, and listed below, shall be offered together at all times this promotion is being offered.

### Royal Flush Jackpot Promotion Qualifying Hand Chart

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- There is a minimum of four players required to be dealt in during an eligible game in order for players to be eligible for the jackpot.
- In Texas Hold'em, a player must make a Royal Flush using at least one hole card.
- The hand may end before the river, but the player still qualifies as long as the hand has been made.
- The player must show both cards on the table to be eligible.
- When a qualifying hand is announced, a casino representative shall verify that the hand qualifies. Any deviation from a standard deck will nullify the jackpot.
- There is no limit to the number of times a player may win a prize in any given promotional period.
- Tournament games do not qualify for this gaming activity.
- Casino employees are eligible to participate is this gaming activity on or off duty and in or out of uniform.
- Third-Party Providers of Player Services (TPPPS) are not eligible for this promotion.

### <u>Prize</u>

The prize will be a progressive amount ranging from \$100-\$5,000 (in each respective suit) in the form of live casino chips. Once the hand has been verified by casino personnel, and proper identification and tax ID information (if applicable) is provided by the patron, the prize will be awarded. Furthermore, the jackpot prize amount shall be displayed prominently within Player's Casino at all times the jackpot is being offered for play. There will be separate prizes in the form of casino chips for Texas Hold'em and Omaha style games (Big O High/Low Split, Omaha, and Omaha High/Low Split). ### **Funding**

This promotion will be fully funded from the previously approved Player's Casino Bad Beat promotion (GEGA-004385). There will be no additional jackpot fees or collection fees taken for this promotion. The Royal Flush Jackpot will be initially seeded with an amount from \$100 to \$1,000. The Royal Flush Jackpot will be a progressive prize with \$25 to \$250 added daily. In Texas Hold'em, all suits will have the same amount added daily. ### Administrative Fees

### No Purchase Necessary

The Royal Flush Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the Royal Flush Jackpot</u>. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### <u>Advertising</u>

Player's Casino may advertise various names for this gaming activity. <u>Should the Casino</u> advertise a different name, the BGC ID (GEAR-001189) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Player's Casino at all times the gaming activity is being offered for play:

- Eligible games
- Eligible time period(s)/qualifying event(s)
- Funding will be provided from the Poker Bad Beat Jackpot (GEGA-004385)
- All specific qualifying conditions
- Availability of No Purchase Necessary
- Amount to be added to the pot (prize amount)
- Any other restrictions that apply to this gaming activity.

### **Eligible Controlled Games**

The Splash Pot Promotion shall be attached to all Bureau approved poker games offered at Player's Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

### **Object and Summary**

The Splash Pot Promotion gaming activity features a promotional element which shall be attached to the above listed approved controlled games at the Casino. During pre-determined times and intervals of the promotional period, a casino representative shall splash the pot by adding a pre-determined and posted prize to the pot at the start of the hand.

The qualifying times for the promotion will be determined by one of two methods:

- Option 1- The prize will be added to the pot at designated times and days which will be clearly specified and announced to the players beforehand.
- Option 2- The prize will be added to the pot when certain qualifying events occur, such as when a score is made during a televised sporting event being shown at the Casino.

After qualifying time is determined and announced, a lucky table method will be used to determine the table that receives the "Splash Pot." The method for determining which table will receive the posted "Splash Pot" prize involves a drawing where a bin, basket, or other non-electronic randomizer shall be used. The cards, balls or other lammer which are pre-printed, equally sized and colored, shall be mixed within the randomizer. During pre-determined times and intervals of the promotional period, a casino representative shall announce the commencement of the drawing. The casino representative shall then select an eligible table by randomly choosing a card, ball or other lammer from the randomizer. Each card or ball shall depict a number that corresponds to each eligible poker table. Betting procedures and play shall proceed as normal.

### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- There is no minimum amount of time played required for a table to qualify for this promotion.
- In the event that two or more players tie, the pot shall be evenly distributed between each player with the winning hand. If the prize is a non-cash prize it will be doubled, and each player shall receive a prize of equal value.
- A minimum of four players must be dealt into the game in order to qualify for the promotion. A table without four players will not be represented by a card, ball or other lammer when the table selection occurs.

The fixed prize for the Splash Pot Promotion shall be a fixed amount ranging from \$1 to \$10,000. The prize shall be paid in the form of live casino chips, merchandise, event tickets, gift certificates, or drawing tickets (GEGA-004619).

### **Funding**

This promotion will be fully funded from the previously approved Poker Bad Beat Jackpot (GEGA-004385) reserve fund. In the event that that reserve fund has been depleted Player's Casino will make up any potential shortfall and will not be reimbursed. Therefore, there shall be no additional jackpot fees or collection fees taken for this promotion.

### **Administrative Fees**

Player's Casino shall not retain an administrative fee as this promotion is funded from the Poker Bad Beat Jackpot (GEGA-004385). No additional fees shall be taken for this promotion.

### No Purchase Necessary

The Splash Pot Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the Splash Pot Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

### Advertising

Player's Casino may advertise various names for this gaming activity. <u>Should the Casino</u> advertise a different name, the BGC ID (GEAR-001174) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Player's Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Requirements for qualifying hands
- Prize payout structure
- Qualifying hands and corresponding jackpot prize amount
- Jackpot fee amount
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Super Jackpot shall be attached to the following Bureau approved controlled games offered at Player's Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

• Texas Hold'em (GEGA-000948)

### **Object and Summary**

The Super Jackpot features a fixed jackpot prize. A prize is awarded to players participating in the above controlled game when a designated qualifying hand is beaten by a better hand at the showdown. When the winning and losing hands are confirmed by a casino representative, those players with the qualifying jackpot hands shall receive the posted percentage of the jackpot prize amount.

Tables shall be eligible for a posted percentage of the jackpot prize, referred to as the Table Share, which shall be evenly distributed among all other players participating at the table at the time the jackpot is hit. If the share of odd amounts is less than a dollar, the amount is rounded up to the nearest dollar. The Casino will cover any additional shortfall to ensure all players are paid the same amount.

Players may be eligible for a posted percentage of the jackpot prize, referred to as the Room Share, which shall be evenly distributed amongst all active players at the other qualifying tables who have participated in the same designated game at the time the jackpot is hit, depending on the payout structure in place at the time, as shown below. If the share of odd amounts is less than a dollar, the amount is rounded up to the nearest dollar. The Casino will cover any additional shortfall to ensure all players are paid the same amount. Player's Casino will utilize a jackpot prize pool monitor, posters, or other advertisements to display the prize amounts, and days and times of the promotion.

### **Qualifying Hands**

Players that make one of the following qualifying hands for the specified poker game shall be eligible to win their share of the Super Jackpot prize amount, as shown below. The losing hand must be the second-best hand to qualify for the jackpot. ### **Eligibility Requirements**

This gaming activity shall be open to all players seated and playing at the above listed controlled game during the predetermined and specified hours designated and posted for the gaming activity.

- In order to qualify for the jackpot, players with qualifying winning and losing hands must play through the final betting round. If any player(s) with one of the qualifying hands folds prior to the final betting round, then the table shall be ineligible for the jackpot.
- In the event two or more players make a qualifying winning and/or losing hand, the player with the highest winning and losing qualifying hands shall win the posted percentage of the prize for that hand; all other players shall win the posted percentage of the table share.
- When a qualifying hand is announced, a casino representative shall verify both hands qualify. Any deviation from a standard deck will nullify the jackpot.
- In order to qualify for the jackpot, both the winning and losing hand must use both hole cards.
- A minimum of four active players are required to be dealt into the base game at each table in order for the table to be eligible for this promotion.
- A player must be dealt in the Jackpot qualifying hand to be eligible for the Winning, Losing, or Table share of the jackpot prize.
- The losing hand must be the second-best hand to qualify for the jackpot.
- Casino employees are eligible to participate in the jackpot on and off duty and in and out of uniform.
- Tournament games are not eligible for the jackpot.
- If multiple jackpots (different Bureau approved gaming activities) are offered at the same time, only the highest jackpot prize amount will be awarded if the player achieves the same qualifying event on multiple jackpots.

### <u>Prize</u>

The players that make the predetermined and posted qualifying losing and winning hands shall be eligible to win the corresponding fixed prize amount. The prize amount shall range between \$10,000 and \$250,000. The prize amount shall be predetermined and prominently displayed in the Casino and all advertisements. Players will be paid immediately following verification by a casino representative.

### Prize Payout Structure

Players that make the approved qualifying hands shall be eligible to win their share of the Super Jackpot prize amount, according to the payout option, as shown below. Only one prize payout structure shall be used at any one time for this jackpot.

\*Table Share: a posted percentage of the jackpot prize that shall be evenly distributed among all other eligible players participating at the table at the time the jackpot is hit.

\*\*Room Share: The Room Share percentage is divided equally among all qualifying players who were dealt in at the time of the qualifying jackpot hand while seated at tables with a minimum of four players. Players that received a Losing, Winning, or Table Share are not eligible to also receive a Room Share.

### Funding

The Super Jackpot features a fixed prize and is player-funded by a mandatory \$1 jackpot collection. The jackpot collection shall be taken from the pot of an eligible game if a flop occurs at a designated table. If the round of play ends before the flop, no jackpot fee shall be taken.

Player's Casino will initially seed the Super Jackpot with an amount ranging from \$10,000 to \$250,000. The entire \$1 jackpot fee shall be placed in the jackpot account from which all prize funds are drawn. The Casino shall be reimbursed for the initial seed amount once sufficient funds become available in the reserve account.

When the jackpot has been hit, it will be reseeded from the reserve account in an amount ranging from \$10,000 to \$250,000. If there are insufficient funds in the reserve account, the Casino will re-seed the jackpot and shall be reimbursed once sufficient funds become available in the reserve account.

### **Administrative Fees**

Player's Casino shall retain an administrative fee in the range of \$8 to \$16 per hour per table that the jackpot was in operation. The administrative fee is taken from the reserve account. If there are not sufficient funds in the reserve account at the usual time the administrative fee is to be withdrawn, the administrative fee will not be withdrawn until such time as the reserve is again adequate.

### No Purchase Necessary

The Super Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the Super Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

### Advertising

The Casino may advertise various names for this gaming activity. <u>Should the Casino advertise</u> a different name, the BGC ID (GEGA-004589) shall be referenced on all advertisements relating to the Three Card Poker Progressive Jackpot gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Casino at all times:

- Eligible games and time periods.
- Qualifying hands and corresponding prize amounts.
- Administrative fees.
- No Purchase Necessary Information.
- Any other restrictions that apply to this gaming activity.

### Eligible Controlled Game

Three Card Poker Progressive gaming activity shall be attached to all limits and versions of the currently approved game offered at the Casino, as listed below. All base game rules shall be played as previously approved by the Bureau.

• Three Card Poker 6 Card Bonus (GEGA-003036)

### **Object and Summary**

Players may place an optional \$1 jackpot fee for a chance to win the Three Card Poker Progressive Jackpot. The Three Card Poker Progressive Jackpot considers the best advertised qualifying hand(s) among each individual player's cards. Also, when a player places the optional \$1 jackpot fee they will also qualify to win an envy payout. If another player at the table hits a hand associated with an envy pay, all other players who paid the \$1 jackpot fee win the envy payout. The player with the qualifying hand receives the normal prize pay only, and does NOT receive the envy pay.

- 1. To begin each round, players must make their regular base game wager. They may optionally place any bonus bet wagers along with the optional jackpot fee of \$1.
- 2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
- 3. Once all players place their bets and/or jackpot fee, the house dealer will press "Game Start" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. If the system malfunctions, the game will continue to be played, without the progressive jackpot feature, until the problem is remedied. Should this occur then it will clearly be announced to all players. The house dealer will then remove all jackpot fees from the table. The jackpot fees are dropped in a separate and locked jackpot collection box affixed to the left side of the gaming table.
- 4. The house dealer then follows standard approved procedures for dealing the base game. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.

### Three Card Poker Progressive Jackpot

### **Qualifying Hands**

When a player is dealt an ace, king, queen, of the same suit, they are paid from the progressive jackpot shown on the progressive meter. Any Straight Flush, a hand that consists of three cards of the same suit in consecutive ranking, other than an ace, king and queen, receives a fixed prize amount according to the pay table below.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- A minimum of two players are required to play for the progressive jackpot; a player and a player-dealer.
- Only seated players, who have paid the jackpot fee and dealt a designated hand, are eligible for payouts.
- Players must be present in order to win the progressive prize.
- Backline betting is not permitted for this gaming activity.
- Tournament players are not eligible for the progressive prize.
- Casino employees are eligible for the Three Card Poker prize only when off duty.
- A Third-Party Provider of Proposition Player Services (TPPPS) is not eligible to place a jackpot collection fee and become eligible for the Three Card Poker Progressive Jackpot gaming activity when either in the player-dealer or player capacity.

### **Prize**

### **Fixed Prize**

All fixed payouts will be paid by a casino representative. Once the proper paperwork has been filled out, the casino representative will pay the winner(s) in live casino chips. The payouts will not be made from the house dealer's tray. All fixed payouts will be deducted from the amount in the reserve fund. If there is a shortfall the Casino will cover the payout and be reimburse from the reserve fund when funds are available. When a player is dealt a Straight Flush, they are paid a fixed prize amount according to the payout table above.

### **Progressive Prize**

When a player is dealt a ace, king, and queen, of the same suit, they are paid from the progressive jackpot shown on the progressive meter. In the event that during a round of play, two or more players have qualifying hands, the players will split equally the posted prize amount for their designated hand. Once the hand has been verified, the progressive prize will be paid out immediately. There is no limit on the number of times that a player may win the progressive prize. All fixed and progressive prizes are paid in live casino chips. If there is a shortfall the Casino will cover the payout and be reimbursed from the reserve fund when funds are available.

### Three Card Poker Progressive Jackpot

### **Envy Bonus**

A player paying the \$1 jackpot fee also qualifies to win an envy payout. If another player at the table hits a hand associated with an envy pay, all other players who paid the \$1 jackpot fee win the envy pay. The player achieving the qualifying hand receives the normal prize pay only and does NOT receive the envy pay. The house dealer pays any Envy Bonus wins at the end of the round. In the event that more than one player is involved in a qualifying envy pay, then all players win the advertised envy bonus amount. The Envy Bonus will be paid in live casino chips obtained from the cage, by a casino representative.

If a player's qualifying hand triggers an envy payout, the house dealer will leave the hand face-up on the table; otherwise, the house dealer will lock up the cards. The house dealer will then move on to the next player.

# All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained by the gambling enterprise for examination by regulatory and law enforcement personnel.

### Funding

The Casino will initially seed the jackpot at \$1,000. Once there are sufficient monies in the Three Card Poker Progressive Jackpot fund, the initial \$1,000 will be reimbursed to the Casino.

Each \$1 jackpot fee paid by a player will be broken down as follows:

- \$0.31 will be immediately posted on the meter.
- \$0.69 will be tracked in a reserve fund.
- The reserve fund will be utilized to immediately reseed the metered progressive jackpot prize in the amount of \$1,000 to \$5,000. In addition this reserve fund will payout all fixed amounts, additional progressive prize payouts, and payout the administrative fee.

### **Administrative Fees**

The Casino shall retain an administrative fee of \$8 to \$30 per table per hour from the reserve fund. The administrative fee shall be utilized to cover expenses incurred by the Casino for administering the Three Card Poker Progressive Jackpot.

### No Purchase Necessary Table Requirement

The Three Card Poker Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the Three Card Poker Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

### Equipment

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

- 1. When a player has a progressive winner, the house dealer shall press the appropriate hand button on the keypad.
- 2. The house dealer shall then contact the floor person.

### Three Card Poker Progressive Jackpot

- 3. Once the Casino verifies the progressive win, the floor person shall select the appropriate hand button then swipe the electronic access card. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
- 4. Processing the jackpot through the computer system will restore normal operation of the table, adjust the meter appropriately for the prize won, and reset system for the next hand.



Although the Bureau has approved this jackpot modification, jackpots with an electronic component are currently under Bureau review. The Bureau reserves the right to: (1) review the lawfulness of the modified Ultimate Texas Hold'em Progressive Jackpot; (2) notify all law enforcement agencies and gambling establishments if further review determines the modified Ultimate Texas Hold'em Progressive Jackpot to be unlawful; (3) require gambling establishments to cease and desist offering for play the modified Ultimate Texas Hold'em Progressive Jackpot if found to be unlawful; and (4) take action against those gambling establishments that decline to abide by the Bureau=s cease and desist notification.

### **Bureau Requirements**

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Player's Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods.
- Qualifying hands and corresponding prize amounts.
- Gaming activity collection fees.
- Prize Payout Structure.
- Availability of No Purchase Necessary.
- Any other restrictions that apply to this gaming activity.

### **Eligible Controlled Games**

The Ultimate Texas Hold'em Progressive Jackpot gaming activity shall be attached to the following Bureau approved games offered at Player's Casino, as shown below. The jackpot features a fixed and a progressive jackpot prize. All controlled game rules shall be played as previously approved by the Bureau.

• Ultimate Texas Hold'em (GEGA-004021)

### **Object and Summary**

Players may place an optional \$1 jackpot fee for a chance to win the Ultimate Texas Hold'em Progressive Jackpot. The Ultimate Texas Hold'em Progressive Jackpot considers the best advertised qualifying hand(s) among each individual player's cards. In addition, when a player places the optional \$1 jackpot fee, the player will also qualify to win an envy payout. If another player at the table hits a hand associated with an envy pay, all other players who paid the \$1 jackpot fee win the envy payout. The player with the qualifying hand receives the normal prize pay only, and does NOT receive the envy pay.

- 1. To begin each round, players must make their regular base game wager and any optional bonus wagers or fees.
- 2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players who wish to participate in the jackpot must place the optional jackpot fee on the sensor. The sensor will then light up.



- 3. Once all players place their bets and/or jackpot fee, the house dealer will press "Game Start" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
- 4. The house dealer then follows standard approved procedures for dealing the base game. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.
- 5. When a player has a progressive winner, the house dealer shall press the appropriate hand button on the keypad.
- 6. The house dealer shall then contact the floor person. Once the casino verifies the progressive win, the floor person shall swipe the necessary card. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
- 7. When the house dealer reconciles all action (on behalf of the player-dealer), he/she presses "Game Over." This resets the system to begin the next hand.
- 8. Should the equipment malfunction, then the progressive jackpot will not be offered during the effected time period.

### **Qualifying Hands**

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- The minimum number of players required to be eligible for the progressive prize is two (2), including the player-dealer.
- Only seated players, who have paid the jackpot collection fee and dealt a designated hand, are eligible for the progressive prize.
- There is no limit on the number of times a player may win the progressive prize or a fixed prize.
- After the hand is verified, the progressive prize will be paid immediately. The winner must be present.
- All fixed and progressive prizes are paid in casino chips.



- Casino employees are eligible for the jackpot prize when off-duty and out of uniform only.
- Backline bettors are not eligible to place a jackpot collection fee or receive the prize amount for a qualifying hand.
- Tournament players are not eligible for the progressive prize.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible to place a jackpot collection fee and become eligible for the Ultimate Texas Hold'em Progressive gaming activity when either in the player-dealer or player capacity.

### <u>Prize</u>

### **Fixed Prizes**

All fixed payouts will be paid by a Casino floor person. Once the proper paperwork has been filled out, a Casino floor person will pay the winners in live casino chips. The payouts will not be made from the house dealer's tray. All fixed payouts will be deducted from the amount in the reserve fund. See the Ultimate Texas Hold'em Progressive Jackpot Qualifying Hands paytable above for qualifying hands and payouts.

### **Progressive Prizes**

A Royal Flush pays 100% of the progressive jackpot amount shown on the progressive meter.

### **Envy Bonus**

A player paying the \$1 jackpot fee also qualifies to win an envy payout. If another player at the table hits a hand associated with an envy pay, all other players who paid the \$1 jackpot fee win the envy pay. The player achieving the qualifying hand receives the normal prize pay only and does NOT receive the envy pay. The house dealer pays any Envy Bonuses at the end of the round. In the event that more than one player is involved in a qualifying envy pay, then all players win the envy pay. The Envy Bonus will be paid in chips obtained from the casino cage by the California section floor person.

If a player's qualifying hand triggers an envy payout, the house dealer will leave the hand faceup on the table; otherwise, the dealer will lock up the cards. The dealer will then move on to the next player.

All monies collected and paid out shall be tracked both electronically and on a handwritten log that shall be maintained by the gambling enterprise for examination by regulatory and law enforcement personnel.

### Prize Payout Structure

In the event more than one qualifying hand hits during the same round, all winning players will be paid the posted progressive prize via the progressive meter or the posted fixed amount via the reserve account.

Once the proper paperwork has been filled out, a Casino floor person will pay the winner(s) in live casino chips. Payouts will not be made from the house dealer's tray. All fixed payouts will be deducted from the amount in the reserve fund. *This payout shall be documented appropriately in the accounting records.* 



- All fixed jackpot qualifying hands are paid from the reserve fund. They do not get deducted from the amount shown on the meter. In the event the reserve fund is depleted, the Casino will make up any shortfall.
- Each player who placed the \$1.00 jackpot fee receives the \$1,000 prize for the community royal flush.
- The progressive jackpot qualifying hand is paid the total amount shown on the progressive meter.
- In the event the reserve fund is depleted, the Casino will make up any shortfall. All hands will be paid the posted prize.

### <u>Funding</u>

The Casino will initially seed the jackpot in an amount between \$1,000 and \$2,000. Once there are sufficient monies in the Ultimate Texas Hold'em Progressive Jackpot reserve fund, the initial seed will be reimbursed to the Casino and shall be documented in the accounting records. After the progressive jackpot is hit, it will be re-seeded by the reserve fund in an amount between \$1,000 and \$10,000. The progressive prize pool shall increase daily based solely on the number of jackpot collection fees placed and collected each day. Furthermore, there is no cap on this progressive prize pool.

Each \$1.00 jackpot fee paid by a player will be broken down as shown in the paytable below.

### Administrative Fees

The Casino will take an administrative fee ranging from \$8-\$16 per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with maintaining and servicing the computer systems.

### No Purchase Necessary

The Ultimate Texas Hold'em Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the Ultimate Texas Hold'em Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

### <u>Equipment</u>

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).
