

5 PIPELINE COMPANY; VALERO ENERGY CORPORATION; VALERO REFINING  
6 COMPANY CALIFORNIA; ULTRAMAR, INC.; ROBINSON OIL CORPORATION; BP  
7 AMERICA, INC.; BP OIL SUPPLY COMPANY; ATLANTIC RICHFIELD COMPANY;  
8 COSTCO WHOLESALE CORP. AND DOES 1- 100, plaintiff CONSUMER DEFENSE  
9 GROUP ACTION alleges as follows:

10 **ALLEGATIONS INCORPORATED INTO EACH CAUSE OF ACTION**

11 **A. PARTIES**

12 1. Plaintiff CONSUMER DEFENSE GROUP ACTION is and has been at all  
13 relevant times a California corporation in good standing, duly organized and existing under and  
14 by virtue of the laws of the State of California, and brings this action in the public interest as  
15 defined under Health & Safety Code § 25249.7 (d).

16 2. Defendants SHELL OIL COMPANY; EQUILON ENTERPRISES, LLC;  
17 EXXON MOBIL CORPORATION; CHEVRON TEXACO CORPORATION; CHEVRON  
18 U.S.A. INC.; UNOCAL CORPORATION; UNION OIL COMPANY OF CALIFORNIA;  
19 UNOCAL CALIFORNIA PIPELINE COMPANY; UNOCAL PIPELINE COMPANY;  
20 VALERO ENERGY CORPORATION; VALERO REFINING COMPANY CALIFORNIA;  
21 ULTRAMAR, INC.; ROBINSON OIL CORPORATION; BP AMERICA, INC.; BP OIL  
22 SUPPLY COMPANY; ATLANTIC RICHFIELD COMPANY; COSTCO WHOLESALE  
23 CORP. AND DOES 1- 100 are and at all times mentioned herein have been qualified to do  
24 business in the State of California.  
25  
26  
27  
28

1           3.       Plaintiff is ignorant of the true names and capacities of defendants sued as  
2 DOES 1 - 100, inclusive, and therefore sues these defendants by such fictitious names. The  
3 fictitious defendants named in this Complaint are sued pursuant to the provisions of C.C.P. §  
4 474. Plaintiff is informed and believes, and upon that ground, alleges that each fictitious  
5 defendant is in some way responsible for, participated in, or contributed to the matters and  
6 things of which Plaintiff complains herein, and in some fashion, has legal responsibility  
7 therefor. When the exact nature and identity of such fictitious defendants' responsibility for,  
8 participation in, and contribution to the matters and things alleged herein are ascertained by  
9 Plaintiff, Plaintiff will seek to amend this Complaint and all proceedings herein to set forth the  
10 same.  
11

12           4.       At all times mentioned each of the defendants herein was a person within the  
13 meaning of Business & Professions Code § 17201 and a person doing business within the  
14 meaning of Health & Safety Code § 25249.11 (a). Plaintiff is informed and believes and  
15 thereon alleges that at all times mentioned herein, each defendant has had 10 or more  
16 employees.  
17

18           5.       The Court has jurisdiction over this action pursuant to California Constitution  
19 Article VI, Section 10, which grants the Superior Court original jurisdiction in all causes except  
20 those given by statute to other trial courts. The statutes under which this action is brought do  
21 not specify any other basis of jurisdiction.  
22

23 **B.    FACTS**

24           6.       Proposition 65, the Safe Drinking Water and Toxic Enforcement Act  
25 (commencing with Health & Safety Code Section 25249.5) (hereinafter referred to as  
26 "Proposition 65").  
27  
28

1           7.       Proposition 65 absolutely prohibits any business from contaminating the  
2 drinking water supplies of California.

3           8.       All water within the State, including groundwater, is the property of the people  
4 of the State of California. California Water Code §§ 102 and 104. As to all water, the  
5 Legislature of the State of California (“the Legislature”) has determined, as set forth in  
6 California Water Code § 13000, that “the people of the State have a primary interest in the  
7 conservation, control and utilization of the water resources of the state, and that the quality of  
8 all waters of the State shall be protected for use and enjoyment of the people of the state.”  
9

10           9.       Under Proposition 65, a “source of drinking water” is not confined to existing  
11 drinking water supplies. Rather, as set forth in a Health & Safety Code §25249.10 (d),  
12 “[s]ource of drinking water means either a present source of drinking water or water which is  
13 identified or designated in a water quality control plan adopted by a regional board as being  
14 suitable for domestic or municipal uses [and] also includes water identified in a regional board”  
15 water quality control plan as being suitable for domestic or municipal uses.”  
16

17           10.       Each of the above-named DEFENDANTS are in violation of Proposition 65  
18 because they have and are knowingly and intentionally threatening to “release chemicals known  
19 to the State of California to cause cancer or reproductive toxicity into water or onto or into land  
20 where such chemical passes or probably will pass into any source of drinking water,” at each of  
21 the facilities listed on Exhibits 1 - 8 hereto (hereinafter “the Facilities”), which are branded  
22 gasoline stations with in place underground storage tank systems.  
23

24           11.       Proposition 65 provides that when a party, such as each of the DEFENDANTS,  
25 all of which are entities with more than ten employees, have been and are knowingly and  
26 intentionally threatening to “release chemicals known to the State of California to cause cancer  
27  
28

1 or reproductive toxicity into water or onto or into land where such chemical passes or probably  
2 will pass into any source of drinking water,” that party is violating Health & Safety Code  
3 Section 25249.5 and may be enjoined from such conduct pursuant to Health & Safety Code  
4 Section 25249.7.  
5

6 12. The DEFENDANTS market gasoline and other refined petroleum products  
7 (hereinafter referred to as “gasoline”) under various trademarks directly to motorists at branded  
8 retail outlets and/or through independent dealers and distributors in California and elsewhere.  
9 DEFENDANTS own and/or operate the underground storage tank systems located at the  
10 Facilities that are used for the storage of gasoline offered for sale to the general public. The  
11 operation by DEFENDANTS of the underground storage tank systems (hereinafter “the USTs”)  
12 located at the Facilities, as well as the delivery, storage and dispensing of gasoline at the  
13 Facilities, as currently controlled and managed by DEFENDANTS, poses a substantial threat of  
14 discharge of gasoline and other refined petroleum products “into water or onto or into land  
15 where such chemical passes or probably will pass into any source of drinking water” in  
16 violation of Health & Safety Code § 25249.5.  
17  
18

19 13. The chemicals which DEFENDANTS are threatening to release are benzene and  
20 toluene which are contained in the gasoline and other refined petroleum products which  
21 DEFENDANTS market and store within the USTs owned and/or operated by DEFENDANTS  
22 at the Facilities.  
23

24 14. Gasoline contains a number of constituents and additives each of which  
25 separately, as well as in combination, present a significant risk to human health, safety and the  
26 environment. The gasoline marketed by each of the DEFENDANTS contains the chemicals  
27 Benzene and Toluene. Benzene is a clear, colorless, highly reactive flammable liquid derived  
28

1 from petroleum and contained in gasoline. Benzene is a chemical known by the State of  
2 California to cause cancer and has been listed as such pursuant to Proposition 65. Toluene is a  
3 colorless flammable liquid obtained from coal tar or petroleum and contained in motor vehicle  
4 fuels. Toluene is a chemical known by the State of California to cause reproductive toxicity and  
5 has been listed as such pursuant to Proposition 65. Hereinafter benzene and toluene are  
6 referred to as the "Designated Chemicals".  
7

8 15. In order to be in compliance with Proposition 65, each of the DEFENDANTS  
9 must effectively contain the Designated Chemicals in a UST system that is "product tight."  
10

11 16. "Product tight" means that the operations of each of the DEFENDANTS at the  
12 Facilities must be impervious to the liquid and vapor of the substance ("the Designated  
13 Chemicals") that is or are contained or to be contained in the underground storage tank systems  
14 so as to prevent discharge or release of the Designated Chemicals from the containment system  
15 and into or on to the ground where the Designated Chemicals will pass or probably will pass  
16 into any source of drinking water.  
17

18 17. The gasoline service station operations undertaken at the Facilities are not  
19 "product tight" (i.e. the operations are not impervious to the liquid and vapor of the substance  
20 that is contained, or is to be contained, in the underground storage tank systems so as to prevent  
21 seepage of the Designated Chemicals from the containment and into the ground) and thus are  
22 threatening to cause a discharge of Designated Chemicals.  
23

24 18. The following are the components of the gasoline service station operations that  
25 pose a threat of discharge of Designated Chemicals: the underground tank(s) and underground  
26 storage tank system(s); the pipes used in connection with the storage of the Designated  
27 Chemicals in the USTs, including connecting pipes, vapor recovery lines, vent lines and  
28

1 associated fittings as well as the associated secondary containment systems; the drainage  
2 systems which collect surface water run off from the petroleum dispensing and delivery areas;  
3 secondary containment and spill control systems, including but not limited to secondary  
4 containment for the underground tank system, pipe, connecting pipe, dispensers and dispenser  
5 piping and the petroleum delivery area, as well as for the drainage systems which collected  
6 surface water run off from the dispensing and delivery area.  
7

8         19.     At the Facilities, the gasoline containing Designated Chemicals is stored in one  
9 or more underground storage tank(s) and an underground storage tank system, which includes,  
10 but is not limited to, one or more tanks, including the piping connected thereto. The pipes used  
11 in connection with the storage of the Designated Chemicals in the USTs includes but is not  
12 limited to valves and other appurtenances connected to the pipe, pumping units, fabricated  
13 assemblies associated with the pumping units, and metering and delivery stations and fabricated  
14 assemblies therein. The pipes used in connection with the storage of the Designated Chemicals  
15 in the USTs include "connecting piping", such as pipe, valves elbows, joints, flanges and  
16 flexible connectors through which the Designated Chemicals flow. The UST system also  
17 includes the vapor recovery lines, vent lines and associated fittings as well as the associated  
18 secondary containment systems, the drainage systems which collect surface water run off from  
19 the petroleum dispensing and delivery areas. Finally, the UST systems include secondary  
20 containment and spill control systems including but not limited to secondary containment for  
21 the underground tank system, leak detection sensors, pipe, connecting pipe, dispensers and  
22 dispenser piping and the petroleum delivery area, as well as for the drainage systems which  
23 collect surface water run off from the dispensing and delivery area.  
24  
25  
26

27         20.     Investigations and reports conducted and prepared for the California State Water  
28

1 Resources Control Board ("SWRCB") (with the assistance and input of the Environmental  
2 Health Divisions and Departments for a number of California counties and Regional Water  
3 Quality Control Boards, as well as various members of the oil industry including some of the  
4 named DEFENDANTS), the California Environmental Protection Agency ("CEPA"),  
5 Department of Toxic Substances Control ("DTSC"), the Office of Pollution Prevention and  
6 Technology Department, as well as testing undertaken by the various city fire departments  
7 where the Facilities are located, demonstrate that discharges of petroleum products including  
8 the Designated Chemicals occur, and are expected to occur, from the gasoline service station  
9 operations at the Facilities on a regular and ongoing basis.  
10

11  
12 21. The CWRQB Report concluded that 61% of all USTs in operation, at any given  
13 time, are discharging/releasing gasoline and other refined petroleum products including the  
14 Designated Chemicals into or on to the land. The CWRQB Report also found that the  
15 percentage of USTs found to be discharging/releasing gasoline and other refined petroleum  
16 products including the Designated Chemicals into or on to the land was not materially different  
17 whether the underground storage tank was single or double-walled.  
18

19 22. Because DEFENDANTS, as well as the oil industry in general, are aware of  
20 these facts, DEFENDANTS, along with the oil industry, have in place leak detection sensor  
21 systems. The fact that DEFENDANTS uses such a system is an acknowledgment by  
22 DEFENDANTS that it knows that the USTs it operates are likely to leak at any given time. The  
23 sensors do not inform DEFENDANTS that the USTs are about to release product, only, at best,  
24 that the USTs have leaked and/or are leaking product, including the Designated Chemicals.  
25

26 23. The CWRQB Report also noted that the leak detection systems in use by the  
27 industry only record a discharge from the USTs where the leak is more than 0.1 gallons/hour  
28

1 (2.4 gallons a day, or 876 gallons a year per sensor). That is, even under this extremely lax  
2 standard, DEFENDANTS do not even record a discharge until an individual tank sensor (of  
3 which there are usually more than one in any UST) records a discharge of greater than 876  
4 gallons a year. The actual level of non-recorded discharge can be much higher for any  
5 individual UST since there may be four or more sensors in any given system each of may be  
6 failing to record a discharge of slightly less than 876 gallons a year.  
7

8           24. A report prepared by the SWRCB Underground Storage Tank Program entitled  
9 “Field Evaluation of Underground Storage Tank System Leak Detection Sensors” expressly  
10 found that the leak detection sensors systems used by the oil industry, including  
11 DEFENDANTS, are not reliable where, as the report noted, the sensors have not been properly  
12 installed, programmed, maintained and operated, or when the secondary containment in which  
13 they are installed are not working properly. The SWRCB, in analyzing the use of leak detection  
14 sensor systems by the oil industry (including DEFENDANTS), specifically noted a number of  
15 significant problems which greatly lessened the utility of such sensors including the following:  
16 “sensors were raised from the low point of the secondary containment, sensors fail[ed] to alarm  
17 when tested, and sensors fail[ed] to shut down the turbine pump in the event of an alarm.” The  
18 report went on to note that almost a third of the secondary containment systems had water or  
19 product in one or more areas, a fact which would seriously impact the operational effectiveness  
20 of the sensor detection systems. Under these circumstances, the sensors will simply not operate  
21 effectively, even at the lax warning level used by DEFENDANTS. Further, since such sensors,  
22 even when working properly, do not prevent leaks but, at best, simply record them, they are  
23 ineffective to avoid liability under Health & Safety Code sections 25249.5 and 25249.7.  
24  
25  
26

27           25. The gasoline service operations of DEFENDANTS therefore pose and threaten  
28



1 to pose an imminent treat to human health or safety or the environment and therefore create a  
2 substantial probability of harm since there is a substantial likelihood that the USTs operated and  
3 maintained by DEFENDANTS are either currently or likely will shortly discharge/release  
4 gasoline and other refined petroleum products into or on to the land. Such a threatened  
5 discharge/release of the Designated Chemicals from the USTs at the Facilities “probably will  
6 pass into [a] source of drinking water” in violation of Proposition 65.  
7

8 **FIRST CAUSE OF ACTION AGAINST EACH NAMED**  
9 **DEFENDANT AND DOES 1-100**

10 **(Violation of California Health & Safety Code Section 25249.5)**

11 **[Threatened Release or Discharge]**

12 26. Plaintiff Consumer Defense Group Action repeats and incorporates by reference  
13 paragraphs 1 through 25 of this Complaint as though fully set forth herein.

14 27. Plaintiff is informed and believes and thereon alleges that DEFENDANTS have  
15 been and are knowingly and intentionally threatening to “release chemicals known to the State  
16 of California to cause cancer or reproductive toxicity into water or onto or into land where such  
17 chemical passes or probably will pass into any source of drinking water” in violation of Health  
18 & Safety Code Section 25249.5 at the site located at the Facilities identified on Exhibits 1 - 8  
19 “the Facilities”).  
20

21 28. More than sixty-five days prior to filing this first amended complaint Plaintiff  
22 mailed to the President and Chief Executive Officer for each DEFENDANT a Sixty (60) Day  
23 Notice of Intent to Sue (hereinafter, “the Notice”) for violations of Proposition 65, the Safe  
24 Drinking Water and Toxic Enforcement Act (commencing with Health & Safety Code Section  
25 25249.5) by knowingly and intentionally threatening to “release chemicals known to the State  
26 of California to cause cancer or reproductive toxicity into water or onto or into land where such  
27  
28

1 chemical passes or probably will pass into any source of drinking water” in violation of Health  
2 & Safety Code § 25249.5 at the Facilities listed on Exhibit 1 - 8 hereto, respectively. The  
3 Notice specifically identified the chemicals each DEFENDANT has and continues to  
4 knowingly and intentionally threaten to release into water or onto or into land where such  
5 chemical passes or probably will pass into any source of drinking water at each of the Facilities  
6 listed on Exhibits 1 - 8 hereto, respectively. Included with the Notice was a copy of “The Safe  
7 Drinking Water and Toxic Enforcement Act of 1986 (Proposition 65): A Summary.” The  
8 Notice fully complied with the requirements of the Safe Drinking Water and Toxic  
9 Enforcement Act of 1986.  
10  
11

12 29. Copies of the Notices referred to in paragraphs 27 and 28 were mailed to the  
13 California Attorney General, the County District Attorneys and City Attorneys for each city  
14 containing a population of at least 750,000 people (hereinafter referred to collectively as “the  
15 Prosecutors”) for the locations where each defendant had violated Health & Safety Code  
16 Sections 25249.5, *et seq.* and 22 California Code of regulations Sections 12000 through 14000.  
17

18 30. On information and belief, none of the Prosecutors is prosecuting an action  
19 against any defendant herein for the violations set forth above.

20 31. This action for injunctive relief and penalties for violation of Health & Safety  
21 Code Sections 25249.5, *et seq.* is specifically authorised by Health & Safety Code Section  
22 25249.7.

Health & Safety Code Section 25249.5 provides that persons who in the course of doing business knowingly and intentionally threaten to “release chemicals known to the State of California to cause cancer or reproductive toxicity into water or onto or into land where such chemical passes or probably will pass into any source of drinking water” are in violation of Health & Safety Code Section 25249.5. Persons who in the course of doing business violate the statute thereby engage in an unlawful and/or unfair business practice constituting unfair competition in violation of Business & Professions Code Sections 17200, *et seq.*

34. By committing the above acts and those stated in the First Cause of Action, each Defendant engaged in an unlawful and/or unfair practice, acts which constitutes unfair competition within the meaning of Business & Professions Code Sections 17200, *et seq.* An action for injunctive relief is specifically authorized by said sections..

35. Continuing commission by these Defendants of the actions alleged above will irreparably harm plaintiffs and the public, a harm for which they have no plain, speedy or adequate remedy at law.

36. As a direct and proximate result of each defendants conduct, as set forth herein, each defendant has received ill-gotten gains, including but not limited to, money and falsely obtained goodwill of unknowing and misled consumers.

(c) Any substance or material deleterious to fish, plant life or bird life.” Persons who in the course of doing business violate this statute engage in an unlawful business practice constituting unfair competition in violation of Business & Professions Code Sections 17200, *et seq.*

39. By committing the above acts and those stated in the First Cause of Action, each Defendant engaged in an unlawful business practice, an act which constitutes unfair competition within the meaning of Business & Professions Code Sections 17200, *et seq.* An action for injunctive relief is specifically authorized by said sections.

40. Continuing commission of the acts alleged above by each Defendant will irreparably harm plaintiff and the citizens of the State of California, for which harm they have no plain, speedy, or adequate remedy at law.
