30 MOBIL CORPORATION; CHEVRON TEXACO CORPORATION; UNOCAL
31 CORPORATION; VALERO ENERGY CORPORATION; ROBINSON OIL CORPORATION;
32 BP AMERICA, INC.; ATLANTIC RICHFIELD COMPANY and DOES 1- 100, plaintiff
33 CONSUMER DEFENSE GROUP ACTION alleges as follows:

34 ALLEGATIONS INCORPORATED INTO EACH CAUSE OF ACTION

35 A. PARTIES

36 1. Plaintiff CONSUMER DEFENSE GROUP ACTION is and has been at all
37

O. K. TO ISSUE SUMMONS

1 relevant times a California corporation in good standing, duly organized and existing under and
2 by virtue of the laws of the State of California, and brings this action in the public interest as
3 defined under Health & Safety Code § 25249.7 (d).

4 2. Defendants SHELL OIL COMPANY; EXXON MOBIL CORPORATION;
5 CHEVRON TEXACO CORPORATION; UNOCAL CORPORATION; VALERO ENERGY
6 CORPORATION; ROBINSON OIL CORPORATION; BP AMERICA, INC.; ATLANTIC
7 RICHFIELD COMPANY AND DOES 1 - 100 are and at all times mentioned herein have been
8 qualified to do business in the State of California.

9 3. Plaintiff is ignorant of the true names and capacities of defendants sued as
10 DOES 1 - 100, inclusive, and therefore sues these defendants by such fictitious names. The
11 fictitious defendants named in this Complaint are sued pursuant to the provisions of C.C.P. §
12 474. Plaintiff is informed and believes, and upon that ground, alleges that each fictitious
13 defendant is in some way responsible for, participated in, or contributed to the matters and
14 things of which Plaintiff complains herein, and in some fashion, has legal responsibility
15 therefor. When the exact nature and identity of such fictitious defendants' responsibility for,
16 participation in, and contribution to the matters and things alleged herein are ascertained by
17 Plaintiff, Plaintiff will seek to amend this Complaint and all proceedings herein to set forth the
18 same.

19 4. At all times mentioned each of the defendants herein was a person within the
20 meaning of Business & Professions Code § 17201 and a person doing business within the
21 meaning of Health & Safety Code § 25249.11 (a). Plaintiff is informed and believes and
22 thereon alleges that at all times mentioned herein, each defendant has had 10 or more
23 employees.

24 5. The Court has jurisdiction over this action pursuant to California Constitution
25 Article VI, Section 10, which grants the Superior Court original jurisdiction in all causes except
26 those given by statute to other trial courts. The statutes under which this action is brought do
27 not specify any other basis of jurisdiction.

1 B. FACTS

2 6. Proposition 65, the Safe Drinking Water and Toxic Enforcement Act
3 (commencing with Health & Safety Code Section 25249.5) (hereinafter referred to as
4 "Proposition 65").

5 7. Proposition 65 absolutely prohibits any business from contaminating the
6 drinking water supplies of California.

7 8. All water within the State, including groundwater, is the property of the people
8 of the State of California. California Water Code §§ 102 and 104. As to all water, the
9 Legislature of the State of California ("the Legislature") has determined, as set forth in
10 California Water Code § 13000, that "the people of the State have a primary interest in the
11 conservation, control and utilization of the water resources of the state, and that the quality of
12 all waters of the State shall be protected for use and enjoyment of the people of the state."

13 9. Under Proposition 65, a "source of drinking water" is not confined to existing
14 drinking water supplies. Rather, as set forth in a Health & Safety Code §25249.10 (d),
15 "[s]ource of drinking water means either a present source of drinking water or water which is
16 identified or designated in a water quality control plan adopted by a regional board as being
17 suitable for domestic or municipal uses [and] also includes water identified in a regional board"
18 water quality control plan as being suitable for domestic or municipal uses."

19 10. Each of the above-named DEFENDANTS are in violation of Proposition 65
20 because they have and are knowingly and intentionally threatening to "release chemicals known
21 to the State of California to cause cancer or reproductive toxicity into water or onto or into land
22 where such chemical passes or probably will pass into any source of drinking water," at each of
23 the facilities listed on Exhibits 1 - 7 hereto (hereinafter "the Facilities"), which are branded
24 gasoline stations with in place underground storage tank systems.

25 11. Proposition 65 provides that when a party, such as each of the DEFENDANTS,
26 all of which are entities with more than ten employees, have been and are knowingly and
27 intentionally threatening to "release chemicals known to the State of California to cause cancer
28

1 or reproductive toxicity into water or onto or into land where such chemical passes or probably
2 will pass into any source of drinking water,” that party is violating Health & Safety Code
3 Section 25249.5 and may be enjoined from such conduct pursuant to Health & Safety Code
4 Section 25249.7.

5 12. The DEFENDANTS market gasoline and other refined petroleum products
6 (hereinafter referred to as “gasoline”) under their various trademarks directly to motorists at
7 branded retail outlets and through independent dealers and distributors in California and
8 elsewhere. DEFENDANTS own and/or operate the underground storage tank systems located
9 at the Facilities that are used for the storage of gasoline offered for sale to the general public.
10 The operation by DEFENDANTS of the underground storage tank systems (hereinafter “the
11 USTs”) located at the Facilities, as well as the delivery, storage and dispensing of gasoline at
12 the Facilities, as currently controlled and managed by DEFENDANTS, poses a substantial
13 threat of discharge of gasoline and other refined petroleum products “into water or onto or into
14 land where such chemical passes or probably will pass into any source of drinking water” in
15 violation of Health & Safety Code § 25249.5.

16 13. The chemicals which DEFENDANTS are threatening to release are benzene and
17 toluene which are contained in the gasoline and other refined petroleum products which
18 DEFENDANTS market and store within the USTs owned and/or operated by DEFENDANTS
19 at the Facilities.

20 14. Gasoline contains a number of constituents and additives each of which
21 separately, as well as in combination, present a significant risk to human health, safety and the
22 environment. The gasoline marketed by each of the DEFENDANTS contains the chemicals
23 Benzene and Toluene. Benzene is a clear, colorless, highly reactive flammable liquid derived
24 from petroleum and contained in gasoline. Benzene is a chemical known by the State of
25 California to cause cancer and has been listed as such pursuant to Proposition 65. Toluene is a
26 colorless flammable liquid obtained from coal tar or petroleum and contained in motor vehicle
27 fuels. Toluene is a chemical known by the State of California to cause reproductive toxicity and
28

1 has been listed as such pursuant to Proposition 65. Hereinafter benzene and toluene are
2 referred to as the "Designated Chemicals".

3 15. In order to be in compliance with Proposition 65, each of the DEFENDANTS
4 must effectively contain the Designated Chemicals in a UST system that is "product tight."

5 16. "Product tight" means that the operations of each of the DEFENDANTS at the
6 Facilities must be impervious to the liquid and vapor of the substance ("the Designated
7 Chemicals") that is or are contained or to be contained in the underground storage tank systems
8 so as to prevent discharge or release of the Designated Chemicals from the containment system
9 and into or on to the ground where the Designated Chemicals will pass or probably will pass
10 into any source of drinking water.

11 17. The gasoline service station operations undertaken at the Facilities are not
12 "product tight" (i.e. the operations are not impervious to the liquid and vapor of the substance
13 that is contained, or is to be contained, in the underground storage tank systems so as to prevent
14 seepage of the Designated Chemicals from the containment and into the ground) and thus are
15 threatening to cause a discharge of Designated Chemicals.

16 18. The following are the components of the gasoline service station operations that
17 pose a threat of discharge of Designated Chemicals: the underground tank(s) and underground
18 storage tank system(s); the pipes used in connection with the storage of the Designated
19 Chemicals in the USTs, including connecting pipes, vapor recovery lines, vent lines and
20 associated fittings as well as the associated secondary containment systems; the drainage
21 systems which collect surface water run off from the petroleum dispensing and delivery areas;
22 secondary containment and spill control systems, including but not limited to secondary
23 containment for the underground tank system, pipe, connecting pipe, dispensers and dispenser
24 piping and the petroleum delivery area, as well as for the drainage systems which collected
25 surface water run off from the dispensing and delivery area.

26 19. At the Facilities, the gasoline containing Designated Chemicals is stored in one
27 or more underground storage tank(s) and an underground storage tank system, which includes,
28

1 but is not limited to, one or more tanks, including the piping connected thereto. The pipes used
2 in connection with the storage of the Designated Chemicals in the USTs includes but is not
3 limited to valves and other appurtenances connected to the pipe, pumping units, fabricated
4 assemblies associated with the pumping units, and metering and delivery stations and fabricated
5 assemblies therein. The pipes used in connection with the storage of the Designated Chemicals
6 in the USTs include "connecting piping", such as pipe, valves elbows, joints, flanges and
7 flexible connectors through which the Designated Chemicals flow. The UST system also
8 includes the vapor recovery lines, vent lines and associated fittings as well as the associated
9 secondary containment systems, the drainage systems which collect surface water run off from
10 the petroleum dispensing and delivery areas. Finally, the UST systems include secondary
11 containment and spill control systems including but not limited to secondary containment for
12 the underground tank system, leak detection sensors, pipe, connecting pipe, dispensers and
13 dispenser piping and the petroleum delivery area, as well as for the drainage systems which
14 collect surface water run off from the dispensing and delivery area.

15 20. Investigations and reports conducted and prepared for the California State Water
16 Resources Control Board ("SWRCB") (with the assistance and input of the Environmental
17 Health Divisions and Departments for a number of California counties and Regional Water
18 Quality Control Boards, as well as various members of the oil industry including some of the
19 named DEFENDANTS), the California Environmental Protection Agency ("CEPA"),
20 Department of Toxic Substances Control ("DTSC"), the Office of Pollution Prevention and
21 Technology Department, as well as testing undertaken by the various city fire departments
22 where the Facilities are located, demonstrate that discharges of petroleum products including
23 the Designated Chemicals occur, and are expected to occur, from the gasoline service station
24 operations at the Facilities on a regular and ongoing basis.

25 21. The CWRQB Report concluded that 61% of all USTs in operation, at any given
26 time, are discharging/releasing gasoline and other refined petroleum products including the
27 Designated Chemicals into or on to the land. The CWRQB Report also found that the
28

1 percentage of USTs found to be discharging/releasing gasoline and other refined petroleum
2 products including the Designated Chemicals into or on to the land was not materially different
3 whether the underground storage tank was single or double-walled.

4 22. Because DEFENDANTS, as well as the oil industry in general, are aware of
5 these facts, DEFENDANTS, along with the oil industry, have in place leak detection sensor
6 systems. The fact that DEFENDANTS uses such a system is an acknowledgment by
7 DEFENDANTS that it knows that the USTs it operates are likely to leak at any given time. The
8 sensors do not inform DEFENDANTS that the USTs are about to release product, only, at best,
9 that the USTs have leaked and/or are leaking product, including the Designated Chemicals.

10 23. The CWRQB Report also noted that the leak detection systems in use by the
11 industry only record a discharge from the USTs where the leak is more than 0.1 gallons/hour
12 (2.4 gallons a day, or 876 gallons a year per sensor). That is, even under this extremely lax
13 standard, DEFENDANTS do not even record a discharge until an individual tank sensor (of
14 which there are usually more than one in any UST) records a discharge of greater than 876
15 gallons a year. The actual level of non-recorded discharge can be much higher for any
16 individual UST since there may be four or more sensors in any given system each of which is
17 failing to record a discharge of slightly less than 876 gallons a year.

18 24. A report prepared by the SWRCB Underground Storage Tank Program entitled
19 "Field Evaluation of Underground Storage Tank System Leak Detection Sensors" expressly
20 found that the leak detection sensors systems used by the oil industry, including
21 DEFENDANTS, are not reliable where, as the report noted, the sensors have not been properly
22 installed, programmed, maintained and operated, or when the secondary containment in which
23 they are installed are not working properly. The SWRCB, in analyzing the use of leak detection
24 sensor systems by the oil industry (including DEFENDANTS), specifically noted a number of
25 significant problems which greatly lessened the utility of such sensors including the following:
26 "sensors were raised from the low point of the secondary containment, sensors fail[ed] to alarm
27 when tested, and sensors fail[ed] to shut down the turbine pump in the event of an alarm." The
28

1 report went on to note that almost a third of the secondary containment systems had water or
2 product in one or more areas, a fact which would seriously impact the operational effectiveness
3 of the sensor detection systems. Under these circumstances, the sensors will simply not operate
4 effectively, even at the lax warning level used by DEFENDANTS. Further, since such sensors,
5 even when working properly, do not prevent leaks but, at best, simply record them, they are
6 ineffective to avoid liability under Health & Safety Code sections 25249.5 and 25249.7.

7 25. The gasoline service operations of DEFENDANTS therefore pose and threaten
8 to pose an imminent treat to human health or safety or the environment and therefore create a
9 substantial probability of harm since there is a substantial likelihood that the USTs operated and
10 maintained by DEFENDANTS are either currently or likely will shortly discharge/release
11 gasoline and other refined petroleum products into or on to the land. Such a threatened
12 discharge/release of the Designated Chemicals from the USTs at the Facilities “probably will
13 pass into [a] source of drinking water” in violation of Proposition 65.

14 **FIRST CAUSE OF ACTION AGAINST EACH NAMED**

15 **DEFENDANT AND DOES 1-100**

16 **(Violation of California Health & Safety Code)**

17 26. Plaintiff Consumer Defense Group repeats and incorporates by reference
18 paragraphs 1 through 25 of this Complaint as though fully set forth herein.

19 27. Plaintiff is informed and believes and thereon alleges that Defendant SHELL
20 OIL COMPANY owns and/or operates the underground storage tank systems located at the
21 Facilities that are used for the storage of gasoline offered for sale to the general public. The
22 operation by Defendant SHELL OIL COMPANY of the underground storage tank systems
23 located at the Facilities, as well as the delivery, storage and dispensing of gasoline at the
24 Facilities listed in Exhibit 1 hereto, as currently controlled and managed by SHELL OIL
25 COMPANY, poses a substantial threat of discharge of chemicals known to the State of
26 California to cause cancer and reproductive toxicity, “into water or onto or into land where such
27 chemical passes or probably will pass into any source of drinking water” in violation of Health
28

1 & Safety Code §§ 25249.5, *et seq.* and 22 California Code of Regulations §§ 12000 through
2 14000.

3 28. Plaintiff is informed and believes and thereon alleges that Defendant EXXON
4 MOBIL CORPORATION owns and/or operates the underground storage tank systems located
5 at the Facilities that are used for the storage of gasoline offered for sale to the general public.
6 The operation by Defendant EXXON MOBIL CORPORATION of the underground storage
7 tank systems located at the Facilities, as well as the delivery, storage and dispensing of gasoline
8 at the Facilities listed in Exhibit 2 hereto, as currently controlled and managed by EXXON
9 MOBIL CORPORATION, poses a substantial threat of discharge of chemicals known to the
10 State of California to cause cancer and reproductive toxicity, “into water or onto or into land
11 where such chemical passes or probably will pass into any source of drinking water” in
12 violation of Health & Safety Code §§ 25249.5, *et seq.* and 22 California Code of Regulations
13 §§ 12000 through 14000.

14 29. Plaintiff is informed and believes and thereon alleges that Defendant
15 CHEVRON TEXACO CORPORATION owns and/or operates the underground storage tank
16 systems located at the Facilities that are used for the storage of gasoline offered for sale to the
17 general public. The operation by Defendant CHEVRON TEXACO CORPORATION of the
18 underground storage tank systems located at the Facilities, as well as the delivery, storage and
19 dispensing of gasoline at the Facilities listed in Exhibit 3 hereto, as currently controlled and
20 managed by CHEVRON TEXACO CORPORATION, poses a substantial threat of discharge
21 of chemicals known to the State of California to cause cancer and reproductive toxicity, “into
22 water or onto or into land where such chemical passes or probably will pass into any source of
23 drinking water” in violation of Health & Safety Code §§ 25249.5, *et seq.* and 22 California
24 Code of Regulations §§ 12000 through 14000.

25 30. Plaintiff is informed and believes and thereon alleges that Defendant UNOCAL
26 CORPORATION owns and/or operates the underground storage tank systems located at the
27 Facilities that are used for the storage of gasoline offered for sale to the general public. The
28

1 operation by Defendant UNOCAL CORPORATION of the underground storage tank systems
2 located at the Facilities, as well as the delivery, storage and dispensing of gasoline at the
3 Facilities listed in Exhibit 4 hereto, as currently controlled and managed by UNOCAL
4 CORPORATION, poses a substantial threat of discharge of chemicals known to the State of
5 California to cause cancer and reproductive toxicity, “into water or onto or into land where such
6 chemical passes or probably will pass into any source of drinking water” in violation of Health
7 & Safety Code §§ 25249.5, *et seq.* and 22 California Code of Regulations §§ 12000 through
8 14000.

9 31. Plaintiff is informed and believes and thereon alleges that Defendant VALERO
10 ENERGY CORPORATION owns and/or operates the underground storage tank systems
11 located at the Facilities that are used for the storage of gasoline offered for sale to the general
12 public. The operation by Defendant VALERO ENERGY CORPORATION of the underground
13 storage tank systems located at the Facilities, as well as the delivery, storage and dispensing of
14 gasoline at the Facilities listed in Exhibit 5 hereto, as currently controlled and managed by
15 VALERO ENERGY CORPORATION, poses a substantial threat of discharge of chemicals
16 known to the State of California to cause cancer and reproductive toxicity, “into water or onto
17 or into land where such chemical passes or probably will pass into any source of drinking
18 water” in violation of Health & Safety Code §§ 25249.5, *et seq.* and 22 California Code of
19 Regulations §§ 12000 through 14000.

20 32. Plaintiff is informed and believes and thereon alleges that Defendant
21 ROBINSON OIL CORPORATION owns and/or operates the underground storage tank systems
22 located at the Facilities that are used for the storage of gasoline offered for sale to the general
23 public. The operation by Defendant ROBINSON OIL CORPORATION of the underground
24 storage tank systems located at the Facilities, as well as the delivery, storage and dispensing of
25 gasoline at the Facilities listed in Exhibit 6 hereto, as currently controlled and managed by
26 ROBINSON OIL CORPORATION, poses a substantial threat of discharge of chemicals known
27 to the State of California to cause cancer and reproductive toxicity, “into water or onto or into
28

1 land where such chemical passes or probably will pass into any source of drinking water” in
2 violation of Health & Safety Code §§ 25249.5, *et seq.* and 22 California Code of Regulations
3 §§ 12000 through 14000.

4 33. Plaintiff is informed and believes and thereon alleges that Defendants BP
5 AMERICA, INC. and ATLANTIC RICHFIELD COMPANY SHELL OIL COMPANY own
6 and/or operate the underground storage tank systems located at the Facilities that are used for
7 the storage of gasoline offered for sale to the general public. The operation by Defendants BP
8 AMERICA, INC. and ATLANTIC RICHFIELD COMPANY HELL OIL COMPANY of the
9 underground storage tank systems located at the Facilities, as well as the delivery, storage and
10 dispensing of gasoline at the Facilities listed in Exhibit 7 hereto, as currently controlled and
11 managed by BP AMERICA, INC. and ATLANTIC RICHFIELD COMPANY, poses a
12 substantial threat of discharge of chemicals known to the State of California to cause cancer and
13 reproductive toxicity, “into water or onto or into land where such chemical passes or probably
14 will pass into any source of drinking water” in violation of Health & Safety Code §§ 25249.5,
15 *et seq.* and 22 California Code of Regulations §§ 12000 through 14000.

16 34. Therefore, SHELL OIL COMPANY; EXXON MOBIL CORPORATION;
17 CHEVRON TEXACO CORPORATION; UNOCAL CORPORATION; VALERO ENERGY
18 CORPORATION; ROBINSON OIL CORPORATION; BP AMERICA, INC.; ATLANTIC
19 RICHFIELD COMPANY and DOES 1- 100 are in violation of Health & Safety Code §§
20 25249.5 *et seq.* because they have and are knowingly and intentionally threatening to “release
21 chemicals known to the State of California to cause cancer or reproductive toxicity into water
22 or onto or into land where such chemical passes or probably will pass into any source of
23 drinking water,” at each of the Facilities listed on Exhibits 1 - 7 hereto.

24 35. More than sixty-five days prior to filing this action Plaintiff mailed to the
25 President for each named defendant a Sixty (60) Day Notice of Intent to Sue (hereinafter, “the
26 Notice”) for violations of Proposition 65, the Safe Drinking Water and Toxic Enforcement Act
27 (commencing with Health & Safety Code Section 25249.5).. The Notice specifically identified
28

1 the chemicals each defendant has and continues to knowingly and intentionally threaten to
2 release into water or onto or into land where such chemical passes or probably will pass into
3 any source of drinking water at each of the Facilities listed on Exhibits 1 - 7 hereto. In violation
4 of Proposition 65, the Safe Drinking Water and Toxic Enforcement Act (commencing with
5 Health & Safety Code Section 25249.5)

6 36. Copies of the Notices referred to in paragraph 35 were mailed to the California
7 Attorney General, the County District Attorneys and City Attorneys for each city containing a
8 population of at least 750,000 people (hereinafter referred to collectively as "the Prosecutors")
9 for the locations where each defendant had violated Health & Safety Code Sections 25249.5, *et*
10 *seq.* and 22 California Code of regulations Sections 12000 through 14000.

11 37. None of the Prosecutors is prosecuting an action against any defendant herein for
12 the violations set forth above.

13 38. This action for injunctive relief for violation of Health & Safety Code Sections
14 25249.5, *et seq.* is specifically authorised by Health & Safety Code Section 25249.7.

15 **SECOND CAUSE OF ACTION AGAINST ALL**
16 **NAMED DEFENDANTS AND DOES 1-100**
17 **(Violation of California Fish & Game Code)**

18 39. Plaintiff Consumer Defense Group repeats and incorporates by reference
19 paragraphs 1 through 38 of this Complaint as though fully set forth herein.

20 40. Fish & Game Code Section 5650 provides in relevant part that "it is unlawful to
21 deposit in, permit to pass into, or place where it can pass into the waters of this state any of the
22 following: (a) Any petroleum, acid, coal, or oil tar . . . or residuary product of petroleum, or
23 carbonaceous material or substance. (b) Any refuse, liquid or solid, from any refinery . . . or
24 factory of any kind. (c) Any substance or material deleterious to fish, plant life or bird life.

25 41. Benzene and toluene are petroleum products and/or residuary product of
26 petroleum, and are deleterious to fish, plant and/or bird life.

27 42. A private right of action for violations of Fish & Game Code § 5650 is provided
28

1 for by Business & Professions Code § 17200, *et seq.*, which defines unfair competition to
2 include “unlawful, unfair or fraudulent business practices and unfair, deceptive, untrue or
3 misleading advertising.” An action for injunctive relief is specifically authorized by said
4 sections by Business & Professions Code §§ 17202, 17203 and 17204.

5 43. By committing acts alleged above in violation of Fish & Game Code 5650, each
6 Defendant is liable for all appropriate relief authorised under the California Unfair Competition
7 Act, Business & professions Code 17203. Continuing commission of the acts alleged above by
8 each Defendant will irreparably harm plaintiff and the citizens of the State of California, for

4. Cost of suit;
5. Reasonable attorneys fees and costs, including expert witness fees; and,
6. Any further relief that the court may deem just and equitable.
