1 As and for its causes of action against defendants SHELL OIL COMPANY; EQUILON
2 ENTERPRISES, LLC; CHEVRON TEXACO CORPORATION; CHEVRON U.S.A. INC.;
3 ROBINSON OIL CORPORATION; BP AMERICA, INC.; BP OIL SUPPLY COMPANY;
4 ATLANTIC RICHFIELD COMPANY; CONOCOPHILIPS; CONOCO, INC.; PHILIPS
5 PETROLEUM, FLYING J, INC. AND DOES 1- 100, plaintiff CONSUMER DEFENSE
6 GROUP ACTION alleges as follow:
7

8 **ALLEGATIONS INCORPORATED INTO THE CAUSE OF ACTION**

9 **A. PARTIES**

10 1. Plaintiff CONSUMER DEFENSE GROUP ACTION is and has been at all
11 relevant times a California corporation in good standing, duly organized and existing under and
12 by virtue of the laws of the State of California, and brings this action in the public interest as
13 defined under Health & Safety Code § 25249.7 (d).

14 2. Defendants SHELL OIL COMPANY; EQUILON ENTERPRISES, LLC;
15 CHEVRON TEXACO CORPORATION; CHEVRON U.S.A. INC.; ROBINSON OIL
16 CORPORATION; BP AMERICA, INC.; BP OIL SUPPLY COMPANY; ATLANTIC
17 RICHFIELD COMPANY; CONOCOPHILIPS; CONOCO, INC.; PHILIPS PETROLEUM;
18 FLYING J, INC. AND DOES 1- 100 are and at all times mentioned herein have been qualified
19 to do business in the State of California.
20

21 3. Plaintiff is ignorant of the true names and capacities of defendants sued as
22 DOES 1 - 100, inclusive, and therefore sues these defendants by such fictitious names. The
23 fictitious defendants named in this Complaint are sued pursuant to the provisions of C.C.P. §
24 474. Plaintiff is informed and believes, and upon that ground, alleges that each fictitious
25 defendant is in some way responsible for, participated in, or contributed to the matters and
26

1 things of which Plaintiff complains herein, and in some fashion, has legal responsibility
2 therefor. When the exact nature and identity of such fictitious defendants' responsibility for,
3 participation in, and contribution to the matters and things alleged herein are ascertained by
4 Plaintiff, Plaintiff will seek to amend this Complaint and all proceedings herein to set forth the
5 same.
6

7 4. At all times mentioned each of the defendants herein was a person within the
8 meaning of Business & Professions Code § 17201 and a person doing business within the
9 meaning of Health & Safety Code § 25249.11 (a). Plaintiff is informed and believes and
10 thereon alleges that at all times mentioned herein, each defendant has had 10 or more
11 employees.
12

13 5. The Court has jurisdiction over this action pursuant to California Constitution
14 Article VI, Section 10, which grants the Superior Court original jurisdiction in all causes except
15 those given by statute to other trial courts. The statutes under which this action is brought do
16 not specify any other basis of jurisdiction.
17

18 **B. FACTS**

19 6. Proposition 65, the Safe Drinking Water and Toxic Enforcement Act
20 (commencing with Health & Safety Code Section 25249.5) (hereinafter referred to as
21 "Proposition 65"), absolutely prohibits any business from contaminating the drinking water
22 supplies of California.

23 7. All water within the State, including groundwater, is the property of the people
24 of the State of California. California Water Code §§ 102 and 104. As to all water, the
25 Legislature of the State of California ("the Legislature") has determined, as set forth in
26 California Water Code § 13000, that "the people of the State have a primary interest in the
27

1 conservation, control and utilization of the water resources of the state, and that the quality of
2 all waters of the State shall be protected for use and enjoyment of the people of the state.”

3 8. Under Proposition 65, a “source of drinking water” is not confined to existing
4 drinking water supplies. Rather, as set forth in Health & Safety Code §25249.10 (d), “[s]ource
5 of drinking water means either a present source of drinking water or water which is identified or
6 designated in a water quality control plan adopted by a regional board as being suitable for
7 domestic or municipal uses [and] also includes water identified in a regional board” water
8 quality control plan as being suitable for domestic or municipal uses.”

9
10 9. Each of the above-named DEFENDANTS are in violation of Proposition 65
11 because they have and are knowingly and intentionally threatening to “release chemicals known
12 to the State of California to cause cancer or reproductive toxicity into water or onto or into land
13 where such chemical passes or probably will pass into any source of drinking water,” at each of
14 the facilities listed on Exhibits 1 - 6 hereto (hereinafter “the Facilities”), which are branded
15 gasoline stations with in-place underground storage tank systems.

16
17 10. Proposition 65 provides that when a party, such as each of the DEFENDANTS,
18 all of which are entities with more than ten employees, have been and are knowingly and
19 intentionally threatening to “release chemicals known to the State of California to cause cancer
20 or reproductive toxicity into water or onto or into land where such chemical passes or probably
21 will pass into any source of drinking water,” that party is violating Health & Safety Code
22 Section 25249.5 and may be enjoined from such conduct pursuant to Health & Safety Code
23 Section 25249.7.

24
25 11. The DEFENDANTS market gasoline and other refined petroleum products
26 (hereinafter referred to as “gasoline”) under various trademarks directly to motorists at branded
27
28

1 retail outlets and/or through independent dealers and distributors in California and elsewhere.
2 DEFENDANTS own and/or operate the underground storage tank systems located at the
3 Facilities that are used for the storage of gasoline offered for sale to the general public. The
4 operation by DEFENDANTS of the underground storage tank systems (hereinafter "the USTs")
5 located at the Facilities, as well as the delivery, storage and dispensing of gasoline at the
6 Facilities, as currently controlled and managed by DEFENDANTS, poses a substantial threat of
7 discharge of gasoline and other refined petroleum products "into water or onto or into land
8 where such chemical passes or probably will pass into any source of drinking water" in
9 violation of Health & Safety Code § 25249.5.
10

11
12 12. The chemicals which DEFENDANTS are threatening to release are benzene and
13 toluene which are contained in the gasoline and other refined petroleum products which
14 DEFENDANTS market and store within the USTs owned and/or operated by DEFENDANTS
15 at the Facilities.

16
17 13. Gasoline contains a number of constituents and additives each of which
18 separately, as well as in combination, present a significant risk to human health, safety and the
19 environment. The gasoline marketed by each of the DEFENDANTS contains the chemicals
20 Benzene and Toluene. Benzene is a clear, colorless, highly reactive flammable liquid derived
21 from petroleum and contained in gasoline. Benzene is a chemical known by the State of
22 California to cause cancer and has been listed as such pursuant to Proposition 65. Toluene is a
23 colorless flammable liquid obtained from coal tar or petroleum and contained in motor vehicle
24 fuels. Toluene is a chemical known by the State of California to cause reproductive toxicity and
25 has been listed as such pursuant to Proposition 65. Hereinafter benzene and toluene are
26 referred to as the "Designated Chemicals".
27
28

1 14. In order to be in compliance with Proposition 65, each of the DEFENDANTS
2 must effectively contain the Designated Chemicals in a UST system that is “product tight.”

3 15. “Product tight” means that the operations of each of the DEFENDANTS at the
4 Facilities must be impervious to the liquid and vapor of the substance (“the Designated
5 Chemicals”) that is or are contained or to be contained in the underground storage tank systems
6 so as to prevent discharge or release of the Designated Chemicals from the containment system
7 and into or on to the ground where the Designated Chemicals will pass or probably will pass
8 into any source of drinking water.
9

10 16. The gasoline service station operations undertaken at the Facilities are not
11 “product tight” (i.e. the operations are not impervious to the liquid and vapor of the substance
12 that is contained, or is to be contained, in the underground storage tank systems so as to prevent
13 seepage of the Designated Chemicals from the containment and into the ground) and thus are
14 threatening to cause a discharge of Designated Chemicals.
15

16 17. The following are the components of the gasoline service station operations that
17 pose a threat of discharge of Designated Chemicals: the underground tank(s) and underground
18 storage tank system(s); the pipes used in connection with the storage of the Designated
19 Chemicals in the USTs, including connecting pipes, vapor recovery lines, vent lines and
20 associated fittings as well as the associated secondary containment systems; the drainage
21 systems which collect surface water run off from the petroleum dispensing and delivery areas;
22 secondary containment and spill control systems, including but not limited to secondary
23 containment for the underground tank system, pipe, connecting pipe, dispensers and dispenser
24 piping and the petroleum delivery area, as well as for the drainage systems which collected
25 surface water run off from the dispensing and delivery area.
26
27
28

1 18. At the Facilities, the gasoline containing Designated Chemicals is stored in one
2 or more underground storage tank(s) and an underground storage tank system, which includes,
3 but is not limited to, one or more tanks, including the piping connected thereto. The pipes used
4 in connection with the storage of the Designated Chemicals in the USTs includes but is not
5 limited to valves and other appurtenances connected to the pipe, pumping units, fabricated
6 assemblies associated with the pumping units, and metering and delivery stations and fabricated
7 assemblies therein. The pipes used in connection with the storage of the Designated Chemicals
8 in the USTs include "connecting piping", such as pipe, valves elbows, joints, flanges and
9 flexible connectors through which the Designated Chemicals flow. The UST system also
10 includes the vapor recovery lines, vent lines and associated fittings as well as the associated
11 secondary containment systems, the drainage systems which collect surface water run off from
12 the petroleum dispensing and delivery areas. Finally, the UST systems include secondary
13 containment and spill control systems including but not limited to secondary containment for
14 the underground tank system, leak detection sensors, pipe, connecting pipe, dispensers and
15 dispenser piping and the petroleum delivery area, as well as for the drainage systems which
16 collect surface water run off from the dispensing and delivery area.
17
18
19

20 19. Investigations and reports conducted and prepared for the California State Water
21 Resources Control Board ("SWRCB") (with the assistance and input of the Environmental
22 Health Divisions and Departments for a number of California counties and Regional Water
23 Quality Control Boards, as well as various members of the oil industry including some of the
24 named DEFENDANTS), the California Environmental Protection Agency ("CEPA"),
25 Department of Toxic Substances Control ("DTSC"), the Office of Pollution Prevention and
26 Technology Department, as well as testing undertaken by the various city fire departments
27
28

1 where the Facilities are located, demonstrate that discharges of petroleum products including
2 the Designated Chemicals occur, and are expected to occur, from the gasoline service station
3 operations at the Facilities on a regular and ongoing basis.

4
5 20. The CWRQB Report concluded that 61% of all USTs in operation, at any given
6 time, are discharging/releasing gasoline and other refined petroleum products including the
7 Designated Chemicals into or on to the land. The CWRQB Report also found that the
8 percentage of USTs found to be discharging/releasing gasoline and other refined petroleum
9 products including the Designated Chemicals into or on to the land was not materially different
10 whether the underground storage tank was single or double-walled.

11
12 21. Because DEFENDANTS, as well as the oil industry in general, are aware of
13 these facts, DEFENDANTS, along with the oil industry, have in place leak detection sensor
14 systems. The fact that DEFENDANTS use such a system is an acknowledgment by
15 DEFENDANTS that they know that the USTs they operate are likely to leak at any given time.
16 The sensors do not inform DEFENDANTS that the USTs are about to release product, only, at
17 best, that the USTs have leaked and/or are leaking product, including the Designated
18 Chemicals.

19
20 22. The CWRQB Report also noted that the leak detection systems in use by the
21 industry only record a discharge from the USTs where the leak is more than 0.1 gallons/hour
22 (2.4 gallons a day, or 876 gallons a year per sensor). That is, even under this extremely lax
23 standard, DEFENDANTS do not even record a discharge until an individual tank sensor (of
24 which there are usually more than one in any UST) records a discharge of greater than 876
25 gallons a year. The actual level of non-recorded discharge can be much higher for any
26 individual UST since there may be four or more sensors in any given system each of may be
27
28

1 failing to record a discharge of slightly less than 876 gallons a year.

2 23. A report prepared by the SWRCB Underground Storage Tank Program entitled
3 “Field Evaluation of Underground Storage Tank System Leak Detection Sensors” expressly
4 found that the leak detection sensors systems used by the oil industry, including
5 DEFENDANTS, are not reliable where, as the report noted, the sensors have not been properly
6 installed, programmed, maintained and operated, or when the secondary containment in which
7 they are installed are not working properly. The SWRCB, in analyzing the use of leak detection
8 sensor systems by the oil industry (including DEFENDANTS), specifically noted a number of
9 significant problems which greatly lessened the utility of such sensors including the following:
10 “sensors were raised from the low point of the secondary containment, sensors fail[ed] to alarm
11 when tested, and sensors fail[ed] to shut down the turbine pump in the event of an alarm.” The
12 report went on to note that almost a third of the secondary containment systems had water or
13 product in one or more areas, a fact which would seriously impact the operational effectiveness
14 of the sensor detection systems. Under these circumstances, the sensors will simply not operate
15 effectively, even at the lax warning level used by DEFENDANTS. Further, since such sensors,
16 even when working properly, do not prevent leaks but, at best, simply record them, they are
17 ineffective to avoid liability under Health & Safety Code sections 25249.5 and 25249.7.
18
19
20

21 24. The gasoline service operations of DEFENDANTS therefore pose and threaten
22 to pose an imminent treat to human health or safety or the environment and therefore create a
23 substantial probability of harm since there is a substantial likelihood that the USTs operated and
24 maintained by DEFENDANTS are either currently or likely will shortly discharge/release
25 gasoline and other refined petroleum products into or on to the land. Such a threatened
26 discharge/release of the Designated Chemicals from the USTs at the Facilities “probably will
27
28

1 pass into [a] source of drinking water” in violation of Proposition 65.

2 **FIRST CAUSE OF ACTION AGAINST EACH**

3 **NAMED DEFENDANT AND DOES 1-100**

4 **(Violations of California Health & Safety Code Section 25249.5)**

5 **[Threatened Release or Discharge]**

6 25. Plaintiff Consumer Defense Group Action repeats and incorporates by reference
7 paragraphs 1 through 24 of this Complaint as though fully set forth herein.

8
9 26. Plaintiff is informed and believes and thereon alleges that DEFENDANTS have
10 been and are knowingly and intentionally threatening to “release chemicals known to the State
11 of California to cause cancer or reproductive toxicity into water or onto or into land where such
12 chemical passes or probably will pass into any source of drinking water” in violation of Health
13 & Safety Code Section 25249.5 at the site located at the Facilities identified on Exhibits 1 - 6
14 “the Facilities”).

15
16 27. More than sixty-five days prior to filing this first amended complaint Plaintiff
17 mailed to the President and Chief Executive Officer for each DEFENDANT a Sixty (60) Day
18 Notice of Intent to Sue (hereinafter, “the Notice”) for violations of Proposition 65, the Safe
19 Drinking Water and Toxic Enforcement Act (commencing with Health & Safety Code Section
20 25249.5) by knowingly and intentionally threatening to “release chemicals known to the State
21 of California to cause cancer or reproductive toxicity into water or onto or into land where such
22 chemical passes or probably will pass into any source of drinking water” in violation of Health
23 & Safety Code § 25249.5 at the Facilities listed on Exhibit 1 - 6 hereto, respectively. The
24 Notice specifically identified the chemicals each DEFENDANT has and continues to
25 knowingly and intentionally threaten to release into water or onto or into land where such
26
27
28

1 chemical passes or probably will pass into any source of drinking water at each of the Facilities
2 listed on Exhibits 1 - 6 hereto, respectively. Included with the Notice was a copy of "The Safe
3 Drinking Water and Toxic Enforcement Act of 1986 (Proposition 65): A Summary." The
4 Notice fully complied with the requirements of the Safe Drinking Water and Toxic
5 Enforcement Act of 1986.
6

7 28. Copies of the Notices referred to in paragraphs 26 and 27 were mailed to the
8 California Attorney General, the County District Attorneys and City Attorneys for each city
9 containing a population of at least 750,000 people (hereinafter referred to collectively as "the
10 Prosecutors") for the locations where each defendant had violated Health & Safety Code
11 Sections 25249.5, *et seq.* and 22 California Code of regulations Sections 12000 through 14000.
12

13 29. On information and belief, none of the Prosecutors is prosecuting an action
14 against any defendant herein for the violations set forth above.

15 30. This action for injunctive relief and penalties for violation of Health & Safety
16 Code Sections 25249.5, *et seq.* is specifically authorized by Health & Safety Code Section
17 25249.7.
18

19 PRAYER FOR RELIEF

20 WHEREFORE, plaintiff requests against each defendant:

- 21 1. A permanent injunction requiring that Defendants and each of them come into full and
22 immediate compliance with each law, statute, regulation or standard, all as more fully
23 alleged in each cause of action;
- 24 2. A declaration by this court the Defendants and each of them have been and continue to
25 be in violation of each of the above-cited statutes;
- 26 3. Cost of suit;
- 27


