TOXIC TORT/ENVIRONMENTAL 20 MATEEL ENVIRONMENTAL JUSTICE FOUNDATION alleges as follows: 21 INTRODUCTION 22 1. This Complaint seeks civil penalties and an injunction to remedy the continuing 23 failure of defendants KITTRICH CORPORATION; TUFF-WARE, INC., and DOES 1 through 24 100 inclusive (hereinafter "Defendants"), to give clear and reasonable warnings to those residents 25 of California, who handle and use shelf and drawer liner material and adhesive decorative 26 covering that are made from lead-containing plastic (hereinafter "leaded plastic coverings"), that 27 handling and use of these products causes those residents to be exposed to lead and lead 28

compounds, lead acetate, lead phosphate, and lead subacetate (hereinafter, collectively, "lead"). The types of products to which this Complaint pertains are those types listed in the Product List appended to the Proposition 65 60-Day Notice Letter that is attached to and incorporated by reference into this Complaint. Lead is known to the State of California to cause cancer, birth defects and male and female reproductive toxicity. Defendants manufacture, distribute, and/or market. These products cause exposures to lead and lead compounds, which are chemicals known to the State of California to cause cancer, birth defects and other reproductive harm.

- 2. Defendants are businesses that manufacture, market, and/or distribute leaded plastic coverings. Defendants intend that residents of California handle and use leaded plastic coverings that Defendants manufacture, market, and/or distribute. When these products are handled and used in their normally intended manner, they expose people to lead. In spite of knowing that residents of California were and are being exposed to these chemicals when they handle and use leaded plastic coverings, Defendants did not and do not provide clear and reasonable warnings that these products cause exposure to chemicals known to cause cancer, birth defects and other reproductive harm.
- 3. Plaintiff seeks injunctive relief pursuant to Health & Safety Code Section 25249.7 to compel Defendants to bring their business practices into compliance with section 25249.5 et seq. by providing a clear and reasonable warning to each individual who has been and who in the future may be exposed to the above mentioned toxic chemicals from the use of Defendants' products. Plaintiff seeks an order that defendants identify and locate each individual person who in the past has purchased leaded plastic coverings and to provide to each such purchaser a clear and reasonable warning that the leaded plastic coverings will cause exposures to chemicals known to cause birth defects.
- 4. In addition to injunctive relief, plaintiff seeks civil penalties to remedy the failure of Defendants to provide clear and reasonable warnings regarding exposure to chemicals known to cause cancer, birth defects and other reproductive harm.

## **PARTIES**

5. Plaintiff MATEEL ENVIRONMENTAL JUSTICE FOUNDATION ("Mateel")

is a non-profit organization dedicated to, among other causes, the protection of the environment, promotion of human health, environmental education, and consumer rights. Mateel is based in Eureka, California, and is incorporated under the laws of the State of California. Mateel is a "person" pursuant to Health & Safety Code Section 25118. Mateel brings this enforcement action in the public interest pursuant to Health & Safety Code §25249.7(d). Residents of California are regularly exposed to lead and lead compounds from leaded plastic coverings manufactured, distributed or marketed by Defendants and are so exposed without a clear and reasonable Proposition 65 warning.

- 6. Defendants are each a person doing business within the meaning of Health & Safety Code Section 25249.11. Defendants are businesses that manufacture, distribute, and/or market leaded plastic coverings in California, including the City and County of San Francisco. Manufacture, distribution and/or marketing of these products in the City and County of San Francisco and/or to people who live in San Francisco, causes people to be exposed to lead and lead compounds while they are physically present in the City and County of San Francisco.
- 7. Mateel is unaware of the true names or capacities of the Defendants sued herein under the fictitious names DOES 1 through 100, inclusive. Defendants DOES 1 through 100 inclusive are therefore sued herein pursuant to Cal. Code Civ. Proc. §474. When Mateel learns their identities, it will amend the complaint.
- 8. Plaintiff brings this enforcement action against Defendants pursuant to Health & Safety Code Section 25249.7(d). Attached hereto and incorporated by reference is a copy of a 60-day Notice letter dated July 29, 2006 which Mateel sent to California's Attorney General. Substantially identical letters were sent to every District Attorney in the state, and to the City Attorneys of every California city with a population greater than 750,000. On that same day, Mateel sent identical 60-Day Notice letters to each defendant. Attached to the 60-Day Notice Letters sent to each defendant was a summary of Proposition 65 that was prepared by California's Office of Environmental Health Hazard Assessment. In addition, each 60-Day Notice Letter plaintiff sent was accompanied by a Certificate of Service attesting to the service of the 60-Day Notice Letter on each entity which received it. Pursuant to California Health & Safety

Code Section 25249.7(d), a Certificate of Merit attesting to the reasonable and meritorious basis for the action was also sent with each 60-Day Notice Letter. Factual information sufficient to establish the basis of the Certificate of Merit was enclosed with the 60-Day Notice letter Mateel sent to the Attorney General.

9. Defendants are all businesses that employ more than ten people.

## JURISDICTION

- 10. The Court has jurisdiction over this action pursuant to California Health & Safety Code Section 25249.7. California Constitution Article VI, Section 10 grants the Superior Court "original jurisdiction in all causes except those given by statute to other trial courts." Chapter 6.6 of the Health & Safety Code, which contains the statutes under which this action is brought, does not grant jurisdiction to any other trial court.
- 11. This Court also has jurisdiction over Defendants because they are businesses that have sufficient minimum contacts in California and within the City and County of San Francisco. Defendants intentionally availed themselves of the California and San Francisco County markets for leaded plastic coverings. It is thus consistent with traditional notions of fair play and substantial justice for the San Francisco Superior Court to exercise jurisdiction over them.
- 12. Venue is proper in this Court because Defendants market their products in and around San Francisco and thus cause people to be exposed to lead and lead compounds while those people are physically present in San Francisco. Liability for Plaintiff's causes of action, or some parts thereof, has accordingly arisen in San Francisco during the times relevant to this Complaint and Plaintiff seeks civil penalties and forfeitures imposed by statutes.

## FIRST CAUSE OF ACTION (Claim for Injunctive Relief)

13. Plaintiff realleges and incorporates by reference into this First Cause of Action, as if specifically set forth herein, paragraphs 1 through 12, inclusive.

- 14. The People of the State of California have declared by referendum under Proposition 65 (California Health & Safety Code § 25249.5 et seq.) their right "[t]o be informed about exposures to chemicals that cause cancer, birth defects, and reproductive harm."
- 15. To effectuate this goal, Section 25249.6 of the Health and Safety Code mandates that persons who, in the course of doing business, knowingly and intentionally expose any individual to a chemical known to the State of California to cause cancer or birth defects must first provide a clear and reasonable warning to such individual prior to the exposure.
- 16. Since at least July 29, 2003, Defendants have engaged in conduct that violates Health and Safety Code Section 25249.6 et seq. This conduct includes knowingly and intentionally exposing to the above mentioned toxic chemicals, those California residents who handle and use leaded plastic coverings. The normally intended use of leaded plastic coverings causes exposure to lead and lead compounds, which are chemicals known to the State of California to cause cancer, birth defects and other reproductive harm. Defendants have not provided clear and reasonable warnings, within the meaning of Health & Safety Code Sections 25249.6 and 25249.11.
- 17. At all times relevant to this action, Defendants knew that the leaded plastic coverings they manufactured, distributed or marketed were causing exposures to lead and lead compounds. Defendants intended that residents of California handle and use leaded plastic coverings in such ways as would lead to significant exposures to these chemicals.
- 18. By the above described acts, Defendants have violated Cal. Health & Safety Code § 25249.6 and are therefore subject to an injunction ordering them to stop violating Proposition 65 and requiring them to provide warnings to their past customers who purchased defendants' products without receiving a clear and reasonable warning.

# SECOND CAUSE OF ACTION (Claim for Civil Penalties)

19. Plaintiff realleges and incorporates by reference into this Second Cause of Action, as if specifically set forth herein, paragraphs 1 through 18, inclusive.

20. By the above described acts, Defendants are liable and should be liable pursuant to Health & Safety Code § 25249.7(b), for a civil penalty of \$2,500.00 per day for each individual exposed without proper warning to lead and lead compounds from the handling or use of Defendants' leaded plastic coverings.

## PRAYER FOR RELIEF

Wherefore, plaintiff prays for judgment against DEFENDANTS, as follows:

- 1. Pursuant to the First Cause of Action, that all Defendants be enjoined, restrained, and ordered to comply with the provisions of Section 25249.6 of the California Health & Safety Code;
- 2. Pursuant to the Second Cause of Action, that Defendants be assessed a civil penalty in an amount equal to \$2,500.00 per day per individual exposed, in violation of Section 25249.6 of the California Health & Safety Code, to lead and lead compounds as the result of Defendants' manufacturing, distributing or marketing of leaded plastic coverings;
- 3. That Defendants be ordered to identify and locate each individual who purchased Leaded plastic coverings and provide a warning to each such person that the leaded plastic coverings the person purchased will expose that person to chemicals known to cause birth defects.
  - 4. For such other relief as this court deems just and proper.

Greetings:

This office and the Mateel Environmental Justice Foundation ("Mateel") give you notice that the private businesses on the attached service list has been, are, will be and threaten to be in violation of Cal. Health & Safety Code § 25249.6. Both this office and Mateel are private enforcers of Proposition 65, both may be contacted at the below listed address and telephone number, and I am a responsible individual at both Mateel and this office. The above referenced violations occur when California residents come into contact with shelf and drawer liner material and adhesive decorative covering. Both types of products are made from plastic (hereinafter "plastic coverings"). A list of specific examples of the specific types of these products is attached. The plastic these coverings are made from contains lead and lead compounds ("lead"), chemicals known to cause cancer, birth defects and other reproductive harm. California residents are exposed to lead when they handle these coverings while installing them, while using them, when coming into contact with them and when using dishes the food or lip surfaces of which come into contact with the coverings. Lead in the plastic is transferred from the plastic to their hands and to other parts of their skin or to their dishes or eating utensils. This lead is then absorbed through the skin, taken into cuts and abrasions, absorbed through mucous membranes, and transferred from the skin to the mouth via oral contact either directly with the plastic, from oral contact with the lead-contaminated skin or dishes and utensiles, and when lead is transferred from contaminated skin and or dishes to cigarettes and food and the contaminated cigarettes and food are smoked and/or eaten. These lead exposures thus occur via the dermal absorption, subcutaneous, mucus membrane, ingestion and inhalation routes. The listed business did not and do not provide people with clear and reasonable warnings before they expose them to lead. These violations have occurred every day since at least June 29, 2003, and will continue every day until the lead is removed from the plastic used to make these coverings, or until clear and reasonable warnings are given. The above-referenced violations are alleged for occupational exposures as well as for consumer and environmental exposures. We do not, however, allege occupational exposure violations as to any plastic coverings made outside of California, except as to workplaces these companies themselves maintain in California. Exposures constituting Proposition 65 environmental exposure violations occur both on and off the property of these businesses and in each of California's 58 counties.

## **CERTIFICATE OF MERIT**

I, William Verick, hereby declare: This Certificate of Merit accompanies the attached sixty-day notice(s) in which it is alleged the parties identified in the notices have violated Health and Safety Code section 25249.6 by failing to provide clear and reasonable warnings. I am the attorney for the noticing party. I have consulted with one or more persons with relevant and appropriate experience or expertise who has reviewed facts, studies, or other data regarding the exposure to the listed chemical that is the subject of the action. Based on the information obtained through those consultations, and on all other information in my possession, I believe there is a reasonable and meritorious case for the private action. I understand that "reasonable and meritorious case for the private action" means that the information provides a credible basis that all elements of the plaintiffs' case can be established and the information did not prove that the alleged violator will be able to establish any of the affirmative defenses set forth in the statute.
