to be exposed to lead and lead compounds, lead acetate, lead phosphate, and lead subacetate (hereinafter, collectively, "lead"). The types of products to which this Complaint pertains are those types listed in the Product List appended to the Proposition 65 60-Day Notice Letter that is attached to and incorporated by reference into this Complaint. Lead is known to the State of California to cause cancer, birth defects and male and female reproductive toxicity. Defendant distributes, and/or markets Leaded Brass Paintball Guns and Accessories. These products cause exposures to lead and lead compounds, which are chemicals known to the State of California to cause cancer, birth defects and other reproductive harm.

- 2. Defendant markets, and/or distributes Leaded Brass Paintball Guns and Accessories. Defendant intends that residents of California handle and use Leaded Brass Paintball Guns and Accessories that Defendant markets, and/or distributes. When these products are handled and used in their normally intended manner, they expose people to lead. In spite of knowing that residents of California were and are being exposed to these chemicals when they handle and use Leaded Brass Paintball Guns and Accessories, Defendant did not and does not provide clear and reasonable warnings that these products cause exposure to chemicals known to cause cancer, birth defects and other reproductive harm.
- 3. Plaintiff seeks injunctive relief pursuant to Health & Safety Code Section 25249.7 to compel Defendants to bring their business practices into compliance with section 25249.5 et seq. by providing a clear and reasonable warning to each individual who has been and who in the future may be exposed to the above mentioned toxic chemicals from the use of Defendant's products. Plaintiff seeks an order that Defendant identify and locate each individual person who in the past has purchased Leaded Brass Paintball Guns and Accessories and to provide to each such purchaser a clear and reasonable warning that the Leaded Brass Paintball Guns and Accessories will cause exposures to chemicals known to cause birth defects.
- 4. In addition to injunctive relief, plaintiff seeks civil penalties to remedy the failure of Defendant to provide clear and reasonable warnings regarding exposure to chemicals known to cause cancer, birth defects and other reproductive harm.

<u>PARTIES</u>

- 5. Plaintiff MATEEL ENVIRONMENTAL JUSTICE FOUNDATION ("Mateel") is a non-profit organization dedicated to, among other causes, the protection of the environment, promotion of human health, environmental education, and consumer rights. Mateel is based in Eureka, California, and is incorporated under the laws of the State of California. Mateel is a "person" pursuant to Health & Safety Code Section 25118. Mateel brings this enforcement action in the public interest pursuant to Health & Safety Code §25249.7(d). Residents of California are regularly exposed to lead and lead compounds from Leaded Brass Paintball Guns and Accessories manufactured, distributed or marketed by Defendant and are so exposed without a clear and reasonable Proposition 65 warning.
- 6. Defendant is a person doing business within the meaning of Health & Safety Code Section 25249.11. Defendant is a business that distributes, and/or markets Leaded Brass Paintball Guns and Accessories in California, including San Francisco County. Distribution and/or marketing of these products in San Francisco County, and/or to people who live in San Francisco County, causes people to be exposed to lead and lead compounds while they are physically present in San Francisco County.
- 7. Plaintiff brings this enforcement action against Defendant pursuant to Health & Safety Code Section 25249.7(d). Attached hereto and incorporated by reference is a copy of a 60-day Notice letter, dated December 23, 2009, which Mateel sent to California's Attorney General. Substantively identical letters were sent to every District Attorney in the state, and to the City Attorneys of every California city with a population greater than 750,000, and to each Defendant. Attached to the 60-Day Notice Letter sent to Defendant was a summary of Proposition 65 that was prepared by California's Office of Environmental Health Hazard Assessment. In addition, each 60-Day Notice Letter plaintiff sent was accompanied by a Certificate of Service attesting to the service of the 60-Day Notice Letter on each entity which received it. Pursuant to California Health & Safety Code Section 25249.7(d), a Certificate of Merit attesting to the reasonable and meritorious basis for the action was also sent with each 60-Day Notice Letter. Factual information sufficient to establish the basis of the Certificate of Merit

was enclosed with the 60-Day Notice letter Mateel sent to the Attorney General.

8. Defendant employs more than ten people.

JURISDICTION

- 9. The Court has jurisdiction over this action pursuant to California Health & Safety Code Section 25249.7. California Constitution Article VI, Section 10 grants the Superior Court "original jurisdiction in all causes except those given by statute to other trial courts." Chapter 6.6 of the Health & Safety Code, which contains the statutes under which this action is brought, does not grant jurisdiction to any other trial court.
- 10. This Court also has jurisdiction over Defendant because it is a business that has sufficient minimum contacts in California and within the City and County of San Francisco. Defendant intentionally availed itself of the California and San Francisco County markets for Leaded Brass Paintball Guns and Accessories. It is thus consistent with traditional notions of fair play and substantial justice for the San Francisco Superior Court to exercise jurisdiction over Defendant.
- 11. Venue is proper in this Court because Defendant markets its products in and around San Francisco County and thus causes people to be exposed to lead and lead compounds while those people are physically present in San Francisco County. Liability for Plaintiff's causes of action, or some parts thereof, has accordingly arisen in San Francisco County during the times relevant to this Complaint and Plaintiff seeks civil penalties imposed by statute.

FIRST CAUSE OF ACTION (Claim for Injunctive Relief)

- 12. Plaintiff realleges and incorporates by reference into this First Cause of Action, as if specifically set forth herein, paragraphs 1 through 11, inclusive.
- 13. The People of the State of California have declared by referendum under Proposition 65 (California Health & Safety Code § 25249.5 et seq.) their right "[t]o be informed about exposures to chemicals that cause cancer, birth defects, and reproductive harm."
- 14. To effectuate this goal, Section 25249.6 of the Health and Safety Code mandates that businesses that knowingly and intentionally expose any individual to a chemical known to

 the State of California to cause cancer or birth defects must first provide a clear and reasonable warning to such individual prior to the exposure.

- Health and Safety Code Section 25249.6 et seq. This conduct includes knowingly and intentionally exposing to the above mentioned toxic chemicals, those California residents who handle and use Leaded Brass Paintball Guns and Accessories. The normally intended use of Leaded Brass Paintball Guns and Accessories causes exposure to lead and lead compounds, which are chemicals known to the State of California to cause cancer, birth defects and other reproductive harm. Defendant has not provided clear and reasonable warnings, within the meaning of Health & Safety Code Sections 25249.6 and 25249.11.
- 16. At all times relevant to this action, Defendant knew that the Leaded Brass
 Paintball Guns and Accessories it distributed or marketed was causing exposures to lead and lead
 compounds. Defendant intended that residents of California handle and use Leaded Brass
 Paintball Guns and Accessories in such ways as would lead to significant exposures to these
 chemicals.
- 17. By the above described acts, Defendant has violated Cal. Health & Safety Code § 25249.6 and is therefore subject to an injunction ordering it to stop violating Proposition 65, to provide warnings to all present and future customers and to provide warnings to its past customers who purchased Defendant's products without receiving a clear and reasonable warning.

SECOND CAUSE OF ACTION (Claim for Civil Penalties)

- 18. Plaintiff realleges and incorporates by reference into this Second Cause of Action, as if specifically set forth herein, paragraphs 1 through 17, inclusive.
- 19. By the above described acts, Defendant is liable and should be liable pursuant to Health & Safety Code § 25249.7(b), for a civil penalty of \$2,500.00 per day for each individual exposed without proper warning to lead and lead compounds from the handling or use of Defendant's Leaded Brass Paintball Guns and Accessories.

PRAYER FOR RELIEF

Wherefore, plaintiff prays for judgment against Defendant, as follows:

- 1. Pursuant to the First Cause of Action, that Defendant be enjoined, restrained, and ordered to comply with the provisions of Section 25249.6 of the California Health & Safety Code;
- 2. Pursuant to the Second Cause of Action, that Defendant be assessed a civil penalty in an amount equal to \$2,500.00 per day per individual exposed, in violation of Section 25249.6 of the California Health & Safety Code, to lead and lead compounds as the result of Defendant's distributing or marketing of Leaded Brass Paintball Guns and Accessories;
- 3. That Defendant be ordered to identify and locate each individual who purchased Leaded Brass Paintball Guns and Accessories and provide a warning to each such person that the Leaded Brass Paintball Guns and Accessories the person purchased will expose that person to chemicals known to cause birth defects.
- 4. That, pursuant to Civil Procedure Code § 1021.5, Defendant be ordered to pay to Plaintiff the attorneys fees and costs it incurred in bringing this enforcement action.
 - 5. For such other relief as this court deems just and proper.

Greetings:

This office and the Mateel Environmental Justice Foundation ("Mateel") give you notice that the private businesses on the attached service list have been, are, will be and threaten to be in violation of Cal. Health & Safety Code § 25249.6. Both this office and Mateel are private enforcers of Proposition 65, both may be contacted at the below-listed address and telephone number, and I am a responsible individual at both Mateel and this office. The above referenced violations occur when California residents come into contact with products that are made of, or that incorporate parts made of, brass and/or bronze, including valves (including the valve handles) and connector hoses with brass fittings that are associated with propane (or other compressed gas) tanks, (collectively "brass products"). A list of examples of the specific types of products at issue is attached. Though the products on the attached list are listed with a product number or SKU, this notice pertains to all products of the same specific type, not just to those products, the specific numbers for which are listed in the product list. The brass products are made in whole, or in part, from leaded brass, which contains lead and lead compounds ("lead"), which are chemicals known to cause cancer, birth defects and other reproductive harm. California residents are exposed to lead whenever they handle these brass products, such as when buying them, when handling them, or when using them. Lead is transferred from the brass products to their hands and to other parts of their skin. This lead is then absorbed through the skin, taken into cuts and abrasions, absorbed through mucous membranes, and transferred from the skin to the mouth via oral contact either directly with the lead-contaminated skin, and when lead is transferred from contaminated skin to cigarettes and food and the contaminated cigarettes and food are smoked and/or eaten. These lead exposures thus occur via the dermal absorption, subcutaneous, mucous membrane, ingestion and inhalation routes. The listed businesses did not and do not provide people with clear and reasonable warnings before they expose them to lead. These violations have occurred every day since at least December 23, 2006, and will continue every day until the lead is removed from the brass products, or until clear and reasonable warnings are given. The above-referenced violations are alleged for occupational exposures as well as for consumer and environmental exposures. We do not, however, allege occupational exposure violations as to any brass products made outside of California, except as to workplaces these companies themselves maintain in California. Exposures constituting Proposition 65 environmental exposure violations occur both on and off the companies' property and in each of California's 58 counties.
