20 Plaintiff Environmental Research Center hereby alleges:

21 **I**

22 **INTRODUCTION**

23
24
25 1. Plaintiff Environmental Research Center (hereinafter "Plaintiff" or "ERC") brings this
26 action as a private attorney general and in the public interest pursuant to Health & Safety Code
27 Section 25249.7 (d). This complaint seeks civil penalties to remedy Defendant's failure to warn
28

1 users of certain products sold by the company that they have been exposed to lead, a chemical
2 known to the State of California to cause cancer, birth defects and other reproductive harm. Based
3 on the Safe Drinking Water and Toxic Enforcement Act of 1986 (Health & Safety Code Section
4 25249.5 et seq) also known as "Proposition 65," businesses with ten or more employees must
5 provide a "clear and reasonable warning" prior to exposing persons to these chemicals.

8 **II**
9 **PARTIES**

10 2. Plaintiff ERC is a California non-profit corporation dedicated to, among other causes, helping
11 safeguard the public from health hazards by bringing about a reduction in the use and misuse of
12 hazardous and toxic chemicals, facilitating a safe environment for consumers and employees and
13 encouraging corporate responsibility.

14 3. Defendant is a business that manufactures, distributes and/or sells nutritional products that
15 have exposed users of the Covered Products to lead in the State of California within the relevant
16 statute of limitations period. These products are: Ardyss Life Nocol; Ardyss Life Collaffee Life;
17 Ardyss Life Ultra Body Cleanse Plus; Ardyss NutriShake Vanilla Flavor; Ardyss Thermogen Plus
18 Natural Herbal Tea; Ardyss Weight Control AM; and Ardyss Weight Control PM. Collectively,
19 the products in this paragraph are referred to as "Covered Products." Ardyss is a company that
20 employs ten or more persons.
21

22 4. Defendants Does I-100, are named herein under fictitious names, as their true names and
23 capacities are unknown to Plaintiff. ERC is informed and believes, and thereon alleges, that each
24 of said Does is responsible, in some actionable manner, for the events and happenings hereinafter
25 referred to, either through said Defendant's conduct, or through the conduct of its agents, servants or
26 employees, or in some other manner, causing the harms alleged by ERC in this complaint. When

1 said true names and capacities of Does are ascertained, ERC will seek leave to amend this complaint
2 to set forth the same.

5 JURISDICTION AND VENUE

6 5. This Court has jurisdiction pursuant to California Constitution Article VI, Section 10 because
7 this case is a cause not given by statute to other trial courts.
8

9 6. The Complaint is based on allegations contained in Notices of Violation dated November
10 23, 2010 and December 23, 2010 served on the California Attorney General, other public
11 enforcers and Ardyss. A true and correct copy of these Notices of Violations is attached hereto
12 as Exhibit A. A Notice of Violation dated June 29, 2010 naming the products Ardyss Life
13 Nocol, Ardyss Life Collaffee Life and Ardyss Life Ultra Body Cleanse Plus was withdrawn on
14 November 23, 2010. These three products were again noticed in the November 23, 2010 Notice
15 of Violation. More than 60 days have passed since these Notices of Violation were mailed and
16 no public enforcement entity has filed a complaint in this case.
17

18 7. This Court is the proper venue for the action because the causes of action have arisen in San
19 Francisco where some of the violations of law have occurred. Furthermore, this Court is the proper
20 venue under Code of Civil Procedure Section 395.5 and Health & Safety Code Section 25249.7.

23 STATUTORY BACKGROUND

24 A. Proposition 65

25 8. The Safe Drinking Water and Toxic Enforcement Act of 1986 is an initiative statute passed as
26 "Proposition 65" by an overwhelming majority vote of the people in November of 1986.
27
28

1 9. The warning requirement of Proposition 65 is contained in Health & Safety Code Section
2 25249.6, which provides:

3
4 No person in the course of doing business shall knowingly and intentionally expose any
5 individual to a chemical known to the state to cause cancer or reproductive toxicity without first
6 giving clear and reasonable warning to such individual, except as provided in Section 25249.10.

7 10. Implementing regulations for Proposition 65 provide that warnings are required for consumer
8 product exposures. A "consumer product exposure is an exposure which results from a person's
9 acquisition, purchase, storage, consumption, or other reasonably foreseeable use of a consumer
10 good, or any exposure that results from receiving a consumer service." 27 CCR Section 25601 (b).

11 11. Whenever a clear and reasonable warning is required under Health & Safety Code Section
12 25249.6, the "method employed to transmit the warning must be reasonably calculated considering
13 the alternative methods available under the circumstances, to make the warning message available
14 prior to exposure." 27 CCR Section 25601. The warning requirement may be satisfied by a
15 warning that appears on a product's label or other labeling, shelf labeling, signs, a system of signs,
16 public advertising identifying the system and toll-free information services, or any other, system,
17 that provides clear and reasonable warnings. *Id.*, Section 25603.1 (a) – (d).

18
19 12. Proposition 65 establishes a procedure by which the State is to develop a list of
20 chemicals "known to the State to cause cancer or reproductive toxicity." Health & Safety Code
21 Section 25249.8. There is no duty to provide a clear and reasonable warning until 12-months after
22 the chemical was published on the State list. *Id.*, Section 25249.10 (b). Lead was listed as a
23 chemical known to the State of California to cause developmental toxicity and male and female
24 reproductive toxicity on February 27, 1987. Lead was listed as a chemical known to the State of
25 California to cause cancer on October 1, 1992. Title 27, Cal. Code Regs., Section 27001.

26
27
28 13. Proposition 65 may be enforced by any person in the public interest who provides notice

1 sixty days before filing suit to both the violator and designated law enforcement officials. The
2 failure of law enforcement officials to file a timely complaint enables a citizen suit to be filed
3 pursuant to Health & Safety Code Section 25249.7 (c).
4

5 14. Proposition 65 provides that any person "violating or threatening to violate" Proposition 65
6 may be enjoined in any court of competent jurisdiction. Health & Safety Code Section 25249.7 (a).
7 To "threaten to violate" means "to create a condition in which there is a substantial probability that a
8 violation will occur." Id., Section 25249.11 (e). Furthermore, violators are subject to a civil penalty
9 of up to \$2,500 per day for each violation. Id., Section 25249.7 (b).
10

12 **STATEMENT OF FACTS**

13 15. Defendant has manufactured, distributed and/or sold the Covered Products containing
14 lead to the State of California. Consumers have been ingesting these products for many years,
15 without any knowledge of their exposure to lead, a very dangerous chemical.
16

17 16. For many years, Defendant has knowingly and intentionally exposed numerous persons to
18 lead, without providing a Proposition 65 warning. Prior to ERC's Notice of Violations, Defendant
19 failed to provide a warning on the label of the Covered Products, nor was there any mention on
20 Defendant's website that the products contain lead. Defendant has at all times relevant hereto been
21 aware that the Covered Products contained lead and that persons using these products have been
22 exposed to the chemical. The Covered Products are systematically tested for heavy metals,
23 including lead. Defendant receives considerable information about the raw materials used in the
24 Covered Products from their supplier. Defendant's website represents to the public that they strive
25 to maximize people's health and wellness. While aware of the lead in their products, Defendant
26 has concealed this fact from the public, who undoubtedly believed they have been ingesting totally
27
28

1 healthy and pure products. Defendant has marketed the Covered Products with knowledge that
2 consumers have been exposed to lead during normal use of the products.
3

4 17. Prior to ERC's Notices of Violation, Defendant failed to provide consumers of the Covered
5 Products with a clear and reasonable warning that they have been exposed to a chemical known to
6 the State of California to cause cancer, birth defects and other reproductive harm.

7 **FIRST CAUSE OF ACTION**

8 **(Violation of Section 25249.6 of the Health and Safety Code, Failure to Provide Clear**
9 **and Reasonable Warning under Proposition 65)**

10 18. Defendant refers to paragraphs 1-17, inclusive, and incorporates them herein by this
11 reference.

12 19. By committing the acts alleged above, Defendant has, in the course of doing business,
13 knowingly and intentionally exposed users of the Covered Products to lead, a chemical known to
14 the State of California to cause cancer, birth defects and other reproductive harm without first giving
15 clear and reasonable warning to such individuals, within the meaning of Health & Safety Code
16 Section 25249.6.
17

18 20. Said violations render Defendant liable for civil penalties up to \$2,500 (two thousand,
19 five hundred dollars) per day, for each violation.
20

21 **VI**

22 **PRAYER**

23 WHEREFORE ERC prays for relief as follows:
24

25 1. On the First Cause of Action, for civil penalties for each and every violation according to
26 proof;


27 2. for reasonable attorneys' fees pursuant to Section 1021.5 of the Code of Civil Procedure or
28 the substantial benefit theory;

1 3. For costs of suit herein; and

2 4. For such other relief as the Court may deem just and proper.

I am the Executive Director of the Environmental Research Center ("ERC") in connection with this Notice of Violations of California's Safe Drinking Water and Toxic Enforcement Act of 1986, which is codified at California Health & Safety Code Section 25249.5 *et seq.* and also referred to as Proposition 65.

ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

The name of the Company covered by this Notice that violated Proposition 65 is:

The products that are the subject of this Notice and the chemical in those products identified as exceeding allowable levels are:

Ardyss Nocol - Lead
Ardyss Collafee - Lead
Ultra Body Cleanse Plus - Lead
Ardyss NutriShake Vanilla Flavor - Lead
Ardyss Thermogen Plus Natural Herbal Tea - Lead
Ardyss Weight Control AM - Lead
Ardyss Weight Control PM - Lead

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead as chemical known to cause cancer.

This letter is a Notice to Ardyss International, Inc.; Ardyss International Canada Corp.; Ardyss International; and the appropriate governmental authorities of the Proposition 65 violations concerning the listed products. This Notice covers all violations of Proposition 65 involving Ardyss International, Inc.; Ardyss International Canada Corp.; Ardyss International; and currently known to ERC from the information now available. ERC may continue to investigate other products that may reveal further violations. A summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, has been provided to the Noticed Company with a copy of this letter.

Ardyss International, Inc.; Ardyss International Canada Corp.; and Ardyss International have manufactured, marketed, distributed, and/or sold the listed products, which have exposed and continue to expose numerous individuals within California to the identified chemicals. The primary route of exposure to these chemicals has been through ingestion, but may have also occurred through inhalation and/or dermal contact. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemicals. The method of warning should be a warning that appears on the product's label. Ardyss International, Inc.; Ardyss International Canada Corp.; and Ardyss International violated Proposition 65 because the Companies have failed to provide an appropriate warning to persons using these products that they are being exposed to the identified chemical.



Pursuant to Section 25249.7(d) of the statute, ERC intends to file a citizen enforcement action sixty days after effective service of this Notice unless Ardyss International, Inc.; Ardyss International Canada Corp.; and Ardyss International agree in an enforceable written instrument to: (1) reformulate the listed products so as to eliminate further exposures to the identified chemicals; and (2) pay an appropriate civil penalty. Consistent with the public interest goals of Proposition 65 and ERC's objectives in pursuing this Notice, ERC is interested in seeking a constructive resolution to this matter. Such resolution will avoid both further unwarned consumer exposures to the identified chemicals and expensive and time consuming litigation.



I am the Executive Director of the Environmental Research Center ("ERC") in connection with this Notice of Violations of California's Safe Drinking Water and Toxic Enforcement Act of 1986, which is codified at California Health & Safety Code Section 25249.5 *et seq.* and also referred to as Proposition 65.

ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

The name of the Company covered by this Notice that violated Proposition 65 is:

Ardyss International, Inc.
Ardyss International Canada Corp.
Ardyss International

The product that is the subject of this Notice and the chemical in that product identified as exceeding allowable levels is:

Ardyss Top Fiber Apple/Berry Flavor 450 g - Lead

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead as chemical known to cause cancer.

This letter is a Notice to Ardyss International, Inc.; Ardyss International Canada Corp.; Ardyss International; and the appropriate governmental authorities of the Proposition 65 violations concerning the listed products. This Notice covers all violations of Proposition 65 involving Ardyss International, Inc.; Ardyss International Canada Corp.; Ardyss International; and currently known to ERC from the information now available. ERC may continue to investigate other products that may reveal further violations. A summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, has been provided to the Noticed Company with a copy of this letter.

Ardyss International, Inc.; Ardyss International Canada Corp.; and Ardyss International have manufactured, marketed, distributed, and/or sold the listed products, which have exposed and continue to expose numerous individuals within California to the identified chemicals. The primary route of exposure to these chemicals has been through ingestion, but may have also occurred through inhalation and/or dermal contact. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemicals. The method of warning should be a warning that appears on the product's label. Ardyss International, Inc.; Ardyss International Canada Corp.; and Ardyss International violated Proposition 65 because the Companies have failed to provide an appropriate warning to persons using these products that they are being exposed to the identified chemical.

Pursuant to Section 25249.7(d) of the statute, ERC intends to file a citizen enforcement action sixty days after effective service of this Notice unless Ardyss International, Inc.; Ardyss International Canada Corp.; and Ardyss International agree in an enforceable written instrument to: (1) reformulate the listed products so as to eliminate further exposures to the identified chemicals; and (2) pay an appropriate civil penalty. Consistent with the public interest goals of Proposition 65 and ERC's objectives in pursuing this Notice, ERC is interested






