If you cannot pay the filing fee, ask the court clerk for a fee waiver form. If you do not file your response on time, you may lose the case by default, and your wages, money, and property may be taken without further warning from the court.

There are other legal requirements. You may want to call an attorney right away. If you do not know an attorney, you may want to call an attorney referral service. If you cannot afford an attorney, you may be eligible for free legal services from a nonprofit legal services program. You can locate these nonprofit groups at the California Legal Services Web site (www.lawhelpcalifornia.org), the California Courts Online Self-Help Center (www.courtinfo.ca.gov/selfhelp), or by contacting your local court or county bar association. **NOTE:** The court has a statutory lien for waived fees and costs on any settlement or arbitration award of \$10,000 or more in a civil case. 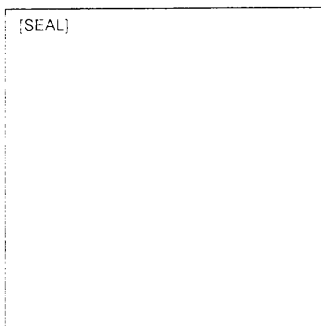

24 **NATURE OF THE ACTION**

25 1. This Complaint is a representative action brought by plaintiff Evelyn Wimberley,
26 in the public interest of the citizens of the State of California, to enforce the people's right to be
27 informed of the presence of lead, a toxic chemical found in Allstar Products Group, LLC Mister
28 Steamy sold in California.

1 2. By this Complaint, plaintiff seeks to remedy defendants' continuing failures to
2 warn California citizens about their exposure to lead present in or on certain Mister Steamy
3 products that defendants manufacture, distribute and/or offer for sale to consumers throughout
4 the State of California.

5 3. High levels of lead are commonly found in Mister Steamy that defendants
6 manufacture, distribute and/or offer for sale to consumers throughout the State of California.

7 4. Under California's Safe Drinking Water and Toxic Enforcement Act of 1986,
8 California Health & Safety Code § 25249.6 et seq. (Proposition 65), "No person in the course of
9 doing business shall knowingly and intentionally expose any individual to a chemical known to
10 the state to cause cancer or reproductive toxicity without first giving clear and reasonable
11 warning to such individual..." (*Cal. Health & Safety Code § 25249.6.*)

12 5. California identified and listed Lead as a chemical known to cause birth defects
13 and other reproductive harm. Lead became subject to the warning requirements of Proposition 65
14 for developmental toxicity beginning on February 27, 1987 and for cancer toxicity on October 1,
15 1992. (*27 CCR § 27002; Cal. Health & Safety Code § 25249.6.*)

16 6. Lead shall hereinafter be referred to as the "LISTED CHEMICAL."

17 7. Defendants manufacture, distribute and/or sell Mister Steamy containing
18 excessive levels of the LISTED CHEMICAL including, but not limited to, Mister Steamy (UPC#
19 7 4027500301 5). All such Mister Steamy's containing the LISTED CHEMICAL shall hereinafter be
20 referred to as the "PRODUCTS."

21 8. Defendants' failures to warn consumers and/or other individuals in the State of
22 California about their exposure to the LISTED CHEMICAL in conjunction with defendant's
23 sale of the PRODUCTS is a violation of Proposition 65 and subjects defendants to enjoinder of
24 such conduct as well as civil penalties for each such violation.

25 9. For defendants' violations of Proposition 65, plaintiff seeks preliminary
26 injunctive and permanent injunctive relief to compel defendants to provide purchasers or users of
27 the PRODUCTS with the required warning regarding the health hazards of the LISTED
28 CHEMICAL. (*Cal. Health & Safety Code § 25249.7(a).*)

1 19. The California Superior Court has jurisdiction over DEFENDANTS based on
2 plaintiff's information and good faith belief that each defendant is a person, firm, corporation or
3 association that either are citizens of the State of California, have sufficient minimum contacts in
4 the State of California, or otherwise purposefully avail themselves of the California market.
5 DEFENDANTS' purposeful availment renders the exercise of personal jurisdiction by California
6 courts consistent with traditional notions of fair play and substantial justice.

7 **FIRST CAUSE OF ACTION**

8 **(Violation of Proposition 65 – Against Defendant)**

9 20. Plaintiff realleges and incorporates by reference, as if full reference, as if full set
10 forth herein, Paragraphs 1 through 18, inclusive.

11 21. The citizens of the State of California have expressly stated in the Safe Drinking
12 Water and Toxic Enforcement Act of 1986, California Health & Safety Code § 25249.5, et seq.
13 (Proposition 65) that they must be informed “about exposures to chemicals that cause cancer,
14 birth defects and order reproductive harm.” (*Cal. Health & Safety Code § 25249.6.*)

15 22. Proposition 65 states, “No person in the course of doing business shall knowingly
16 and intentionally expose any individual to a chemical known to the state to cause cancer or
17 productive toxicity without first giving clear and reasonable warning to such individual...
18 (*Id.*)”

19 23. On January 24, 2011 a sixty-day notice violation, together with the requisite
20 certificate of merit, was provided to DEFENDANTS., and various public enforcement agencies
21 stating that as a result of the DEFENDANTS' sales of the PRODUCTS, purchasers and users in
22 the State of California were being exposed to the LISTED CHEMICAL resulting from the
23 reasonably foreseeable users of the PRODUCTS, without the individual purchasers and users
24 first having been provided with a “clear and reasonable warning” regarding such toxic exposures.

25 24. DEFENDANTS have engaged in the manufacture, distribution and/or offering of
26 the PRODUCTS for sale or use in violation of California Health & Safety Code § 25249.6 and
27 DEFENDANTS' manufacture, distribution and/or offering of the PRODUCTS for sale or use in
28 violation of California Health & Safety Code § 25249.6 has continued to occur beyond

1 DEFENDANTS' receipt of plaintiff's sixty-day notice of violation. Plaintiff further alleges and
2 believes that such violations will continue to occur into the future.

3 25. After receipt of the claims asserted in the sixty-day notices of violation, the
4 appropriate public enforcement agencies have failed to commence and diligently prosecute a
5 cause of action against DEFENDANTS under Proposition 65.

6 26. The PRODUCTS manufactured, distributed, and/or offered for sale or use in
7 California by DEFENDANTS contained the LISTED CHEMICAL above the allowable state
8 limits.

9 27. DEFENDANTS knew or should have known that the PRODUCTS manufactured,
10 distributed, and/or for sale or use by DEFENDANTS in California contained the LISTED
11 CHEMICAL.

12 28. The LISTED CHEMICAL was present in or on the PRODUCTS in such away as
13 to expose individuals to the LISTED CHEMICAL through dermal contact, hand to mouth
14 contact, and/or ingestion etc. during the reasonably foreseeable use of the PRODUCTS.

15 29. The normal and reasonably foreseeable use of he PRODUCTS has caused and
16 continues to cause consumer exposures to the LISTED CHEMICAL, as such exposure is defined
17 by 27 CCR§ 25602(b).

18 30. DEFENDANTS had knowledge that the normal and reasonably foreseeable use of
19 the PRODUCTS would expose individuals to the LISTED CHEMICAL through dermal contact,
20 hand to mouth contact and/or ingestion.

21 31. DEFENDANTS intended that such exposures to the LISTED CHEMICAL from
22 the reasonably foreseeable use of the PRODUCTS would occur by their deliberate, non-
23 accidental participation in the manufacture, distribution and/or offer for sale or use of
24 PRODUCTS to individuals in the State of California.

25 32. DEFENDANTS failed to provide a "clear and reasonable warning" to those
26 consumers and/or other individuals in the State of California who were or who could become
27 exposed to the LISTED CHEMICAL through dermal contact and/or ingestion during the
28 reasonably foreseeable use of the PRODUCTS.


