19 Plaintiff Environmental Research Center hereby alleges:

20 **I**

21 **INTRODUCTION**

22
23 1. Plaintiff Environmental Research Center (hereinafter "Plaintiff" or "ERC") brings this
24 action as a private attorney general enforcer and in the public interest pursuant to Health & Safety
25 Code section 25249.7, subdivision (d). This complaint seeks injunctive and declaratory relief and
26 civil penalties to remedy Defendant TriMedica International, Inc. and Does 1-100 (hereinafter
27 "TriMedica")'s failure to warn consumers that they have been exposed to lead from several of
28 TriMedica's nutritional health products. Lead is a chemical known to the State of California to

1 cause cancer, birth defects and other reproductive harm. Based on the Safe Drinking Water and
2 Toxic Enforcement Act of 1986 (Health & Safety Code section 25249.5 *et seq.*) also known as
3 “Proposition 65,” businesses with ten or more employees must provide a “clear and reasonable
4 warning” prior to exposing persons to these chemicals.

5 II

6 PARTIES

7 2. Plaintiff ERC is a California non-profit corporation dedicated to, among other causes,
8 helping safeguard the public from health hazards by reducing the use and misuse of hazardous and
9 toxic chemicals, facilitating a safe environment for consumers and employees and encouraging
10 corporate responsibility.

11 3. Defendant TriMedica is a business that distributes and/or sells nutritional health products
12 that have exposed users to lead in the State of California within the relevant statute of limitations
13 period. These “Covered Products” are TriMedica Inc. Testostro Plus, and TriMedica Inc. Alkaline
14 Greens Contains AlkaMax. TriMedica is a company subject to Proposition 65 as it employs ten or
15 more persons.

16 4. Defendants Does 1-100, are named herein under fictitious names, as their true names and
17 capacities are unknown to ERC. ERC is informed and believes, and thereon alleges, that each of
18 said Does is responsible, in some actionable manner, for the events and happenings hereinafter
19 referred to, either through said Defendant’s conduct, or through the conduct of its agents, servants or
20 employees, or in some other manner, causing the harms alleged by ERC in this complaint. When
21 said true names and capacities of Does are ascertained, ERC will seek leave to amend this complaint
22 to set forth the same.

23 III

24 JURISDICTION AND VENUE

25 5. This Court has jurisdiction pursuant to California Constitution Article VI, Section 10
26 because this case is a cause not given by statute to other trial courts.

27 6. The Complaint is based on allegations contained in a Notice of Violation dated
28 November 30, 2012, served on the California Attorney General and other public enforcers and a

1 Notice of Violation dated January 18, 2013, served on TriMedica. A true and correct copy of
2 the Notices of Violation is attached as Exhibit A. More than 60 days have passed since the
3 Notice of Violation was mailed and no public enforcement entity has filed a complaint in this
4 case.

5 7. This Court is the proper venue for the action because the causes of action have arisen in
6 the County of Alameda where some of the violations of law have occurred. Furthermore, this Court
7 is the proper venue under Code of Civil Procedure section 395.5 and Health & Safety Code section
8 25249.7.

9 IV

10 STATUTORY BACKGROUND

11 A. Proposition 65

12 8. The Safe Drinking Water and Toxic Enforcement Act of 1986 is an initiative statute
13 passed as “Proposition 65” by an overwhelming majority vote of the people in November of 1986.

14 9. The warning requirement of Proposition 65 is contained in Health & Safety Code section
15 25249.6, which provides:

16 No person in the course of doing business shall knowingly and intentionally expose
17 any individual to a chemical known to the state to cause cancer or reproductive
18 toxicity without first giving clear and reasonable warning to such individual, except
as provided in Section 25249.10.

19 10. Implementing regulations for Proposition 65 define expose as “to cause to ingest,
20 inhale, contact via body surfaces or otherwise come into contact with a listed chemical.” An
21 individual may come into contact with a listed chemical through water, air, food, consumer products
22 and any other environmental exposure as well as occupational exposures.” (Cal. Code Regs., tit. 27,
23 § 25102, subd. (i).)

24 11. In this case, the exposures at issue are caused by consumer products. Implementing
25 regulations for Proposition 65 define a consumer product exposure as “ an exposure which results
26 from a person’s acquisition, purchase, storage, consumption, or other reasonably foreseeable use of
27 a consumer good, or any exposure that results from receiving a consumer service.” (Cal. Code
28 Regs., tit. 27, § 25602, subd. (b).)

1 12. Whenever a clear and reasonable warning is required under Health & Safety Code
2 section 25249.6, the “method employed to transmit the warning must be reasonably calculated
3 considering the alternative methods available under the circumstances, to make the warning
4 message available prior to exposure.” (Cal. Code Regs., tit. 27, § 25601.) The warning requirement
5 may be satisfied by a warning that appears on a product’s label or other labeling, shelf labeling,
6 signs, a system of signs, public advertising identifying the system and toll-free information services,
7 or any other, system, that provides clear and reasonable warnings. (Cal. Code Regs., tit. 27, §
8 25603.1, subd. (a)-(d).)

9 13. Proposition 65 establishes a procedure by which the State is to develop a list of
10 chemicals “known to the State to cause cancer or reproductive toxicity.” (Health & Safety Code,
11 § 25249.8.) There is no duty to provide a clear and reasonable warning until 12-months after the
12 chemical was published on the State list. (Health & Safety Code, § 25249.10, subd. (b).) Lead
13 was listed as a chemical known to the State of California to cause developmental toxicity in the
14 fetus and male and female reproductive toxicity on February 27, 1987. Lead was listed as a
15 chemical known to the State of California to cause cancer on October 1, 1992. (Cal. Code Regs., tit.
16 27, § 27001.)

17 14. The Maximum Allowable Dose Level for lead as a chemical known to cause
18 reproductive toxicity is 0.5 micrograms per day. (Cal. Code Regs., tit. 27, § 25805.) The No
19 Significant Risk Level for lead as a carcinogen is 15 micrograms per day. (Cal. Code Regs., tit.
20 27, § 25705.)

21 15. Proposition 65 may be enforced by any person in the public interest who provides
22 notice sixty days before filing suit to both the violator and designated law enforcement officials.
23 The failure of law enforcement officials to file a timely complaint enables a citizen suit to be filed
24 pursuant to Health & Safety Code section 25249.7, subdivisions (c) and (d).

25 16. Proposition 65 provides that any person “violating or threatening to violate” Proposition
26 65 may be enjoined in any court of competent jurisdiction. (Health & Safety Code, § 25249.7,
27 subd. (a).) To “threaten to violate” means “to create a condition in which there is a substantial
28 probability that a violation will occur.” (Health & Safety Code, § 25249.11, subd. (e).)

1 Furthermore, violators are subject to a civil penalty of up to \$2,500 per day for each violation.
2 (Health & Safety Code, § 25249.7, subd. (b)(1).

3 V

4 **STATEMENT OF FACTS**

5 17. TriMedica has distributed and/or sold the Covered Products containing lead into the
6 State of California. Consumers have been ingesting these products for many years, without any
7 knowledge of their exposure to lead, a very dangerous chemical.

8 18. For many years, TriMedica has knowingly and intentionally exposed numerous persons
9 to lead. TriMedica has at all times relevant hereto been aware that the Covered Products contained
10 lead and that persons using these products have been exposed to the chemical.

11 19. TriMedica has been aware of the lead in the Covered Products and has failed to disclose
12 the presence of this chemical to the public, who undoubtedly believed they have been ingesting
13 totally healthy and pure products. Both prior and subsequent to ERC's Notice of Violation,
14 TriMedica failed to provide consumers of the Covered Products with a warning that they have been
15 exposed to a chemical known to the State of California to cause cancer, birth defects and other
16 reproductive harm.

17 **FIRST CAUSE OF ACTION**

18 **(Violation of Section 25249.6 of the Health and Safety Code, Failure to Provide Clear**
19 **and Reasonable Warning under Proposition 65)**

20 20. ERC refers to paragraphs 1-19, inclusive, and incorporates them herein by this
21 reference.

22 21. By committing the acts alleged above, TriMedica has, in the course of doing business,
23 knowingly and intentionally exposed users of the Covered Products to lead, a chemical known to
24 the State of California to cause cancer, birth defects and other reproductive harm without first giving
25 clear and reasonable warning to such individuals, within the meaning of Health & Safety Code
26 section 25249.6.

27 22. Said violations render TriMedica liable for civil penalties up to \$2,500 per day, for
28 each violation.

1 **SECOND CAUSE OF ACTION**

2 **(Declaratory Relief)**

3 23. ERC refers to paragraphs 1-22, inclusive, and incorporates them herein by this
4 reference.

5 24. There exists an actual controversy relating to the legal rights and duties of the parties,
6 within the meaning of Code of Civil Procedure section 1060, between ERC and TriMedica
7 concerning whether TriMedica has exposed individuals to a chemical known to the State of
8 California to cause cancer, birth defects and other reproductive harm without providing clear and
9 reasonable warning.

10 **VI**

11 **PRAYER**

12 WHEREFORE ERC prays for relief as follows:

13 1. On the First Cause of Action, for civil penalties for each and every violation according to
14 proof;

15 2. On the First Cause of Action, and pursuant to Health & Safety Code section 25249.7,
16 subdivision (a), for such temporary restraining orders, preliminary and permanent injunctive orders,
17 or other orders, prohibiting TriMedica from exposing persons to lead without providing clear and
18 reasonable warning;

19 3. On the Second Cause of Action, for a declaratory judgment pursuant to Code of Civil
20 Procedure section 1060 declaring that TriMedica has exposed individuals to a chemical known to
21 the State of California to cause, birth defects and other reproductive harm without providing clear
22 and reasonable warning; and


23 4. On all Causes of Action, for reasonable attorneys' fees pursuant to section 1021.5 of the
24 Code of Civil Procedure or the substantial benefit theory;

25 5. For costs of suit herein; and

26 6. For such other relief as the Court may deem just and proper.

NOTICE OF VIOLATIONS OF CALIFORNIA HEALTH & SAFETY CODE SECTION 25249.5 *ET SEQ.* (PROPOSITION 65)

Dear Alleged Violator and the Appropriate Public Enforcement Agencies:

I am the Executive Director of the Environmental Research Center (“ERC”). ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California’s Safe Drinking Water and Toxic Enforcement Act of 1986 (“Proposition 65”), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the products identified below. These violations have occurred and continue to occur because the alleged Violator identified below failed to provide required clear and reasonable warnings with these products. This letter serves as a notice of these violations to the alleged Violator and the appropriate public enforcement agencies. Pursuant to Section 25249.7(d) of the statute, ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

General Information about Proposition 65. A copy of a summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is an attachment with the copy of this letter served to the alleged Violator identified below.

Alleged Violator. The name of the company covered by this notice that violated Proposition 65 (hereinafter collectively referred to as “the Violator”) is:

TriMedica International, Inc.

Consumer Products and Listed Chemicals. The products that are the subject of this notice and the chemical in that product identified as exceeding allowable levels are:

TriMedica Inc. Testostro Plus – Lead

TriMedica Inc. Alkaline Greens Contains AlkaMax - Lead

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.

Route of Exposure. The consumer exposures that are the subject of this notice result from the purchase, acquisition, handling and recommended use of these products. Consequently, the primary route of exposure to these chemicals has been and continues to be through ingestion, but may have also occurred and may continue to occur through inhalation and/or dermal contact.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least November 30, 2009, as well as every day since the products were introduced into the California marketplace, and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until these known toxic chemicals are either removed from or reduced to allowable levels in the products. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemicals. The method of warning should be a warning that appears on the product label. The Violator violated Proposition 65 because it failed to provide persons handling and/or using these products with appropriate warnings that they are being exposed to these chemicals.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violator to: (1) reformulate the identified products so as to eliminate further exposures to the identified chemicals, or provide appropriate warnings on the labels of these products; and (2) pay an appropriate civil penalty. Such a resolution will prevent further unwarned consumer exposures to the identified chemicals, as well as an expensive and time consuming litigation.

The copy of this Certificate of Merit served on the Attorney General attaches to it factual information sufficient to establish the basis for this certificate, including the information identified in Health and Safety Code section 25249.7(h)(2), i.e., (1) the identity of the persons consulted with and relied on by the certifier, and (2) the facts, studies, or other data reviewed by those persons.

Dear Alleged Violator and the Appropriate Public Enforcement Agencies:

I am the Executive Director of the Environmental Research Center (“ERC”). ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California’s Safe Drinking Water and Toxic Enforcement Act of 1986 (“Proposition 65”), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the products identified below. These violations have occurred and continue to occur because the alleged Violator identified below failed to provide required clear and reasonable warnings with these products. This letter serves as a notice of these violations to the alleged Violator and the appropriate public enforcement agencies. Pursuant to Section 25249.7(d) of the statute, ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

General Information about Proposition 65. A copy of a summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is attached with the copy of this letter served to the alleged Violator identified below.

Alleged Violator. The name of the company covered by this notice that violated Proposition 65 (hereinafter referred to as “the Violator”) is:

TriMedica International, Inc.

Exhibit A

Consumer Products and Listed Chemicals. The products that are the subject of this notice and the chemical in that product identified as exceeding allowable levels are:

TriMedica Inc. Testostro Plus – Lead

TriMedica Inc. Alkaline Greens Contains AlkaMax - Lead

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.

Route of Exposure. The consumer exposures that are the subject of this notice result from the purchase, acquisition, handling and recommended use of these products. Consequently, the primary route of exposure to these chemicals has been and continues to be through ingestion, but may have also occurred and may continue to occur through inhalation and/or dermal contact.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least November 30, 2009, as well as every day since the products were introduced into the California marketplace, and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until these known toxic chemicals are either removed from or reduced to allowable levels in the products. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemicals. The method of warning should be a warning that appears on the product label. The Violator violated Proposition 65 because it failed to provide persons handling and/or using these products with appropriate warnings that they are being exposed to these chemicals.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violator to: (1) reformulate the identified products so as to eliminate further exposures to the identified chemicals, or provide appropriate warnings on the labels of these products; and (2) pay an appropriate civil penalty. Such a resolution will prevent further unwarned consumer exposures to the identified chemicals, as well as an expensive and time consuming litigation.
