

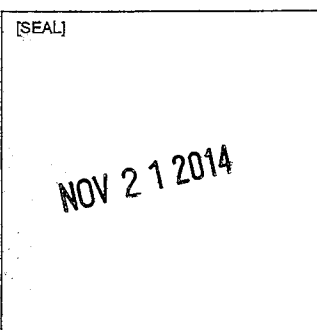

1 **INTRODUCTION**

2 1. This Complaint is brought by Plaintiff, ELISE ROSKOPF ("Plaintiff") in the
3 public interest of the citizens of the State of California, a representative action to enforce the
4 People's right to be informed of the presence of lead and lead compounds (collectively
5 "LEAD"), chemicals known to the State of California to cause cancer, birth defects, and other
6 reproductive harm, found in ceramic mugs with exterior decorations sold by Defendants.

7 2. The purpose of this Complaint is to remedy Defendants' continuing failure to
8 warn California residents about the risk of exposure to LEAD in the ceramic mugs with exterior
9 decorations manufactured, distributed, sold, and/or offered for sale to consumers in California.

10 3. Defendants have and continue to manufacture, distribute, sell, and/or offer to sell
11 ceramic mugs with exterior decorations containing dangerous levels of LEAD, including,
12 without limitation the "Bntcl Wreathing" ceramic mug (104-3569738-3784). The products
13 described in this paragraph shall hereinafter be referred to as the "Products".

14 4. Children and adults are exposed to LEAD when they use, touch, handle, eat or
15 drink from the Products.

16 5. Hazardous levels of LEAD are found in the accessible surface areas of the
17 Products manufactured, distributed, sold, and/or offered for sale by Defendants to consumers in
18 California.

19 6. California Health and Safety Code section 25249.6 et seq. ("Proposition 65")
20 provides in pertinent part: "[n]o person in the course of doing business shall knowingly and
21 intentionally expose any individual to a chemical known to the state to cause cancer or
22 reproductive toxicity without first giving clear and reasonable warning to such individual..."

23 7. Studies repeatedly conclude that exposure to LEAD is hazardous to the health of
24 children and adults. Children are especially vulnerable to the toxic effects of LEAD.
25 Accordingly, California has listed LEAD as chemicals known to the state to cause cancer or
26 reproductive toxicity and therefore subject to Proposition 65 warning requirements.

27 8. Defendants have and continue to manufacture, distribute, sell, and/or offer to sell
28 the Products without the required warnings. Defendants' conduct violates the warning

1 requirements of Proposition 65.

2 **PARTIES**

3 9. Plaintiff is a citizen of the state of California who is dedicated to protecting the
4 environment, improving human health and the health of ecosystems, and supporting
5 environmentally sound practices. Plaintiff brings this action in the public interest pursuant to
6 California Health and Safety Code section 25249.7(d).

7 10. Defendant, WILLIAMS-SONOMA, INC. is a person in the course of doing
8 business within the meaning of California Health and Safety Code section 25249.11.
9 WILLIAMS-SONOMA, INC. manufactures, distributes, and/or sells the Products for sale and
10 use in California.

11 11. DOES 1 through 100 are each a person in the course of doing business within the
12 meaning of California Health and Safety Code section 25249.11. DOES 1 through 100
13 manufacture, distribute, and/or sell the Products for sale and use in California. The true names of
14 DOES 1 through 100 are unknown to Plaintiff at this time. When their identities are discovered,
15 Plaintiff's Complaint shall be amended to reflect their true names.

16 12. The defendant identified in paragraph 10, collectively with DOES 1 through 100,
17 shall be referred to herein as "Defendants".

18 **JURISDICTION AND VENUE**

19 13. This Court has jurisdiction over this action pursuant to California Health and
20 Safety Code section 25249.7, which allows enforcement in any court of competent jurisdiction,
21 and pursuant to California Constitution Article VI, Section 10, because this lawsuit is based on a
22 cause not given by statute to other trial courts.

23 14. This Court has jurisdiction over Defendants because each is a person, firm,
24 corporation, or association with sufficient minimum contacts in the State of California, or
25 otherwise purposefully avails itself to the California market as to render jurisdiction by the
26 California courts consistent with traditional notions of fair play and substantial justice.

27 15. Venue is proper is Los Angeles County Superior Court because one or more
28 occurrences of the wrongful conduct occurred, and continues to occur, in Los Angeles County,

1 and/or because Defendants conducted, and continue to conduct, business in this County with
2 respect to the Products.

3 **FIRST CAUSE OF ACTION**

4 **(Violations of Health & Safety Code Section 25249.6 et seq.)**

5 16. Plaintiff re-alleges and incorporates by reference, as if fully set forth herein,
6 Paragraphs 1 through 15, inclusive.

7 17. On April 11, 2014, a sixty-day notice of violation ("60-Day Notice"), along with a
8 Certificate of Merit, was provided to WILLIAMS-SONOMA, INC. and various public
9 enforcement agencies. In addition, on said date, in compliance with Health & Safety Code
10 section 25249.7(d), confidential factual information sufficient to establish the basis for the
11 Certificate of Merit was provided to the California Attorney General.

12 18. None of the public prosecutors with the authority to prosecute Proposition 65
13 violations has commenced and/or is diligently prosecuting the cause of action against Defendants
14 based on the claims asserted in Plaintiff's 60-Day Notice.

15 19. By placing the Products into the stream of commerce, each Defendant is a person
16 in the course of doing business within the meaning of Health & Safety Code section 25249.11.

17 20. Defendants knew and intended that consumers, including children, will eat and
18 drink from, use, touch or handle the Products.

19 21. Defendants knew or should have known that the Products contain LEAD.
20 Defendants, who are in the business of marketing consumer goods, also have constructive
21 knowledge that the Products contain LEAD from widespread media coverage concerning the
22 presence of LEAD in consumer goods, especially in ceramics, paints, and glazes made in China.

23 22. LEAD is a chemical listed by the State of California as known to cause cancer,
24 birth defects and other reproductive harm.

25 23. Defendants' Products contain sufficient quantities of LEAD such that consumers,
26 including children, who eat from, drink from, use, touch or handle the Products are exposed to
27 unsafe levels of LEAD. LEAD is present in the Products in such a way as to expose individuals
28 to LEAD, as exposure is defined by 27 CCR section 25602(b), through ingestion and/or dermal

1 contact during the reasonably foreseeable use of the Products.

2 24. Defendants knew or should have known that the reasonably foreseeable use of the
3 Products exposes individuals to LEAD through ingestion and/or dermal contact.

4 25. Defendants failed to provide a "clear and reasonable warning" to individuals in
5 the State of California who were or could become exposed to LEAD during the reasonably
6 foreseeable use of the Products.

7 26. By committing the acts alleged in this Complaint, Defendants have violated
8 California Health & Safety Code section 25249.6 et seq. by knowingly and intentionally
9 exposing individuals to LEAD without first giving clear and reasonable warning to such
10 individuals regarding the toxicity of LEAD.

11 27. As a result of Defendants' wrongful conduct, individuals in the State of California
12 have been exposed to LEAD through the ingestion and/or dermal contact during the reasonably
13 foreseeable use of the Products without a "clear and reasonable warning", and have suffered and
14 continue to suffer harm.

15 **PRAYER FOR RELIEF**

16 **WHEREFORE**, Plaintiff prays for judgment against Defendants as follows:

17 1. That the Court, pursuant to California Health & Safety Code section 25249.7(b),
18 assess civil penalties against Defendants in the amount of \$2,500 per day for each violation
19 alleged herein;

20 2. That the Court, pursuant to California Health & Safety Code section 25249.7(a),
21 preliminarily and permanently enjoin Defendants from manufacturing, distributing, or offering
22 the Products for sale in California without providing "clear and reasonable warnings" as defined
23 by 27 CCR section 25601;

24 3. That the Court, pursuant to California Health & Safety Code section 25249.7(a),
25 order Defendants to take action to stop ongoing unwarned exposures to LEAD resulting from use
26 of Products sold by Defendants;

27 4. That the Court, pursuant to California Code of Civil Procedure section 1021.5, or
28 any other applicable theory, grant Plaintiff's reasonable attorneys' fees and costs of suit; and

1 5. Such other and further relief as may be just and proper.

INSTRUCTIONS FOR HANDLING UNLIMITED CIVIL CASES

The following critical provisions of the Chapter Three Rules, as applicable in the Central District, are summarized for your assistance.

APPLICATION

The Chapter Three Rules were effective January 1, 1994. They apply to all general civil cases.

PRIORITY OVER OTHER RULES

The Chapter Three Rules shall have priority over all other Local Rules to the extent the others are inconsistent.

CHALLENGE TO ASSIGNED JUDGE

A challenge under Code of Civil Procedure section 170.6 must be made within **15** days after notice of assignment for all purposes to a judge, or if a party has not yet appeared, within 15 days of the first appearance.

TIME STANDARDS

Cases assigned to the Individual Calendaring Court will be subject to processing under the following time standards:

COMPLAINTS: All complaints shall be served within 60 days of filing and proof of service shall be filed within 90 days of filing.

CROSS-COMPLAINTS: Without leave of court first being obtained, no cross-complaint may be filed by any party after their answer is filed. Cross-complaints shall be served within 30 days of the filing date and a proof of service filed within 60 days of the filing date.

A Status Conference will be scheduled by the assigned Independent Calendar Judge no later than 270 days after the filing of the complaint. Counsel must be fully prepared to discuss the following issues: alternative dispute resolution, bifurcation, settlement, trial date, and expert witnesses.

FINAL STATUS CONFERENCE

The Court will require the parties at a status conference not more than 10 days before the trial to have timely filed and served all motions in limine, bifurcation motions, statements of major evidentiary issues, dispositive motions, requested jury instructions, and special jury instructions and special jury verdicts. These matters may be heard and resolved at this conference. At least 5 days before this conference, counsel must also have exchanged lists of exhibits and witnesses and have submitted to the court a brief statement of the case to be read to the jury panel as required by Chapter Eight of the Los Angeles Superior Court Rules.

SANCTIONS

The court will impose appropriate sanctions for the failure or refusal to comply with Chapter Three Rules, orders made by the Court, and time standards or deadlines established by the Court or by the Chapter Three Rules. Such sanctions may be on a party or if appropriate on counsel for the party.

This is not a complete delineation of the Chapter Three Rules, and adherence only to the above provisions is therefore not a guarantee against the imposition of sanctions under Trial Court Delay Reduction. Careful reading and compliance with the actual Chapter Rules is absolutely imperative.

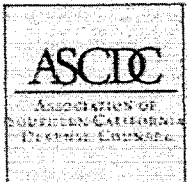

These stipulations are meant to encourage cooperation between the parties and to assist in resolving issues in a manner that promotes economic case resolution and judicial efficiency.

This stipulation is intended to provide a fast and informal resolution of discovery issues through limited paperwork and an informal conference with the Court to aid in the resolution of the issues.

The parties agree that:

1. Prior to the discovery cut-off in this action, no discovery motion shall be filed or heard unless the moving party first makes a written request for an Informal Discovery Conference pursuant to the terms of this stipulation.
2. At the Informal Discovery Conference the Court will consider the dispute presented by parties and determine whether it can be resolved informally. Nothing set forth herein will preclude a party from making a record at the conclusion of an Informal Discovery Conference, either orally or in writing.
3. Following a reasonable and good faith attempt at an informal resolution of each issue to be presented, a party may request an Informal Discovery Conference pursuant to the following procedures:
 - a. The party requesting the Informal Discovery Conference will:
 - i. File a Request for Informal Discovery Conference with the clerk's office on the approved form (copy attached) and deliver a courtesy, conformed copy to the assigned department;
 - ii. Include a brief summary of the dispute and specify the relief requested; and
 - iii. Serve the opposing party pursuant to any authorized or agreed method of service that ensures that the opposing party receives the Request for Informal Discovery Conference no later than the next court day following the filing.
 - b. Any Answer to a Request for Informal Discovery Conference must:
 - i. Also be filed on the approved form (copy attached);
 - ii. Include a brief summary of why the requested relief should be denied;

- iii. Be filed within two (2) court days of receipt of the Request; and
 - iv. Be served on the opposing party pursuant to any authorized or agreed upon method of service that ensures that the opposing party receives the Answer no later than the next court day following the filing.
- c. No other pleadings, including but not limited to exhibits, declarations, or attachments, will be accepted.
 - d. If the Court has not granted or denied the Request for Informal Discovery Conference within ten (10) days following the filing of the Request, then it shall be deemed to have been denied. If the Court acts on the Request, the parties will be notified whether the Request for Informal Discovery Conference has been granted or denied and, if granted, the date and time of the Informal Discovery Conference, which must be within twenty (20) days of the filing of the Request for Informal Discovery Conference.
 - e. If the conference is not held within twenty (20) days of the filing of the Request for Informal Discovery Conference, unless extended by agreement of the parties and the Court, then the Request for the Informal Discovery Conference shall be deemed to have been denied at that time.
4. If (a) the Court has denied a conference or (b) one of the time deadlines above has expired without the Court having acted or (c) the Informal Discovery Conference is concluded without resolving the dispute, then a party may file a discovery motion to address unresolved issues.
 5. The parties hereby further agree that the time for making a motion to compel or other discovery motion is tolled from the date of filing of the Request for Informal Discovery Conference until (a) the request is denied or deemed denied or (b) twenty (20) days after the filing of the Request for Informal Discovery Conference, whichever is earlier, unless extended by Order of the Court.

It is the understanding and intent of the parties that this stipulation shall, for each discovery dispute to which it applies, constitute a writing memorializing a "specific later date to which the propounding [or demanding or requesting] party and the responding party have agreed in writing," within the meaning of Code Civil Procedure sections 2030.300(c), 2031.320(c), and 2033.290(c).
 6. Nothing herein will preclude any party from applying *ex parte* for appropriate relief, including an order shortening time for a motion to be heard concerning discovery.
 7. Any party may terminate this stipulation by giving twenty-one (21) days notice of intent to terminate the stipulation.
 8. References to "days" mean calendar days, unless otherwise noted. If the date for performing any act pursuant to this stipulation falls on a Saturday, Sunday or Court holiday, then the time for performing that act shall be extended to the next Court day.

In a personal injury case, an incident or police report, medical records, and repair or maintenance records could be considered "core.");
 - c. Exchange of names and contact information of witnesses;
 - d. Any insurance agreement that may be available to satisfy part or all of a judgment, or to indemnify or reimburse for payments made to satisfy a judgment;
 - e. Exchange of any other information that might be helpful to facilitate understanding, handling, or resolution of the case in a manner that preserves objections or privileges by agreement;
 - f. Controlling issues of law that, if resolved early, will promote efficiency and economy in other phases of the case. Also, when and how such issues can be presented to the Court;
 - g. Whether or when the case should be scheduled with a settlement officer, what discovery or court ruling on legal issues is reasonably required to make settlement discussions meaningful, and whether the parties wish to use a sitting judge or a private mediator or other options as

This stipulation is intended to provide fast and informal resolution of evidentiary issues through diligent efforts to define and discuss such issues and limit paperwork.

The parties agree that:

1. At least ____ days before the final status conference, each party will provide all other parties with a list containing a one paragraph explanation of each proposed motion in limine. Each one paragraph explanation must identify the substance of a single proposed motion in limine and the grounds for the proposed motion.
2. The parties thereafter will meet and confer, either in person or via teleconference or videoconference, concerning all proposed motions in limine. In that meet and confer, the parties will determine:
 - a. Whether the parties can stipulate to any of the proposed motions. If the parties so stipulate, they may file a stipulation and proposed order with the Court.
 - b. Whether any of the proposed motions can be briefed and submitted by means of a short joint statement of issues. For each motion which can be addressed by a short joint statement of issues, a short joint statement of issues must be filed with the Court 10 days prior to the final status conference. Each side's portion of the short joint statement of issues may not exceed three pages. The parties will meet and confer to agree on a date and manner for exchanging the parties' respective portions of the short joint statement of issues and the process for filing the short joint statement of issues.
3. All proposed motions in limine that are not either the subject of a stipulation or briefed via a short joint statement of issues will be briefed and filed in accordance with the California Rules of Court and the Los Angeles Superior Court Rules.
