If you cannot pay the filing fee, ask the court clerk for a fee waiver form. If you do not file your response on time, you may lose the case by default, and your wages, money, and property may be taken without further warning from the court.

INSTRUCTIONS FOR HANDLING UNLIMITED CIVIL CASES

The following critical provisions of the Chapter Three Rules, as applicable in the Central District, are summarized for your assistance.

APPLICATION

The Chapter Three Rules were effective January 1, 1994. They apply to all general civil cases.

PRIORITY OVER OTHER RULES

The Chapter Three Rules shall have priority over all other Local Rules to the extent the others are inconsistent.

CHALLENGE TO ASSIGNED JUDGE

A challenge under Code of Civil Procedure section 170.6 must be made within 15 days after notice of assignment for all purposes to a judge, or if a party has not yet appeared, within 15 days of the first appearance.

TIME STANDARDS

Cases assigned to the Individual Calendaring Court will be subject to processing under the following time standards:

COMPLAINTS: All complaints shall be served within 60 days of filing and proof of service shall be filed within 90 days of filing.

CROSS-COMPLAINTS: Without leave of court first being obtained, no cross-complaint may be filed by any party after their answer is filed. Cross-complaints shall be served within 30 days of the filing date and a proof of service filed within 60 days of the filing date.

A Status Conference will be scheduled by the assigned Independent Calendar Judge no later than 270 days after the filing of the complaint. Counsel must be fully prepared to discuss the following issues: alternative dispute resolution, bifurcation, settlement, trial date, and expert witnesses.

FINAL STATUS CONFERENCE

The Court will require the parties at a status conference not more than 10 days before the trial to have timely filed and served all motions in limine, bifurcation motions, statements of major evidentiary issues, dispositive motions, requested jury instructions, and special jury instructions and special jury verdicts. These matters may be heard and resolved at this conference. At least 5 days before this conference, counsel must also have exchanged lists of exhibits and witnesses and have submitted to the court a brief statement of the case to be read to the jury panel as required by Chapter Eight of the Los Angeles Superior Court Rules.

SANCTIONS

The court will impose appropriate sanctions for the failure or refusal to comply with Chapter Three Rules, orders made by the Court, and time standards or deadlines established by the Court or by the Chapter Three Rules. Such sanctions may be on a party or if appropriate on counsel for the party.

This is not a complete delineation of the Chapter Three Rules, and adherence only to the above provisions is therefore not a guarantee against the imposition of sanctions under Trial Court Delay Reduction. Careful reading and compliance with the actual Chapter Rules is absolutely imperative.

Failure to file a cover sheet with the first paper filed in a civil case may subject a party, its counsel, or both to sanctions under rules 2.30 and 3.220 of the California Rules of Court.

To Parties in Rule 3.740 Collections Cases. A "collections case" under rule 3.740 is defined as an action for recovery of money owed in a sum stated to be certain that is not more than \$25,000, exclusive of interest and attorney's fees, arising from a transaction in which property, services, or money was acquired on credit. A rule 3.740 collections case will be subject to the requirements for service and obtaining a judgment in rule 3.740.

**COMPLAINT FOR CIVIL PENALTIES
AND INJUNCTIVE RELIEF**

(Health & Safety Code. § 25249.6 *et seq.*)

NATURE OF THE ACTION

1
2 1. This Complaint is brought by plaintiffs JOHN BONILLA, RAFAEL DELGADO,
3 JR., JESSE GARRETT, and RACHEL PADILLA (“Plaintiffs”) in the public interest of the
4 People of the State of California to enforce their right to be informed of the presence of
5 chemicals listed by the State of California, pursuant to the Safe Drinking Water and Toxic
6 Enforcement Act of 1986, codified at Health and Safety Code section 25249.6 *et seq.*
7 (“Proposition 65”) (“Listed Chemicals”), including (1) alcoholic beverages when associated
8 with alcohol abuse, (2) ethyl alcohol in alcoholic beverages, [and (3) ethanol in alcoholic
9 beverages]. This Complaint will be deemed amended on March 23, 2014 to include the
10 bracketed language.

11 2. Plaintiffs seek to remedy Defendants’ failure to warn citizens of the State of
12 California, in violation of Proposition 65, about the presence of Listed Chemicals in
13 Defendants’ alcohol beverage products manufactured, distributed, offered for sale, sold, and/or
14 served in the State of California (“Products”).

15 3. Defendants’ Products contain Listed Chemicals and consumers of Products in the
16 State of California are exposed to Listed Chemicals through ingestion of Products.

17 4. Defendants know and intend that their Products expose consumers in the State of
18 California to the Listed Chemicals.

19 5. Attached hereto and incorporated by reference are copies of letters (“60-Day
20 Notices”), dated March 13, 2013, April 4 and 12, 2013, August 14, 2013, October 28-30, 2013,
21 November 5, 2013, and December 10, 2013, and amended 60-Day Notices dated January 21-23,
22 2014, which Plaintiffs sent to California’s Attorney General. Identical letters were sent to every
23 District Attorney in the state, to the City Attorneys of every California city with a population
24 greater than 750,000, and to all Defendants. Attached to the 60-Day Notices were Certificates
25 of Merit attesting to the reasonable and meritorious basis for this action, Certificates of Service
26 attesting to service of the letters on each entity described above, and a description of
27 Proposition 65 prepared by the California Office of Environmental Health Hazard Assessment.
28

1 Furthermore, factual information sufficient to establish the basis of the Certificates of Merit was
2 enclosed with the 60-Day Notices sent to California's Attorney General.

3 6. After receiving the claims asserted in the 60-Day Notices, the public enforcement
4 agencies identified in Paragraph 5 have failed to commence and diligently prosecute a cause of
5 action against Defendants under Proposition 65.

6 7. Plaintiffs seek preliminary and permanent injunctive relief to compel Defendants
7 to provide the warning required under Proposition 65 regarding the Products.

8 8. Pursuant to Health and Safety Code section 25249.7(b), Plaintiffs also seek civil
9 penalties against Defendants for violations of Proposition 65.

10 PARTIES

11 9. Plaintiffs are citizens of the State of California. They bring this action in the
12 public interest pursuant to Health and Safety Code section 25249.7(d).

13 10. Each Defendant is a person in the course of doing business within the meaning of
14 Health and Safety Code section 25249.11.

15 11. Each Defendant is a business that manufactures, distributes, offers for sale, sells,
16 and/or serves, including in Los Angeles County, Products that contain Listed Chemicals.

17 12. Defendants DOES 1-150, which manufacture, distribute, offer for sale, sell,
18 and/or serve in the State of California Products that contain Listed Chemicals, are each persons
19 in the course of doing business within the meaning of Health and Safety Code section 25249.11.

20 At this time, the true names and capacities of defendants DOES 1 through 150, inclusive, are
21 unknown to Plaintiffs, who, therefore, sue said defendants by their fictitious names pursuant to
22 Code of Civil Procedure section 474. Plaintiffs are informed and believe, and on that basis
23 allege, that each of the fictitiously named defendants is responsible for the acts and occurrences
24 alleged herein. When ascertained, their true names and capacities shall be reflected in an
25 amended complaint.

26 VENUE AND JURISDICTION

27 13. The Court has jurisdiction over this action pursuant to Health and Safety Code
28 section 25249.7. Pursuant to California Constitution Article VI, section 10, the California

1 Superior Court has “original jurisdiction in all causes except those given by statute to other trial
2 courts.” The statute under which this action is brought does not specify any other trial courts
3 that should have jurisdiction.

4 14. The Court has jurisdiction over Defendants based on Plaintiffs’ information and
5 good faith belief that each Defendant is a person, firm, corporation, or association that is a
6 citizen of the State of California, has sufficient minimum contacts in the State of California,
7 and/or otherwise purposefully avails itself of the California market. Defendants’ purposeful
8 availment renders the exercise of personal jurisdiction by the Court consistent with traditional
9 notions of fair play and substantial justice.

10 15. Venue is proper in this Court because Defendants manufacture, distribute, offer
11 for sale, sell, and/or serve Products that contain Listed Chemicals. Liability for Plaintiffs’
12 causes of action, or some parts thereof, has accordingly arisen during the times relevant to this
13 Complaint and Plaintiffs accordingly seek civil penalties and forfeitures imposed by statutes.

14 **FIRST CAUSE OF ACTION**

15 **(Violation of Proposition 65 - Against All Defendants)**

16 16. Plaintiffs reallege and incorporate by reference, as if fully set forth herein,
17 Paragraphs 1 through 15, inclusive.

18 17. Pursuant to Health and Safety Code section 25249.7(b), as a consequence of the
19 above-described acts, Defendants are liable for a violation of Proposition 65.

20 **PRAYER FOR RELIEF**

21 Wherefore, Plaintiffs pray for judgment against Defendants as follows:

22 1. That the Court, pursuant to Health and Safety Code section 25249.7(a),
23 preliminarily and permanently enjoin Defendants from manufacturing, distributing, offering for
24 sale, selling, and/or serving in the State of California Products that contain Listed Chemicals
25 without first providing a “clear and reasonable warning” under Proposition 65;

26 2. That the Court grant Plaintiffs’ reasonable attorneys’ fees and costs of suit;


27 3. That the Court, pursuant to Health and Safety Code section 25249.7(b), assess
