



2 1. This Complaint is brought by Plaintiff, ISABEL RUGGERI (“Plaintiff”) in the

15 maintain, or otherwise handle the Products.

16 5. Hazardous levels of LEAD are found in the accessible surface areas of the

3 9. Plaintiff is a citizen of the state of California who is dedicated to protecting the
4 environment, improving human health and the health of ecosystems, and supporting
5 environmentally sound practices. Plaintiff brings this action in the public interest pursuant to
6 California Health and Safety Code section 25249.7(d).

7 10. Defendant, HD SUPPLY REPAIR AND REMODEL, LLC DBA HD SUPPLY
8 HOME IMPROVEMENT SOLUTIONS is a person in the course of doing business within the
