

Depending on the outcome of that assessment, the case may be reassigned to one of the judges of the Complex Litigation Program or reassigned randomly to a court in the Central District.

INSTRUCTIONS FOR HANDLING UNLIMITED CIVIL CASES

The following critical provisions of the Chapter Three Rules, as applicable in the Central District, are summarized for your assistance.

APPLICATION

The Chapter Three Rules were effective January 1, 1994. They apply to all general civil cases.

PRIORITY OVER OTHER RULES

The Chapter Three Rules shall have priority over all other Local Rules to the extent the others are inconsistent.

CHALLENGE TO ASSIGNED JUDGE

A challenge under Code of Civil Procedure section 170.6 must be made within 15 days after notice of assignment for all purposes to a judge, or if a party has not yet appeared, within 15 days of the first appearance.

TIME STANDARDS

Cases assigned to the Individual Calendaring Court will be subject to processing under the following time standards:

COMPLAINTS: All complaints shall be served within 60 days of filing and proof of service shall be filed within 90 days of filing.

CROSS-COMPLAINTS: Without leave of court first being obtained, no cross-complaint may be filed by any party after their answer is filed. Cross-complaints shall be served within 30 days of the filing date and a proof of service filed within 60 days of the filing date.

A Status Conference will be scheduled by the assigned Independent Calendar Judge no later than 270 days after the filing of the complaint. Counsel must be fully prepared to discuss the following issues: alternative dispute resolution, bifurcation, settlement, trial date, and expert witnesses.

FINAL STATUS CONFERENCE

The Court will require the parties at a status conference not more than 10 days before the trial to have timely filed and served all motions in limine, bifurcation motions, statements of major evidentiary issues, dispositive motions, requested jury instructions, and special jury instructions and special jury verdicts. These matters may be heard and resolved at this conference. At least 5 days before this conference, counsel must also have exchanged lists of exhibits and witnesses and have submitted to the court a brief statement of the case to be read to the jury panel as required by Chapter Eight of the Los Angeles Superior Court Rules.

SANCTIONS

The court will impose appropriate sanctions for the failure or refusal to comply with Chapter Three Rules, orders made by the Court, and time standards or deadlines established by the Court or by the Chapter Three Rules. Such sanctions may be on a party or if appropriate on counsel for the party.

This is not a complete delineation of the Chapter Three Rules, and adherence only to the above provisions is therefore not a guarantee against the imposition of sanctions under Trial Court Delay Reduction. Careful reading and compliance with the actual Chapter Rules is absolutely imperative.



Failure to file a cover sheet with the first paper filed in a civil case may subject a party, its counsel, or both to sanctions under rules 2.30 and 3.220 of the California Rules of Court.



**COMPLAINT FOR CIVIL PENALTIES
AND INJUNCTIVE RELIEF**

(Health & Safety Code. § 25249.6 *et seq.*)

NATURE OF THE ACTION

1
2 1. This Complaint is brought by plaintiff ECOLOGICAL ALLIANCE, LLC
3 (“Plaintiff”) in the public interest of the People of the State of California to enforce their right to
4 be informed of the presence of chemicals listed by the State of California, pursuant to the Safe
5 Drinking Water and Toxic Enforcement Act of 1986, codified at Health and Safety Code
6 section 25249.6 *et seq.* (“Proposition 65”), including Lead.

7 2. Plaintiffs seek to remedy Defendants’ failure to warn citizens of the State of
8 California, in violation of Proposition 65, about the presence of Lead (“Listed Chemical”) in
9 Defendants’ Supply Lines for appliances and fixtures offered for sale throughout the State of
10 California (“Products”).

11 3. Defendant’s Products contain the Listed Chemical and consumers of Products in
12 the State of California are exposed to the Listed Chemical through dermal exposure and
13 ingestion of Products.

14 4. Defendants know and intend that their Products expose consumers in the State of
15 California to the Listed Chemical.

16 5. Attached hereto and incorporated by reference are copies of a letter (“60-Day
17 Notice”), dated May 28, 2015, which Plaintiff sent to California’s Attorney General. Identical
18 letters were sent to every District Attorney in the state, to the City Attorneys of every California
19 city with a population greater than 750,000, and to all Defendants. Attached to the 60-Day
20 Notices were Certificates of Merit attesting to the reasonable and meritorious basis for this
21 action, Certificates of Service attesting to service of the letters on each entity described above,
22 and a description of Proposition 65 prepared by the California Office of Environmental Health
23 Hazard Assessment. Furthermore, factual information sufficient to establish the basis of the
24 Certificates of Merit was enclosed with the 60-Day Notice sent to California’s Attorney
25 General.

26 6. After receiving the claims asserted in the 60-Day Notice, the public enforcement
27 agencies identified in Paragraph 5 have failed to commence and diligently prosecute a cause of
28 action against Defendants under Proposition 65.

1 citizen of the State of California, has sufficient minimum contacts in the State of California,
2 and/or otherwise purposefully avails itself of the California market. Defendants' purposeful
3 availment renders the exercise of personal jurisdiction by the Court consistent with traditional
4 notions of fair play and substantial justice.

5 15. Venue is proper in this Court because Defendants manufacture, distribute, offer
6 for sale, sell, and/or serve Products that contain the Listed Chemical. Liability for Plaintiff's
7 causes of action, or some parts thereof, has accordingly arisen during the times relevant to this
8 Complaint and Plaintiff accordingly seeks civil penalties and forfeitures imposed by statutes.

9 **FIRST CAUSE OF ACTION**

10 **(Violation of Proposition 65 - Against All Defendants)**

11 16. Plaintiff realleges and incorporates by reference, as if fully set forth herein,
12 Paragraphs 1 through 15, inclusive.

13 17. Pursuant to Health and Safety Code section 25249.7(b), as a consequence of the
14 above-described acts, Defendants are liable for a violation of Proposition 65.

15 **PRAYER FOR RELIEF**

16 Wherefore, Plaintiff prays for judgment against Defendants as follows:

17 1. That the Court, pursuant to Health and Safety Code section 25249.7(a),
18 preliminarily and permanently enjoin Defendants from manufacturing, distributing, offering for
19 sale, selling, and/or serving in the State of California Products that contain the Listed Chemical
20 without first providing a "clear and reasonable warning" under Proposition 65;

21 2. That the Court grant Plaintiff's reasonable attorneys' fees and costs of suit;

22 3. That the Court, pursuant to Health and Safety Code section 25249.7(b), assess
23 civil penalties against Defendants in such amount as the Court deems appropriate; and

24 4. That the Court grant such other and further relief as may be just and proper.
