1 Plaintiff, Ecological Rights Foundation, in the public interest, based on information and belief, and
2 knowledge and investigation of counsel allege as follows:

3 **INTRODUCTION**

4 1. This Complaint seeks civil penalties and an injunction against Hayneedle, Inc.; Landmann
5 USA, Inc.; Modern Marketing Concepts, Inc.; and Well Traveled Imports, Inc. (collectively
6 “Defendants”) to remedy Defendants’ continuing failure to warn individuals in California about
7 exposures to carbon monoxide, a chemical known to the State of California to cause reproductive
8 toxicity. Such exposures have occurred and continue to occur, through the use wood-burning
9 outdoor heating products, such as fire pits, fire rings, fire tables and chimeneas that Defendants
10 manufacture, distribute and/or sell in the State (“Products”). These Products are intended to be
11 used with wood fuel and are primarily used for heating, ambience, and cooking. The combustion of
12 wood causes carbon monoxide to be released into the air. People using wood-burning outdoor
13 heating products, and those standing near the Products when wood fuel is burning in or on them,
14 inhale the released carbon monoxide.

15 2. Under California’s Proposition 65, California Health & Safety Code § 25249.5, *et seq.*, it is
16 unlawful for businesses to knowingly and intentionally expose individuals in California to
17 chemicals known to the State to cause cancer, birth defects, or other reproductive harm without
18 providing clear and reasonable warnings to individuals prior to their exposure. Defendants
19 introduce wood-burning outdoor heating products into the California marketplace, exposing users
20 of the Products, including pregnant women, to carbon monoxide. Despite the fact that Defendants
21 expose pregnant women and other consumers and individuals to carbon monoxide, Defendants
22 provide no warnings about the reproductive hazards associated with such exposures. Defendants’
23 conduct thus violates the warning provision of Proposition 65. Health & Safety Code § 25249.6.

24 3. Plaintiff seeks injunctive relief pursuant to Health & Safety Code Section 25249.7 to
25 compel Defendants to bring their business practices into compliance with Proposition 65 by
26 providing a clear and reasonable warning to each individual who has been and who in the future
27 may be exposed to carbon monoxide in the ways set forth above. Plaintiff seeks an order that
28 Defendants identify and locate each individual person to whom the Defendants conveyed wood-

1 burning outdoor heating products during the past three years and to provide to each such
2 individual, as well as new purchasers and Product users, a clear and reasonable warning that use of
3 the Products causes exposures to a chemical known to cause birth defects and other reproductive
4 harm.

5 4. In addition to injunctive relief, Plaintiff seeks civil penalties to remedy the failure of
6 Defendants to provide clear and reasonable warnings regarding exposure to a chemical known to
7 cause birth defects and other reproductive harm.

8 **PARTIES**

9 5. Plaintiff, Ecological Rights Foundation (“ERF”) is a non-profit public benefit organization
10 dedicated to, among other causes, protecting California residents from toxic exposures,
11 environmental and human health education, and consumer rights. ERF is incorporated under the
12 laws of the State of California and is a "person" pursuant to Health & Safety Code §25249.11(a).
13 ERF brings this enforcement action in the public interest pursuant to Health & Safety Code
14 §25249.7(d).

15 6. Defendant Hayneedle, Inc. is a person in the course of doing business within the meaning
16 of Health & Safety Code §25249.11. Hayneedle, Inc. markets, distributes, and/or sells the
17 Products for sale and use in the State of California.

18 7. Defendant Landmann USA, Inc. is a person in the course of doing business within the
19 meaning of Health & Safety Code §25249.11. Landmann USA, Inc. markets, distributes, and/or
20 sells the Products for sale and use in California.

21 8. Defendant Modern Marketing Concepts, Inc. is a person in the course of doing business
22 within the meaning of Health & Safety Code §25249.11. Modern Marketing Concepts, Inc.
23 markets, distributes, and/or sells the Products for sale and use in California.

24 9. Defendant Well Traveled Imports, Inc. is a person in the course of doing business within
25 the meaning of Health & Safety Code §25249.11. Well Traveled Imports, Inc. markets, distributes,
26 and/or sells the Products for sale and use in California.

27 10. Each Defendant employs more than ten people.

1 **JURISDICTION**

2 11. The Court has jurisdiction over this action pursuant to California Health & Safety Code
3 Section 25249.7. California Constitution Article VI, Section 10 grants the Superior Court "original
4 jurisdiction in all causes except those given by statute to other trial courts." Chapter 6.6 of the
5 Health & Safety Code, which contains the statutes under which this action is brought, does not
6 grant jurisdiction to any other trial court.

7 12. This Court also has jurisdiction over Defendants because they are businesses that have
8 sufficient minimum contacts in California and within the County of San Francisco. Defendants
9 intentionally availed themselves of the California and San Francisco County markets. It is thus
10 consistent with traditional notions of fair play and substantial justice for the San Francisco County
11 Superior Court to exercise jurisdiction over Defendants.

12 13. Venue is proper in San Francisco County Superior Court because one or more of the
13 violations arise in the County of San Francisco.

14 **BACKGROUND FACTS**

15 14. The People of the State of California have declared by initiative under Proposition 65 their
16 right "[t]o be informed about exposures to chemicals that cause cancer, birth defects, or other
17 reproductive harm." Proposition 65, § 1(b). To effectuate this goal, Proposition 65 prohibits
18 exposing people to chemicals listed by the State of California as known to cause cancer, birth
19 defects, or other reproductive harm without a "clear and reasonable warning" unless the business
20 responsible for the exposure can prove that it fits within a statutory exemption. Health & Safety
21 Code Section 25249.6 states, in pertinent part:
22 No person in the course of doing business shall knowingly and intentionally expose any
23 individual to a chemical known to the state to cause cancer or reproductive toxicity
24 without first giving clear and reasonable warning to such individual . . .

25 15. On July 1, 1989, the State of California officially listed carbon monoxide as a chemical
26 known to cause developmental reproductive toxicity, which means harm to the developing fetus.
27 On July 1, 1990, carbon monoxide exposures became subject to the clear and reasonable warning
28 requirements under Proposition 65. 27 C.C.R. § 27001(b); Health & Safety Code Section
25249.10(b).

1 16. Plaintiff brings this enforcement action against Defendants pursuant to Health & Safety
2 Code Section 25249.7(d). Attached hereto and incorporated by reference are copies of Notices of
3 Violation dated June 9, 2016 and June 27, 2016, which on those dates ERF sent to California's
4 Attorney General, every county District Attorney in California, and to the City Attorneys of every
5 California City with a population greater than 750,000. On the same day, Plaintiff sent
6 substantively identical letters to each Defendant. In compliance with Health & Safety Code §
7 25249.7(d) and 27 C.C.R. § 25903(b), each Notice included the following information: (1) the
8 name and address of each violator; (2) the statute violated; (3) the time period during which
9 violations occurred; (4) specific descriptions of the violations, including (a) the routes of exposure
10 to carbon monoxide from the Products, and (b) the specific type of Products sold and used in
11 violation of Proposition 65; and (5) the name of the specific Proposition 65-listed chemical that is
12 the subject of the violations described in each Notice.

13 17. Attached to the Notices of Violation sent to each Defendant was a summary of Proposition
14 65 that was prepared by California's Office of Environmental Health Hazard Assessment. In
15 addition, each Notice of Violation was accompanied by a Certificate of Service attesting to the
16 service of the Notice of Violation on each entity which received it. Pursuant to Health & Safety
17 Code Section 25249.7(d) and 11 C.C.R. § 3101, Plaintiff also sent a Certificate of Merit with each
18 Notice of Violation attesting to the reasonable and meritorious basis for the action. Plaintiff
19 enclosed factual information sufficient to establish the basis of the Certificate of Merit with the
20 Notice of Violation letters sent to the Attorney General.

21 18. None of the public prosecutors with the authority to prosecute violations of Proposition 65
22 has commenced and/or is diligently prosecuting a cause of action against Defendants under Health
23 & Safety Code Section 25249.5 *et seq.*, based on the claims asserted in ERF's Notices.

24 19. Defendants both know and intend that individuals, including pregnant women, will use the
25 products for heating, ambience and/or cooking, thus exposing them to carbon monoxide. Under
26 Proposition 65, an exposure is "knowing" where the party responsible for such exposure has
27 "knowledge of the fact that a[n] . . . exposure to a chemical listed pursuant to [Health & Safety
28 Code § 25249.8(a)] is occurring. No knowledge that . . . exposure is unlawful is required." 27

1 C.C.R. § 25102(n). This knowledge may be either actual or constructive. *See, e.g.*, Final Statement
2 of Reasons Revised (November 4, 1988) (pursuant to former 22 C.C.R. Division 2, § 12201).
3 Defendants have been informed of the carbon monoxide exposures caused by the use of Products
4 by the 60-Day Notice of Violation, and the accompanying Certificate of Merit served on them by
5 ERF. Defendants also have constructive knowledge of the carbon monoxide exposures caused by
6 Products. As companies that manufacture, market, distribute and/or sell the Products for use in the
7 State of California, Defendants know or should know that carbon monoxide exposures to users of
8 the Products are a natural and foreseeable consequence of Defendants' placing the Products into
9 the stream of commerce.

10 20. Any person "violating or threatening to violate" Proposition 65 may be enjoined in any
11 court of competent jurisdiction. Health & Safety Code § 25249.7. "Threaten to violate" is defined
12 to mean "to create a condition in which there is a substantial probability that a violation will
13 occur." Health & Safety Code § 25249.11(e). Proposition 65 provides for civil penalties not to
14 exceed \$2,500 per day for each violation of the statute.

15 21. ERF has engaged in good faith efforts to resolve the claims alleged herein prior to filing
16 this complaint.

17 **FIRST CAUSE OF ACTION**

18 **(Violations of Health & Safety Code §25249.6)**

19 22. ERF realleges and incorporates by reference into this First Cause of Action as if
20 specifically set forth herein, paragraphs 1 through 21, inclusive.

21 23. Each defendant is a person in the course of doing business within the meaning of Health &
22 Safety Code § 25249.11 who, by manufacturing, marketing, distribution, sale or otherwise placing
23 the Products into the stream of commerce, violated, violates or threatens to violate Proposition 65.

24 24. Carbon monoxide is a chemical listed by the State of California as known to cause
25 developmental reproductive toxicity.

26 25. Defendants know that the average use of the Products will expose users of the Products to
27 carbon monoxide. Defendants intend that the Products be used in a manner that results in
28 exposures to carbon monoxide.

1 regarding the reproductive toxicity of carbon monoxide to users of the Products.

2 27. Since at least three years prior to the Notice of Violation Letters, Defendants have violated
3 Proposition 65 by knowingly and intentionally exposing individuals to carbon monoxide without
4 first giving clear and reasonable warnings to such individuals regarding the reproductive toxicity of
5 carbon monoxide.

6 **PRAYER FOR RELIEF**

7 Wherefore, Plaintiff prays for judgment against Defendants as follows:

- 8 1. Pursuant to the First Cause of Action, that Defendants be enjoined, restrained, and ordered
9 to comply with the provisions of Section 25249.6 of the California Health & Safety Code;
- 10 2. That Defendants be ordered to make best efforts to identify and locate each individual in
11 California to whom they, or their customers or agents, distributed or sold Products during the past
12 three years, and to provide a warning to each such person that use of the Product will expose that
13 person to a chemical known to cause birth defects and other reproductive harm;
- 14 3. That Defendants be assessed a civil penalty in an amount equal to \$2,500.00 per day per
15 individual exposed to carbon monoxide in violation of Section 25249.6 of the California Health &
16 Safety Code, as the result of Defendants' marketing, distributing, and/or selling the Products for use
17 in California.
- 18 4. That, pursuant to Civil Procedure Code § 1021.5, Defendants be ordered to pay to Plaintiff
19 the attorneys' fees and costs it incurred in bringing this enforcement action; and
- 20 5. For such other relief as this court deems just and proper.

In accord with California Health & Safety Code § 25249.7, the Ecological Rights Foundation ("ERF") hereby gives you notice that the companies listed on the attached Exhibit A have violated and are in ongoing violation of California Health & Safety Code § 25249.6, which provides that "[n]o person in the course of doing business shall knowingly and intentionally expose any individual to a chemical known to the state to cause cancer or reproductive toxicity without first providing a clear and reasonable warning to such individual."

Pursuant to California Health & Safety Code § 25249.7, ERF intends to bring an enforcement action 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify the violations discussed in this notice letter. The public enforcement agencies that have been served with copies of this notice of violations are identified with the attached Certificate of Service.

The above-referenced violations occur when California residents use wood-burning outdoor heating products, such as fire pits, fire rings, fire tables and chimeneas. These products are used primarily for heating, ambience and cooking. Combustion of wood fuel produces and exposes people to **carbon monoxide**, a chemical known to the State of California to cause reproductive toxicity. Because the combustion of wood causes carbon monoxide to be released into the air, people using wood-burning outdoor heating products, and others standing near the products when wood fuel is burning in or on the products, inhale carbon monoxide. Exposure to carbon monoxide is via the inhalation route. These products cause carbon monoxide exposures to occur in peoples yards, at parks and beaches, and everywhere else throughout California where the products are used. These violations are alleged for consumer and environmental exposures.

Included on Exhibit A is a non-exclusive list of examples of the types of products manufactured, marketed or sold by the Noticed Parties in the State of California. Though specific models or SKU or product numbers are given as examples, this Notice pertains to all models, and all

variations, of the specific type of product (wood-burning outdoor heating products, such as fire pits, fire rings, fire tables and chimeneas) of which the named model is an example.

The noticed parties on Exhibit A, and on the attached Certificate of Service, did not and do not provide people with clear and reasonable warnings before exposing those people to carbon monoxide.

The above-referenced violations have occurred every day since at least June 9, 2013 and will continue every day until clear and reasonable warnings are given.

In accord with California Health & Safety Code § 25249.7, the Ecological Rights Foundation ("ERF") hereby gives you notice that the companies listed on the attached Exhibit A have violated and are in ongoing violation of California Health & Safety Code § 25249.6, which provides that "[n]o person in the course of doing business shall knowingly and intentionally expose any individual to a chemical known to the state to cause cancer or reproductive toxicity without first providing a clear and reasonable warning to such individual."

Pursuant to California Health & Safety Code § 25249.7, ERF intends to bring an enforcement action 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify the violations discussed in this notice letter. The public enforcement agencies that have been served with copies of this notice of violations are identified with the attached Certificate of Service.

The above-referenced violations occur when California residents use wood-burning outdoor heating products, such as fire pits, fire rings, fire tables and chimeneas. These products are used primarily for heating, ambience and cooking. Combustion of wood fuel produces and exposes people to **carbon monoxide**, a chemical known to the State of California to cause reproductive toxicity. Because the combustion of wood causes carbon monoxide to be released into the air, people using wood-burning outdoor heating products, and others standing near the products when wood fuel is burning in or on the products, inhale carbon monoxide. Exposure to carbon monoxide is via the inhalation route. These products cause carbon monoxide exposures to occur in peoples yards, at parks and beaches, and everywhere else throughout California where the products are used. These violations are alleged for consumer and environmental exposures.

Included on Exhibit 1 is a non-exclusive list of examples of the types of products manufactured, marketed or sold by the Noticed Parties in the State of California. Though specific models or SKU or product numbers are given as examples, this Notice pertains to all models, and all

variations, of the specific type of product (wood-burning outdoor heating products, such as fire pits, fire rings, fire tables and chimeneas) of which the named model is an example.

The noticed parties on Exhibit 1, and on the attached Certificate of Service, did not and do not provide people with clear and reasonable warnings before exposing those people to carbon monoxide.

The above-referenced violations have occurred every day since at least June 27, 2013 and will continue every day until clear and reasonable warnings are given.

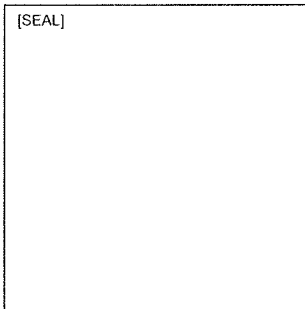

CRC 3.725 requires the filing and service of a case management statement form CM-110 no later than 15 days before the case management conference. However, it would facilitate the issuance of a case management order **without an appearance** at the case management conference if the case management statement is filed, served and lodged in Department 610 twenty-five (25) days before the case management conference.

Plaintiff must serve a copy of this notice upon each party to this action with the summons and complaint. Proof of service subsequently filed with this court shall so state. **This case is eligible for electronic filing and service per Local Rule 2.11. For more information, please visit the Court's website at www.sfsuperiorcourt.org under Online Services.**

ALTERNATIVE DISPUTE RESOLUTION POLICY REQUIREMENTS

**IT IS THE POLICY OF THE SUPERIOR COURT THAT EVERY CIVIL CASE PARTICIPATE IN EITHER MEDIATION, JUDICIAL OR NON-JUDICIAL ARBITRATION, THE EARLY SETTLEMENT PROGRAM OR SOME SUITABLE FORM OF ALTERNATIVE DISPUTE RESOLUTION PRIOR TO A TRIAL.
(SEE LOCAL RULE 4)**

Plaintiff must serve a copy of the Alternative Dispute Resolution Information Package on each defendant along with the complaint. All counsel must discuss ADR with clients and opposing counsel and provide clients with a copy of the Alternative Dispute Resolution Information Package prior to filing the Case Management Statement.

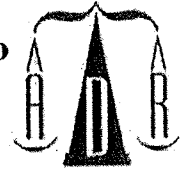

WHAT IS ADR?

Alternative Dispute Resolution (ADR) is the term used to describe the various options available for settling a dispute without a trial. There are many different ADR processes, the most common forms of which are mediation, arbitration and settlement conferences. In ADR, trained, impartial people decide disputes or help parties decide disputes themselves. They can help parties resolve disputes without having to go to court.

WHY CHOOSE ADR?

"It is the policy of the Superior Court that every noncriminal, nonjuvenile case participate either in an early settlement conference, mediation, arbitration, early neutral evaluation or some other alternative dispute resolution process prior to trial." (Local Rule 4)

ADR can have a number of advantages over traditional litigation:

- **ADR can save time.** A dispute often can be resolved in a matter of months, even weeks, through ADR, while a lawsuit can take years.
- **ADR can save money,** including court costs, attorney fees, and expert fees.
- **ADR encourages participation.** The parties may have more opportunities to tell their story than in court and may have more control over the outcome of the case.
- **ADR is more satisfying.** For all the above reasons, many people participating in ADR have reported a high degree of satisfaction.

HOW DO I PARTICIPATE IN ADR?

Litigants may elect to participate in ADR at any point in a case. General civil cases may voluntarily enter into the court's ADR programs by any of the following means:

- Filing a Stipulation to ADR: Complete and file the Stipulation form (attached to this packet)
- Indicating your ADR preference on the Case Management Statement (also attached to this packet); or
- Contacting the court's ADR office (see below) or the Bar Association of San Francisco's ADR Services at 415-782-8905 or www.sfbar.org/adr for more information.

The San Francisco Superior Court offers different types of ADR processes for general civil matters; each ADR program is described in the subsections below:

1) SETTLEMENT CONFERENCES

The goal of settlement conferences is to provide participants an opportunity to reach a mutually acceptable settlement that resolves all or part of a dispute early in the litigation process.

(A) THE BAR ASSOCIATION OF SAN FRANCISCO (BASF) EARLY SETTLEMENT PROGRAM (ESP): ESP remains as one of the Court's ADR programs (see Local Rule 4.3) but parties must select the program – the Court no longer will order parties into ESP.

Operation: Panels of pre-screened attorneys (one plaintiff, one defense counsel) each with at least 10 years' trial experience provide a minimum of two hours of settlement conference time, including evaluation of strengths and weakness of a case and potential case value. On occasion, a panelist with extensive experience in both plaintiff and defense roles serves as a sole panelist. BASF handles notification to all parties, conflict checks with the panelists, and full case management. The success rate for the program is 78% and the satisfaction rate is 97%. Full procedures are at: www.sfbar.org/esp.

Cost: BASF charges an administrative fee of \$295 per party with a cap of \$590 for parties represented by the same counsel. Waivers are available to those who qualify. For more information, call Marilyn King at 415-782-8905, email adr@sfbar.org or see enclosed brochure.

(B) MANDATORY SETTLEMENT CONFERENCES: Parties may elect to apply to the Presiding Judge's department for a specially-set mandatory settlement conference. See Local Rule 5.0 for further instructions. Upon approval of the Presiding Judge, the court will schedule the conference and assign the case for a settlement conference.

2) MEDIATION

Mediation is a voluntary, flexible, and confidential process in which a neutral third party facilitates negotiations. The goal of mediation is to reach a mutually satisfactory agreement that resolves all or part of a dispute after exploring the interests, needs, and priorities of the parties in light of relevant evidence and the law.

(A) MEDIATION SERVICES OF THE BAR ASSOCIATION OF SAN FRANCISCO, in cooperation with the Superior Court, is designed to help civil litigants resolve disputes before they incur substantial costs in litigation. While it is best to utilize the program at the outset of litigation, parties may use the program at any time while a case is pending.

Operation: Experienced professional mediators, screened and approved, provide one hour of preparation time and the first two hours of mediation time. Mediation time beyond that is charged at the mediator's hourly rate. BASF pre-screens all mediators based upon strict educational and experience requirements. Parties can select their mediator from the panels at www.sfbar.org/mediation or BASF can assist with mediator selection. The BASF website contains photographs, biographies, and videos of the mediators as well as testimonials to assist with the selection process. BASF staff handles conflict checks and full case management. Mediators work with parties to arrive at a mutually agreeable solution. The success rate for the program is 64% and the satisfaction rate is 99%.

Cost: BASF charges an administrative fee of \$295 per party. The hourly mediator fee beyond the first three hours will vary depending on the mediator selected. Waivers of the administrative fee are available to those who qualify. For more information, call Marilyn King at 415-782-8905, email adr@sfbay.org or see the enclosed brochure.

(B) JUDICIAL MEDIATION provides mediation with a San Francisco Superior Court judge for civil cases, which include but are not limited to, personal injury, construction defect, employment, professional malpractice, insurance coverage, toxic torts and industrial accidents. Parties may utilize this program at anytime throughout the litigation process.

Operation: Parties interested in judicial mediation should file a Stipulation to Judicial Mediation indicating a joint request for inclusion in the program. A preference for a specific judge may be indicated. The court will coordinate assignment of cases for the program. There is no charge for the Judicial Mediation program.

(C) PRIVATE MEDIATION: Although not currently a part of the court's ADR program, parties may elect any private mediator of their choice; the selection and coordination of private mediation is the responsibility of the parties. Parties may find mediators and organizations on the Internet. The cost of private mediation will vary depending on the mediator selected.

3) ARBITRATION

An arbitrator is neutral attorney who presides at a hearing where the parties present evidence through exhibits and testimony. The arbitrator applies the law to the facts of the case and makes an award based upon the merits of the case.

(A) JUDICIAL ARBITRATION: When the court orders a case to arbitration it is called "judicial arbitration". The goal of arbitration is to provide parties with an adjudication that is earlier, faster, less formal, and usually less expensive than a trial.

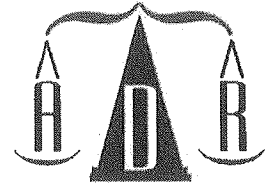
Operation: Pursuant to CCP 1141.11, all civil actions in which the amount in controversy is \$50,000 or less, and no party seeks equitable relief, shall be ordered to arbitration. (Upon stipulation of all parties, other civil matters may be submitted to judicial arbitration.) An arbitrator is chosen from the court's arbitration panel. Arbitrations are generally held between 7 and 9 months after a complaint has been filed. Judicial arbitration is not binding unless all parties agree to be bound by the arbitrator's decision. Any party may request a trial within 60 days after the arbitrator's award has been filed. Local Rule 4.2 allows for mediation in lieu of judicial arbitration, so long as the parties file a stipulation to mediate after the filing of a complaint. There is no cost to the parties for judicial arbitration.

(B) PRIVATE ARBITRATION: Although not currently a part of the court's ADR program, civil disputes may also be resolved through private arbitration. Here, the parties voluntarily consent to arbitration. If all parties agree, private arbitration may be binding and the parties give up the right to judicial review of the arbitrator's decision. In private arbitration, the parties select a private arbitrator and are responsible for paying the arbitrator's fees.

Expedited Jury Trial Information Sheet

What is an expedited jury trial?

An expedited jury trial is a trial that is much faster and has a smaller jury than a traditional jury trial. An expedited jury trial differs from a regular jury trial in several ways:

- **The trial will be shorter.** Each side has 3 hours to make opening statements, present witnesses and evidence, and make closing statements.
- **The jury will be smaller.** There will be 8 jurors instead of 12.
- **Choosing the jury will be faster.** The parties will exercise fewer preemptory challenges.
- **Parties will waive some post trial motions and rights to appeal.** Appeals are allowed only if there is: (1) Misconduct of the judicial officer that materially affected substantial rights of a party; (2) Jury misconduct; or (3) Corruption or fraud or some other bad act that prevented a fair trial.

In addition, parties may not ask the judge to set the jury verdict aside, except on those same grounds.

Does the jury have to reach a unanimous decision?

No. Just as in a traditional civil jury trial, only three-quarters of the jury must agree in order to reach a decision in an expedited jury trial. With 8 people on the jury, that means that at least 6 of the jurors must agree on the verdict in an expedited jury trial.

Is the decision of the jury binding on the parties?

Generally, yes. A verdict from a jury in an expedited jury trial is like a verdict in a traditional jury trial. However, parties who take part in expedited jury trials are allowed to make an agreement before the trial that guarantees that the defendant will pay a certain amount to the plaintiff even if the jury decides on a lower payment or no payment. That agreement may also impose a cap, or maximum, on the highest amount that a defendant has to pay, even if the jury decides on a higher amount. These agreements are commonly known as "high/low agreements."

How do I qualify for an expedited jury trial?

The process can be used in any civil case. To have an expedited jury trial, both sides must want one. Each side must agree that it will use only three hours to put on its case and agree to the other rules described above. This agreement must be put in writing in a Stipulation and submitted along with a Proposed Consent Order Granting an Expedited Jury Trial, which is given to the court for approval. The court will usually agree to the Consent Order.

How do I request an expedited jury trial?

To have an expedited jury trial, both sides must submit a Stipulation and Proposed Consent Order for Expedited Jury Trial to the court for approval. This may happen at three stages of litigation:

- 1) **At Filing and Prior to Setting of a Trial Date:** Parties may submit a Stipulation to Expedited Jury Trial to Dept. 610 using the attached short form (see below). Parties must

also submit a Proposed Consent Order for Expedited Jury Trial to Dept. 610.

2) **After a Trial Date has been Set:** Parties submit a Stipulation and Proposed Consent Order for Expedited Jury Trial directly to Dept. 206 at least 30 days prior to the assigned trial date.

3) **After Trial Assignment:** A Proposed Consent Order for Expedited Jury Trial may be submitted immediately to the assigned trial department not less than 30 days prior to the assigned trial date.

Also, after a case is assigned to a particular judge for trial, the parties may ask the trial judge to have an Expedited Jury Trial, and the judge may permit the parties to then sign the appropriate Stipulation and Proposed Consent Order for Expedited Jury Trial.

Can I change my mind after agreeing to an expedited jury trial?

No, unless the other side or the court agrees. Once you and the other side have agreed to take part in an expedited jury trial the agreement is binding on both sides.

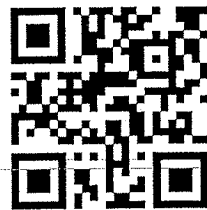

What is ESP?

The Bar Association of San Francisco's **Early Settlement Program (ESP)** is available as one of San Francisco Superior Court's Alternative Dispute Resolution (ADR) programs (Local Rule 4.3).

ESP is a **highly successful** ADR program that handles cases in areas of law such as business, personal injury, employment, labor, civil rights, discrimination, insurance, malpractice, landlord/tenant, and many others.

ESP is **unique** in that the panelists, in helping you move toward settlement, can provide you confidential feedback about their evaluation of your case, including opinions as to potential case value.

Who are the Panelists?

They are experienced attorneys with at least **10 years of trial experience**. Panels consist of one plaintiff and one defense attorney. Sometimes an attorney who is experienced in both types of representation serves as a solo panelist.

Costs

There is a **\$295 administrative fee per party**, capped at **\$590** for multiple parties represented by the same attorney, to pay for the cost of running this program. If you have a fee waiver with the Superior Court, your fee will be waived by the ESP program.

- ➎ When BASF receives the fees from all parties, your matter will be assigned to a panelist (or panel of 2), who you will work with to set the date, time and location for your conference.
- ➏ If you must reschedule your ESP conference date, work with the other side and your panelist(s) to set the new date. BASF does not need to be notified.
- ➐ Before your conference, provide a copy of your description of the dispute to all parties and panelists. BASF does not need a copy.
- ➑ If the matter is settled in your ESP conference, congratulations!
- ➒ If the matter is not settled in your ESP conference, your initial court date remains the same.

WHAT IS BASF'S MEDIATION SERVICE?

The Bar Association of San Francisco's Mediation Services is a private mediation service which will assist you with almost any type of dispute, from simple contract disputes to complex commercial matters.

WHO ARE THE MEDIATORS?

They are established mediators who have private mediation practices and have met our extensive experience requirements. By going through BASF you receive the services of these highly qualified mediators at a great value.

HOW DO I LEARN MORE ABOUT THE MEDIATORS?

BASF's website at www.sfbar.org/mediation provides bios, photos and hourly rates of mediators. You can search by name or by area of law needed for your case. BASF staff is always available to assist you with selection or to answer questions.

HOW MUCH DOES THE SERVICE COST?

A \$295 per party administrative fee is paid to BASF at the time the Consent to Mediate form is filed. This fee covers the first hour of mediator preparation time and the first two hours of session time. Time beyond that is paid at the mediator's normal hourly rate.

HOW IS THE MEDIATOR CHOSEN?

You may request a specific mediator from our website (www.sfbar.org/mediation) and indicate your choice on the BASF Consent to Mediate form, or you may indicate on the form that you would like BASF staff to assist with the selection.

WHY SHOULD I GO THROUGH BASF? CAN'T I JUST CALL THE MEDIATOR DIRECTLY?

BASF mediators have agreed to provide three free hours as a service to BASF. If you go directly to one of our mediators, you do not qualify for the free hours unless you notify us. Once you have filed with us, you will talk directly to the mediator to ask questions and to set a convenient mediation date and time.

HOW LONG IS THE MEDIATION SESSION?

The time spent in mediation will vary depending on your dispute. BASF mediators are dedicated to reaching a settlement, whether you need a few hours or several days.

WHO CAN USE THE SERVICE?

BASF mediation can be utilized by anyone and is NOT limited to San Francisco residents or issues. Also, the service may be used before a court action is filed or at any time during a court action.

OUR CASE IS FILED IN COURT. HOW DO WE USE BASF'S MEDIATION SERVICES?

When you file the San Francisco Superior Court's Stipulation to ADR form, check the box indicating "Mediation Services of BASF." Then complete BASF's Consent to Mediate form found on our website and file it with us. (If the matter was filed in a different county, please check with that court for the appropriate process.)

WE ARE ON A DEADLINE; HOW QUICKLY CAN WE MEDIATE?

Once all parties have filed all the paperwork, BASF can normally have you in touch with the mediator within a day or two. If there is a deadline, BASF staff will give the matter top priority.

WHAT TYPES OF DISPUTES CAN I MEDIATE?

BASF mediators are trained in 30+ areas of law. If you don't see the area you need on our website or in this brochure, contact us; it is very likely we can match your need with one of our panelists.
