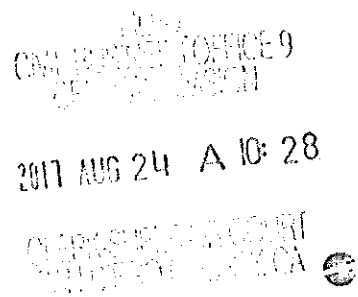

19 NATURE OF THE ACTION

20 1. KINGPUN CHENG (hereinafter, "Plaintiff") brings this representative  
21 action, in the public interest of the citizens of the State of California (hereinafter, "citizens"), to  
22 enforce the citizen's right to be informed of the presence of LEAD AND/OR LEAD  
23 COMPOUNDS (hereinafter, "Lead") found in ECHO INCORPORATED's (hereinafter,  
24 "ECHO") products—specifically ECHO PROFESSIONAL TRIMMER SRM—230, UPC  
25 743184508121 (hereinafter, "TRIMMER".) which were sold in Home Depot, U.S.A, Inc.'s  
26 (hereinafter, "HD") stores.

27 2. HD and ECHO shall collectively be referred to as "Defendant".

3. Plaintiff seeks to remedy Defendant's failure to warn citizens about the risks of exposure to lead present in Defendant's TRIMMER manufactured, distributed and/or offered for sale to consumers throughout the State of California.

4. Defendant manufactures, distributes or offers for sale TRIMMER containing detectable levels of lead to consumers throughout the State of California.

5. California's Safe Drinking Water and Toxic Enforcement Act of 1986, California Health & Safety Code § 25249.5 et seq. ("Proposition 65") states, "No person in the course of doing business shall knowingly and intentionally expose any individual to a chemical known to the state to cause cancer or reproductive toxicity without first giving clear and reasonable warning to such individual..." (*Cal. Health & Safety Code § 25249.6.*)

6. California identified and listed lead as chemicals known to cause birth defects and other reproductive harm under Proposition 65.

7. Defendant manufactures, distributes or offers for sale TRIMMER containing lead without providing a health hazard warning in California.

8. Defendant's failure to warn consumers and/or other individuals in the State of California about their exposure to lead in conjunction with Defendant's sale of TRIMMER is a violation of Proposition 65 which subjects Defendant to enjoinder of such conduct as well as civil penalties for each such violation.

9. For Defendant's violations of Proposition 65, plaintiff seeks preliminary injunctive and permanent injunctive relief to compel Defendant to provide purchasers or users of TRIMMER with the required warning regarding the health hazards of lead. (*Cal. Health & Safety Code* § 25249.7(a).)

10. Plaintiff also seeks civil penalties against Defendant for its violations of Proposition 65, as provided for by *California Health & Safety Code* § 25249.7(b).

PARTIES

11. Plaintiff resides in the City of Carlsbad, County of San Diego, in the State of California and as such, as citizen of the state of California. Plaintiff is dedicated to protecting the health of California citizens through the elimination or reduction of toxic exposures from

1 consumer products, represented by and through its counsel of record, Parker A. Smith. Plaintiff  
2 brings this action in the public interest pursuant to *California Health & Safety Code § 25249.7*.

3 12. Echo Incorporated, is a person doing business within the meaning of *California*  
4 *Health & Safety Code § 25249.11*.

5 13. Home Depot U.S.A, Inc., is a person doing business within the meaning of  
6 *California Health & Safety Code § 25249.11*.

### 7 VENUE AND JURISDICTION

8 14. Venue is proper in the San Diego County Superior Court, pursuant to Code of Civil  
9 Procedure § § 394, 495, 395.5, because this Court is a court of competent jurisdiction, because  
10 one or more instances of wrongful conduct occurred, and continues to occur, in the County of San  
11 Diego and/or because Defendant conducted, and continues to conduct, business in this County  
12 with respect to TRIMMER.

13 15. The California Superior Court has jurisdiction over this action pursuant to  
14 California Constitution Article VI, § 10, which grants the Superior Court “original jurisdiction in  
15 all causes except those given by statute to other trial courts.” The statute under which this action  
16 is brought does not specify any other basis of subject matter jurisdiction.

17 16. The California Superior Court has jurisdiction over Defendant based on Plaintiff’s  
18 information and good faith belief that Defendant is a person, firm, corporation or association that  
19 is either a citizen of the State of California, has sufficient minimum contacts in the State of  
20 California, or otherwise purposefully avail itself of the California market. Defendant’s purposeful  
21 availment renders the exercise of personal jurisdiction by California courts consistent with  
22 traditional notions of fair play and substantial justice.

### 23 FIRST CAUSE OF ACTION

#### 24 (Violation of Proposition 65 – Against Defendant)

25 17. Plaintiff alleges and incorporates by reference, as if full reference, as if full set forth  
26 herein, Paragraphs 1 through 16, inclusive.

27 18. The citizens of the State of California have expressly stated in the Safe Drinking  
28 Water and Toxic Enforcement Act of 1986, *California Health & Safety Code § 25249.5*, et seq.

1 (Proposition 65) that they must be informed "about exposures to chemicals that cause cancer,  
2 birth defects and order reproductive harm." (*Cal. Health & Safety Code § 25249.6.*)

3 19. Proposition 65 states, "No person in the course of doing business shall knowingly  
4 and intentionally expose any individual to a chemical known to the state to cause cancer or  
5 productive toxicity without first giving clear and reasonable warning to such individual (*Id.*)"

6 20. A sixty-day notice of violation, together with the requisite certificates of merit, was  
7 provided to Defendant on September 26, 2016, other potential violators and various public  
8 enforcement agencies, including the California Attorney General's Office, stating that as a result  
9 of the Defendant's sale of TRIMMER, purchasers and users in the State of California were being  
10 exposed to lead resulting from the reasonably foreseeable users of TRIMMER, without the  
11 individual purchasers and users first having been provided with a "clear and reasonable warning"  
12 regarding such toxic exposures.

13 21. Defendant manufactures, distributes and/or offers TRIMMER for sale or use in  
14 violation of *California Health & Safety Code § 25249.6* and Defendant's manufacture,  
15 distribution and/or offering of TRIMMER for sale or use in violation of *California Health &*  
16 *Safety Code § 25249.6* has continued to occur beyond Defendant's receipt of Plaintiff's sixty-day  
17 Notice of Violation. Plaintiff further alleges and believes that such violations will continue to  
18 occur into the future.

19 22. After receipt of the claims asserted in the sixty-day notices of violation, the  
20 appropriate public enforcement agencies have failed to commence and diligently prosecute a  
21 cause of action against Defendant under Proposition 65.

22 23. The TRIMMER manufactured, distributed, and/or offered for sale or use in  
23 California by Defendant contained lead above the allowable state limits.

24 24. Defendant knew or should have known that the TRIMMER manufactured,  
25 distributed, and/or for sale or use by Defendant in California contained lead.

26 25. Lead was present in or on the TRIMMER in such a way as to expose individuals to  
27 lead through dermal contact and/or ingestion during the reasonably foreseeable use of the  
28 TRIMMER.

26. The normal and reasonably foreseeable use of the TRIMMER have caused and continue to cause consumer exposure to lead, as such exposure is defined by 27 CCR§ 25602(b).

27. Defendant had knowledge that the normal and reasonably foreseeable use of the TRIMMER would expose individuals to lead through dermal contact and/or ingestion.

28. Defendant intended that such exposures to lead from the reasonably foreseeable use of the TRIMMER would occur by its deliberate, non-accidental participation in the manufacture, distribution and/or offer for sale or use of the TRIMMER to purchasers, consumers, or users in the State of California.

29. Defendant failed to provide a “clear and reasonable warning” to those consumers and/or other individuals in the State of California who were or who could become exposed to lead through dermal contact and/or ingestion during the reasonably foreseeable use of the TRIMMER.

30. Contrary to the express policy and statutory prohibition of Proposition 65, enacted directly by California voters, individuals exposed to lead through dermal contact and/or ingestion resulting from the reasonably foreseeable use of the TRIMMER, sold by Defendant without a “clear and reasonable warning,” have suffered, and continue to suffer, irreparable harm, for which harm they have no plain, speedy or adequate remedy at law.

31. As a consequence of the above-described acts, each Defendant is liable for a maximum civil penal of \$2,500.00 per day for each violation pursuant to *California Health & Safety Code § 25249.7(b)*.

32. As a consequence of the above-described acts, *California Health & Safety Code* § 25249.7(a) also specifically authorizes the Court to grant injunctive relief against Defendant.

33. Wherefore, Plaintiff prays for judgment against Defendant as set forth hereinafter.

### PRAYER FOR RELIEF

Wherefore, Plaintiff prays for judgment against Defendant as follows:

1. That the Court, pursuant to *California Health & Safety Code § 25249.7(b)*, assess civil penalties against Defendant, in the amount of \$2,500.00 per day for each violation alleged herein;

2. That the Court, pursuant to *California Health & Safety Code § 25249.7(a)*, preliminarily and permanently enjoin Defendant from manufacturing, distributing or offering

1 TRIMMER for sale or use in California, without providing "clear and reasonable warnings" as  
2 detailed by 27 CCR § 25601, as to the harms associated with exposures to lead;

3 3. That the Court grant Plaintiff reasonable attorneys' fees and cost of suit; and  
4 the Court grant such other and further relief as may be just and proper.

This information will be used to compile statistics about the types and numbers of cases filed. You must complete items 1 through 6 on the sheet. In item 1, you must check one box for the case type that best describes the case. If the case fits both a general and a more specific type of case listed in item 1, check the more specific one. If the case has multiple causes of action, check the box that best indicates the primary cause of action. To assist you in completing the sheet, examples of the cases that belong under each case type in item 1 are provided below. A cover sheet must be filed only with your initial paper. Failure to file a cover sheet with the first paper filed in a civil case may subject a party, its counsel, or both to sanctions under rules 2.30 and 3.220 of the California Rules of Court.

**To Parties in Rule 3.740 Collections Cases.** A "collections case" under rule 3.740 is defined as an action for recovery of money owed in a sum stated to be certain that is not more than \$25,000, exclusive of interest and attorney's fees, arising from a transaction in which property, services, or money was acquired on credit. A collections case does not include an action seeking the following: (1) tort damages, (2) punitive damages, (3) recovery of real property, (4) recovery of personal property, or (5) a prejudgment writ of attachment. The identification of a case as a rule 3.740 collections case on this form means that it will be exempt from the general time-for-service requirements and case management rules, unless a defendant files a responsive pleading. A rule 3.740 collections case will be subject to the requirements for service and obtaining a judgment in rule 3.740.

**To Parties in Complex Cases.** In complex cases only, parties must also use the *Civil Case Cover Sheet* to designate whether the case is complex. If a plaintiff believes the case is complex under rule 3.400 of the California Rules of Court, this must be indicated by completing the appropriate boxes in items 1 and 2. If you cannot pay the filing fee, ask the court clerk for a fee waiver form.
