21	Plaintiff, SAFE PRODUCTS FOR CALIFORNIANS, LLC ("Plaintiff"), alleges as		
22	follows:		
23	SUMMARY		
24	1. This is a representative action brought by Plaintiff in the public interest of the		
25	citizens of the State of California to enforce the public's right to be informed of the health		
26	hazards caused by exposures to di(2-ethylhexyl) phthalate ("DEHP"), a toxic chemical found		
27	in and on the products manufactured, distributed, and/or sold by Defendants, AMAZON.COM,		
28	LLC; AMAZON.COM, INC.; AMAZON FULFILLMENT SERVICES, INC.; and DOES		
	Safe Products for Californians, LLC, v. Amazon.com, LLC	C, et al.	

 THROUGH 150, inclusive (collectively "Defendants"), as set forth below.

2 2. By this Complaint, Plaintiff seeks to remedy Defendants' continuing failure to warn individuals not covered by California's Occupational Safety Health Act, Labor Code 3 § 6300, et seq. ("OSHA"), who purchase, use, or handle Defendants' products, about the risks 4 5 of exposure to DEHP present in and on the products manufactured, distributed, and sold throughout the State of California. Individuals not covered by OSHA who purchase, use, or 6 7 handle Defendants' products are referred to hereinafter as "Consumers."

3. Detectable levels of DEHP are found in and on the portable waterproof 8 cosmetic makeup bag that Defendants manufacture, distribute, and/or offer for sale to 9 10 Consumers throughout the State of California.

11 4. Under the Safe Drinking Water and Toxic Enforcement Act of 1986, codified at Health & Safety Code § 25249.5, et seq. ("Proposition 65"), "[n]o person in the course of 12 doing business shall knowingly and intentionally expose any individual to a chemical known to 13 14 the state to cause cancer or reproductive toxicity without first giving clear and reasonable warning to such individual ..." Health & Safety Code § 25249.6. 15

5. Pursuant to Proposition 65, on October 24, 2003, California identified and listed 16 17 DEHP as a chemical known to cause birth defects and reproductive harm. DEHP became 18 subject to the "clear and reasonable warning" requirements of Proposition 65 one year later on 19 October 25, 2004. Cal. Code Regs. tit. 27, § 27001(c); Health & Safety Code § 25249.8.

20 6. Defendants manufacture, distribute, import, sell, and offer for sale without health warnings in the State of California, portable waterproof cosmetic makeup bags that 21 contain excessive levels of DEHP including, but not limited to, "ZOONAI Portable Waterproof 22 Cosmetic Makeup Bag Case Travel Organizer Toiletry Bag" BSIN # B01F118M8M. All such 23 24 products containing DEHP are referred to collectively hereinafter as "Products."

7. Defendants' failure to warn Consumers in the State of California of the health hazards associated with exposures to DEHP in conjunction with Defendants' sales of the 26 27 Products are violations of Proposition 65, and subject Defendants, and each of them, to 28 enjoinment of such conduct as well as civil penalties for each violation. Health & Safety Code

§ 25249.7(a) & (b)(1).

8. For Defendants' violations of Proposition 65, Plaintiff seeks preliminary and
permanent injunctive relief to compel Defendants to provide Consumers of the Products with
the required warning regarding the health hazards associated with exposures to DEHP. Health
& Safety Code § 25249.7(a).

9. Pursuant to Health & Safety Code § 25249.7(b), Plaintiff also seeks civil
penalties against Defendants for their violations of Proposition 65.

JURISDICTION AND VENUE

9 10. The California Superior Court has jurisdiction over this action pursuant to 10 California Constitution Article VI, section 10, which grants the Superior Court "original 11 jurisdiction in all cases except those given by statute to other trial courts." The statute under 12 which this action is brought does not specify any other basis of subject matter jurisdiction.

13 11. The California Superior Court has jurisdiction over Defendants based on 14 Plaintiff's information and good faith belief that Defendants are each a person, firm, 15 corporation, or association that is a citizen of the State of California, has sufficient minimum 16 contacts in the State of California, and/or purposefully avails itself of the California market. 17 Defendants' purposeful availment renders the exercise of personal jurisdiction by California 18 courts consistent with traditional notions of fair play and substantial justice.

19 12. Venue is proper in the Superior Court for the County of Santa Clara, pursuant to
20 Code of Civil Procedure §§ 393, 395, and 395.5, because this Court is a court of competent
21 jurisdiction, because Plaintiff seeks civil penalties against Defendants, because one or more
22 instances of wrongful conduct occurred, and continue to occur, in this county, and/or because
23 Defendants conducted, and continue to conduct, business in Santa Clara County with respect to
24 the Products.

25

PARTIES

Plaintiff is a limited liability California company with its principal place of
business within the State of California, County of Santa Clara. Plaintiff seeks to reduce or
eliminate the presence of hazardous substances in consumer products sold in California, and to

ensure that California consumers are aware of the presence of such substances in consumer
 goods so that they can make an educated effort to limit their own exposure where deemed
 necessary. Plaintiff brings this action in the public interest pursuant to Health & Safety Code
 § 25249.7(d).

5 14. Defendants AMAZON.COM, LLC; AMAZON.COM, INC; and AMAZON
6 FULFILLMENT SERVICES, INC. are each persons in the course of doing business within the
7 meaning of Health & Safety Code §§ 25249.6 and 25249.11.

8 15. Defendants manufacture, import, distribute, sell, and/or offer the Products for
9 sale or use in the State of California, or imply by their conduct that they manufacture, import,
10 distribute, sell, and/or offer the Products for sale or use in the State of California.

11 16. Defendants DOES 1 THROUGH 50, inclusive ("Manufacturer Defendants"),
12 are each a person in the course of doing business within the meaning of Health & Safety Code
13 §§ 25249.6 and 25249.11.

14 17. Manufacturer Defendants, and each of them, research, test, design, assemble,
15 fabricate, and manufacture, or each implies by its conduct that it researches, tests, designs,
16 assembles, fabricates, and manufactures, one or more of the Products offered for sale or use in
17 California.

18 18. Defendants DOES 51 THROUGH 100, inclusive ("Distributor Defendants"),
19 are each a person in the course of doing business within the meaning of Health & Safety Code
20 §§ 25249.6 and 25249.11.

19. Distributor Defendants, and each of them, distribute, exchange, transfer,
process, and transport one or more of the Products to individuals, businesses, or retailers for
sale or use in the State of California, or each implies by its conduct that it distributes,
exchanges, transfers, processes, and transports one or more of the Products to individuals,
businesses, or retailers for sale or use in the State of California.

26 20. Defendants DOES 101 THROUGH 150, inclusive ("Retailer Defendants"), are
27 each a person in the course of doing business within the meaning of Health & Safety Code
28 §§ 25249.6 and 25249.11.

21. 1 Retailer Defendants, and each of them, offer the Products for sale to individuals 2 in the State of California.

3 22. At this time, the true names of Defendants DOES 1 THROUGH 150, inclusive, 4 are unknown to Plaintiff, who, therefore, sues said defendants by their fictitious names 5 pursuant to Code of Civil Procedure § 474. Plaintiff is informed and believes, and on that basis 6 alleges, that each of the fictitiously named defendants is responsible for the acts and 7 occurrences alleged herein. When ascertained, their true names shall be reflected in an 8 amended complaint.

FIRST CAUSE OF ACTION

Violation of Proposition 65

23. Plaintiff re-pleads and incorporates by reference the allegations contained in 11 12 each of the foregoing paragraphs, and incorporates them herein as if separately re-pled.

24. Plaintiff is informed and believes, and on that basis alleges, that each of the 13 Defendants employs ten or more persons. 14

25. 15 In enacting Proposition 65, in the preamble to the Safe Drinking Water and 16 Toxic Enforcement Act of 1986, the People of California expressly declared their right "[t]o be 17 informed about exposures to chemicals that cause cancer, birth defects, or other reproductive 18 harm."

19 26. Proposition 65 states, "[no] person in the course of doing business shall 20 knowingly and intentionally expose any individual to a chemical known to the state to cause 21 cancer or reproductive toxicity without first giving clear and reasonable warning to such 22 individual ..." Health & Safety Code § 25249.6.

27. On August 10, 2017, Plaintiff served a sixty-day notice of violation, including the attachment of a Certificate of Merit affirming that Plaintiff's counsel had consulted with at 24 least one person with relevant and appropriate expertise who reviewed relevant data regarding 25 the alleged exposures to DEHP and that counsel believed there was meritorious and reasonable 26 27 cause for a public action, on Defendants AMAZON.COM, LLC; AMAZON.COM, INC; and 28 AMAZON FULFILLMENT SERVICES, INC., the California Attorney General's Office, and

1 the requisite public enforcement agencies, alleging that, as a result of Defendants' sales of the Products, Consumers in the State of California are being exposed to DEHP resulting from their 2 reasonably foreseeable use of the Products, without the Consumers first receiving a "clear and 3 reasonable warning" regarding the harms associated with exposures to DEHP, as required by 4 Proposition 65. 5

28. Defendants manufacture, import, distribute, sell, and offer the Products for sale 6 or use in violation of Health & Safety Code § 25249.6, and Defendants' violations have 7 continued beyond their receipt of Plaintiff's sixty-day notice of violation. As such, Defendants' 8 violations are ongoing and continuous in nature and, unless enjoined, will continue in the 9 10 future.

29. After receiving Plaintiff's sixty-day notice of violation, and to Plaintiff's best 11 information and belief, no public enforcement agency has commenced and diligently 12 prosecuted a cause of action against Defendants under Proposition 65 to enforce the alleged 13 14 violations that are the subject of Plaintiff's notice of violation.

15 30. The Products that Defendants manufacture, import, distribute, sell, and offer for sale or use in California cause exposures to DEHP as a result of the reasonably foreseeable use 16 of the Products. Such exposures caused by Defendants and endured by Consumers in 17 18 California are not exempt from the "clear and reasonable" warning requirements of Proposition 65, yet Defendants provide no clear and reasonable warning. 19

31. Defendants knew or should have known that the Products they manufacture, 20 import, distribute, sell, and offer for sale or use in California contain DEHP. 21

22 32. DEHP is present in or on the Products in such a way as to expose Consumers through dermal contact, inhalation, and/or ingestion during reasonably foreseeable use. 23

24

25

33. The normal and reasonably foreseeable use of the Products has caused, and continues to cause, consumer exposures to DEHP, as defined by title 27 of the California Code of Regulations, section 25602(b). 26

Defendants know that the normal and reasonably foreseeable use of the 27 34. Products exposes individuals to DEHP through dermal contact, inhalation, and/or ingestion. 28

1 35. Defendants intend that exposures to DEHP through the reasonably foreseeable 2 use of the Products will occur by their deliberate, non-accidental participation in the 3 manufacture, importation, distribution, sale, and offering of the Products for sale or use to 4 Consumers in California.

5 36. Defendants failed to provide a "clear and reasonable warning" to those
6 Consumers in California who have been, or will be, exposed to DEHP through dermal contact,
7 inhalation, and/or ingestion resulting from their use of the Products.

8 37. Contrary to the express policy and statutory prohibition of Proposition 65 9 enacted directly by California voters, consumers exposed to DEHP through dermal contact, 10 inhalation, and/or ingestion as a result of their use of the Products that Defendants sold without 11 a "clear and reasonable" health hazard warning have suffered, and continue to suffer, 12 irreparable harm for which they have no plain, speedy, or adequate remedy at law.

38. Pursuant to Health & Safety Code § 25249.7(b), as a consequence of the abovedescribed acts, Defendants, and each of them, are liable for a maximum civil penalty of \$2,500
per day for each violation.

39. As a consequence of the above-described acts, Health & Safety Code
§ 25249.7(a) also specifically authorizes the Court to grant injunctive relief against
Defendants.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff prays judgment against Defendants, and each of them, for:

 Civil penalties in the amount of \$2,500 per day for each violation, pursuant to Health & Safety Code § 25249.7(b);
