18 NATURE OF THE ACTION

19 1. Plaintiff KINGPUN CHENG (hereinafter, "Plaintiff") brings this representative
20 action, in the public interest of the citizens of the State of California (hereinafter, "citizens"), to
21 enforce the citizen's right to be informed of the presence of LEAD AND/OR LEAD
22 COMPOUNDS (hereinafter, "Lead") found in Defendants TENERGY CORPORATION and
23 AMAZON.COM, INC.'s (hereinafter, collectively referred to as "Defendants") products—
24 specifically UPC844949029612 TENERGY P/N 61241 MODEL 61241 PREMIUM FINGER
25 SPINNER (hereinafter, "Finger Spinner".)

26 2. Plaintiff seeks to remedy Defendants' failure to warn citizens about the risks of
27 exposure to lead present in Defendant's stove and Finger Spinner manufactured, distributed
and/or offered for sale to consumers throughout the State of California.

1 19. On October 9, 2017, a sixty-day notice of violation, together with the requisite
2 certificates of merit, was provided to Defendants, other potential violators and various public
3 enforcement agencies, including the California Attorney General's Office, stating that as a result
4 of the Defendants' sale of Finger Spinner, purchasers and users in the State of California were
5 being exposed to lead resulting from the reasonably foreseeable users of the Finger Spinner
6 without the individual purchasers and users first having been provided with a "clear and
7 reasonable warning" regarding such toxic exposures.

8 20. Defendants manufactures, distributes and/or offers Finger Spinner for sale or use in
9 violation of *California Health & Safety Code § 25249.6* and Defendant's manufacture,
10 distribution and/or offering of Finger Spinner for sale or use in violation of *California Health &*
11 *Safety Code § 25249.6* has continued to occur beyond Defendant's receipt of Plaintiff's sixty-day
12 Notice of Violation. Plaintiff further alleges and believes that such violations will continue to
13 occur into the future.

14 21. After receipt of the claims asserted in the sixty-day notices of violation, the
15 appropriate public enforcement agencies have failed to commence and diligently prosecute a
16 cause of action against Defendants under Proposition 65.

17 22. The Finger Spinner manufactured, distributed, and/or offered for sale or use in
18 California by Defendants contained lead above the allowable state limits.

19 23. Defendants knew or should have known that the Finger Spinner manufactured,
20 distributed, and/or for sale or use by Defendants in California contained lead.

21 24. Lead was present in or on the Finger Spinner in such a way as to expose individuals
22 to lead through dermal contact and/or ingestion during the reasonably foreseeable use of the
23 Finger Spinner.

24 25. The normal and reasonably foreseeable use of the Finger Spinner have caused and
25 continue to cause consumer exposure to lead, as such exposure is defined by *27 CCR§ 25602(b)*.

26 26. Defendants had knowledge that the normal and reasonably foreseeable use of the
27 Finger Spinner would expose individuals to lead through dermal contact and/or ingestion.

28 27. Defendants intended that such exposures to lead from the reasonably foreseeable
use of the Finger Spinner would occur by its deliberate, non-accidental participation in the

1 manufacture, distribution and/or offer for sale or use of the Finger Spinner to purchasers,
2 consumers, or users in the State of California.

3 28. Defendants failed to provide a “clear and reasonable warning” to those consumers
4 and/or other individuals in the State of California who were or who could become exposed to lead
5 through dermal contact and/or ingestion during the reasonably foreseeable use of the Finger
6 Spinner.

7 29. Contrary to the express policy and statutory prohibition of Proposition 65, enacted
8 directly by California voters, individuals exposed to lead through dermal contact and/or ingestion
9 resulting from the reasonably foreseeable use of the Finger Spinner, sold by Defendants without a
10 “clear and reasonable warning,” have suffered, and continue to suffer, irreparable harm, for which
11 harm they have no plain, speedy or adequate remedy at law.

12 30. As a consequence of the above-described acts, each Defendants are liable for a
13 maximum civil penal of \$2,500.00 per day for each violation pursuant to *California Health &*
14 *Safety Code § 25249.7(b)*.

15 31. As a consequence of the above-described acts, *California Health & Safety Code §*
16 *25249.7(a)* also specifically authorizes the Court to grant injunctive relief against Defendants.

17 32. Wherefore, Plaintiff prays for judgment against Defendants as set forth hereinafter.

18 PRAYER FOR RELIEF

19 Wherefore, Plaintiff prays for judgment against Defendants as follows:

20 1. That the Court, pursuant to *California Health & Safety Code § 25249.7(b)*, assess
21 civil penalties against Defendants, in the amount of \$2,500.00 per day for each violation alleged
22 herein;


23 2. That the Court, pursuant to *California Health & Safety Code § 25249.7(a)*,
24 preliminarily and permanently enjoin Defendants from manufacturing, distributing or offering
25 Finger Spinner for sale or use in California, without providing “clear and reasonable warnings”
26 as detailed by *27 CCR § 25601*, as to the harms associated with exposures to lead;

27 3. That the Court grant Plaintiff reasonable attorneys’ fees and cost of suit; and
28 the Court grant such other and further relief as may be just and proper.

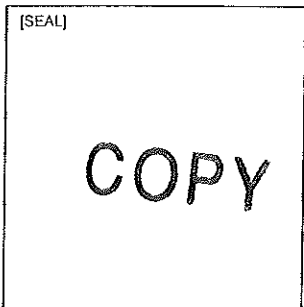
