20 NATURE OF THE ACTION

21 1. Plaintiff Kingpun Cheng ("Plaintiff") brings this representative action, in the
22 public interest of the citizens of the State of California ("citizens"), to enforce the citizen's right
23 to be informed of the presence of DI[2-Ethylhexyl]Phthalate ("DEHP") found in Defendants Big
24 Game International, Shoreline Marine, and Wal-Mart Stores, Inc.'s ("Defendants") Shoreline
25 Marine Wire Fishing Rod Holder with Mount UPC013893766632 ("Product").

26 2. Plaintiff seeks to remedy Defendants' failure to warn citizens about the risks of
27 exposure to DEHP present in Defendants' Product manufactured, distributed and/or offered for
sale to consumers throughout the State of California.

1 3. Defendant manufactures, distributes or offers for sale to consumers throughout the
2 State of California Product containing detectable levels of DEHP.

3 4. Under California’s Safe Drinking Water and Toxic Enforcement Act of 1986,
4 California Health & Safety Code § 25249.5 et seq. (“Proposition 65”), “No person in the course
5 of doing business shall knowingly and intentionally expose any individual to a chemical known to
6 the state to cause cancer or reproductive toxicity without first giving clear and reasonable warning
7 to such individual...” (*Cal. Health & Safety Code § 25249.6.*)

8 5. Under Proposition 65, California identified and listed DEHP as chemicals known to
9 cause cancer or reproductive harm.

10 6. Defendants manufacture, distribute or sell Products containing DEHP without a
11 health hazard warning in California.

12 7. Defendants’ failure to warn consumers and/or other individuals in the State of
13 California about their exposure to DEHP in conjunction with Defendants’ sale of the Product is a
14 violation of Proposition 65 which subjects Defendants to enjoiment of such conduct as well as
15 civil penalties for each such violation.

16 8. For Defendant’s violations of Proposition 65, plaintiff seeks preliminary injunctive
17 and permanent injunctive relief to compel Defendants to provide purchasers or users of the
18 Product with the required warning regarding the health hazards of DEHP. (*Cal. Health & Safety
19 Code § 25249.7(a).*)

20 9. Plaintiff also seeks civil penalties against Defendants for their violations of
21 Proposition 65, as provided for by California Health & Safety Code § 25249.7(b).

PARTIES

22 10. Plaintiff resides in the City of Carlsbad, County of San Diego, in the State of
23 California and as such, as citizen of the state of California. Plaintiff is dedicated to protecting the
24 health of California citizens through the elimination or reduction of toxic exposures from
25 consumer products, represented by and through its counsel of record, Sy and Smith, PC. Plaintiff
26 brings this action in the public interest pursuant to California Health & Safety Code § 25249.7.

27 11. Big Game International, is a person doing business within the meaning of
28 California Health & Safety Code § 25249.11.

1 12. Shoreline Marine, is a person doing business within the meaning of California
2 Health & Safety Code § 25249.11.

3 13. Wal-Mart Stores, Inc., is a person doing business within the meaning of California
4 Health & Safety Code § 25249.11.

5 VENUE AND JURISDICTION

6 14. Venue is proper in the San Diego County Superior Court, pursuant to Code of Civil
7 Procedure § § 394, 495, 395.5, because this Court is a court of competent jurisdiction, because
8 one or more instances of wrongful conduct occurred, and continues to occur, in the County of San
9 Diego and/or because Defendants conducted, and continue to conduct, business in this County
10 with respect to the Product.

11 15. The California Superior Court has jurisdiction over this action pursuant to
12 California Constitution Article VI, § 10, which grants the Superior Court “original jurisdiction in
13 all causes except those given by statute to other trial courts.” The statute under which this action
14 is brought does not specify any other basis of subject matter jurisdiction.

15 16. The California Superior Court has jurisdiction over Defendants based on Plaintiff’s
16 information and good faith belief that Defendants are each a person, firm, corporation or
17 association that either are citizens of the State of California, have sufficient minimum contacts in
18 the State of California, or otherwise purposefully avail themselves of the California market.
19 Defendants’ purposeful availment renders the exercise of personal jurisdiction by California
20 courts consistent with traditional notions of fair play and substantial justice.

21 FIRST CAUSE OF ACTION

22 (Violation of Proposition 65 – Against Defendant)

23 17. Plaintiff alleges and incorporates by reference, as if full reference, as if full set forth
24 herein, Paragraphs 1 through 16, inclusive.

25 18. The citizens of the State of California have expressly stated in the Safe Drinking
26 Water and Toxic Enforcement Act of 1986, California Health & Safety Code § 25249.5, et seq.
27 (Proposition 65) that they must be informed “about exposures to chemicals that cause cancer,
28 birth defects and order reproductive harm.” (*Cal. Health & Safety Code § 25249.6.*)

1 19. Proposition 65 states, "No person in the course of doing business shall knowingly
2 and intentionally expose any individual to a chemical known to the state to cause cancer or
3 productive toxicity without first giving clear and reasonable warning to such individual (*Id.*)"

4 20. On October 9, 2017, a sixty-day notice of violation, together with the requisite
5 certificates of merit, was provided to Defendants, other potential violators and various public
6 enforcement agencies, including the California Attorney General's Office, stating that as a result
7 of the Defendants' sale of Product, purchasers and users in the State of California were being
8 exposed to the DEHP resulting from the reasonably foreseeable users of the Product, without the
9 individual purchasers and users first having been provided with a "clear and reasonable warning"
10 regarding such toxic exposures.

11 21. Defendant manufactures, distributes and/or offers Product for sale or use in
12 violation of California Health & Safety Code § 25249.6 and Defendant's manufacture,
13 distribution and/or offering of the power strip for sale or use in violation of California Health &
14 Safety Code § 25249.6 has continued to occur beyond Defendant's receipt of plaintiff's sixty-day
15 Notice of Violation. Plaintiff further alleges and believes that such violations will continue to
16 occur into the future.

17 22. After receipt of the claims asserted in the sixty-day notices of violation, the
18 appropriate public enforcement agencies have failed to commence and diligently prosecute a
19 cause of action against Defendants under Proposition 65.

20 23. The Product manufactured, distributed, and/or offered for sale or use in California
21 by Defendants contained DEHP above the allowable state limits.

22 24. Defendants knew or should have known that the Product manufactured, distributed,
23 and/or for sale or use by Defendants in California contained DEHP.

24 25. DEHP was present in or on the Product in such a way as to expose individuals to
25 DEHP through dermal contact and/or ingestion during the reasonably foreseeable use of the
26 Product.

27 26. The normal and reasonably foreseeable use of the Product have caused and
28 continue to cause consumer exposure to DEHP, as such exposure is defined by 27 CCR §
25602(b).

1 27. Defendants had knowledge that the normal and reasonably foreseeable use of the
2 Product would expose individuals to DEHP through dermal contact and/or ingestion.

3 28. Defendants intended that such exposures to DEHP from the reasonably foreseeable
4 use of the Product would occur by its deliberate, non-accidental participation in the manufacture,
5 distribution and/or offer for sale or use of the Product to purchasers, consumers, or users in the
6 State of California.

7 29. Defendants failed to provide a "clear and reasonable warning" to those consumers
8 and/or other individuals in the State of California who were or who could become exposed to
9 DEHP through dermal contact and/or ingestion during the reasonably foreseeable use of the
10 Product.

11 30. Contrary to the express policy and statutory prohibition of Proposition 65, enacted
12 directly by California voters, individuals exposed to DEHP through dermal contact and/or
13 ingestion resulting from the reasonably foreseeable use of the Product, sold by Defendants
14 without a "clear and reasonable warning," have suffered, and continue to suffer, irreparable harm,
15 for which harm they have no plain, speedy or adequate remedy at law.

16 31. As a consequence of the above-described acts, each Defendant is liable for a
17 maximum civil penal of \$2,500.00 per day for each violation pursuant to California Health &
18 Safety Code § 25249.7(b).

19 32. As a consequence of the above-described acts, California Health & Safety Code §
20 25249.7(a) also specifically authorizes the Court to grant injunctive relief against Defendant.

21 33. Wherefore, Plaintiff prays for judgment against Defendants as set forth hereinafter.

22 **PRAYER FOR RELIEF**

23 Wherefore, Plaintiff prays for judgment against Defendants as follows:

24 1. That the Court, pursuant to California Health & Safety Code § 25249.7(b), assess
25 civil penalties against Defendants, in the amount of \$2,500.00 per day for each violation alleged
26 herein;

27 2. That the Court, pursuant to California Health & Safety Code § 25249.7(a),
28 preliminarily and permanently enjoin Defendants from manufacturing, distributing or offering


1 Product for sale or use in California, without providing "clear and reasonable warnings" as
2 detailed by 27 CCR § 25601, as to the harms associated with exposures to DEHP;

3 3. That the Court grant Plaintiff reasonable attorneys' fees and cost of suit; and
4 the Court grant such other and further relief as may be just and proper.

If you cannot pay the filing fee, ask the court clerk for a fee waiver form. If you do not file your response on time, you may lose the case by default, and your wages, money, and property may be taken without further warning from the court.

There are other legal requirements. You may want to call an attorney right away. If you do not know an attorney, you may want to call an attorney referral service. If you cannot afford an attorney, you may be eligible for free legal services from a nonprofit legal services program. Si no puede pagar la cuota de presentación, pida al secretario de la corte que le dé un formulario de exención de pago de cuotas. Si no presenta su respuesta a tiempo, puede perder el caso por incumplimiento y la corte le podrá quitar su sueldo, dinero y bienes sin más advertencia.

Hay otros requisitos legales. Es recomendable que llame a un abogado inmediatamente. Si no conoce a un abogado, puede llamar a un servicio de remisión a abogados. Si no puede pagar a un abogado, es posible que cumpla con los requisitos para obtener servicios legales gratuitos de un programa de servicios legales sin fines de lucro. Puede encontrar estos grupos sin fines de lucro en el sitio web de California Legal Services, (www.lawhelpcalifornia.org), en el Centro de Ayuda de las Cortes de California, (www.sucorte.ca.gov) o poniéndose en contacto con la corte o el colegio de abogados locales. **AVISO:** Por ley, la corte tiene derecho a reclamar las cuotas y los costos exentos por imponer un gravamen sobre cualquier recuperación de \$10,000 ó más de valor recibida mediante un acuerdo o una concesión de arbitraje en un caso de derecho civil. Tiene que pagar el gravamen de la corte antes de que la corte pueda desechar el caso.

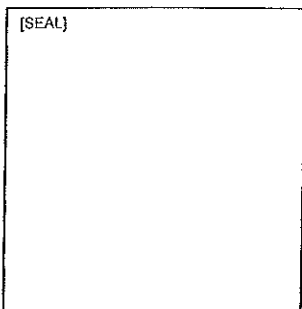
