All unserved parties must be served with summons/complaint/cross-complaint, a copy of this order, and proof of service filed with the court.

OTHER ORDERS

TENTATIVE CASE MANAGEMENT ORDERS

Counsel and self-represented litigants are ordered to check the court's register of action before appearing at any case management conference or other scheduled appearance to determine if the court has issued a tentative case management order. If published, this tentative case management order will become the order of the Court unless counsel or self-represented party notifies the Court and opposing counsel/self-represented party by email not less than one court day prior to the Case Management Conference (CMC) that s/he intends to appear in person at the CMC to discuss some aspect of the order, and specifies the nature of the party's concern. (Please note that the Tentative Rulings postings on the website are for tentative rulings on law and motion matters and will not display tentative Case Management Orders. The tentative Case Management Orders are found in the Register of Action). The court may be reached at Dept.18@alameda.courts.ca.gov. If no tentative case management order has been posted or the tentative order specifies parties to appear, counsel and/or self-represented litigant may appear at the CMC via CourtCall unless specially ordered to appear personally.

DISCOVERY MOTIONS

Parties are advised that before a discovery motion is filed, a conference with the judge is required in addition to parties meeting and conferring among each other. To arrange a conference with the judge, parties shall email the Dept. 18 court clerk at Dept.18@alameda.courts.ca.gov requesting the

conference. Counsel shall briefly outline the discovery in dispute (e.g. need to compel further responses to written interrogatories seeking medical damage information) and shall refrain from arguing issues. The time for filing the motion shall be tolled at the time the informal discovery conference is requested.


NOTICES
