22 Plaintiff ENVIRONMENTAL RESEARCH CENTER, INC. ("Plaintiff" or "ERC")
 23 brings this action in the interests of the general public and hereby alleges:

24 **INTRODUCTION**

25 1. This action seeks to remedy the continuing failure of Defendants REPP SPORTS,
 26 LLC and MACROCAP LABS, INC. (collectively "REPP SPORTS" or "DEFENDANTS") to
 27 warn consumers in California that they are being exposed to lead, a substance known to the
 28 State of California to cause cancer, birth defects, and other reproductive harm.

1 2. DEFENDANTS manufacture, package, distribute, market, and/or sell, in California,
2 certain products containing lead, including each of the following products (“PRODUCTS”): (1)
3 Repp Sports Premium Protein Complex Whey+ Vanilla Waffle Cone, (2) Repp Sports Premium
4 Protein Complex Whey+ Tropic O's, (3) Repp Sports Premium Protein Complex Whey+ Funnel
5 Cake, (4) Repp Sports Premium Protein Complex Whey+ Choco-Hoo, (5) Repp Sports High
6 Intensity Pre-Workout Reactr Zap Berry, (6) Repp Sports High Intensity Pre-Workout Reactr
7 Rainbow Burst, (7) Repp Sports High Intensity Pre-Workout Reactr Dragon Fruit, (8) Repp
8 Sports High Intensity Pre-Workout Reactr Blue Magic, (9) Repp Sports Hyper Sleep
9 Performance Sleep Aid Vanilla Soft Serve, (10) Repp Sports Pre-Workout Reactr Dragon Fruit,
10 (11) Repp Sports Pre-Workout Reactr Zap Berry, (12) Repp Sports Pre-Workout Reactr Blue
11 Magic, and (13) Repp Sports Pre-Workout Reactr Rainbow Burst.

12 3. Lead and lead compounds (hereinafter, the “LISTED CHEMICAL”) are substances
13 known to the State¹ of California to cause cancer, birth defects, and other reproductive harm.
14 Proposition 65 requires that consumers must be warned before they are exposed to the LISTED
15 CHEMICAL.

16 4. The ingestion of the PRODUCTS causes exposures to the LISTED CHEMICAL at
17 levels requiring a “clear and reasonable warning” under California’s Safe Drinking Water and
18 Toxic Enforcement Act of 1986, Health & Safety Code (“H&S Code”) Section 25249.5, *et seq.*
19 (also known and referred to herein as “Proposition 65”).

20 5. DEFENDANTS have failed to provide the health hazard warnings required by
21 Proposition 65.

22 6. DEFENDANTS’ past and continuing manufacturing, packaging, distributing,
23 marketing, and/or sales of the PRODUCTS, without the required health hazard warnings, causes
24 or threatens to cause individuals to be involuntarily and unwittingly exposed to levels of the
25 LISTED CHEMICAL that violate or threaten to violate Proposition 65. As a proximate result
26 of these actions, DEFENDANTS have violated, are violating, and will continue to violate,
27 Proposition 65.

1 violated or threaten to violate California law in the County of Alameda.

2 **PARTIES**

3 12. Plaintiff ERC is a non-profit corporation organized under California’s Corporation
4 Law. ERC is dedicated to, among other causes, reducing the use and misuse of hazardous and
5 toxic substances, consumer protection, worker safety, and corporate responsibility.

6 13. ERC is a person within the meaning of H&S Code Section 25118 and brings this
7 enforcement action in the public interest pursuant to H&S Code Section 25249.7(d).

8 14. DEFENDANT REPP SPORTS, LLC is a limited liability company organized under
9 the laws of the State of Florida and is a person doing business within the meaning of H&S Code
10 Section 25249.11. DEFENDANT manufactures, packages, distributes, markets, and/or sells the
11 PRODUCTS for sale or use in California and in Alameda County.

12 15. DEFENDANT MACROCAP LABS, INC. is a corporation organized under the laws
13 of the State of Florida and is a person doing business within the meaning of H&S Code Section
14 25249.11. DEFENDANT manufactures, packages, distributes, markets, and/or sells the
15 PRODUCTS for sale or use in California and in Alameda County.

16 **STATUTORY BACKGROUND**

17 16. The Safe Drinking Water and Toxic Enforcement Act of 1986 is an initiative statute
18 passed as “Proposition 65” by a vote of the People of the State of California in 1986. In passing
19 Proposition 65, the People declared in their right “[t]o be informed about exposures to
20 chemicals that cause cancer, birth defects, or other reproductive harm.” Section 1(b) of Initiative
21 Measure, Proposition 65.

22 17. To effectuate this goal, Proposition 65 requires that individuals be provided with a
23 “clear and reasonable warning” before being exposed to substances listed by the State of
24 California as causing cancer or reproductive toxicity. H&S Code Section 25249.6 states, in
25 pertinent part:

26 No person in the course of doing business shall knowingly and intentionally
27 expose any individual to a chemical known to the state to cause cancer or
28 reproductive toxicity without first giving clear and reasonable warning to such
individual....

1 18. “‘Knowingly’ refers only to knowledge of the fact that a discharge of, release of, or
2 exposure to a chemical listed pursuant to H&S Code Section 25249.8(a) of the Act is occurring.
3 No knowledge that the discharge, release, or exposure is unlawful is required.” 27 California
4 Code of Regulations (“CCR”) § 25102(n).

5 19. Proposition 65 establishes a procedure by which the Governor lists chemicals known
6 to the state to cause cancer or reproductive toxicity. H&S Code § 25249.8. The warning
7 requirements under Proposition 65 for a given chemical go into effect one year after the
8 Governor places that chemical on the list. H&S Code § 25249.10(b).

9 20. Proposition 65 provides that any “person who violates or threatens to violate” the
10 warning requirements of the statute may be enjoined in a court of competent jurisdiction. H&S
11 Code § 25249.7. The phrase “threaten to violate” is defined to mean creating “a condition in
12 which there is a substantial probability that a violation will occur.” H&S Code § 25249.11(e).

13 21. Violators are liable for civil penalties of up to \$2,500 per day for each violation of
14 the Act. H&S Code § 25249.7.

15 **FACTUAL BACKGROUND**

16 22. On February 27, 1987, the State of California officially listed the chemical lead as a
17 chemical known to cause reproductive toxicity. Lead became subject to the warning
18 requirement one year later and was therefore subject to the “clear and reasonable” warning
19 requirements of Proposition 65 beginning on February 27, 1988. H&S Code § 25249.5, *et seq.*;
20 27 CCR § 25000, *et seq.* Due to the high toxicity of lead, the maximum allowable dose level for
21 lead is 0.5 micrograms a day (“µg/day”) for reproductive toxicity. 27 CCR § 25805(b).

22 23. On October 1, 1992, the State of California officially listed the chemicals lead and
23 lead compounds as chemicals known to cause cancer. Lead and lead compounds became subject
24 to the warning requirement one year later and were therefore subject to the “clear and
25 reasonable” warning requirements of Proposition 65 beginning on October 1, 1993. 27 CCR
26 § 25102, *et seq.*; H&S Code § 25249.6, *et seq.* Due to the carcinogenicity of lead, the no
27 significant risk level for lead is 15 µg/day. 27 CCR § 25705(b)(1).

28 ///

1 24. The PRODUCTS have been sold by DEFENDANTS for use in California since at
2 least March 12, 2016.

3 25. To test DEFENDANTS' PRODUCTS for lead, Plaintiff hired a well-respected and
4 accredited testing laboratory. The results of testing undertaken by Plaintiff of DEFENDANTS'
5 PRODUCTS show that the PRODUCTS were in violation of the 0.5 µg/day "safe harbor" daily
6 dose limits for lead set forth in Proposition 65's regulations. Very significant is the fact that
7 people are being exposed to lead through ingestion as opposed to other, less harmful, methods of
8 exposure such as dermal exposure.

9 26. At all times relevant to this action, DEFENDANTS, therefore, have knowingly and
10 intentionally exposed the users of the PRODUCTS to the LISTED CHEMICAL without first
11 giving a clear and reasonable warning to such individuals.

12 27. On March 12, 2019 and March 28, 2019, Plaintiff served REPP SPORTS and each
13 of the appropriate public enforcement agencies with 60-Day Notices of Proposition 65
14 violations document entitled "Notice of Violations of California Health & Safety Code
15 §25249.5 ("Notices"). A true and correct copy of the Notices is attached hereto as *Exhibits A*
16 *and B* respectively, and each is incorporated herein by reference. The Notices were issued
17 pursuant to, and in compliance with, the requirements of H&S Code Section 25249.7(d) and the
18 statute's implementing regulations regarding the notice of the violations to be given to certain
19 public enforcement agencies and to the violator. The Notices included, *inter alia*, the following
20 information: the name, address, and telephone number of the noticing individual; the name of
21 the alleged violators; the statute violated; the approximate time period during which violations
22 occurred; and descriptions of the violations, including the chemical involved, the route of toxic
23 exposure, and the specific product or type of product causing the violations, and was issued as
24 follows:

- 25 a. REPP SPORTS was provided a copy of the Notices by Certified Mail;
26 b. REPP SPORTS was provided a copy of a document entitled "The Safe
27 Drinking Water and Toxic Enforcement Act of 1986 (Proposition 65): A
28 Summary," which is also known as Appendix A to Title 27 of CCR

1 Section 25903 with each Notice;

2 c. The California Attorney General was provided a copy of the Notices via
3 online submission; and

4 d. The California Attorney General was provided with Certificates of Merit
5 by the attorney for the noticing party, stating that there is a reasonable
6 and meritorious case for this action, and attaching factual information
7 sufficient to establish a basis for the certificate, including the identity of
8 the persons consulted with and relied on by the certifier, and the facts,
9 studies, or other data reviewed by those persons, pursuant to H&S Code
10 Section 25249.7(h) (2).

11 e. The District Attorneys, city attorneys or prosecutors of each jurisdiction
12 within which the PRODUCTS are offered for sale within California were
13 provided with a copy of the Notices via first class mail or electronic
14 submission pursuant to H&S Code Section 25249.7(d)(1).

15 28. DEFENDANTS' sales of the PRODUCTS have resulted in numerous exposures
16 without the warnings required by Proposition 65 since at least March 12, 2018 and March 28,
17 2018, the one-year period preceding the Notices. These exposures entitle the Court to award civil
18 penalties for the applicable statutory penalty period, which is one year prior to the date of the
19 Notice of Violation. CCP § 340; *Consumer Advocacy Group, Inc.*, 150 Cal.App.4th at 981.

20 29. DEFENDANTS' sales of the PRODUCTS have resulted in numerous exposures
21 without the warnings required by Proposition 65 since at least March 12, 2016 and March 28,
22 2016, the three-year period preceding the March 12, 2019 and March 28, 2019 Notices that is
23 relevant to Plaintiff's prayer for injunctive relief. H&S Code § 25249.7(a); CCP § 338.

24 30. The imposition of a civil penalty award will have a deterrent economic effect in that
25 it is likely to deter future conduct in violation of Proposition 65 by REPP SPORTS and the
26 regulated community as a whole.

27 31. The PRODUCTS continue to be distributed and sold in California without the
28 requisite warning information.

1 32. At least 60 days have elapsed since Plaintiff sent the Notices to DEFENDANTS.
2 The appropriate public enforcement agencies have failed to commence and diligently prosecute
3 a cause of action under Proposition 65 against DEFENDANTS based on the allegations herein.

4 33. As a proximate result of acts by DEFENDANTS, as persons in the course of doing
5 business within the meaning of H&S Code Section 25249.11, individuals throughout the State
6 of California, including in the County of Alameda, have been exposed to the LISTED
7 CHEMICAL without a clear and reasonable warning. The individuals subject to the illegal
8 exposures include normal and foreseeable users of the PRODUCTS, as well as all other persons
9 exposed to the PRODUCTS.

10 **FIRST CAUSE OF ACTION**

11 **(Injunctive Relief for Violations of Health and Safety Code Section 25249.5, et seq.**
12 **Concerning the PRODUCTS Described in the March 12, 2019 and March 28, 2019**
13 **Proposition 65 Notices**
14 **By Plaintiff Against All DEFENDANTS)**

15 34. Plaintiff re-alleges and incorporates by reference all preceding paragraphs as if fully
16 set forth herein.

17 35. By committing the acts alleged in this Complaint DEFENDANTS, at all times
18 relevant to this action and continuing through the present, have violated H&S Code Section
19 25249.6 by, in the course of doing business, knowingly and intentionally exposing individuals
20 who ingest the PRODUCTS set forth in the Notices to the LISTED CHEMICAL, without first
21 providing a clear and reasonable warning to such individuals pursuant to H&S Code Sections
22 25249.6 and 25249.11(f).

23 36. By the above-described acts, DEFENDANTS have violated H&S Code Section
24 25249.6 and are therefore subject to an injunction ordering DEFENDANTS to stop violating
25 Proposition 65, to provide warnings to all present and future customers, and to provide warnings
26 to DEFENDANTS' past customers who purchased or used the PRODUCTS without receiving a
27 clear and reasonable warning.

28 37. An action for injunctive relief under Proposition 65 is specifically authorized by
H&S Code Section 25249.7(a).

1 38. Continuing commission by DEFENDANTS of the acts alleged above will
2 irreparably harm the citizens of the State of California, for which harm they have no plain,
3 speedy, or adequate remedy at law.

4 Wherefore, Plaintiff prays judgment against DEFENDANTS, as set forth hereafter.

5 **SECOND CAUSE OF ACTION**

6 **(Civil Penalties for Violations of Health and Safety Code Section 25249.5, et seq.**
7 **Concerning the PRODUCTS Described in the March 12, 2019 and March 28, 2019**
8 **Proposition 65 Notices**
9 **By Plaintiff Against All DEFENDANTS)**

10 39. Plaintiff realleges and incorporates by reference all preceding paragraphs as if fully
11 set forth herein.

12 40. By the above-described acts, DEFENDANTS are liable, pursuant to H&S Code
13 Section 25249.7(b), for a civil penalty of \$2,500 per day per violation for each unlawful
14 exposure to the LISTED CHEMICAL from the PRODUCTS.

15 Wherefore, Plaintiff prays for judgment against REPP SPORTS, as set forth hereafter.

16 **THE NEED FOR INJUNCTIVE RELIEF**

17 41. Plaintiff realleges and incorporates by this reference all preceding paragraphs as if
18 set forth below.

19 42. By committing the acts alleged in this Complaint, DEFENDANTS have caused
20 irreparable harm for which there is no plain, speedy, or adequate remedy at law. In the absence
21 of equitable relief, DEFENDANTS will continue to create a substantial risk of irreparable injury
22 by continuing to cause consumers to be involuntarily and unwittingly exposed to the LISTED
23 CHEMICAL through the ingestion of the PRODUCTS.

24 **PRAYER FOR RELIEF**

25 Wherefore, Plaintiff accordingly prays for the following relief:

26 A. A temporary restraining order, preliminary injunction and permanent
27 injunction, pursuant to H&S Code Section 25249.7(a), enjoining DEFENDANTS,
28 their agents, employees, assigns and all persons acting in concert or participating
with DEFENDANTS, from distributing or selling the PRODUCTS in California

1 without first providing a clear and reasonable warning, within the meaning of
2 Proposition 65, to consumers that the ingestion of the PRODUCTS exposes them to
3 the LISTED CHEMICAL;

4 B. An injunctive order, pursuant to H&S Code Section 25249.7(a),
5 compelling DEFENDANTS to identify and locate each individual who has
6 purchased the PRODUCTS since March 12, 2016 and to provide a warning to each
7 such person that the use of the PRODUCTS will expose the user to a chemical
8 known to cause cancer, birth defects, and other reproductive harm;

9 C. An assessment of civil penalties pursuant to H&S Code Section
10 25249.7(b), against DEFENDANTS in the amount of \$2,500 per day for each
11 violation of Proposition 65;

12 D. An award to Plaintiff of its reasonable attorneys' fees and costs of suit
13 pursuant to California Code of Civil Procedure Section 1021.5, as Plaintiff shall
14 specify in further application to the Court; and

15 E. Such other and further relief as may be just and proper.

ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

- 4. Repp Sports Premium Protein Complex Whey+ Choco-Hoo - Lead**
- 5. Repp Sports High Intensity Pre-Workout Reactr Zap Berry - Lead**
- 6. Repp Sports High Intensity Pre-Workout Reactr Rainbow Burst - Lead**

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

This letter is a notice to the Violators and the appropriate governmental authorities of the Proposition 65 violations concerning the listed products. This notice covers all violations of Proposition 65 involving the Violators currently known to ERC from the information now available. ERC may continue to investigate other products that may reveal further violations. A summary of

Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is enclosed with the copy of this letter to the Violator.

The Violators have manufactured, marketed, distributed, and/or sold the listed products, which have exposed and continue to expose numerous individuals within California to the identified chemical, lead. The consumer exposures that are the subject of this notice result from the recommended use of these products by consumers. The primary route of exposure to lead has been through ingestion. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to lead. The method of warning should be a warning that appears on the product's label. The Violators violated Proposition 65 because they failed to provide an appropriate warning to persons ingesting these products that they are being exposed to lead. Each of these ongoing violations has occurred on every day since March 12, 2016, as well as every day since the products were introduced in the California marketplace, and will continue every day until clear and reasonable warnings are provided to product purchasers and users.

Pursuant to Section 25249.7(d) of the statute, ERC intends to file a citizen enforcement action sixty days after effective service of this notice unless the Violators agree in an enforceable written instrument to: (1) reformulate the listed products so as to eliminate further exposures to the identified chemical; (2) pay an appropriate civil penalty; and (3) provide clear and reasonable warnings compliant with Proposition 65 to all persons located in California who purchased the above products in the last three years. Consistent with the public interest goals of Proposition 65 and my client's objectives in pursuing this notice, ERC is interested in seeking a constructive resolution to this matter. Such resolution will avoid both further unwarned consumer exposures to the identified chemical and expensive and time-consuming litigation.

APPENDIX A

OFFICE OF ENVIRONMENTAL HEALTH HAZARD ASSESSMENT CALIFORNIA ENVIRONMENTAL PROTECTION AGENCY

THE SAFE DRINKING WATER AND TOXIC ENFORCEMENT ACT OF 1986 (PROPOSITION 65): A SUMMARY

The following summary has been prepared by the California Office of Environmental Health Hazard Assessment (OEHHA), the lead agency for the implementation of the Safe Drinking Water and Toxic Enforcement Act of 1986 (commonly known as "Proposition 65"). A copy of this summary must be included as an attachment to any notice of violation served upon an alleged violator of the Act. The summary provides basic information about the provisions of the law, and is intended to serve only as a convenient source of general information. It is not intended to provide authoritative guidance on the meaning or application of the law. The reader is directed to the statute and OEHHA implementing regulations (see citations below) for further information.

FOR INFORMATION CONCERNING THE BASIS FOR THE ALLEGATIONS IN THE NOTICE RELATED TO YOUR BUSINESS, CONTACT THE PERSON IDENTIFIED ON THE NOTICE.

The text of Proposition 65 (Health and Safety Code Sections 25249.5 through 25249.13) is available online at: <http://oehha.ca.gov/prop65/law/P65law72003.html>. Regulations that provide more specific guidance on compliance, and that specify procedures to be followed by the State in carrying out certain aspects of the law, are found in Title 27 of the California Code of Regulations, sections 25102 through 27001.¹ These implementing regulations are available online at: <http://oehha.ca.gov/prop65/law/P65Regs.html>.

WHAT DOES PROPOSITION 65 REQUIRE?

The "Proposition 65 List." Under Proposition 65, the lead agency (OEHHA) publishes a list of chemicals that are known to the State of California to cause cancer and/or reproductive toxicity. Chemicals are placed on the Proposition 65 list if they are known to cause cancer and/or birth defects or other reproductive harm, such as damage to

female or male reproductive systems or to the developing fetus. This list must be updated at least once a year. The current Proposition 65 list of chemicals is available on the OEHHA website at: http://www.oehha.ca.gov/prop65/prop65_list/Newlist.html.

Only those chemicals that are on the list are regulated under Proposition 65. Businesses that produce, use, release or otherwise engage in activities involving listed chemicals must comply with the following:

Clear and reasonable warnings. A business is required to warn a person before “knowingly and intentionally” exposing that person to a listed chemical unless an exemption applies. The warning given must be “clear and reasonable.” This means that the warning must: (1) clearly make known that the chemical involved is known to cause cancer, or birth defects or other reproductive harm; and (2) be given in such a way that it will effectively reach the person before he or she is exposed to that chemical. Some exposures are exempt from the warning requirement under certain circumstances discussed below.

Prohibition from discharges into drinking water. A business must not knowingly discharge or release a listed chemical into water or onto land where it passes or probably will pass into a source of drinking water. Some discharges are exempt from this requirement under certain circumstances discussed below.

DOES PROPOSITION 65 PROVIDE ANY EXEMPTIONS?

Yes. You should consult the current version of the statute and regulations (<http://www.oehha.ca.gov/prop65/law/index.html>) to determine all applicable exemptions, the most common of which are the following:

Grace Period. Proposition 65 warning requirements do not apply until 12 months after the chemical has been listed. The Proposition 65 discharge prohibition does not apply to a discharge or release of a chemical that takes place less than 20 months after the listing of the chemical.

Governmental agencies and public water utilities. All agencies of the federal, state or local government, as well as entities operating public water systems, are exempt.

Businesses with nine or fewer employees. Neither the warning requirement nor the discharge prohibition applies to a business that employs a total of nine or fewer employees. This includes all employees, not just those present in California.

Exposures that pose no significant risk of cancer. For chemicals that are listed under Proposition 65 as known to the State to cause cancer, a warning is not required if the business causing the exposure can demonstrate that the exposure occurs at a level that poses “no significant risk.” This means that the exposure is calculated to result in not more than one excess case of cancer in 100,000 individuals exposed over a 70-year lifetime. The Proposition 65 regulations identify specific “No Significant Risk Levels” (NSRLs) for many listed carcinogens. Exposures below these levels are exempt from the warning requirement. See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of NSRLs, and Section 25701 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures that will produce no observable reproductive effect at 1,000 times the level in question. For chemicals known to the State to cause reproductive toxicity, a warning is not required if the business causing the exposure can demonstrate that the exposure will produce no observable effect, even at 1,000 times the level in question. In other words, the level of exposure must be below the “no observable effect level” divided by 1,000. This number is known as the Maximum Allowable Dose Level (MADL). See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of MADLs, and Section 25801 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures to Naturally Occurring Chemicals in Food. Certain exposures to chemicals that naturally occur in foods (i.e., that do not result from any known human activity, including activity by someone other than the person causing the exposure) are exempt from the warning requirements of the law. If the chemical is a contaminant² it must be reduced to the lowest level feasible. Regulations explaining this exemption can be found in Section 25501.

Discharges that do not result in a “significant amount” of the listed chemical entering any source of drinking water. The prohibition from discharges into drinking water does not apply if the discharger is able to demonstrate that a “significant amount” of the listed chemical has not, does not, or will not pass into or probably pass into a source of drinking water, and that the discharge complies with all other applicable laws, regulations, permits, requirements, or orders. A “significant amount” means any detectable amount, except an amount that would meet the “no significant risk” level for chemicals that cause cancer or that is 1,000 times below the “no observable effect” level for chemicals that cause reproductive toxicity, if an individual were exposed to that amount in drinking water.

HOW IS PROPOSITION 65 ENFORCED?

Enforcement is carried out through civil lawsuits. These lawsuits may be brought by the Attorney General, any district attorney, or certain city attorneys. Lawsuits may also be brought by private parties acting in the public interest, but only after providing notice of the alleged violation to the Attorney General, the appropriate district attorney and city attorney, and the business accused of the violation. The notice must provide adequate information to allow the recipient to assess the nature of the alleged violation. The notice must comply with the information and procedural requirements specified in Section 25903 of Title 27 and sections 3100-3103 of Title 11. A private party may not pursue an independent enforcement action under Proposition 65 if one of the governmental officials noted above initiates an enforcement action within sixty days of the notice.

A business found to be in violation of Proposition 65 is subject to civil penalties of up to \$2,500 per day for each violation. In addition, the business may be ordered by a court to stop committing the violation.

A private party may not file an enforcement action based on certain exposures if the alleged violator meets specific conditions. For the following types of exposures, the Act provides an opportunity for the business to correct the alleged violation:

- An exposure to alcoholic beverages that are consumed on the alleged violator's premises to the extent onsite consumption is permitted by law;
- An exposure to a Proposition 65 listed chemical in a food or beverage prepared and sold on the alleged violator's premises that is primarily intended for immediate consumption on- or off-premises. This only applies if the chemical was not intentionally added to the food, and was formed by cooking or similar preparation of food or beverage components necessary to render the food or beverage palatable or to avoid microbiological contamination;
- An exposure to environmental tobacco smoke caused by entry of persons (other than employees) on premises owned or operated by the alleged violator where smoking is permitted at any location on the premises;
- An exposure to listed chemicals in engine exhaust, to the extent the exposure occurs inside a facility owned or operated by the alleged violator and primarily intended for parking non-commercial vehicles.

If a private party alleges that a violation occurred based on one of the exposures described above, the private party must first provide the alleged violator a notice of special compliance procedure and proof of compliance form.

I represent the Environmental Research Center, Inc. (“ERC”) in connection with this Notice of Violations of California’s Safe Drinking Water and Toxic Enforcement Act of 1986, which is codified at California Health & Safety Code Section 25249.5 *et seq.* and also referred to as Proposition 65.

ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

The names of the Companies covered by this notice that violated Proposition 65 (hereinafter the “Violators”) are:

REPP Sports, LLC
MacroCap Labs, Inc.

The products that are the subject of this notice and the chemical in those products identified as exceeding allowable levels are:

- 1. Repp Sports Hyper Sleep Performance Sleep Aid Vanilla Soft Serve - Lead**
- 2. Repp Sports Pre-Workout Reactr Dragon Fruit - Lead**
- 3. Repp Sports Pre-Workout Reactr Zap Berry - Lead**
- 4. Repp Sports Pre-Workout Reactr Blue Magic - Lead**
- 5. Repp Sports Pre-Workout Reactr Rainbow Burst - Lead**

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

This letter is a notice to the Violators and the appropriate governmental authorities of the Proposition 65 violations concerning the listed products. This notice covers all violations of Proposition 65 involving the Violators currently known to ERC from the information now available. ERC may continue to investigate other products that may reveal further violations. A summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is enclosed with the copy of this letter to the Violator.

The Violators have manufactured, marketed, distributed, and/or sold the listed products, which have exposed and continue to expose numerous individuals within California to the identified chemical, lead. The consumer exposures that are the subject of this notice result from the recommended use of these products by consumers. The primary route of exposure to lead has been through ingestion. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to lead. The method of warning should be a warning that appears on the product's label. The Violators violated Proposition 65 because they failed to provide an appropriate warning to persons ingesting these products that they are being exposed to lead. Each of these ongoing violations has occurred on every day since March 28, 2016, as well as every day since the products were introduced in the California marketplace, and will continue every day until clear and reasonable warnings are provided to product purchasers and users.

Pursuant to Section 25249.7(d) of the statute, ERC intends to file a citizen enforcement action sixty days after effective service of this notice unless the Violators agree in an enforceable written instrument to: (1) reformulate the listed products so as to eliminate further exposures to the identified chemical; (2) pay an appropriate civil penalty; and (3) provide clear and reasonable warnings compliant with Proposition 65 to all persons located in California who purchased the above products in the last three years. Consistent with the public interest goals of Proposition 65 and my client's objectives in pursuing this notice, ERC is interested in seeking a constructive resolution to this matter. Such resolution will avoid both further unwarned consumer exposures to the identified chemical and expensive and time-consuming litigation.



OFFICE OF ENVIRONMENTAL HEALTH HAZARD ASSESSMENT CALIFORNIA ENVIRONMENTAL PROTECTION AGENCY

THE SAFE DRINKING WATER AND TOXIC ENFORCEMENT ACT OF 1986 (PROPOSITION 65): A SUMMARY

The following summary has been prepared by the California Office of Environmental Health Hazard Assessment (OEHHA), the lead agency for the implementation of the Safe Drinking Water and Toxic Enforcement Act of 1986 (commonly known as "Proposition 65"). A copy of this summary must be included as an attachment to any notice of violation served upon an alleged violator of the Act. The summary provides basic information about the provisions of the law, and is intended to serve only as a convenient source of general information. It is not intended to provide authoritative guidance on the meaning or application of the law. The reader is directed to the statute and OEHHA implementing regulations (see citations below) for further information.

FOR INFORMATION CONCERNING THE BASIS FOR THE ALLEGATIONS IN THE NOTICE RELATED TO YOUR BUSINESS, CONTACT THE PERSON IDENTIFIED ON THE NOTICE.

The text of Proposition 65 (Health and Safety Code Sections 25249.5 through 25249.13) is available online at: <http://oehha.ca.gov/prop65/law/P65law72003.html>. Regulations that provide more specific guidance on compliance, and that specify procedures to be followed by the State in carrying out certain aspects of the law, are found in Title 27 of the California Code of Regulations, sections 25102 through 27001.¹ These implementing regulations are available online at: <http://oehha.ca.gov/prop65/law/P65Regs.html>.

WHAT DOES PROPOSITION 65 REQUIRE?

The "Proposition 65 List." Under Proposition 65, the lead agency (OEHHA) publishes a list of chemicals that are known to the State of California to cause cancer and/or reproductive toxicity. Chemicals are placed on the Proposition 65 list if they are known to cause cancer and/or birth defects or other reproductive harm, such as damage to

female or male reproductive systems or to the developing fetus. This list must be updated at least once a year. The current Proposition 65 list of chemicals is available on the OEHHA website at: http://www.oehha.ca.gov/prop65/prop65_list/Newlist.html.

Only those chemicals that are on the list are regulated under Proposition 65. Businesses that produce, use, release or otherwise engage in activities involving listed chemicals must comply with the following:

Clear and reasonable warnings. A business is required to warn a person before “knowingly and intentionally” exposing that person to a listed chemical unless an exemption applies. The warning given must be “clear and reasonable.” This means that the warning must: (1) clearly make known that the chemical involved is known to cause cancer, or birth defects or other reproductive harm; and (2) be given in such a way that it will effectively reach the person before he or she is exposed to that chemical. Some exposures are exempt from the warning requirement under certain circumstances discussed below.

Prohibition from discharges into drinking water. A business must not knowingly discharge or release a listed chemical into water or onto land where it passes or probably will pass into a source of drinking water. Some discharges are exempt from this requirement under certain circumstances discussed below.

DOES PROPOSITION 65 PROVIDE ANY EXEMPTIONS?

Yes. You should consult the current version of the statute and regulations (<http://www.oehha.ca.gov/prop65/law/index.html>) to determine all applicable exemptions, the most common of which are the following:

Grace Period. Proposition 65 warning requirements do not apply until 12 months after the chemical has been listed. The Proposition 65 discharge prohibition does not apply to a discharge or release of a chemical that takes place less than 20 months after the listing of the chemical.

Governmental agencies and public water utilities. All agencies of the federal, state or local government, as well as entities operating public water systems, are exempt.

Businesses with nine or fewer employees. Neither the warning requirement nor the discharge prohibition applies to a business that employs a total of nine or fewer employees. This includes all employees, not just those present in California.

Exposures that pose no significant risk of cancer. For chemicals that are listed under Proposition 65 as known to the State to cause cancer, a warning is not required if the business causing the exposure can demonstrate that the exposure occurs at a level that poses “no significant risk.” This means that the exposure is calculated to result in not more than one excess case of cancer in 100,000 individuals exposed over a 70-year lifetime. The Proposition 65 regulations identify specific “No Significant Risk Levels” (NSRLs) for many listed carcinogens. Exposures below these levels are exempt from the warning requirement. See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of NSRLs, and Section 25701 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures that will produce no observable reproductive effect at 1,000 times the level in question. For chemicals known to the State to cause reproductive toxicity, a warning is not required if the business causing the exposure can demonstrate that the exposure will produce no observable effect, even at 1,000 times the level in question. In other words, the level of exposure must be below the “no observable effect level” divided by 1,000. This number is known as the Maximum Allowable Dose Level (MADL). See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of MADLs, and Section 25801 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures to Naturally Occurring Chemicals in Food. Certain exposures to chemicals that naturally occur in foods (i.e., that do not result from any known human activity, including activity by someone other than the person causing the exposure) are exempt from the warning requirements of the law. If the chemical is a contaminant² it must be reduced to the lowest level feasible. Regulations explaining this exemption can be found in Section 25501.

Discharges that do not result in a “significant amount” of the listed chemical entering any source of drinking water. The prohibition from discharges into drinking water does not apply if the discharger is able to demonstrate that a “significant amount” of the listed chemical has not, does not, or will not pass into or probably pass into a source of drinking water, and that the discharge complies with all other applicable laws, regulations, permits, requirements, or orders. A “significant amount” means any detectable amount, except an amount that would meet the “no significant risk” level for chemicals that cause cancer or that is 1,000 times below the “no observable effect” level for chemicals that cause reproductive toxicity, if an individual were exposed to that amount in drinking water.

HOW IS PROPOSITION 65 ENFORCED?

Enforcement is carried out through civil lawsuits. These lawsuits may be brought by the Attorney General, any district attorney, or certain city attorneys. Lawsuits may also be brought by private parties acting in the public interest, but only after providing notice of the alleged violation to the Attorney General, the appropriate district attorney and city attorney, and the business accused of the violation. The notice must provide adequate information to allow the recipient to assess the nature of the alleged violation. The notice must comply with the information and procedural requirements specified in Section 25903 of Title 27 and sections 3100-3103 of Title 11. A private party may not pursue an independent enforcement action under Proposition 65 if one of the governmental officials noted above initiates an enforcement action within sixty days of the notice.

A business found to be in violation of Proposition 65 is subject to civil penalties of up to \$2,500 per day for each violation. In addition, the business may be ordered by a court to stop committing the violation.

A private party may not file an enforcement action based on certain exposures if the alleged violator meets specific conditions. For the following types of exposures, the Act provides an opportunity for the business to correct the alleged violation:

- An exposure to alcoholic beverages that are consumed on the alleged violator's premises to the extent onsite consumption is permitted by law;
- An exposure to a Proposition 65 listed chemical in a food or beverage prepared and sold on the alleged violator's premises that is primarily intended for immediate consumption on- or off-premises. This only applies if the chemical was not intentionally added to the food, and was formed by cooking or similar preparation of food or beverage components necessary to render the food or beverage palatable or to avoid microbiological contamination;
- An exposure to environmental tobacco smoke caused by entry of persons (other than employees) on premises owned or operated by the alleged violator where smoking is permitted at any location on the premises;
- An exposure to listed chemicals in engine exhaust, to the extent the exposure occurs inside a facility owned or operated by the alleged violator and primarily intended for parking non-commercial vehicles.

If a private party alleges that a violation occurred based on one of the exposures described above, the private party must first provide the alleged violator a notice of special compliance procedure and proof of compliance form.
