**FIRST AMENDED COMPLAINT FOR CIVIL  
PENALTIES AND INJUNCTIVE RELIEF**

**(Violation of Health & Safety Code § 25249.5 et  
seq.)**

14 Plaintiff Ema Bell (“Plaintiff”), by and through her attorneys, alleges the following cause  
15 of action in the public interest of the citizens of the State of California.

16 **BACKGROUND OF THE CASE**

17 1. Plaintiff brings this representative action on behalf of all California citizens to  
18 enforce relevant portions of Safe Drinking Water and Toxic Enforcement Act of 1986, codified at  
19 the Health and Safety Code § 25249.5 et seq (“Proposition 65”), which reads, in relevant part,  
20 “[n]o person in the course of doing business shall knowingly and intentionally expose any  
21 individual to a chemical known to the state to cause cancer or reproductive toxicity without first  
22 giving clear and reasonable warning to such individual ...”. Health & Safety Code § 25249.6.

23 2. This first amended complaint is a representative action brought by Plaintiff in the  
24 public interest of the citizens of the State of California to enforce the People’s right to be informed  
25 of the health hazards caused by exposure to di(2-ethylhexyl) phthalate (DEHP), a toxic chemical  
26 found in products sold and/or distributed by defendant Macy’s, Inc. (“Macy’s” or “Defendant”) in  
27 California.  
28

1           3.       DEHP is a harmful chemical known to the State of California to cause cancer and  
2 birth defects or other reproductive harm. On January 1, 1988, the State of California listed DEHP  
3 as a chemical known to the State to cause cancer and it has come under the purview of Proposition  
4 65 regulations since that time. Cal. Code Regs. Tit. 27, § 27001(c); Health & Safety Code §§  
5 25249.8 & 25249.10(b). On October 24, 2003, the State of California listed DEHP as a chemical  
6 known to cause birth defects or other reproductive harm.

7           4.       Proposition 65 requires all businesses with ten (10) or more employees that operate  
8 within California or sell products therein to comply with Proposition 65 regulations. Included in  
9 such regulations is the requirement that businesses must label any product containing a Proposition  
10 65-listed chemical that will create an exposure above safe harbor levels with a “clear and  
11 reasonable” warning before “knowingly and intentionally” exposing any person to any such listed  
12 chemical.

13           5.       Proposition 65 allows for civil penalties of up to \$2,500.00 per day per violation  
14 for up to 365 days (up to a maximum civil penalty amount per violation of \$912,000.00) to be  
15 imposed upon defendants in a civil action for violations of Proposition 65. Health & Safety Code  
16 § 25249.7(b). Proposition 65 also allows for any court of competent jurisdiction to enjoin the  
17 actions of a defendant which “violate or threaten to violate” the statute. Health & Safety Code §  
18 25249.7.

19           6.       Plaintiff alleges that Defendant distributes, sells and/or offers for sale in California,  
20 without a requisite exposure warning, *Judy*® first aid bags, # B085Z16GW4, that expose users to  
21 DEHP (the “Products”) when used for its intended purpose.

22           7.       Defendant’s failure to warn consumers and other individuals in California of the  
23 health hazards associated with exposure to DEHP in conjunction with the sale and/or distribution  
24 of the Products is a violation of Proposition 65 and subjects Defendant to the enjoinder and civil  
25 penalties described herein.

26           8.       Plaintiff seeks civil penalties against Defendant for its violations of Proposition 65  
27 in accordance with Health and Safety Code § 25249.7(b).

1 9. Plaintiff also seeks injunctive relief, preliminarily and permanently requiring  
2 Defendant to provide purchasers or users of the Products with required warnings related to the  
3 dangers and health hazards associated with exposure to DEHP, pursuant to Health and Safety Code  
4 § 25249.7(a).

5 10. Plaintiff further seeks a reasonable award of attorney's fees and costs.

6 **PARTIES**

7 11. Plaintiff is a citizen of the State of California acting in the interest of the general  
8 public to promote awareness of exposures to toxic chemicals in products sold in California and to  
9 improve human health by reducing hazardous substances contained in such items. She brings this  
10 action in the public interest pursuant to Health and Safety Code § 25249.7(d).

11 12. Defendant Macy's, through its business, effectively imports, distributes, sells,  
12 and/or offers the Products for sale or use in the State of California, or it implies by its conduct that  
13 it imports, distributes, sells, and/or offers the Products for sale or use in the State of California.

14 13. Plaintiff alleges that defendant Macy's is a "person" in the course of doing business  
15 within the meaning of Health & Safety Code sections 25249.6 and 25249.11.

16 **VENUE AND JURISDICTION**

17 14. Venue is proper in the County of San Francisco because one or more of the  
18 instances of wrongful conduct occurred and continue to occur in this county and/or because  
19 Defendant conducted, and continues to conduct, business in the County of San Francisco with  
20 respect to the Products.

21 15. This Court has jurisdiction over this action pursuant to California Constitution  
22 Article VI, § 10, which grants the Superior Court original jurisdiction in all causes except those  
23 given by statute to other trial courts. Health and Safety Code § 25249.7 allows for the enforcement  
24 of violations of Proposition 65 in any Court of competent jurisdiction; therefore, this Court has  
25 jurisdiction over this lawsuit.

26 16. This Court has jurisdiction over Defendant because Defendant is either a citizen of  
27 the State of California, has sufficient minimum contacts with the State of California, is registered  
28 with the California Secretary of State as a foreign corporation authorized to do business in the

1 State of California, and/or has otherwise purposefully availed itself of the California market. Such  
2 purposeful availment has rendered the exercise of jurisdiction by California courts consistent and  
3 permissible with traditional notions of fair play and substantial justice.

4 **STATUTORY BACKGROUND**

5 17. The people of the State of California declared in Proposition 65 their right “[t]o be  
6 informed about exposures to chemicals that cause cancer, birth defects, or other reproductive  
7 harm.” (Section 1(b) of Initiative Measure, Proposition 65.)

8 18. To effect this goal, Proposition 65 requires that individuals be provided with a  
9 “clear and reasonable warning” before being exposed to substances listed by the State of California  
10 as causing cancer and birth defects or other reproductive harm. H&S Code § 25249.6 states, in  
11 pertinent part:

12 No person in the course of doing business shall knowingly and intentionally expose any  
13 individual to a chemical known to the state to cause cancer or reproductive toxicity without  
14 first giving clear and reasonable warning to such individual...

15 19. An exposure to a chemical in a consumer product is one “which results from a  
16 person’s acquisition, purchase, storage, consumption or other reasonably foreseeable use of a  
17 consumer good, or any exposure that results from receiving a consumer service.” (27 CCR §  
18 25602, para (b).) H&S Code § 25603(c) states that “a person in the course of doing business ...  
19 shall provide a warning to any person to whom the product is sold or transferred unless the product  
20 is packaged or labeled with a clear and reasonable warning.”

21 20. Pursuant to H&S Code § 25603.1, the warning may be provided by using one or  
22 more of the following methods individually or in combination:<sup>1</sup>

- 23 a. A warning that appears on a product’s label or other labeling.

28 requirements set out in the amended version of 27 CCR 25601, et.seq. as amended on August 30,  
2016, and operative on August 30, 2018.

1            b. Identification of the product at the retail outlet in a manner which provides  
2 a warning. Identification may be through shelf labeling, signs, menus, or a combination  
3 thereof.

4            c. The warnings provided pursuant to subparagraphs (a) and (b) shall be  
5 prominently placed upon a product's labels or other labeling or displayed at the retail outlet  
6 with such conspicuousness, as compared with other words, statements, designs, or devices  
7 in the label, labeling or display as to render it likely to be read and understood by an  
8 ordinary individual under customary conditions of purchase or use.

9            d. A system of signs, public advertising identifying the system and toll-free  
10 information services, or any other system that provides clear and reasonable warnings.

11        21. Proposition 65 provides that any "person who violates or threatens to violate" the  
12 statute may be enjoined in a court of competent jurisdiction. (H&S Code § 25249.7.) The phrase  
13 "threaten to violate" is defined to mean creating "a condition in which there is a substantial  
14 probability that a violation will occur." (H&S Code § 25249.11(e).) Violators are liable for civil  
15 penalties of up to \$2,500.00 per day for each violation of the Act (H&S Code § 25249.7) for up to  
16 365 days (up to a maximum civil penalty amount per violation of \$912,000.00).

17                                    **FACTUAL BACKGROUND**

18        22. On January 1, 1988, the State of California listed DEHP as a chemical known to  
19 the State to cause cancer and it has come under the purview of Proposition 65 regulations since  
20 that time. Cal. Code Regs. Tit. 27, § 27001(c); Health & Safety Code §§ 25249.8 & 25249.10(b).  
21 On October 24, 2003, the State of California listed DEHP as a chemical known to cause birth  
22 defects or other reproductive harm.

23        23. The exposures that are the subject of the Notice result from the purchase,  
24 acquisition, handling and recommended use of the Product. The primary route of exposure to the  
25 is through dermal absorption directly through the skin when consumers use, touch, or handle the  
26 Products. Exposure through ingestion will occur by touching the Product with subsequent touching  
27 of the user's hand to mouth. No clear and reasonable warning is provided with the Products  
28 regarding the health hazards of exposure.

1           24. Defendant has marketed, distributed, offered to sell and/or sold the Products in  
2 California since at least April 28, 2021. The Products continue to be distributed and sold in  
3 California without the requisite warning information.

4           25. At all times relevant to this action, Defendant has knowingly and intentionally  
5 exposed users of the Products to DEHP without first giving a clear and reasonable exposure  
6 warning to such individuals.

7           26. As a proximate result of acts by Defendant, as a person in the course of doing  
8 business within the meaning of H&S Code § 25249.11, individuals throughout the State of  
9 California, including in San Francisco County, have been exposed to Proposition 65 listed  
10 chemicals without a clear and reasonable warning on the Products. The individuals subject to the  
11 violative exposures include normal and foreseeable users and consumers that use the Products, as  
12 well as all others exposed to the Products.

13   **SATISFACTION OF NOTICE REQUIREMENTS**

14           27. Plaintiff purchased the Products from Macy's. At the time of the purchase,  
15 Macy's did not provide a Proposition 65 exposure warning for DEHP in a manner consistent with  
16 H&S Code § 25603.1 as described *supra*.

17           28. The Product was sent to a testing laboratory for phthalate testing to determine the  
18 phthalate content of the Product.

19           29. The laboratory provided the results of its analysis. Results of this test determined  
20 the Product exposes users to DEHP (the "Chemical Test Report," ).

21           30. Plaintiff provided the Chemical Test Report and the Product to an analytical  
22 chemist to determine if, based on the findings of the Chemical Test Report and the reasonable and  
23 foreseeable use of the Product, exposure to DEHP will occur at levels that require Proposition 65  
24 warnings under the Clear and Reasonable Warnings section 25601 of Title 27 of the California  
25 Code of Regulations.

26           31. On April 28, 2021, Plaintiff received from the analytical chemist an exposure  
27 assessment report that concluded that persons in California who use the Product will be exposed  
28 to levels of DEHP that require a Proposition 65 exposure warning.

1 32. On April 28, 2021, Plaintiff gave notice of alleged violation of Health and Safety  
2 Code § 25249.6 (the "Notice") to Defendant concerning the exposure of California citizens to  
3 DEHP from use of the Product without proper warning, subject to a private action to Defendant  
4 and to the California Attorney General's office and the offices of the County District attorneys and  
5 City Attorneys for each city with a population greater than 750,000 persons wherein the herein  
6 violations allegedly occurred.

7 33. The Notice complied with all procedural requirements of Proposition 65 including  
8 the attachment of a Certificate of Merit affirming that Plaintiff's counsel had consulted with at  
9 least one person with relevant and appropriate expertise who reviewed relevant data regarding  
10 DEHP exposure, and that counsel believed there was meritorious and reasonable cause for a private  
11 action.

12 34. After receiving the Notice, and to Plaintiff's best information and belief, none of  
13 the noticed appropriate public enforcement agencies have commenced and diligently prosecuted a  
14 cause of action against Defendant under Proposition 65 to enforce the alleged violations which are  
15 the subject of the Notice.

16 35. Plaintiff is commencing this action more than sixty (60) days from the date of the  
17 Notice to Defendant, as required by law.

18 **FIRST CAUSE OF ACTION**

19 **(By Plaintiff against Defendant for the Violation of Proposition 65)**

20 36. Plaintiff hereby repeats and incorporates by reference paragraphs 1 through 35 of  
21 this First Amended Complaint as though fully set forth herein.

22 37. Defendant has, at all times mentioned herein, acted as distributor, and/or retailer of  
23 the Product.

24 38. Use of the Products will expose users and consumers thereof to DEHP, a hazardous  
25 chemical found on the Proposition 65 list of chemicals known to be hazardous to human health.

26 39. The Products do not comply with the Proposition 65 warning requirements.

27 40. Plaintiff, based on her best information and belief, avers that at all relevant times  
28 herein, and at least April 28, 2021, continuing until the present, that Defendant has continued to

1 knowingly and intentionally expose California users and consumers of the Products to DEHP  
2 without providing required warnings under Proposition 65.

3 41. The exposures that are the subject of the Notice result from the purchase,  
4 acquisition, handling and recommended use of the Product. The primary route of exposure to the  
5 is through dermal absorption directly through the skin when consumers use, touch, or handle the  
6 Products. Exposure through ingestion will occur by touching the Product with subsequent touching  
7 of the user's hand to mouth. No clear and reasonable warning is provided with the Products  
8 regarding the health hazards of exposure.

9 42. Plaintiff, based on her best information and belief, avers that such exposures will  
10 continue every day until clear and reasonable warnings are provided to purchasers and users or  
11 until this known toxic chemical is removed from the Products.

12 43. Defendant has knowledge that the normal and reasonably foreseeable use of the  
13 Products exposes individuals to DEHP, and Defendant intends that exposures to DEHP will occur  
14 by its deliberate, non-accidental participation in the importation, distribution, sale and offering of  
15 the Products to consumers in California

16 44. Plaintiff has engaged in good faith efforts to resolve the herein claims prior to this  
17 First Amended Complaint.

18 45. Pursuant to Health and Safety Code § 25249.7(b), as a consequence of the above  
19 described acts, Defendant is liable for a maximum civil penalty of \$2,500 per day per violation.

20 46. Pursuant to Health and Safety Code § 25249.7(a), this Court is specifically  
21 authorized to grant injunctive relief in favor of Plaintiff and against Defendant.



1 **PRAYER FOR RELIEF**

2 WHEREFORE, Plaintiff demands judgment against Defendant and requests the following  
3 relief:

4 A. That the court assess civil penalties against defendant in the amount of \$2,500 per  
5 day for each violation for up to 365 days (up to a maximum civil penalty amount per  
6 violation of \$912,000.00) in accordance with Health and Safety Code § 25249.7(b);

7 B. That the court preliminarily and permanently enjoin Defendant, mandating  
8 Proposition 65 compliant warnings on the Products;

9 C. That the court grant Plaintiff reasonable attorney’s fees and costs of suit, in the  
10 amount of \$50,000.00.

11 D. That the court grant any further relief as may be just and proper.
