If you cannot pay the filing fee, ask the court clerk for a fee waiver form. If you do not file your response on time, you may lose the case by default, and your wages, money, and property may be taken without further warning from the court.

There are other legal requirements. You may want to call an attorney right away. If you do not know an attorney, you may want to call an attorney referral service. If you cannot afford an attorney, you may be eligible for free legal services from a nonprofit legal services program. ## INSTRUCTIONS FOR HANDLING UNLIMITED CIVIL CASES

The following critical provisions of the California Rules of Court, Title 3, Division 7, as applicable in the Superior Court, are summarized for your assistance.

### APPLICATION

The Division 7 Rules were effective January 1, 2007. They apply to all general civil cases.

### PRIORITY OVER OTHER RULES

The Division 7 Rules shall have priority over all other Local Rules to the extent the others are inconsistent.

### CHALLENGE TO ASSIGNED JUDGE

A challenge under Code of Civil Procedure Section 170.6 must be made within **15** days after notice of assignment for all purposes to a judge, or if a party has not yet appeared, within 15 days of the first appearance.

### TIME STANDARDS

Cases assigned to the Independent Calendaring Courts will be subject to processing under the following time standards:

### COMPLAINTS

All complaints shall be served within 60 days of filing and proof of service shall be filed within 90 days.

### CROSS-COMPLAINTS

Without leave of court first being obtained, no cross-complaint may be filed by any party after their answer is filed. Cross-complaints shall be served within 30 days of the filing date and a proof of service filed within 60 days of the filing date.

### STATUS CONFERENCE

A status conference will be scheduled by the assigned Independent Calendar Judge no later than 270 days after the filing of the complaint. Counsel must be fully prepared to discuss the following issues: alternative dispute resolution, bifurcation, settlement, trial date, and expert witnesses.

### FINAL STATUS CONFERENCE

The Court will require the parties to attend a final status conference not more than 10 days before the scheduled trial date. All parties shall have motions in limine, bifurcation motions, statements of major evidentiary issues, dispositive motions, requested form jury instructions, special jury instructions, and special jury verdicts timely filed and served prior to the conference. These matters may be heard and resolved at this conference. At least five days before this conference, counsel must also have exchanged lists of exhibits and witnesses, and have submitted to the court a brief statement of the case to be read to the jury panel as required by Chapter Three of the Los Angeles Superior Court Rules.

### SANCTIONS

The court will impose appropriate sanctions for the failure or refusal to comply with Chapter Three Rules, orders made by the Court, and time standards or deadlines established by the Court or by the Chapter Three Rules. Such sanctions may be on a party, or if appropriate, on counsel for a party.

**This is not a complete delineation of the Division 7 or Chapter Three Rules, and adherence only to the above provisions is therefore not a guarantee against the imposition of sanctions under Trial Court Delay Reduction. Careful reading and compliance with the actual Chapter Rules is imperative.**

### Class Actions

Pursuant to Local Rule 2.3, all class actions shall be filed at the Stanley Mosk Courthouse and are randomly assigned to a complex judge at the designated complex courthouse. If the case is found not to be a class action it will be returned to an Independent Calendar Courtroom for all purposes.

### \*Provisionally Complex Cases

Cases filed as provisionally complex are initially assigned to the Supervising Judge of complex litigation for determination of complex status. If the case is deemed to be complex within the meaning of California Rules of Court 3.400 et seq., it will be randomly assigned to a complex judge at the designated complex courthouse. If the case is found not to be complex, it will be returned to an Independent Calendar Courtroom for all purposes.



If the case has multiple causes of action, check the box that best indicates the **primary** cause of action. To assist you in completing the sheet, examples of the cases that belong under each case type in item 1 are provided below. A cover sheet must be filed only with your initial paper. Failure to file a cover sheet with the first paper filed in a civil case may subject a party, its counsel, or both to sanctions under rules 2.30 and 3.220 of the California Rules of Court.

**To Parties in Rule 3.740 Collections Cases.** A "collections case" under rule 3.740 is defined as an action for recovery of money owed in a sum stated to be certain that is not more than \$25,000, exclusive of interest and attorney's fees, arising from a transaction in which property, services, or money was acquired on credit. A collections case does not include an action seeking the following: (1) tort damages, (2) punitive damages, (3) recovery of real property, (4) recovery of personal property, or (5) a prejudgment writ of attachment. The identification of a case as a rule 3.740 collections case on this form means that it will be exempt from the general time-for-service requirements and case management rules, unless a defendant files a responsive pleading. A rule 3.740 collections case will be subject to the requirements for service and obtaining a judgment in rule 3.740.

**To Parties in Complex Cases.** In complex cases only, parties must also use the Civil Case Cover Sheet to designate whether the case is complex. If a plaintiff believes the case is complex under rule 3.400 of the California Rules of Court, this must be indicated by completing the appropriate boxes in items 1 and 2. If a plaintiff designates a case as complex, the cover sheet must be served with the complaint on all parties to the action. A defendant may file and serve no later than the time of its first appearance a joinder in the plaintiff's designation, a counter-designation that the case is not complex, or, if the plaintiff has made no designation, a designation that the case is complex.

**NATURE OF THE ACTION**

1. This Complaint is brought by plaintiff Ecological Alliance, LLC (“Plaintiff”) in the public interest of the People of the State of California to enforce their right to be informed of the presence of chemicals, including Lead, listed by the State of California pursuant to the Safe Drinking Water and Toxic Enforcement Act of 1986, codified at Health and Safety Code section 25249.6 *et seq.* (“Proposition 65”).

2. Plaintiffs seek to remedy Defendants’ failure to warn citizens of the State of California, in violation of Proposition 65, about the presence of Lead (“Listed Chemical”) in the Defendants: Trader Joe’s super spinach salad, Trader Joe’s palak paneer, Trader Joe’s cauliflower stir fry, Trader Joe’s pesto tortellini, and Trader Joe’s vegetable spring rolls; all offered for sale throughout the State of California (“Products”).

3. Lead is a toxic metal that, even at low levels, may cause a range of health effects, including behavioral problems and learning disabilities. Young children are most at risk because their brains are developing; however, Lead exposure affects people of all ages. Lead exposure negatively affects virtually every aspect of a child’s development: neurological, sight, hearing, IQ, intelligence, etc... In adults Lead exposure can lead to high blood pressure, kidney failure, and brain damage. In pregnant women Lead exposure can lead to miscarriage, premature, or stillbirths.

4. Defendants’ Products contain Lead and consumers of Products in the State of California are exposed to the Lead through ingestion of the Products.

5. Plaintiff’s testing found that one serving of Trader Joe’s super spinach salad exposes a consumer to approximately 25.30 micrograms of Lead, over 50 times greater than the 0.5 micrograms allowed per day for adults by Proposition 65.

6. Plaintiff’s testing found that one serving of Trader Joe’s palak paneer exposes a consumer to approximately 16.20 micrograms of Lead, over 32 times greater than the 0.5 micrograms allowed per day for adults by Proposition 65.

1           7.       Plaintiff’s testing found that one serving of Trader Joe’s cauliflower stir fry  
2 exposes a consumer to approximately 10.40 micrograms of Lead, over 20 times greater than the  
3 0.5 micrograms allowed per day for adults by Proposition 65.

4           8.       Plaintiff’s testing found that one serving of Trader Joe’s pesto tortellini exposes a  
5 consumer to approximately 10.00 micrograms of Lead, over 20 times greater than the 0.5  
6 micrograms allowed per day for adults by Proposition 65.

7           9.       Plaintiff’s testing found that one serving of Trader Joe’s vegetable spring rolls  
8 exposes a consumer to approximately 4.40 micrograms of Lead, over 8 times greater than the 0.5  
9 micrograms allowed per day for adults by Proposition 65.

10          10.       Defendants know and intend that their Products expose consumers in the State of  
11 California to Lead.

12           11.       Plaintiff sent notice of violation letters (“60-Day Notices”), dated June 22nd and  
13 August 9th, 2021, to Trader Joe’s Company, and both to California’s Attorney General.  
14 Identical letters were sent to every District Attorney in the state, to the City Attorneys of every  
15 California city with a population greater than 750,000, and to all Defendants. Attached to the  
16 60-Day Notices were Certificates of Merit attesting to the reasonable and meritorious basis for  
17 this action, Certificates of Service attesting to service of the letters on each entity described  
18 above, and a description of Proposition 65 prepared by the California Office of Environmental  
19 Health Hazard Assessment. Furthermore, factual information sufficient to establish the basis of  
20 the Certificates of Merit was enclosed with the 60-Day Notice sent to California’s Attorney  
21 General.

22           12.       After receiving the claims asserted in the 60-Day Notice, the public enforcement  
23 agencies identified in Paragraph 5 have failed to commence and diligently prosecute a cause of  
24 action against Defendants under Proposition 65.

25           13.       Plaintiff seeks preliminary and permanent injunctive relief to compel Defendants  
26 to provide the warning required under Proposition 65 regarding the Products.

2 14. Pursuant to Health and Safety Code section 25249.7(b), Plaintiff also seeks civil  
3 penalties against Defendants for violations of Proposition 65.

4 **PARTIES**

5 15. Plaintiff is a California limited liability company. It brings this action in the  
6 public interest pursuant to Health and Safety Code section 25249.7(d).

7 16. Defendant Trader Joe’s Company is a “Person” in the course of doing business  
8 within the meaning of Health and Safety Code section 25249.11(a) – “Person” means an  
9 individual, trust, firm, joint stock company, corporation, company, partnership, limited liability  
10 company, and association.”

11 17. Defendant is a corporation that manufactures, distributes, and/or offers for sale in  
12 the State of California, Products that contain the Listed Chemical.

13 18. Defendants DOES 1-10, which manufacture, distribute, and/or offers for sale in  
14 the State of California Products that contain the Listed Chemical, are each persons in the course  
15 of doing business within the meaning of Health and Safety Code section 25249.11. At this  
16 time, the true names and capacities of defendants DOES 1 through 10, inclusive, are unknown  
17 to Plaintiff, who, therefore, sues said defendants by their fictitious names pursuant to Code of  
18 Civil Procedure section 474. Plaintiff is informed and believes, and on that basis alleges, that  
19 each of the fictitiously named defendants is responsible for the acts and occurrences alleged  
20 herein. When ascertained, their true names and capacities shall be reflected in an amended  
21 complaint.

22 **VENUE AND JURISDICTION**

23 19. The Court has jurisdiction over this action pursuant to Health and Safety Code  
24 section 25249.7. Pursuant to California Constitution Article VI, section 10, the California  
25 Superior Court has “original jurisdiction in all causes except those given by statute to other trial  
26 courts.” The statute under which this action is brought does not specify any other trial courts  
27 that should have jurisdiction.

20. The Court has jurisdiction over Defendants based on Plaintiff's information and good faith belief that each Defendant is a person, firm, corporation, or association that is a citizen of the State of California, has sufficient minimum contacts in the State of California, and/or otherwise purposefully avails itself of the California market. Defendants' purposeful availment renders the exercise of personal jurisdiction by the Court consistent with traditional notions of fair play and substantial justice.

21. Venue is proper in this Court because Defendants manufacture, distribute, offer for sale, sell, and/or serve Products that contain the Listed Chemical. Liability for Plaintiff's causes of action, or some parts thereof, has accordingly arisen during the times relevant to this Complaint and Plaintiff accordingly seeks civil penalties and forfeitures imposed by statutes.

**FIRST CAUSE OF ACTION**

**(Violation of Proposition 65 - Against All Defendants)**

22. Plaintiff realleges and incorporates by reference, as if fully set forth herein, Paragraphs 1 through 15, inclusive.

23. Pursuant to Health and Safety Code section 25249.7(b), as a consequence of the above-described acts, Defendants are liable for a violation of Proposition 65.

**PRAYER FOR RELIEF**

18  
Wherefore, Plaintiff prays for judgment against Defendants as follows:

1. That the Court, pursuant to Health and Safety Code section 25249.7(a), preliminarily and permanently enjoin Defendants from manufacturing, distributing, offering for sale, selling, and/or serving in the State of California Products that contain the Listed Chemical without first providing a "clear and reasonable warning" under Proposition 65;

2. That the Court grant Plaintiff's reasonable attorneys' fees and costs of suit;

3. That the Court, pursuant to Health and Safety Code section 25249.7(b), assess civil penalties against Defendants in such amount as the Court deems appropriate up to \$2,500 per violation; and
