You have 30 CALENDAR DAYS after this summons and legal papers are served on you to file a written response at this court and have a copy served on the plaintiff. A letter or phone call will not protect you. Your written response must be in proper legal form if you want the court to hear your case. There may be a court form that you can use for your response. You can find these court forms and more information at the California Courts Online Self-Help Center (www.courtinfo.ca.gov/selfhelp), your county law library, or the courthouse nearest you. If you cannot pay the filing fee, ask the court clerk for a fee waiver form. If you do not file your response on time, you may lose the case by default, and your wages, money, and property may be taken without further warning from the court.

There are other legal requirements. You may want to call an attorney right away. If you do not know an attorney, you may want to call an attorney referral service. If you cannot afford an attorney, you may be eligible for free legal services from a nonprofit legal services program. You can locate these nonprofit groups at the California Legal Services Web site (www.lawhelpcalifornia.org), the California Courts Online Self-Help Center (www.courtinfo.ca.gov/selfhelp), or by contacting your local court or county bar association. **NOTE:** The court has a statutory lien for waived fees and costs on any settlement or arbitration award of \$10,000 or more in a civil case. 1 4. Defendants have failed to sufficiently warn consumers
2 and individuals in California about potential exposure to LEAD
3 and/or CADMIUM in connection with Defendants' manufacture,
4 import, sale, or distribution of Products in violation of
5 Proposition 65.

6 5. Plaintiff seeks injunctive relief compelling Defendants
7 to sufficiently warn consumers in California before exposing
8 them to LEAD and CADMIUM in Products (Health & Safety Code
9 Section 25249.7(a)). Plaintiff also seeks civil penalties against
10 Defendants for their violations of Proposition 65 along with
11 reasonable attorney's fees and legal costs (Health & Safety Code
12 Section 25249.7(b)).

13
14 **PARTIES**

15 6. Plaintiff CPA is an LLC operating in the State
16 of California dedicated to protecting the health of California
17 citizens through the elimination or reduction of toxic exposure
18 from consumer products. It brings this action in the public
19 interest pursuant to Health & Safety Code Section 25249.7.

20 7. Defendant Rhythm Superfoods, LLC ("Rhythm") is
21 a limited liability company that manufacturers and/or imports,
22 and/or sells and/or distributes Products in Los Angeles County
23 and throughout the State of California, within the meaning of
24 Health & Safety Code Section 25249.11.

2 8. Defendants DOES 1 through 100, inclusive, are sued
3 herein under fictitious names. Their true names and capacities
4 are unknown to Plaintiff. When their true names and capacities
5 are ascertained, plaintiff will amend this complaint by
6 inserting their true names and capacities herein. Plaintiff is
7 informed and believes and thereon alleges, that each of the
8 fictitiously named defendants is responsible in some manner for
9 the occurrences alleged in this complaint and that Plaintiff's
10 damages as alleged in this complaint were proximately caused by
11 such defendants.
12

13 9. Plaintiff is informed and believes and thereon
14 alleges, that at all times alleged in this complaint, each
15 defendant was the agent, alter ego, servant, joint venturer,
16 joint employer and/or employee, of each of the remaining
17 defendants, and in doing the things hereinafter alleged, was
18 acting within the course and scope of said relationships and
19 with the permission and consent of all other co-defendants. All
20 conduct was also ratified by Defendants and each of them.

23 **JURISDICTION AND VENUE**

24 10. California Constitution Article VI, Section 10, grants
25 the Superior Court original jurisdiction in all cases except
26 those given by statute to other trial courts. The Health and
27

1 Safety Code statutes upon which this action is based does not
2 give jurisdiction to any other Court. As such, this Court has
3 jurisdiction over this action.

4 11. Venue is proper in Los Angeles County Superior Court
5 pursuant to Code of Civil Procedure Sections 394, 395 and 395.5
6 as wrongful conduct as alleged in this complaint has occurred
7 and continues to occur in this County.

8 12. Defendants have sufficient minimum contacts in the
9 State of California or otherwise purposefully avail themselves
10 of the California market. Exercising jurisdiction over
11 Defendants would therefore be consistent with traditional
12 notions of fair play and substantial justice.

13
14 **CAUSES OF ACTION**

15 **FIRST CAUSE OF ACTION**

16 **(Violation of Proposition 65 - Against all Defendants**

17 13. Plaintiff incorporates by reference herein, each and
18 every allegation set forth above in this complaint.

19 14. Proposition 65 mandates that California citizens be
20 informed about exposures to chemicals that cause cancer, birth
21 defects, and other reproductive harm.

22 15. More than sixty days prior to the filing of this
23 lawsuit naming each Defendant, Plaintiff issued a 60-Day Notice
24 Of Violation dated July 5, 2022 ("Notice") as required by and
25 in compliance with Proposition 65. Plaintiff provided said

1 Notice to the various required public enforcement agencies along
2 with a Certificate of Merit. The Notice alleged that Defendants
3 violated Proposition 65 by failing to sufficiently warn
4 consumers in California of the health hazards associated with
5 exposure to LEAD and CADMIUM contained in their Products.

6 16. The appropriate public enforcement agencies provided
7 with the Notice failed to commence and diligently prosecute a
8 cause of action against Defendants.

9 17. At all times relevant herein, Defendants manufactured
10 and/or imported and/or sold and/or distributed Products
11 containing LEAD and CADMIUM, including, but not limited to, the
12 Product named in paragraph one of this complaint in violation of
13 Health and Safety Code Sections 25249.6 et. seq. Plaintiff is
14 informed and believes and thereon alleges that such violations
15 have continued after receipt of the Notice described above and
16 such conduct will continue to occur into the future.

17 18. In manufacturing, importing, selling and/or
18 distributing Products, including, but not limited to the Product
19 named in paragraph one of this complaint, Defendants failed to
20 provide a clear and reasonable warning to consumers in the State
21 of California who may be exposed to LEAD and CADMIUM through
22 reasonably foreseeable use of the Products.

23 19. The Products exposed individuals to LEAD and CADMIUM
24 through direct ingestion. This exposure is a natural and
25 foreseeable consequence of Defendants placing the Products into
26

1 the stream of commerce. As such Defendants intend that consumers
2 will ingest said Products, exposing them to LEAD and CADMIUM.

3 20. Defendants knew or should have known that their
4 Products contained LEAD and CADMIUM and exposed individuals to
5 LEAD and CADMIUM as described above in this complaint. The
6 Notice described above in this complaint informed Defendants of
7 the presence of LEAD and CADMIUM in their Products. Likewise,
8 media coverage concerning LEAD and CADMIUM related chemicals
9 in consumer products provided "Constructive Notice" to
10 Defendants. Defendants' actions, therefore, were deliberate and
11 not accidental.
12

13 21. Individuals exposed to LEAD and CADMIUM contained in
14 Defendants' Products through direct ingestion resulting from
15 reasonably foreseeable use of the Products have suffered and
16 continue to suffer irreparable harm. There is no other plain,
17 speedy or adequate remedy at law other than the relief requested
18 in this complaint.
19

20 22. Defendants are liable for a maximum civil penalty of
21 \$2,500.00 per day for each violation of Proposition 65 pursuant
22 to Health and Safety Code Section 252497(b). Injunctive relief
23 is also appropriate pursuant to Health and Safety Code Section
24 25249.7(a).

PRAYER FOR RELIEF

Wherefore, Plaintiff prays for judgment against Defendants, and each of them, as follows:

1. Civil penalties in the amount of \$2,500.00 per day for each violation of the law as described above in this complaint. Plaintiff alleges that damages total a minimum of \$1,000,000.00;
2. A preliminary and permanent injunction against Defendants from manufacturing, importing, selling and/or distributing Products in California without providing a clear and reasonable warning as required by Proposition 65 and related regulations;
3. Reasonable attorney's fees and costs of suit;
4. Pre-Judgement interest as allowed by law; and
5. Such other and further relief as may be just and proper.
