


I.

INTRODUCTION

1. This Complaint is a representative action brought by Environmental Health Advocates, Inc. ("Plaintiff") in the public interest of the citizens of the State of California ("the People"). Plaintiff seeks to remedy Defendant's failure to inform the People of exposure to Titanium Dioxide (airborne, unbound particles of respirable size) ("TiO2"), a known carcinogen. Defendant exposes consumers to TiO2 by manufacturing, importing, selling, and/or distributing face powder products including but not limited to the Last Act Translucent Setting Powder ("Products"). Defendant knows and intends that customers will use Products containing TiO2. Below are pictures of TiO2 particles found in an exemplar of Defendant's Products:





- 2. Under California's Safe Drinking Water and Toxic Enforcement Act of 1986, California Health and Safety Code, section 25249.6 et seq. ("Proposition 65"), "[n]o person in the course of doing business shall knowingly and intentionally expose any individual to a chemical known to the state to cause cancer or reproductive toxicity without first giving clear and reasonable warning to such individual..." (Health & Safety Code, § 25249.6.)
- 3. California identified and listed Titanium Dioxide (airborne, unbound particles of respirable size) ("TiO2") as a chemical known to cause cancer as early as September 2, 2011.
- 4. Defendant failed to sufficiently warn consumers and individuals in California about potential exposure to TiO2 in connection with Defendant's manufacture, import, sale, or distribution of Products. This is a violation of Proposition 65.

1	5. Plaintiff seeks injunctive relief compelling Defendant to sufficiently warn consumers in
2	California before exposing them to TiO2 in Products. (Health & Safety Code, § 25249.7(a).) Plaintiff
3	also seeks civil penalties against Defendant for its violations of Proposition 65 along with attorney's
4	fees and costs. (Health & Safety Code, § 25249.7(b).)
5	II.
6	<u>PARTIES</u>
7	6. Plaintiff ENVIRONMENTAL HEALTH ADVOCATES, INC. ("Plaintiff") is a
8	corporation in the State of California dedicated to protecting the health of California citizens through
9	the elimination or reduction of toxic exposure from consumer products. It brings this action in the public
10	interest pursuant to Health and Safety Code, section 25249.7.
11	7. Defendant JACLYN COSMETICS, LLC ("JC") is a limited liability company
12	organized and existing under the laws of Delaware. JC is registered to do business in California, and
13	does business in the County of San Francisco, within the meaning of Health and Safety Code, section
14	25249.11. JC manufactures, imports, sells, or distributes the Products in California and San Francisco
15	County.
16	8. Plaintiff does not know the true names and/or capacities, whether individual, partners,
17	or corporate, of the defendant sued herein as DOES 1 through 100, inclusive, and for that reason sues
18	said defendants under fictitious names. Plaintiff will seek leave to amend this Complaint when the true
19	names and capacities of these defendants have been ascertained. Plaintiff is informed and believes and
20	thereon alleges that these defendants are responsible in whole or in part for the remedies and penalties
21	sought herein.
22	9. At all times mentioned, Defendants were the agents, alter egos, servants, joint venturers,
23	joint employers, or employees for each other. Defendants acted with the consent of the other Co-
24	Defendants and acted within the course, purpose, and scope of their agency, service, or employment.
25	All conduct was ratified by Defendants, and each of them.

1	III.	
2	VENUE AND JURISDICTION	
3	10. California Constitution Article VI, Section 10 grants the Superior Court original	
4	jurisdiction in all cases except those given by statute to other trial courts. The Health and Safety Cod	
5	statute upon which this action is based does not give jurisdiction to any other court. As such, this Cour	
6	has jurisdiction.	
7	11. Venue is proper in San Francisco County Superior Court pursuant to Code of Civ	
8	Procedure, sections 394, 395, and 395.5. Wrongful conduct occurred and continues to occur in the	
9	County. Defendant conducted and continues to conduct business in this County as it relates to Product	
10	12. Defendant has sufficient minimum contacts in the State of California or otherwis	
11	purposefully avail itself of the California market. Exercising jurisdiction over Defendant would be	
12	consistent with traditional notions of fair play and substantial justice.

14	CAUSES OF ACTION	
15	FIRST CAUSE OF ACTION	
16	(Violation of Proposition 65 – Against all Defendants)	
17	13. Plaintiff incorporates by reference each and every allegation contained above.	
18	14. Proposition 65 mandates that citizens be informed about exposures to chemicals that	
19	cause cancer, birth defects, and other reproductive harm.	
20	15. Defendant manufactured, imported, sold, and/or distributed Products containing TiO	
21	in violation of Health and Safety Code, section 25249.6 et seq. Plaintiff is informed and believes suc	
22	violations have continued after receipt of the Notice (defined infra) and will continue to occur into the	
23	future.	
24	16. In manufacturing, importing, selling, and/or distributing Products, Defendant failed t	
25	provide a clear and reasonable warning to consumers and individuals in California who may be expose	
26	to TiO2 through reasonably foreseeable use of the Products.

1 PRAYER FOR RELIEF 2 Wherefore, Plaintiff prays for judgment against Defendant as follows: 3 Civil penalties in the amount of \$2,500 per day for each violation. Plaintiff alleges that 4 damages total a minimum of \$1,000,000; 5 2. A preliminary and permanent injunction against Defendant from manufacturing, importing, selling, and/or distributing Products in California without providing a clear and reasonable 6 7 warning as required by Proposition 65 and related Regulations; 8 3. Reasonable attorney's fees and costs of suit; and 9 4.
