Action Filed: February 9, 2023

1 On February 9, 2023, Plaintiff Center for Environmental Health (“CEH”) filed its original
2 Complaint in this action. On October 13, 2023, CEH filed its First Amended Complaint (the
3 “operative Complaint”). On November 3, 2023, CEH amended the operative Complaint pursuant
4 to California Code of Civil Procedure § 474 (“November 3 Amendment”). The November 3
5 Amendment inadvertently included a party, Outdoor Voices, Inc., that was already named in the
6 operative Complaint. CEH hereby submits a corrected version of the November 3 Amendment to
7 amend the operative Complaint as follows:

8 1. By inserting the name Delta Galil USA, Inc. in place of the reference to
9 DOE 1 in each place that it appears in the operative Complaint. The Clothing Products at issue
10 for Delta Galil USA, Inc. are limited to Sports Bras.

11 2. By inserting the name Amer Sports Company in place of the reference to
12 DOE 3 in each place that it appears in the operative Complaint. The Clothing Products at issue for
13 Amer Sports Company are limited to Leggings.

14 3. By inserting the name Wilson Sporting Goods Co. in place of the reference
15 to DOE 4 in each place that it appears in the operative Complaint. The Clothing Products at issue
16 for Wilson Sporting Goods Co. are limited to Leggings.
