#### NATURE OF THE ACTION 1 2 This Complaint is a representative action brought by plaintiff Jay Epps in the public 1. 3 interest of the citizens of the State of California to enforce the People's right to be informed of the health hazard caused by exposures to toluene, which is a main ingredient found in clear and 4 5 colored furniture wax manufactured by Briwax International Inc. (the Products). The Products are 6 repackaged, stored, distributed, shipped and/or sold online and shipped to a consumer with an address in California (sold) by defendant Wayfair LLC (WAYFAIR or defendant). 7 8 2. By this Complaint, plaintiff seeks to remedy defendant's continuing failure to warn 9 consumers and businesses not covered by California's Occupational Safety Health Act, Labor 10 Code §§6300 et seq., about the risks of exposure to toluene in the Products that are distributed 11 and/or offered for online sale for use by California citizens. Individuals, consumers and 12 businesses not covered by California's Occupational Safety Health Act, Labor Code §§6300 et 13 seq., are referred to hereinafter as "consumers." 3. 14 Defendant has actual knowledge of the toluene content of Products which were and 15 continue to be offered for purchase and/or transacted through wayfair.com. 16 4. Under the Safe Drinking Water and Toxic Enforcement Act of 1986, codified at 17 Health & Safety Code §§25249.6 et seq. (Proposition 65), "[n]o person in the course of doing

business shall knowingly and intentionally expose any individual to a chemical known to the state
to cause cancer or reproductive toxicity without first giving clear and reasonable warning to such
individual..." Health & Safety Code §25249.6.

5. Pursuant to Proposition 65, on January 1, 1991, California identified and listed
toluene as a chemical known to cause birth defects and other reproductive harm. 27 Cal. Code
Regs. §27001(b). Toluene became subject to the "clear and reasonable warning" requirements of
the act twelve months later. Health & Safety Code §25249.8 and §25249.10(b).

25 6. Defendant imports, distributes, facilitates and/or otherwise offers for sale online the
26 Products without the mandated health hazard warning for developmental toxicity in California.
27 An example of a Product is Briwax Furniture Wax Polish - Cleans, Stains and Polishes, (1LB),

SKU AIWA1000. The universe of all toluene-containing furniture waxes, which are limited to

2 those branded by Briwax International Inc., at issue are, as follows:

22	7. Defendant's failure to warn consumers and other individuals in California of the
23	developmental hazard associated with exposures to toluene, which bears the chemical abstracts
24	service (CAS) number: 108-88-3, in conjunction with each online sale of the Products are
25	violations of Proposition 65 which subjects defendant to be enjoined of such further conduct as
26	well as assessed civil penalties for such acts. Health & Safety Code §25249.7(a) and (b)(1).

1	8. For defendant's violations and threatened violations of Proposition 65, plaintiff
2	seeks preliminary and permanent injunctive relief to compel defendant to provide purchasers of
3	the Products with the required warning regarding the specific health hazard associated with
4	exposures to toluene prior to sale. Health & Safety Code §25249.7(a).
5	9. Pursuant to Health & Safety Code §25249.7(b), plaintiff also seeks civil fines
6	against defendant for its violations of Proposition 65, dating back as far as May 30, 2021.
7	PARTIES

8 10. Plaintiff Jay Epps is a citizen of the State of California who is dedicated to
9 protecting the health of California citizens through the elimination or reduction of toxic exposures
10 from consumer products, and he brings this action in the public interest pursuant to Health &
11 Safety Code §25249.7(d).

12 11. WAYFAIR is person in the course of doing business within the meaning of Health
13 & Safety Code §§25249.6 and 25249.11.

14 12. WAYFAIR imports, distributes, sells and/or offers the Products for sale online and 15 are shipped to an address in California, or implies by its conduct that it imports, distributes, sells, 16 and/or offers the Products for sale online and are shipped to an address in California. One or more 17 of the Products offered for sale by WAYFAIR were or likely to have been supplied to it by entities 18 that are not subject to enforcement under Proposition 65 because: (i) they have fewer than ten 19 employees during all relevant periods; and/or (ii) do not have an agent for process of service in 20 California.

21

#### VENUE AND JURISDICTION

13. Venue is proper in the Superior Court for the County of San Francisco pursuant to
Code of Civil Procedure §§393, 395, and 395.5, because this Court is a court of competent
jurisdiction, because plaintiff seeks civil penalties against defendant, one or more instances of
wrongful conduct occurred, and continue to occur, in this county, and/or defendant conducted, and
continue to conduct business in San Francisco.

1	14. The California Superior Court has jurisdiction over this action pursuant to
2	California Constitution Article VI, section 10, which grants the Superior Court "original
3	jurisdiction in all causes except those given by statute to other trial courts." The statute under
4	which this action is brought does not specify any other basis of subject matter jurisdiction.
5	15. The California Superior Court has jurisdiction over defendant based on plaintiff's
6	information and good faith belief that defendant is a person, firm, corporation has a principal
7	office or association that is a citizen of the State of California, has sufficient minimum contacts in
8	the State of California, and/or otherwise purposefully avails itself of the California market.
9	Defendant's purposeful availment renders the exercise of personal jurisdiction (specific, limited or
10	both) by California courts consistent with traditional notions of fair play and substantial justice.
11	FIRST CAUSE OF ACTION
12	(Violation of Proposition 65)
13	16. Plaintiff realleges and incorporates by reference, as if fully set forth herein,
14	Paragraphs 1 through 15, inclusive.
15	17. In enacting Proposition 65, in the preamble to the Safe Drinking Water and Toxic
16	Enforcement Act of 1986, the People of California expressly declared their right "[t]o be informed
17	about exposures to chemicals that cause cancer, birth defects, or other reproductive harm."
18	18. Proposition 65 states, "[n]o person in the course of doing business shall knowingly
19	and intentionally expose any individual to a chemical known to the state to cause cancer or
20	reproductive toxicity without first giving clear and reasonable warning to such individual"
21	Health & Safety Code §25249.6.
22	19. On February 28, 2025, plaintiff served a 60-Day Notice of Violation (Notice),
23	together with the requisite certificates of merit, on WAYFAIR, the California Attorney General's
24	Office, and the requisite public enforcement agencies alleging that, as a result of defendant's sales
25	of Briwax-branded clear and colored furniture wax, consumers in California were and likely
26	continue to be exposed to toluene from the reasonably foreseeable use of the Products, without
27	them first receiving a "clear and reasonable warning" at the time of their online purchase of the

furniture wax on wayfair.com regarding the developmental harm associated with such exposures,
 as required by Proposition 65.

20. Defendant imported, distributed, facilitated for sale, sold, and/or offered the
Products for sale or use on its website in violation of Health & Safety Code §25249.6, as far back
as May 30, 2021 (relevant period). Defendant's violations likely have continued beyond its
receipt of the Notice. As such, defendant's violations are allegedly ongoing and, unless enjoined,
will continue to occur.

8 21. After receiving the Notice, no public enforcement agency has commenced and
9 diligently prosecuted a cause of action against defendant under Proposition 65 to enforce the
10 alleged violations that are the subject of plaintiff's sixty-day letter dated February 28, 2025.

11 22. The Products that defendant offers for sale and sold cause exposure to toluene as a
12 result of the reasonably foreseeable use. Defendant did not provide a compliant warning for the
13 risk of developmental toxicity linked to toluene exposure on its website in a clear and conspicuous
14 manner, if at all, during the relevant period.

15 23. Defendant has (and has had at all relevant times) actual knowledge that the Products
16 contain toluene.

17 24. Toluene is present in amounts up to 90% by weight in the Products, as indicated by
18 Briwax International Inc., in its safety data sheets (SDS). An example of an SDS is attached here
19 as Exhibit A. As a result, such Products expose consumers to the solvent by way of inhalation
20 during a reasonably foreseeable use.

21 25. The normal and reasonably foreseeable use of the Products has caused, and
22 continues to cause, consumer product exposures to toluene as defined by 27 California Code of
23 Regulations §25600.1(e) as set forth in the Notice.

24 26. Defendant knows that the normal and reasonably foreseeable use of the Products
25 exposes individuals to toluene through route of inhalation.

26 27. Defendant intends that exposures to toluene from the reasonably foreseeable use of
27 the Products will occur by its deliberate, non-accidental participation in the importation,

distribution, sale, and/or offering of the Products for sale or use to consumers and others in
 California.

3 28. Defendant failed to provide a "clear and reasonable warning" on its website to
4 those consumers and other citizens in California who have been, or who will be, exposed to
5 toluene through inhalation resulting from their use of the Products.

6 29. Contrary to the express policy and statutory prohibition of Proposition 65 enacted 7 directly by California voters, consumers exposed to toluene as a result of their use of the Products 8 that defendant sold without a "clear and reasonable" health hazard warning, have suffered, and 9 continue to suffer, irreparable harm for which they have no plain, speedy, or adequate remedy at 10 law.

30. Pursuant to Health & Safety Code §25249.7(b), as a consequence of the abovedescribed acts, defendant is liable for a maximum civil penalty of \$2,500 per day for each
violation.

14 31. As a consequence of the above-described acts, Health & Safety Code §25249.7(a)
15 also specifically authorizes the Court to grant injunctive relief against defendant.

**PRAYER FOR RELIEF** 

Wherefore, plaintiff prays for judgment against defendant as follows:

That the Court, pursuant to Health & Safety Code §25249.7(b), assess civil
 penalties against defendant, in the amount of \$2,500 per day for each violation that occurred since
 May 30, 2021;

2. That the Court, pursuant to Health & Safety Code §25249.7(a), preliminarily and
 permanently enjoin defendant from importing, distributing, or offering the Products for sale online
 in California without first providing a "clear and reasonable warning" regarding the harm
 associated with exposures to toluene unless they are reformulated to eliminate the toxicant;


4. That the Court, pursuant to Health & Safety Code §25249.7(a), mandate defendant
to contact each California online purchaser of the Products that were sold in violation of Health &
