1. INTRODUCTION

i

- 1.1 Plaintiff and Defendant. This Consent Judgment is entered into by and between plaintiff Whitney Leeman (hereafter "Leeman" or "Plaintiff") and defendant Signature Housewares, Inc., ("Signature" or "Defendant"), with Plaintiff and Defendant collectively referred to as the "Parties" and Leeman and Signature each being a "Party."
- 1.2 Plaintiff. Leeman is an individual residing in Northern California who seeks to promote awareness of exposures to toxic chemicals and improve human health by reducing or eliminating hazardous substances contained in consumer and industrial products.
- 1.3 General Allegations. Plaintiff alleges that Defendant has distributed and/or sold in the State of California certain tableware products with colored artwork, designs or markings on the exterior surface with materials in that colored artwork, designs or markings that contain lead and/or cadmium, which are listed pursuant to the Safe Drinking Water and Toxic Enforcement Act of 1986, California Health & Safety Code §§ 25249.5 et seq., also known as Proposition 65, to cause birth defects and other reproductive harm. Lead (and/or lead compounds) and cadmium shall be referred to herein as "Listed Chemicals."
- 1.4 **Product Descriptions.** The products that are covered by this Consent Judgment are defined as follows: ceramic mugs and other glass and ceramic tableware items sold or distributed by Defendant in California with colored artwork, designs or markings on the exterior surface including, by way of example and without limitation, products contained in the items listed at Exhibit A. Such products collectively are referred to herein as the "Products."
- 1.5 Notices of Violation. Beginning on September 3, 2004, Leeman served Defendant and various public enforcement agencies with documents, entitled "60-Day Notice of Violation" ("Notice") that provided Defendant and such public enforcers with notice that alleged that Defendant was in violation of Health & Safety Code § 25249.6 for failing to warn purchasers that certain products that it sold expose users in California to the Listed Chemicals.
- 1.6 Complaint. On December 8, 2004, Leeman, in the interest of the general public in California, filed a complaint (hereafter referred to as the "Complaint" or the "Action") in the Superior Court for the City and County of San Francisco against Defendant and Does 1 through

150, alleging violations of Health & Safety Code § 25249.6 based on the alleged exposures to one or more of the Listed Chemicals contained in certain products sold by Defendant.

- 1.7 No Admission. Defendant denies the material factual and legal allegations contained in Plaintiff's Notice and Complaint and maintains that all products that it has sold and distributed in California including the Products have been and are in compliance with all laws. Nothing in this Consent Judgment shall be construed as an admission by Defendant of any fact, finding, issue of law, or violation of law, nor shall compliance with this Agreement constitute or be construed as an admission by Defendant of any fact, finding, conclusion, issue of law or violation of law. However, this section shall not diminish or otherwise affect the obligations, responsibilities and duties of Defendant under this Consent Judgment.
- 1.8 Consent to Jurisdiction. For purposes of this Consent Judgment only, the Parties stipulate that this Court has jurisdiction over the allegations of violations contained in the Complaint and personal jurisdiction over Defendant as to the acts alleged in the Complaint, that venue is proper in the County of San Francisco, and that this Court has jurisdiction to enter this Consent Judgment and to enforce the provisions thereof.
- 1.9 Effective Date. For purposes of this Consent Judgment, "Effective Date" shall be June 15, 2005.

2. INJUNCTIVE RELIEF: WARNINGS AND REFORMULATION

2.1 Warning Obligations

- (a) Required Warnings. As of the Effective Date, Defendant shall not ship, distribute or offer for sale in California any Products containing one or more the Listed Chemicals (or supply any Products containing one or more of the Listed Chemicals to any entity for distribution, sale or use in California) unless warnings are given in accordance with one or more provisions in subsection 2.2 below.
- (b) Exceptions. The warning requirements set forth in subsections 2.1(a) and 2.2 below shall not apply to:
 - (i) any Products manufactured before the Effective Date; or

2.2 Clear and Reasonable Warnings

(a) Product Labeling. A warning may be given by affixing the following language to the packaging, labeling or directly on a Product by Defendant, its agents, the manufacturer, the importer, the distributor, or the retailer of the Product that states:

WARNING: The materials used as colored decorations on the exterior of this product contain lead and/or cadmium, chemicals known to the State of California to cause birth defects or other reproductive harm.

Warnings issued for Products pursuant to this subsection shall be prominently placed with such conspicuousness as compared with other words, statements, designs, or devices as to render it likely to be read and understood by an ordinary individual under customary conditions of use or purchase. For purposes of this subsection, a warning statement or sticker placed on the bottom of the product packaging is not an adequate warning. Similarly, for purposes of this Consent Judgment, a warning insert that is placed inside the product packaging that is not intended to be opened prior to leaving the retail establishment is deemed not reasonably calculated to transmit the health hazard warning to the individual prior to purchase.

Any changes to the language or format of the warning required by this subsection shall only be made following: (1) written approval from the California Attorney General's Office, provided that written notice of at least fifteen (15) days is given to Plaintiff for the opportunity to comment; or (2) Court approval.

- (b) Point-of-Sale Warnings. Defendant may satisfy its warning obligations, where applicable, by arranging for signs to be posted at retail outlets or other locations in the State of California at which Products are sold directly to individuals, in accordance with the terms specified in subsections 2.2(b)(i), 2.2(b)(ii) and 2.2(b)(iii).
- (i) Point-of-Sale warnings may be provided through one or more signs posted at or near the point of sale or display of the Products that state:

WARNING: The materials used as colored decorations on the exterior of this [glass or ceramic] product contain lead and/or cadmium, chemicals known to the State of California to cause birth defects or other reproductive harm.

Where Covered Products are sold in proximity to other like items that do not require a warning (e.g., Reformulated Products as defined in section 2.3), the following statement must be used:1

> The materials used as colored decorations on the WARNING: exterior of the following glass and/or ceramic products sold in this store contain lead and/or cadmium, chemicals known to the State of California to cause birth defects or other reproductive harm:

IDISPLAY LIST OF EACH SPECIFIC PRODUCT FOR WHICH WARNING IS REQUIRED!

A point-of-sale warning provided pursuant to subsection 2.2(b)(i) (ii) shall be prominently placed with such conspicuousness as compared with other words, statements, designs, or devices as to render it likely to be read and understood by an ordinary individual under customary conditions of purchase and shall be placed or written in a manner such that the consumer understands to which specific Products the warnings apply so as to minimize, if not eliminate, the chances that an overwarning situation will arise.

If Signature intends to utilize point-of-sale warnings to comply with (iii) this Consent Judgment, it must provide advanced notice to each entity to whom it ships the Products for sale in California and expects to use point-of-sale warning signs and obtain the written consent of such entity that it will transmit the warning sign to its customers as required in section 2.2 herein before shipping Products requiring a warning unless warnings will be provided for such products pursuant to subsection 2.2(a). Such notice shall include specific posting instructions and any required warning materials (including, as appropriate, signs and/or stickers).

Signature shall not be found to have violated this Consent Judgment if it has complied with the terms of this Consent Judgment and has transmitted the requisite warnings in the manner provided herein.

Any changes to the language or format of the warning required for (iv) Products by this subsection shall only be made following: (1) written approval from the California Attorney General's Office, provided that written notice of at least fifteen (15) days is given to Plaintiff for the opportunity to comment; or (2) Court approval.

(c) Internet Sales

For Products that require a warning pursuant to this Consent Judgment and that are sold by Defendant from the Internet to a California address, a warning containing the language in subsection 2.2 shall be included on the website pursuant to subsection 2.2(a), and in the manner prescribed in subsection 2.2(c)(i) below. Any warnings given on the website shall identify the specific Products so as to minimize, if not eliminate, the chances that an "overwarning" situation will arise.

(i) Internet Web Sites

The warning text set forth in Section 2.2(a), or a link to a page containing such warning text, shall be displayed either (a) on the same page on which a Product is displayed, (b) on the same page as any order form for a Product, (c) on the same page as the price for any Product, (d) on one or more pages displayed to a purchaser over the Internet or via electronic mail during the checkout and order confirmation process for sale of a Product, or (e) in any manner such that is likely to be read and understood by an ordinary individual under customary conditions of purchase of a Product, including the same language as that appearing in subsection 2.2. If a link is used, it shall state "Warning information for California residents," and shall be of a size equal to the size of other links on the page. No warning shall be required under this subsection if Signature does not sell Products via the Internet to California addresses.

(ii) Any changes to the language or format of the warning required for Products by this subsection shall only be made following: (1) written approval from the

California Attorney General's Office, provided that written notice of at least fifteen (15) days is given to Plaintiff for the opportunity to comment; or (2) Court approval.

2.3 Reformulation Standards. The following subsections 2.3.1, 2.3.2 and 2.3.3 set forth the specifications which the Products must meet in order to be sold without a Proposition 65 warning. For purposes of this section, the following definitions apply:

"Exterior Decorations" is defined as all colored artwork, designs and/or markings on the exterior surface of the Product.

"Lip and Rim Area" is defined as the interior and exterior top 20 millimeters of a hollowware Product, as defined by American Society of Testing and Materials Standard Test Method C927-99.

"No Detectable lead or cadmium" shall mean that neither lead nor cadmium is detected at a level above .02% (for lead) or .08% (for cadmium) by weight, respectively, using a sample size of the materials in question measuring approximately 50-100 mg and a test method of sufficient sensitivity to establish a limit of quantitation of less than 200 ppm.²

"Reformulated Product" refers to any Product that meets the reformulation standards described in section 2.3 as set forth below.

2.3.1 Food and Beverage Use Glassware Products. Any glassware Product that is to be used for the storage, consumption or serving of food or beverages is a Reformulated Product if it satisfies either standard outlined in subsection 2.3.1 (a) or (b), subject to the following qualifications:

If the Product is decorated in the Lip and Rim Area, it must also satisfy subsection 2.3.1(c) to be considered a Reformulated Product.

(a) Wipe Test-Based Standard. The Product must produce a test result no higher than 1.0 micrograms (ug) of lead or 8.0 ug of cadmium when applied to all of the decorated portions of the exterior surface of the Product performed as outlined in NIOSH method

² If the decoration is tested after it is affixed to the Product, the percentage of the Listed Chemical by weight must relate only to the decorating material and must not include any quantity attributable to non-decorating material (e.g. the ceramic substrate).

- (c) Lip and Rim Area Exterior Decoration. If the Product contains Exterior Decorations in the Lip and Rim Area:
- (i) Any Exterior Decorations that extend into the Lip and Rim Area must only utilize decorating materials that contain No Detectable lead or cadmium.
- 2.3.2 Food and Beverage Use Ceramic Products. Any Ceramic Product that is to be used for the storage, consumption or serving of food or beverages is a Reformulated Product if it satisfies either standard outlined in subsection 2.3.2 (a) or (b) or (c), subject to the following qualifications:

If the Product is decorated in the Lip and Rim Area, it must satisfy subsection 2.3.2(d) to be considered a Reformulated Product.

- (a) Wipe Test-Based Standard. The Product must produce a test result no higher than 1.0 micrograms (ug) of lead or 8.0 ug of cadmium when applied to all of the decorated portions of the exterior surface of the Product performed as outlined in NIOSH method no. 9100.
- (b) Decorating Material Content-Based Standard. The Exterior Decorations, exclusive of the Lip and Rim Area, must only utilize decorating materials that contain six one-hundredths of one percent (0.06%) lead by weight or less AND forty-eight one-hundredths of one percent (0.48%) cadmium by weight or less, as measured either before or after

Reformulation Commitment. Signature hereby commits to undertake good faith 2.4 efforts to ensure that as many Products as reasonably possible that it offers for sale in California after January 1, 2006 shall qualify as Reformulated Products with the commitment that at least 80% (eighty percent) of the Products manufactured on or after December 31, 2006 shall qualify as Reformulated Products, and with the further commitment to undertake all commercially reasonable efforts to ensure that 100% (one-hundred percent) of the Products reasonably likely to be sold in California after January 1, 2008, qualify as Reformulated Products.

MONETARY PAYMENTS. 3.

Payments Pursuant to Health & Safety Code § 25249.7(b). Pursuant to 3.1 Health & Safety Code Section 25249.7(b), Defendant shall pay \$10,000. This payment shall be made payable to "Chanler Law Group in Trust For Whitney R. Leeman," and shall be delivered to Plaintiff's counsel on or before June 15, 2005, at the following address:

- (a) In the event that Defendant pays any sum pursuant to this section and the Consent Judgment is not thereafter approved and entered by the Court, Leeman or her counsel shall return any funds paid under this agreement within fifteen (15) days of receipt of a written request from Defendant following notice of the issuance of the Court's decision.
- The Parties agree that Defendant's potential interest in and ability to **(b)** acquire and market Reformulated Products is to be accounted for in this section and, since it is not a remedy provided for by law, the absence of Defendant previously acquiring, manufacturing, marketing or selling Reformulated Products is not relevant to the establishment of a penalty amount pursuant to section 3.1 above.
- Apportionment Pursuant to Health & Safety Code § 25192. After Court 3.2 approval of this Consent Judgment pursuant to section 6, all monies received pursuant to section 3.1 shall be apportioned by Plaintiff in accordance with Health & Safety Code § 25192, with 75%

of these funds remitted to the State of California's Office of Environmental Health Hazard Assessment and the remaining 25% of these monies retained by Plaintiff as provided by Health & Safety Code § 25249.12(d). Plaintiff shall bear all responsibility for apportioning and paying to the State of California the appropriate sums paid in accordance with this section.

REIMBURSEMENT OF FEES AND COSTS 4.

The Parties acknowledge that Plaintiff and her counsel offered to resolve this dispute without reaching terms on the amount of fees and costs to be reimbursed to them, thereby leaving this fee issue to be resolved after the material terms of the agreement had been settled. Defendant then expressed a desire to resolve the fee and cost issue shortly after the other settlement terms had been finalized. The Parties then attempted to (and did) reach an accord on the compensation due to Plaintiff and her counsel under the private attorney general doctrine codified at Code of Civil Procedure § 1021.5 for all work performed through the Effective Date of the Agreement. Under the private attorney general doctrine codified at Code of Civil Procedure §1021.5, Defendant shall reimburse Plaintiff and her counsel for fees and costs, incurred as a result of investigating, bringing this matter to Defendant's attention, litigating and negotiating a settlement in the public interest. Specifically, Defendant shall pay Plaintiff and her counsel \$30,000 for all attorneys' fees, expert and investigation fees, and litigation costs. The payment shall be made payable to the "Chanler Law Group" and shall be delivered to Plaintiff's counsel on or before June 15, 2005, at the following address:

Plaintiff's Release of Defendant. In further consideration of the promises and 5.1 agreements herein contained, and for the payments to be made pursuant to sections 3 and 4, Plaintiff, on behalf of herself, her past and current agents, representatives, attorneys, successors and/or assignees, and in the interest of the general public, hereby waives all rights to institute or participate in, directly or indirectly, any form of legal action and release all claims, including, without limitation, all actions, causes of action, in law or in equity, suits, liabilities, demands, obligations, damages, costs, fines, penalties, losses or expenses (including, but not limited to, investigation fees, expert fees and attorneys' fees) of any nature whatsoever, whether known or unknown, fixed or contingent (collectively "Claims"), against Defendant and each of its distributors, wholesalers, licensors, licensees, auctioneers, retailers, dealers, customers, owners, purchasers, users, parent companies, corporate affiliates, subsidiaries (specifically including Century Universe USA, Century Unia Corp. and Century Universe Japan, Co. LTD.) and their respective officers, directors, attorneys, representatives, shareholders, agents, and employees (collectively, "Defendant's Releasees") arising under or derived from Proposition 65 related to Defendant's or Defendant's Releasees' alleged failure to warn about exposures to or identification of Listed Chemicals contained in the Products and for all actions or statements made by Defendant or its attorneys or representatives, in the course of responding to alleged violations of Proposition 65 by Defendant.

The Parties further agree and acknowledge that this Consent Judgment is a full, final, and binding resolution of any direct or derivative violation of Proposition 65 that have been or could have been asserted in the Complaints against Defendant for its alleged failure to provide clear and reasonable warnings of exposure to or identification of Listed Chemicals in the Products.

It is specifically understood and agreed that the Parties intend that Defendant's compliance with the terms of this Consent Judgment resolves all issues and liability, now and in the future (so long as Defendant complies with the terms of the Consent Judgment) concerning Defendant and the Defendant's Releasees' compliance with the requirements of Proposition 65 as to the Listed

Chemicals in the Products.

5.2 Defendant's Release of Plaintiff. Defendant and Defendant Releasees waive all rights to institute any form of legal action against Plaintiff, or her attorneys or representatives, for all actions taken or statements made by Plaintiff and her attorneys or representatives, in the course of seeking enforcement of Proposition 65 in this Action.

6. COURT APPROVAL

This Consent Judgment is not effective until it is approved and entered by the Court and shall be null and void if, for any reason, it is not approved and entered by the Court within one year after it has been fully executed by all Parties, in which event any monies that have been provided by Defendant pursuant to section 3 and section 4 above, shall be refunded within fifteen (15) days.

7. SEVERABILITY

If, subsequent to court approval of this Consent Judgment, any of the provisions of this Consent Judgment are held by a court to be unenforceable, the validity of the enforceable provisions remaining shall not be adversely affected.

8. ATTORNEYS' FEES

In the event that a dispute arises with respect to any provision(s) of this Consent

Judgment, the prevailing party shall, except as otherwise provided herein, be entitled to recover
reasonable and necessary costs and reasonable attorneys' fees incurred from the resolution of such
dispute.

9. GOVERNING LAW

The terms of this Consent Judgment shall be governed by the laws of the State of California and apply within the State of California. In the event that Proposition 65 is repealed or is otherwise rendered inapplicable by reason of law generally, or as to the Products specifically, then Defendant shall have no further obligations pursuant to this Consent Judgment with respect to, and to the extent that, those Products are so affected.

A noticed motion to enter the Consent Judgment will then be served on the Attorney General's Office at least forty-five (45) days prior to the date a hearing is scheduled on such motion in the Superior Court for the City and County of San Francisco unless the Court allows a shorter period of time.
