19 This Consent Judgment is entered into by and between As You Sow (“Plaintiff”) and
20 Vitacost.com (“Defendant”) and shall be effective upon entry (the “Effective Date”) by the court.
21 Plaintiff and Defendant (each a “Party” and collectively, “the Parties”) agree to the terms and
22 conditions set forth below. This Consent Judgment applies solely to products manufactured,
23 distributed or sold under the Nutraceutical’s Science Institute (NSI), Walker Diets, Smart Basics
24 and Cosmesutical Sciences Institute (CSI) brands and set forth on Exhibit A (or properly added to
25 Exhibit A subsequent to the Effective Date, as more fully described herein below), and does not
26 apply to any other branded product lines manufactured, distributed or sold by Defendant.

27 1. INTRODUCTION

1.1 Plaintiff is a Section 501(c)(3) non-profit foundation dedicated to, among other causes, the protection of the environment, the promotion of human health, the improvement of

1 worker and consumer rights, environmental education, and corporate accountability. Plaintiff is
2 based in San Francisco, California and incorporated under the laws of the State of California.

3 1.2 Defendant directly or indirectly sells finished herbal products for ingestion to
4 California consumers under the Nutraceutical's Science Institute (NSI), Walker Diets, Smart
5 Basics and Cosmesutical Sciences Institute (CSI) branded product lines. Plaintiff alleges that
6 certain of the products contain lead, a chemical listed by the State of California as known to
7 cause cancer and reproductive toxicity pursuant to the Safe Drinking Water and Toxic
8 Enforcement Act of 1986 ("Proposition 65"), California Health and Safety Code § 25249.5 et
9 seq.; Title 27, California Code of Regulations § 25000 et seq. For purposes of this Consent
10 Judgment only, each of the products is deemed to be a "food" within the meaning of Title 27,
11 California Code of Regulations § 25501.

12 1.3 The specific Nutraceutical's Science Institute (NSI), Walker Diets, Smart Basics
13 and Cosmesutical Sciences Institute (CSI) products Plaintiff alleges contain lead and which are
14 covered by this Consent Judgment as of the Effective Date are set forth in Exhibit A hereto (the
15 "Products"). Any products not set forth in Exhibit A hereto are not subject to the injunctive
16 provisions herein, except as specifically provided in Section 9: *New Products*, and are not
17 covered by the release of liability set forth in Section 6 herein.

18 1.4 Pursuant to Health & Safety Code § 25249.8: (a) on February 27, 1987, the State
19 of California listed the chemical lead as a chemical known to cause reproductive toxicity; and (b)
20 on October 1, 1992, the State of California listed the chemicals lead and lead compounds as
21 chemicals known to cause cancer.

22 1.5 Beginning on February 27, 2008 and again on or about November 5, 2008,
23 Plaintiff served on Defendant and each of the appropriate public enforcement agencies "60-Day
24 Notices" that provided Defendant and the public enforcement agencies with a notice alleging that
25 Defendant was in violation of Proposition 65 for failing to warn the purchasers and individuals
26 using the Products that the use of the Products exposes them to certain chemicals known to the
27 State of California to cause cancer and/or reproductive toxicity (each, a "60-Day Notice"). A
copy of each such 60-Day Notice issued to Defendant is attached hereto as Exhibit B. Defendant

1 stipulates for the purpose of this Consent Judgment only that the 60-Day Notices sent to it are
2 adequate to comply with Title 27, California Code of Regulations §25903.

3 **1.6** On August 4, 2008, Plaintiff filed a Complaint (the "Action") in San Francisco
4 Superior Court, alleging violations of Proposition 65. Plaintiff brings the Action in the public
5 interest. Plaintiff has provided 60-Day Notice(s) to Defendant and the appropriate public
6 enforcement agencies and none of the public enforcement agencies has commenced and begun
7 diligently prosecuting an action against Defendant for such alleged violations.

8 **1.7** For purposes of this Consent Judgment, each Party stipulates that venue is proper
9 and that this Court has subject matter jurisdiction over the allegations contained in the Action.
10 Defendant stipulates it employs ten (10) or more employees and employed ten (10) or more
11 employees for one year prior to the date of the first 60-Day Notice Letter. The Parties enter into
12 this Consent Judgment to settle disputed claims between them and to avoid prolonged litigation.
13 By execution of this Consent Judgment, Defendant does not admit any facts, violations of law,
14 conclusions of law, the applicability of Proposition 65, or the applicability or violation of any
15 other law or standard governing warnings or disclosures in connection with the manufacture,
16 packaging, labeling, distribution and/or sale of the Products. Except for the stipulations made in
17 Sections 1.5 and 1.7 by Defendant, nothing in this Consent Judgment shall be construed as an
18 admission by Defendant of any fact, issue of law, conclusion of law, or violation of law, nor shall
19 compliance with this Consent Judgment constitute or be construed as an admission by Defendant
20 of any fact, issue of law, conclusion of law, or violation of law. Except for the stipulations made
21 in this Section 1.7 by Plaintiff, nothing in this Consent Judgment shall be construed as an
22 admission by Plaintiff of any fact, issue of law, conclusion of law, or violation of law, nor shall
23 compliance with this Consent Judgment constitute or be construed as an admission by Plaintiff of
24 any fact, issue of law, conclusion of law, or violation of law.

25 **1.8** Except as expressly provided herein, nothing in this Consent Judgment shall
26 prejudice, waive or impair any right, remedy or defense any Party may have in any other or
27 further legal proceeding. This paragraph shall not diminish or otherwise affect the obligations,
responsibilities, and duties of any Party to this Consent Judgment. This Consent Judgment is a

1 full and final settlement of all claims that were raised in the Action, or which could have been
2 raised in the Action arising out of the facts or conduct alleged therein. In the unlikely event that
3 Vitacost is sued again for violations of Proposition 65 for lead levels in any of the covered
4 products, and they have been in full compliance with this Consent Judgment, As You Sow will
5 take steps to appear and defend the reasonableness of all provisions contained in this Consent
6 Judgment and will defend its *res judicata* effect; however this shall not impose any duty to
7 indemnify or otherwise make pecuniary obligations on the part of AYS.

8 **2. INJUNCTIVE PROVISIONS**

9 **2.1 Defendant's Duty To Ascertain The Lead Content of Products On Or Before**
10 **Sixty Days Following the Effective Date.** On or before sixty (60) days following the Effective
11 Date, Defendant shall ascertain the concentration of lead in each of the Products as follows.

12 **2.1.1 Lead Testing Protocol.** To ascertain a Product's concentration of lead,
13 Defendant shall test the Product (or rely on testing of the Product by others provided it is
14 undertaken in the manner set forth herein), using inductively coupled plasma mass spectrometry
15 ("ICP-MS") under the protocol set forth in EPA Method 6020 as set forth in this Section 2.1.

16 **2.1.2 Additional Testing Protocols.** In the event that equally or more accurate
17 testing methods are developed or identified and accepted by the scientific community as accurate
18 enough to allow for detection and quantification of lead to ascertain compliance under this
19 Consent Judgment, any Party shall have the right to move the court to modify this Consent
20 Judgment as set forth in Section 8 herein, to allow testing by such equally or more accurate testing
21 method in addition to the methods authorized herein.

22 **2.1.3 Approved Laboratories.** Product or raw material testing may be
23 undertaken at Defendant's in-house laboratories or by third-party testing laboratories; however, all
24 third-party laboratory testing shall be performed only at laboratories that are certified, accredited,
25 or registered by an agency of the United States, Canada, California or another State of the United
26 States or Province of Canada, including but not limited to the U.S. Environmental Protection
27 Agency, the U.S. Food and Drug Administration, or the California Department of Health Services,
for the purposes of administering the specific protocol used in such testing. If a given agency does

1 not certify specific protocols for testing for lead in dietary supplements, the certification,
2 accreditation or registration customarily bestowed upon laboratories testing dietary supplements or
3 ingredients in dietary supplements for lead in accordance with that agency's standards shall be
4 required; if no such agency standards exist specifically for dietary supplements, then the standards
5 for foods shall be required.

6 **2.1.4 Sampling Protocol For Lead Content.** In fulfilling its duty to ascertain
7 the concentration of lead in each Product, Defendant may at its option, test (or rely on testing of
8 the Product by others) Representative Samples of the finished Products, or test (or rely on testing
9 of raw materials by others) Representative Samples of each of the raw materials comprising the
10 finished Product(s). Any results relied upon must use the analytical methods and sampling
11 requirements specified herein, except that a Defendant (or a laboratory conducting tests for
12 Defendant) may modify or adjust an analytical method if necessary to ensure accurate results in
13 light of the nature, composition, quantity, or other characteristic of the test specimen, the nature of
14 the test, or the specific equipment being used to conduct the test so as to enhance the quality and
15 reliability of the test results. If Defendant (or a laboratory conducting tests for Defendant)
16 modifies or adjusts any analytical method specified in this Consent Judgment, in the event of an
17 enforcement action by Plaintiff under this Consent Judgment contesting such modification or
18 adjustment, Defendant shall bear the burden of showing by a preponderance of the evidence that
19 the modification or adjustment was (a) necessary, appropriate and reasonable under the
20 circumstances; and (b) fully consistent with generally accepted scientific principles and practices
21 concerning analytical testing and test methods for Metals in foods, including dietary supplements.
22 The terms of Section 2 shall apply to all finished Product units listed on Exhibit A if and when
23 such Product units are manufactured by or for Defendant after the Effective Date.

24 **2.1.5 Representative Sampling.**

25 (a) Finished Products. "Representative Sampling" as used herein shall mean with respect
26 to the testing of finished Products, any of the following, at Defendant's option: (a) testing of two
27 (2) or more samples, each from a different final Product of the most recent manufacturing,
labeling or processing lot or batch ("Manufacturing Lot") of that Product; or (b) testing of one (1)

1 sample from the most recent Manufacturing Lot of a Product, provided that the one sample
2 actually tested is a composite of three (3) or more samples taken from three (3) or more final
3 Products from such Manufacturing Lot of that Product. Each of the three (3) or more samples
4 taken from three (3) or more final Products must be equal to the other samples (e.g., 4 capsules
5 taken from each of three final Products, or 1 gram taken from each of three final Products).

6 (b) Raw Materials. "Representative Sampling" as used herein shall mean with respect to
7 the testing of raw material, testing of one (1) or more samples from the most recent shipping lot
8 received by Defendant of each raw material comprising the Product, provided that the sample
9 actually tested is a composite of three (3) or more samples from the most recent shipping lot of
10 that raw material. Each of the three (3) or more raw material samples which comprise the
11 composite sample actually tested shall be equal to the other samples.

12 (c) First Two Year's Frequency of Sampling. During each of the two years after the
13 Effective Date, for purposes of documenting compliance with Sections 2.2, 2.4 and 9 of this
14 Consent Judgment after sixty (60) days from the Effective Date, Defendant shall conduct (or have
15 conducted on its behalf) Representative Sampling of each Product meeting the definition of either
16 Section 2.1.5(a) or 2.1.5(b), or any combination of the two, as Defendant shall elect in its sole
17 discretion. The Parties agree that this frequency of Representative Sampling of each Product for
18 the first two years after the Effective Date shall be the minimum amount of sampling required
19 under this Consent Judgment. Defendant shall retain laboratory test data documenting the
20 foregoing Representative Sampling with respect to each Product Defendant ships for sale to
21 California between the Effective Date and the second anniversary of the Effective Date. Such
22 laboratory test data for the initial two year testing period shall be retained for at least four years
23 from the date of testing.

24 (d) Sampling Frequency After Second Anniversary of Effective Date. After the second
25 anniversary of the Effective Date, Defendant shall conduct (or have conducted on its behalf)
26 Representative Sampling on raw materials or finished Products, as the case may be, but
27 Defendant may adjust the frequency of the sampling regime set forth in Section 2.1.5(c). Any
adjustments to the sampling regime shall be sufficient to allow Defendant to continue to

1 accurately determine levels of lead in Products or in raw materials. Any adjustments to the
2 sampling regime shall be based upon Defendant's consideration of the following factors: (i)
3 existing data, (ii) the variability of lead levels in a raw material or in a Product, as documented
4 through testing, (iii) the predictability of the distribution of the range of lead levels in a raw
5 material, based on prior laboratory test data, (iv) the amount of a raw material used in a finished
6 Product, and (v) other relevant considerations. In any proceeding to enforce this Consent
7 Judgment, Defendant bears the burden of showing by a preponderance of the evidence that any
8 testing regime adopted under this Section 2.1.5(d) is reasonable and is sufficient to accurately
9 determine lead levels in raw materials or finished Products. This Section 2.1.5(d) governs the
10 frequency of sampling, and does not alter the definitions of Representative Sampling set forth in
11 Sections 2.1.5(a), or (b), or the testing protocols set forth herein. Defendants are not limited to
12 providing only Representative Sampling data to Plaintiff in the event Plaintiff conducts
13 compliance monitoring under Section 2.1.6 or otherwise moves to enforce this Consent Judgment.

14 **2.1.6 Compliance Monitoring.** At any time following 60 days after the
15 Effective Date, Plaintiff may request that Defendant provide, within thirty-five (35) days of the
16 date of its request, documentation supporting the sale in California of any Product without the
17 health hazard warnings specified in this Consent Judgment. For the first two years after the
18 Effective Date, such requests may be made with respect to as many as twenty-five (25) percent,
19 annually, of the number of Products listed on Defendant's then current list of Products subject to
20 this Consent Judgment, up to a maximum of twenty (20) requests in total for the year, concerning
21 up to twenty (20) different Products in that year. After year two after the Effective Date, Plaintiff
22 may request information on no more than ten (10) percent, annually, of the number of Products
23 listed on Defendant's then current list of Products subject to this Consent Judgment, up to a
24 maximum of ten (10) requests in total for the year, concerning up to ten (10) different Products in
25 that year. After year three after the Effective Date, Plaintiff shall not be entitled to request
26 information pursuant to this Section 2.1.6, unless a violation of this Consent Judgment previously
27 was established within the three years preceding the date of the Plaintiff request, in which case
Plaintiff shall be entitled to tender up to twelve (12) requests in total for information respecting up

1 to twelve (12) different Products for up to one more year after the date of Plaintiff's request. For
2 any Product for which Plaintiff's request for such documentation is not provided within sixty (60)
3 days of the date of the request, such Product will be deemed sold in violation of this Consent
4 Judgment as to all sales in California of that Product after the date of Plaintiff's request through
5 the date upon which such documentation is received by Plaintiff and therefore will be subject to
6 the provisions of Section 3.1; provided, however, that Defendant's mere contesting of any
7 assertion by Plaintiff concerning inadequacies in the documentation produced to Plaintiff shall not,
8 in and of itself, be deemed a violation of this Section 2.1.6. For Plaintiff to establish a violation of
9 this Section, the documentation provided or other documentation must show that a health hazard
10 warning was required under this Consent Judgment. Violations of this Section 2.1.6 may be
11 enforced as specified hereinbelow and are not exclusive of other remedies, if any, available to
12 Plaintiff.

13 **2.1.7 Limited Exemptions from Testing.** Defendant need not test (or have
14 tested on its behalf) all excipients, fillers, flavors, colors, binders or other ingredients of uniform
15 manufacture or consistently uniform high purity ("Standardized Ingredients") if it reasonably and
16 in good faith believes, after conducting the research and analysis described below, that it can
17 demonstrate, with admissible evidence, such Standardized Ingredients do not contain lead at levels
18 that might cause or contribute to a violation of this Consent Judgment. Defendant's good faith
19 belief shall be based on periodic laboratory test data, vendor certifications, or other such
20 reasonable and appropriate information including consideration of the reliability and consistency
21 of the supplier, the nature of the ingredient, the amount used and other relevant scientific factors.
22 Defendant periodically shall monitor and evaluate such Standardized Ingredients for lead levels.
23 In the event that Plaintiff should move to enforce this Consent Judgment, Defendant bears the
24 burden of establishing by a preponderance of the evidence that any failure to test a Standardized
25 Ingredient for lead content was reasonable and in good faith, and must produce all such supporting
26 evidence in the context of the meet and confer process concerning enforcement of this Consent
27 Judgment contemplated under Section 8.1 herein. Defendant's failure to test a Standardized
Ingredient for lead content, in the absence of a reasonable and good faith belief that such

1 ingredient does not contain lead at levels that might cause or contribute to a violation of this
2 Consent Judgment, shall constitute a material breach of this Consent Judgment and be subject to
3 stipulated civil penalties as provided for herein if such failure to test causes or contributes to a
4 failure to provide a warning when required under Section 2.2 or causes or contributes to a
5 violation of Section 2.4 of this Consent Judgment.

6 **2.1.8 Product or Ingredient Specifications.** On or before the date that is sixty
7 (60) days after the Effective Date, Defendant shall establish, at its option, either: (a) specifications
8 for the lead content of all raw materials used in the Products, or (b) specifications for the lead
9 content in finished Products. Defendant shall not use raw materials which fail to meet the lead
10 specifications Defendant established for raw materials used in the manufacture of Products.
11 Defendant shall not ship for sale or use in California Products which fail to meet Defendant's
12 specifications for lead content in finished Products, unless such Products meet all terms of this
13 Consent Judgment, including the warning obligations in Section 2 and Section 9. Defendant may
14 from time to time adjust specifications for raw materials or for finished Products.

15 **2.1.9 Purchase of Testing Equipment.** On or before the date that is sixty (60)
16 days after the Effective Date, Defendant shall commence acquisition of an Inductively Coupled
17 Plasma Mass Spectrometer Varian 820 ICP-MS (Three Phase), recirculation chiller, SPS3
18 Autosampler, computer, monitor, software included and related digestion block and Cary 100 Bio
19 Spectrophotometer Series II Detector plus Cary WinUV Bio Suite operating software, Reference
20 Standards and NIST standards for USP testing for the purpose of providing in house testing for
21 lead. In compliance with this Consent Judgment, Defendant may utilize outside laboratories as
22 well.

23 **2.2 Provision of Clear and Reasonable Warnings.**

24 **2.2.1 On-Product Warnings.** On or before the date that is sixty (60) days
25 following the Effective Date, Defendant shall permanently cease and no longer ship for sale or use
26 in California any Products (as defined in Sections 1.3 and 9.1) which require a warning under the
27 terms of this Consent Judgment, unless each individual Product (in the form intended for sale to

1 the end-user) bears one of the warning statements specified below on its individual unit label or
2 unit packaging:

3 (a) (i) Subject to Sections 2.3 and 2.4, if use or consumption of the Product in
4 accordance with Defendant's label directions results in an exposure exceeding 0.50
5 micrograms/day of lead, then the warning shall state the following:

6 **WARNING: The use of this product will expose you to lead, a
7 substance known to the State of California to cause birth defects or other
8 reproductive harm.**

9 (ii) Subject to Sections 2.3 and 2.4, if use or consumption of the Product in
10 accordance with Defendant's label directions results in an exposure exceeding 0.50
11 micrograms/day of lead, and such use or consumption of the Product also results in
12 exposure to one or more additional reproductive toxicants for which a warning is
13 required to comply with Proposition 65, then the warning shall state the following:

14 **WARNING: The use of this product will expose you to lead, and other
15 substances known to the State of California to cause birth defects or other
16 reproductive harm.**

17 (iii) Subject to Sections 2.3 and 2.4, if use or consumption of the Product in
18 accordance with Defendant's label directions results in an exposure exceeding 0.50
19 micrograms/day of lead, and such use or consumption of the Product also results in
20 exposure to one or more carcinogens for which a warning is required to comply
21 with Proposition 65, then the warning shall state the following:

22 **WARNING: The use of this product will expose you to lead, and other
23 substances known to the State of California to cause cancer and birth defects
24 or other reproductive harm.**

25 (b) The warning statement shall be prominent and displayed on the label or packaging of
26 each Product with such conspicuousness, as compared with other words, statements, or designs,
27 so as to render it likely to be read and understood by an ordinary individual prior to purchasing or
using the Product. The warning statement shall be printed on the label or packaging in a font size

1 no smaller than any other precautionary statements or warnings printed on the Product's label or
2 packaging.

3 **2.2.2 Additional Warnings Concerning Mail Order & Internet Sales.** If a
4 Defendant sells a Product that requires a warning under this Consent Judgment, by mail order or
5 over the Internet to a purchaser in the State of California on or after the date that is sixty (60) days
6 after the Effective Date, the following additional requirements shall apply.

7 (a) For such mail order sales, the warning language required under this Consent Judgment
8 shall also be included in the mail order catalogue, either on the same page as any order form, or
9 on the same page(s) upon which the Product's price is listed, in the same type size as the
10 surrounding, non-heading text (this requirement shall be applicable only to all catalogues
11 featuring Products printed after the Effective Date). If Defendant determines, after a mail order
12 catalogue is printed, that a Product featured therein requires a warning under this Consent
13 Judgment, Defendant may provide a warning in compliance with Section 2.2.1 until the next
14 printing of a mail order catalogue featuring that Product.

15 (b) For such Internet sales, the warning language required under this Consent Judgment
16 shall be displayed in the same type size as the surrounding, non-heading text, either: (a) on the
17 same page upon which the Product is displayed or referenced; (b) on the same page as the order
18 form for the Product; (c) on the same page as the price for the Product is displayed; or (d) in a
19 dialogue box (which cannot be suppressed by "pop up" box blocking software) which appears
20 when a California address for delivery is provided by the consumer, so long as the dialogue box
21 appears prior to the completion of the internet sale and requires the consumer to affirmatively
22 accept receipt of the warning set forth in the dialogue box (which shall be displayed in the same
23 type size as the surrounding, non-heading text on the screen at the time of the appearance of the
24 dialogue box), as a condition precedent to completing the sale.

25 **2.3 Exceptions To Warning Requirements.** No Product that meets each of the
26 following criteria shall require a warning pursuant to this Consent Judgment:
27

1 **2.3.1 For Lead Warnings, Exposure Below “No Observable Effect Level.”**

2 Use or consumption of a Product causes total daily exposure¹ to lead of less than 0.5 micrograms
3 when consumed or used in accordance with the Defendant’s label directions, excluding any
4 naturally occurring lead, as defined for purposes of this Consent Judgment in Section 2.3.2
5 (“Naturally Occurring Lead”), in such Product. Prior to shipment for sale to California consumers,
6 Defendant shall provide consumer use instructions on the label or packaging of each individual
7 Product unit (in the form intended for sale to the end-user). If the consumer use instructions
8 include a range of consumption levels (e.g., “take 2 to 4 tablets daily”), then for purposes of
9 determining compliance with Sections 2.2, 2.4, 9 and otherwise under this Consent Judgment, the
10 highest dose instructed shall be the dose.

11 **2.3.2 “Naturally Occurring” Allowance For Lead for Products Shipped for**
12 **Sale After Sixty Days Following The Effective Date.**

13 (a) Initial Naturally Occurring Lead Level. Unless a Product contains a warning in
14 compliance with this Consent Judgment, the initial Naturally Occurring Lead level in any Product
15 subject to this Consent Judgment (as set forth in Exhibit A hereto) Defendant ships for sale or use
16 in California after the date that is sixty (60) days following the Effective Date, shall not, if listed
17 in Section 1 of Exhibit A hereto, exceed a concentration that will result in 2.25 micrograms lead
18 ingested/day as per, or shall not, if listed in Section 2 of Exhibit A hereto, exceed a lead
19 concentration of 2.0 micrograms per gram of ingested material, assuming the Product is used or
20 consumed in accordance with the Defendant’s consumer use instructions. Products where the
21 concentration results in lead levels that exceed: (i) this initial 2.25 micrograms ingested level; (ii)
22 this initial concentration of 2.0 micrograms per gram of ingested material; or (iii) any future
23 Naturally Occurring Lead level subsequently established pursuant to this Consent Judgment (plus
24 an additional 0.5 micrograms lead as allowed by regulation and under Section 2.3.1), shall be
25 subject to the warning requirements set forth in Sections 2.2.1, 2.2.2 and 9 herein, unless
26

27

¹ For purposes of this Consent Judgment only, the term “exposure” is deemed to mean
“ingestion”, consistent with Title 27, Cal. Code Regs., section 25102(i) (which defines the term
“expose” as “to cause to ingest....”).

1 Defendant can show by a preponderance of the evidence that all lead in such Products (except 0.5
2 micrograms ingested in a daily dose) is naturally occurring per 27 Cal. Code Reg. § 25501. If
3 Defendant in the future elects to make a showing that more than 2.25 micrograms of lead in the
4 daily dose (or more than 2.0 micrograms per gram of ingested material, depending upon whether
5 the product is listed under Section 1 or Section 2 of Exhibit A) is naturally occurring, Defendant
6 agrees to provide all information on which it relies to support such a showing to Plaintiff in the
7 context of the meet and confer process concerning enforcement of this Consent Judgment
8 contemplated under Section 8.1 herein. Defendant's failure to produce complete information
9 during the meet and confer process, or Defendant's failure to establish to the Court, based on
10 such information, by a preponderance of the evidence, that lead in excess of 0.5 micrograms in a
11 daily dose, plus Naturally Occurring Lead, is naturally occurring under the criteria in 27 Cal.
12 Code Reg. § 25501 shall constitute a material breach of this Consent Judgment and be subject to
13 stipulated civil penalties as provided for herein if a Product which requires a health hazard
14 warning under this Consent Judgment was sold in California without such warning. Nothing in
15 this Section 2.3.2 constitutes a waiver of Defendant's right to establish, in accordance with the
16 procedures set forth in Sections 2.3.2 and 8.1, that levels of metals other than lead are naturally
17 occurring under the criteria of 27 Cal. Code Reg. § 25501. The Parties agree that the initial 2.25
18 micrograms per day and the 2.0 micrograms per gram concentration of Naturally Occurring Lead
19 levels is the result of negotiations and a review of the available information and shall be
20 applicable to the Products subject to this Consent Judgment and shall have no application to other
21 products.

22 (b) Evaluation of Future Naturally Occurring Lead Levels. In recognition of the
23 possibility that the "lowest level feasible" of lead may change over time, the Parties agree that for
24 at least three years after the Effective Date, Defendant shall have the right to tender a statement of
25 determination to AYS as to whether an adjustment to the Naturally Occurring Lead level can be
26 supported by a preponderance of the evidence. If tendered, such statement of determination shall
27 be tendered to AYS on or before December 31st for the years 2009, 2010 and 2011. Such a
determination respecting the Naturally Occurring Lead level shall be made in good faith and be

1 based on Representative Sampling and "Feasibility." "Feasibility" for purposes of this Consent
2 Judgment shall mean consideration of the following: (1) the availability and reliability of a
3 supply to Defendant of raw materials in question; (2) the reasonable cost to Defendant of
4 Products or raw materials therein; (3) any resulting unreasonable increase in cost to a Defendant
5 to procure a Product or raw materials with lower levels of lead; (4) performance characteristics,
6 including formulation, performance, safety, taste, efficacy and stability, of any raw materials or
7 finished Product; (5) the lawfulness of alternatives (no alternative shall result in a violation of
8 law, or a breach of a standard of identity); and (6) other relevant and reasonable considerations.
9 If upon determination of Defendant a change in the Naturally Occurring Lead level is warranted
10 under the criteria above, then Defendant within sixty (60) days of the statement date may proceed
11 to modify this Consent Judgment in accordance with Section 8 herein. Defendant's obligations
12 under this Section 2.3.2(b) are without prejudice to any rights of Plaintiff under Section 8 or
13 otherwise herein. If either Party seeks to modify the initial or any subsequently established
14 Naturally Occurring Lead level as defined herein, such modification shall only be effective upon
15 an order by the Court, after a noticed motion, notice of which motion shall be served on the
16 Office of the Attorney General at least forty-five (45) days prior to the hearing date, and which
17 motion shall include the information supporting the request for modification.

18 (c) Defendant also shall be entitled to exclude from the calculation of the daily lead
19 exposure the amount of naturally occurring lead in the following non-herbal ingredients only, if
20 used in a Product: calcium, ferrous fumarate, zinc oxide, magnesium oxide, magnesium chloride,
21 magnesium hydroxide, zinc gluconate and potassium chloride. The amount of lead in each of
22 these ingredients deemed naturally occurring shall be conclusively and irrefutably presumed to be
23 the amount of lead that would be deemed naturally occurring under the consent judgment entered
24 on November 11, 1998 in *People v. Warner Lambert*, San Francisco Superior Court Case No.
25 984403.

26 **2.3.3 Conditions Under Which "Naturally Occurring" Allowance For Lead**
27 **Applies.** For purposes of compliance with this Agreement, Defendant shall be required to adhere
to 27 Cal. Code Reg. § 25501 and Defendant shall be entitled to exclude the amount of lead

1 specified in Section 2.3.2 pursuant to the provisions of this Agreement. Defendant shall bear the
2 burden of proof in establishing, by a preponderance of the evidence that, with respect to each
3 Product unit subject to an enforcement proceeding, the conditions specified in this Section 2.3.3
4 have been satisfied.

5 **2.4 Ban on Sales of Products Causing Exposures to Lead in Excess of 10**
6 **Micrograms Per Day.** No Product subject to this Consent Judgment may be shipped by
7 Defendant for sale in the State of California after sixty (60) days following the Effective Date if,
8 when used or consumed in accordance with the Defendant's label directions, it causes an
9 exposure to lead in excess of ten (10.0) micrograms/day.

10 **3. CIVIL PENALTIES**

11 **3.1 Stipulated Civil Penalties For Future Violations of This Agreement.**

12 Proposition 65 provides for civil penalties of up to \$2500 per violation per day, pursuant to
13 California Health & Safety Code § 25249.7. In the event that after sixty (60) days following the
14 Effective Date Defendant violates Sections 2 or 9 herein, the Parties stipulate that Defendants
15 shall be liable for a stipulated civil penalty in the amount of \$10.00 per unit item sold in violation
16 of this Consent Judgment, unless the Defendant's actual per unit sale price to the buyer was less
17 than \$10.00, in which case the stipulated penalty shall be fifty percent (50%) of the sale price
18 Defendant received from the relevant buyer for the Products at issue. Total civil penalties
19 concerning all Products sold in violation of this Consent Judgment shall not exceed \$75,000 for
20 such violations in any calendar year. Plaintiff may establish such violation(s) hereunder by a
21 preponderance of the evidence upon a duly noticed motion in the San Francisco Superior Court
22 and subject to the provisions of Section 8 herein. Plaintiff shall remit 75% of this amount to the
23 State of California pursuant to Health & Safety Code § 25249.12(b).

24 **3.2 Civil Penalty Assessment.** In recognition of Defendant's commitment to
25 purchase product testing equipment pursuant to Section 2.1.9 above, Defendant shall pay a
26 reduced civil penalty in the amount of \$12,000 to Plaintiff, pursuant to Health & Safety Code
27 § 25249.7(b). Plaintiff shall remit 75% of this amount to the State of California pursuant to
Health & Safety Code § 25249.12(b).

1 **3.3 Payment & Capital Improvements in Lieu of Additional Civil Penalties.**

2 Defendant shall make a payment in lieu of additional penalties in the amount of \$98,000 to
3 Plaintiff. Plaintiff shall forward at least one-half of these funds to California non-profit groups to
4 reduce exposures to toxic chemicals, and to increase consumer, worker and community awareness
5 of the health hazards posed by toxic chemicals. Any remaining funds shall be deposited in the As
6 You Sow Foundation Environmental Enforcement Fund and shall be used to reduce exposures to
7 toxic chemicals, and to increase consumer, worker and community awareness of the health
8 hazards posed by toxic chemicals. In deciding among the grantee proposals, the As You Sow
9 Board of Directors ("Board") takes into consideration a number of factors, including: (1) the
10 nexus between the alleged harm in the underlying case(s), and the grant program work; (2) the
11 potential for toxics reduction, prevention, remediation or education benefits to California
12 residents from the proposal; (3) the budget requirements of the proposed grantee and the alternate
13 funding sources available to it for its project; and (4) the Board's assessment of the grantee's
14 chances for success in its program work. Plaintiff shall ensure that all funds will be disbursed and
15 used in accordance with Plaintiff's mission statement, articles of incorporation, and bylaws and
16 applicable state and federal laws and regulations within one year of receipt. On or before sixty
17 (60) days after the Effective Date, Defendant shall order and commence the expenditure of at
18 least \$300,000 for the acquisition, installation, calibration, worker training, and related start up
19 costs associated with the testing equipment identified in Section 2.1.9.

20 **3.4 Penalties are not a credit.** No penalties paid herein shall be construed as a
21 credit against future new claims against Defendant.

22 **4. REIMBURSEMENT OF FEES AND COSTS**

23 **4.1 Reimbursement of Plaintiff's Investigative, Expert and Legal Fees and Costs.**

24 Defendant shall reimburse Plaintiff in the amount of \$40,000 for Plaintiff's reasonable
25 investigative, expert, and legal fees and costs incurred as a result of investigating and negotiating
26 a settlement in the public interest.
27

1 **5. PAYMENT OBLIGATIONS**

2 **5.1** Pursuant to Sections 3.2, 3.3 and 4.1 herein, Defendant agrees to remit the total
3 amount of \$150,000 to Plaintiff, payable to "As You Sow" (Employer Identification Number 94-
4 3169008) as follows: (a) an initial payment of \$25,000 within fifteen days of the Effective Date of
5 this Consent Judgment; (b) the balance of \$125,000 due in five equal months installments of
6 \$25,000 each, beginning on February 1, 2009 and continuing on March 1, 2009; April 1, 2009;
7 May 1, 2009; and June 1, 2009 until fully paid. In the event that any payments owed by
8 Defendant under this Consent Judgment is not remitted to Plaintiff or post-marked on or before its
9 due date, Defendant shall be deemed to be in default of its obligations under this Consent
10 Judgment. Plaintiff shall provide written notice to Defendant of any default; if Defendant fails to
11 remedy the default within two (2) business days of such notice, then all future payments due
12 hereunder shall become immediately due and payable, with the prevailing federal funds rate
13 applying to all interest accruing on unpaid balances due hereunder, beginning on the due date of
14 the funds in default.

15 **6. RELEASE OF LIABILITY**

16 **6.1 Release of Liability.** Plaintiff, on its own behalf, and on behalf of the general
17 public, waives all rights to institute or participate in, directly or indirectly, any claim or form of
18 legal action against Defendant, its officers, directors, employees, agents, attorneys,
19 representatives, shareholders, parents, subsidiaries, affiliates, divisions, predecessors, successors,
20 subdivisions, downstream distributors, downstream retailers, downstream customers, and
21 upstream suppliers (including manufacturers of the Products and manufacturers of the raw
22 materials of the Products) under Proposition 65 based upon Defendant's alleged failure to warn,
23 within the meaning of Proposition 65, about exposure to lead in any of the Products sold in
24 California or to California consumers on or before sixty (60) days after the Effective Date or
25 based on any other legal claim or theory that was or could have been alleged in the Action based
26 on the facts alleged in the Action.

27 **6.2 Release of Liability of Plaintiff.** Defendant waives all of its rights to institute any
claim, or form of legal action against Plaintiff, its officers, directors, employees, agents, attorneys

1 and representatives (the "Plaintiff Releasees") for all actions or statements made or undertaken by
2 the Plaintiff Releasees in the course of seeking enforcement of Proposition 65 through the Action.

3 **7. CONSENT JUDGMENT**

4 **7.1 Consent Judgment.** Upon execution of this [Proposed] Consent Judgment by all
5 Parties, Plaintiff shall promptly notice a Motion for Approval & Entry of Consent Judgment in
6 the San Francisco Superior Court pursuant to Title 11, Cal. Code of Regs. §3000, *et seq.* This
7 Motion shall be served upon all of the Parties to the Action and upon the California Attorney
8 General's Office. In the event that the Court fails to approve and order entry of the judgment, this
9 Consent Judgment shall become null and void upon the election of any Party as to them and upon
10 written notice to all of the Parties to the Action pursuant to the notice provisions herein. If this
11 Consent Judgment becomes null and void, or is not approved by the Court within one hundred
12 and eighty (180) days of its execution by all Parties, Plaintiff shall refund all sums paid by
13 Defendant pursuant to Sections 3.2, 3.3 and 4.1 within fifteen (15) days of written notice to
14 Plaintiff by Defendant that a refund is due. Defendant and Plaintiff shall use best efforts to
15 support entry of this Consent Judgment in the form submitted to the Office of the Attorney
16 General. If the Attorney General objects in writing to any term in this Consent Judgment, the
17 Parties shall use best efforts to resolve the concern in a timely manner and prior to the hearing on
18 the motion to approve this Consent Judgment. If the Parties cannot resolve an objection of the
19 Attorney General, then AYS and Defendant shall proceed with seeking entry of an order by the
20 court approving this Consent Judgment in the form originally submitted to the Office of the
21 Attorney General, or in such other form as the Parties shall mutually agree upon after
22 consideration of any comments of the Attorney General. If the Attorney General elects to file a
23 notice or motion with the Court stating that the People shall appear at the hearing for entry of this
24 Consent Judgment so as to oppose entry of the Consent Judgment, then a party may withdraw
25 from this Consent Judgment prior to the date of the hearing, with notice to all parties and the
26 Attorney General, and upon such notice this Consent Judgment shall be null and void and any
27 sums paid hereunder shall be returned to Defendant within fifteen (15) days of the date of the
notice. If the Attorney General files a notice of appeal of this Consent Judgment, then a party

1 may withdraw from this Consent Judgment within forty-five (45) days of the People's notice of
2 appeal and this Consent Judgment shall be null and void ab initio five (5) days after notice of the
3 withdrawal and any sums paid hereunder shall be returned to Defendant within fifteen (15) day of
4 the date of voiding.

5 **7.2 Amendment To Complaint.** Upon the expiration of the 60-Day Notice issued on
6 or about November 5, 2008, and in the event that no public prosecutors have commenced diligent
7 prosecution against Defendants for such violations, the Complaint herein shall be deemed
8 amended to include all violations described in that 60-Day Notice.

9 **8. ENFORCEMENT AND MODIFICATION**

10 **8.1 Enforcement and Stipulated Civil Penalties.** In the event that a dispute arises
11 with respect to any of the provisions of this Consent Judgment, the Parties shall meet and confer
12 within twenty (20) days after any Party receives written notice of an alleged violation of this
13 Consent Judgment from another Party. In the event the affected Parties cannot resolve the
14 dispute, this Consent Judgment may be enforced pursuant to Code of Civil Procedure § 664.6 or
15 any other valid provision of law. The prevailing party in any dispute regarding compliance with
16 the terms of this Consent Judgment shall be awarded its reasonable fees and costs incurred, in
17 addition to any other relief otherwise ordered by the Court, including but not limited to civil
18 penalties assessed pursuant to Section 3 herein.

19 **8.2 Modification of Judgment - Grounds.** This Consent Judgment shall not
20 obligate Defendant to provide a health hazard warning (as described in Section 2 herein) for a
21 Product if that Product causes an exposure below the "No Significant Risk Level" or "Maximum
22 Allowable Daily Level," as those terms are defined in Proposition 65 and its implementing
23 regulations. Any such levels adopted in a final regulation or law pursuant to Proposition 65 after
24 the Effective Date shall become the standard under this Consent Judgment on the date of adoption
25 without need for formal modification of this Consent Judgment, but Defendant retains its rights
26 and obligations under Section 2.3.2. to establish naturally occurring levels of lead. The Parties
27 acknowledge that new toxicological information or exposure assessments concerning hazardous
substances and testing methodologies are continuously becoming available, and that statutory and

1 regulatory standards applicable to the Products may evolve in the future. Accordingly, the Parties
2 agree that any Party may file a motion pursuant to § 664.6 of the California Code of Civil
3 Procedure, and under the conditions set forth below, move the Court for modification of the
4 warning requirement or any other term set forth in Section 2 herein on the grounds that (a) they
5 conflict with the applicable legal standards concerning the Products or any ingredient therein, or
6 (b) the warning requirement or any other term set forth in Section 2 herein are more stringent than
7 the warning requirements AYS agrees to after the Effective Date in an order, judgment or
8 settlement under Proposition 65 with respect to any dietary supplements that are substantially
9 similar to the Products herein. Absent good cause shown by Plaintiff, Plaintiff shall allow
10 modification of this Consent Judgment to permit Defendant to adhere to such less stringent
11 warning requirements. Any disputes regarding the issues set forth in this subsection shall be
12 resolved in accordance with the procedures set forth in Section 8.3 below.

13 **8.3 Modification of Judgment – Procedure.** In the spirit of cooperation and in the
14 interests of minimizing the investigative, expert and attorneys’ fees and costs associated with
15 such a motion, the Parties agree to meet and confer in good faith as follows. Prior to filing a
16 motion pursuant to Section 8.2 herein, the Party seeking to modify the judgment shall first
17 provide the non-moving Party and the California Attorney General’s Office with any legal or
18 scientific information upon which the motion would rely. The non-moving Party and the
19 California Attorney General’s Office shall be allowed a period of forty-five (45) days to review
20 that information and to provide the moving Party with its formal written response (the Attorney
21 General’s Office’s failure to respond to this submission shall not be construed in any manner to
22 reflect any particular view, on the part of the Attorney General’s Office, of this Consent Judgment
23 or of the applicable law or science). The Parties shall then meet and confer within twenty (20)
24 days of the non-moving Party’s written response. If, after meeting and conferring, the moving
25 Party elects to proceed with a motion to amend this Consent Judgment, it may do so with proper
26 notice to the other Party and the Attorney General’s Office as required under the California Code
27 of Civil Procedure. Such a motion may be accompanied by scientific data, studies, written
declarations, and live testimony or discovery responses. In the event that the Court determines

1 that a Party seeking or opposing a motion to modify this Consent Judgment did so without
2 justification or failed to meet and confer in good faith prior to moving for such modification, the
3 other Party shall be awarded reasonable fees and costs incurred.

4 **9. NEW PRODUCTS.**

5 **9.1 New Product Testing Prior to Sale in California.** If, after the date that is sixty
6 (60) days after the Effective Date, Defendant elects to ship for sale in California any new herbal
7 products under the Nutraceutical's Science Institute (NSI), Walker Diets, Smart Basics and
8 Cosmesutical Sciences Institute (CSI) brand line, but not identified on Exhibit A hereto,
9 Defendant shall, before shipping the new product(s) for sale in California, conduct the testing set
10 forth in Section 2.1 and adhere to the requirements of this Consent Judgment with respect to such
11 new product(s). Failure to provide the warning if required under Section 2.2 shall be a violation
12 of this Consent Judgment subject to stipulated penalties in accordance with Section 3.1. Such
13 new Nutraceutical's Science Institute (NSI), Walker Diets, Smart Basics and Cosmesutical
14 Sciences Institute (CSI) branded herbal product(s) shall then be deemed Product(s) subject to all
15 of the terms of this Consent Judgment. Before the date that is sixty (60) days after the Effective
16 Date, Defendant may ship for sale to California customers new or reformulated products of the
17 type set forth in Section 1.2 that are not listed on Exhibit A, and the sales of such products shall
18 not be deemed in violation of any term of this Consent Judgment.

19 **9.2 Annual New Product Update List.** Commencing on December 31, 2009 and
20 annually on that date through and including December 31, 2011, Defendant shall provide Plaintiff
21 with an annual updated list of new Nutraceutical's Science Institute (NSI), Walker Diets, Smart
22 Basics and Cosmesutical Sciences Institute (CSI) branded Products Defendant shipped for sale or
23 use in California in the preceding calendar year for which Defendant has ascertained that
24 warnings are not required under this Consent Judgment. Defendant shall include, for each new
25 Product identified on the annual updated list, either: (a) at least one finished product test result
26 documenting the lead level in each new Product or (b) a calculation of the total lead level in the
27 Product, expressed in micrograms/day, based on Defendant's Representative Sampling data. If
Plaintiff cannot ascertain and in good faith inquires in writing as to whether a specific Product is a

1 new Product in a given year, Defendant shall promptly (and in any event within thirty-five (35)
2 days the date of AYS' request) reply to advise whether the Product is a new Product for that year
3 or is an existing Product.

4 **10. GOVERNING LAW**

5 **10.1 Governing Law.** The terms of this Consent Judgment shall be governed by the
6 laws of the State of California. This Consent Judgment shall not govern Products or products
7 sold to consumers or other persons outside the State of California.

8 **11. NOTICES**

9 **11.1 Notices.** All correspondence and notices required to be provided under this
10 Agreement shall be in writing and shall be sent by first class registered or certified mail, or via a
11 reputable overnight delivery service with a tracking mechanism, addressed as follows:

22 **12.1 Integration & Modification.** This Consent Judgment, together with the Exhibits
23 hereto which are specifically incorporated herein by this reference, constitutes the entire
24 agreement between the Parties relating to the rights and obligations herein granted and assumed,
25 and supersedes all prior agreements and understandings between the Parties. Except as set forth
26 in Section 8, this Consent Judgment may be modified only upon the written agreement of the
27 Parties to be bound. If any term of this Consent Judgment is found by the court to be invalid,
then such term shall be stricken and the remaining terms shall not be affected thereby. In the
interpretation hereof, references to general "Sections" (e.g., "Section 8") shall include all
