1 **1. INTRODUCTION**

2 1.1 **Parties**

3 This Consent Judgment is entered into by and between plaintiff Laurence Vinocur
4 (“Plaintiff”) and defendant Stakmore Company, Inc., the defendant identified in Exhibit A
5 (“Settling Defendant”), with Plaintiff and the Settling Defendant collectively referred to as the
6 “Parties.”

7 1.2 **Plaintiff**

8 Plaintiff is an individual residing in the State of California who seeks to promote awareness
9 of exposures to toxic chemicals and to improve human health by reducing or eliminating hazardous
10 substances contained in consumer and commercial products.

11 1.3 **Settling Defendant**

12 The Settling Defendant employs ten or more persons and is a person in the course of doing
13 business for purposes of the Safe Drinking Water and Toxic Enforcement Act of 1986, California
14 Health & Safety Code § 25249.6, *et seq.* (“Proposition 65”).

15 1.4 **General Allegations**

16 1.4.1 Plaintiff alleges that the Settling Defendant manufactured, imported, sold
17 and/or distributed for sale in California, products with foam cushioned components containing
18 tris(1,3-dichloro-2-propyl) phosphate (“TDCPP”) without the requisite Proposition 65 health hazard
19 warnings.

20 1.4.2 Pursuant to Proposition 65, on October 28, 2011, California identified and
21 listed TDCPP as a chemical known to cause cancer. TDCPP became subject to the “clear and
22 reasonable warning” requirements of Proposition 65 one year later on October 28, 2012. Cal. Code
23 Regs., tit. 27, § 27001(b); Health & Safety Code §§ 25249.8 and 25249.10(b).

24 TDCPP is hereinafter referred to as the “Listed Chemical.” Plaintiff alleges that the Listed
25 Chemical escapes from the foam padding, leading to human exposures.

1.5 Product Description

The categories of products that are covered by this Consent Judgment as to the Settling Defendant are identified on Exhibit A (hereinafter “Products”). Polyurethane foam that is supplied, shaped or manufactured for use as a component of another product, such as upholstered furniture, but which is not itself a finished product, is specifically excluded from the definition of Products and shall not be identified by the Settling Defendant on Exhibit A as a Product.

1.6 Notice of Violation

On January 10, 2013, Plaintiff served the Settling Defendant and certain requisite public enforcement agencies with a “60-Day Notice of Violation” (“Notice”) that provided the recipients with notice of alleged violations of Proposition 65 based on the alleged failure to warn customers, consumers, and workers in California that the Products expose users to the Listed Chemical. To the best of the Parties’ knowledge, no public enforcer has commenced or is diligently prosecuting the allegations set forth in the Notice.

1.7 Complaint

On March 26, 2013, Plaintiff filed a Complaint in the Superior Court in and for the County of Alameda against the Settling Defendant, and Does 1 through 150, *Laurence Vinocur v. True Design, Inc., et al.*, Case No. RG 13-673027, alleging violations of Proposition 65, based in part on the alleged unwarned exposures to TDCPP contained in the Products.

1.8 No Admission

The Settling Defendant denies the material factual and legal allegations contained in Plaintiff’s Notice and Complaint and maintains that all products that it has manufactured, imported, distributed, and/or sold in California, including the Products, have been and are in compliance with all laws. Nothing in this Consent Judgment shall be construed as an admission by the Settling Defendant of any fact, finding, conclusion, issue of law, or violation of law, nor shall compliance with this Consent Judgment constitute or be construed as an admission by the Settling Defendant of any fact, finding, conclusion, issue of law, or violation of law. However, this section shall not

1 diminish or otherwise affect the Settling Defendant's obligations, responsibilities, and duties under
2 this Consent Judgment.

3 **1.9 Consent to Jurisdiction**

4 For purposes of this Consent Judgment only, the Parties stipulate that this Court has
5 jurisdiction over the Settling Defendant as to the allegations contained in the Complaint, that venue
6 is proper in the County of Alameda, and that this Court has jurisdiction to enter and enforce the
7 provisions of this Consent Judgment pursuant to Proposition 65 and California Code of Civil
8 Procedure § 664.6.

9 **2. DEFINITIONS**

10 **2.1 California Customers**

11 "California Customer" shall mean any customer that the Settling Defendant reasonably
12 understands is located in California, has a California warehouse or distribution center, maintains a
13 retail outlet in California, or has made internet sales into California on or after January 1, 2011.

14 **2.2 Detectable**

15 "Detectable" shall mean containing more than 25 parts per million ("ppm") (the equivalent
16 of .0025%) of any one chemical in any material, component, or constituent of a
17 subject product, when analyzed by a NVLAP accredited laboratory pursuant to EPA testing
18 methodologies 3545 and 8270C, or equivalent methodologies utilized by federal or state agencies to
19 determine the presence, and measure the quantity of, TDCPP and/or tris(2-chloroethyl) phosphate
20 ("TCEP") in a solid substance.

21 **2.3 Effective Date**

22 "Effective Date" shall mean October 15, 2013.

23 **2.4 Private Label Covered Products**

24 "Private Label Covered Products" means Products that bear a brand or trademark owned or
25 licensed by a Retailer or affiliated entity that are sold or offered for sale by a Retailer in the State of
26 California.

27 ///

28 ///

1 **2.5 Reformulated Products**

2 “Reformulated Products” shall mean Products that contain no Detectable amount of TDCPP
3 or TCEP.¹

4 **2.6 Reformulation Standard**

5 The “Reformulation Standard” shall mean containing no more than 25 ppm for TDCPP and
6 TCEP.

7 **2.7 Retailer**

8 “Retailer” means an individual or entity that offers a Product for retail sale to consumers in
9 the State of California.

10 **3. INJUNCTIVE RELIEF: REFORMULATION**

11 **3.1 Reformulation Commitment**

12 Commencing on March 31, 2014, the Settling Defendant shall not manufacture or import for
13 distribution or sale to California Customers, or cause to be manufactured or imported for
14 distribution or sale to California Customers, any Products that are not Reformulated Products.

15 **3.2 Vendor Notification/Certification**

16 On or before the Effective Date, the Settling Defendant shall provide written notice to all of
17 its then-current vendors of the Products that will be sold or offered for sale in California, or to
18 California Customers, instructing each such vendor to use reasonable efforts to provide only
19 Reformulated Products for potential sale in California. In addressing the obligation set forth in the
20 preceding sentence, the Settling Defendant shall not employ statements that will encourage a
21 vendor to delay compliance with the Reformulation Standard. The Settling Defendant shall
22 subsequently obtain written certifications, no later than April 1, 2014, from such vendors, and any
23 newly engaged vendors, that the Products manufactured by such vendors are in compliance with the
24 Reformulation Standard. Certifications shall be held by the Settling Defendant for at least two
25 years after their receipt and shall be made available to Plaintiff upon request.

27 ¹ As to this Settling Defendant’s receipt of the separate Notice concerning DEHP, the term
28 “Reformulated Products” further requires that the Products for which claims concerning DEHP
were Noticed (the “Phthalate Products”) contain no more than 1000 ppm each of DEHP, BBP, and
DBP.

1 **3.3 Products No Longer in the Settling Defendant’s Control**

2 No later than 45 days after the Effective Date, the Settling Defendant shall send a letter,
3 electronic or otherwise (“Notification Letter”) to: (1) each California Customer and/or Retailer to
4 which it, after October 28, 2011, supplied the item for resale in California described as an exemplar
5 in the Notice the Settling Defendant received from Plaintiff (“Exemplar Product”); and (2) any
6 California Customer and/or Retailer that the Settling Defendant reasonably understands or believes
7 had any inventory for resale in California of Exemplar Products as of the Notice date. The
8 Notification Letter shall advise the recipient that the Exemplar Product “contains TDCPP, a
9 chemical known to the State of California to cause cancer,” and request that the recipient either: (a)
10 label the Exemplar Products remaining in inventory for sale in California, or to California
11 Customers, pursuant to Section 3.5; or (b) return, at the Settling Defendant’s sole expense, all units
12 of the Exemplar Product held for sale in California, or to California Customers, to the Settling
13 Defendant or a party the Settling Defendant has otherwise designated. The Notification Letter shall
14 require a response from the recipient within 15 days confirming whether the Exemplar Product will
15 be labeled or returned. The Settling Defendant shall maintain records of all correspondence or
16 other communications generated pursuant to this Section for two years after the Effective Date and
17 shall promptly produce copies of such records upon Plaintiff’s written request.

18 **3.4 Current Inventory**

19 Any Products in, or manufactured and en route to, the Settling Defendant’s inventory as of
20 or after December 31, 2013, that do not qualify as Reformulated Products and that the Settling
21 Defendant has reason to believe may be sold or distributed for sale in California, shall contain a
22 clear and reasonable warning as set forth in Section 3.5 below unless Section 3.6 applies.

23 **3.5 Product Warnings**

24 **3.5.1 Product Labeling**

25 Any warning provided under Section 3.3 or 3.4 above shall be affixed to the packaging,
26 labeling, or directly on each Product. Each warning shall be prominently placed with such
27 conspicuousness as compared with other words, statements, designs, or devices as to render it likely
28 to be read and understood by an ordinary individual under customary conditions before purchase.

1 Each warning shall be provided in a manner such that the consumer or user understands to which
2 specific Product the warning applies, so as to minimize the risk of consumer confusion.

3 A warning provided pursuant to this Consent Judgment shall state:

4 **WARNING:** This product contains TDCPP, a flame
5 retardant Chemical known to the State of California
6 to cause cancer, and DEHP, a Chemical known to the
7 State of California to cause birth defects and other
8 reproductive harm.²

9 Attached as Exhibit B are template warnings developed by Plaintiff that are deemed to be
10 clear and reasonable for purposes of this Consent Judgment.³ Provided that the other requirements
11 set forth in this Section are addressed, including as to the required warning statement and method of
12 transmission as set forth above, the Settling Defendant remains free not to utilize the template
13 warnings.

14 3.5.2 Internet Website Warning

15 A warning shall be given in conjunction with the sale of the Products to California, or
16 California Customers, via the internet, which warning shall appear on one or more web pages
17 displayed to a purchaser during the checkout process. The following warning statement shall be
18 used and shall: (a) appear adjacent to or immediately following the display, description, or price of
19 the Product; (b) appear as a pop-up box; or (c) otherwise appear automatically to the consumer.

20 The warning text shall be the same type size or larger than the Product description text:

21 ² The regulatory safe harbor warning language specified in 27 CCR § 25601, 3.2. may also
22 be used if the Settling Defendant had begun to use it, prior to the Effective Date. The Settling
23 Defendant may seek to use alternative warning language, other than the language specified above or
24 the safe harbor warning specified in 27 CCR § 25603.2, or may seek to use an alternate method of
25 transmission of the warning, but must obtain the Court's approval of its proposed alternative and
26 provide all Parties and the Office of the Attorney General with timely notice and the opportunity to
27 comment or object before the Court acts on the request. The Parties agree that the following
28 warning language shall not be deemed to meet the requirements of 27 CCR § 25601 and shall not
be used pursuant to this Consent Judgment: (a) "cancer or birth defects or other reproductive harm";
and (b) "cancer, birth defects or other reproductive harm."

29 ³ The characteristics of the template warnings are as follows: (a) a yellow hang tag
30 measuring 3" x 5", with no less than 12 point font, with the warning language printed on each side
31 of the hang tag, which shall be affixed directly to the Product; (b) a yellow warning sign measuring
32 8.5" x. 11", with no less that 32 point font, with the warning language printed on each side, which
33 shall be affixed directly to the Product; and (c) for Products sold at retail in a box or packaging, a
34 yellow warning sticker measuring 3" x 3", with no less than 12 point font, which shall be affixed
35 directly to the Product packaging.

WARNING: This product contains TDCPP, a flame retardant Chemical known to the State of California to cause cancer, and DEHP, a Chemical known to the State of California to cause birth defects and other reproductive harm.⁴

3.6 Alternatives to Interim Warnings

The obligations of the Settling Defendant under Section 3.3 shall be relieved provided the Settling Defendant certifies on or before December 15, 2013, that only Exemplar Products meeting the Reformulation Standard will be offered for sale in California, or to California Customers for sale in California, after December 31, 2013. The obligations of the Settling Defendant under Section 3.4 shall be relieved provided the Settling Defendant certifies on or before December 15, 2013, that, after June 30, 2014, it will only distribute or cause to be distributed for sale in, or sell in, California, or to California Customers for sale in California, Products (i.e., Products beyond the Exemplar Product) meeting the Reformulation Standard. The certifications provided by this Section are material terms and time is of the essence.

4. MONETARY PAYMENTS

4.1 Civil Penalties Pursuant to Health & Safety Code § 25249.7(b)

In settlement of all the claims referred to in this Consent Judgment, the Settling Defendant shall pay the civil penalties shown for it on Exhibit A in accordance with this Section.⁵ Each penalty payment will be allocated in accordance with California Health & Safety Code § 25249.12(c)(1) and (d), with 75% of the funds remitted to the California Office of Environmental Health Hazard Assessment (“OEHHA”) and 25% of the penalty remitted to “The Chanler Group in Trust for Laurence Vinocur.” Each penalty payment shall be made within two business days of the date it is due and be delivered to the addresses listed in Section 4.5 below. The Settling Defendant shall be liable for payment of interest, at a rate of 10% simple interest, for all amounts due and owing under Section 4 that are not received within two business days of the due date.

⁴ Footnote 3 applies in this context as well.

⁵ For this Settling Defendant’s receipt of the Notice alleging violations of Proposition 65 concerning DEHP in Phthalate Products, the penalty amount shown on Exhibit A includes an additional component to address the resolution of those additional claims.

1 4.1.1 Initial Civil Penalty. On or before the Effective Date, the Settling Defendant
2 shall make an initial civil penalty payment in the amount identified on the Settling Defendant's
3 Exhibit A.

4 4.1.2 Second Civil Penalty. On or before January 15, 2014, the Settling Defendant
5 shall make a second civil penalty payment in the amount identified on the Settling Defendant's
6 Exhibit A. The amount of the second penalty may be reduced according to any penalty waiver the
7 Settling Defendant is eligible for under Sections 4.1.4(i) and 4.1.4(iii), below.

8 4.1.3 Third Civil Penalty. On or before November 30, 2014, the Settling
9 Defendant shall make a third civil penalty payment in the amount identified on the Settling
10 Defendant's Exhibit A. The amount of the third penalty may be reduced according to any penalty
11 waiver the Settling Defendant is eligible for under Sections 4.1.4(ii) and 4.1.4(iv), below.

12 4.1.4 Reductions to Civil Penalty Payment Amounts. The Settling Defendant may
13 reduce the amount of the second and/or third civil penalty payments identified on the Settling
14 Defendant's Exhibit A by providing Plaintiff with certification of certain efforts undertaken to
15 reformulate their Products or limit the ongoing sale of non-reformulated Products in California.
16 The options to provide a written certification in lieu of making a portion of the Settling Defendant's
17 civil penalty payment constitute material terms of this Consent Judgment, and with regard to such
18 terms, time is of the essence.

19 4.1.4(i) **Partial Penalty Waiver for Accelerated Reformulation of**
20 **Products Sold or Offered for Sale in California.**

21 As shown on the Settling Defendant's Exhibit A, a portion of the second civil penalty shall
22 be waived, to the extent that it has agreed that, as of November 1, 2013, and continuing into the
23 future, it shall only manufacture or import for distribution or sale to California Customers or cause
24 to be manufactured or imported for distribution or sale to California Customers, Reformulated
25 Products. An officer or other authorized representative of the Settling Defendant that has exercised
26 this election shall provide Plaintiff with a written certification confirming compliance with such
27 conditions, which certification must be received by Plaintiff's counsel on or before December 15,
28 2013.

4.1.4(ii) Partial Penalty Waiver for Extended Reformulation.

As shown on the Settling Defendant's Exhibit A, a portion of the third civil penalty shall be waived, to the extent that it has agreed that, as of March 15, 2014, and continuing into the future, it shall only manufacture or import for distribution or sale in California, or cause to be manufactured or imported for distribution or sale in California, Reformulated Products which also do not contain tris(2,3-dibromopropyl)phosphate ("TDBPP") in a detectable amount of more than 25 parts per million ("ppm") (the equivalent of .0025%) in any material, component, or constituent of a subject product, when analyzed by a NVLAP accredited laboratory pursuant to EPA testing methodologies 3545 and 8270C, or equivalent methodologies utilized by federal or state agencies to determine the presence, and measure the quantity, of TDBPP in a solid substance. An officer or other authorized representative of the Settling Defendant that has exercised this election shall provide Plaintiff with a written certification confirming compliance with such conditions, which certification must be received by Plaintiff's counsel on or before November 15, 2014.

4.1.4(iii) Partial Penalty Waiver for Withdrawal of Unreformulated Exemplar Products from the California Market.

As shown on the Settling Defendant's Exhibit A, a portion of the second civil penalty shall be waived, if an officer or other authorized representative of the Settling Defendant provides Plaintiff with written certification, by December 15, 2013, confirming that each individual or establishment in California to which it supplied the Exemplar Product after October 28, 2011, has elected, pursuant to Section 3.3, to return all Exemplar Products held for sale in California.⁶

4.1.4(iv) Partial Penalty Waiver for Termination of Distribution to California of Unreformulated Inventory.

As shown on the Settling Defendant's Exhibit A, a portion of the third civil penalty shall be waived, if an officer or other authorized representative of the Settling Defendant provides Plaintiff with written certification, on or before November 15, 2014, confirming that, as of July 1, 2014, it

⁶ For purposes of this Section, the term Exemplar Products shall further include Products for which Plaintiff has, prior to September 10, 2013, provided the Settling Defendant with test results from a NVLAP accredited laboratory showing the presence of a Listed Chemical at a level in excess of 250 ppm pursuant to EPA testing methodologies 3545 or 8270C.

1 has and will continue to distribute, offer for sale, or sell in California, or to California Customers,
2 only Reformulated Products.

3 **4.2 Representations Regarding Sales Volume**

4 The Settling Defendant represents that the sales data and other information concerning its
5 size, knowledge of the Listed Chemical, and prior reformulation and/or warning efforts, it provided
6 to Plaintiff was truthful to its knowledge and a material factor upon which Plaintiff has relied to
7 determine the amount of civil penalties assessed pursuant to Health & Safety Code § 25249.7 in this
8 Consent Judgment. If, within nine months of the Effective Date, Plaintiff discovers and presents to
9 the Settling Defendant, evidence demonstrating that the preceding representation and warranty was
10 materially inaccurate, then the Settling Defendant shall have 30 days to meet and confer regarding
11 the Plaintiff's contention. Should this 30 day period pass without any such resolution between the
12 Plaintiff and the Settling Defendant, Plaintiff shall be entitled to file a formal legal claim including,
13 but not limited to, a claim for damages for breach of contract.

14 The Settling Defendant further represents that in implementing the requirements set forth in
15 Sections 3.1 and 3.2 of this Consent Judgment, it will voluntarily employ commercial best efforts to
16 achieve reformulation of its Products and Additional Products on a nationwide basis and not
17 employ statements that will encourage a vendor to limit its compliance with the Reformulation
18 Standard to goods intended for sale to California Consumers.

19 **4.3 Penalties for Certain Violations of the Reformulation Standard.**

20 If Plaintiff provides notice and appropriate supporting information to the Settling Defendant
21 that levels of the Listed Chemical in excess of the Reformulation Standard have been detected in
22 one or more Products labeled or otherwise marked in an identifiable manner as manufactured or
23 imported after a deadline for meeting the Reformulation Standard has arisen for the Settling
24 Defendant under Sections 3.1 or 3.6 above, the Settling Defendant may elect to pay a stipulated
25 penalty to relieve any further potential liability under Proposition 65 or sanction under this Consent
26
27
28

1 Judgment as to Products sourced from the vendor in question.⁷ The stipulated penalty shall be
2 \$1,500 if the violation level is below 100 ppm and \$3,000 if the violation level is between 100 ppm
3 and 249 ppm, this being applicable for any amount in excess of the Reformulation Standards but
4 under 250 ppm.⁸ Plaintiff shall further be entitled to reimbursement of his associated expense in an
5 amount not to exceed \$5,000 regardless of the stipulated penalty level. The Settling Defendant
6 under this Section must provide notice and appropriate supporting information relating to the
7 purchase (e.g. vendor name and contact information including representative, purchase order,
8 certification (if any) received from vendor for the exemplar or subcategory of products), test results,
9 and a letter from a company representative or counsel attesting to the information provided, to
10 Plaintiff within 30 calendar days of receiving test results from Plaintiff's counsel. Any violation
11 levels at or above 250 ppm shall be subject to the full remedies provided pursuant to this Consent
12 Judgment and at law.

13 4.4 Reimbursement of Fees and Costs

14 The Parties acknowledge that Plaintiff and his counsel offered to resolve this dispute
15 without reaching terms on the amount of fees and costs to be reimbursed to them, thereby leaving
16 this fee reimbursement issue to be resolved after the material terms of the agreement had been
17 settled. Shortly after the other settlement terms had been finalized, the Settling Defendant
18 expressed a desire to resolve the fee and cost issue. The Settling Defendant then agreed to pay
19 Plaintiff and his counsel under general contract principles and the private attorney general doctrine
20 codified at California Code of Civil Procedure section 1021.5 for all work performed through the
21 mutual execution of this agreement, including the fees and costs incurred as a result of
22 investigating, bringing this matter to the Settling Defendant's attention, negotiating a settlement in
23 the public interest, and seeking court approval of the same. In addition, the negotiated fee and cost

1 figure expressly includes the anticipated significant amount of time plaintiffs' counsel will incur to
2 monitor various provisions in this agreement over the next two years, with the exception of
3 additional fees that may be incurred pursuant to the Settling Defendant's election in Section 11.
4 The Settling Defendant more specifically agreed, upon the Court's approval and entry of this
5 Consent Judgment, to pay Plaintiff's counsel the amount of fees and costs indicated on the Settling
6 Defendant's Exhibit A. The Settling Defendant further agreed to tender and shall tender its full
7 required payment under this Section to a trust account at The Chanler Group (made payable "In
8 Trust for The Chanler Group") within two business days of the Effective Date. Such funds shall be
9 released from the trust account upon the Court's approval and entry of this Consent Judgment.

11 **5. CLAIMS COVERED AND RELEASED**

12 **5.1 Plaintiff’s Release of Proposition 65 Claims**

13 Plaintiff, acting on his own behalf and in the public interest, releases the Settling Defendant,
14 its parents, subsidiaries, affiliated entities under common ownership, directors, officers, agents
15 employees, attorneys, and each entity to whom the Settling Defendant directly or indirectly
16 distributes or sells Products, including, but not limited, to downstream distributors, wholesalers,
17 customers, retailers, franchisees, cooperative members, and licensees (collectively, “Releasees”),
18 from all claims for violations of Proposition 65 through the Effective Date based on unwarned
19 exposures to the Listed Chemical in the Products, as set forth in the Notice. Compliance with the
20 terms of this Consent Judgment constitutes compliance with Proposition 65 with respect to
21 exposures to the Listed Chemical from the Products, as set forth in the Notice. The Parties further
22 understand and agree that this Section 5.1 release shall not extend upstream to any entities, other
23 than the Settling Defendant, that manufactured the Products or any component parts thereof, or any
24 distributors or suppliers who sold the Products or any component parts thereof to a Settling
25 Defendant, except that entities upstream of the Settling Defendant that is a Retailer of a Private
26

1 Labeled Covered Product shall be released as to the Private Labeled Covered Products offered for
2 sale in California, or to California Customers, by the Retailer in question.⁹

3 **5.2 Plaintiff's Individual Releases of Claims**

4 Plaintiff, in his individual capacity only and *not* in his representative capacity, provides a
5 release herein which shall be effective as a full and final accord and satisfaction, as a bar to all
6 actions, causes of action, obligations, costs, expenses, attorneys' fees, damages, losses, claims,
7 liabilities, and demands of Plaintiff of any nature, character, or kind, whether known or unknown,
8 suspected or unsuspected, limited to and arising out of alleged or actual exposures to TDCPP in the
9 Products or Additional Products (as defined in Section 11.1 and delineated on the Settling
10 Defendant's Exhibit A) manufactured, imported, distributed, or sold by Settling Defendant prior to
11 the Effective Date.¹⁰ The Parties further understand and agree that this Section 5.2 release shall not
12 extend upstream to any entities that manufactured the Products or Additional Products, or any
13 component parts thereof, or any distributors or suppliers who sold the Products or Additional
14 Products, or any component parts thereof to Settling Defendant, except that entities upstream of the
15 Settling Defendant that is a Retailer of a Private Labeled Covered (or Additional) Product shall be
16 released as to the Private Labeled Covered (or Additional) Products offered for sale in California by
17 the Retailer in question. Nothing in this Section affects Plaintiff's rights to commence or prosecute
18 an action under Proposition 65 against a Releasee that does not involve the Settling Defendant's
19 Products or Additional Products.¹¹

20 **5.3 Settling Defendant's Release of Plaintiff**

21 The Settling Defendant, on behalf of itself, its past and current agents, representatives,
22 attorneys, successors, and assignees, hereby waives any and all claims against Plaintiff and his

1 attorneys and other representatives, for any and all actions taken or statements made (or those that
2 could have been taken or made) by Plaintiff and his attorneys and other representatives, whether in
3 the course of investigating claims or otherwise seeking to enforce Proposition 65 against it in this
4 matter with respect to the Products and Additional Products.

5 **6. COURT APPROVAL**

6 This Consent Judgment is not effective until it is approved and entered by the Court and
7 shall be null and void if, for any reason, it is not approved in its entirety and entered by the Court
8 within one year after it has been fully executed by all Parties. If the Court does not approve the
9 Consent Judgment, the Parties shall meet and confer as to whether to modify the language or appeal
10 the ruling. If the Parties do not jointly agree on a course of action to take, then the case shall
11 proceed in its normal course on the Court's trial calendar. If the Court's approval is ultimately
12 overturned by an appellate court, the Parties shall meet and confer as to whether to modify the
13 terms of this Consent Judgment. If the Parties do not jointly agree on a course of action to take,
14 then the case shall proceed in its normal course on the Court's trial calendar. In the event that this
15 Consent Judgment is entered by the Court and subsequently overturned by any appellate court, any
16 monies that have been provided to OEHHA, Plaintiff or his counsel pursuant to Section 4, above,
17 shall be refunded within 15 days of the appellate decision becoming final. If the Court does not
18 approve and enter the Consent Judgment within one year of the Effective Date, any monies that
19 have been provided to OEHHA or held in trust for Plaintiff or his counsel pursuant to Section 4,
20 above, shall be refunded to the associated Settling Defendant within 15 days.

21 **7. GOVERNING LAW**

22 The terms of this Consent Judgment shall be governed by the laws of the State of California.
23 In the event that Proposition 65 is repealed, preempted, or is otherwise rendered inapplicable by
24 reason of law generally, or if any of the provisions of this Consent Judgment are rendered
25 inapplicable or are no longer required as a result of any such repeal or preemption, or rendered
26 inapplicable by reason of law generally as to the Products, then the Settling Defendant may provide
27 written notice to Plaintiff of any asserted change in the law, and shall have no further obligations
28 pursuant to this Consent Judgment with respect to, and to the extent that, the Products are so

1 affected. Nothing in this Consent Judgment shall be interpreted to relieve the Settling Defendant
2 from any obligation to comply with any pertinent state or federal law or regulation.

3 **8. NOTICE**

4 Unless specified herein, all correspondence and Notice required to be provided pursuant to
5 this Consent Judgment shall be in writing and sent by: (i) personal delivery, (ii) first-class
6 registered or certified mail, return receipt requested; or (iii) overnight courier to any party by the
7 other party at the following addresses:

15 **9. COUNTERPARTS, FACSIMILE AND PDF SIGNATURES**

16 This Consent Judgment may be executed in counterparts and by facsimile or portable
17 document format (“pdf”) signature, each of which shall be deemed an original, and all of which,
18 when taken together, shall constitute one and the same document. A facsimile or pdf signature shall
19 be as valid as the original.

20 **10. COMPLIANCE WITH HEALTH & SAFETY CODE SECTION 25249.7(f)**

21 Plaintiff and his attorneys agree to comply with the reporting form requirements referenced
22 in California Health & Safety Code section 25249.7(f).

23 **11. ADDITIONAL POST EXECUTION ACTIVITIES**

24 11.1 In addition to the Products, where the Settling Defendant has identified on Exhibit A
25 additional products that contain TDCPP, TCEP, TDBPP and/or any Proposition 65-listed
26 chemical(s) and that are sold or offered for sale by it in California, or to California Customers,
27 (“Additional Products”), then by no later than October 15, 2013, the Settling Defendant may
28 provide Plaintiff with additional information or representations necessary to enable him to issue a

1 60-Day Notice of Violation and valid Certificate of Merit therefore, pursuant to Health & Safety
2 Code section 25249.7, that includes the Additional Products. Polyurethane foam that is supplied,
3 shaped or manufactured for use as a component of a product, such as upholstered furniture, is
4 specifically excluded from the definition of Additional Products and shall not be identified by the
5 Settling Defendant on Exhibit A as an Additional Product. Except as agreed upon by Plaintiff,
6 Settling Defendant shall not include a product, as an Additional Product, that is the subject of an
7 existing 60-day notice issued by Plaintiff or any other private enforcer at the time of execution.

8 After receipt of the required information, Plaintiff agrees to issue a supplemental 60-day
9 notice in compliance with all statutory and regulatory requirements for the Additional Products.
10 Plaintiff will, and in no event later than October 1, 2014, prepare and file an amendment to this
11 Consent Judgment to incorporate the Additional Products within the defined term “Products” and
12 serve a copy thereof and its supporting papers (including the basis for supplemental stipulated
13 penalties, if any) on the Office of the California Attorney General; upon the Court’s approval and
14 finding that the supplemental stipulated penalty amount, if any, is reasonable, the Additional
15 Products shall become subject to Sections 5.1 and 5.2. The Settling Defendant shall, at the time it
16 elects to utilize this Section and tenders the additional information or representations regarding the
17 Additional Products to Plaintiff, tender to The Chanler Group’s trust account an amount not to
18 exceed \$8,750 as stipulated penalties and attorneys’ fees and costs incurred by Plaintiff in issuing
19 the new notice and engaging in other reasonably related activities, which may be released from the
20 trust as awarded by the Court upon Plaintiff’s application. Any fee award associated with the
21 modification of the Consent Judgment to include Additional Products shall not offset any associated
22 supplemental penalty award, if any. (Any tendered funds remaining in the trust thereafter shall be
23 refunded to the Settling Defendant within 15 days). Such payment shall be made to “In trust for
24 The Chanler Group” and delivered as per Section 4.5.1(a) above.

25 11.2 Plaintiff and Settling Defendant agree to support the entry of this agreement as a
26 Consent Judgment and obtain approval of the Consent Judgment by the Court in a timely manner.
27 The Parties acknowledge that, pursuant to California Health & Safety Code section 25249.7, a
28 noticed motion is required to obtain judicial approval of this Consent Judgment, which Plaintiff

1 shall draft and file. If any third party objection to the noticed motion is filed, Plaintiff and the
2 Settling Defendant shall work together to file a reply and appear at any hearing before the Court.
3 This provision is a material component of the Consent Judgment and shall be treated as such in the
4 event of a breach.


5 **12. MODIFICATION**

6 This Consent Judgment may be modified only: (1) by written agreement of the Parties and
7 upon entry of a modified Consent Judgment by the Court thereon; or (2) upon a successful motion
8 of any party and entry of a modified Consent Judgment by the Court.



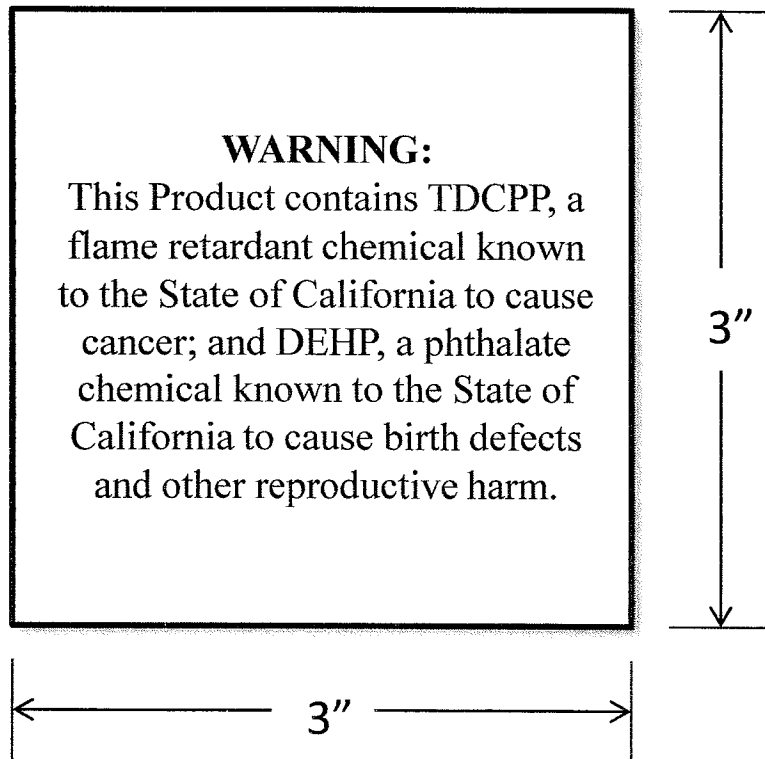

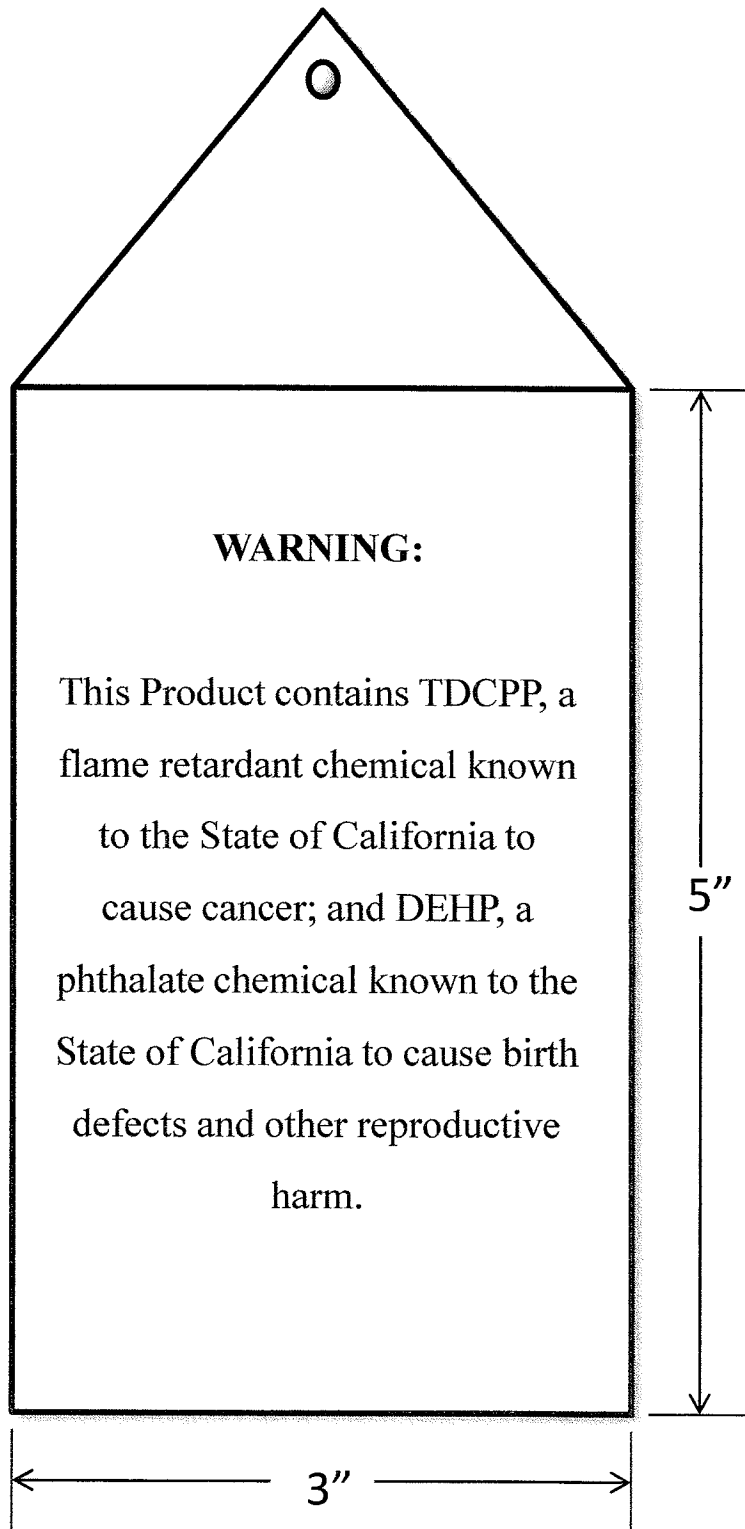
