1 **1. INTRODUCTION**

2 **1.1** On October 24, 2013, Plaintiff Environmental Research Center (“ERC”), a
3 non-profit corporation, as a private enforcer, and in the public interest, initiated this action by
4 filing a Complaint for Injunctive Relief and Civil Penalties (the “Complaint”) pursuant to the
5 provisions of California Health and Safety Code section 25249.5 *et seq.* (“Proposition 65”),
6 against AL GLOBAL CORPORATION. Subsequently, on February 21, 2014, an Amended
7 Complaint (the “Amended Complaint”) was filed which included Defendant YOUNGEVITY
8 INTERNATIONAL, INC.¹ (Defendants AL GLOBAL CORPORATION and YOUNGEVITY
9 INTERNATIONAL, INC. are referred to collectively as “YOUNGEVITY”). In this action,
10 ERC alleges that a number of products manufactured, distributed or sold by YOUNGEVITY
11 contain lead, a chemical listed under Proposition 65 as a carcinogen and reproductive toxin, and
12 expose consumers to this chemical at a level requiring a Proposition 65 warning. These products
13 (referred to hereinafter individually as a “Covered Product” or collectively as “Covered
14 Products”) are:

1.2 ERC also alleges that other products manufactured by R-Garden Inc., which YOUNGEVITY never manufactured and which YOUNGEVITY has not distributed or sold for more than one year prior to the date on which ERC filed its Complaint, expose consumers to lead at a level requiring a Proposition 65 warning. These products (referred to hereinafter individually as a “R-Garden Product” or collectively as “R-Garden Products”) are:

- R-Garden Milk Thistle Formula (incorrectly referred to as “Youngevity R-Garden Milk Thistle Formula”)
- R-Garden Inc. Memory Formula
- R-Garden Brown Seaweed Extract Formula (incorrectly referred to as “Youngevity Brown Seaweed Extract Formula”)
- R-Garden Inc. Herbal Blends Female Hormone System
- R-Garden Green Energy Plus (incorrectly referred to as “Youngevity R-Garden Green Energy Plus”)
- R-Garden Herbal Blends Eyes System
- R-Garden Herbal Blends Immune Fungi System

- 2 • R-Garden Inc. Bowel Toner
- 3 • R-Garden Inc. Herbal Blends Thyroid System

6 **1.3** ERC also alleged in its May 17, 2013 Notice of Violation, which was served
7 on the California Attorney General, other public enforcers, that the product “True2Life True
8 Kids” (referred to hereinafter as the “Other Noticed Product”) contains lead at a level that
9 requires a Proposition 65 Warning, but ERC made no allegations concerning the Other Noticed
10 Product in either its Complaint or its Amended Complaint.

11 **1.4** ERC is a California non-profit corporation dedicated to, among other causes,
12 helping safeguard the public from health hazards by reducing the use and misuse of hazardous
13 and toxic chemicals, facilitating a safe environment for consumers and employees, and
14 encouraging corporate responsibility.

15 **1.5** YOUNGEVITY INTERNATIONAL, INC. is a Delaware corporation that is
16 dedicated to promoting health and wellness and that markets nutritional supplements and lifestyle
17 products and produces gourmet coffee. At all relevant times for the purpose of this Consent
18 Judgment, YOUNGEVITY INTERNATIONAL, INC. employed ten or more persons and
19 qualified as a “person in the course of business” within the meaning of Proposition 65.
20 YOUNGEVITY INTERNATIONAL, INC. manufactures, distributes and sells the Covered
21 Products.

22 **1.6** AL GLOBAL CORPORATION is a California corporation that is a wholly
23 owned subsidiary of YOUNGEVITY INTERNATIONAL, INC.

24 **1.7** ERC and YOUNGEVITY are referred to individually as a “Party” or
25 collectively as the “Parties.”

1. **1.8** The Amended Complaint is based on allegations contained in ERC's Notices
2 of Violation dated May 17, 2013, September 13, 2013, and October 18, 2013, that were served
3 on the California Attorney General, other public enforcers, and YOUNGEVITY ("Notices").
4 True and correct copies of the Notices are attached as Exhibit A and are hereby incorporated by
5 reference. More than 60 days have passed since the Notices were mailed and uploaded to the
6 Attorney General's website, and no designated governmental entity has filed a complaint against
7 YOUNGEVITY with regard to the Covered Products or the alleged violations.

8 **1.9** ERC's Notices and Amended Complaint allege that use of the Covered
9 Products exposes persons in California to lead without first providing clear and reasonable
10 warnings in violation of California Health and Safety Code section 25249.6. YOUNGEVITY
11 denies all material allegations contained in the Notices and Amended Complaint.

12 **1.10** The Parties have entered into this Consent Judgment in order to settle,
13 compromise and resolve disputed claims and thus avoid prolonged and costly litigation. Nothing
14 in this Consent Judgment shall constitute or be construed as an admission by any of the Parties,
15 or by any of their respective officers, directors, shareholders, employees, agents, parent
16 companies, subsidiaries, divisions, affiliates, franchisees, licensees, customers, suppliers,
17 distributors, wholesalers, or retailers. Except for the representations made above, nothing in this
18 Consent Judgment shall be construed as an admission by the Parties of any fact, issue of law, or
19 violation of law, nor shall compliance with this Consent Judgment be construed as an admission
20 by the Parties of any fact, issue of law, or violation of law, at any time, for any purpose.

21 **1.11** Except as expressly set forth herein, nothing in this Consent Judgment shall
22 prejudice, waive, or impair any right, remedy, argument, or defense the Parties may have in any
23 other or future legal proceeding unrelated to these proceedings.

24 **1.12** The Effective Date of this Consent Judgment is the date on which it is entered
25 as a Judgment by this Court.

1 For the purposes of determining the Daily Lead Exposure Level under this Consent
2 Judgment, Defendant shall be afforded the following naturally occurring allowances:

15 YOUNGEVITY may only utilize the naturally occurring allowances listed in Table 3.1 if,
16 subject to Confidentiality, it supplies ERC with a list of the ingredients from Table 3.1 in the
17 product and the percentage of each ingredient contained in the Covered Product. This list shall
18 be provided once for each Covered Product for which YOUNGEVITY utilizes the naturally
19 occurring allowances within 15 days of any attempt to use the naturally occurring defense, and
20 YOUNGEVITY shall send a supplemental list in the event the Table 3.1 ingredient percentage
21 changes in the future. If, after receiving the ingredient list from YOUNGEVITY, ERC disputes
22 the amount of the ingredients from Table 3.1 in the Covered Product, YOUNGEVITY shall
23 provide ERC with a manufacturer's declaration as to the specific ingredient at issue.

24 **3.2 Clear and Reasonable Warnings**

25 If YOUNGEVITY is required to provide a warning ("Warning") pursuant to Section 3.1,
26 the following warning must be utilized:

1 **[PROPOSITION 65] WARNING: This product contains [lead,] a chemical known to**
2 **the State of California to cause [cancer and] birth defects or other reproductive harm.**

3 YOUNGEVITY shall use the phrase “cancer and” in the Warning only if the maximum
4 daily dose recommended on the label contains more than 15 micrograms of lead as determined
5 pursuant to the quality control methodology set forth in Section 3.4. The word “lead” is
6 optional, as Proposition 65 permits, but does not require, the specific chemical to be identified.
7 The words “PROPOSITION 65” are also optional. No other statements about Proposition 65 or
8 lead may accompany the Warning. For illustrative purposes only, attached hereto as Exhibits B
9 and C are examples of warnings that provide an adequate warning under this Consent Judgment.

10 YOUNGEVITY shall provide the Warning on at least one of the following: 1) on the
11 container, cap, or label of each Covered Product; 2) on YOUNGEVITY checkout page on their
12 website for California consumers; 3) on YOUNGEVITY insert in boxes of Covered Products
13 shipped to California; or 4) on YOUNGEVITY packing list in boxes of Covered Products
14 shipped to California.

15 For a Warning appearing on the checkout page, insert, or packing list, YOUNGEVITY
16 shall identify with an asterisk (or some other identifying method) each product to which the
17 Warning applies and YOUNGEVITY shall not include a Warning that does not identify (with an
18 asterisk or some other identifying method) the product to which the Warning applies.

19 For a Warning appearing on the container, cap, or label of the Covered Product, the
20 Warning shall be securely affixed to or printed upon the container, cap, or label of the Covered
21 Product. The Warning shall be displayed with such conspicuousness, as compared with other
22 words, statements, or design of the label, container or cap, as applicable, to render the Warning
23 likely to be read and understood by an ordinary individual under customary conditions of
24 purchase or use of the product. The Warning appearing on the label, container, or cap shall be at
25 least the same size as the largest of any other health or safety warnings correspondingly

1 appearing on the label, container, or cap, as applicable, of such product, and the word

2 **“WARNING”** shall be in all capital letters and in bold print.

3 If YOUNGEVITY provides the Warning in an insert, YOUNGEVITY shall provide one
4 insert Warning for each Covered Product in a box or one insert warning that lists all of the
5 Covered Products in the box. The insert Warning will be a minimum of 5 inches x 7 inches. If
6 YOUNGEVITY provides the Warning in a packing list, the packing list shall identify each
7 Covered Product with an asterisk, and the Warning must be present on the front of the packing
8 list. If a Warning is provided in an insert or packing list, the Covered Products may be returned
9 by the consumer for a refund within 30 days of the invoice date if the consumer references the
10 Warning as a reason for the return. If YOUNGEVITY provides the Warning in an insert, the
11 Warning must be present on the front of the insert.

12 **3.3 Reformulated Covered Products**

13 A Reformulated Covered Product is one for which the Daily Lead Exposure Level when the
14 maximum suggested dose is taken as directed on the Reformulated Covered Product’s label,
15 contains no more than 0.5 micrograms of lead per day as determined by the quality control
16 methodology described in Section 3.4, excluding the naturally occurring lead allowances listed in
17 Table 3.1. Reformulated Products are not subject to the warning requirements of Section 3.2.

18 **3.4 Testing and Quality Control Methodology**

19 **3.4.1** All testing pursuant to this Consent Judgment shall be performed using a
20 laboratory method that complies with the performance and quality control factors appropriate for
21 the method used, including limit of detection, qualification, accuracy, and precision that meets
22 the following criteria: Inductively Coupled Plasma-Mass Spectrometry (ICP-MS) achieving a
23 limit of quantification of less than or equal to 0.010 mg/kg or any other testing method
24 subsequently agreed upon in writing by the Parties.

25 **3.4.2** All testing pursuant to this Consent Judgment shall be performed by an
26 independent third-party laboratory certified by the California Environmental Laboratory

1 Accreditation Program or an independent third-party laboratory that is registered with the United
2 States Food & Drug Administration. Nothing in this Consent Judgment shall limit
3 YOUNGEVITY's ability to conduct, or require that others conduct, additional testing of the
4 Covered Products, including the raw materials used in their manufacture.

5 **3.4.3** At its option, YOUNGEVITY may designate any Covered Product as a
6 Reformulated Covered Product and elect to remove the warnings otherwise required by this
7 Consent Judgment if the Covered Product at issue does not expose a person to a Daily Lead
8 Exposure Level of more than 0.5 micrograms per day, as defined in section 3.1 above.
9 YOUNGEVITY may elect to remove the warnings from the Reformulated Covered Product(s)
10 when it is satisfied that no warnings are required. YOUNGEVITY shall engage in ongoing
11 testing as set forth below, but may elect to remove warnings prior to the completion of the three-
12 year testing protocol if it is satisfied that no warnings are required under the terms of this Consent
13 Judgment. Upon YOUNGEVITY's election to remove the warning, YOUNGEVITY shall
14 arrange for lead testing of the Reformulated Covered Product at issue by arranging for testing of
15 three randomly selected samples of the Reformulated Covered Product, in the form intended for sale
16 to the end-user, which YOUNGEVITY intends to sell or is manufacturing for sale in California,
17 directly selling to a consumer in California or "Distributing into California." Calculations for
18 determining whether a warning is or is not required shall be based on section 3.1.2. of this agreement
19 minus any allowances from Table 3.1 YOUNGEVITY agrees to conduct this testing protocol a
20 total of three times, over three consecutive years. YOUNGEVITY need not provide the test
21 results to ERC unless ERC requests the test results in writing, in which case YOUNGEVITY
22 shall provide the requested test results to ERC in writing within ten (10) business days. If tests
23 conducted pursuant to this Section confirm that no warning was required for a Reformulated
24 Covered Product during each of the three (3) consecutive years, then the testing requirements of
25 this Section will no longer be required as to that Reformulated Covered Product. However, if
26 YOUNGEVITY changes ingredient suppliers for any of the Covered Products and/or

1 reformulates any of the Covered Products, YOUNGEVITY shall test that Covered Product at
2 least once after such change is made. The testing requirements discussed in Section 3.4 are not
3 applicable to any Covered Product for which YOUNGEVITY has provided the warning as
4 specified in Section 3.2.

5 **3.5 Sell Through Period.**

6 Notwithstanding anything else in this Consent Judgment, YOUNGEVITY's Covered
7 Products that were manufactured prior to the Effective Date shall be subject to the release of
8 liability pursuant to Section 8 of this Consent Judgment, without regard to when such Covered
9 Products were, or are in the future, distributed or sold to consumers. As a result, the obligations
10 of YOUNGEVITY as set forth in this Consent Judgment, including but not limited to Section 3,
11 do not apply to these products manufactured prior to the Effective Date. Within no more than
12 ten (10) days of the Effective Date, YOUNGEVITY will provide ERC with the final lot numbers
13 of Covered Products manufactured before the Effective Date.

14 **4. SETTLEMENT PAYMENT**

15 **4.1** In full satisfaction of all potential civil penalties, payment in lieu of civil penalties,
16 attorney's fees, and costs, YOUNGEVITY shall make a total payment of \$410,000.00, ("Total
17 Settlement Amount"), payable in twelve (12) monthly installments to ERC. Specifically,
18 YOUNGEVITY shall make eleven (11) monthly payments of \$34,166.66 each and one (1) final
19 monthly payment of \$34,166.74, with the first payment due on the first of the month following
20 Court approval of this Consent Judgment and the remaining payments due on the first day of
21 each of the following months until the Total Settlement Amount is paid. YOUNGEVITY shall
22 make these payments by wire transfer to ERC's escrow account, for which ERC will give
23 YOUNGEVITY the necessary account information. The Total Settlement Amount shall be
24 apportioned as follows:

25 **4.2** \$90,000.00 shall be considered a civil penalty pursuant to California Health and
26 Safety Code §25249.7(b)(1). ERC shall remit 75% (\$67,500.00) of the civil penalty to the Office

1 of Environmental Health Hazard Assessment ("OEHHA") for deposit in the Safe Drinking Water
2 and Toxic Enforcement Fund in accordance with California Health and Safety Code
3 §25249.12(c). ERC will retain the remaining 25% (\$22,500.00) of the civil penalty.

4 **4.3** \$19,043.29 shall be distributed to Environmental Research Center as
5 reimbursement to ERC for reasonable costs incurred in bringing this action; and \$60,255.49 shall
6 be distributed to Environmental Research Center in lieu of further civil penalties, for the day-to-
7 day business activities such as (1) continued enforcement of Proposition 65, which includes
8 work, analyzing, researching and testing consumer products that may contain Proposition 65
9 chemicals, focusing on the same or similar type of ingestible products that are the subject matter
10 of the current action; (2) the continued monitoring of past consent judgments and settlements to
11 ensure companies are in compliance with Proposition 65; and (3) giving a donation of \$3,000.00
12 to the Global Community Monitor to address reducing toxic chemical exposures in California.

13 **4.4** \$180,000.00 shall be distributed to Lozeau|Drury LLP as reimbursement of
14 ERC's attorney's fees, while \$60,701.22 shall be distributed to ERC for its in-house legal fees.

15 **5. MODIFICATION OF CONSENT JUDGMENT**

16 **5.1** This Consent Judgment may be modified only (i) by written stipulation of the
17 Parties or pursuant to Section 5.4 and (ii) upon entry by the Court of a modified consent
18 judgment.

19 **5.2** If YOUNGEVITY seeks to modify this Consent Judgment under Section 5.1, then
20 YOUNGEVITY must provide written notice to ERC of its intent ("Notice of Intent"). If ERC
21 seeks to meet and confer regarding the proposed modification in the Notice of Intent, then ERC
22 must provide written notice to YOUNGEVITY within thirty days of receiving the Notice of
23 Intent. If ERC notifies YOUNGEVITY in a timely manner of ERC's intent to meet and confer,
24 then the Parties shall meet and confer in good faith as required in this Section. The Parties shall
25 meet in person or via telephone within thirty (30) days of ERC's notification of its intent to meet
26 and confer. Within thirty days of such meeting, if ERC disputes the proposed modification, ERC

1 shall provide to YOUNGEVITY a written basis for its position. The Parties shall continue to
2 meet and confer for an additional thirty (30) days in an effort to resolve any remaining disputes.
3 Should it become necessary, the Parties may agree in writing to different deadlines for the meet-
4 and-confer period.

5 **5.3** In the event that YOUNGEVITY initiates or otherwise requests a modification
6 under Section 5.1 for its primary benefit, and the meet and confer process leads to a joint motion
7 or joint-application of the Consent Judgment at YOUNGEVITY's request, then YOUNGEVITY
8 shall reimburse ERC its costs and reasonable attorney's fees for the time spent in the meet-and-
9 confer process and filing and arguing the motion or application, provided that ERC must inform
10 YOUNGEVITY of its anticipated attorney's fees and costs prior to any such motion or
11 application. ERC, however, agrees that, since it would not be opposing YOUNGEVITY's
12 motion and/or application in such a court proceeding, it will seek minimize its attorneys' fees
13 and costs during such a proceeding. ERC also agrees to meet and confer with YOUNGEVITY
14 in the event that YOUNGEVITY requests a conference to discuss ERC's anticipated attorneys'
15 fees and costs.

16 **5.4** Where the meet-and-confer process does not lead to a joint motion or application
17 in support of a modification of the Consent Judgment, then either Party may seek judicial relief
18 on its own. In such a situation, the prevailing party may seek to recover costs and reasonable
19 attorney's fees. As used in the preceding sentence, the term "prevailing party" means a party
20 who is successful in obtaining relief more favorable to it than the relief that the other party was
21 amenable to providing during the Parties' good faith attempt to resolve the dispute that is the
22 subject of the modification.

1 **6. RETENTION OF JURISDICTION, ENFORCEMENT OF CONSENT**
2 **JUDGMENT**

3 **6.1** This Court shall retain jurisdiction of this matter to enforce, modify or terminate
4 this Consent Judgment.

5 **6.2** If ERC alleges that any Covered Product fails to qualify as a Reformulated
6 Covered Product (for which ERC alleges that no warning has been provided), then ERC shall
7 inform YOUNGEVITY in a reasonably prompt manner of its test results, including information
8 sufficient to permit YOUNGEVITY to identify the Covered Products at issue. YOUNGEVITY
9 shall, within forty five (45) days following such notice ("YOUNGEVITY's EVALUATION
10 PERIOD"), provide ERC with any information, including testing information, from an
11 independent third-party laboratory meeting the requirements of Sections 3.4.1 and 3.4.2,
12 demonstrating YOUNGEVITY's compliance with the Consent Judgment, if warranted. The
13 Parties shall first attempt in good faith to resolve the matter prior to ERC taking any further legal
14 action. If the Parties are unable to informally resolve their dispute after good faith efforts, then
15 either Party may seek enforcement of this Consent Judgment from the Court. The prevailing
16 Party in any such enforcement action shall be entitled to its reasonable attorney's fees and costs
17 as determined by the Court.

18 **6.3** Should there be an amendment to Proposition 65 or should OEHHA promulgate
19 regulations that establish a Maximum Allowable Dose Level ("MADL") of lead that is more or
20 less stringent than 0.5 micrograms per day, this Consent Judgment shall be deemed modified on
21 the date the amendment becomes final to incorporate the new standard, provided however, such
22 time period shall be extended to include the completion through final appeal of timely filed legal
23 challenges. The new MADL shall thereafter replace the references in this Consent Judgment to
24 0.5 micrograms.

25 **7. APPLICATION OF CONSENT JUDGMENT**

26 This Consent Judgment may apply to, be binding upon, and benefit the Parties and their

1 respective officers, directors, shareholders, employees, agents, parent companies, subsidiaries,
2 divisions, affiliates, franchisees, licensees, customers (excluding private labelers), distributors,
3 wholesalers, retailers, predecessors, successors, and assigns. This Consent Judgment shall have no
4 application to Covered Products which are distributed or sold exclusively outside the State of
5 California and which are not used by California consumers.

6 **8. BINDING EFFECT, CLAIMS COVERED AND RELEASED**

7 **8.1** This Consent Judgment is a full, final, and binding resolution between ERC, on
8 behalf of itself and in the public interest, and YOUNGEVITY, of any alleged violation of
9 Proposition 65 or its implementing regulations for failure to provide Proposition 65 warnings of
10 exposure to lead from the handling, use, or consumption of the Covered Products and fully
11 resolves all claims that have been or could have been asserted in this action up to and including
12 the Effective Date for failure to provide Proposition 65 warnings for the Covered Products and
13 the R-Garden Products and the Other Noticed Product. ERC, on behalf of itself and in the public
14 interest, hereby discharges YOUNGEVITY and its respective officers, directors, shareholders,
15 employees, agents, parent companies, subsidiaries, divisions, affiliates, suppliers, franchisees,
16 licensees, customers (not including private label customers of YOUNGEVITY), distributors,
17 wholesalers, retailers, and all other upstream and downstream entities in the distribution chain of
18 any Covered Product, and the predecessors, successors and assigns of any of them (collectively,
19 "Released Parties"), from any and all claims, actions, causes of action, suits, demands, liabilities,
20 damages, penalties, fees, costs and expenses asserted, or that could have been asserted, as to any
21 alleged violation of Proposition 65 arising from the failure to provide Proposition 65 warnings
22 on the Covered Products and the R-Garden Products and the Other Noticed Product regarding
23 lead.

24 **8.2.** ERC on its own behalf only, on one hand, and YOUNGEVITY on its own behalf
25 only, on the other, further waive and release any and all claims they may have against each other
26 for all actions or statements made or undertaken in the course of seeking or opposing enforcement

1 of Proposition 65 in connection with the Notices or Amended Complaint up through and including
2 the Effective Date, provided, however, that nothing in Section 8 shall affect or limit any Party's
3 right to seek to enforce the terms of this Consent Judgment.

4 **8.3.** It is possible that other claims not known to the Parties arising out of the facts
5 alleged in the Notices or the Amended Complaint and relating to the Covered Products or the R-
6 Garden Products or the Other Noticed Product will develop or be discovered. ERC on behalf of
7 itself only, on one hand, and YOUNGEVITY, on the other hand, acknowledge that this Consent
8 Judgment is expressly intended to cover and include all such claims up through the Effective
9 Date, including all rights of action therefore. ERC and YOUNGEVITY acknowledge that the
10 claims released in Sections 8.1 and 8.2 above may include unknown claims, and nevertheless
11 waive California Civil Code section 1542 as to any such unknown claims. California Civil Code
12 section 1542 reads as follows:

13 A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE
14 CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER
15 FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF
16 KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS
17 OR HER SETTLEMENT WITH THE DEBTOR.

18 ERC on behalf of itself only, on the one hand, and YOUNGEVITY, on the other hand,
19 acknowledge and understand the significance and consequences of this specific waiver of
20 California Civil Code section 1542.

21 **8.4** Compliance with the terms of this Consent Judgment shall be deemed to constitute
22 compliance with Proposition 65 by any releasee regarding alleged exposures to lead in the
23 Covered Products as set forth in the Notices and the Amended Complaint.

24 **8.5** Nothing in this Consent Judgment is intended to apply to any occupational or
25 environmental exposures arising under Proposition 65, nor shall it apply to any of Youngevity's
26 products other than the Covered Products.

27 **9. SEVERABILITY OF UNENFORCEABLE PROVISIONS**

28 In the event that any of the provisions of this Consent Judgment are held by a court to be

1 unenforceable, the validity of the remaining enforceable provisions shall not be adversely affected.

2 **10. GOVERNING LAW**

3 The terms and conditions of this Consent Judgment shall be governed by and construed in
4 accordance with the laws of the State of California.

5 **11. PROVISION OF NOTICE**

6 All notices required to be given to either Party to this Consent Judgment by the other shall
7 be in writing and sent to the following agents listed below by: (a) registered or certified mail; (b)
8 overnight courier; or (c) personal delivery. Courtesy copies via email must also be sent to the
9 electronic mail addresses listed below.

8 **12. COURT APPROVAL**

9 **12.1** Upon execution of this Consent Judgment by the Parties, ERC shall notice a
10 Motion for Court Approval. The Parties shall use their best efforts to support entry of this
11 Consent Judgment.

12 **12.2** If the California Attorney General objects to any term in this Consent Judgment,
13 the Parties shall use their best efforts to resolve the concern in a timely manner, and if possible
14 prior to the hearing on the motion.

15 **12.3** If this Stipulated Consent Judgment is not approved by the Court, it shall be void
16 and have no force or effect.

17 **13. EXECUTION AND COUNTERPARTS**

18 This Consent Judgment may be executed in counterparts, which taken together shall be
19 deemed to constitute one document. A facsimile or .pdf signature shall be construed as valid as the
20 original signature.

21 **14. DRAFTING**

22 The terms of this Consent Judgment have been reviewed by the respective counsel for each
23 Party prior to its signing, and each Party has had an opportunity to fully discuss the terms with
24 counsel. The Parties agree that, in any subsequent interpretation and construction of this Consent
25 Judgment entered thereon, the terms and provisions shall not be construed against any Party.

26 **15. GOOD FAITH ATTEMPT TO RESOLVE DISPUTES**

27 If a dispute arises with respect to either Party's compliance with the terms of this Consent
28 Judgment entered by the Court, the Parties shall meet in person or by telephone and endeavor to

1 resolve the dispute in an amicable manner. No action or motion may be filed in the absence of such
2 a good faith attempt to resolve the dispute beforehand. In the event an action or motion is filed,
3 however, the prevailing party may seek to recover costs and reasonable attorney's fees. As used in
4 the preceding sentence, the term "prevailing party" means a party who is successful in obtaining
5 relief more favorable to it than the relief that the other party was amenable to providing during the
6 Parties' good faith attempt to resolve the dispute that is the subject of such enforcement action.

7 **16. ENTIRE AGREEMENT, AUTHORIZATION**

8 **16.1.** This Consent Judgment contains the sole and entire agreement and understanding
9 of the Parties with respect to the entire subject matter herein, and any and all prior discussions,
10 negotiations, commitments and understandings related hereto. No representations, oral or
11 otherwise, express or implied, other than those contained herein have been made by any Party.
12 No other agreements, oral or otherwise, unless specifically referred to herein, shall be deemed to
13 exist or to bind any Party.

14 **16.2** Each signatory to this Consent Judgment certifies that he or she is fully authorized
15 by the Party he or she represents to stipulate to this Consent Judgment. Except as explicitly
16 provided herein, each Party shall bear its own fees and costs.

17 **17. REQUEST FOR FINDINGS, APPROVAL OF SETTLEMENT AND ENTRY OF**
18 **CONSENT JUDGMENT**

19 This Consent Judgment has come before the Court upon the request of the Parties. The
20 Parties request the Court to fully review this Consent Judgment and, being fully informed regarding
21 the matters which are the subject of this action, to:

22 (1) Find that the terms and provisions of this Consent Judgment represent a fair and
23 equitable settlement of all matters raised by the allegations of the Complaint, that the matter has
24 been diligently prosecuted, and that the public interest is served by such settlement; and

25 (2) Make the findings pursuant to California Health and Safety Code section
26 25249.7(f)(4), approve the Settlement, and approve this Consent Judgment.

I represent the Environmental Research Center ("ERC") in connection with this Notice of Violations of California's Safe Drinking Water and Toxic Enforcement Act of 1986, which is codified at California Health & Safety Code Section 25249.5 *et seq.* and also referred to as Proposition 65.

ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

The name of the Company covered by this notice that violated Proposition 65 (hereinafter the "Violator") is:

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

This letter is a notice to the Violator and the appropriate governmental authorities of the Proposition 65 violations concerning the listed products. This notice covers all violations of Proposition 65 involving the Violator currently known to ERC from the information now available. ERC may continue to investigate other products that may reveal further violations. A summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is enclosed with the copy of this letter to the Violator.



The Violator has manufactured, marketed, distributed, and/or sold the listed products, which have exposed and continue to expose numerous individuals within California to the identified chemical, lead. The consumer exposures that are the subject of this notice result from the purchase, acquisition, handling and/or recommended use of these products by consumers. The primary route of exposure to lead has been through ingestion, but may have also occurred through inhalation and/or dermal contact. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to lead. The method of warning should be a warning that appears on the product's label. The Violator violated Proposition 65 because it failed to provide an appropriate warning to persons using and/or handling these products that they are being exposed to lead. Each of these ongoing violations has occurred on every day since May 17, 2010, as well as every day since the products were introduced in the California marketplace, and will continue every day until clear and reasonable warnings are provided to product purchasers and users.

Pursuant to Section 25249.7(d) of the statute, ERC intends to file a citizen enforcement action sixty days after effective service of this notice unless the Violator agrees in an enforceable written instrument to: (1) reformulate the listed products so as to eliminate further exposures to lead; and (2) pay an appropriate civil penalty. Consistent with the public interest goals of Proposition 65 and my client's objectives in pursuing this notice, ERC is interested in seeking a constructive resolution to this matter. Such resolution will avoid both further unwarned consumer exposures to the identified chemical and expensive and time-consuming litigation.
