24	1. INTRODUCTION	
25	1.1 The parties to this Consent Judgment ("Parties") are the Center for Environmental Health ("CEH") and defendant Olympic Mountain and Marine Products, Inc., dba

Olympic Mountain Products ("Settling Defendant").	CEH and Settling Defendant are referred to
collectively as the "Parties."	

- 1.2 Settling Defendant is a corporation that employs ten (10) or more persons and that manufactures, distributes and/or sells shampoo and liquid soaps that contain coconut oil diethanolamine condensate (cocamide diethanolamine) (hereinafter, "cocamide DEA") in the State of California or has done so in the past.
- On September 27, 2013, CEH served a 60-Day Notice of Violation under Proposition 65 (The Safe Drinking Water and Toxic Enforcement Act of 1986, California Health & Safety Code §§ 25249.5, et seq.) (the "Notice") to Settling Defendant, the California Attorney General, the District Attorneys of every County in the State of California, and the City Attorneys for every City in the State of California with a population greater than 750,000. The Notice alleges violations of Proposition 65 with respect to the presence of cocamide DEA in shampoo and liquid soaps manufactured, distributed and/or sold by Settling Defendant.
- 1.4 On December 18, 2013, CEH filed the action entitled *CEH v. Skinfood USA*, *Inc.*, *et al.*, Case No. RG 13-707307, in the Superior Court of California for Alameda County, naming Settling Defendant as a defendant in that action.
- 1.5 For purposes of this Consent Judgment only, the Parties stipulate that: (i) this Court has jurisdiction over the allegations of violations contained in the operative Complaint applicable to Settling Defendant (the "Complaint") and personal jurisdiction over Settling Defendant as to the acts alleged in the Complaint; (ii) that venue is proper in the County of Alameda; and (iii) that this Court has jurisdiction to enter this Consent Judgment.
- 1.6 Nothing in this Consent Judgment is or shall be construed as an admission by the Parties of any fact, conclusion of law, issue of law or violation of law, nor shall compliance with the Consent Judgment constitute or be construed as an admission by the Parties of any fact, conclusion of law, issue of law, or violation of law. Nothing in this Consent Judgment shall prejudice, waive or impair any right, remedy, argument or defense the Parties may have in any other legal proceeding. This Consent Judgment is the product of negotiation and compromise and is accepted by the Parties for purposes of settling, compromising and resolving issues disputed in

Defendant shall not manufacture, distribute, sell or offer for sale any Covered Product that

contains cocamide DEA and that will be sold or offered for sale to California consumers. For

purposes of this Consent Judgment, a product "contains cocamide DEA" if cocamide DEA is an intentionally added ingredient in the product and/or part of the product formulation.

3.2 **Specification to Suppliers.** No more than 30 days after the Effective Date, Settling Defendant shall issue specifications to its suppliers of Covered Products requiring that Covered Products not contain any cocamide DEA, and shall instruct each supplier to use reasonable efforts to eliminate Covered Products containing cocamide DEA on a nationwide basis.

3.3 Action Regarding Specific Products.

3.3.1 On or before the Effective Date, Settling Defendant shall, to the extent it has not already done so, cease selling the Morgan Childs Premium Shower Gel in Pomegranate, SKU No. 0-34644-33350-7 (the "Section 3.3 Product") in California. On or before the Effective Date, Settling Defendant shall also, to the extent it has not already done so,: (i) cease shipping the Section 3.3 Product to any of its stores and/or customers that resell the Section 3.3 Product in California, and (ii) send instructions to its stores and/or customers that resell the Section 3.3 Product in California instructing them either to: (a) return all the Section 3.3 Product to Settling Defendant for destruction; or (b) directly destroy the Section 3.3 Product.

3.3.2 Any destruction of Section 3.3 Product shall be in compliance with all applicable laws.

Within sixty days of the Effective Date, Settling Defendant shall provide 3.3.3 CEH with written certification from Settling Defendant confirming compliance with the requirements of this Section 3.3.

4.1 CEH may, by motion or application for an order to show cause before the Superior Court of Alameda County, enforce the terms and conditions contained in this Consent Judgment. Prior to bringing any motion or application to enforce the requirements of Section 3 above, CEH shall provide Settling Defendant with a Notice of Violation and a copy of any test results which purportedly support CEH's Notice of Violation. The Parties shall then meet and confer regarding the basis for CEH's anticipated motion or application in an attempt to resolve it informally, including providing Settling Defendant a reasonable opportunity of at least thirty (30) days to cure any alleged violation. Should such attempts at informal resolution fail, CEH may file its enforcement motion or application. The prevailing party on any motion to enforce this Consent Judgment shall be entitled to its reasonable attorney's fees and costs incurred as a result of such motion or application. This Consent Judgment may only be enforced by the Parties.

5. **PAYMENTS**

- 5.1 Payments by Settling Defendant. Within five (5) business days of the Effective Date, Settling Defendant shall pay the total sum of \$15,000 as a settlement payment. The total settlement amount for Settling Defendant shall be paid in four separate checks delivered to counsel for CEH at the address set forth in Section 8.1 below. The funds paid by Settling Defendant shall be allocated between the following categories:
- 5.1.1 \$1,650 as a civil penalty pursuant to Health & Safety Code § 25249.7(b), such money to be apportioned by CEH in accordance with Health & Safety Code § 25249.12 (25% to CEH and 75% to the State of California's Office of Environmental Health Hazard Assessment). The civil penalty check shall be made payable to the Center For Environmental Health.
- 5.1.2 \$2,250 as a payment in lieu of civil penalty to CEH pursuant to Health & Safety Code § 25249.7(b), and California Code of Regulations, Title 11, § 3203(b). CEH will use

such funds to continue its work educating and protecting people from exposures to toxic chemicals. CEH may also use a portion of such funds to monitor compliance with this Consent Judgment and to purchase and test Settling Defendant's products to confirm compliance. In addition, as part of its Community Environmental Action and Justice Fund, CEH will use four percent (4%) of such funds to award grants to grassroots environmental justice groups working to educate and protect people from exposures to toxic chemicals. The method of selection of such groups can be found at the CEH web site at www.ceh.org/justicefund. The payment pursuant to this Section shall be made payable to the Center For Environmental Health.

5.1.3 \$11,100 as reimbursement of a portion of CEH's reasonable attorneys' fees and costs. A check for \$9,600 shall be made payable to the Lexington Law Group, and a check for \$1,500 shall be made payable to the Center For Environmental Health.

6. MODIFICATION

- 6.1 **Written Consent.** This Consent Judgment may be modified from time to time by express written agreement of the Parties with the approval of the Court, or by an order of this Court upon motion and in accordance with law.
- 6.2 **Meet and Confer.** Any Party seeking to modify this Consent Judgment shall attempt in good faith to meet and confer with all affected Parties prior to filing a motion to modify the Consent Judgment.

7. CLAIMS COVERED AND RELEASED

This Consent Judgment is a full, final and binding resolution between CEH on behalf of itself and the public interest and Settling Defendant, and its parents, subsidiaries, affiliated entities that are under common ownership, directors, officers, employees, and attorneys ("Defendant Releasees"), and all entities to whom they directly or indirectly distribute or sell Covered Products including, but not limited to, distributors, wholesalers, customers, retailers, franchisees, cooperative members, and licensees ("Downstream Releasees"), of any violation of Proposition 65 that was or could have been asserted in the Complaint against Settling Defendant, Defendant Releasees, and/or Downstream Releasees, based on failure to warn about alleged exposure to cocamide DEA contained in Covered Products that were sold by Settling Defendant

- The Parties, including their counsel, have participated in the preparation of this Consent Judgment and this Consent Judgment is the result of the joint efforts of the Parties. This Consent Judgment was subject to revision and modification by the Parties and has been accepted and approved as to its final form by all Parties and their counsel. Accordingly, any uncertainty or ambiguity existing in this Consent Judgment shall not be interpreted against any Party as a result of the manner of the preparation of this Consent Judgment. Each Party to this Consent Judgment agrees that any statute or rule of construction providing that ambiguities are to
