4 The Motion to Approve and Enter [Proposed] Proposition 65 Consent Judgment is GRANTED.


5 The Court makes the following findings pursuant to California Health and Safety Code Section  
6 25249.7(f) and 11 Cal. Code Regs. Section 3201 et seq.:

- 7 1. The warning required by the Stipulated Consent Judgment complies with Health  
8 and Safety Code Sections 25249.5 *et seq.* ("Proposition 65");
- 9 2. The award of attorneys' fees and costs provided in the Stipulated Consent Judgment  
10 is reasonable under California law;
- 11 3. The penalties provided by the Stipulated Consent Judgment are reasonable based on  
12 the criteria set forth in Health and Safety Code Section 25249.7(b);
- 13 4. Plaintiff's continued prosecution of the action was necessary to obtain the relief in  
14 the Stipulated Consent Judgment; and
- 15 5. The Stipulated Consent Judgment is in the public interest.

16 Therefore, for the foregoing reasons, the Stipulated Consent Judgment shall be entered as the  
17 Judgment of this Court as of the date of entry this Order.

18 IT IS SO ORDERED. *Proposed consent judgment to be submitted by Plaintiff.*
