

24 **1. INTRODUCTION**

25 1.1 On November 13, 2014, Plaintiff Environmental Research Center ("ERC"), a
26 non-profit corporation, as a private enforcer, and in the public interest, initiated the action
27 captioned above by filing a Complaint for Injunctive Relief and Civil Penalties (the
28 "Complaint") pursuant to the provisions of California Health and Safety Code section 25249.5

1 *et seq.* ("Proposition 65"), against Living Ecology Inc., Living Ecology Manufacturing Inc.,
2 and Does 1-25.

3 1.2 Defendant Living Ecology Inc. is an active Nevada Corporation. Defendant
4 Living Ecology Manufacturing Inc. is an active California Corporation. Defendants Living
5 Ecology Inc. and Living Ecology Manufacturing Inc. are hereinafter collectively referred to as
6 "Living Ecology".

7 1.3 Thereafter, on July 22, 2015, ERC filed a separate Complaint for Injunctive
8 Relieve and Civil Penalties in a second action against Living Ecology, Inc. Living Ecology
9 Manufacturing, Inc. and Does 1-25, inclusive; i.e. Alameda County Superior Court Case
10 Number RG15778780. The action captioned first above, and the second action filed in
11 Alameda County Superior Court Case Number RG15778780 involve the same parties, similar
12 products, and related claims and are collectively referred to herein as the "Actions". In the
13 Actions, ERC alleges that a number of products manufactured, distributed or sold by Living
14 Ecology contain lead (a-p below), cadmium (q and r below), or both lead and cadmium (l
15 below), which are chemicals listed under Proposition 65 as carcinogens and reproductive
16 toxins, and expose consumers to these chemicals at levels requiring a Proposition 65 warning.
17 These products (referred to hereinafter individually as a "Covered Product" or collectively as
18 "Covered Products") are:

- 19 a. Bio International Organic Active Greens Powder
- 20 b. Bio International Organic Active Greens
- 21 c. Organic Food Bar Inc. Raw Organic Food Bar Cinnamon Raisin

- 24 e. Organic Food Bar Inc. Organic Food Bar Chocolate Covered

- 26 f. Organic Food Bar Inc. Organic Food Bar Active Greens- Protein
27 Chocolate Covered
- 28 g. Organic Food Bar Inc. Organic Food Bar Active Greens

- 1 h. Organic Food Bar Inc. Organic Food Bar Active Greens Chocolate
- 2 i. Organic Food Bar Inc. Organic Food Bar Original
- 3 j. Organic Food Bar Inc. Organic Food Bar Protein
- 4 k. Organic Food Bar Inc. Organic Food Bar Vegan
- 5 l. Organic Food Bar Inc. OFB Vegan Protein Vanilla
- 6 m. Organic Food Bar Inc. OFB Vegan Protein Strawberry

12 1.4 ERC and Living Ecology are hereinafter referred to individually as a "Party" or
13 collectively as the "Parties."

14 1.5 ERC is a California non-profit corporation dedicated to, among other causes,
15 helping safeguard the public from health hazards by reducing the use and misuse of hazardous
16 and toxic chemicals, facilitating a safe environment for consumers and employees, and
17 encouraging corporate responsibility.

18 1.6 For purposes of this Consent Judgment, the Parties agree that Living Ecology is a
19 business entity that has employed ten or more persons at all times relevant to this action, and
20 qualifies as a "person in the course of business" within the meaning of Proposition 65. Living
21 Ecology manufactures, distributes or sells the Covered Products.

22 1.7 The Actions are based on allegations contained in ERC's Notices of Violation
23 dated January 31, 2014 and April 4, 2014, and April 10, 2015 that were served on the
24 California Attorney General, other public enforcers, and Living Ecology (the "Notices"). True
25 and correct copies of the Notices are attached as Exhibit A and are hereby incorporated by
26 reference. More than 60 days have passed since the Notices were mailed and uploaded to the
27 Attorney General's website, and no designated governmental entity has filed a complaint
28 against Living Ecology with regard to the Covered Products or the alleged violations.

1 1.8 ERC's Notices and Complaint allege that use or consumption of the Covered
2 Products exposes persons in California to lead and/or cadmium without first providing clear
3 and reasonable warnings in violation of California Health and Safety Code section 25249.6.
4 Living Ecology denies all material allegations contained in the Notices and the Complaint.

5 1.9 The Parties have entered into this Consent Judgment in order to settle,
6 compromise and resolve disputed claims and thus avoid prolonged and costly litigation.
7 Nothing in this Consent Judgment shall constitute or be construed as an admission by any of
8 the Parties, or by any of their respective officers, directors, shareholders, employees, agents,
9 parent companies, subsidiaries, divisions, affiliates, franchisees, licensees, customers, suppliers,
10 distributors, wholesalers, or retailers. Except for the representations made above, nothing in
11 this Consent Judgment shall be construed as an admission by the Parties of any fact, issue of
12 law, or violation of law, nor shall compliance with this Consent Judgment be construed as an
13 admission by the Parties of any fact, issue of law, or violation of law, at any time, for any
14 purpose.

15 1.10 Except as expressly set forth herein, nothing in this Consent Judgment shall
16 prejudice, waive, or impair any right, remedy, argument, or defense the Parties may have in any
17 other or future legal proceeding unrelated to these proceedings, the Actions, or the Covered
18 Products.

19 1.11 The Effective Date of this Consent Judgment is the date on which it is entered
20 as a Judgment by this Court.

21 **2. JURISDICTION AND VENUE**

22 For purposes of this Consent Judgment and any further court action that may become
23 necessary to enforce this Consent Judgment, the Parties stipulate that this Court has subject matter
24 jurisdiction over the allegations of violations contained in the Complaint, personal jurisdiction
25 over Living Ecology as to the acts alleged in the Complaint, that venue is proper in Alameda
26 County, and that this Court has jurisdiction to enter this Consent Judgment as a full and final
27 compromise and resolution of all claims up through and including the Effective Date which were
28 or could have been asserted in this action based on the facts alleged in the Notices and Complaint.

1 **3. INJUNCTIVE RELIEF AND WARNINGS**

2 **3.1** Beginning four (4) months following the Effective Date (the "Compliance
3 Date"), Living Ecology shall be permanently enjoined from manufacturing for sale in the State
4 of California, "Distributing into the State of California", or directly selling in the State of
5 California, any Covered Product which exposes a person to a "Daily Lead Exposure Level" of
6 more than 0.5 micrograms per day of lead or "Daily Cadmium Exposure Level" of more than
7 4.10 micrograms per day of cadmium when the maximum suggested dose is taken as directed
8 on the Covered Product's label excluding the lead deemed "naturally occurring" for purposes
9 of this Consent Judgment only pursuant to Section 3, unless it meets the warning requirements
10 under Section 3.2.

11 **3.1.1** As used in this Consent Judgment, the term "Distributing into the State
12 of California" shall mean to directly ship a Covered Product into California for sale in
13 California or to sell a Covered Product to a distributor that Living Ecology knows will sell the
14 Covered Product in California.

15 **3.1.2** For purposes of this Consent Judgment, the "Daily Lead Exposure
16 Level" and "Daily Cadmium Exposure Level" shall be measured in micrograms, and shall be
17 calculated using the following formula: micrograms of lead or cadmium per gram of product,
18 multiplied by grams of product per serving of the product (using the largest serving size
19 appearing on the product label), multiplied by the servings of the product per day (using the
20 largest number of servings in a recommended dosage appearing on the product label), which
21 equals micrograms of lead or cadmium exposure per day.

22 **3.1.3** For purposes of Section 3, the term "no more than 0.5 micrograms of
23 lead per day" means that there is not more than 0.5 micrograms of lead when calculated using
24 the formula in Section 3.1.2 after subtracting the amount of lead deemed to be "naturally
25 occurring" for purposes of this Consent Judgment only for the ingredient cocoa powder as
26 listed in Table 3 below. The amount of lead deemed "naturally occurring" listed in Table 3 is in
27 micrograms of "naturally occurring" lead per gram of the ingredient that is contained in the
28 Covered Product.

5 3.1.4. If Living Ecology uses Table 3 to calculate the amount of naturally
6 occurring lead in a Covered Product, then Living Ecology must submit to ERC, prior to the
7 Compliance Date, a complete list showing all the ingredients in that Covered Product including
8 the ingredients from Table 3, that are being used in the Covered Product as well as the
9 percentage and the amount in grams of each ingredient contained in the Covered Product.
10 Living Ecology may update this list from time to time and will be entitled to submit this
11 information to ERC confidentially.

12 **3.2 Clear and Reasonable Warnings**

13 If Living Ecology is required to provide a warning pursuant to Section 3.1, the following
14 warning must be utilized:

15 **WARNING: This product contains [a] chemical[s] known to the State of California to**
16 **cause [cancer and] birth defects or other reproductive harm.**

17 Living Ecology shall use the phrase "cancer and" in the warning only if the maximum daily dose
18 recommended on the label contains more than 15 micrograms of lead. The term "a chemical" shall
19 be used when Living Ecology has identified one Proposition 65 chemical in the Covered Product
20 while the phrase "chemicals" shall be utilized when more than one Proposition 65 chemical has
21 been identified by Living Ecology in the Covered Product.

22 The warning shall be securely affixed to or printed upon the container or label of each
23 Covered Product. The warning shall be at least the same size as the largest of any other health
24 or safety warnings also appearing on its website or on the label or container of Living
25 Ecology's product packaging and the word "WARNING" shall be in all capital letters and in
26 bold print. No other statements about Proposition 65 or lead or cadmium may be contained in
27 the Warning.

28 Living Ecology must display the above warnings with such conspicuousness, as compared

1 with other words, statements, or design of the label or container, as applicable, to render the
2 warning likely to be read and understood by an ordinary individual under customary conditions of
3 purchase or use of the product.

4 **4. SETTLEMENT PAYMENT**

5 4.1 In full satisfaction of all potential civil penalties, payment in lieu of civil
6 penalties, attorney's fees, and costs claimable in the Actions, Living Ecology shall make a total
7 of \$225,000.00 ("Total Settlement Amount") in settlement payments to ERC on the following
8 schedule: An initial payment of \$37,500.00 shall be made to ERC within five (5) days of the
9 Effective Date, followed by five (5) consecutive monthly payments in the amount of
10 \$37,500.00 due and owing no later than the 15th of each month after the month the first
11 payment is made. Living Ecology shall make these payments by wire transfer to ERC's escrow
12 account, for which ERC will give Living Ecology the necessary account information. The
13 Total Settlement Amount shall be apportioned as follows:

14 4.2 \$81,688.00 shall be considered a civil penalty pursuant to California Health and
15 Safety Code §25249.7(b)(1). ERC shall remit 75% (\$61,266.00) of the civil penalty to the
16 Office of Environmental Health Hazard Assessment ("OEHHA") for deposit in the Safe
17 Drinking Water and Toxic Enforcement Fund in accordance with California Health and Safety
18 Code §25249.12(c). ERC will retain the remaining 25% (\$20,422.00) of the civil penalty.

19 4.3 \$11,737.45 shall be distributed to ERC as reimbursement to ERC for reasonable
20 costs incurred in bringing this action.

21 4.4 \$61,538.80 shall be distributed to ERC in lieu of further civil penalties, for the
22 day-to-day business activities such as (1) continued enforcement of Proposition 65, which
23 includes work, analyzing, researching and testing consumer products that may contain
24 Proposition 65 chemicals, focusing on the same or similar type of ingestible products that are
25 the subject matter of the current action; (2) the continued monitoring of past consent judgments
26 and settlements to ensure companies are in compliance with Proposition 65; and (3) giving a
27 donation of \$3,075.00 to the Global Community Monitor to address reducing toxic chemical
28 exposures in California.

1 4.5 \$44,555.00 shall be distributed to William F. Wraith as reimbursement of ERC's
2 attorney's fees, while \$25,480.75 shall be distributed to ERC for its in-house legal fees.

3 4.6 In the event that Living Ecology fails to pay the Total Settlement Amount on or
4 before the date that it is due and owing pursuant to section 4.1 above, then ERC will provide
5 Defendant with ten days' written notice of default. If the Settling Defendant fails to cure the
6 default within ten days, then at the option of ERC, all unpaid balances due pursuant to section 4
7 shall be accelerated, and shall become immediately due and payable, with interest thereon as
8 specified in section 685.010 of the Code of Civil Procedure, commencing to accrue on the
9 entire remaining unpaid balance as of the first day after the ten-day notice has expired.
10 California Code of Civil Procedure section 1013, and the extensions provided therein, shall not
11 apply to nor extend any deadline referred to in this paragraph. If ERC waives the optional
12 acceleration as to any one or more default(s) in payment, the waiver or waivers shall not
13 constitute a waiver of this option in the event of any other default.

14 **5. MODIFICATION OF CONSENT JUDGMENT**

15 5.1 This Consent Judgment may be modified only (i) by written stipulation of the
16 Parties or pursuant to Section 5.4 and (ii) upon entry by the Court of a modified consent
17 judgment.

18 5.2 If Living Ecology seeks to modify this Consent Judgment under Section 5.1,
19 then Living Ecology must provide written notice to ERC of its intent ("Notice of Intent"). If
20 ERC seeks to meet and confer regarding the proposed modification in the Notice of Intent, then
21 ERC must provide written notice to Living Ecology within thirty days of receiving the Notice
22 of Intent. If ERC notifies Living Ecology in a timely manner of ERC's intent to meet and
23 confer, then the Parties shall meet and confer in good faith as required in this Section. The
24 Parties shall meet in person or via telephone within thirty (30) days of ERC's notification of its
25 intent to meet and confer. Within thirty days of such meeting, if ERC disputes the proposed
26 modification, ERC shall provide to Living Ecology a written basis for its position. The Parties
27 shall continue to meet and confer for an additional thirty (30) days in an effort to resolve any
28

1 remaining disputes. Should it become necessary, the Parties may agree in writing to different
2 deadlines for the meet-and-confer period.

3 **5.3** In the event that Living Ecology initiates or otherwise requests a modification
4 under Section 5.1, and the meet and confer process leads to a joint motion or application of the
5 Consent Judgment, Living Ecology shall reimburse ERC its costs and reasonable attorney's
6 fees for the time spent in the meet-and-confer process and filing and arguing the motion or
7 application.

8 **5.4** Where the meet-and-confer process does not lead to a joint motion or
9 application in support of a modification of the Consent Judgment, then either Party may seek
10 judicial relief on its own. In such a situation, the prevailing Party may seek to recover costs
11 and reasonable attorney's fees. As used in the preceding sentence, the term "prevailing party"
12 means a party who is successful in obtaining relief more favorable to it than the relief that the
13 other party was amenable to providing during the Parties' good faith attempt to resolve the
14 dispute that is the subject of the modification.

15 **6. RETENTION OF JURISDICTION, ENFORCEMENT OF CONSENT**
16 **JUDGMENT**

17 This Court shall retain jurisdiction of this matter pursuant to California Code of Civil
18 Procedure 664.6 to enforce, modify, or terminate this Consent Judgment.

19 **7. APPLICATION OF CONSENT JUDGMENT**

20 This Consent Judgment may apply to, be binding upon, and benefit the Parties and their
21 respective officers, directors, shareholders, employees, agents, parent companies, subsidiaries,
22 divisions, affiliates, franchisees, licensees, customers (including Private Labelers), distributors,
23 wholesalers, retailers, predecessors, successors, and assigns. For purposes of this Consent
24 Judgment, the term Private Labelers means a retailer that either (a) purchases any Living
25 Ecology bar, which is an identical formulation as one of the Covered Product bars, to sell under
26 the name of the retailer, or (b) purchases, on or before the Compliance Date, any Living Ecology
27 product that is not a bar, which is an identical formulation as a Covered Product, to sell under the
28

1 name of the retailer. This Consent Judgment shall have no application to Covered Products
2 which are distributed or sold exclusively outside the State of California.

3 **8. BINDING EFFECT, CLAIMS COVERED AND RELEASED**

4 **8.1** This Consent Judgment is a full, final, and binding resolution between ERC, on
5 behalf of itself and in the public interest, and Living Ecology, of any alleged violation of
6 Proposition 65 or its implementing regulations for failure to provide Proposition 65 warnings of
7 exposure to lead, and/or cadmium, from the handling, use, or consumption of the Covered
8 Products and fully resolves all claims that have been or could have been asserted in these Actions
9 up to and including the Effective Date for failure to provide Proposition 65 warnings for the
10 Covered Products. For purposes of this Section 8, Covered Products includes the products sold
11 by Private Labelers as defined in Section 7. ERC, on behalf of itself and in the public interest,
12 hereby discharges Living Ecology and its respective officers, directors, shareholders, employees,
13 agents, parent companies, subsidiaries, divisions, affiliates, suppliers, franchisees, licensees,
14 customers (including Private Labelers) and their respective distributors, wholesalers, retailers,
15 and all other upstream and downstream entities in the distribution chain of any Covered Product,
16 and the predecessors, successors and assigns of any of them (collectively, "Released Parties"),
17 from any and all claims, actions, causes of action, suits, demands, liabilities, damages, penalties,
18 fees, costs and expenses asserted, or that could have been asserted, as to any alleged violation of
19 Proposition 65 arising from the failure to provide Proposition 65 warnings on the Covered
20 Products regarding lead and/or cadmium, as these chemicals are alleged regarding the Covered
21 Products in the Covered Products as set forth in the Notices and the Complaint up through and
22 including the Compliance Date. Living Ecology warrants that as of the date Living Ecology
23 executes this Consent Judgment: (a) no public enforcer is diligently prosecuting an action related
24 to chemicals in the Covered Products from any of its Private Labelers; and (b) no Private Labeler
25 has either received a pending 60-Day Notice of Violation of Proposition 65 regarding lead and/or
26 cadmium in the Covered Products or is currently in litigation, or been threatened with litigation,
27 as to lead and/or cadmium in the Covered Products. The release provided herein in favor of
28 Private Labelers shall not apply to any existing or pending 60-day Notices of Violations,

1 litigation, or actions against any of the Private Labelers by any public or private enforcer
2 regarding lead and/or cadmium in the Covered Products.

3 8.2 ERC on its own behalf only, on one hand, and Living Ecology on its own behalf
4 only, on the other, further waive and release any and all claims they may have against each
5 other for all actions or statements made or undertaken in the course of seeking or opposing
6 enforcement of Proposition 65 in connection with the Notices or Complaint up through and
7 including the Effective Date, provided, however, that nothing in Section 8 shall affect or limit
8 any Party's right to seek to enforce the terms of this Consent Judgment.

9 8.3 It is possible that other claims not known to the Parties arising out of the facts alleged in the
10 Notices, the Actions or the Complaint and relating to the Covered Products will develop or be
11 discovered. ERC on behalf of itself only, on one hand, and Living Ecology, on the other hand,
12 acknowledge that this Consent Judgment is expressly intended to cover and include all such
13 claims up through the Effective Date, including all rights of action therefore. ERC and Living
14 Ecology acknowledge that the claims released in Sections 8.1 and 8.2 above may include
15 unknown claims, and nevertheless waive California Civil Code section 1542 as to any such
16 unknown claims. California Civil Code section 1542 reads as follows:

17
18 A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE
19 CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER
20 FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF
21 KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS
22 OR HER SETTLEMENT WITH THE DEBTOR.

22 ERC on behalf of itself only, on the one hand, and Living Ecology, on the other hand,
23 acknowledge and understand the significance and consequences of this specific waiver of
24 California Civil Code section 1542.

25 8.4 Compliance with the terms of this Consent Judgment shall be deemed to constitute
26 compliance with Proposition 65 by any releasee regarding alleged exposures to lead and/or
27 cadmium, in the Covered Products as set forth in the Notices and the Complaint.

1 8.5 Nothing in this Consent Judgment is intended to apply to any occupational or
2 environmental exposures arising under Proposition 65, nor shall it apply to any of Living
3 Ecology's products other than the Covered Products.

4 **9. SEVERABILITY OF UNENFORCEABLE PROVISIONS**

5 In the event that any of the provisions of this Consent Judgment are held by a court to be
6 unenforceable, the validity of the remaining enforceable provisions shall not be adversely affected.

7 **10. GOVERNING LAW**

8 The terms and conditions of this Consent Judgment shall be governed by and construed in
9 accordance with the laws of the State of California.

10 **11. PROVISION OF NOTICE**

11 All notices required to be given to either Party to this Consent Judgment by the other shall
12 be in writing and sent to the following agents listed below by: (a) first-class, registered, or certified
13 mail; (b) overnight courier; or (c) personal delivery. Courtesy copies via email may also be sent.

Dear Alleged Violators and the Appropriate Public Enforcement Agencies:

I represent Environmental Research Center ("ERC"), 3111 Camino Del Rio North, Suite 400, San Diego, CA 92108; Tel. (619) 500-3090. ERC's Executive Director is Chris Heptinstall. ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California's Safe Drinking Water and Toxic Enforcement Act of 1986 ("Proposition 65"), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the products identified below. These violations have occurred and continue to occur because the alleged Violators identified below failed to provide required clear and reasonable warnings with these products. This letter serves as a notice of these violations to the alleged Violators and the appropriate public enforcement agencies. Pursuant to Section 25249.7(d) of the statute, ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

Cadmium was officially listed as a chemical known to cause developmental toxicity and male reproductive toxicity on May 1, 1997 while Cadmium and Cadmium Compounds were listed as chemicals known to the State of California to cause cancer on October 1, 1987.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.


Route of Exposure. The consumer exposures that are the subject of this notice result from the purchase, acquisition, handling and recommended use of these products. Consequently, the primary route of exposure to this chemical has been and continues to be through ingestion, but may have also occurred and may continue to occur through inhalation and/or dermal contact.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least April 10, 2012, as well as every day since the products were introduced into the California marketplace, and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until this known toxic chemical is either removed from or reduced to allowable levels in the products. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemical. The method of warning should be a warning that appears on the product label. The Violators violated Proposition 65 because they failed to provide persons handling and/or using these products with appropriate warnings that they are being exposed to this chemical.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violators to: (1) reformulate the identified products so as to eliminate further exposures to the identified chemical, or provide appropriate warnings on the labels of these products; (2) pay an appropriate civil penalty; and (3) provide clear and reasonable warnings compliant with Proposition 65 to all persons located in California who purchased the above products in the last three years. Such a resolution will prevent further unwarned consumer exposures to the identified chemical, as well as an expensive and time consuming litigation.


