

1. INTRODUCTION

2 1.1 The parties to this Consent Judgment ("Parties") are Shefa LMV, LLC ("Shefa")
3 and Orlane, Inc. ("Settling Defendant"). Shefa and Settling Defendant are referred to collectively as the "Parties."

5 1.2 The Settling Defendant manufactures, distributes, and/or sells types of products
6 identified on Exhibit A that contain Cocamide diethanolamine ("Cocamide DEA") in the State of
7 California or has done so in the past.

8 1.3 On the date identified on Exhibit A, Shefa served a 60-Day Notice of Violation
9 under Proposition 65 (The Safe Drinking Water and Toxic Enforcement Act of 1986, California
10 Health & Safety Code §§ 25249.5, et seq.) ("Notice") to Settling Defendant, the California
11 Attorney General, the District Attorneys of every County in the State of California, and the City
12 Attorneys for every City in the State of California with a population greater than 750,000.

1

1.4 The Notice alleges violations of Proposition 65 with respect to the presence of Cocamide DEA in the types of products identified in Exhibit A.

15 1.5 On the date(s) identified on Exhibit A, Shefa filed the Complaint applicable to the
16 Settling Defendant ("Complaint") for the Proposition 65 Action identified in Exhibit A.

17 1.6 For purposes of this Consent Judgment only, the Parties stipulate that: (i) this
18 Court has jurisdiction over the allegations of violations contained in the operative Complaint
19 applicable to Settling Defendant and personal jurisdiction over Settling Defendant as to the acts
20 alleged in the Complaint; (ii) venue is proper in the County of Alameda; and (iii) this Court has
21 jurisdiction to enter this Consent Judgment.

1.7 Nothing in this Consent Judgment is or shall be construed as an admission by the
Parties of any fact, conclusion of law, issue of law, or violation of law, nor shall compliance with
the Consent Judgment constitute or be construed as an admission by the Parties of any fact,
conclusion of law, issue of law, or violation of law.

26 1.8 Nothing in this Consent Judgment shall prejudice, waive, or impair any right,
27 remedy, argument, or defense the Parties may have in any other legal proceeding.

1.9 This Consent Judgment is the product of negotiation and compromise and is
 2 accepted by the Parties solely for purposes of settling, compromising, and resolving issues
 3 disputed in this action.

4

2. DEFINITIONS

5 2.1 "Covered Products" means the types of products identified on the Exhibit A for
6 each Settling Defendant.

7 2.2 "Effective Date" means the date on which this Consent Judgment is entered by
8 the Court.

9

3. INJUNCTIVE RELIEF

3.1 Reformulation of Covered Products. As of the Effective Date, Settling
Defendant shall not manufacture, distribute, sell, or offer for sale any Covered Product that
contains Cocamide DEA and that will be sold or offered for sale to California consumers. For
purposes of this Consent Judgment, a product "contains Cocamide DEA" if Cocamide DEA is an
intentionally added ingredient in the product and/or intentionally added part of the product
formulation.

3.2 Specification to Suppliers. No more than thirty (30) days after the Effective
Date, Settling Defendant shall issue specifications to its supplier(s) of Covered Products
requiring that Covered Products do not contain any Cocamide DEA, and shall instruct each
supplier to use reasonable efforts to eliminate Covered Products containing Cocamide DEA on a
nationwide basis.

3.3 Action Regarding Specific Products. On or before the Effective Date, Settling
Defendant shall cease selling the specific products (if any) identified as Section 3.3 Products on
the Exhibit A for such Settling Defendant ("Section 3.3 Products") in California unless such
products have been reformulated such that they do not contain Cocamide DEA.

3.4 On or before the Effective Date, Settling Defendant shall also: (i) cease shipping
the Section 3.3 Products to any of its California stores and/or California customers that resell the
Section 3.3 Products in California; and (ii) send instructions to its California stores and/or

California customers that resell the Section 3.3 Products in California instructing them either to:
 (a) return all the Section 3.3 Products to Settling Defendant for destruction, or (b) directly
 destroy the Section 3.3 Products.

4 3.5 The requirements of this Section apply only to those Section 3.3 Products that
5 contain Cocamide DEA.

6 3.6 Any destruction of Section 3.3 Products shall be in compliance with all applicable
7 laws.

8

4. ENFORCEMENT

9 4.1 Shefa may, by motion or application for an order to show cause before the
10 Superior Court of Alameda County, enforce the terms and conditions contained in this Consent
11 Judgment.

4.2 Prior to bringing any motion or application to enforce the requirements of Section
3 above, Shefa shall provide Settling Defendant with a Notice of Violation and proof of purchase
and a copy of any test results which purportedly support the Notice of Violation.

15 4.3 The Parties shall then meet and confer regarding the basis for the anticipated
16 motion or application in an attempt to resolve it informally, including providing Settling
17 Defendant(s) with a reasonable opportunity of at least thirty (30) days to cure any alleged
18 violation.

4.4 Should such attempts at informal resolution fail, Shefa may file an enforcement
motion or application.

4.5 This Consent Judgment may only be enforced by the Parties.

5. PAYMENTS

5.1 Within ten (10) business days of the Effective Date, Settling Defendant shall pay
the settlement payment identified for it on Exhibit A.

5.2 The total settlement amount for Settling Defendant shall be paid pursuant to the
instructions outlined in Exhibit A.

5.3 The funds paid by Settling Defendant shall be allocated, as identified in ExhibitA, between the following categories:

5.4 Civil Penalty. A civil penalty pursuant to Health & Safety Code § 25249.7(b),
with such money to be apportioned by Shefa as identified on the Exhibit A for the Settling
Defendant in accordance with Health & Safety Code § 25249.12 (25% to Shefa and 75% to the
State of California's Office of Environmental Health Hazard Assessment).

5.5 Attorney's Fees and Costs. A reimbursement of a portion of Shefa's reasonable attorney's fees and costs.

6. MODIFICATION

10 6.1 Written Consent. This Consent Judgment may be modified from time to time by
11 express written agreement of the Parties with the approval of the Court, or by an order of this
12 Court upon motion and in accordance with law.

6.2 Meet and Confer. Any Party seeking to modify this Consent Judgment shall attempt in good faith to meet and confer with all affected Parties prior to filing a motion to modify the Consent Judgment.

CLAIMS COVERED AND RELEASED

This Consent Judgment is a full, final, and binding resolution between (i) Shefa 7.1 17 on behalf of itself and the public interest; and (ii) Settling Defendant and its affiliates, its former 18 affiliates ("affiliate" means a person or entity who directly or indirectly owns or controls, is 19 owned or controlled by, or is under common ownership or control with, Settling Defendant), and 20 their current and past directors, officers, employees and attorneys ("Defendant Releasees"), and 21 each entity to whom any of them directly or indirectly distribute or sell Covered Products, 22 including but not limited to distributors, wholesalers, contractors, customers, retailers, 23 franchisees, cooperative members, licensors, and licensees ("Downstream Defendant 24 Releasees"); of any violation of Proposition 65 that was or could have been asserted in the 25 Complaint against Settling Defendant, Defendant Releasees, and Downstream Defendant 26 27

Releasees, based on failure to warn about alleged exposure to Cocamide DEA contained in Covered Products that were sold by Settling Defendant prior to the Effective Date.

7.2 Compliance with the terms of this Consent Judgment by Settling Defendant and
Defendant Releasees shall constitute compliance with Proposition 65 by Settling Defendant,
Defendant Releasees, and Downstream Defendant Releasees with respect to any alleged failure
to warn about Cocamide DEA in Covered Products manufactured, distributed, or sold by Settling
Defendants after the Effective Date.

8 7.3 Shefa, acting on its behalf and in the public interest, releases and discharges
9 Settling Defendant, Defendant Releasees, and Downstream Defendant Releasees from any and
10 all claims, actions, causes of action, suits, demands, liabilities, damages, penalties, fees, costs
11 and expenses asserted, or that could have been asserted, as to any alleged violation of
12 Proposition 65 arising from the alleged failure to warn about alleged exposure to Cocamide DEA
13 in the Covered Products.

Shefa, acting on its behalf only, releases and discharges Settling Defendant, 7.4 14 Defendant Releasees, and Downstream Defendant Releasees from any and all known and 15 unknown claims for alleged violations of Proposition 65 or for any other statutory or common 16 law claims, arising from or relating to alleged exposures to Cocamide DEA in the Covered 17 Products. It is possible that other claims not known to the parties arising out of the facts alleged 18 in the Notice or the Complaint and relating to the Covered Products will develop or be 19 discovered. Shefa, on behalf of itself only, acknowledges that this Consent Judgment is 20 expressly intended to cover and include all such claims including all rights of action thereof. 21 Shefa has full knowledge of the contents of California Civil Code section 1542. Shefa, on behalf 22 itself only, acknowledges that the claims released above may include unknown claims, and 23 nevertheless waives California Civil Code section 1542 as to any such unknown claims. 24 California Civil Code section 1542 reads as follows: 25

> A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM OR

10. ATTORNEYS' FEES

10.1 Should Shefa prevail on any motion, application for an order to show cause, or other proceeding to enforce a violation of this Consent Judgment, Shefa shall be entitled to its reasonable attorneys' fees and costs incurred as a result of such motion or application.

10.2 Should Settling Defendant prevail on any motion application for an order to show cause or other proceeding, that Settling Defendant may be awarded its reasonable attorneys' fees and costs against Shefa as a result of such motion or application upon a finding by the Court that Shefa's prosecution of the motion or application lacked substantial justification.

9 10.3 For purposes of this Consent Judgment, the term substantial justification shall
10 carry the same meaning as used in the Civil Discovery Act of 1986, Code of Civil Procedure §§
11 2016, et seq.

12 10.4 Except as otherwise provided in this Consent Judgment, each Party shall bear its
13 own attorneys' fees and costs.

11. OTHER TERMS

15 11.1 The terms of this Consent Judgment shall be governed by the laws of the State of16 California.

17 11.2 This Consent Judgment shall apply to and be binding upon Shefa, Settling
18 Defendant, its affiliates, and successors or assigns of any of them.

19 11.3 This Consent Judgment contains the sole and entire agreement and understanding
20 of the Parties with respect to the entire subject matter hereof, and any and all prior discussions,
21 negotiations, commitments, or understandings related thereto, if any, are hereby merged herein
22 and therein.

23 11.4 There are no warranties, representations, or other agreements between the Parties
24 except as expressly set forth herein.

25 11.5 No representations, oral or otherwise, express or implied, other than those
26 specifically referred to in this Consent Judgment have been made by any Party hereto.

11.6 No other agreements not specifically contained or referenced herein, oral or otherwise, shall be deemed to exist or to bind any of the Parties hereto.

3 11.7 No supplementation, modification, waiver, or termination of this Consent
4 Judgment shall be binding unless executed in writing by the Party to be bound thereby.

11.8 No waiver of any of the provisions of this Consent Judgment shall be deemed or shall constitute a waiver of any of the other provisions hereof whether or not similar, nor shall such waiver constitute a continuing waiver.

8 11.9 Nothing in this Consent Judgment shall release, or in any way affect any rights
9 Settling Defendant might have against any other party, whether or not that party is a Settling
10 Defendant.

11 11.10 This Court shall retain jurisdiction of this matter to implement or modify the
12 Consent Judgment.

13 11.11 The stipulations to this Consent Judgment may be executed in counterparts and
14 by means of facsimile or portable document format (pdf), which taken together shall be deemed
15 to constitute one document.

16 11.12 Each signatory to this Consent Judgment certifies that he or she is fully
17 authorized by the Party he or she represents to stipulate to this Consent Judgment and to enter
18 into and execute the Consent Judgment on behalf of the Party represented and legally to bind
19 that Party.

20 11.13 The Parties, including their counsel, have participated in the preparation of this
21 Consent Judgment and this Consent Judgment is the result of the joint efforts of the Parties.

11.14 This Consent Judgment was subject to revision and modification by the Parties
and has been accepted and approved as to its final form by all Parties and their counsel.

11.15 Accordingly, any uncertainty or ambiguity existing in this Consent Judgment
shall not be interpreted against any Party as a result of the manner of the preparation of this
Consent Judgment.
