1. INTRODUCTION

1.1 On July 5, 2017, Plaintiff Environmental Research Center, Inc. ("ERC"), a non-profit corporation, as a private enforcer and in the public interest, will initiate this action by filing a Complaint for Injunctive and Declaratory Relief and Civil Penalties (the "Complaint") pursuant

1 to the provisions of California Health and Safety Code section 25249.5 *et seq.* (“Proposition
2 65”), against Chaban Wellness LLC, individually and doing business as Yes You Can! (“Chaban
3 Wellness”) and Does 1-100. In this action, ERC alleges that a number of products
4 manufactured, distributed, or sold by Chaban Wellness contain lead, a chemical listed under
5 Proposition 65 as a carcinogen and reproductive toxin, and expose consumers to this chemical at
6 a level requiring a Proposition 65 warning. These products (referred to hereinafter individually
7 as a “Covered Product” or collectively as “Covered Products”) are: (1) YesYouCan! Diet Plan
8 Transform Kit Food Lover (Vanilla) which includes the following products: a. YesYouCan! Diet
9 Plan Protein Shake Snack Vanilla, b. YesYouCan! Diet Plan Appetite Suppressant, c.
10 YesYouCan! Diet Plan Fat Burner, d. YesYouCan! Diet Plan Collagen, and e. YesYouCan! Diet
11 Plan Colon Cleanser; (2) YesYouCan! Diet Plan Transform Kit Food Lover (Choco Brownie)
12 which includes the following products: a. YesYouCan! Diet Plan Protein Shake Snack Choco
13 Brownie, b. YesYouCan! Diet Plan Appetite Suppressant, c. YesYouCan! Diet Plan Fat Burner,
14 d. YesYouCan! Diet Plan Collagen, and e. YesYouCan! Diet Plan Colon Cleanser; (3)
15 YesYouCan! Diet Plan Protein Shake Snack Vanilla; and (4) YesYouCan! Diet Plan Protein
16 Shake Snack Choco Brownie. Chaban Wellnes denies these allegations of ERC.

17 1.2 ERC and Chaban Wellness are hereinafter referred to individually as a “Party”
18 or collectively as the “Parties.”

19 1.3 ERC is a 501 (c)(3) California non-profit corporation dedicated to, among other
20 causes, helping safeguard the public from health hazards by reducing the use and misuse of
21 hazardous and toxic chemicals, facilitating a safe environment for consumers and employees,
22 and encouraging corporate responsibility.

23 1.4 For purposes of this Consent Judgment, the Parties agree that Chaban Wellness is a
24 business entity that has employed ten or more persons at all times relevant to this action, and
25 qualifies as a “person in the course of business” within the meaning of Proposition 65. Chaban
26 Wellness manufactures, distributes, and/or sells the Covered Products.

27 1.5 The Complaint is based on allegations contained in ERC’s Notice of Violation
28 dated March 24, 2017 that was served on the California Attorney General, other public

1 enforcers, and Chaban Wellness ("Notice"). A true and correct copy of the 60-Day Notice
2 dated March 24, 2017 is attached hereto as **Exhibit A** and incorporated herein by reference.
3 More than 60 days have passed since the Notice was served on the Attorney General, public
4 enforcers, and Chaban Wellness and no designated governmental entity has filed a complaint
5 against Chaban Wellness with regard to the Covered Products or the alleged violations.

6 **1.6** ERC's Notice and Complaint allege that use of the Covered Products exposes
7 persons in California to lead without first providing clear and reasonable warnings in violation
8 of California Health and Safety Code section 25249.6. Chaban Wellness denies all allegations
9 contained in the Notice and Complaint.

10 **1.7** The Parties have entered into this Consent Judgment in order to settle,
11 compromise, and resolve disputed claims and thus avoid prolonged and costly litigation.
12 Nothing in this Consent Judgment nor compliance with this Consent Judgment shall constitute or
13 be construed as an admission by any of the Parties or by any of their respective officers,
14 directors, shareholders, employees, agents, parent companies, subsidiaries, divisions, franchisees,
15 licensees, customers, suppliers, distributors, wholesalers, or retailers of any fact, issue of law, or
16 violation of law.

17 **1.8** Except as expressly set forth herein, nothing in this Consent Judgment shall
18 prejudice, waive, or impair any right, remedy, argument, or defense the Parties may have in any
19 current or future legal proceeding unrelated to these proceedings.

20 **1.9** The Effective Date of this Consent Judgment is the date on which it is entered as
21 a Judgment by this Court.

22 **2. JURISDICTION AND VENUE**

23 For purposes of this Consent Judgment and any further court action that may become
24 necessary to enforce this Consent Judgment, the Parties stipulate that this Court has subject matter
25 jurisdiction over the allegations of violations contained in the Complaint, personal jurisdiction
26 over Chaban Wellness as to the acts alleged in the Complaint, that venue is proper in Alameda
27 County, and that this Court has jurisdiction to enter this Consent Judgment as a full and final
28 resolution of all claims up through and including the Effective Date which were or could have

1 been asserted in this action based on the facts alleged in the Notice and Complaint.

2 **3. INJUNCTIVE RELIEF, REFORMULATION, TESTING AND WARNINGS**

3 **3.1** Beginning on the Effective Date, Chaban Wellness shall be permanently
4 enjoined from manufacturing for sale in the State of California, "Distributing into the State of
5 California", or directly selling in the State of California, any Covered Products which
6 individually expose a person to a "Daily Lead Exposure Level" of more than 0.5 micrograms of
7 lead per day unless it meets the warning requirements under Section 3.2.

8 **3.1.1** As used in this Consent Judgment, the term "Distributing into the State
9 of California" shall mean to directly ship a Covered Product into California for sale in
10 California or to sell a Covered Product to a distributor that Chaban Wellness knows or has
11 reason to know will sell the Covered Product in California.

12 **3.1.2** For purposes of this Consent Judgment, the "Daily Lead Exposure
13 Level" shall be measured in micrograms, and shall be calculated using the following formula:
14 micrograms of lead per gram of product, multiplied by grams of product per serving of the
15 product (using the largest serving size appearing on the product label), multiplied by servings
16 of the product per day (using the largest number of servings in a recommended dosage
17 appearing on the product label), which equals micrograms of lead exposure per day. If no
18 recommended daily serving size is provided on the label, then the daily serving size shall equal
19 one serving.

20 **3.2 Clear and Reasonable Warnings**

21 If Chaban Wellness is required to provide a warning pursuant to Section 3.1 prior to
22 August 30, 2018, the following warning must be utilized ("Warning"):

23 **WARNING:** This product contains a chemical known to the state of California to cause
24 [cancer and] birth defects or other reproductive harm.

25 If Chaban Wellness is required to provide a warning pursuant to Section 3.1 on or after
26 August 30, 2018, the following warning must be utilized ("Warning"):

27 **WARNING:** Consuming this product can expose you to chemicals including lead which is
28 [are] known to the State of California to cause [cancer and] birth defects or other
reproductive harm. For more information go to www.P65Warnings.ca.gov/food.

1 Chaban Wellness shall use the phrase "cancer and" in the Warning only if the "Daily Lead
2 Exposure Level" is greater than 15 micrograms of lead as determined pursuant to the quality
3 control methodology set forth in Section 3.4.

4 Chaban Wellness shall provide at least one of the following methods of transmission for
5 the Warning: 1) The warning shall be affixed to or printed upon the container or label of each
6 Covered Product; or 2) for any Covered Product sold over the internet, the Warning shall appear
7 on the checkout page when a California delivery address is indicated for any purchase of any
8 Covered Product, or (3) the Warning shall be placed on the front of the product invoice. For
9 internet or invoice warnings, an asterisk or other identifying method must be utilized to identify
10 which products on the checkout page are subject to the Warning.

11 The Warning shall be at least the same size as the largest of any other health or safety
12 warnings also appearing on its website or on the label or container of Chaban Wellness' product
13 packaging and the word "WARNING" shall be in all capital letters and in bold print. No
14 statements intended to or likely to have the effect of diminishing the impact of, or reducing the
15 clarity of, the Warning on the average lay person shall accompany the Warning. Further, no
16 statements may accompany the Warning that state or imply that the source of the listed chemical
17 has an impact on or results in a less harmful effect of the listed chemical.

18 Chaban Wellness must display the above Warning with such conspicuousness, as
19 compared with other words, statements, design of the label, container, or on its website, as
20 applicable, to render the Warning likely to be read and understood by an ordinary individual under
21 customary conditions of purchase or use of the product.

22 3.3 Reformulated Covered Products

23 A Reformulated Covered Product is one for which the "Daily Lead Exposure Level" is no
24 greater than 0.5 micrograms of lead per day as determined by the quality control methodology
25 described in Section 3.4.

26 3.4 Testing and Quality Control Methodology

27 3.4.1 Beginning within one year of the Effective Date, Chaban Wellness shall
28 arrange for lead testing of the Covered Products at least once a year for a minimum of three

1 consecutive years by arranging for testing of five randomly selected samples of each of the
2 Covered Products, in the form intended for sale to the end-user, which Chaban Wellness
3 intends to sell or is manufacturing for sale in California, directly selling to a consumer in
4 California or "Distributing into the State of California." If tests conducted pursuant to this
5 Section demonstrate that no Warning is required for a Covered Product during each of three
6 consecutive years, then the testing requirements of this Section will no longer be required as to
7 that Covered Product. However, if during or after the three-year testing period, Chaban
8 Wellness changes ingredient suppliers for any of the Covered Products and/or reformulates any
9 of the Covered Products, Chaban Wellness shall test that Covered Product annually for at least
10 three consecutive years after such change is made.

11 **3.4.2** For purposes of measuring the "Daily Lead Exposure Level," the
12 arithmetic mean lead detection result of the five (5) randomly selected samples of the Covered
13 Products will be controlling.

14 **3.4.3** All testing pursuant to this Consent Judgment shall be performed using a
15 laboratory method that complies with the performance and quality control factors appropriate
16 for the method used, including limit of detection, qualification, accuracy, and precision that
17 meets the following criteria: Inductively Coupled Plasma-Mass Spectrometry ("ICP-MS")
18 achieving a limit of quantification of less than or equal to 0.010 mg/kg or any other testing
19 method subsequently agreed to in writing by the Parties and approved by the Court through
20 entry of a modified consent judgment.

21 **3.4.4** All testing pursuant to this Consent Judgment shall be performed by an
22 independent third party laboratory certified by the California Environmental Laboratory
23 Accreditation Program or an independent third-party laboratory that is registered with the
24 United States Food & Drug Administration.

25 **3.4.5** Nothing in this Consent Judgment shall limit Chaban Wellness' ability to
26 conduct, or require that others conduct, additional testing of the Covered Products, including
27 the raw materials used in their manufacture.

1 **3.4.6** For the timeperiod identified in section 3.4.1 within which testing must
2 occur, within thirty (30) days of ERC's written request, Chaban Wellness shall deliver lab
3 reports obtained pursuant to Section 3.4 to ERC. Chaban Wellness shall retain all test results
4 and documentation for a period of five years from the date of each test.

5 **4: SETTLEMENT PAYMENT**

6 **4.1** In full satisfaction of all potential civil penalties, additional settlement payments,
7 attorney's fees, and costs, Chaban Wellness shall make a total payment of \$62,500.00 ("Total
8 Settlement Amount") according to the following payment schedule ("Due Dates):

- 9 • Payment 1 -- \$12,500.00 within 5 days of the Effective Date
- 10 • Payment 2 -- \$12,500.00 within 35 days of the Effective Date
- 11 • Payment 3 -- \$12,500.00 within 65 days of the Effective Date
- 12 • Payment 4 -- \$12,500.00 within 95 days of the Effective Date
- 13 • Payment 5 -- \$12,500.00 within 125 days of the Effective Date

14 Chaban Wellness shall make these payments by wire transfer to ERC's escrow account, for
15 which ERC will give Chaban Wellness the necessary account information. The Total
16 Settlement Amount shall be apportioned as follows:

17 **4.2** \$20,106.91 shall be considered a civil penalty pursuant to California Health and
18 Safety Code section 25249.7(b)(1). ERC shall remit 75% (\$15,080.18) of the civil penalty to
19 the Office of Environmental Health Hazard Assessment ("OEHHA") for deposit in the Safe
20 Drinking Water and Toxic Enforcement Fund in accordance with California Health and Safety
21 Code section 25249.12(c). ERC will retain the remaining 25% (\$5,026.73) of the civil penalty.

22 **4.3** \$3,203.59 shall be distributed to ERC as reimbursement to ERC for reasonable
23 costs incurred in bringing this action.

24 **4.4** \$15,080.16 shall be distributed to ERC as an Additional Settlement Payment
25 ("ASP"), pursuant to California Code of Regulations, title 11, sections 3203, subdivision (d) and
26 3204. ERC will utilize the ASP for activities that address the same public harm as allegedly
27 caused by Chaban Wellness in this matter. These activities are detailed below and support
28 ERC's overarching goal of reducing and/or eliminating hazardous and toxic chemicals in dietary

1 supplement products in California. ERC's activities have had, and will continue to have, a direct
2 and primary effect within the State of California because California consumers will be benefitted
3 by the reduction and/or elimination of exposure to lead in dietary supplements and/or by
4 providing clear and reasonable warnings to California consumers prior to ingestion of the
5 products.

6 Based on a review of past years' actual budgets, ERC is providing the following list of
7 activities ERC engages in to protect California consumers through Proposition 65 citizen
8 enforcement, along with a breakdown of how ASP funds will be utilized to facilitate those
9 activities: (1) ENFORCEMENT (65-80%): obtaining, shipping, analyzing, and testing dietary
10 supplement products that may contain lead and are sold to California consumers. This work
11 includes continued monitoring and enforcement of past consent judgments and settlements to
12 ensure companies are in compliance with their obligations thereunder, with a specific focus on
13 those judgments and settlements concerning lead. This work also includes investigation of new
14 companies that ERC does not obtain any recovery through settlement or judgment; (2)
15 VOLUNTARY COMPLIANCE PROGRAM (10-20%): maintaining ERC's Voluntary
16 Compliance Program by acquiring products from companies, developing and maintaining a case
17 file, testing products from these companies, providing the test results and supporting
18 documentation to the companies, and offering guidance in warning or implementing a self-
19 testing program for lead in dietary supplement products; and (3) "GOT LEAD" PROGRAM (up
20 to 5%): maintaining ERC's "Got Lead?" Program which reduces the numbers of contaminated
21 products that reach California consumers by providing access to free testing for lead in dietary
22 supplement products (Products submitted to the program are screened for ingredients which are
23 suspected to be contaminated, and then may be purchased by ERC, catalogued, sent to a
24 qualified laboratory for testing, and the results shared with the consumer that submitted the
25 product).

26 ERC shall be fully accountable in that it will maintain adequate records to document and
27 will be able to demonstrate how the ASP funds will be spent and can assure that the funds are
28 being spent only for the proper, designated purposes described in this Consent Judgment. ERC

1 shall provide the Attorney General, within thirty days of any request, copies of documentation
2 demonstrating how such funds have been spent.

3 4.5 \$10,940.00 shall be distributed to Michael Freund as reimbursement of ERC's
4 attorney's fees, while \$13,169.34 shall be distributed to ERC for its in-house legal fees. Except
5 as explicitly provided herein, each Party shall bear its own fees and costs.

6 4.6 In the event that Chaban Wellness fails to remit any of the payments set forth in
7 Section 4.1 on or before their respective Due Dates, Chaban Wellness shall be deemed to be in
8 material breach of its obligations under this Consent Judgment. ERC shall provide written
9 notice of the delinquency to Chaban Wellness via electronic mail. If Chaban Wellness fails to
10 deliver the delinquent payment within five (5) days from the written notice, the Total Settlement
11 Amount shall become immediately due and owing and accrue interest at the statutory judgment
12 interest rate provided in the California Code of Civil Procedure section 685.010. Additionally,
13 Chaban Wellness agrees to pay ERC's reasonable attorney's fees and costs for any efforts to
14 collect the payment due under this Consent Judgment.

15 5. MODIFICATION OF CONSENT JUDGMENT

16 5.1 This Consent Judgment may be modified only as to injunctive terms (i) by
17 written stipulation of the Parties or pursuant to Section 5.4 and (ii) upon entry by the Court of a
18 modified consent judgment.

19 5.2 If Chaban Wellness seeks to modify this Consent Judgment under Section 5.1,
20 then Chaban Wellness must provide written notice to ERC of its intent ("Notice of Intent"). If
21 ERC seeks to meet and confer regarding the proposed modification in the Notice of Intent, then
22 ERC must provide written notice to Chaban Wellness within thirty (30) days of receiving the
23 Notice of Intent. If ERC notifies Chaban Wellness in a timely manner of ERC's intent to meet
24 and confer, then the Parties shall meet and confer in good faith as required in this Section. The
25 Parties shall meet in person or via telephone within thirty (30) days of ERC's notification of its
26 intent to meet and confer. Within thirty (30) days of such meeting, if ERC disputes the
27 proposed modification, ERC shall provide to Chaban Wellness a written basis for its position.
28 The Parties shall continue to meet and confer for an additional thirty (30) days in an effort to

1 resolve any remaining disputes. Should it become necessary, the Parties may agree in writing
2 to different deadlines for the meet-and-confer period.

3 **5.3** In the event that Chaban Wellness initiates or otherwise requests a modification
4 under Section 5.1, and the meet and confer process leads to a joint motion or application of the
5 Consent Judgment. Chaban Wellness shall reimburse ERC its costs and reasonable attorney's
6 fees for the time spent in the meet-and-confer process and filing and arguing the motion or
7 application.

8 **5.4** Where the meet-and-confer process does not lead to a joint motion or
9 application in support of a modification of the Consent Judgment, then either Party may seek
10 judicial relief on its own. In any such contested court proceeding, ERC may seek any
11 attorney's fees and costs incurred in opposing the motion pursuant to 1021.5.

12 **6. RETENTION OF JURISDICTION, ENFORCEMENT OF CONSENT**
13 **JUDGMENT**

14 **6.1** This Court shall retain jurisdiction of this matter to enforce, modify, or terminate
15 this Consent Judgment.

16 **6.2** If ERC alleges that any Covered Product fails to qualify as a Reformulated
17 Covered Product (for which ERC alleges that no Warning has been provided), then ERC shall
18 inform Chaban Wellness in a reasonably prompt manner of its test results, including
19 information sufficient to permit Chaban Wellness to identify the Covered Products at issue.
20 Chaban Wellness shall, within thirty (30) days following such notice, provide ERC with testing
21 information, from an independent third-party laboratory meeting the requirements of Sections
22 3.4.3 and 3.4.4, demonstrating Chaban Wellness' compliance with the Consent Judgment, if
23 warranted. The Parties shall first attempt to resolve the matter prior to ERC taking any further
24 legal action.

25 **7. APPLICATION OF CONSENT JUDGMENT**

26 This Consent Judgment may apply to, be binding upon, and benefit the Parties and their
27 respective officers, directors, shareholders, employees, agents, parent companies, subsidiaries,
28 divisions, franchisees, licensees, customers (excluding private labelers), distributors, wholesalers,

1 retailers, predecessors, successors, and assigns. This Consent Judgment shall have no
2 application to any Covered Product which is distributed or sold exclusively outside the State of
3 California and which is not used by California consumers.

4 **8. BINDING EFFECT, CLAIMS COVERED AND RELEASED**

5 **8.1** This Consent Judgment is a full, final, and binding resolution between
6 ERC, on behalf of itself and in the public interest, and Chaban Wellness and its respective
7 officers, directors, shareholders, employees, agents, parent companies, subsidiaries, divisions,
8 suppliers, franchisees, licensees, customers (not including private label customers of Chaban
9 Wellness), distributors, wholesalers, retailers, and all other upstream and downstream entities
10 in the distribution chain of any Covered Product, and the predecessors, successors, and assigns
11 of any of them (collectively, "Released Parties"). ERC hereby fully releases and discharges the
12 Released Parties from any and all claims, actions, causes of action, suits, demands, liabilities,
13 damages, penalties, fees, costs, and expenses asserted, or that could have been asserted from
14 the handling, use, or consumption of the Covered Products, as to any alleged violation of
15 Proposition 65 or its implementing regulations arising from the failure to provide Proposition
16 65 warnings on the Covered Products regarding lead up to and including the Effective Date.

17 **8.2** ERC on its own behalf only, and Chaban Wellness on its own behalf only,
18 further waive and release any and all claims they may have against each other for all actions or
19 statements made or undertaken in the course of seeking or opposing enforcement of Proposition
20 65 in connection with the Notice and Complaint up through and including the Effective Date,
21 provided, however, that nothing in Section 8 shall affect or limit any Party's right to seek to
22 enforce the terms of this Consent Judgment.

23 **8.3** It is possible that other claims not known to the Parties, arising out of the facts
24 alleged in the Notice and Complaint, and relating to the Covered Products, will develop or be
25 discovered. ERC on behalf of itself only, and Chaban Wellness on behalf of itself only,
26 acknowledge that this Consent Judgment is expressly intended to cover and include all such
27 claims up through and including the Effective Date, including all rights of action therefore.
28 ERC and Chaban Wellness acknowledge that the claims released in Sections 8.1 and 8.2 above

1 may include unknown claims, and nevertheless waive California Civil Code section 1542 as to
2 any such unknown claims. California Civil Code section 1542 reads as follows:

3 A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE
4 CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER
5 FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF
6 KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS
7 OR HER SETTLEMENT WITH THE DEBTOR.

8 ERC on behalf of itself only, and Chaban Wellness on behalf of itself only, acknowledge and
9 understand the significance and consequences of this specific waiver of California Civil Code
10 section 1542.

11 8.4 Compliance with the terms of this Consent Judgment shall be deemed to
12 constitute compliance with Proposition 65 by any releasee regarding alleged exposures to lead
13 in the Covered Products as set forth in the Notice and Complaint.

14 8.5 Nothing in this Consent Judgment is intended to apply to any occupational or
15 environmental exposures arising under Proposition 65, nor shall it apply to any of Chaban
16 Wellness' products other than the Covered Products.

17 9. SEVERABILITY OF UNENFORCEABLE PROVISIONS

18 In the event that any of the provisions of this Consent Judgment are held by a court to be
19 unenforceable, the validity of the remaining enforceable provisions shall not be adversely affected.

20 10. GOVERNING LAW

21 The terms and conditions of this Consent Judgment shall be governed by and construed in
22 accordance with the laws of the State of California.

23 11. PROVISION OF NOTICE

24 All notices required to be given to either Party to this Consent Judgment by the other shall
25 be in writing and sent to the following agents listed below via first-class mail. Courtesy copies via
26 email may also be sent.







**NOTICE OF VIOLATION OF
CALIFORNIA HEALTH & SAFETY CODE SECTION 25249.5 ET SEQ.
(PROPOSITION 65)**

Dear Alleged Violator and the Appropriate Public Enforcement Agencies:

I represent Environmental Research Center, Inc. ("ERC"), 3111 Camino Del Rio North, Suite 400, San Diego, CA 92108; Tel. (619) 500-3090. ERC's Executive Director is Chris Heptinstall. ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California's Safe Drinking Water and Toxic Enforcement Act of 1986 ("Proposition 65"), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the products identified below. These violations have occurred and continue to occur because the alleged Violator identified below failed to provide required clear and reasonable warnings with these products. This letter serves as a notice of these violations to the alleged Violator and the appropriate public enforcement agencies. Pursuant to Health and Safety Code Section 25249.7(d), ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

General Information about Proposition 65. A copy of a summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is enclosed with this letter served to the alleged Violator identified below.

Alleged Violator. The name of the company covered by this notice that violated Proposition 65 (hereinafter the "Violator") is:

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.

Route of Exposure. The consumer exposures that are the subject of this notice result from the recommended use of these products. Consequently, the route of exposure to this chemical has been and continues to be through ingestion.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least March 24, 2014, as well as every day since the products were introduced into the California marketplace, and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until this known toxic chemical is either removed from or reduced to allowable levels in the products. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemical. The method of warning should be a warning that appears on the product label. The Violator violated Proposition 65 because it failed to provide persons handling and/or using these products with appropriate warnings that they are being exposed to this chemical.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violator to: (1) reformulate the identified products so as to eliminate further exposures to the identified chemical, or provide appropriate warnings on the labels of these products; (2) pay an appropriate civil penalty; and (3) provide clear and reasonable warnings compliant with Proposition 65 to all persons located in California who purchased the above products in the last three years. Such a resolution will prevent further unwarned consumer exposures to the identified chemical, as well as an expensive and time consuming litigation.

ERC has retained me as legal counsel in connection with this matter. **Please direct all communications regarding this Notice of Violation to my attention at the law office address and telephone number indicated on the letterhead.**





(PROPOSITION 65): A SUMMARY

The following summary has been prepared by the California Office of Environmental Health Hazard Assessment (OEHHA), the lead agency for the implementation of the Safe Drinking Water and Toxic Enforcement Act of 1986 (commonly known as "Proposition 65"). A copy of this summary must be included as an attachment to any notice of violation served upon an alleged violator of the Act. The summary provides basic information about the provisions of the law, and is intended to serve only as a convenient source of general information. It is not intended to provide authoritative guidance on the meaning or application of the law. Please refer to the statute and OEHHA's implementing regulations (see citations below) for further information.

FOR INFORMATION CONCERNING THE BASIS FOR THE ALLEGATIONS IN THE NOTICE RELATED TO YOUR BUSINESS, CONTACT THE PERSON IDENTIFIED ON THE NOTICE.

The text of Proposition 65 (Health and Safety Code Sections 25249.5 through 25249.13) is available online at: <http://oehha.ca.gov/prop65/law/P65law72003.html>. Regulations that provide more specific guidance on compliance, and that specify procedures to be followed by the State in carrying out certain aspects of the law, are found in Title 27 of the California Code of Regulations, sections 25102 through 27001.¹ These implementing regulations are available online at: <http://oehha.ca.gov/prop65/law/P65Regs.html>.

WHAT DOES PROPOSITION 65 REQUIRE?

The "Proposition 65 List." Under Proposition 65, the lead agency (OEHHA) publishes a list of chemicals that are known to the State of California to cause cancer and/or reproductive toxicity. Chemicals are placed on the Proposition 65 list if they are known to cause cancer and/or birth defects or other reproductive harm, such as damage to female or male reproductive systems or to the developing fetus. This list must be updated at least once a year. The current Proposition 65 list of chemicals is available on the OEHHA website at:

http://www.oehha.ca.gov/prop65/prop65_list/Newlist.html.

Only those chemicals that are on the list are regulated under Proposition 65. Businesses that produce, use, release or otherwise engage in activities involving listed chemicals must comply with the following:

Clear and reasonable warnings. A business is required to warn a person before "knowingly and intentionally" exposing that person to a listed chemical unless an exemption applies. The warning given must be "clear and

reasonable." This means that the warning must: (1) clearly say that the chemical involved is known to cause cancer, or birth defects or other reproductive harm; and (2) be given in such a way that it will effectively reach the person before he or she is exposed to that chemical. Some exposures are exempt from the warning requirement under certain circumstances discussed below.

Prohibition from discharges into drinking water. A business must not knowingly discharge or release a listed chemical into water or onto land where it passes or probably will pass into a source of drinking water. Some discharges are exempt from this requirement under certain circumstances discussed below.

DOES PROPOSITION 65 PROVIDE ANY EXEMPTIONS?

Yes. You should consult the current version of the statute and regulations (<http://www.oehha.ca.gov/prop65/law/index.html>) to determine all applicable exemptions, the most common of which are the following:

Grace Periods. Proposition 65 warning requirements do not apply until 12 months after the chemical has been listed. The Proposition 65 discharge prohibition does not apply to a discharge or release of a chemical that takes place less than 20 months after the listing of the chemical.

Governmental agencies and public water utilities. All agencies of the federal, state or local government, as well as entities operating public water systems, are exempt.

Businesses with nine or fewer employees. Neither the warning requirement nor the discharge prohibition applies to a business that employs a total of nine or fewer employees. This includes all employees, not just those present in California.

Exposures that pose no significant risk of cancer. For chemicals that are listed under Proposition 65 as known to the State to cause cancer, a warning is not required if the business causing the exposure can demonstrate that the exposure occurs at a level that poses "no significant risk." This means that the exposure is calculated to result in not more than one excess case of cancer in 100,000 individuals exposed over a 70-year lifetime. The Proposition 65 regulations identify specific "No Significant Risk Levels" (NSRLs) for many listed carcinogens. Exposures below these levels are exempt from the warning requirement. See OEHHA's website at:

<http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of NSRLs, and Section 25701 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures that will produce no observable reproductive effect at 1,000 times the level in question. For chemicals known to the State to cause reproductive toxicity, a warning is not required if the business causing the exposure can demonstrate that the exposure will produce no observable effect, even at 1,000 times the level in question. In other words, the level of exposure must be below the "no observable effect level" divided by 1,000. This number is known as the Maximum Allowable Dose Level (MADL). See OEHHA's website at:

<http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of MADLs, and Section 25801 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures to Naturally Occurring Chemicals in Food. Certain exposures to chemicals that naturally occur in foods (i.e., that do not result from any known human activity, including activity by someone other than the person causing the exposure) are exempt from the warning requirements of the law. If the chemical is a contaminant² it must be reduced to the lowest level feasible. Regulations explaining this exemption can be found in Section 25501.

Discharges that do not result in a "significant amount" of the listed chemical entering any source of drinking water. The prohibition from discharges into drinking water does not apply if the discharger is able to demonstrate that a "significant amount" of the listed chemical has not, does not, or will not pass into or probably pass into a source of drinking water, and that the discharge complies with all other applicable laws, regulations, permits, requirements, or orders. A "significant amount" means any detectable amount, except an amount that would meet the "no significant risk" level for chemicals that cause cancer or that is 1,000 times below the "no observable effect" level for chemicals that cause reproductive toxicity, if an individual were exposed to that amount in drinking water.

HOW IS PROPOSITION 65 ENFORCED?

Enforcement is carried out through civil lawsuits. These lawsuits may be brought by the Attorney General, any district attorney, or certain city attorneys. Lawsuits may also be brought by private parties acting in the public interest, but only after providing notice of the alleged violation to the Attorney General, the appropriate district attorney and city attorney, and the business accused of the violation. The notice must provide adequate information to allow the recipient to assess the nature of the alleged violation. The notice must comply with the information and procedural requirements specified in Section 25903 of Title 27 and sections 3100-3103 of Title 11. A private party may not pursue an independent enforcement action under Proposition 65 if one of the governmental officials noted above initiates an enforcement action within sixty days of the notice.

A business found to be in violation of Proposition 65 is subject to civil penalties of up to \$2,500 per day for each violation. In addition, the business may be ordered by a court to stop committing the violation.

A private party may not file an enforcement action based on certain exposures if the alleged violator meets specific conditions. For the following types of exposures, the Act provides an opportunity for the business to correct the alleged violation:

- An exposure to alcoholic beverages that are consumed on the alleged violator's premises to the extent onsite consumption is permitted by law;
- An exposure to a Proposition 65 listed chemical in a food or beverage prepared and sold on the alleged violator's premises that is primarily intended for immediate consumption on- or off- premises. This only applies if the chemical was not intentionally added to the food, and was formed by cooking or similar preparation of food or beverage components necessary to render the food or beverage palatable or to avoid microbiological contamination;

- An exposure to environmental tobacco smoke caused by entry of persons (other than employees) on premises owned or operated by the alleged violator where smoking is permitted at any location on the premises;
- An exposure to listed chemicals in engine exhaust, to the extent the exposure occurs inside a facility owned or operated by the alleged violator and primarily intended for parking non-commercial vehicles.

If a private party alleges that a violation occurred based on one of the exposures described above, the private party must first provide the alleged violator a notice of special compliance procedure and proof of compliance form.

A private party may not file an action against the alleged violator for these exposures, or recover in a settlement any payment in lieu of penalties any reimbursement for costs and attorney's fees, if the notice was served on or after October 5, 2013, and the alleged violator has done *all* of the following within 14 days of being served notice:

- Corrected the alleged violation;
- Agreed to pay a civil penalty of \$5B500 (subject to change as noted below) to the private party within 30 days; and
- Notified the private party serving the notice in writing that the violation has been corrected.

The written notification to the private-party must include a notice of special compliance procedure and proof of compliance form completed by the alleged violator as directed in the notice. On April 1, 2019, and every five years thereafter, the dollar amount of the civil penalty will be adjusted by the Judicial Council based on the change in the annual California Consumer Price Index. The Judicial Council will publish the dollar amount of the adjusted civil penalty at each five-year interval, together with the date of the next scheduled adjustment.

An alleged violator may satisfy these conditions only one time for a violation arising from the same exposure in the same facility or on the same premises. The satisfaction of these conditions does not prevent the Attorney General, a district attorney, a city attorney of a city of greater than 750,000 population, or any full-time city prosecutor with the consent of the district attorney, from filing an enforcement action against an alleged violator. The amount of any civil penalty for a violation shall be reduced to reflect any payment made by the alleged violator for the same alleged violation to a private-party.

Dear Alleged Violator and the Appropriate Public Enforcement Agencies:

I represent Environmental Research Center, Inc. ("ERC"), 3111 Camino Del Rio North, Suite 400, San Diego, CA 92108; Tel. (619) 500-3090. ERC's Executive Director is Chris Heptinstall. ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California's Safe Drinking Water and Toxic Enforcement Act of 1986 ("Proposition 65"), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the products identified below. These violations have occurred and continue to occur because the alleged Violator identified below failed to provide required clear and reasonable warnings with these products. This letter serves as a notice of these violations to the alleged Violator and the appropriate public enforcement agencies. Pursuant to Health and Safety Code Section 25249.7(d), ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

General Information about Proposition 65. A copy of a summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is enclosed with this letter served to the alleged Violator identified below.

Alleged Violator. The name of the company covered by this notice that violated Proposition 65 (hereinafter the "Violator") is:

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.


Route of Exposure. The consumer exposures that are the subject of this notice result from the recommended use of these products. Consequently, the route of exposure to this chemical has been and continues to be through ingestion.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least March 24, 2014, as well as every day since the products were introduced into the California marketplace, and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until this known toxic chemical is either removed from or reduced to allowable levels in the products. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemical. The method of warning should be a warning that appears on the product label. The Violator violated Proposition 65 because it failed to provide persons handling and/or using these products with appropriate warnings that they are being exposed to this chemical.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violator to: (1) reformulate the identified products so as to eliminate further exposures to the identified chemical, or provide appropriate warnings on the labels of these products; (2) pay an appropriate civil penalty; and (3) provide clear and reasonable warnings compliant with Proposition 65 to all persons located in California who purchased the above products in the last three years. Such a resolution will prevent further unwarned consumer exposures to the identified chemical, as well as an expensive and time consuming litigation.

ERC has retained me as legal counsel in connection with this matter. **Please direct all communications regarding this Notice of Violation to my attention at the law office address and telephone number indicated on the letterhead.**





THE SAFE DRINKING WATER AND TOXIC ENFORCEMENT ACT OF 1986

(PROPOSITION 65): A SUMMARY

The following summary has been prepared by the California Office of Environmental Health Hazard Assessment (OEHHA), the lead agency for the implementation of the Safe Drinking Water and Toxic Enforcement Act of 1986 (commonly known as "Proposition 65"). A copy of this summary must be included as an attachment to any notice of violation served upon an alleged violator of the Act. The summary provides basic information about the provisions of the law, and is intended to serve only as a convenient source of general information. It is not intended to provide authoritative guidance on the meaning or application of the law. Please refer to the statute and OEHHA's implementing regulations (see citations below) for further information.

FOR INFORMATION CONCERNING THE BASIS FOR THE ALLEGATIONS IN THE NOTICE RELATED TO YOUR BUSINESS, CONTACT THE PERSON IDENTIFIED ON THE NOTICE.

The text of Proposition 65 (Health and Safety Code Sections 25249.5 through 25249.13) is available online at: <http://oehha.ca.gov/prop65/law/P65law72003.html>. Regulations that provide more specific guidance on compliance, and that specify procedures to be followed by the State in carrying out certain aspects of the law, are found in Title 27 of the California Code of Regulations, sections 25102 through 27001.¹ These implementing regulations are available online at: <http://oehha.ca.gov/prop65/law/P65Regs.html>.

WHAT DOES PROPOSITION 65 REQUIRE?

The "Proposition 65 List." Under Proposition 65, the lead agency (OEHHA) publishes a list of chemicals that are known to the State of California to cause cancer and/or reproductive toxicity. Chemicals are placed on the Proposition 65 list if they are known to cause cancer and/or birth defects or other reproductive harm, such as damage to female or male reproductive systems or to the developing fetus. This list must be updated at least once a year. The current Proposition 65 list of chemicals is available on the OEHHA website at:

http://www.oehha.ca.gov/prop65/prop65_list/Newlist.html.

Only those chemicals that are on the list are regulated under Proposition 65. Businesses that produce, use, release or otherwise engage in activities involving listed chemicals must comply with the following:

Clear and reasonable warnings. A business is required to warn a person before "knowingly and intentionally" exposing that person to a listed chemical unless an exemption applies. The warning given must be "clear and

reasonable." This means that the warning must: (1) clearly say that the chemical involved is known to cause cancer, or birth defects or other reproductive harm; and (2) be given in such a way that it will effectively reach the person before he or she is exposed to that chemical. Some exposures are exempt from the warning requirement under certain circumstances discussed below.

Prohibition from discharges into drinking water. A business must not knowingly discharge or release a listed chemical into water or onto land where it passes or probably will pass into a source of drinking water. Some discharges are exempt from this requirement under certain circumstances discussed below.

DOES PROPOSITION 65 PROVIDE ANY EXEMPTIONS?

Yes. You should consult the current version of the statute and regulations (<http://www.oehha.ca.gov/prop65/law/index.html>) to determine all applicable exemptions, the most common of which are the following:

Grace Periods. Proposition 65 warning requirements do not apply until 12 months after the chemical has been listed. The Proposition 65 discharge prohibition does not apply to a discharge or release of a chemical that takes place less than 20 months after the listing of the chemical.

Governmental agencies and public water utilities. All agencies of the federal, state or local government, as well as entities operating public water systems, are exempt.

Businesses with nine or fewer employees. Neither the warning requirement nor the discharge prohibition applies to a business that employs a total of nine or fewer employees. This includes all employees, not just those present in California.

Exposures that pose no significant risk of cancer. For chemicals that are listed under Proposition 65 as known to the State to cause cancer, a warning is not required if the business causing the exposure can demonstrate that the exposure occurs at a level that poses "no significant risk." This means that the exposure is calculated to result in not more than one excess case of cancer in 100,000 individuals exposed over a 70-year lifetime. The Proposition 65 regulations identify specific "No Significant Risk Levels" (NSRLs) for many listed carcinogens. Exposures below these levels are exempt from the warning requirement. See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of NSRLs, and Section 25701 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures that will produce no observable reproductive effect at 1,000 times the level in question. For chemicals known to the State to cause reproductive toxicity, a warning is not required if the business causing the exposure can demonstrate that the exposure will produce no observable effect, even at 1,000 times the level in question. In other words, the level of exposure must be below the "no observable effect level" divided by 1,000. This number is known as the Maximum Allowable Dose Level (MADL). See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of MADLs, and Section 25801 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures to Naturally Occurring Chemicals in Food. Certain exposures to chemicals that naturally occur in foods (i.e., that do not result from any known human activity, including activity by someone other than the person causing the exposure) are exempt from the warning requirements of the law. If the chemical is a contaminant² it must be reduced to the lowest level feasible. Regulations explaining this exemption can be found in Section 25501.

Discharges that do not result in a "significant amount" of the listed chemical entering any source of drinking water. The prohibition from discharges into drinking water does not apply if the discharger is able to demonstrate that a "significant amount" of the listed chemical has not, does not, or will not pass into or probably pass into a source of drinking water, and that the discharge complies with all other applicable laws, regulations, permits, requirements, or orders. A "significant amount" means any detectable amount, except an amount that would meet the "no significant risk" level for chemicals that cause cancer or that is 1,000 times below the "no observable effect" level for chemicals that cause reproductive toxicity, if an individual were exposed to that amount in drinking water.

HOW IS PROPOSITION 65 ENFORCED?

Enforcement is carried out through civil lawsuits. These lawsuits may be brought by the Attorney General, any district attorney, or certain city attorneys. Lawsuits may also be brought by private parties acting in the public interest, but only after providing notice of the alleged violation to the Attorney General, the appropriate district attorney and city attorney, and the business accused of the violation. The notice must provide adequate information to allow the recipient to assess the nature of the alleged violation. The notice must comply with the information and procedural requirements specified in Section 25903 of Title 27 and sections 3100-3103 of Title 11. A private party may not pursue an independent enforcement action under Proposition 65 if one of the governmental officials noted above initiates an enforcement action within sixty days of the notice.

A business found to be in violation of Proposition 65 is subject to civil penalties of up to \$2,500 per day for each violation. In addition, the business may be ordered by a court to stop committing the violation.

A private party may not file an enforcement action based on certain exposures if the alleged violator meets specific conditions. For the following types of exposures, the Act provides an opportunity for the business to correct the alleged violation:

- An exposure to alcoholic beverages that are consumed on the alleged violator's premises to the extent onsite consumption is permitted by law;
- An exposure to a Proposition 65 listed chemical in a food or beverage prepared and sold on the alleged violator's premises that is primarily intended for immediate consumption on- or off- premises. This only applies if the chemical was not intentionally added to the food, and was formed by cooking or similar preparation of food or beverage components necessary to render the food or beverage palatable or to avoid microbiological contamination;

- An exposure to environmental tobacco smoke caused by entry of persons (other than employees) on premises owned or operated by the alleged violator where smoking is permitted at any location on the premises;
- An exposure to listed chemicals in engine exhaust, to the extent the exposure occurs inside a facility owned or operated by the alleged violator and primarily intended for parking non-commercial vehicles.

If a private party alleges that a violation occurred based on one of the exposures described above, the private party must first provide the alleged violator a notice of special compliance procedure and proof of compliance form.

A private party may not file an action against the alleged violator for these exposures, or recover in a settlement any payment in lieu of penalties any reimbursement for costs and attorney's fees, if the notice was served on or after October 5, 2013, and the alleged violator has done *all* of the following within 14 days of being served notice:

- Corrected the alleged violation;
- Agreed to pay a civil penalty of \$5B500 (subject to change as noted below) to the private party within 30 days; and
- Notified the private party serving the notice in writing that the violation has been corrected.

The written notification to the private-party must include a notice of special compliance procedure and proof of compliance form completed by the alleged violator as directed in the notice. On April 1, 2019, and every five years thereafter, the dollar amount of the civil penalty will be adjusted by the Judicial Council based on the change in the annual California Consumer Price Index. The Judicial Council will publish the dollar amount of the adjusted civil penalty at each five-year interval, together with the date of the next scheduled adjustment.

An alleged violator may satisfy these conditions only one time for a violation arising from the same exposure in the same facility or on the same premises. The satisfaction of these conditions does not prevent the Attorney General, a district attorney, a city attorney of a city of greater than 750,000 population, or any full-time city prosecutor with the consent of the district attorney, from filing an enforcement action against an alleged violator. The amount of any civil penalty for a violation shall be reduced to reflect any payment made by the alleged violator for the same alleged violation to a private-party.
