unless the Product is accompanied by a warning that complies with Article 6 of Title 27 of the California Code of Regulations provide clear and reasonable warnings as set forth below. The warning shall be prominently placed with such conspicuousness as compared with other words, statements, designs, or devices as to render it likely to be read and understood by an ordinary individual under customary conditions before purchase or use. The warning shall be provided in a manner such that the consumer or user understands to which specific Product the warning applies, so as to minimize the risk of consumer confusions, and shall be issued as follows:

a. For any Product shipped, sold, or offered in California by Ichi Trading that is not DEHP-Free, one of the following warnings shall accompany the Products: (a) **A WARNING:** This product can expose you to chemicals including di(2thylhexyll) phthalate (DEHP), which is known to the State of California to cause cancer and birth defects or other reproductive harm. The warning that is provided must print the word "WARNING:" in all capital letters and in bold font, followed by a colon. The warning symbol to the left of the word "WARNING:" must be a black exclamation point in a yellow equilateral triangle with a black outline, except that if the sign or label for the Products does not use the color yellow, the symbol may be in black and white. The symbol must be in a size no smaller than the height of the word "WARNING:". The warning shall be affixed to or printed on the Products' packaging or labeling, or on a placard, shelf tag, sign or electronic device or automatic process, providing that the warning is displayed with such conspicuousness, as compared with other words, statements, or designs as to render it likely to be read and understood by an ordinary individual under customary conditions of purchase or use. A warning may be contained in the same section of the packaging, labeling, or instruction booklet that states other safety warnings, if

any, concerning the use of the Product and shall be at least the same size as those other safety warnings

b.
